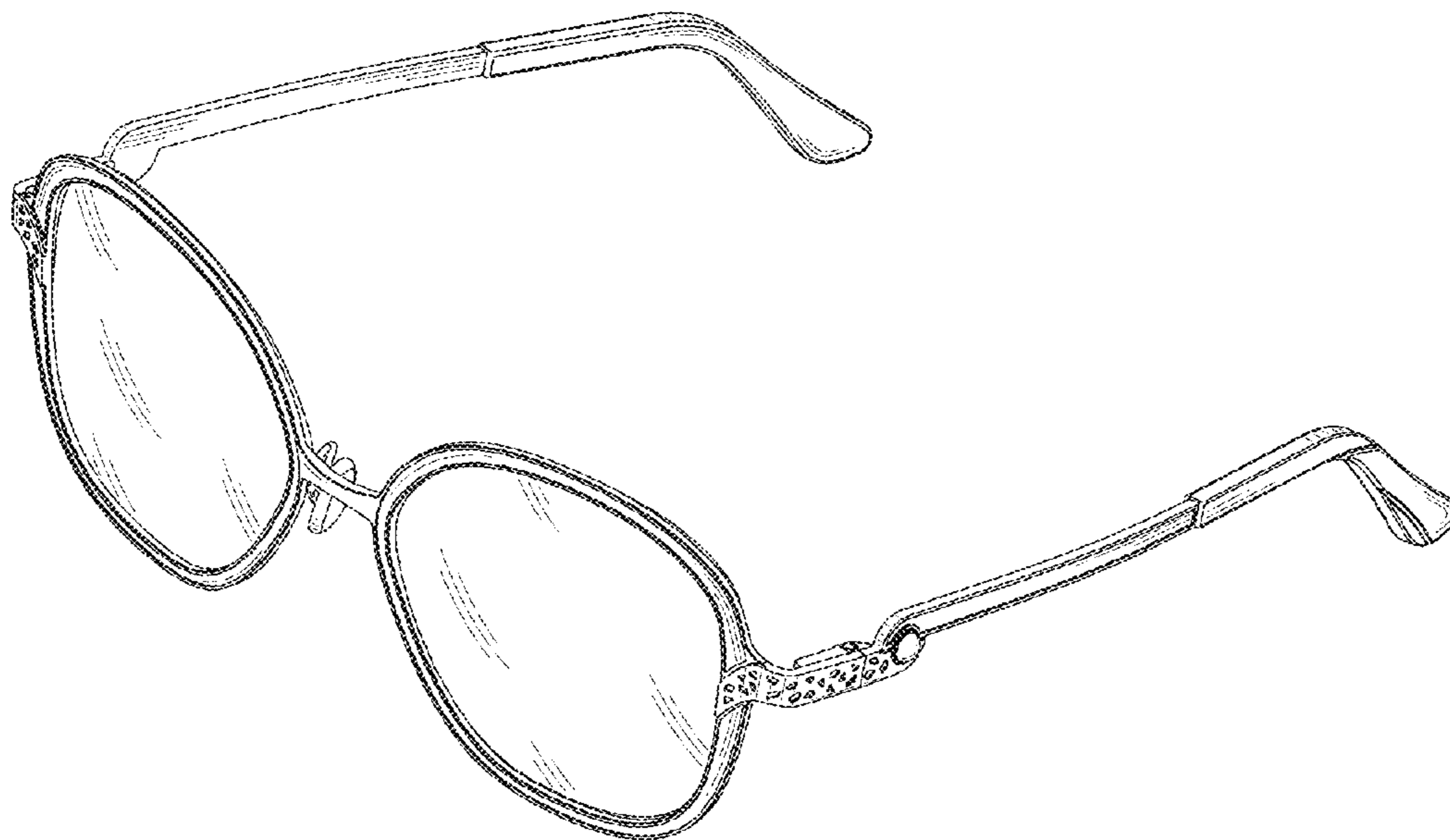
FIG. 5 is a right side view of the frame for sunglasses of FIG.

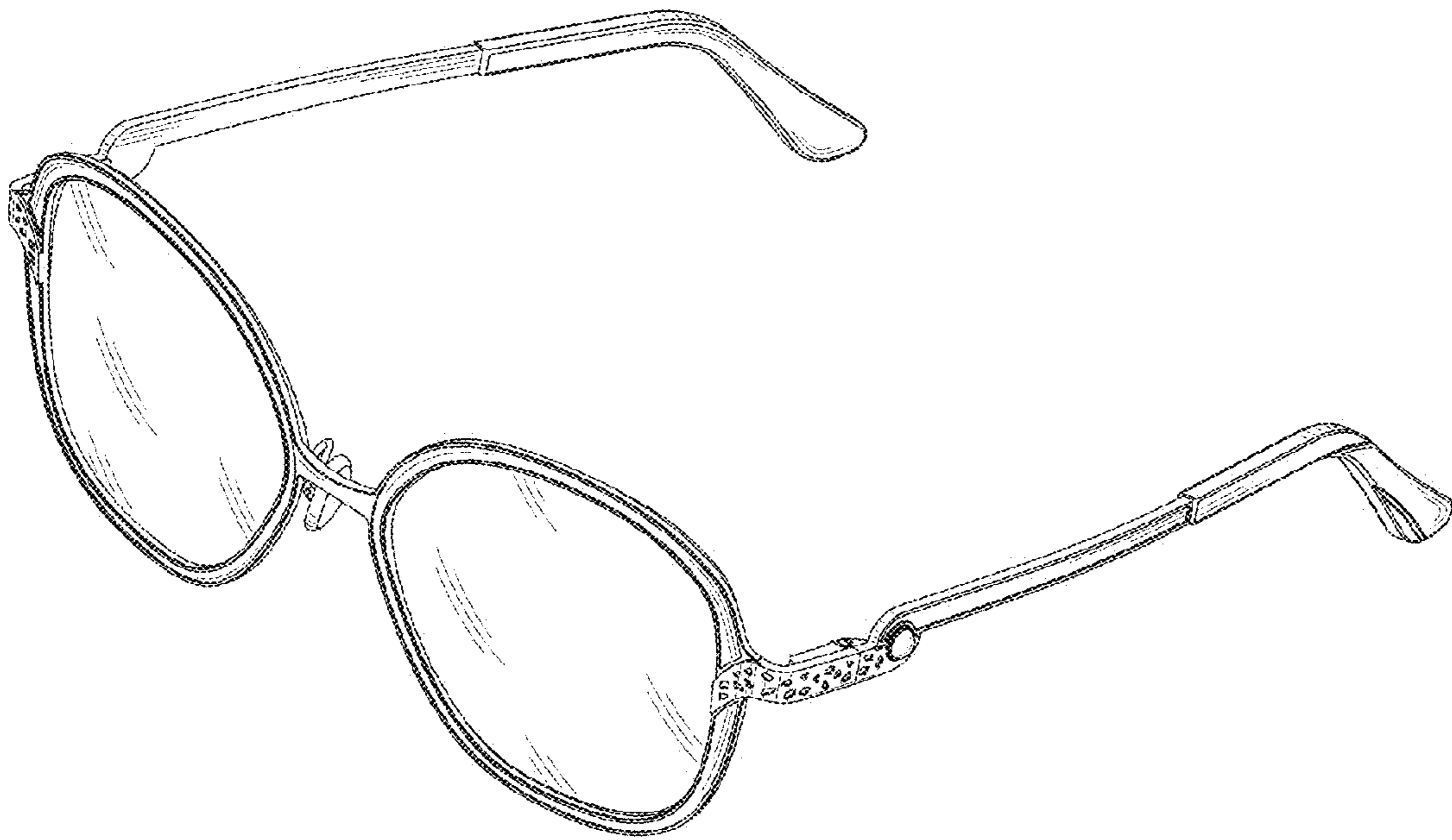

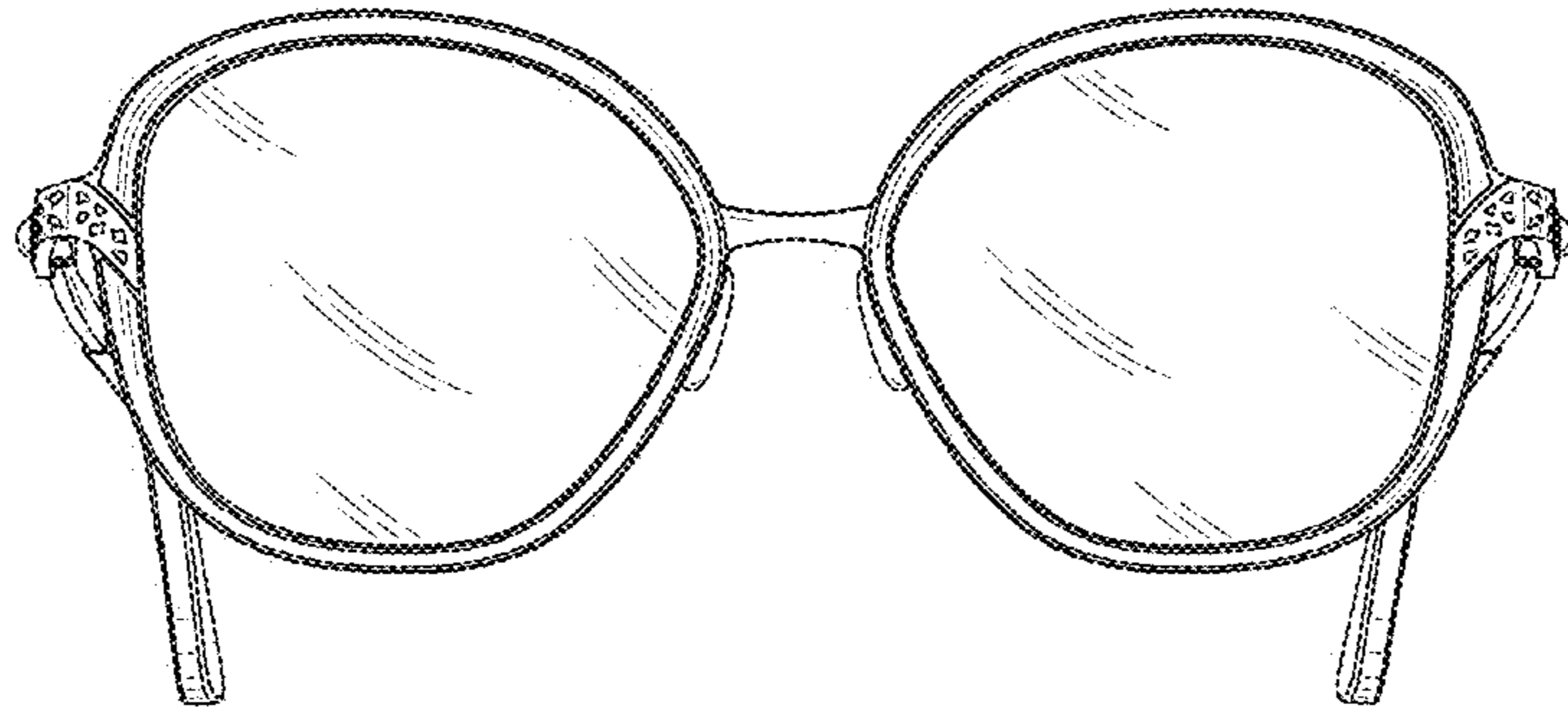

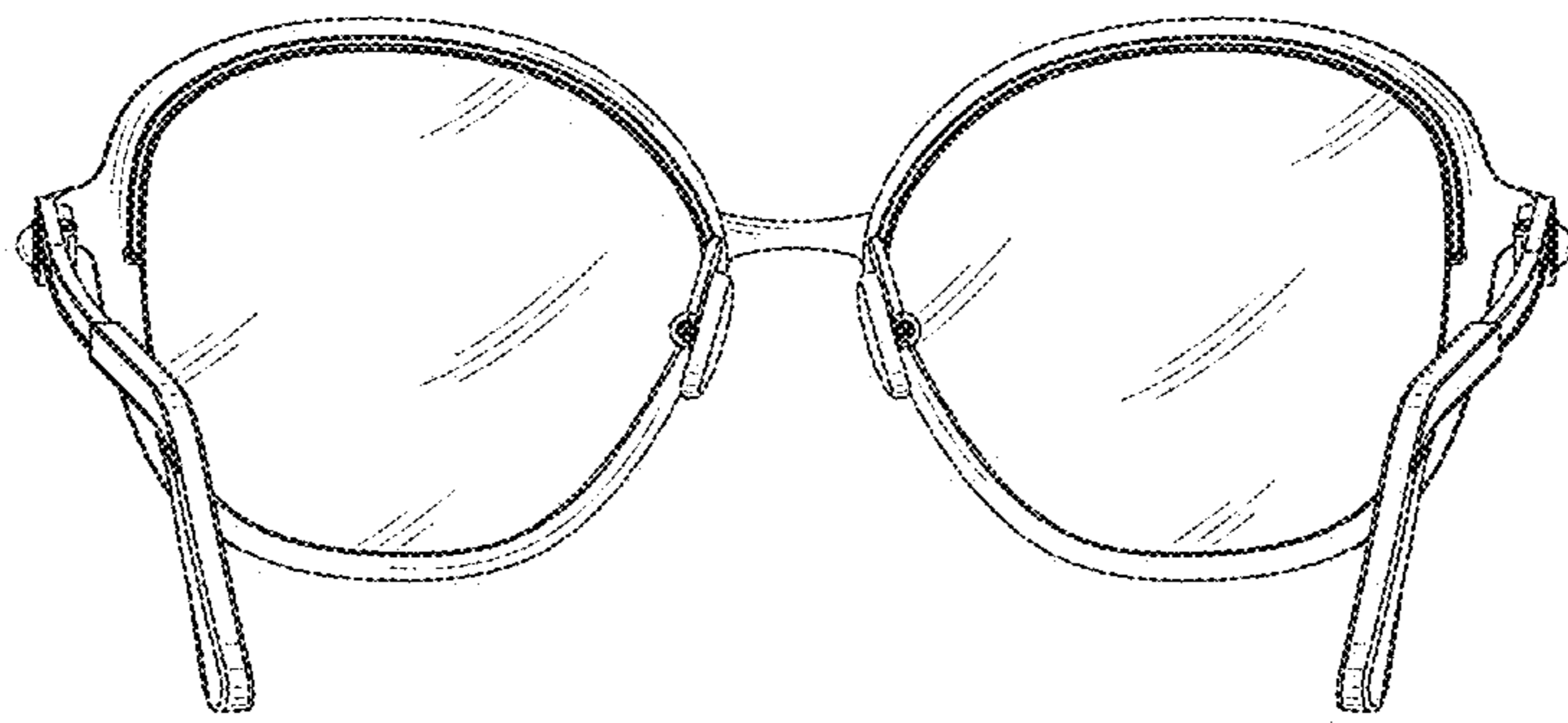

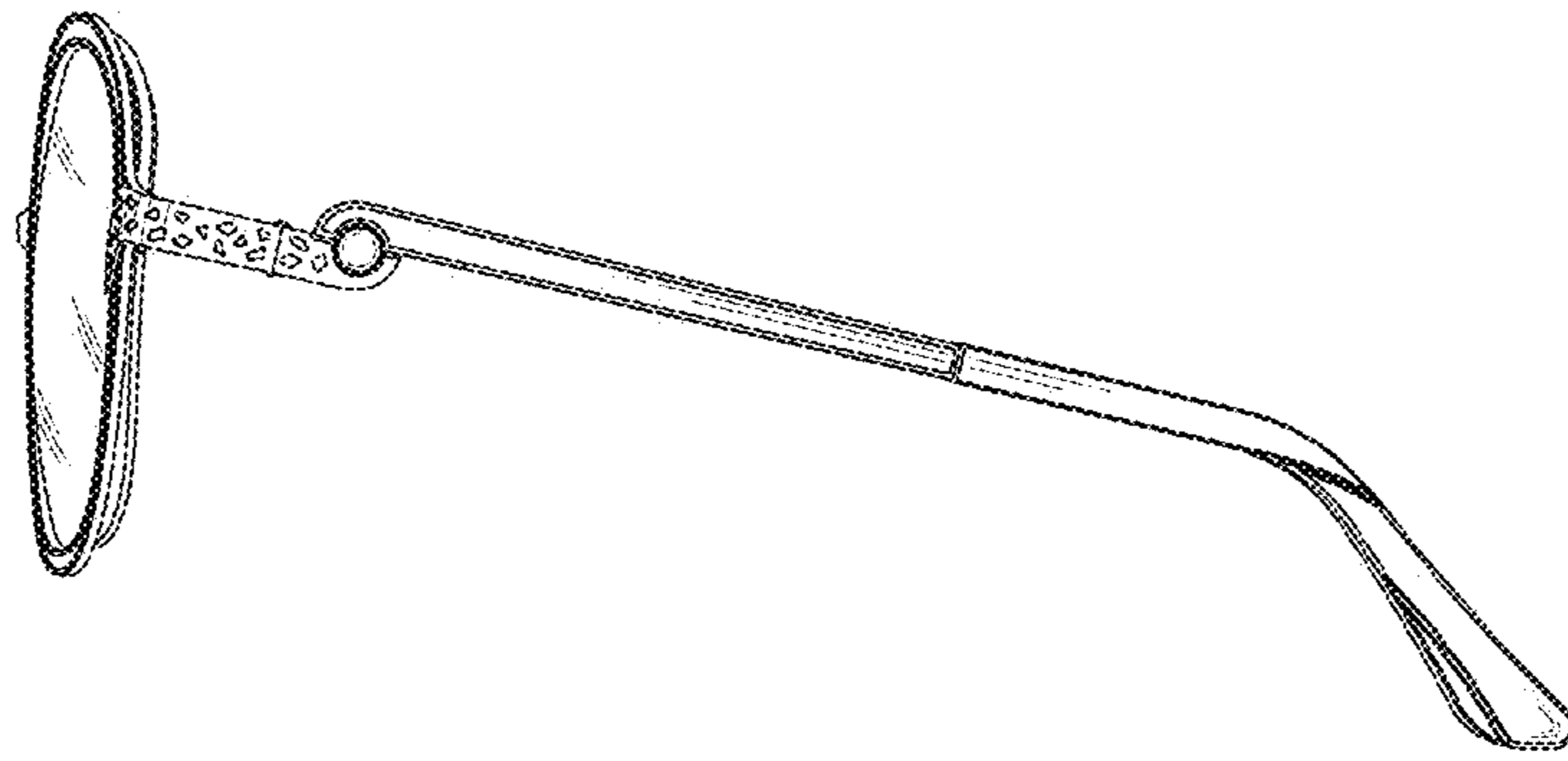

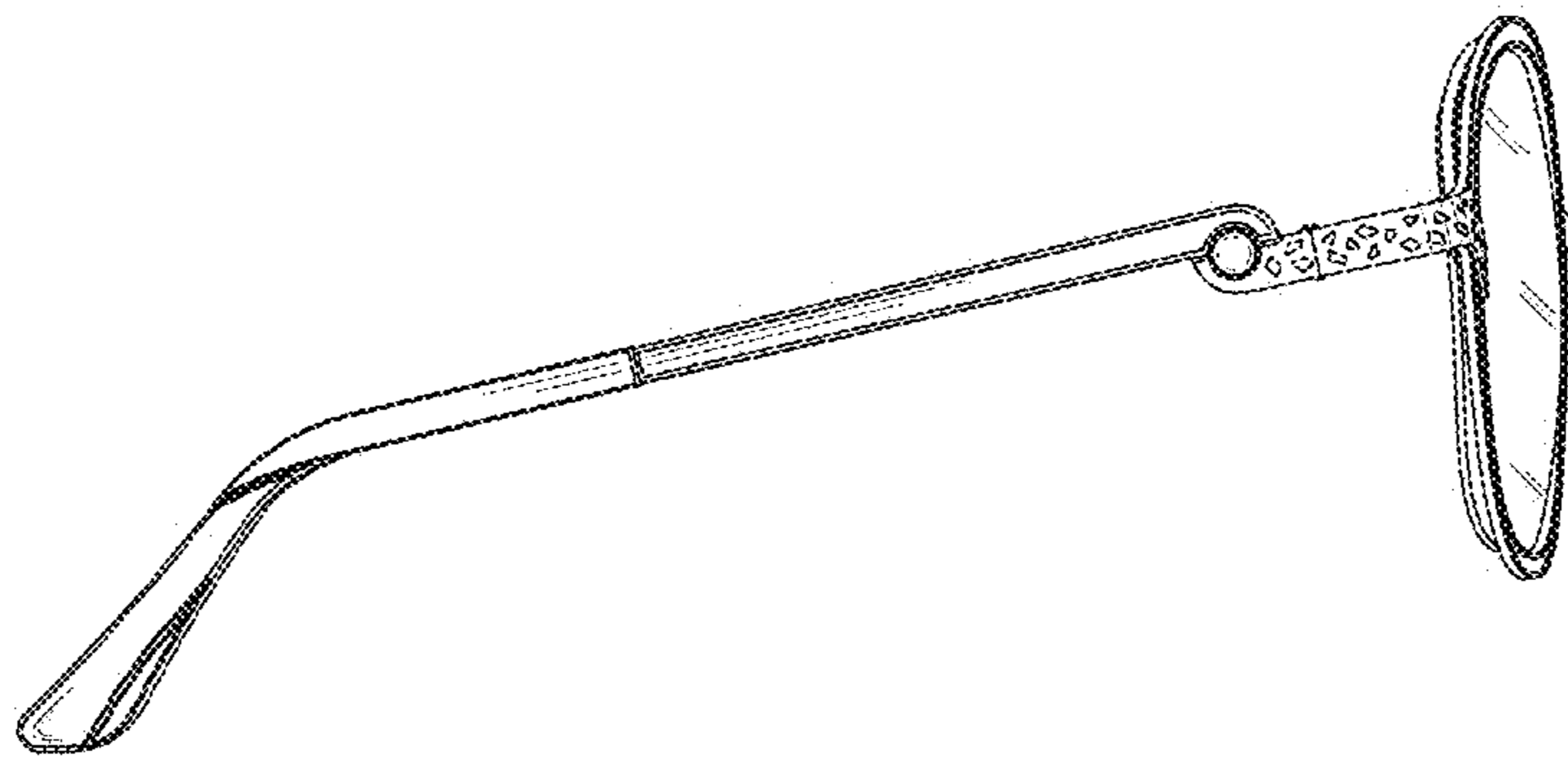

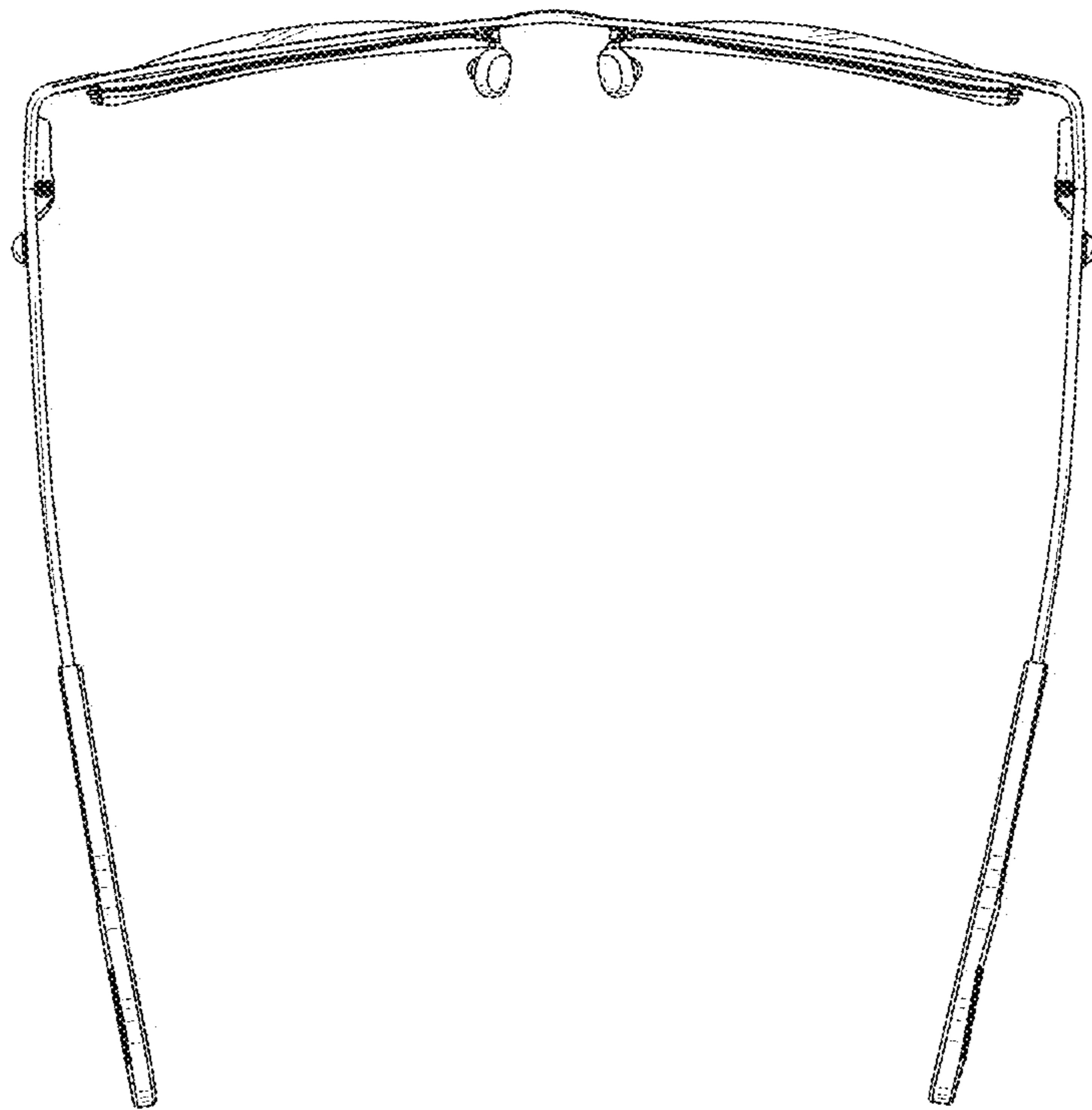
