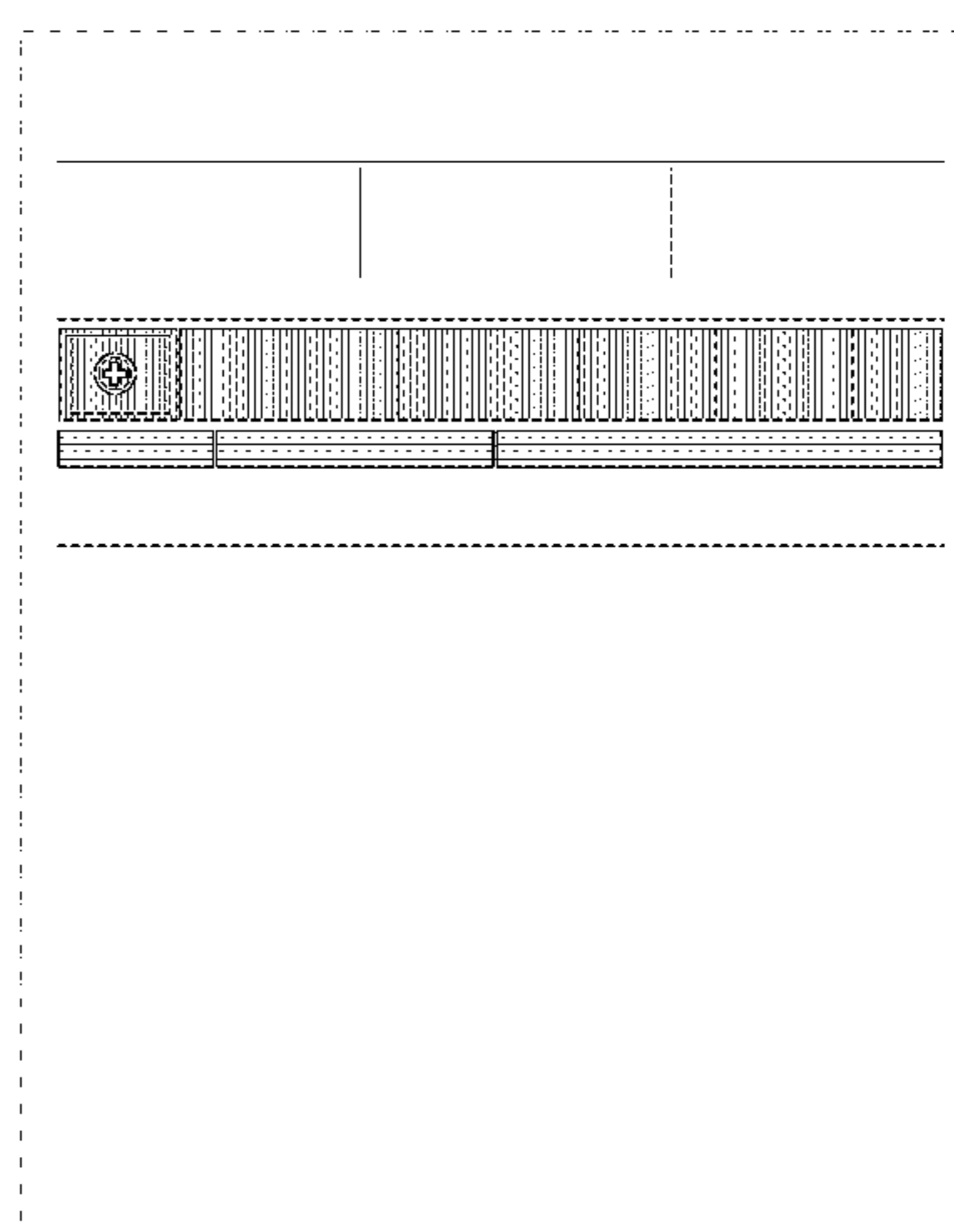
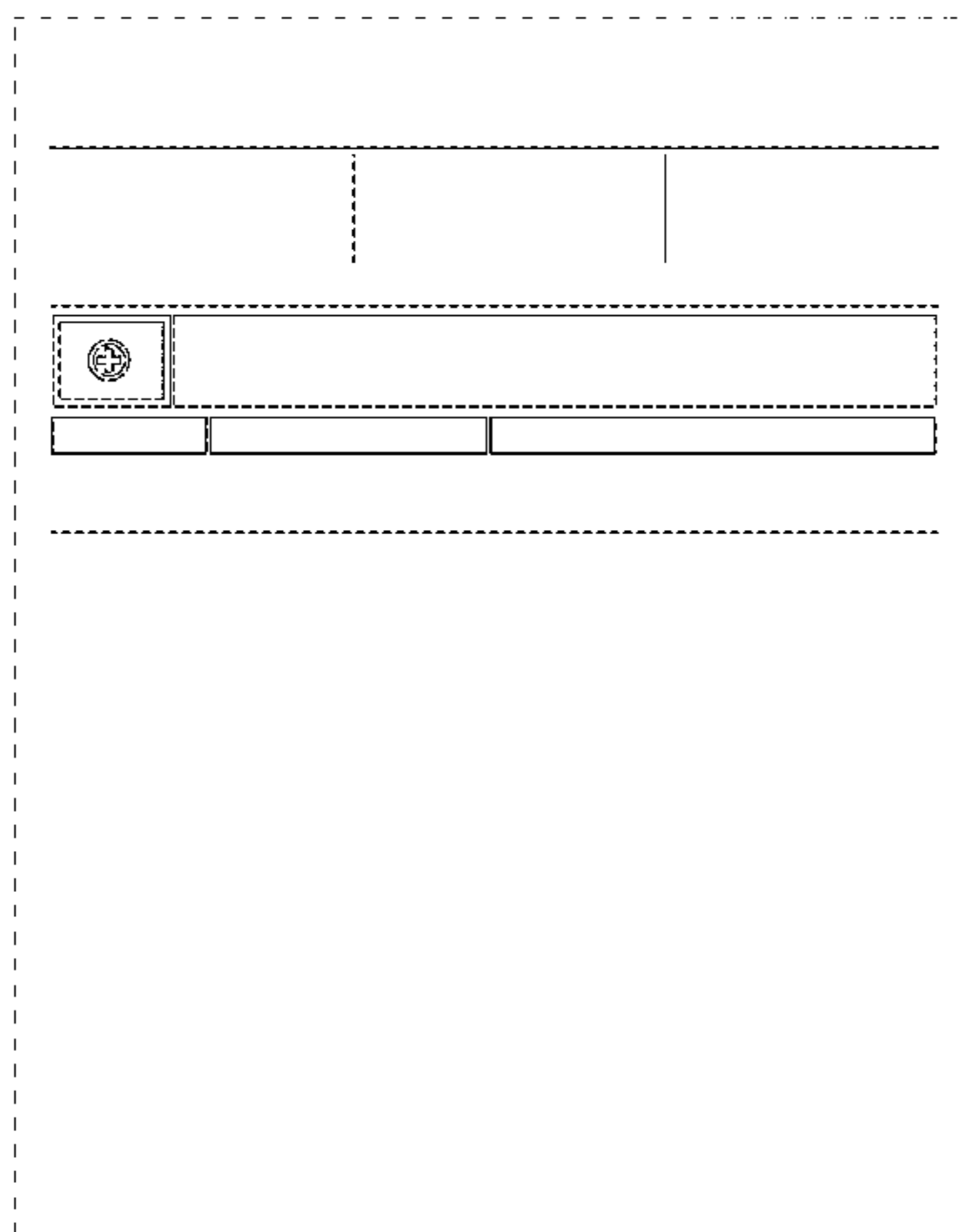
(57) **CLAIM**

The ornamental design for a form, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first embodiment of a form showing our new design; and,
FIG. 2 is a front view of a second embodiment of a form showing our new design, wherein the vertical line pattern represents the color red and the horizontal line pattern represents the color blue.
The outer rectangular broken lines shown in FIGS. 1 and 2 are for illustrative purposes only and form no part of the claimed design.

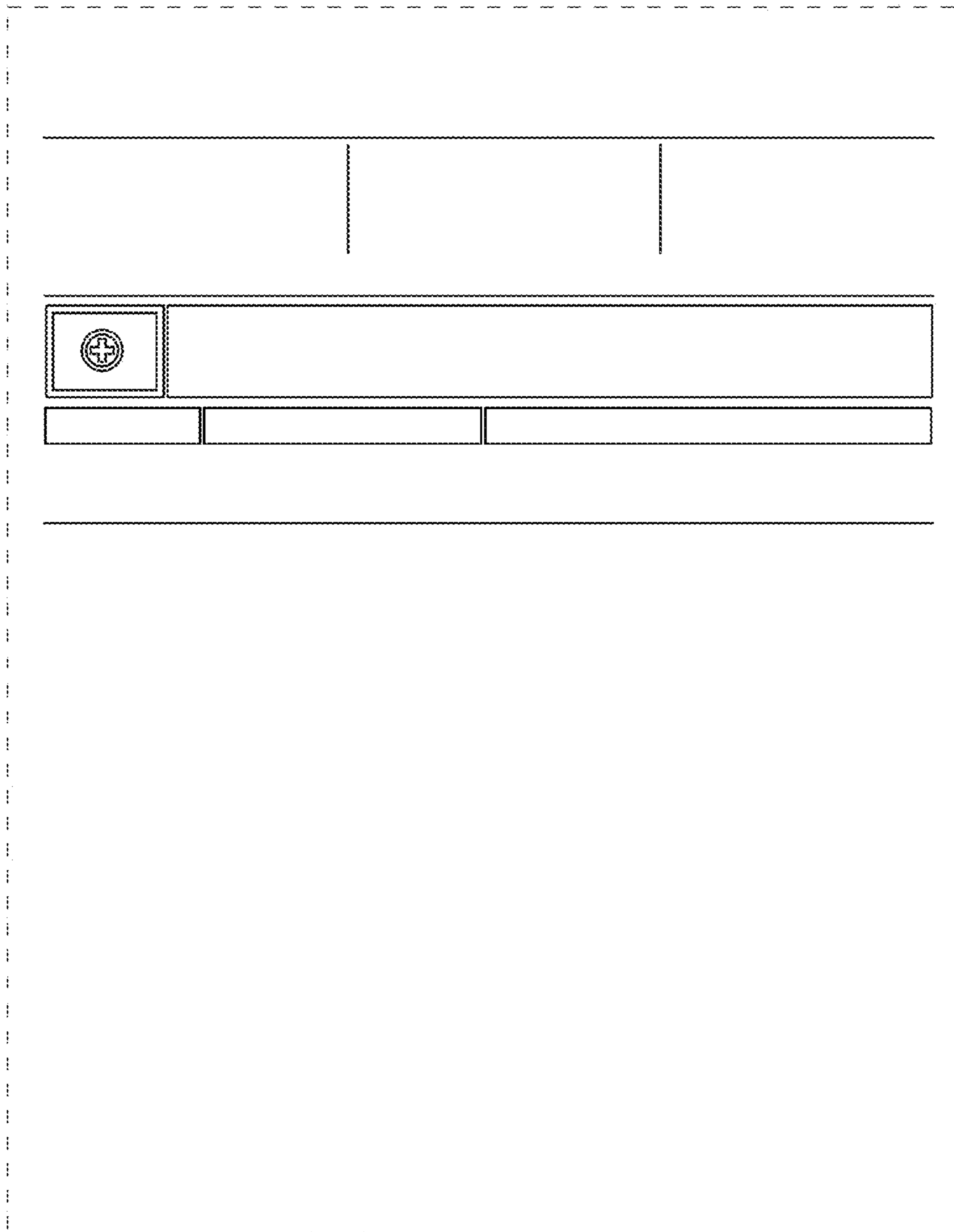

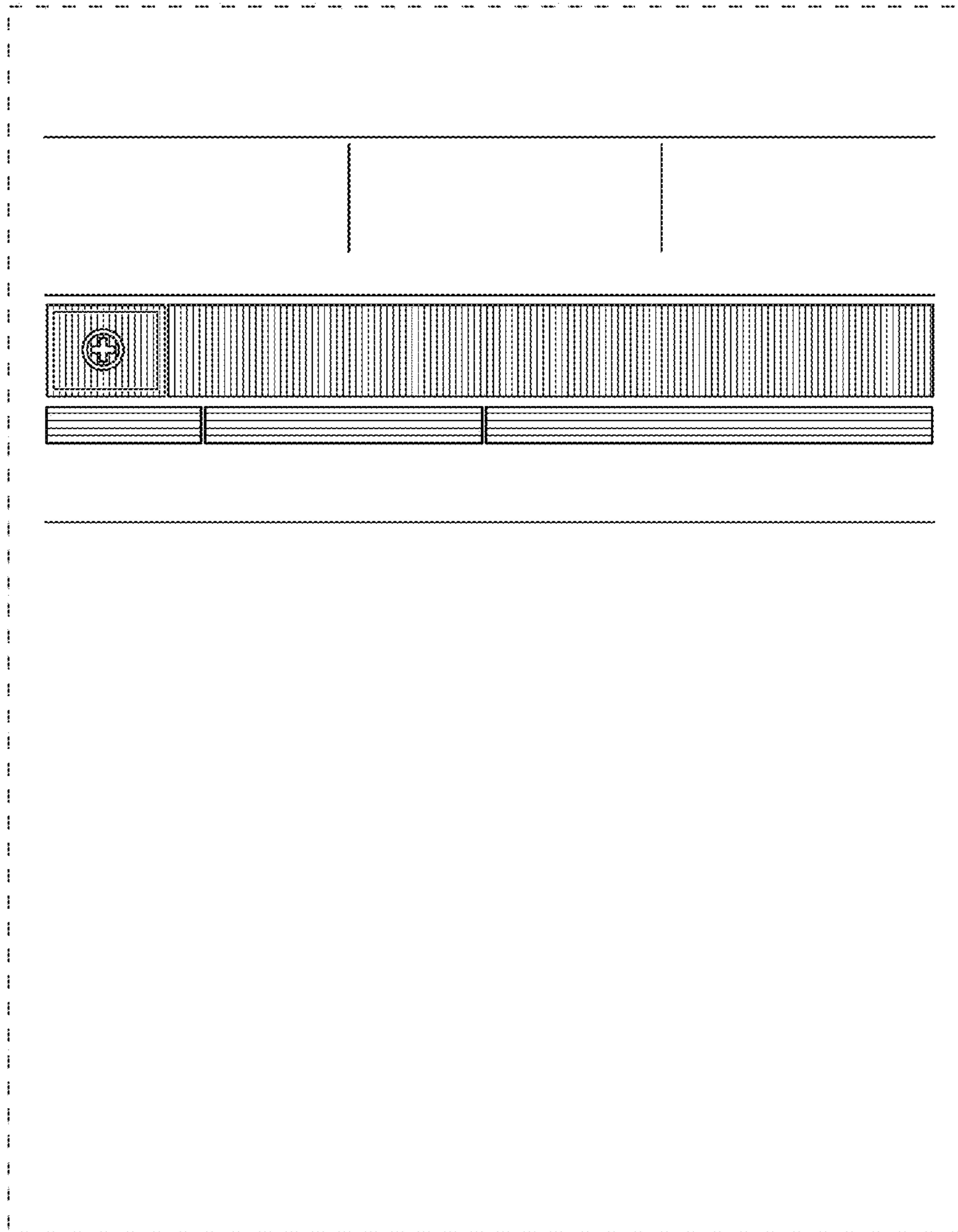
