The ornamental designs for a greeting card, as shown and described.

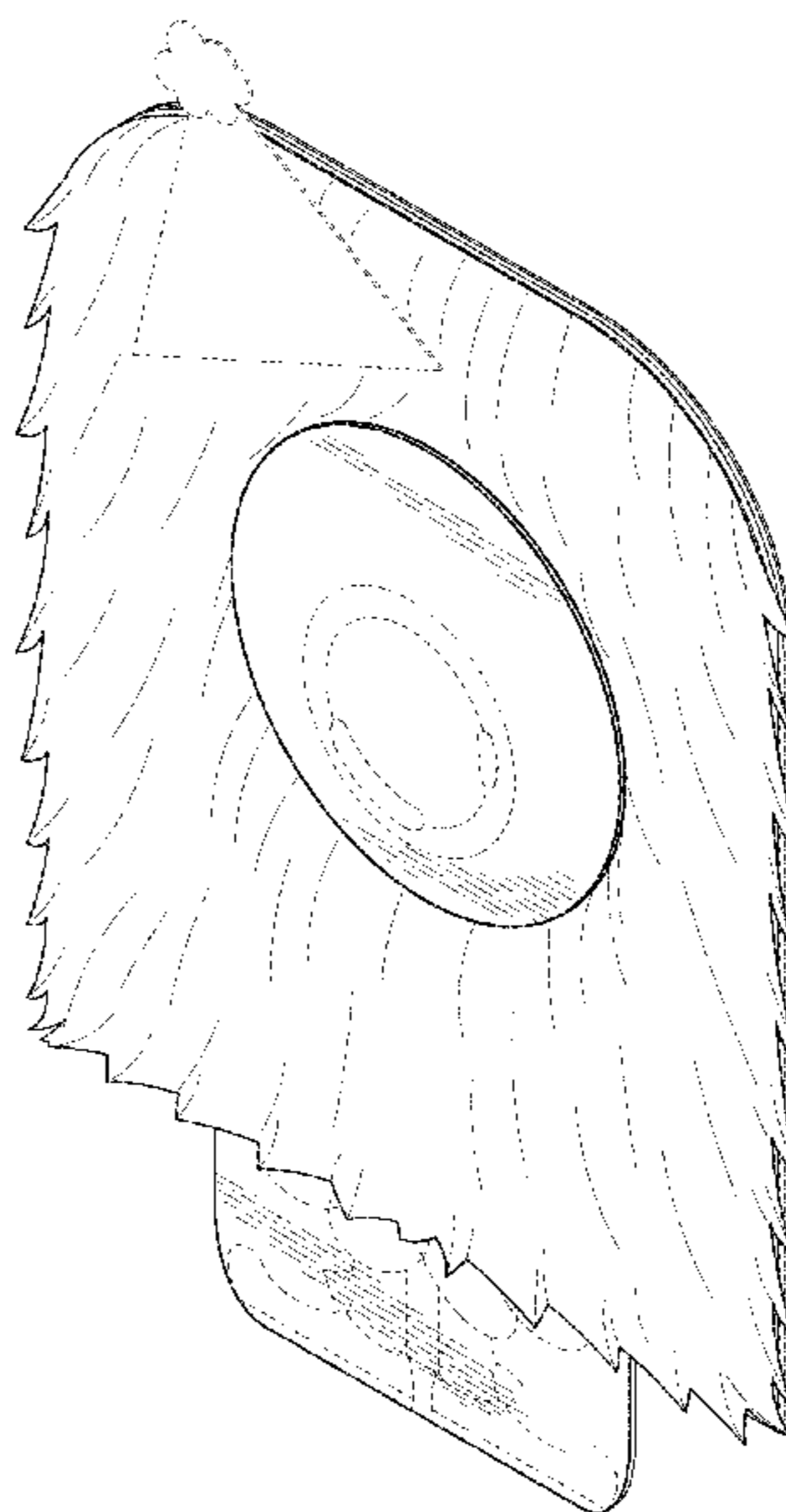

FIG. 2 is a front view of the greeting card of FIG. 1.
FIG. 3 is a rear view of the greeting card of FIG. 1.
FIG. 4 is a right side view of the greeting card of FIG. 1.
FIG. 5 is a left side view of the greeting card of FIG. 1.
FIG. 6 is a top view of the greeting card of FIG. 1.
FIG. 7 is a bottom view of the greeting card of FIG. 1; and, FIG. 8 is a front perspective view of the greeting card of FIG. 1, in an open position.

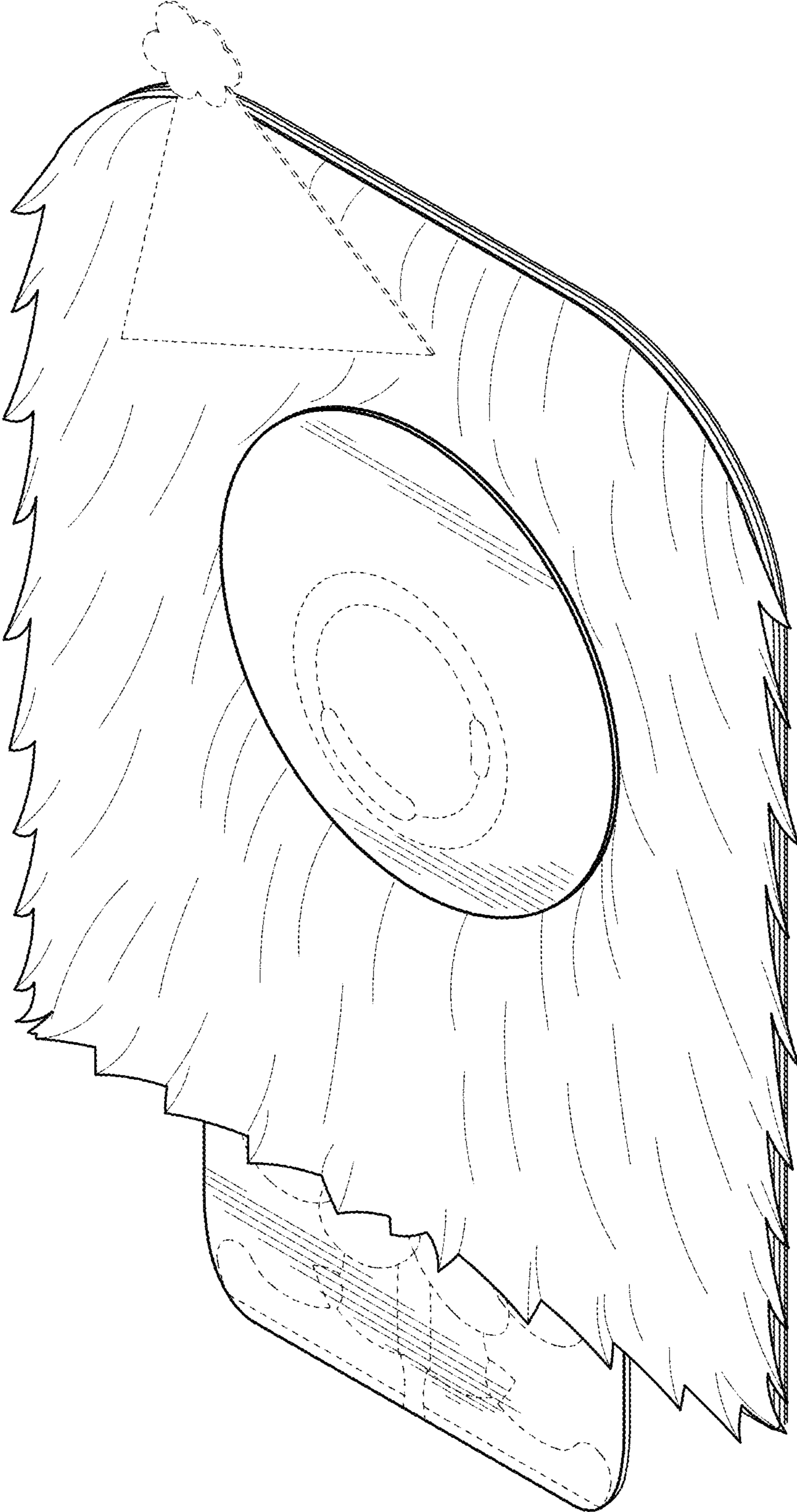

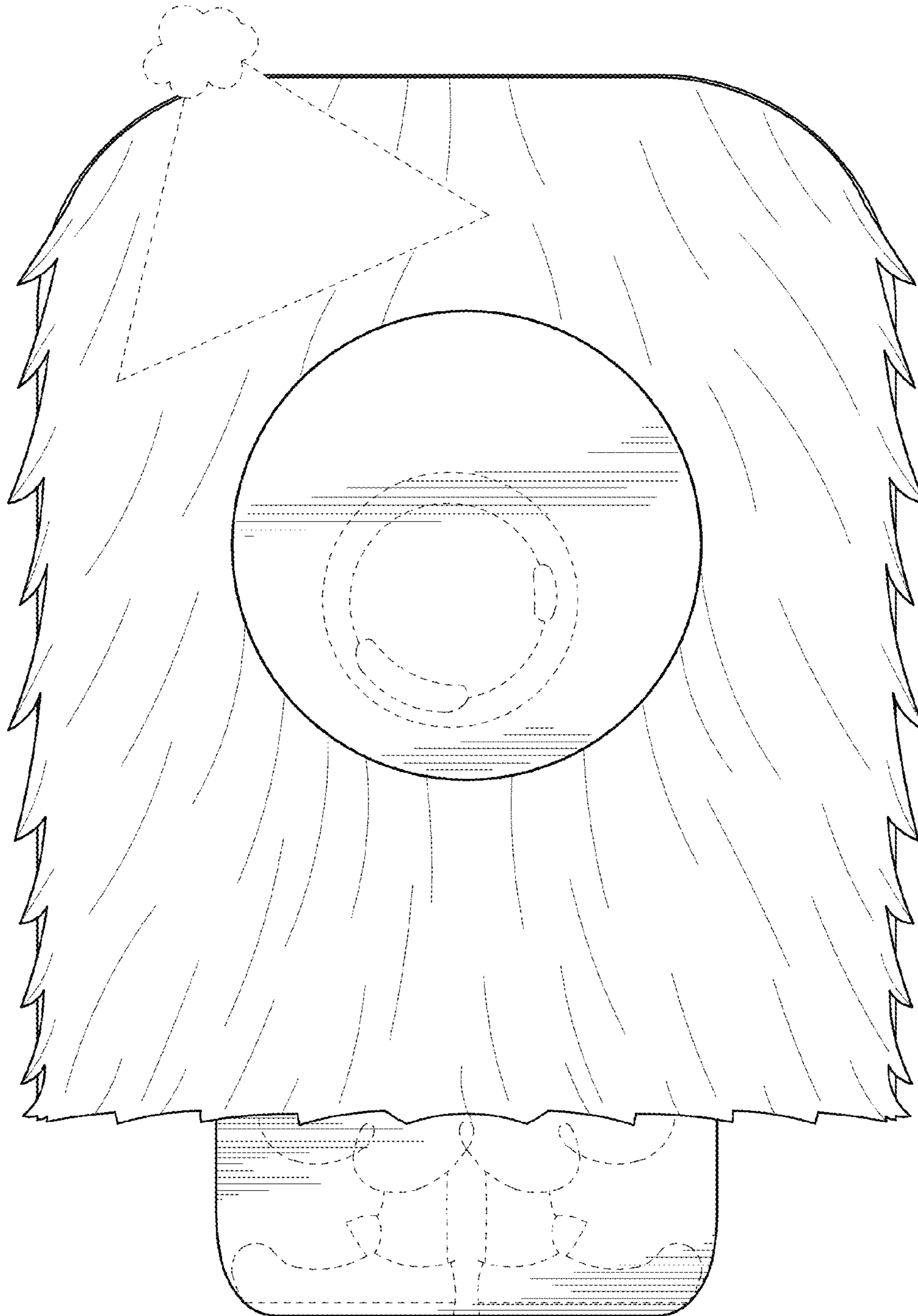

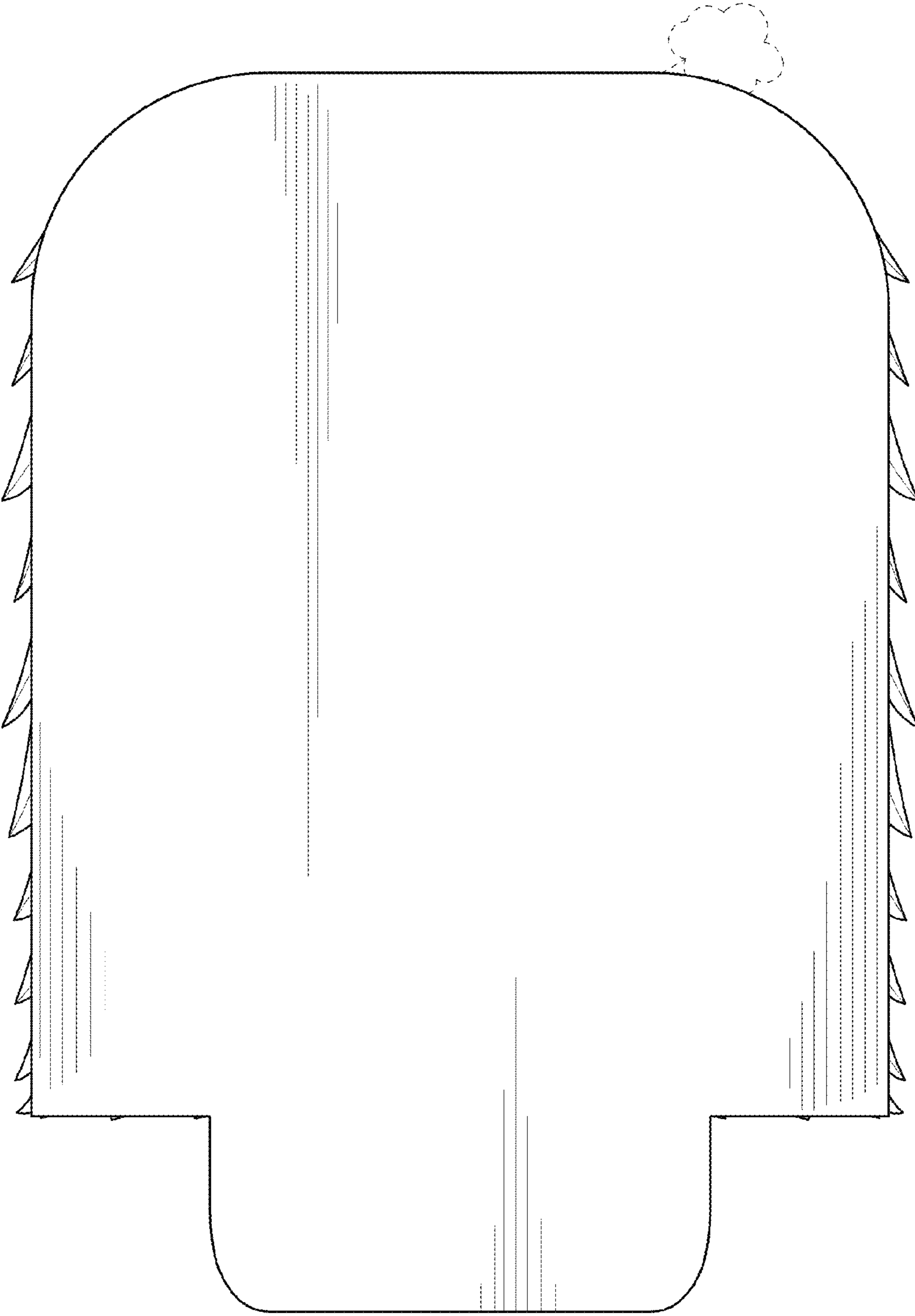

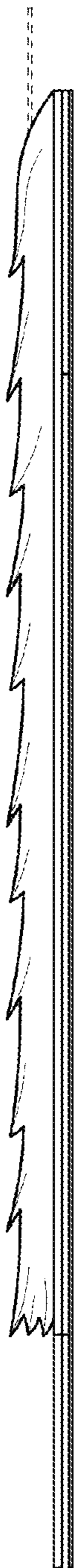

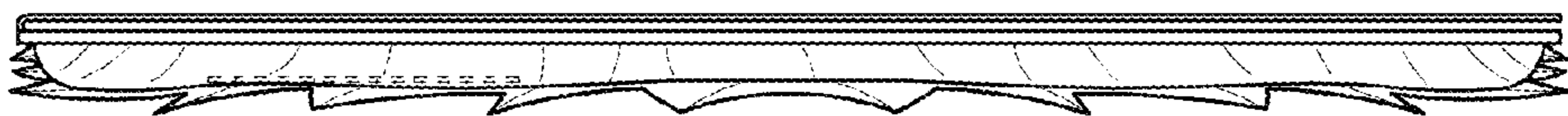

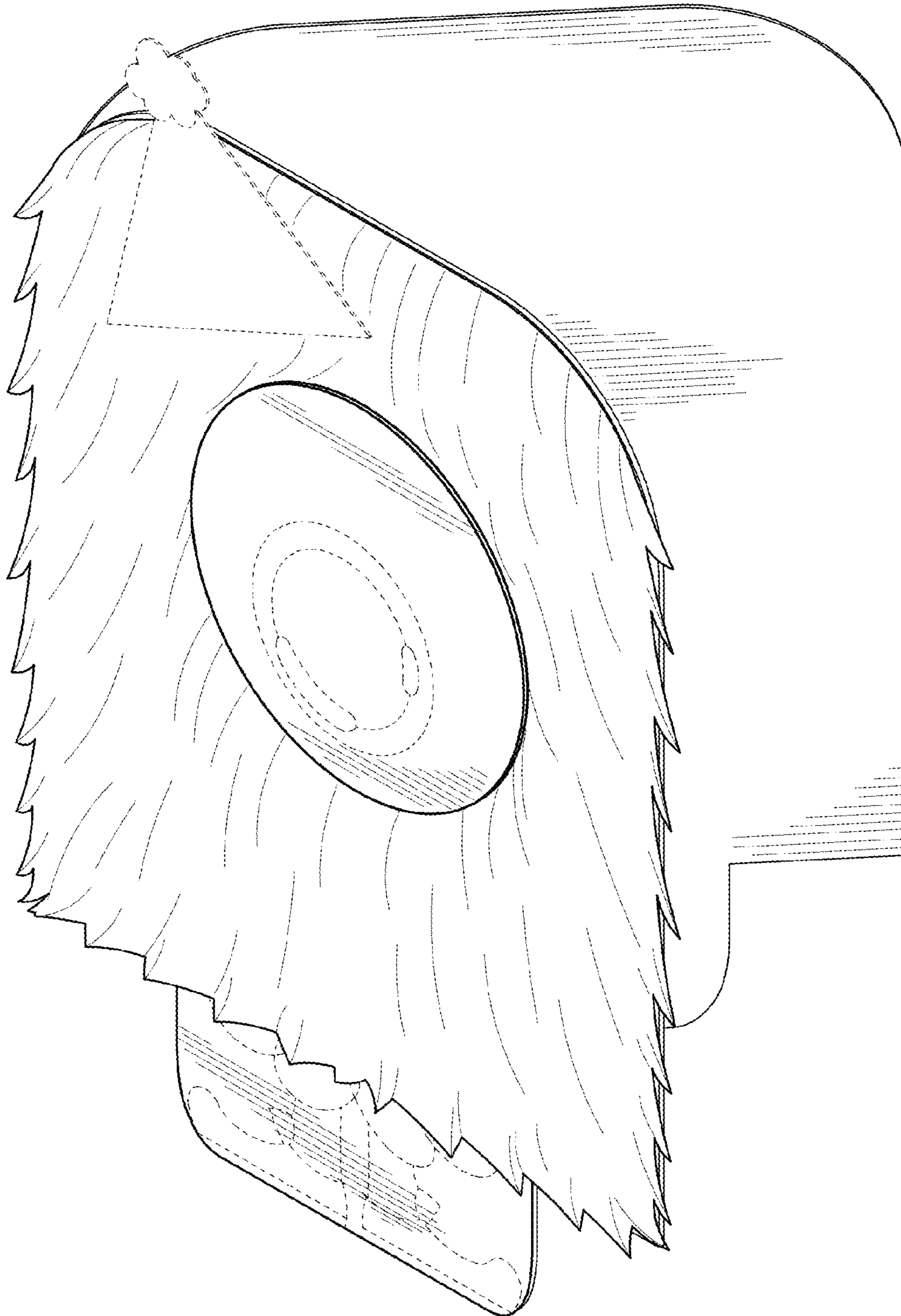
