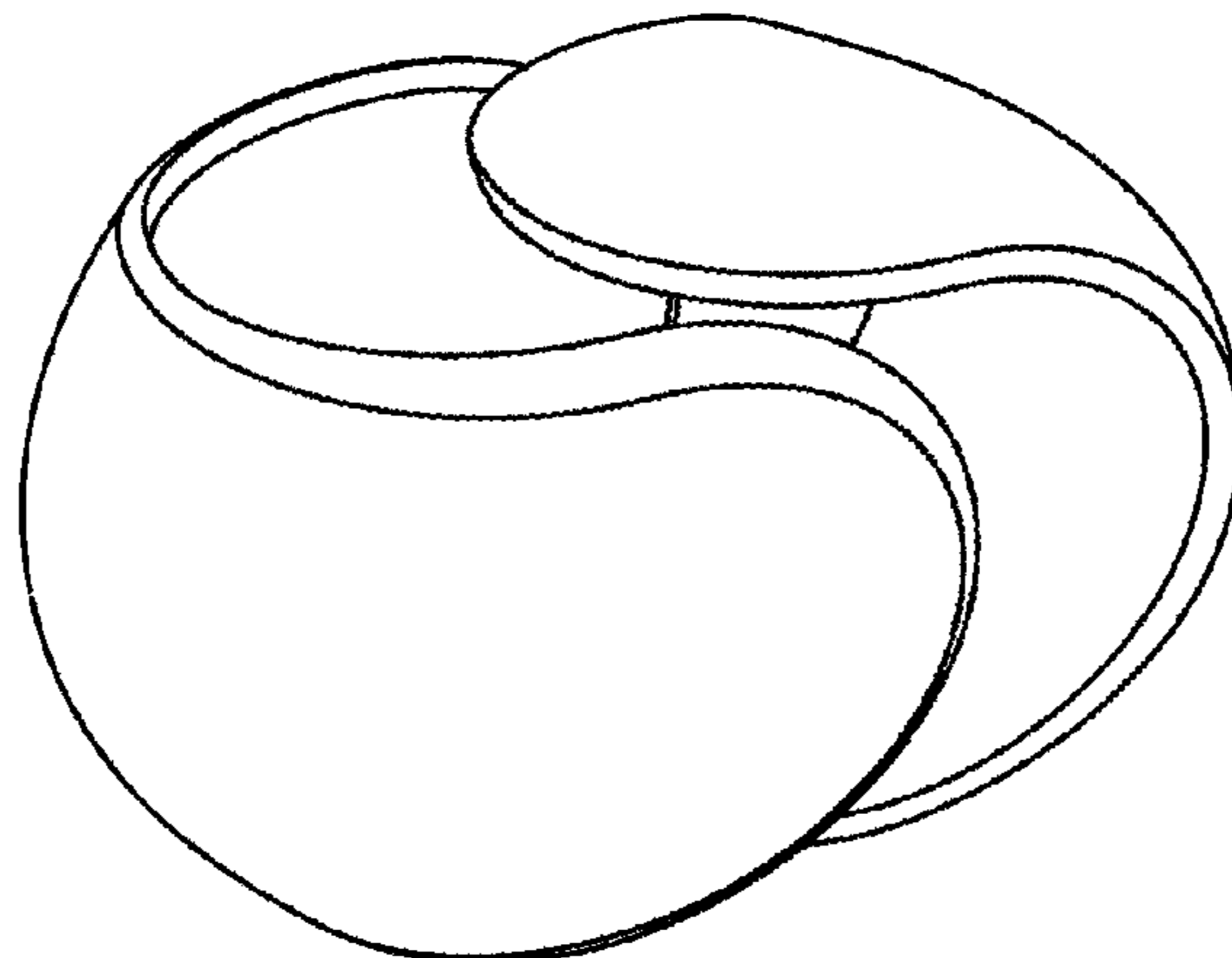
(57) **CLAIM**

The ornamental design for a stamp housing, substantially as shown.

**DESCRIPTION**

FIG. 1 is a top view of a stamp housing of a new, original and ornamental design;  
 FIG. 2 is a top, front, left-hand side perspective view thereof;  
 FIG. 3 is a front view thereof;  
 FIG. 4 is a left-hand side view with the right-hand side view being a mirror image thereof;  
 FIG. 5 is a top, front, left-hand side perspective view shown in an open position thereof;  
 FIG. 6 is a top view shown in an open position thereof; and,  
 FIG. 7 is a left-hand side view shown in an open position thereof.

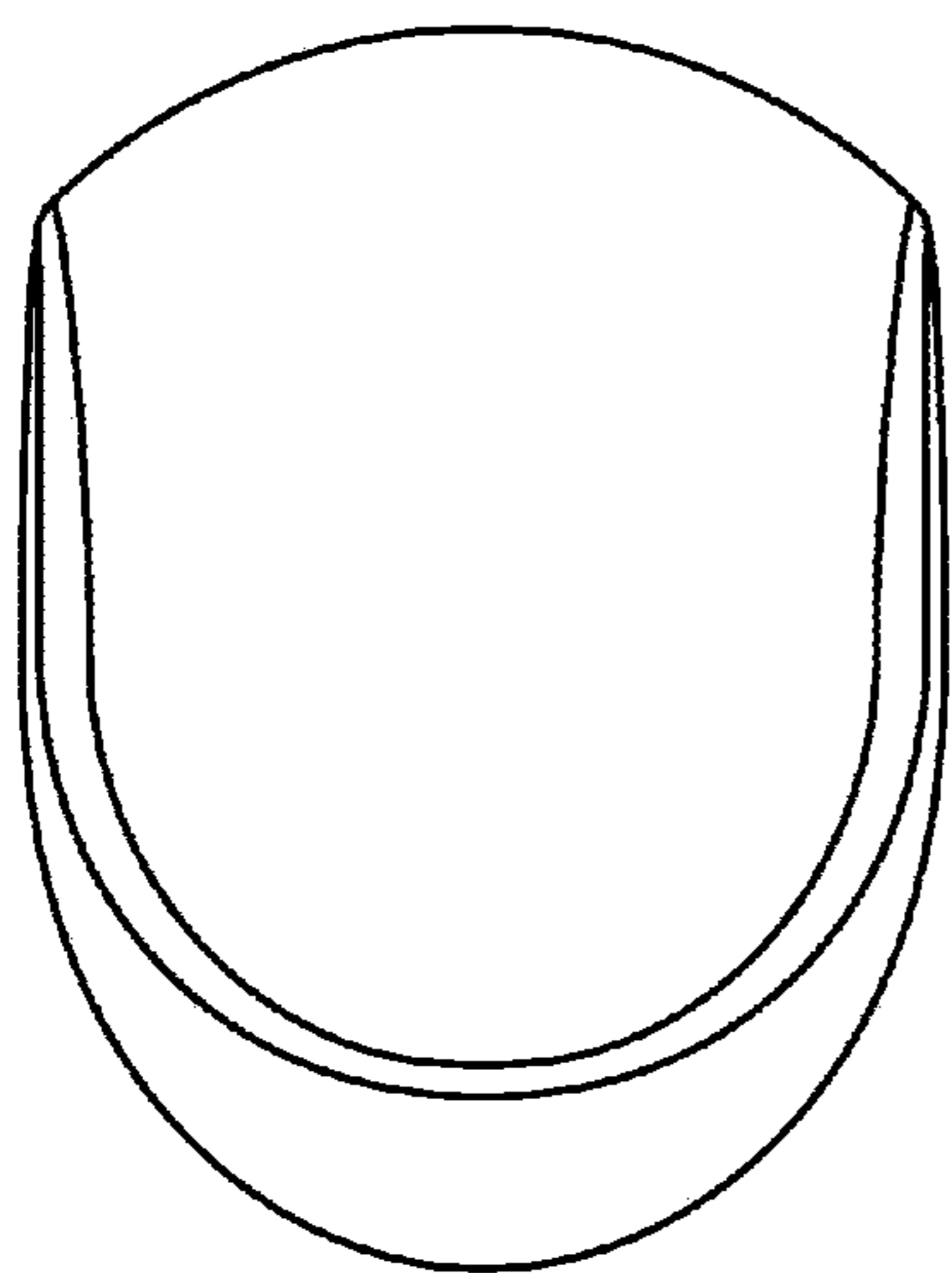

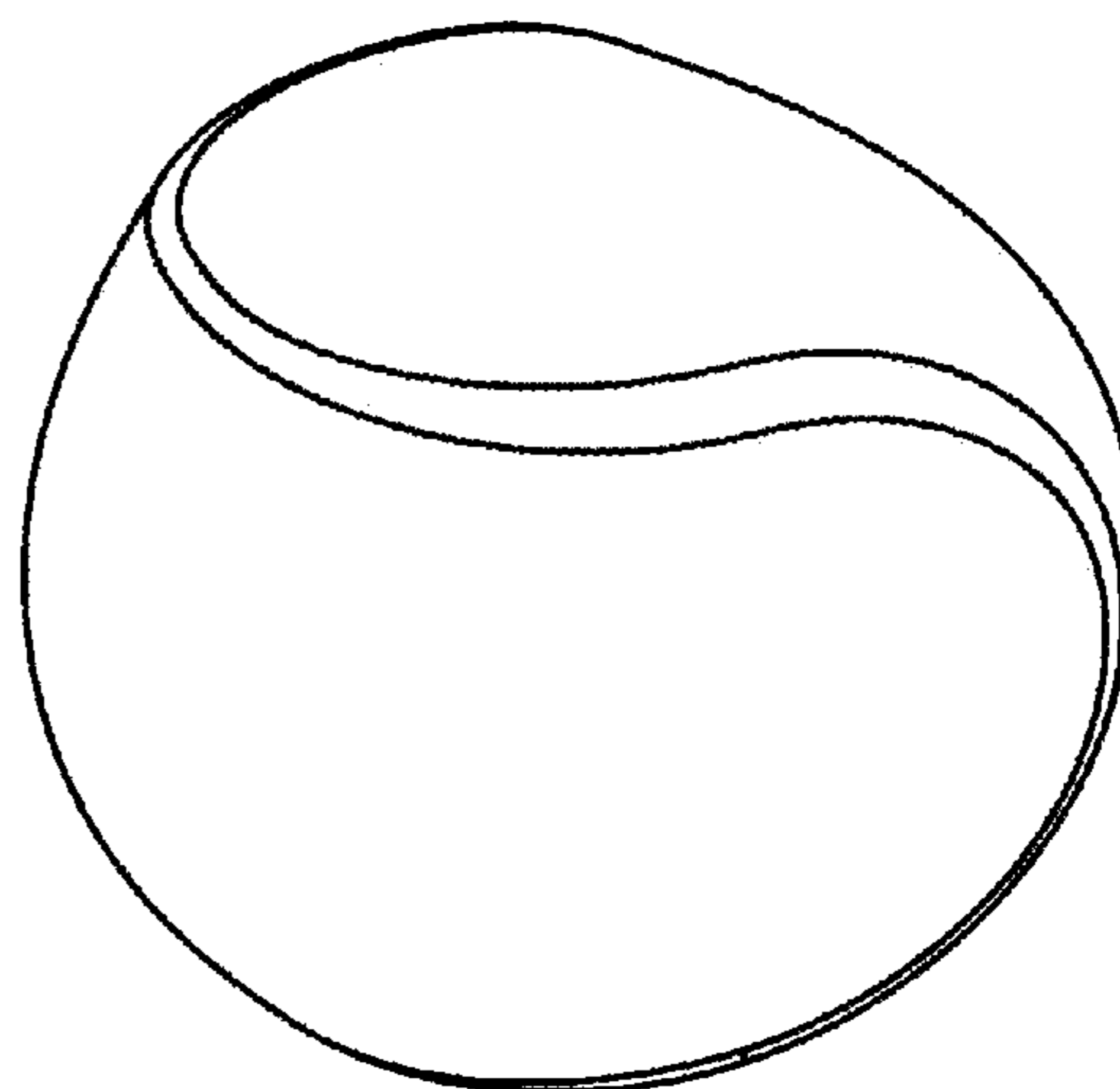

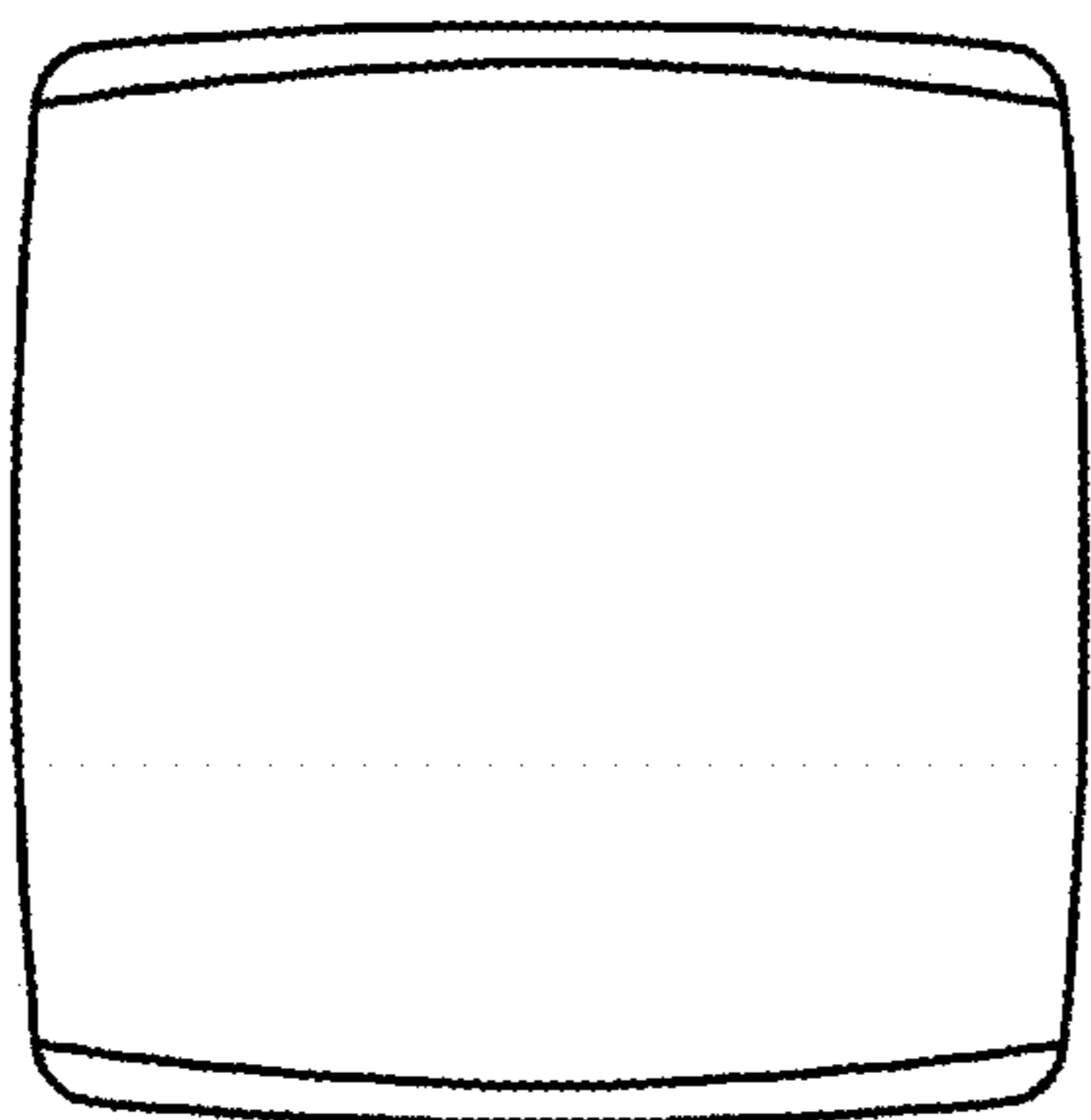

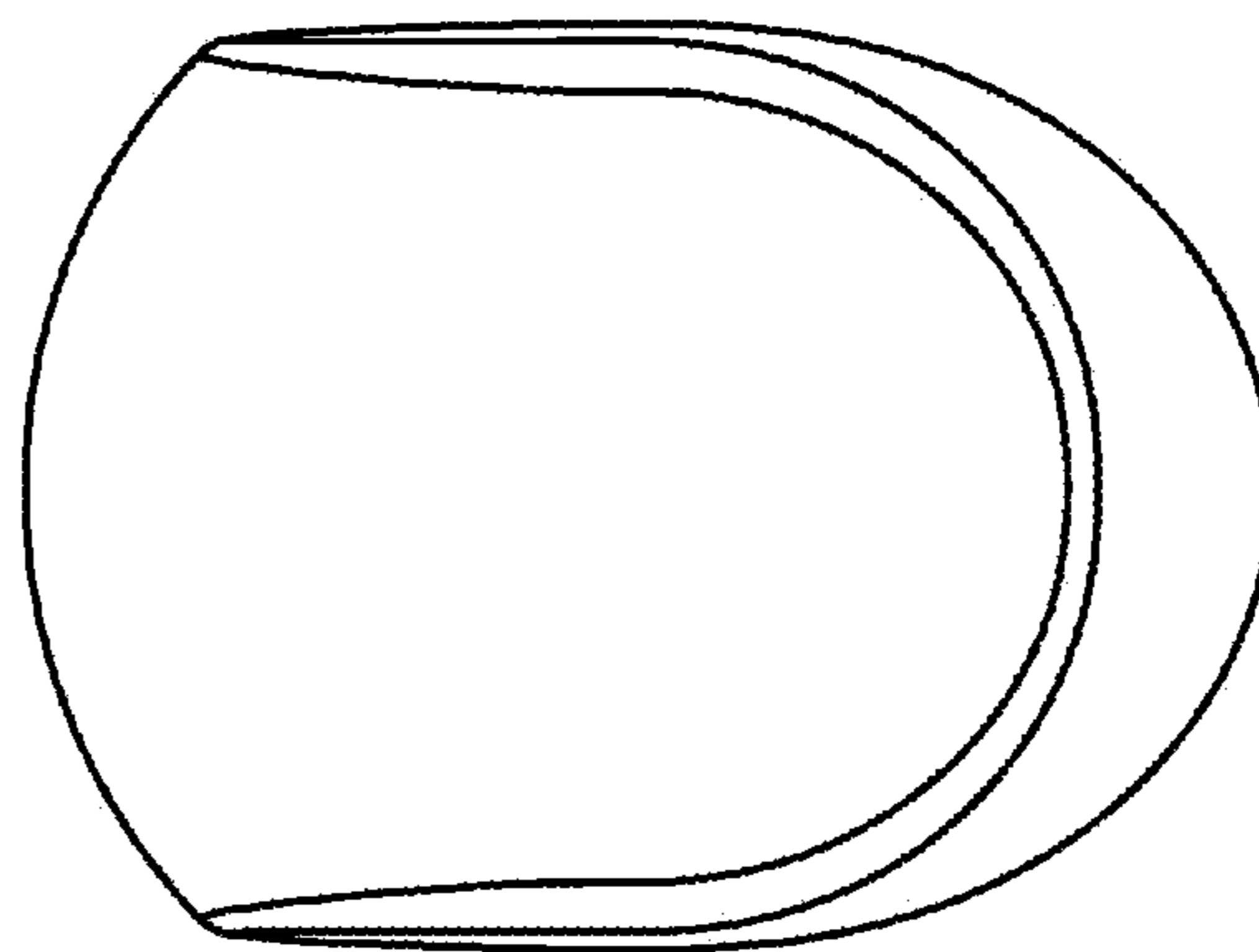

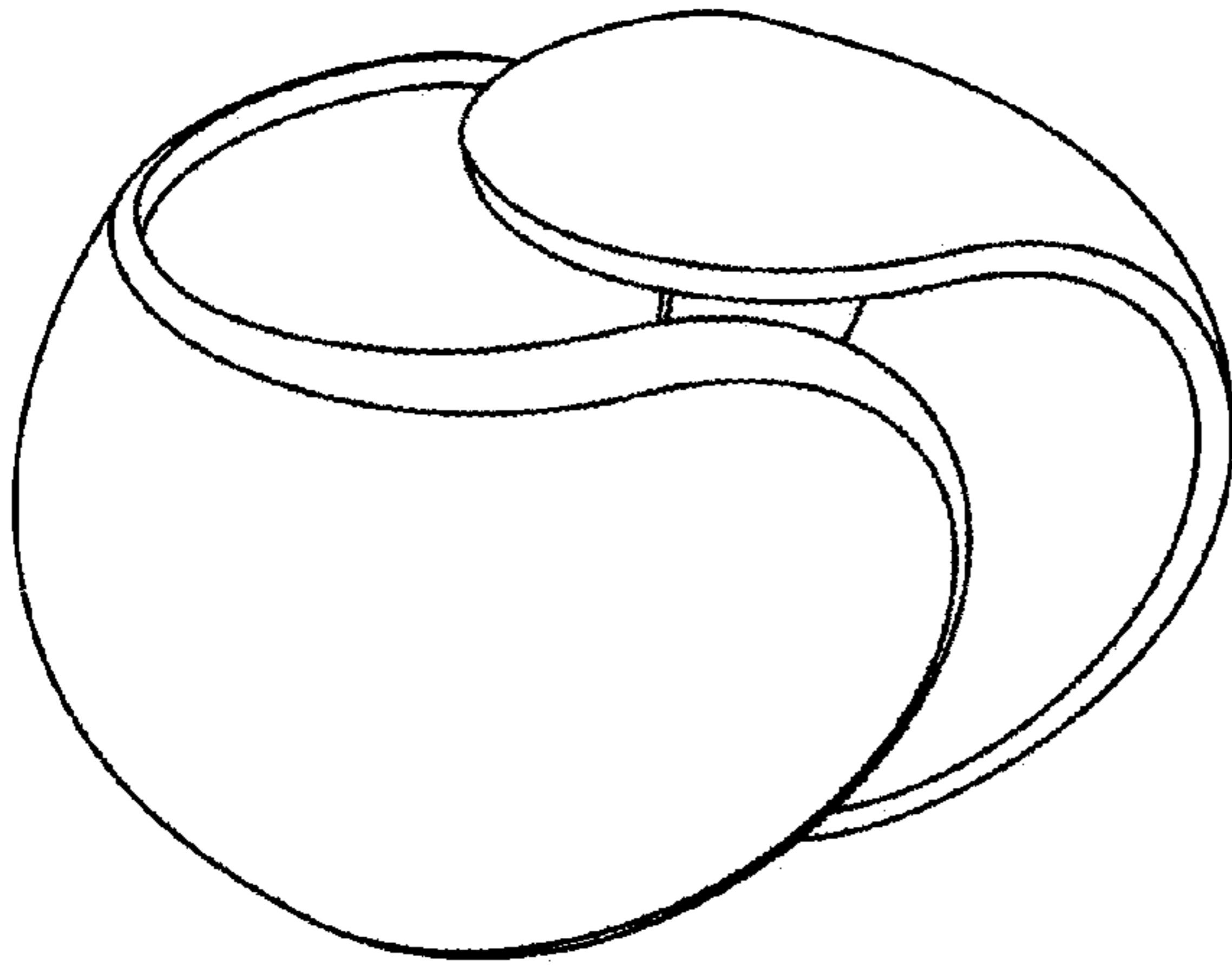

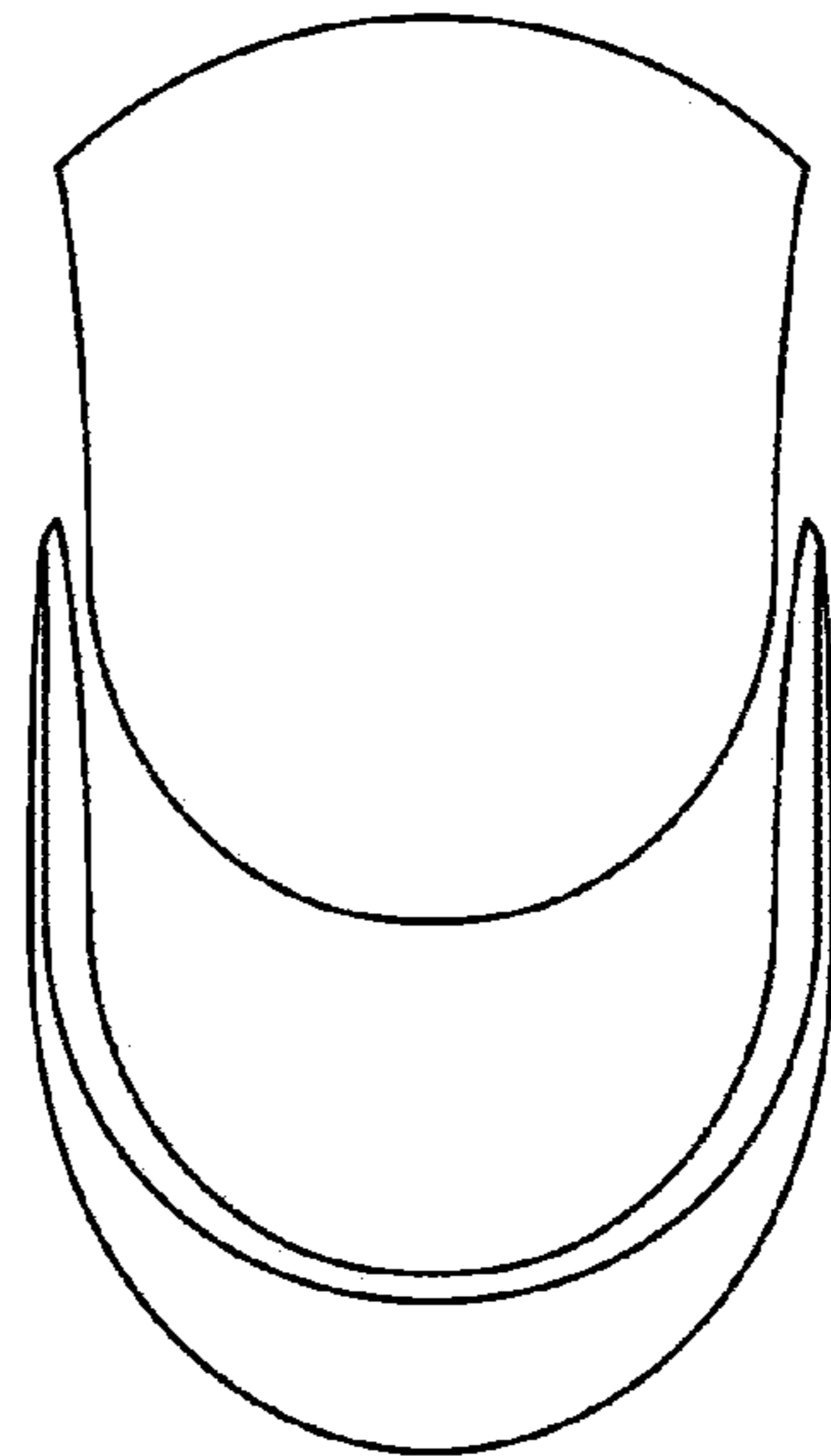

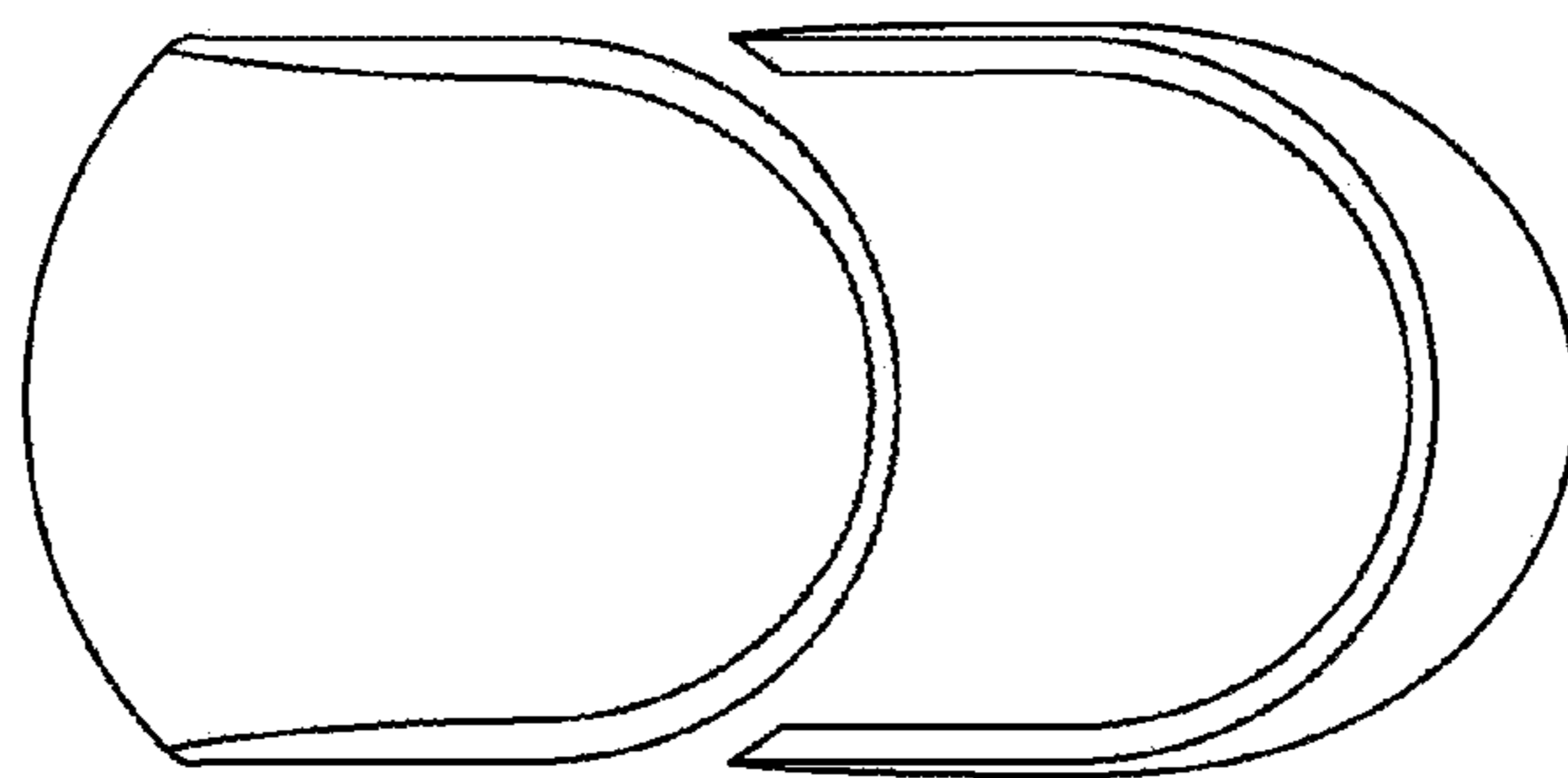
