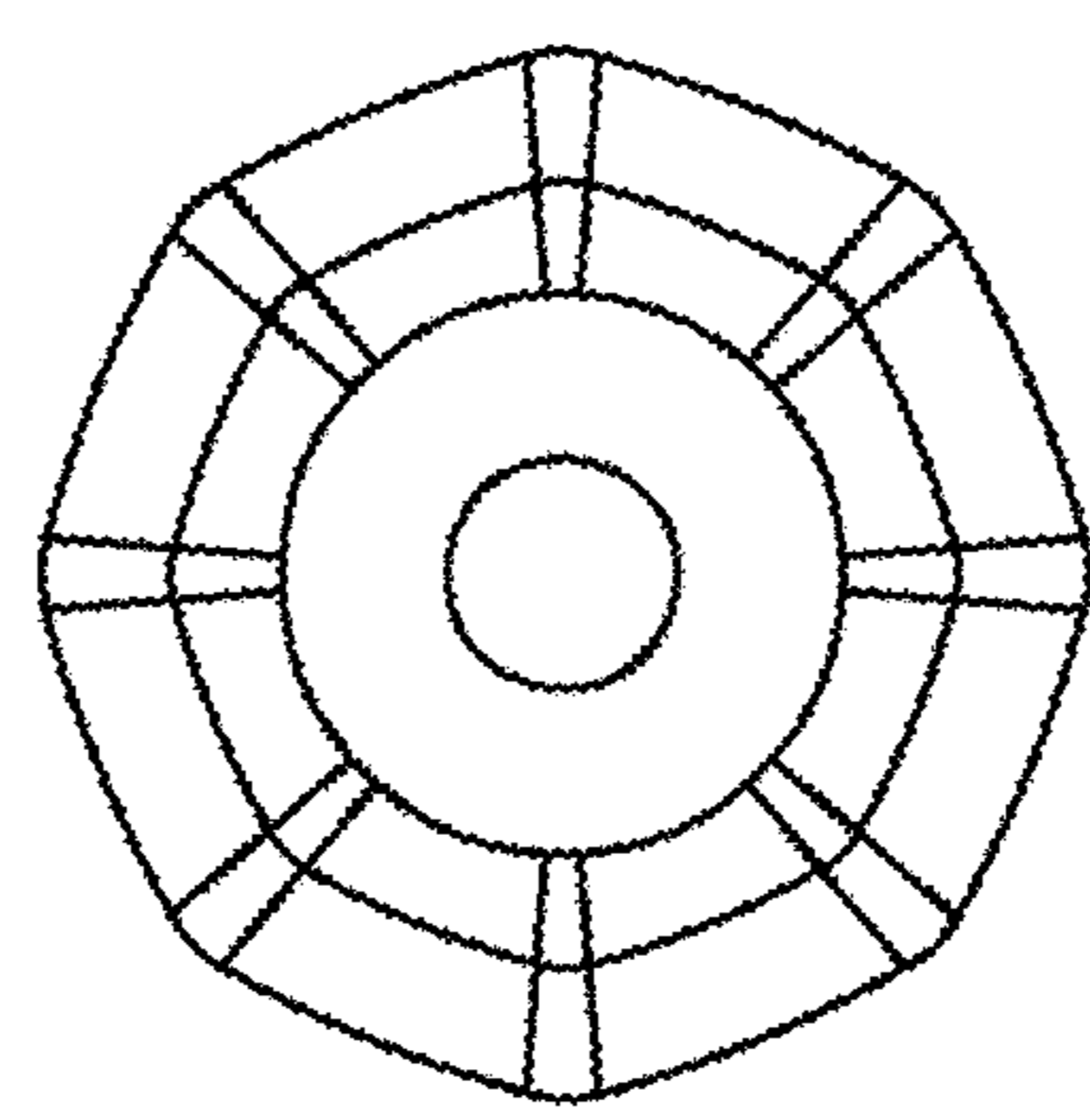
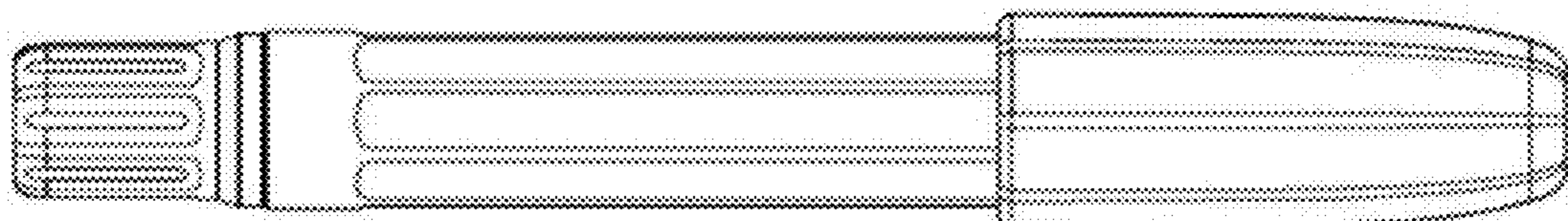

The ornamental design for a highlighter, as shown and described.

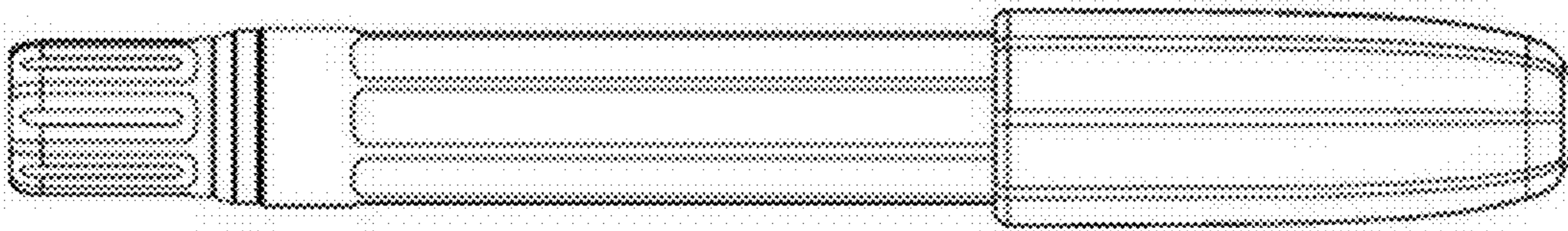
**DESCRIPTION**

- A highlighter used by removing the cap.

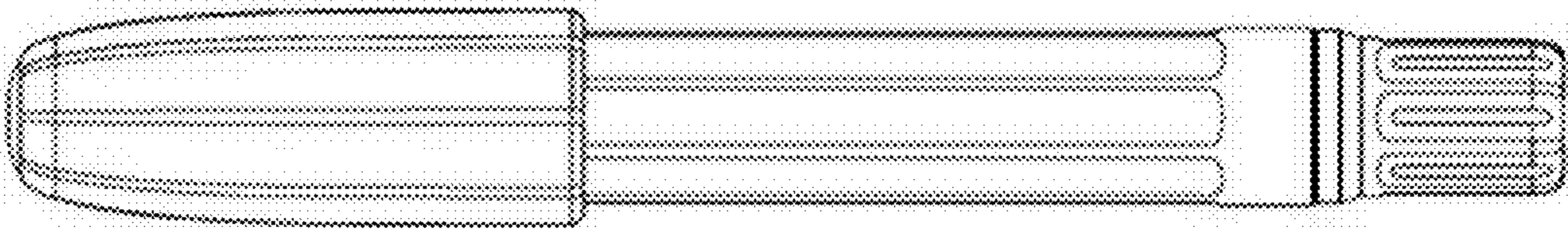

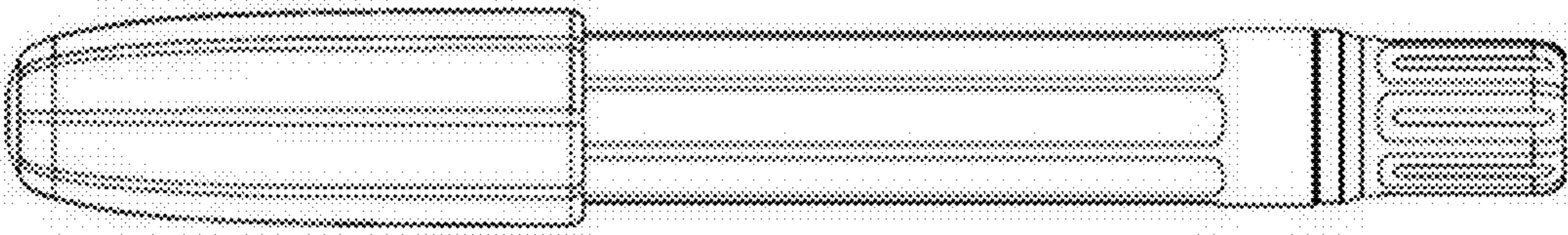

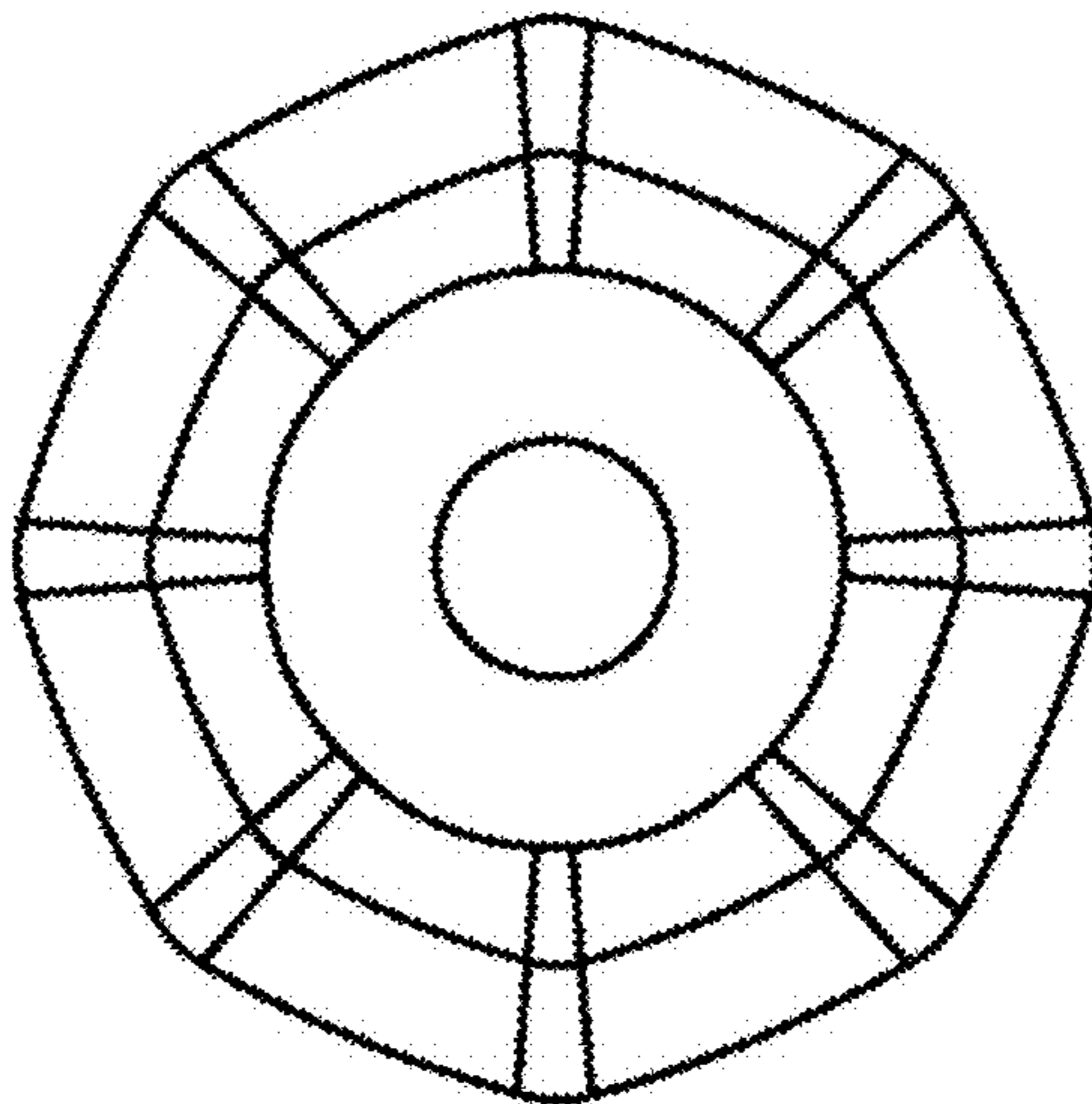

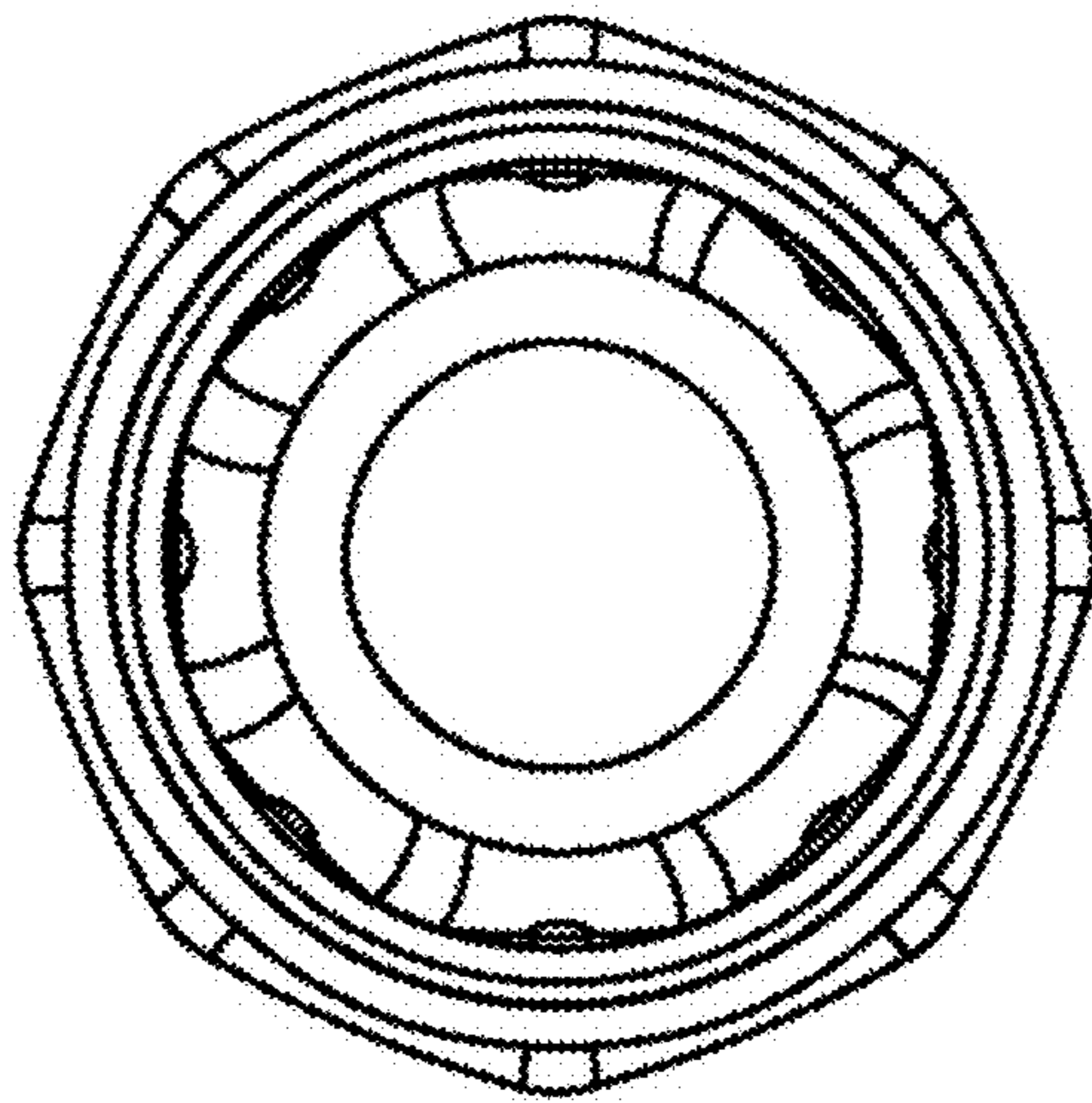

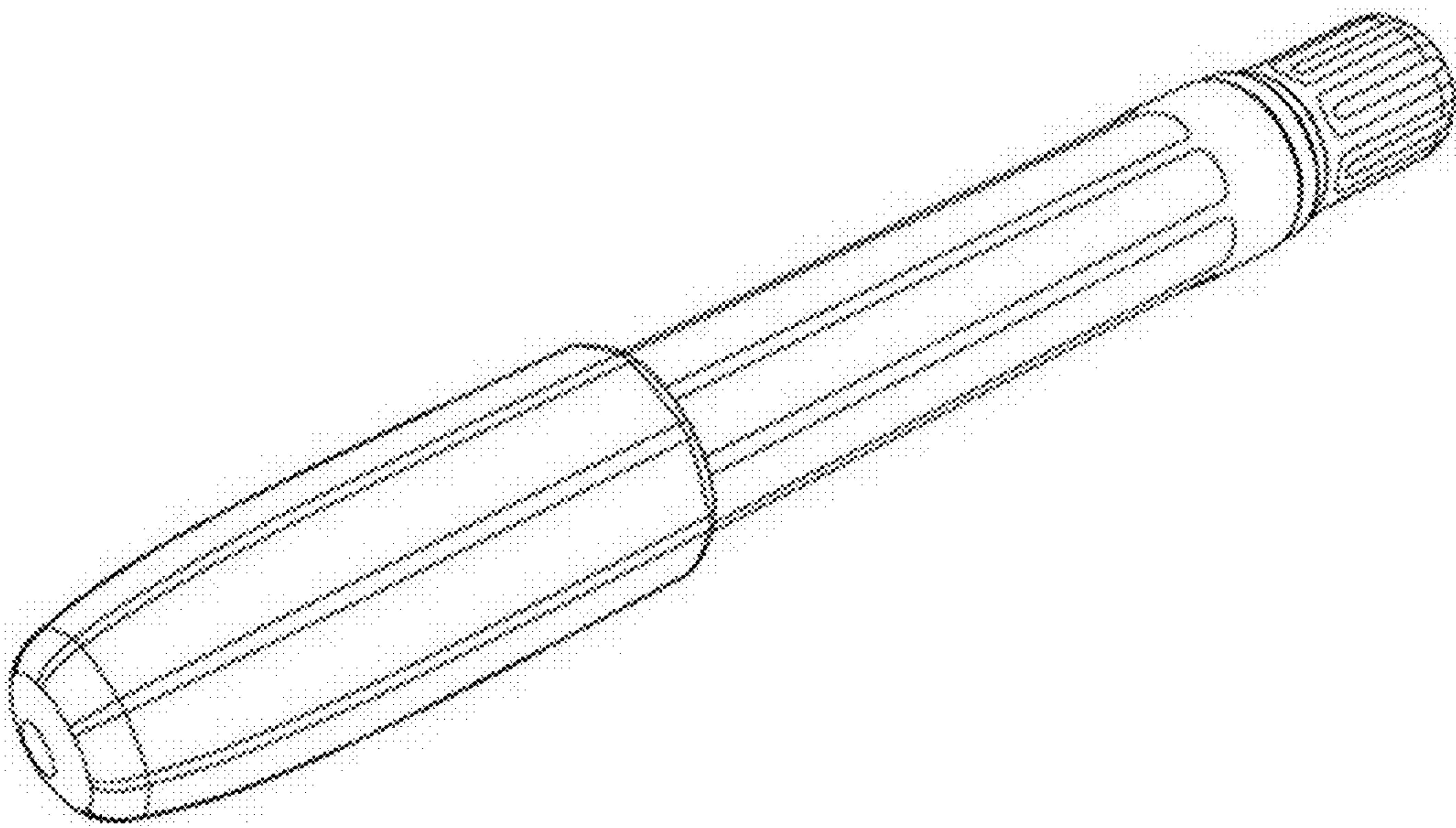
