The ornamental design for a martial arts stick, as shown and described.

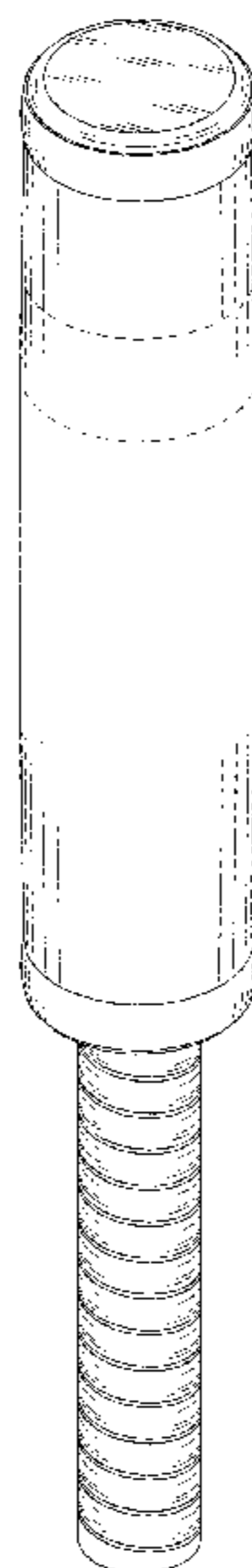
**DESCRIPTION**

FIG. 1 is a perspective view of martial arts stick;

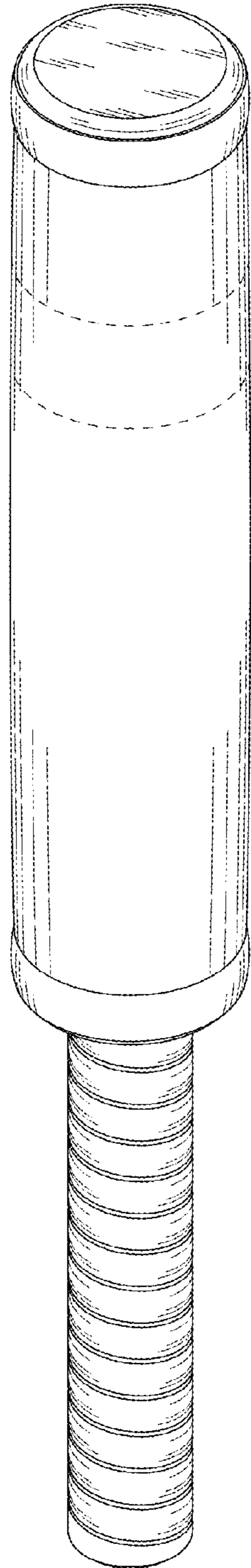

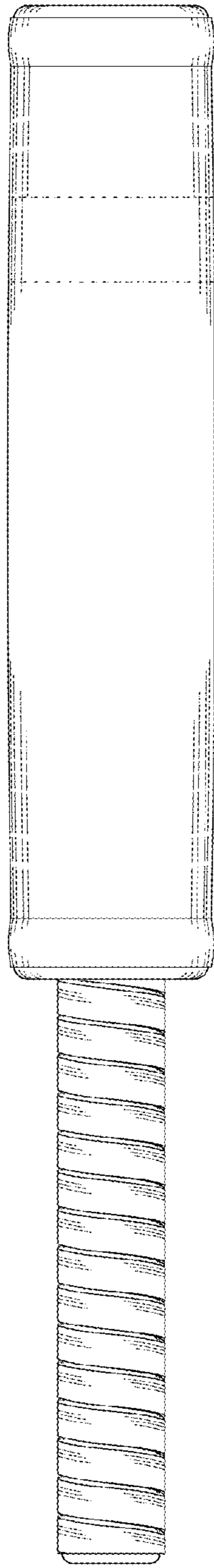

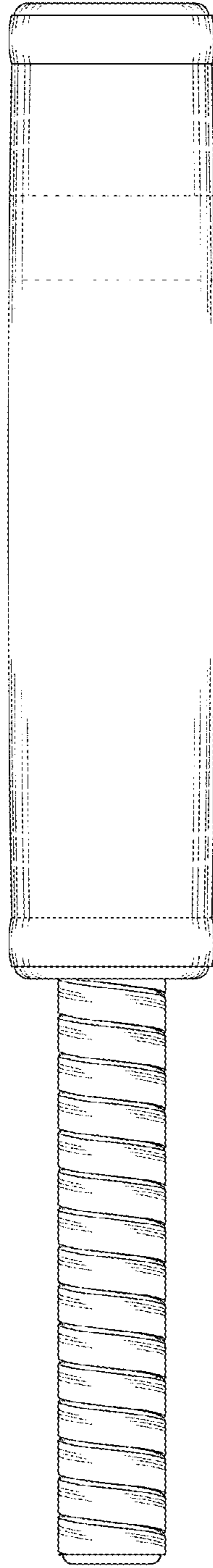

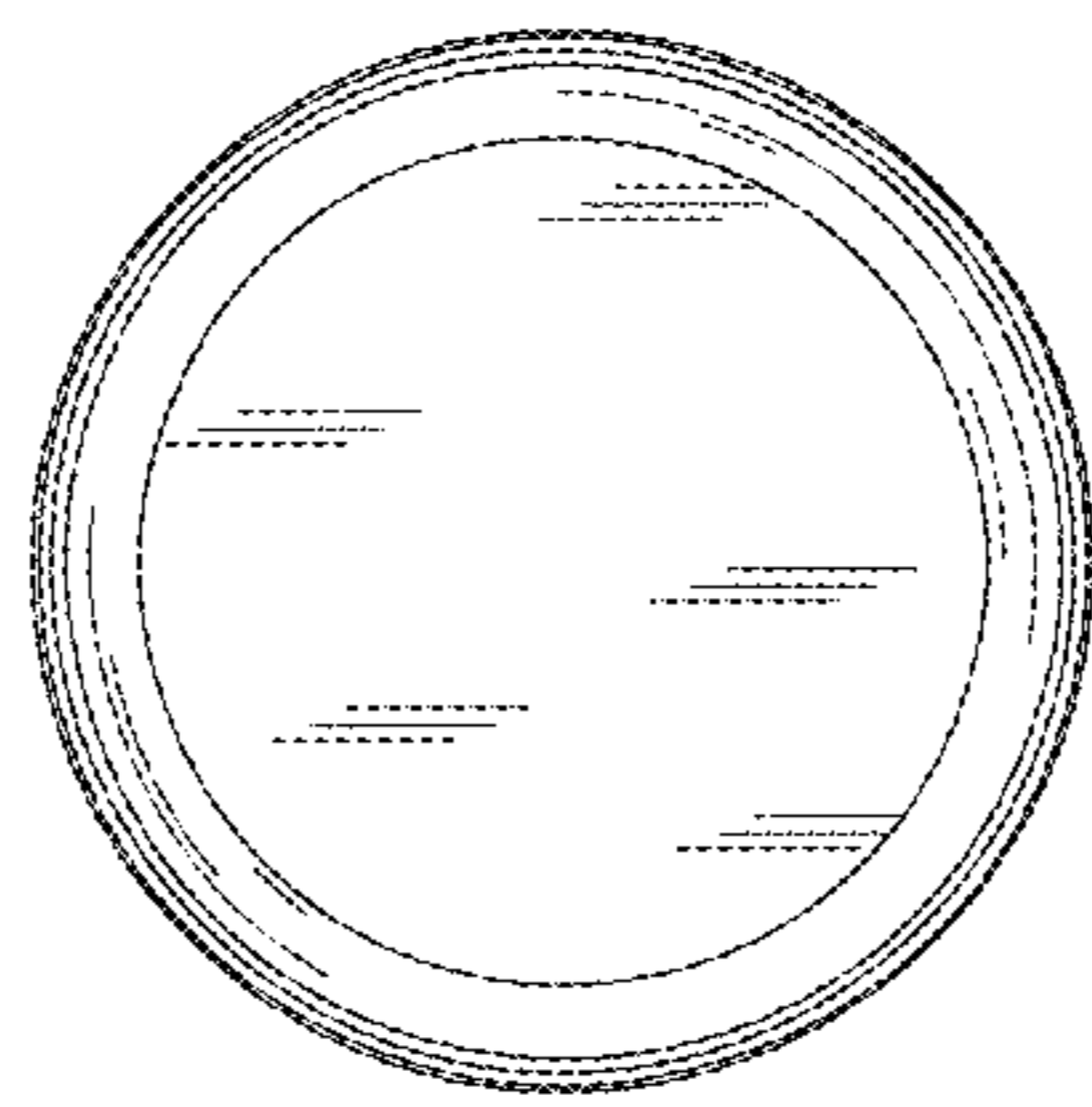

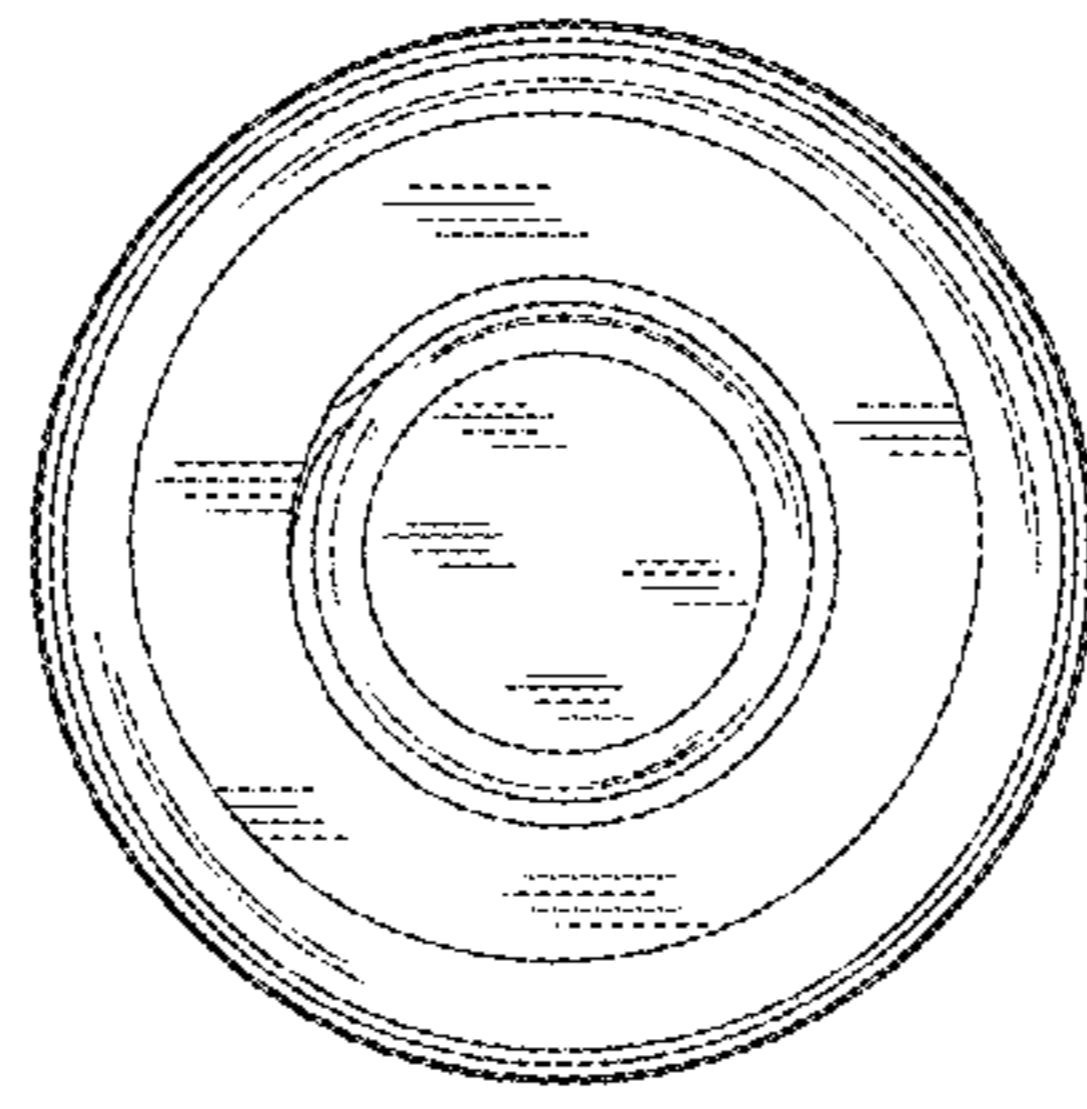
