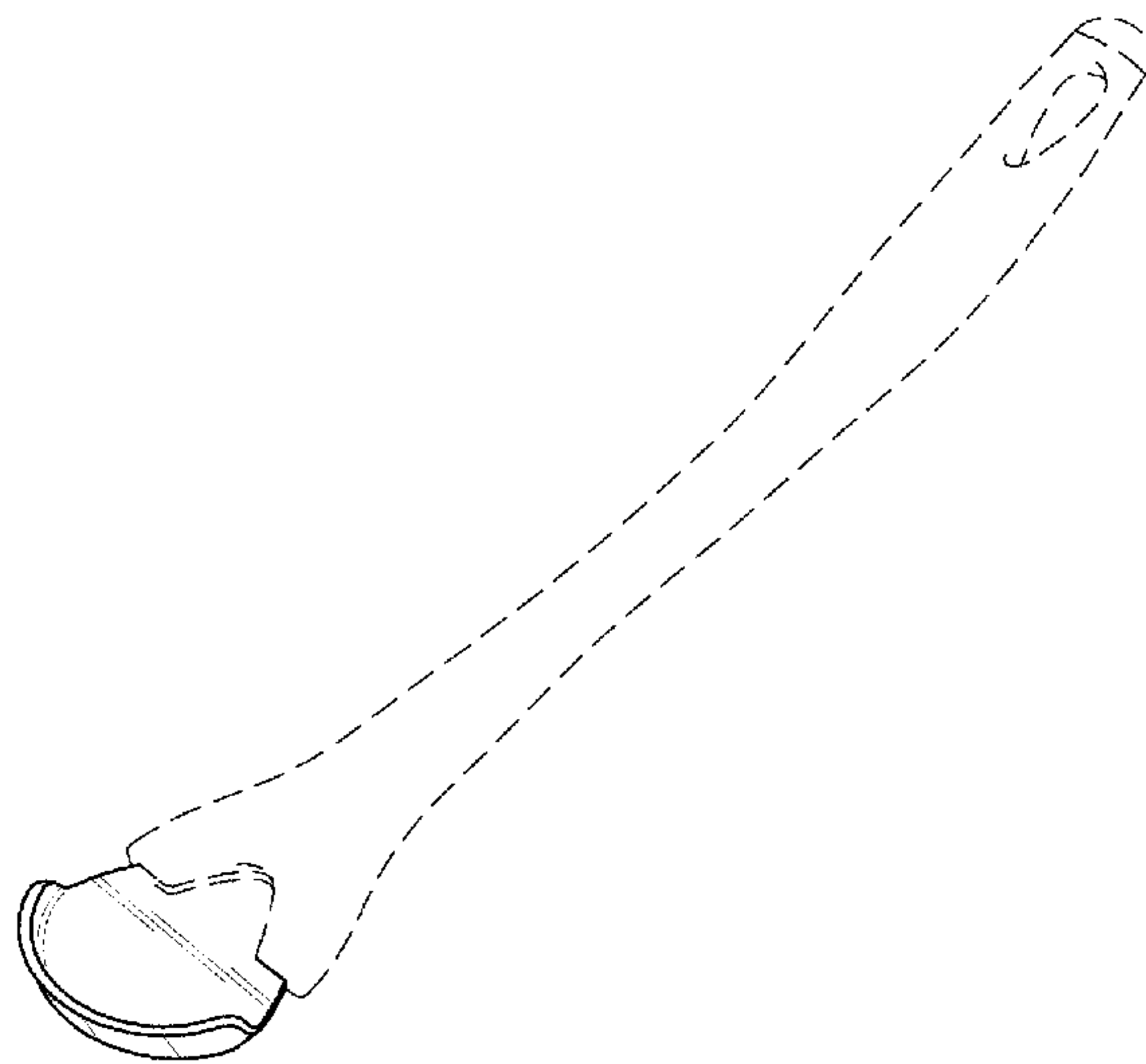
(57) **CLAIM**

The ornamental design for a tongue cleaning device, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a tongue cleaning device showing our new design;  
FIG. 2 is a bottom perspective thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a left side view thereof; the right side view being a mirror image thereof;  
FIG. 5 is a bottom plan view thereof;  
FIG. 6 is a front elevation view thereof; and,  
FIG. 7 is a rear elevation view thereof.

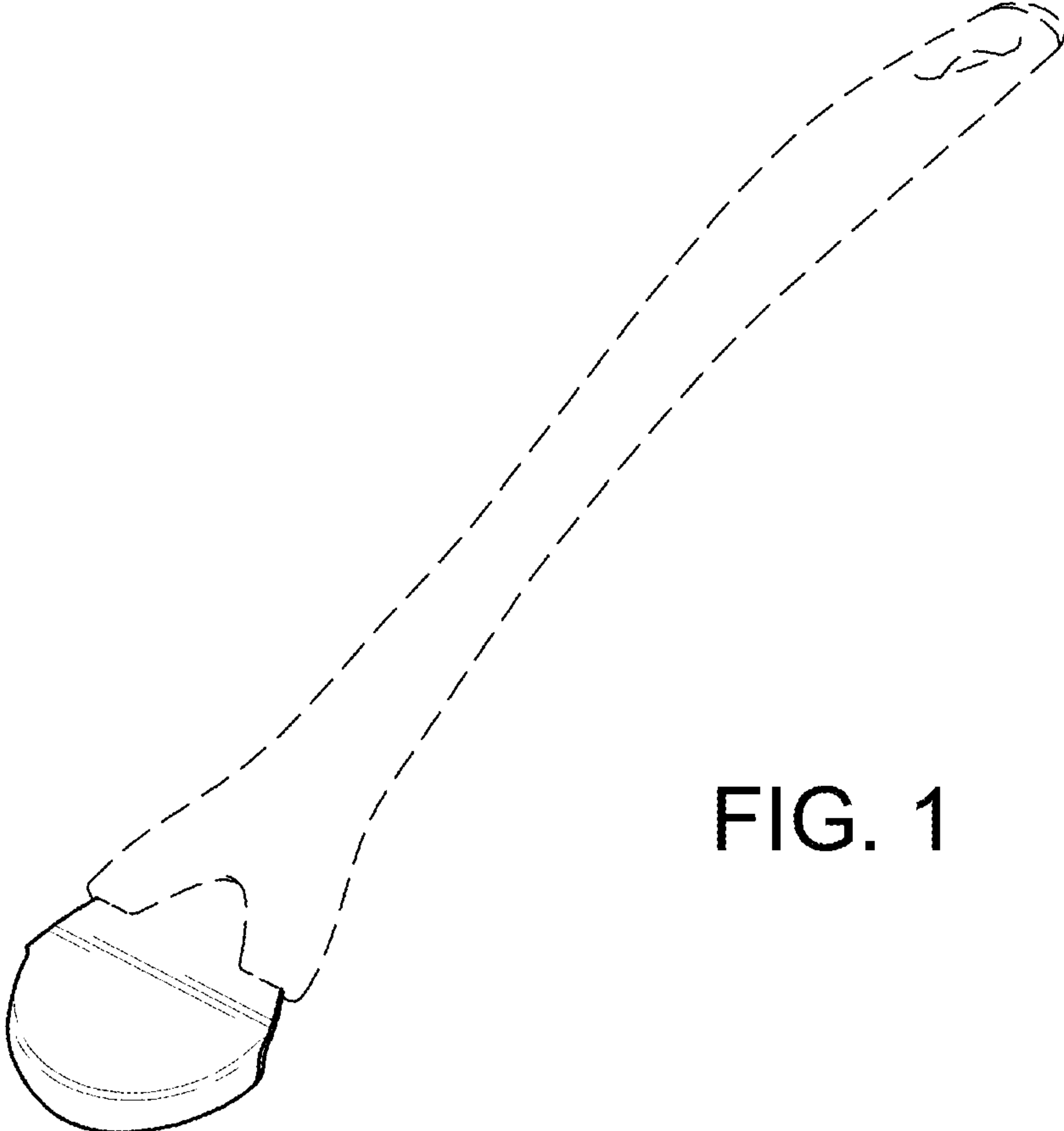

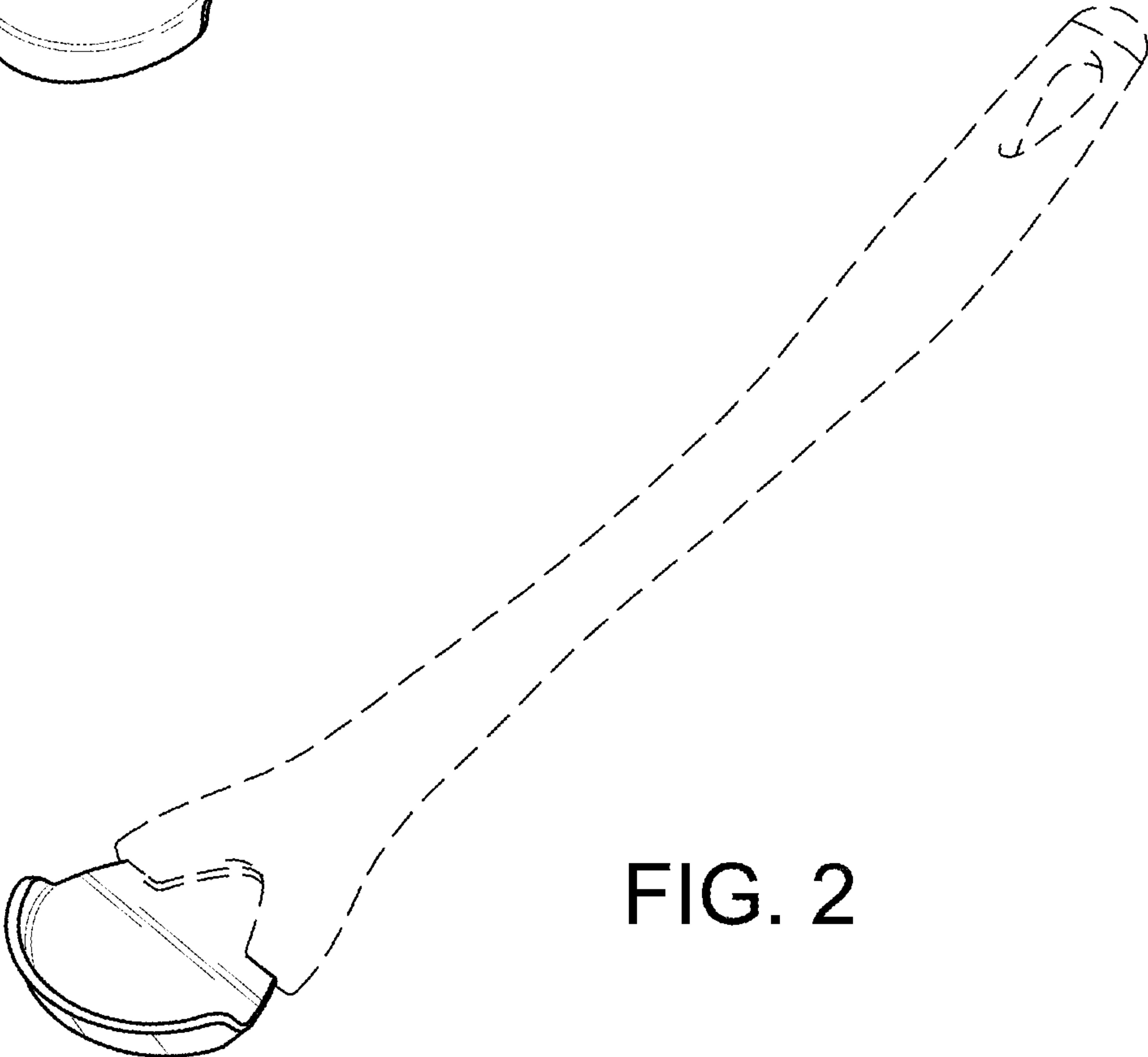

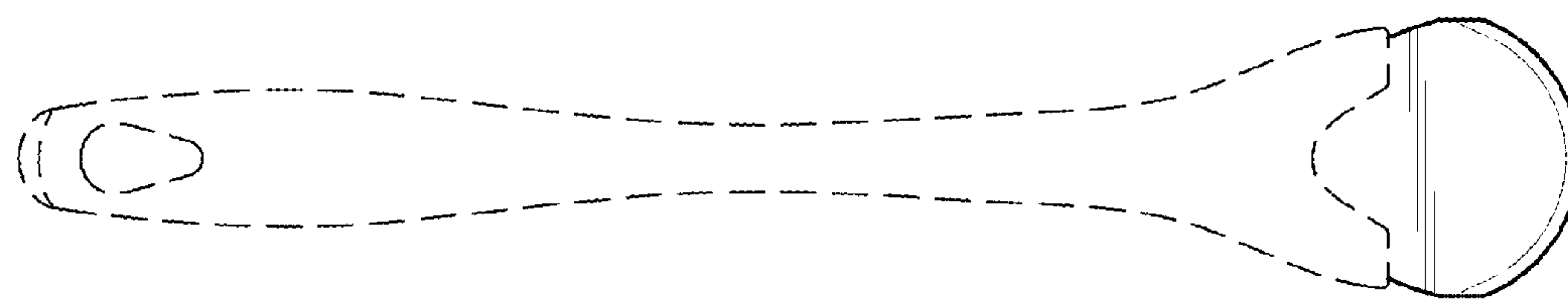

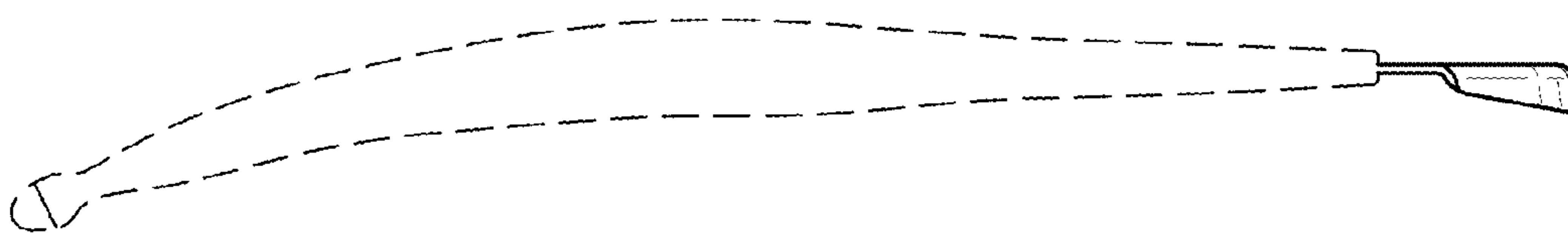

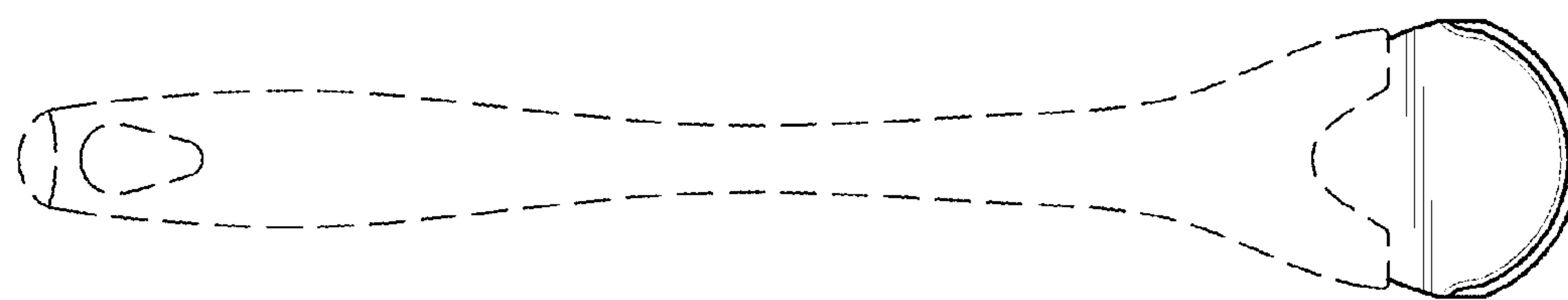

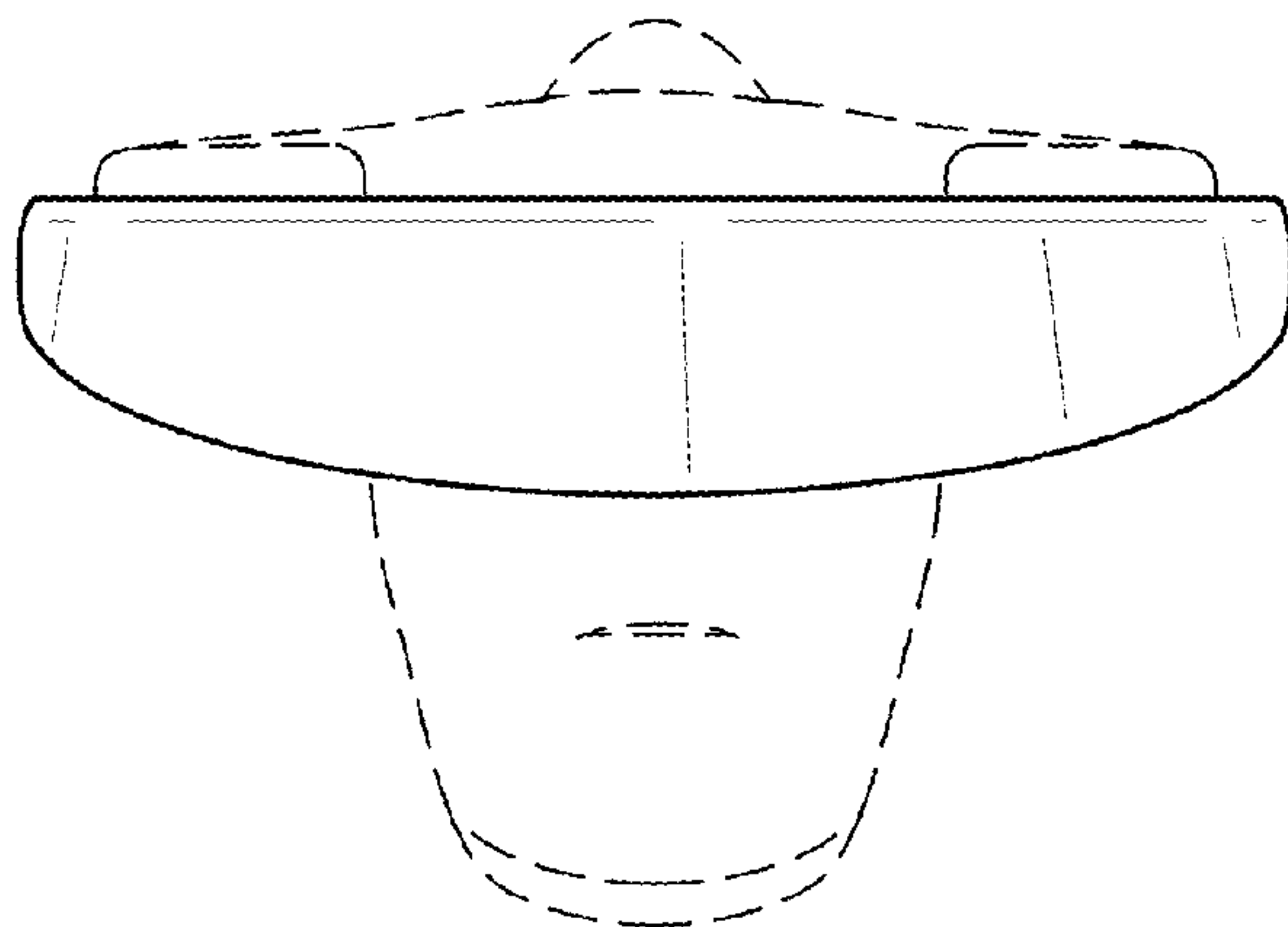

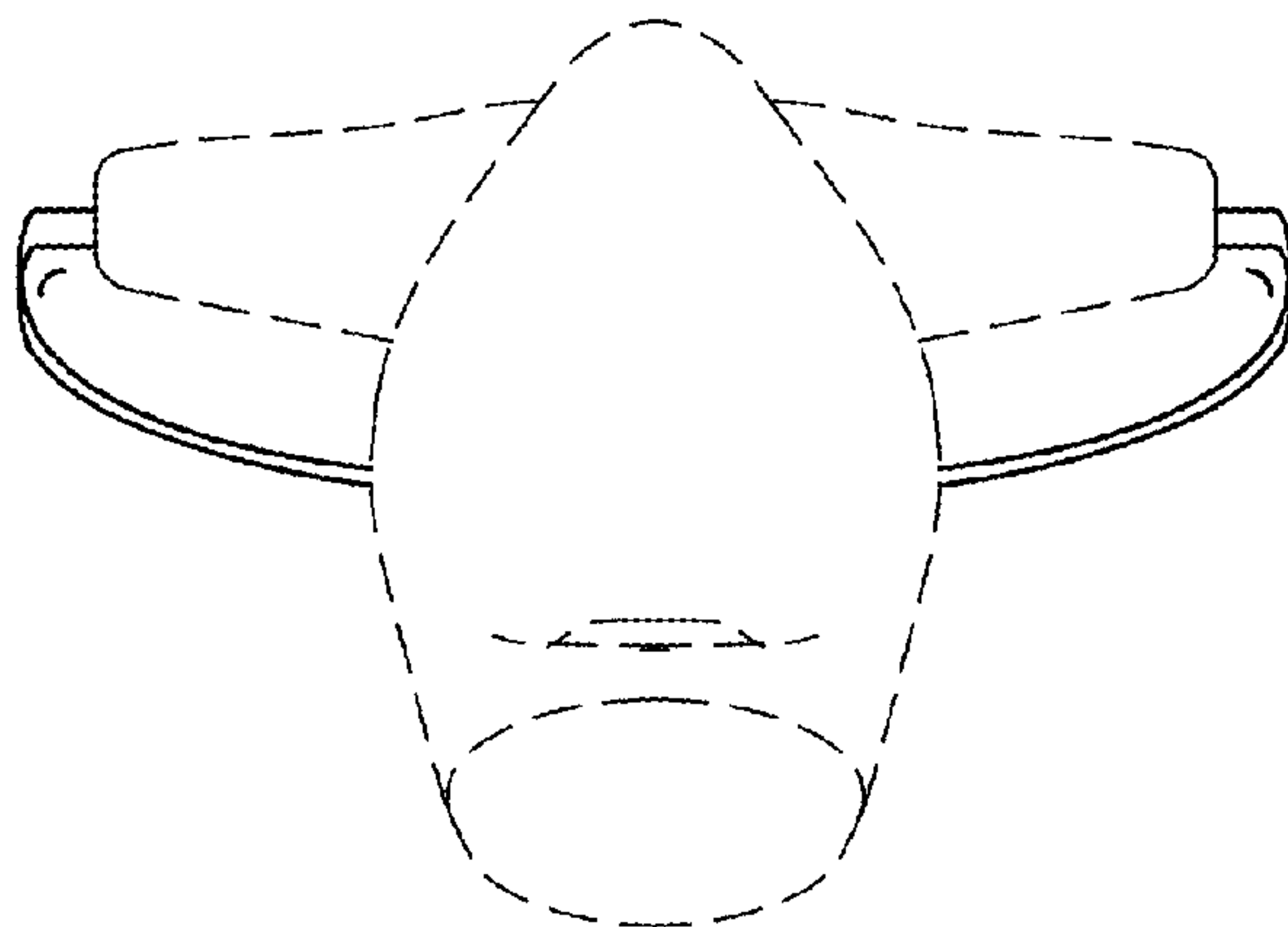
