DESCRIPTION

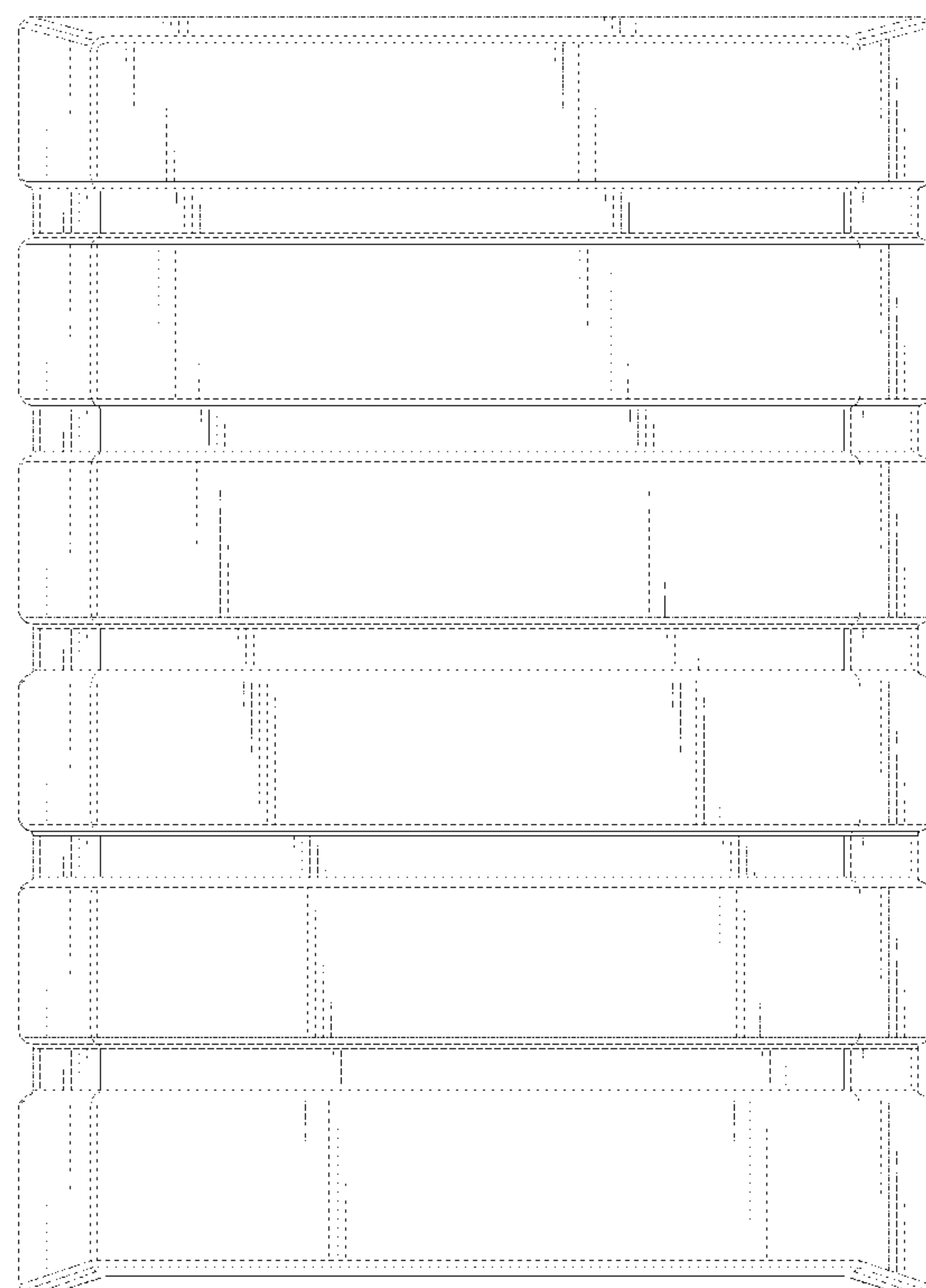
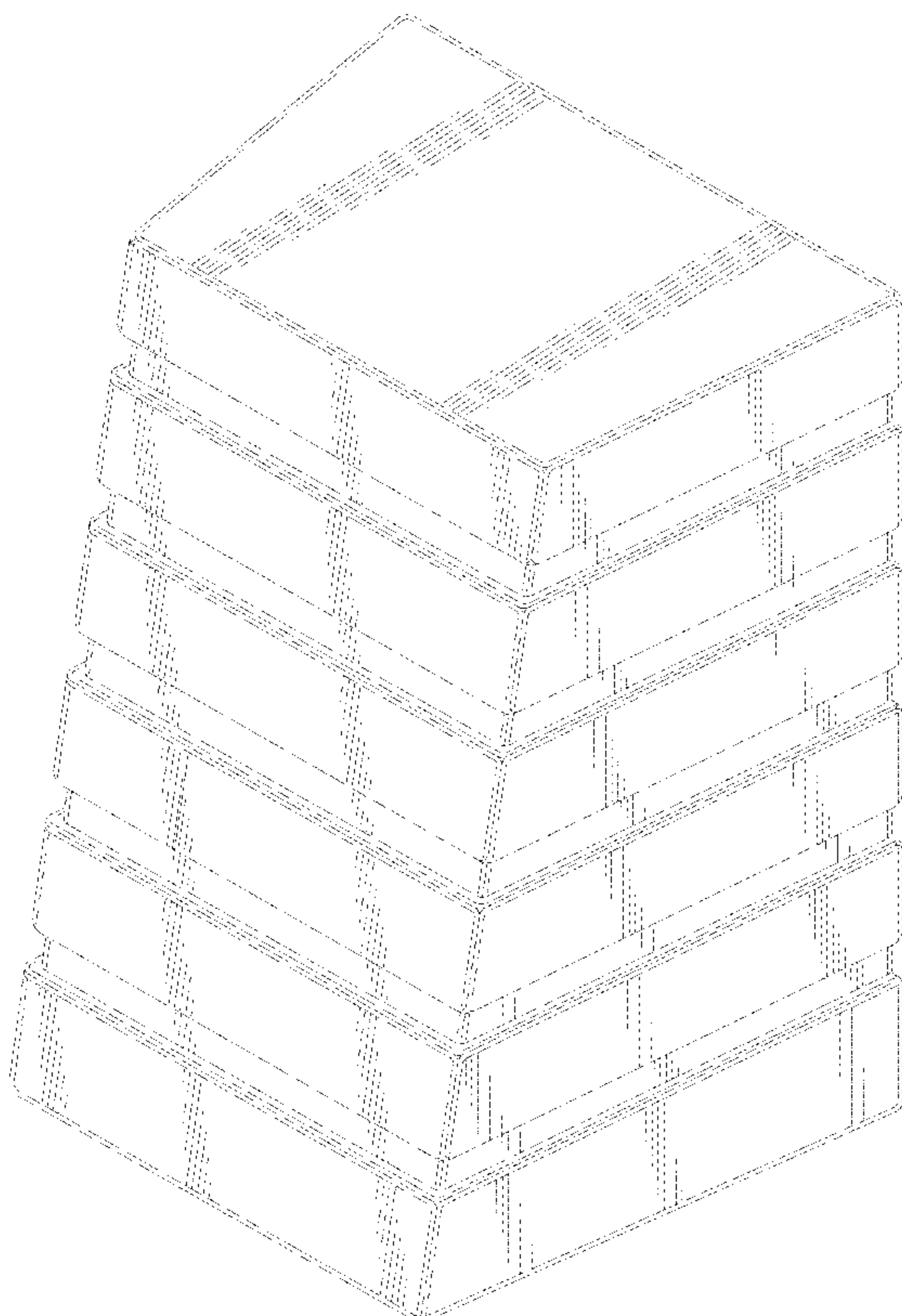

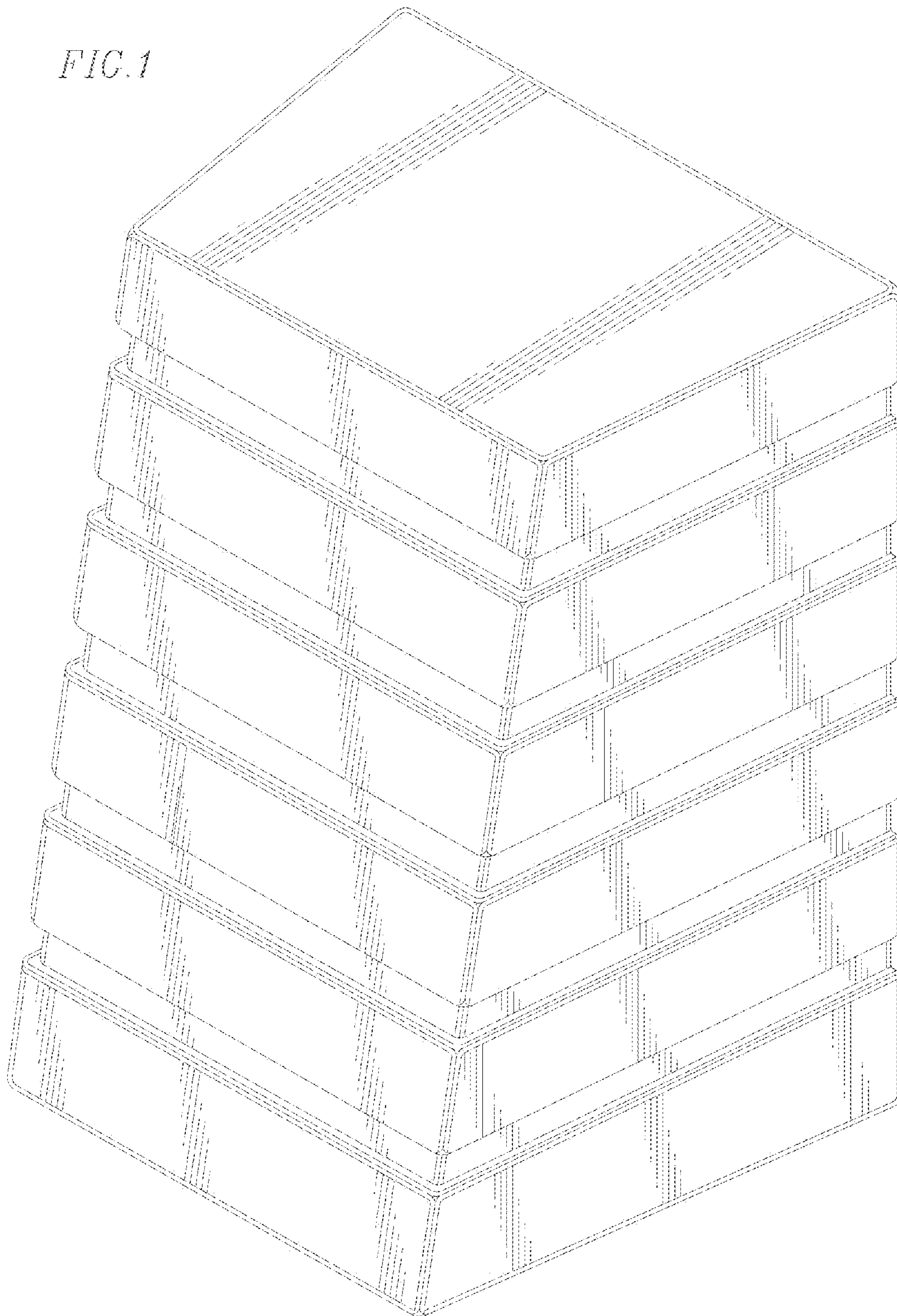

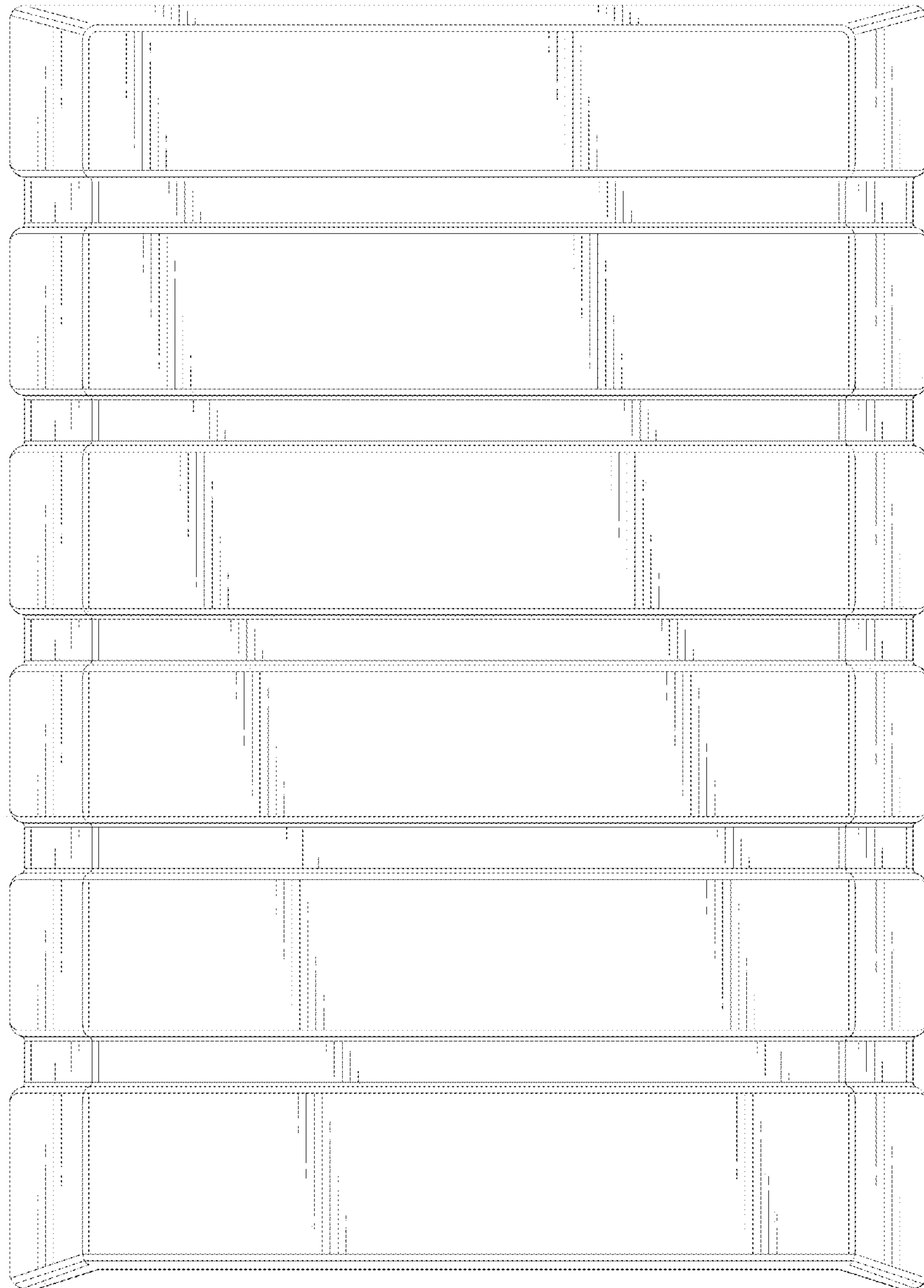

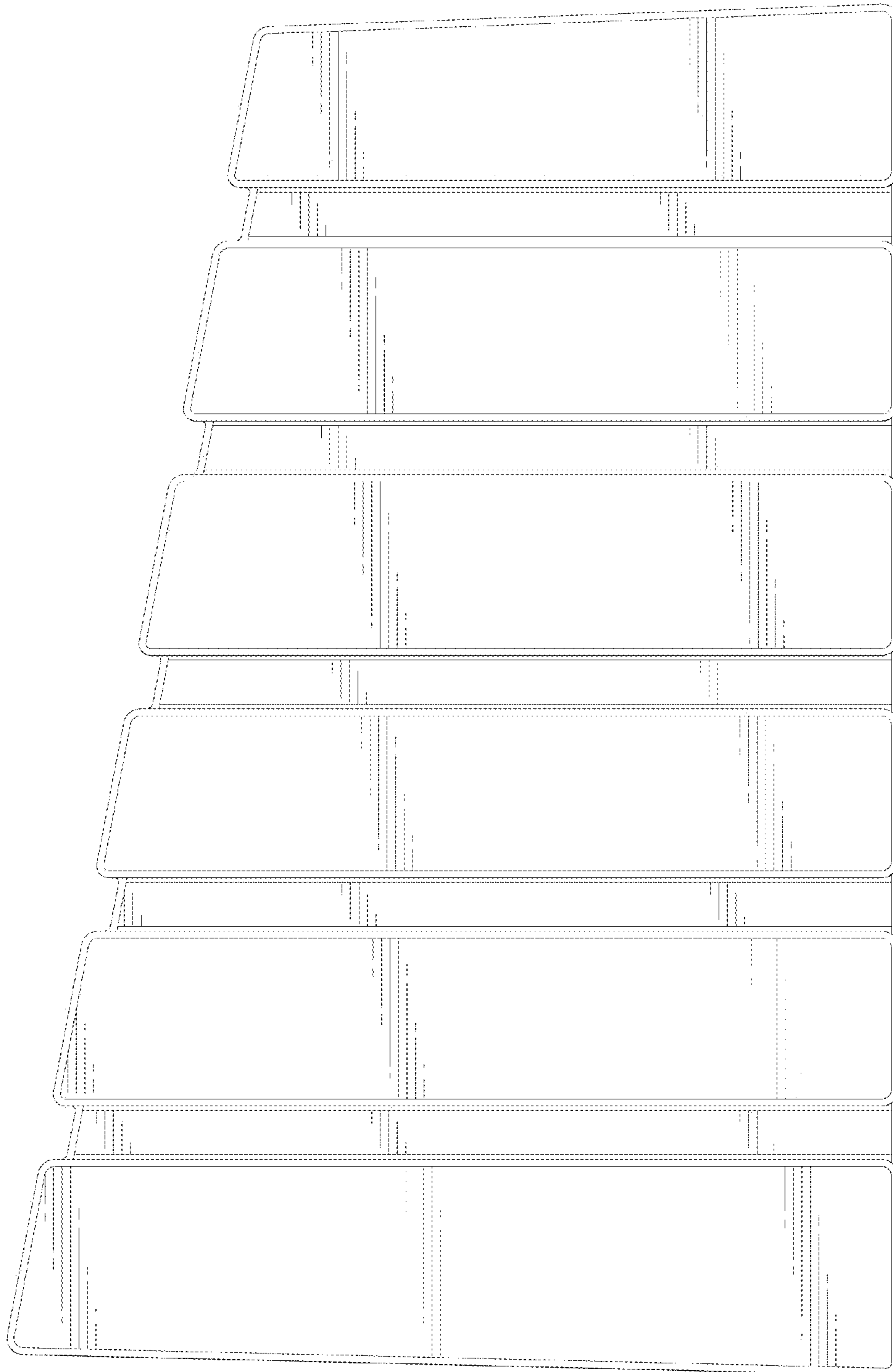

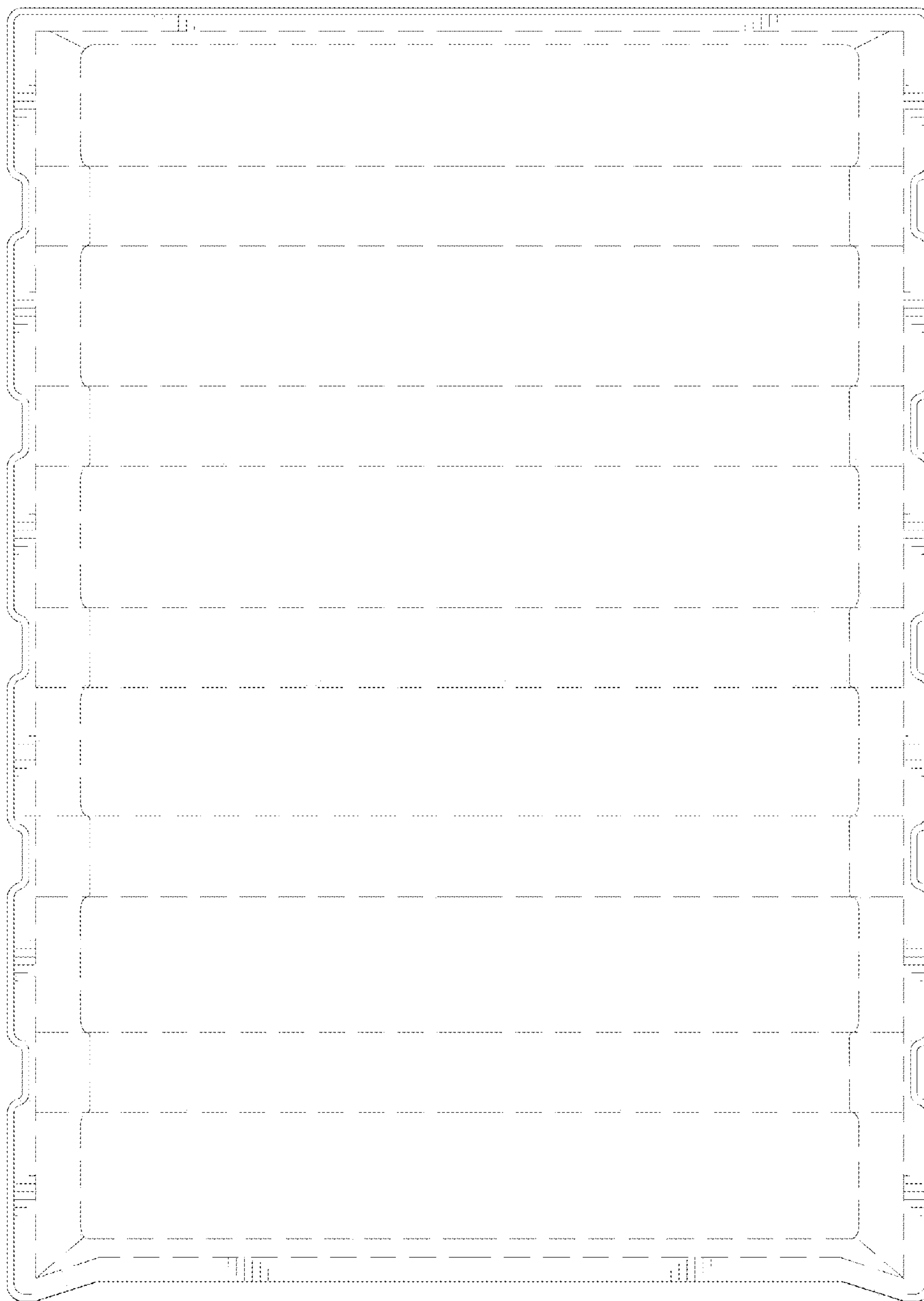

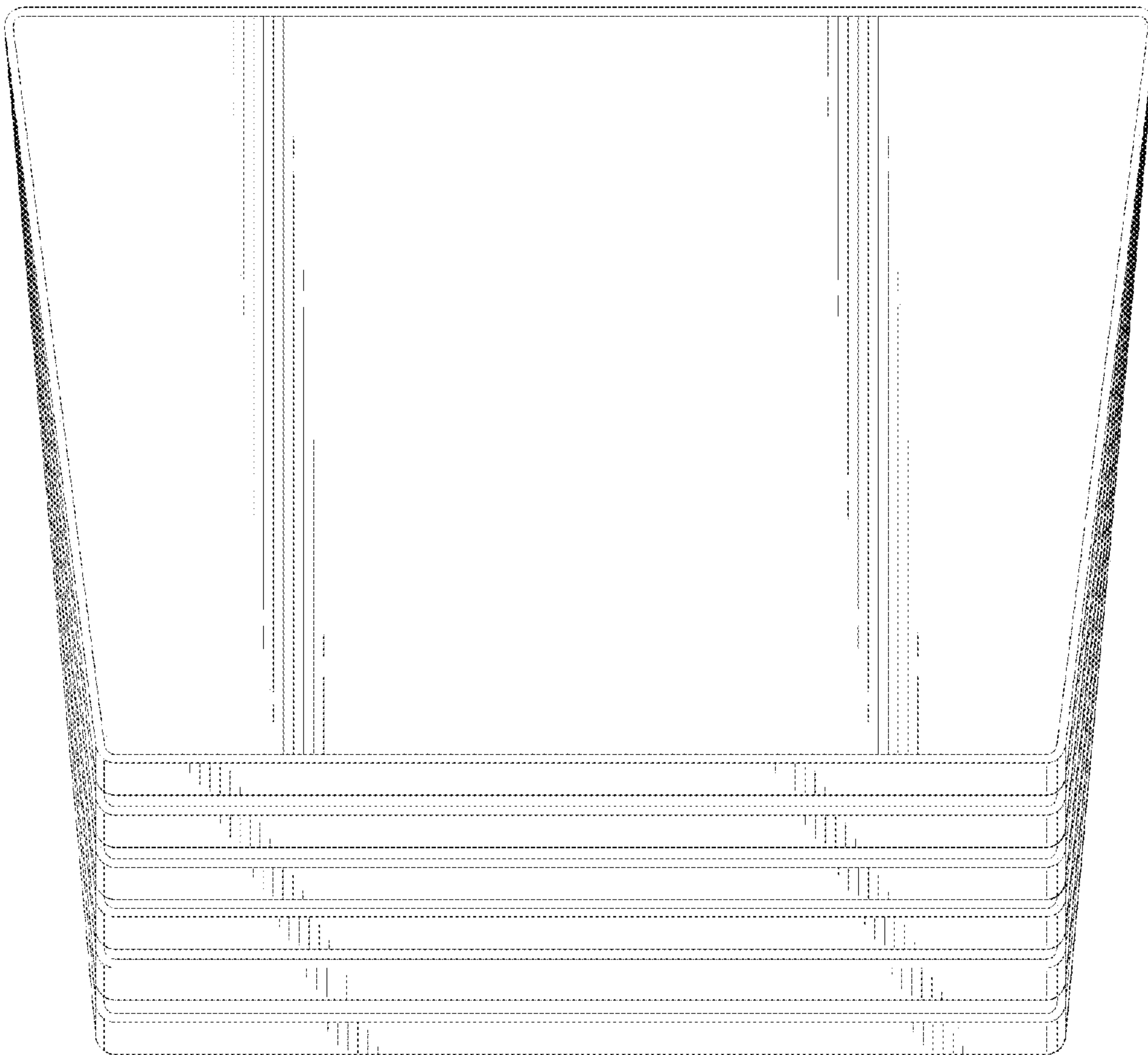
