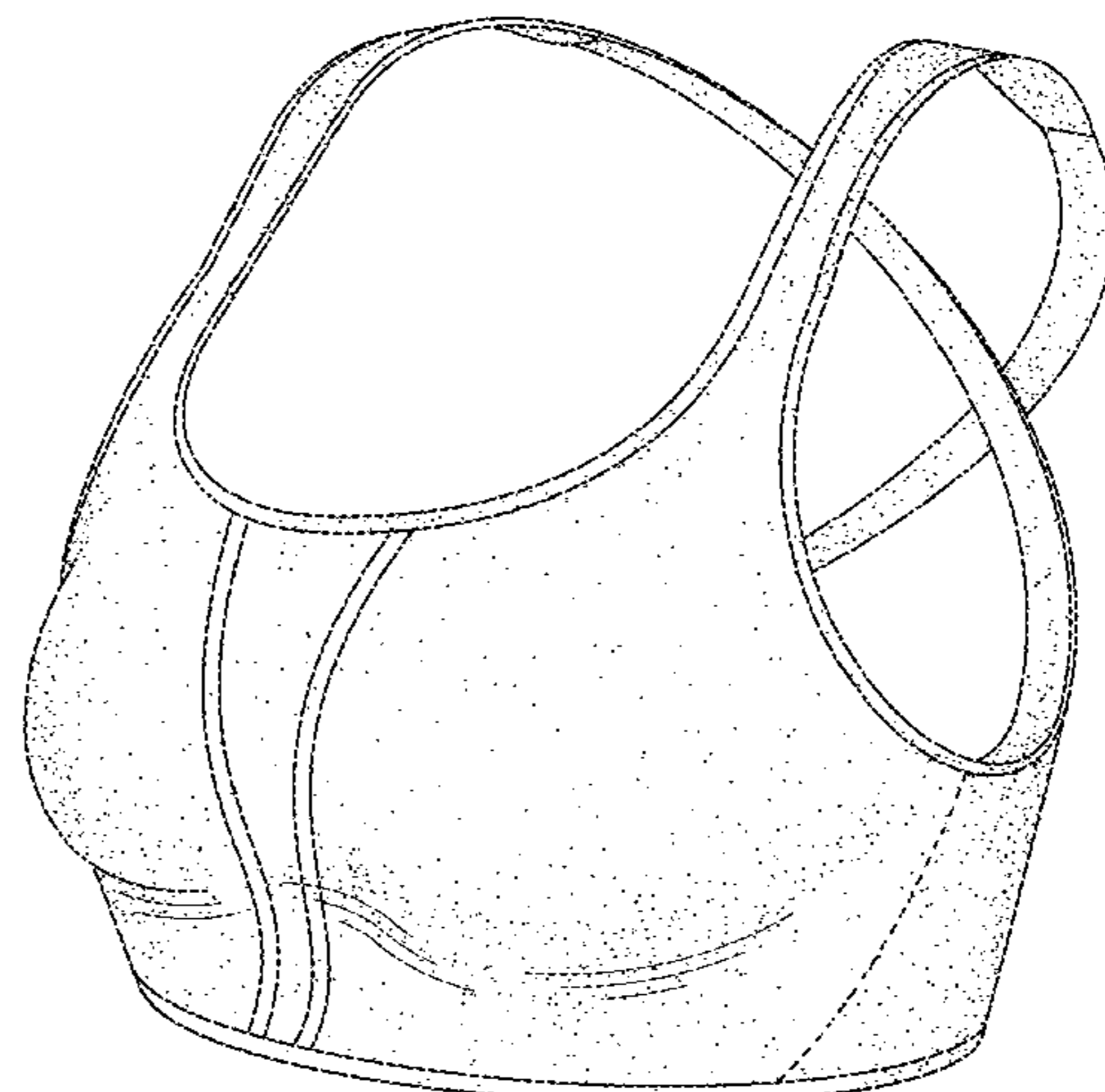
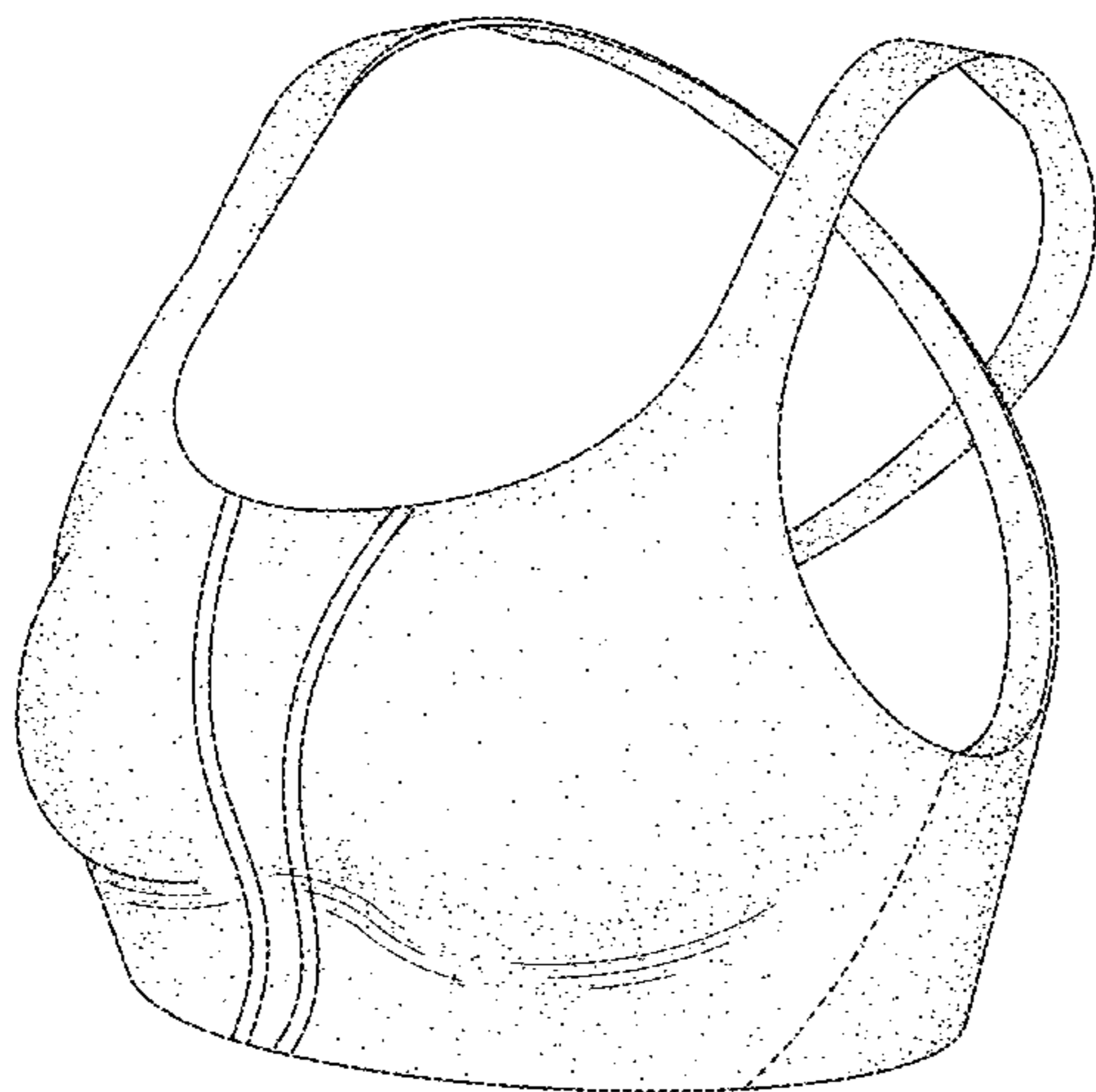
(57) **CLAIM**

The ornamental design for a brassiere, as shown and described.

**DESCRIPTION**

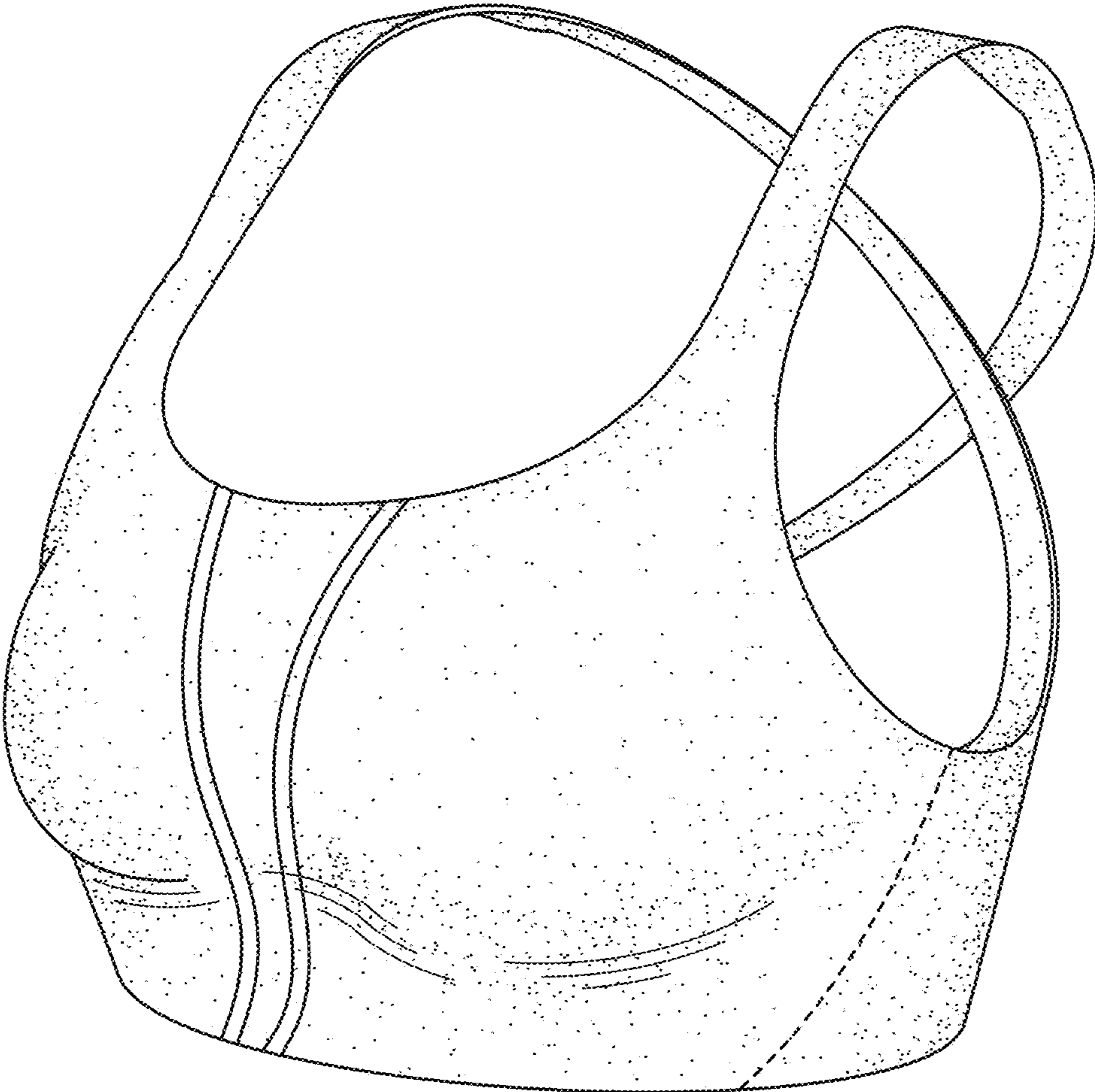

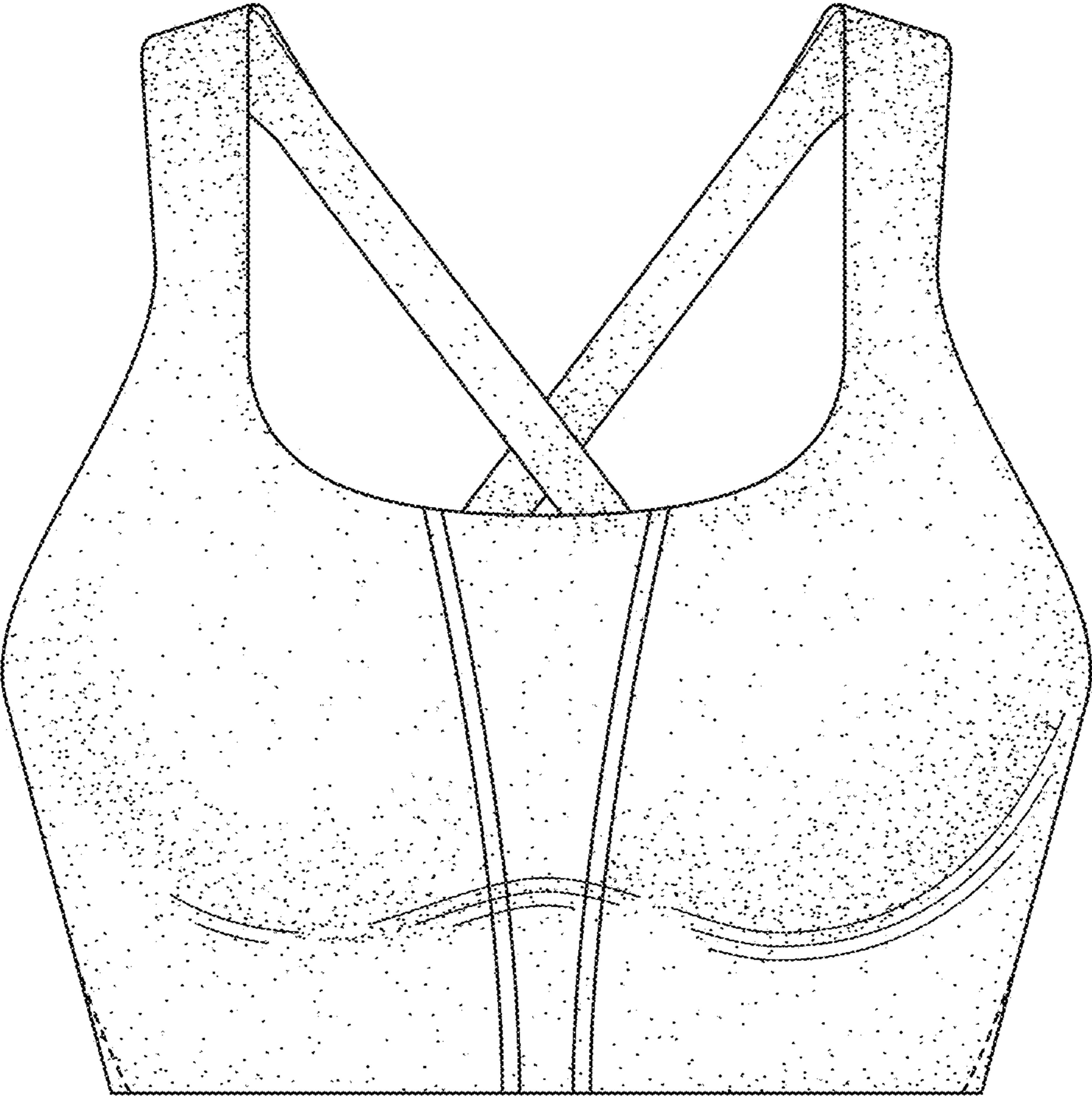

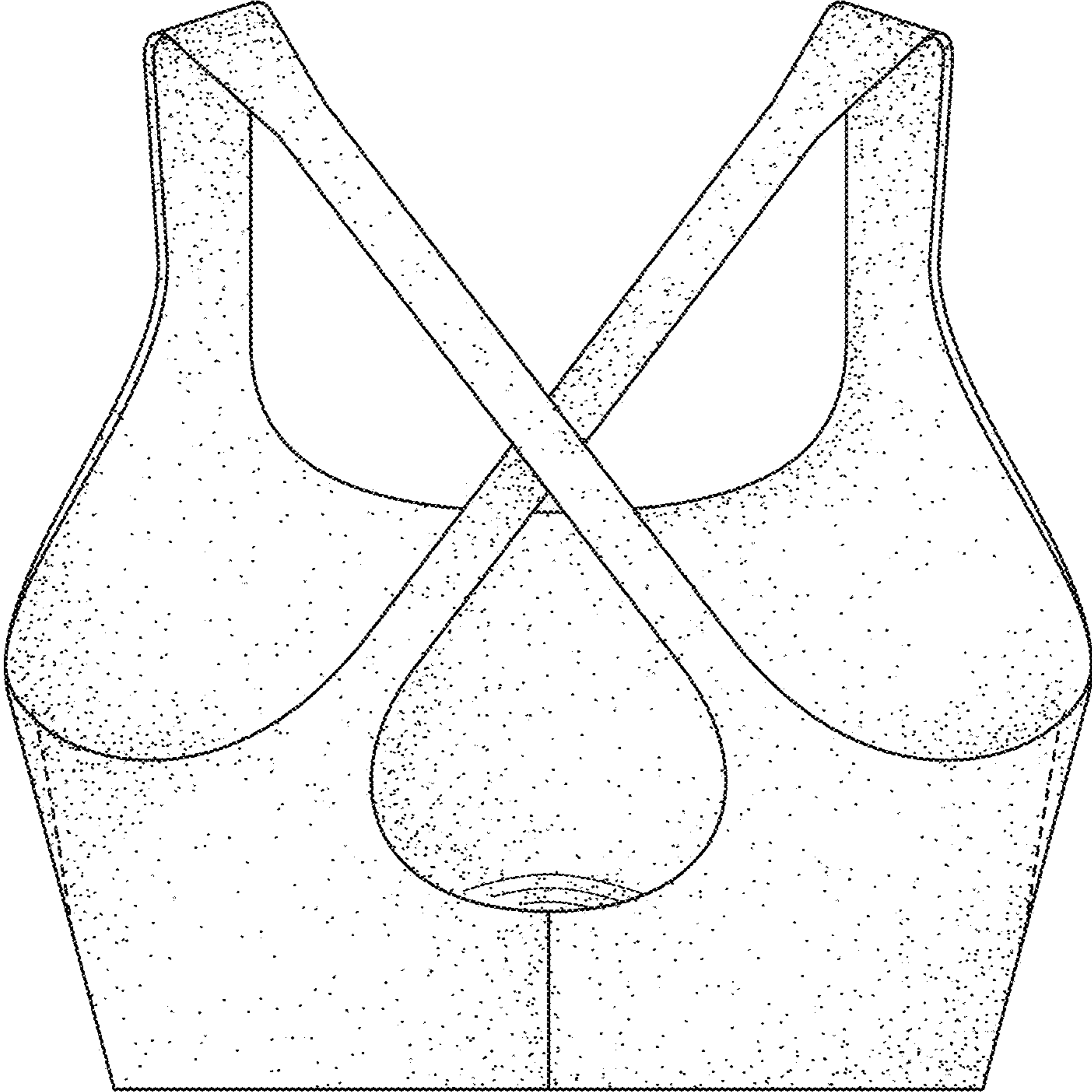

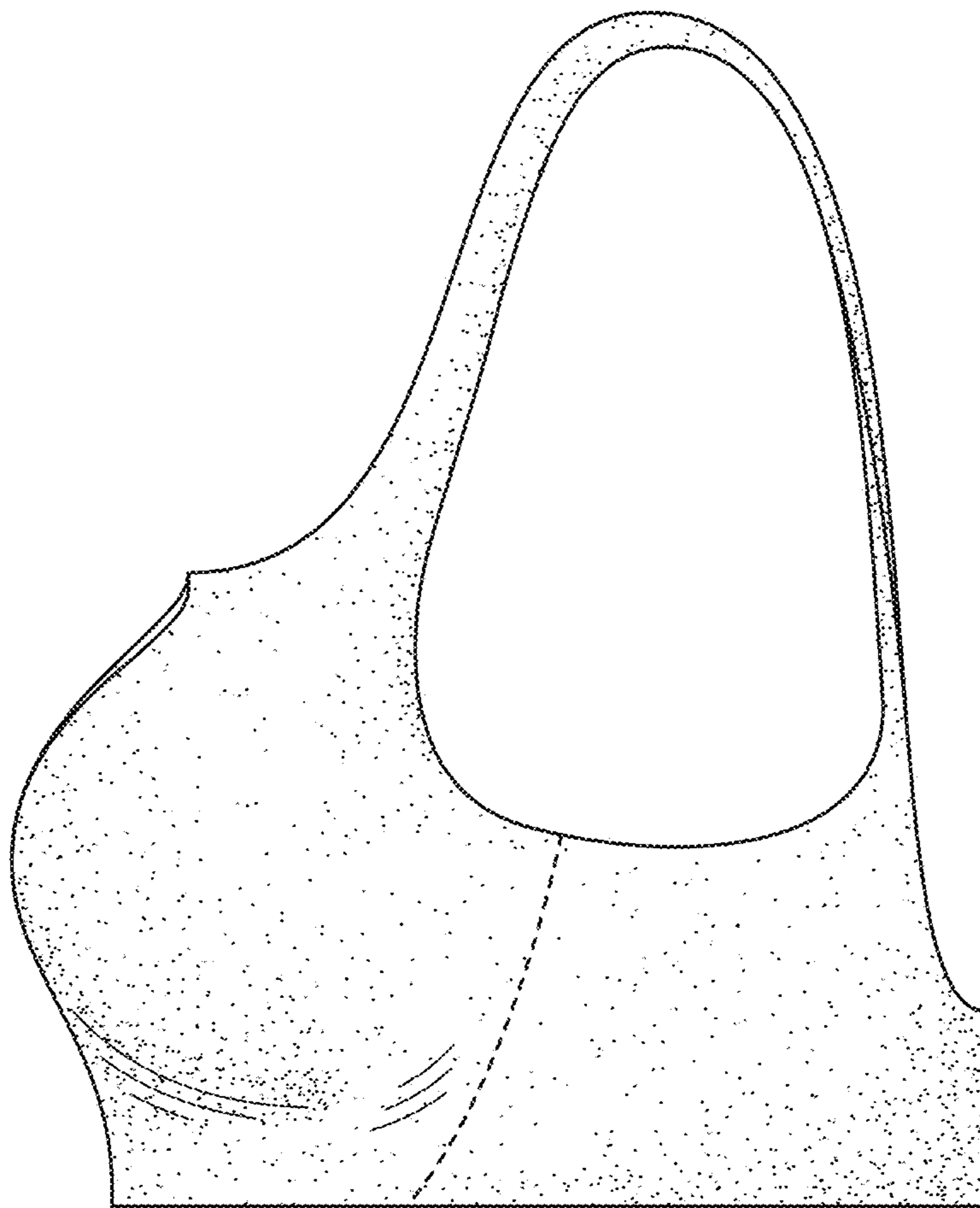

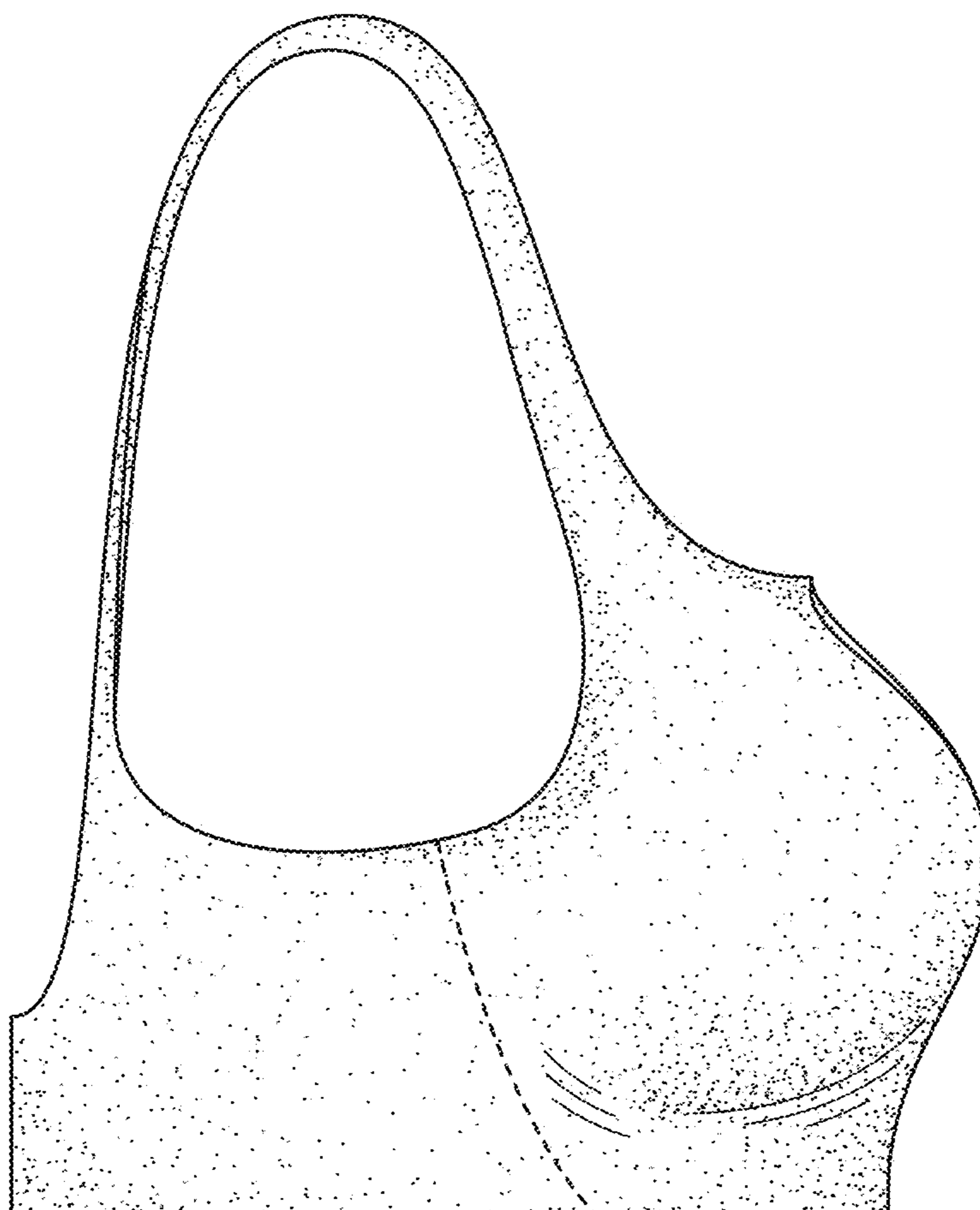

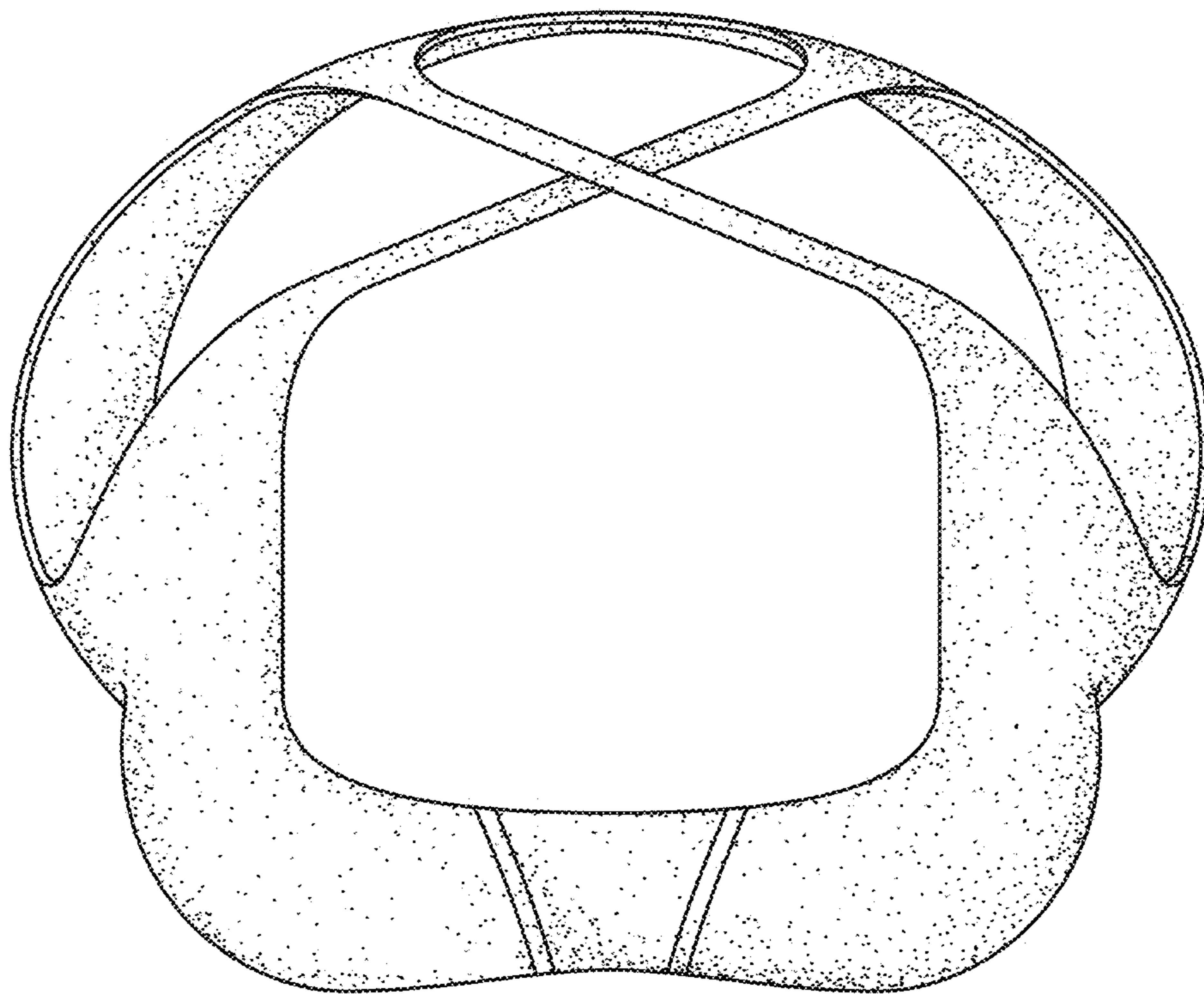

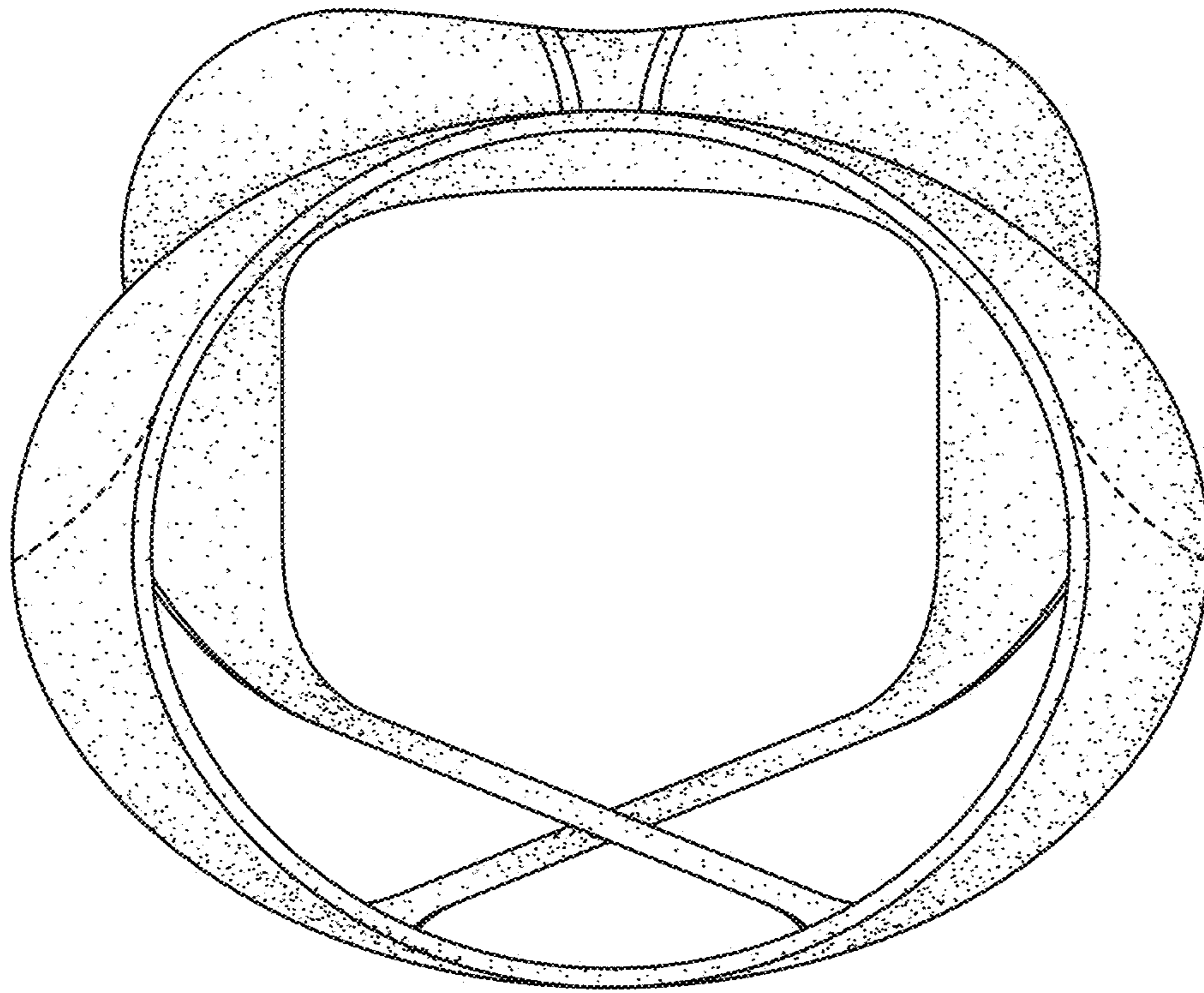

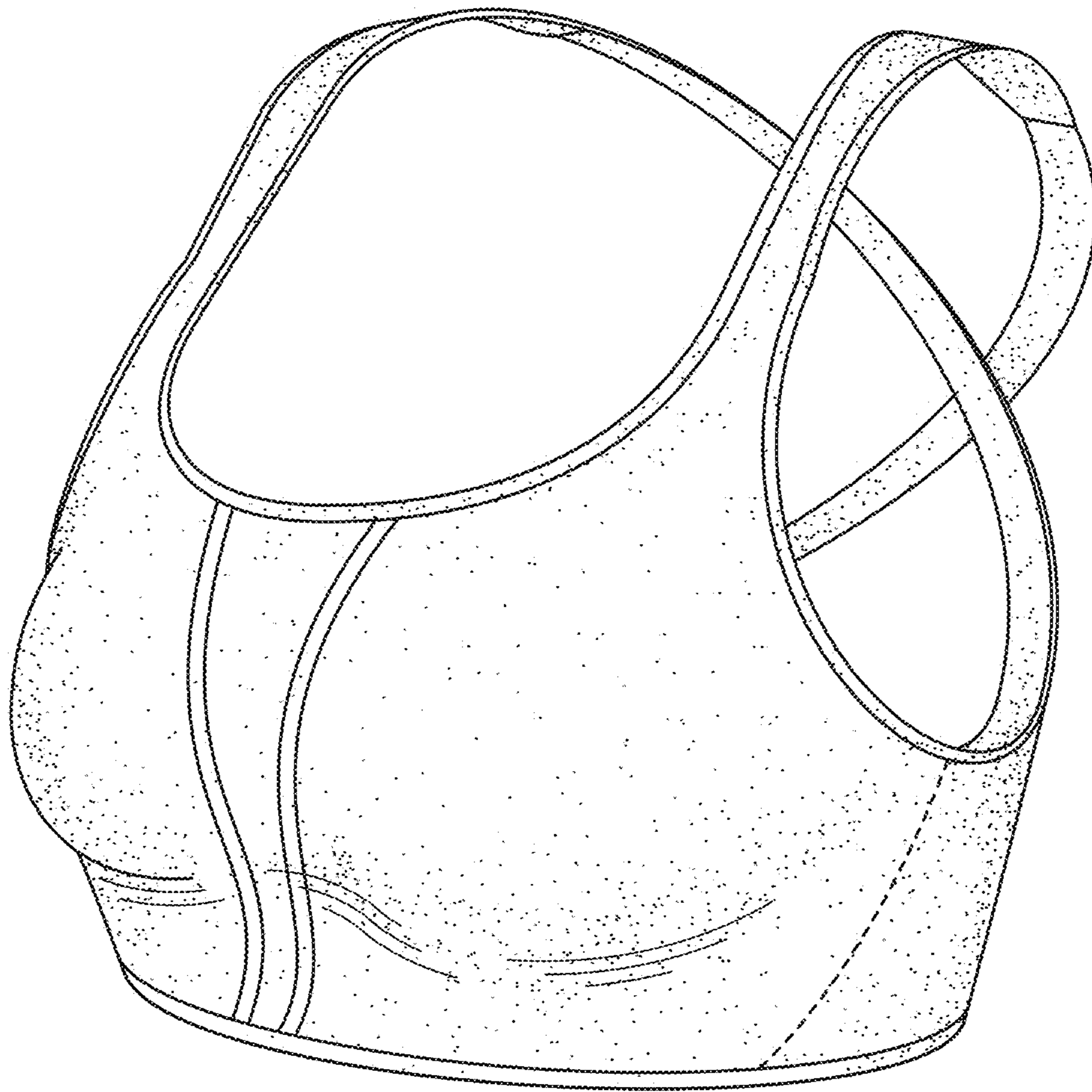

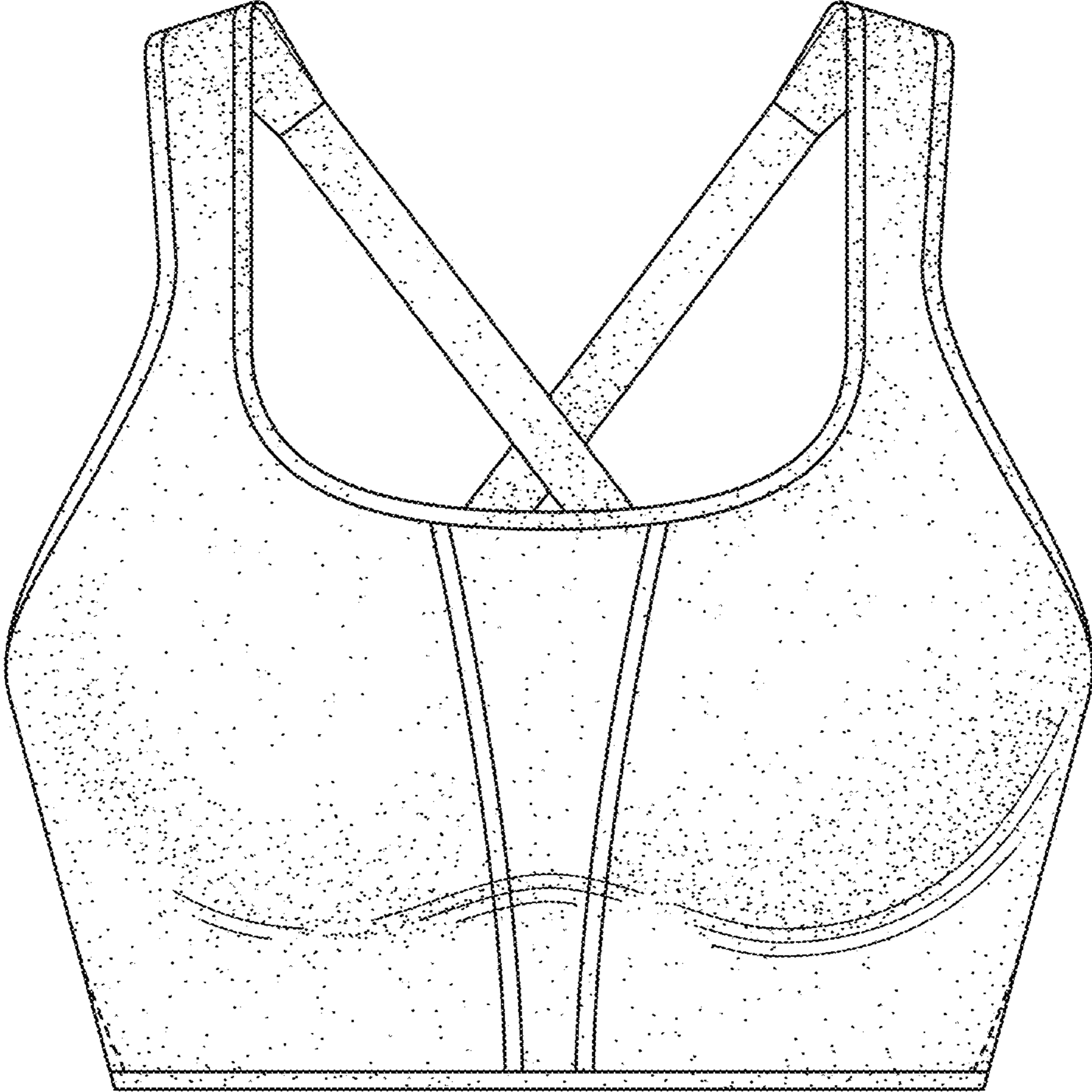

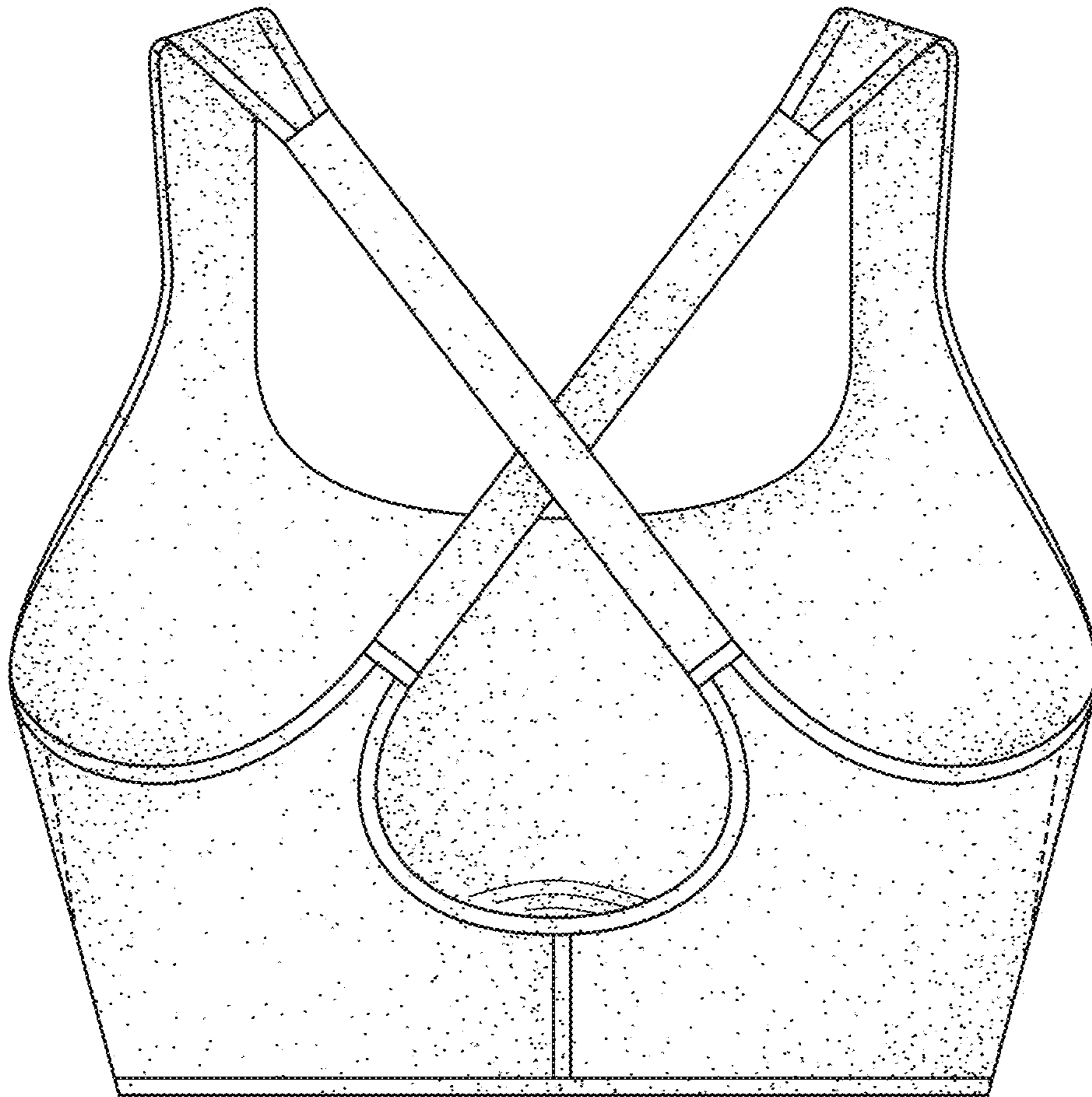

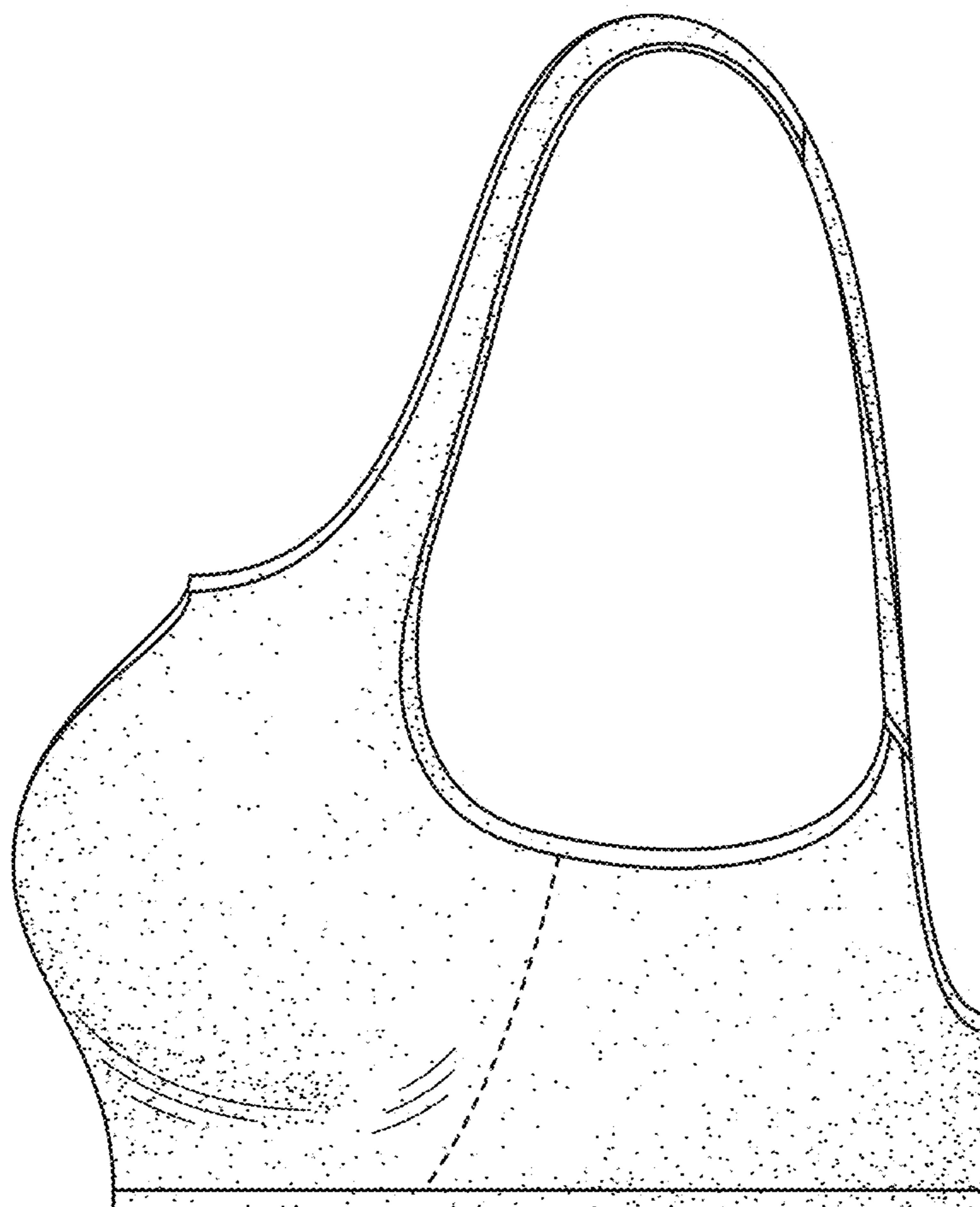

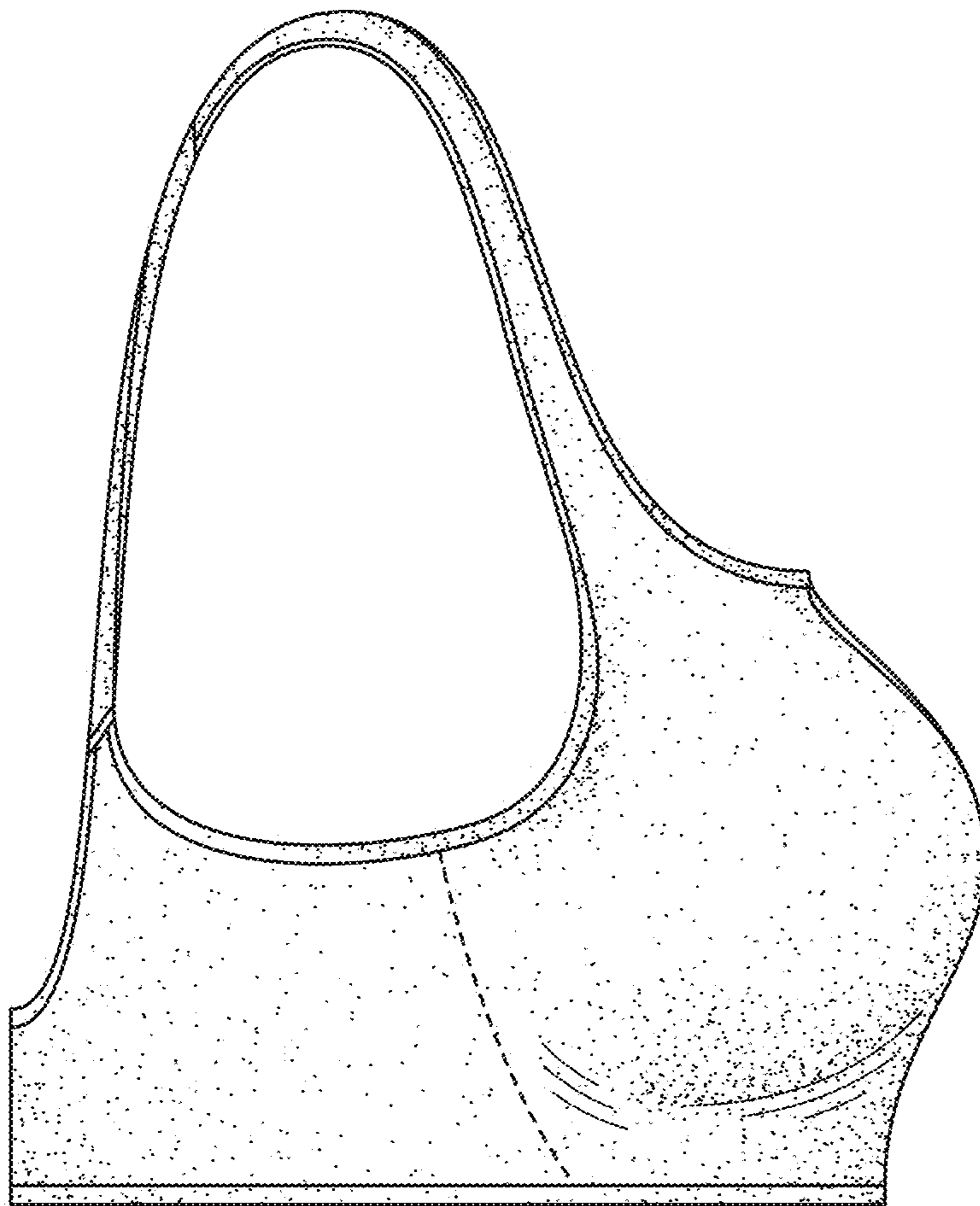

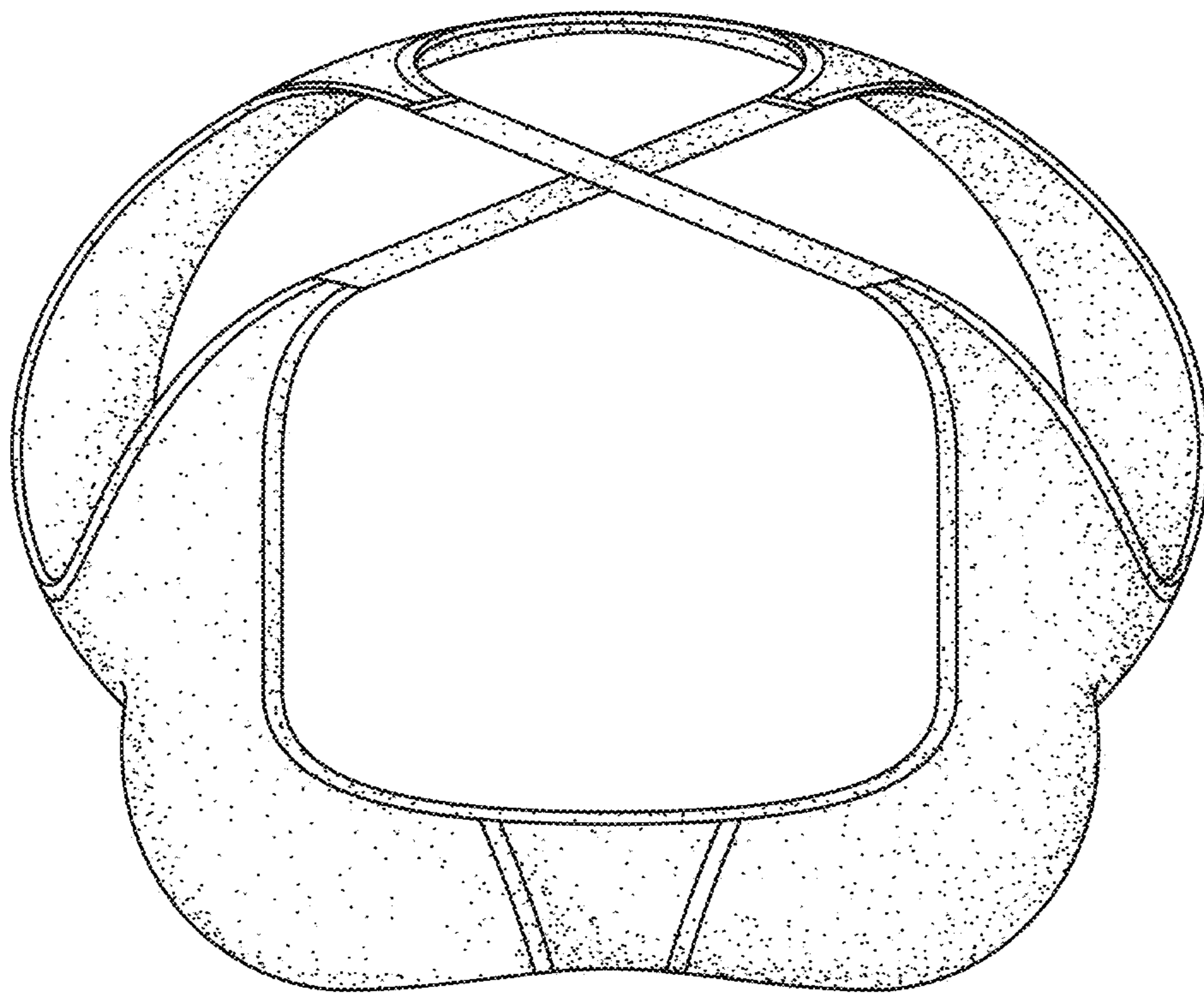

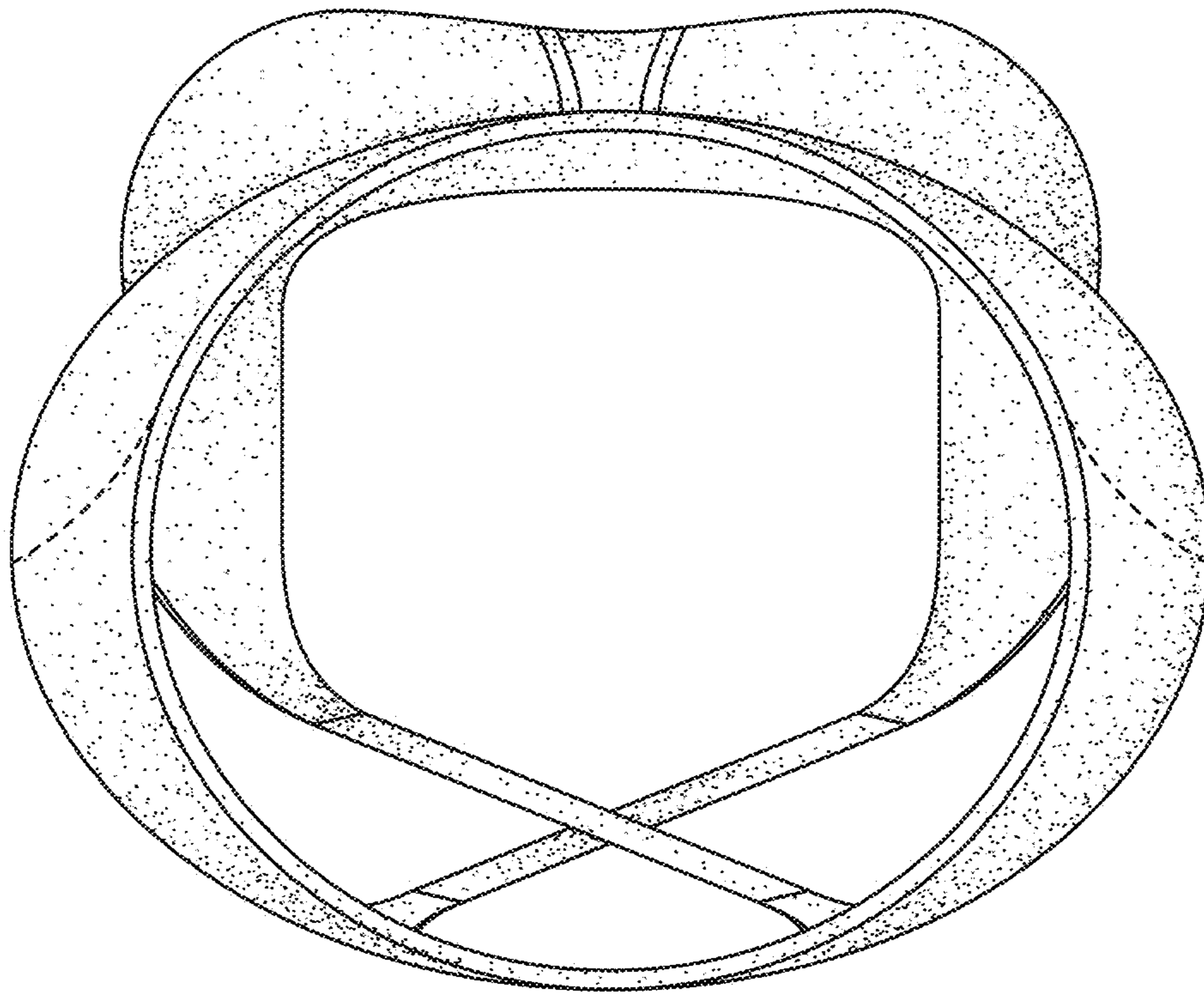
