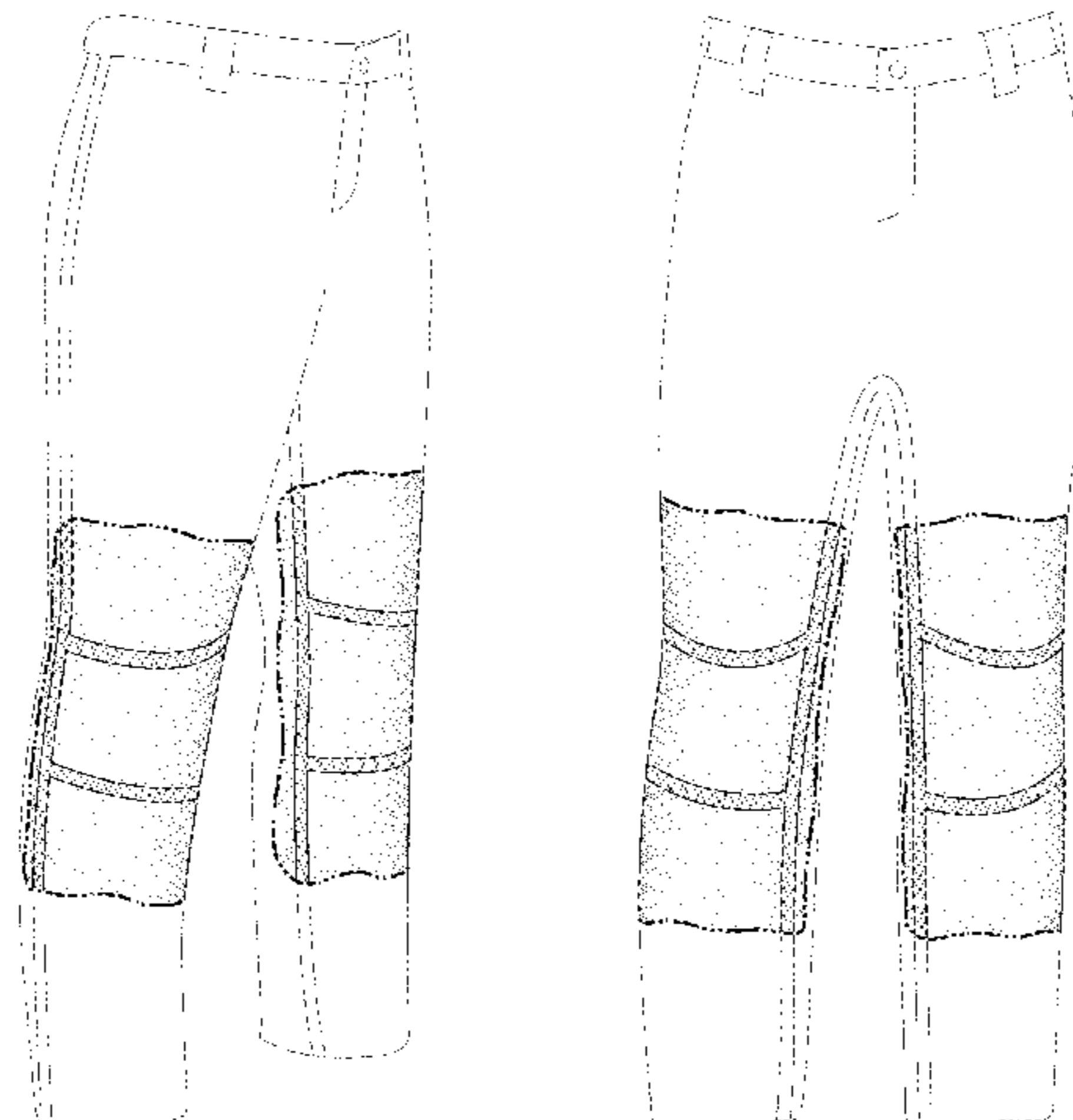
(57) **CLAIM**

I claim the ornamental design for pants, as shown and described.

DESCRIPTION

FIG. 1 is a left perspective view of pants, showing my new design;
FIG. 2 is a right perspective view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a left side view thereof; and,
FIG. 5 is a right side view thereof.
The regular dot-dash lines are included for the purpose of illustrating portions of the pants that form no part of the claimed design. The bold dot-dash lines represent boundaries of the claimed design. The different stipple shading is used in various regions to show contrast.

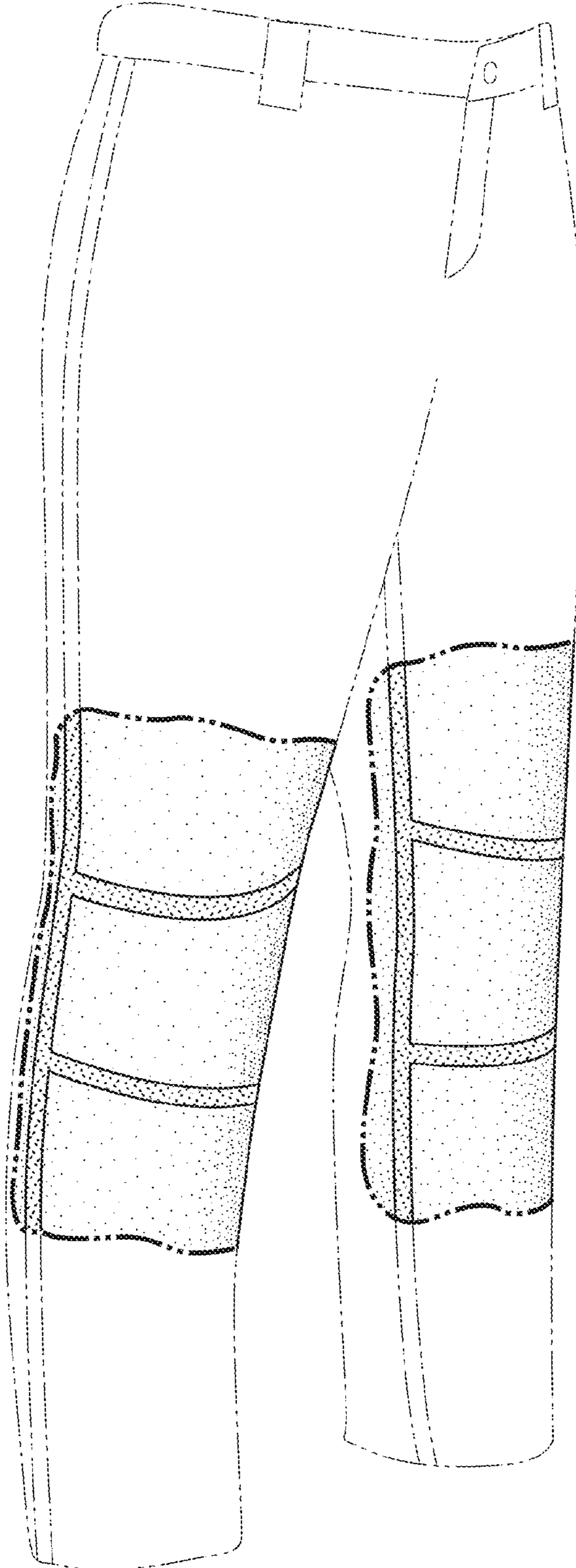

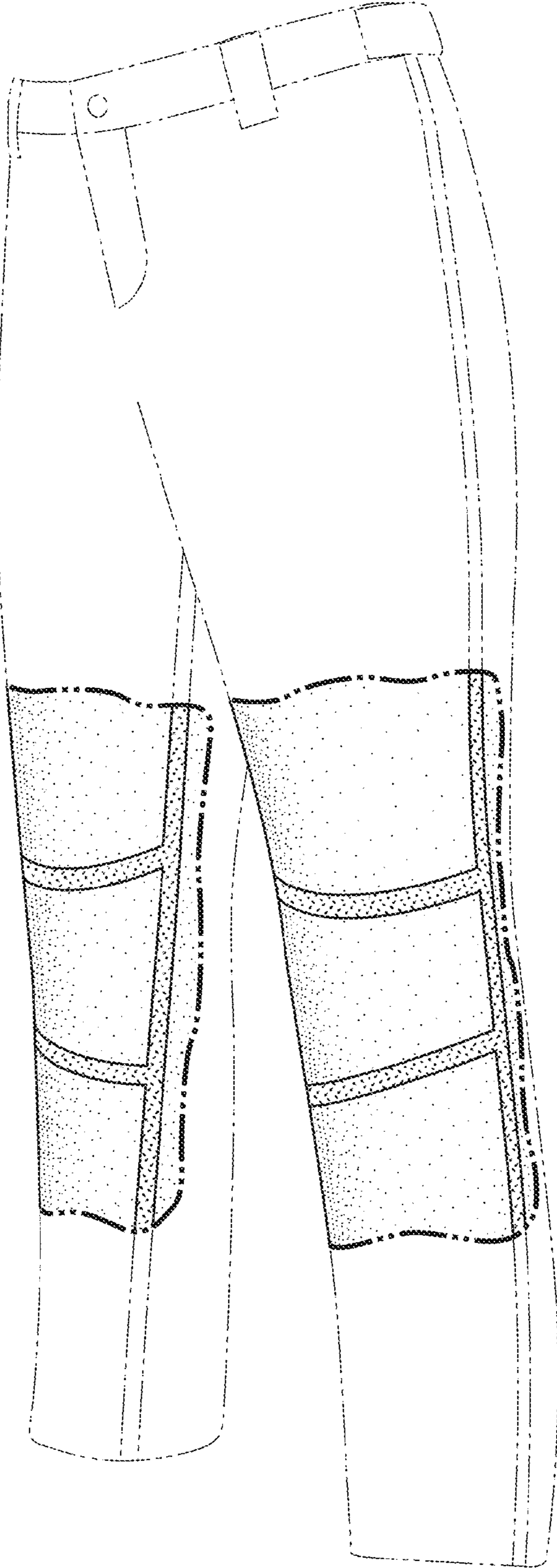

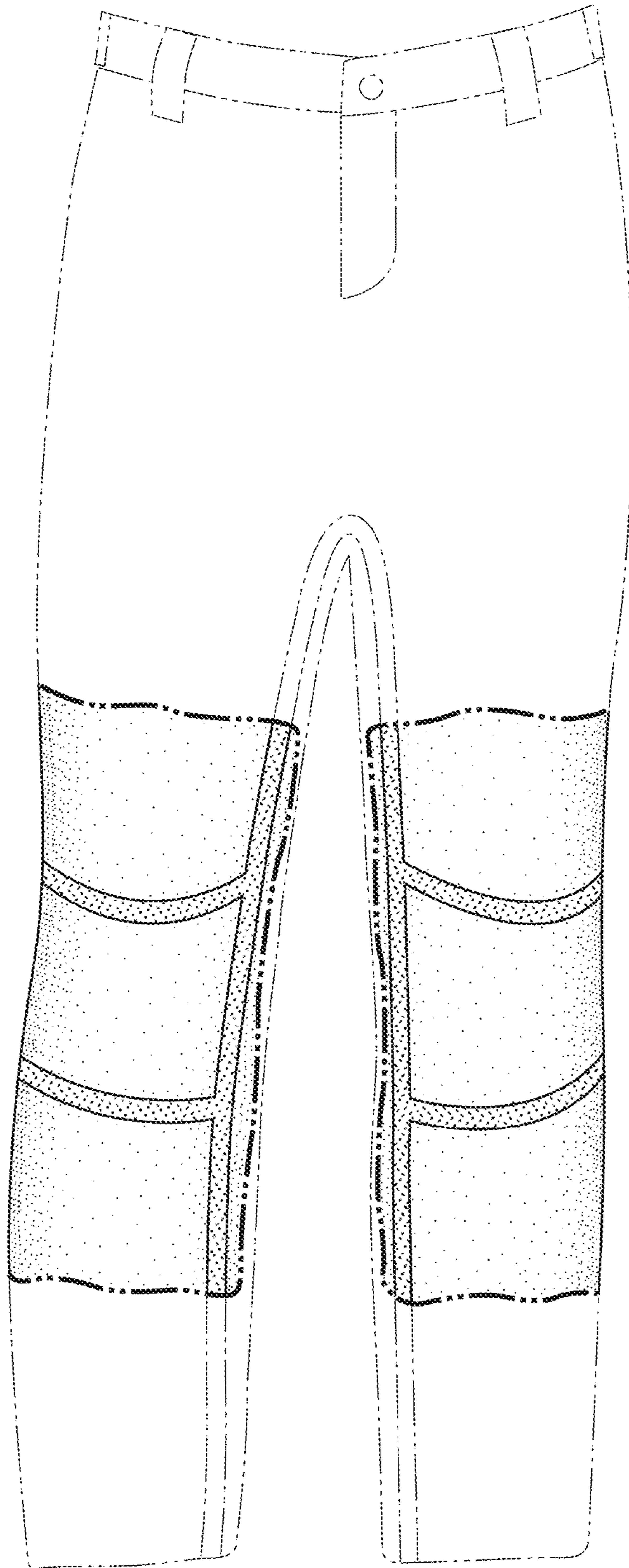

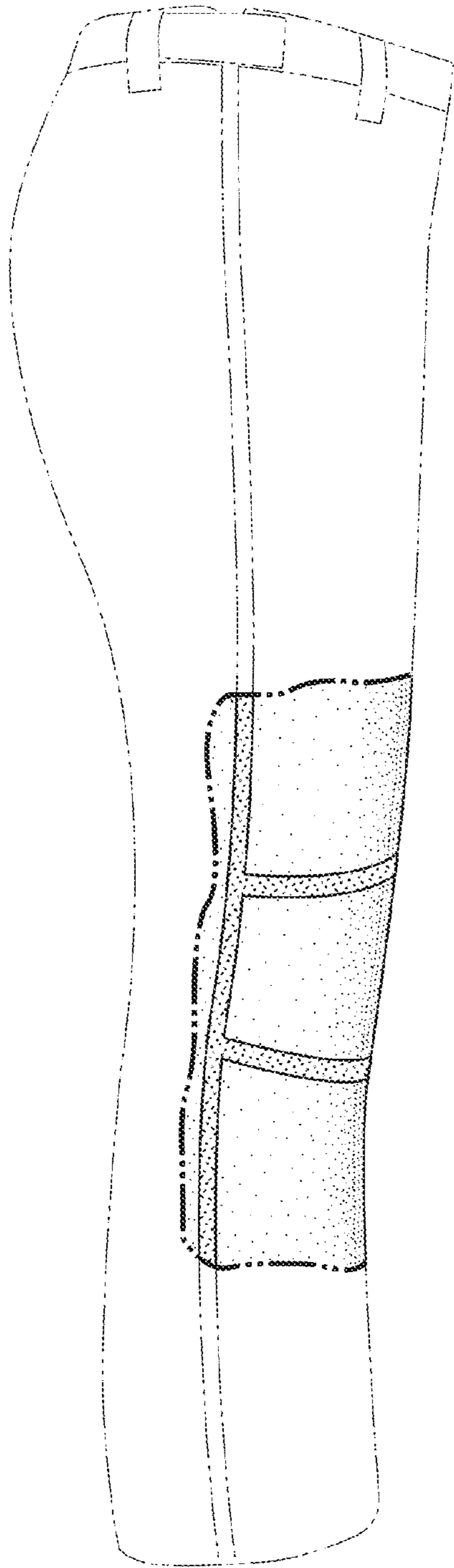

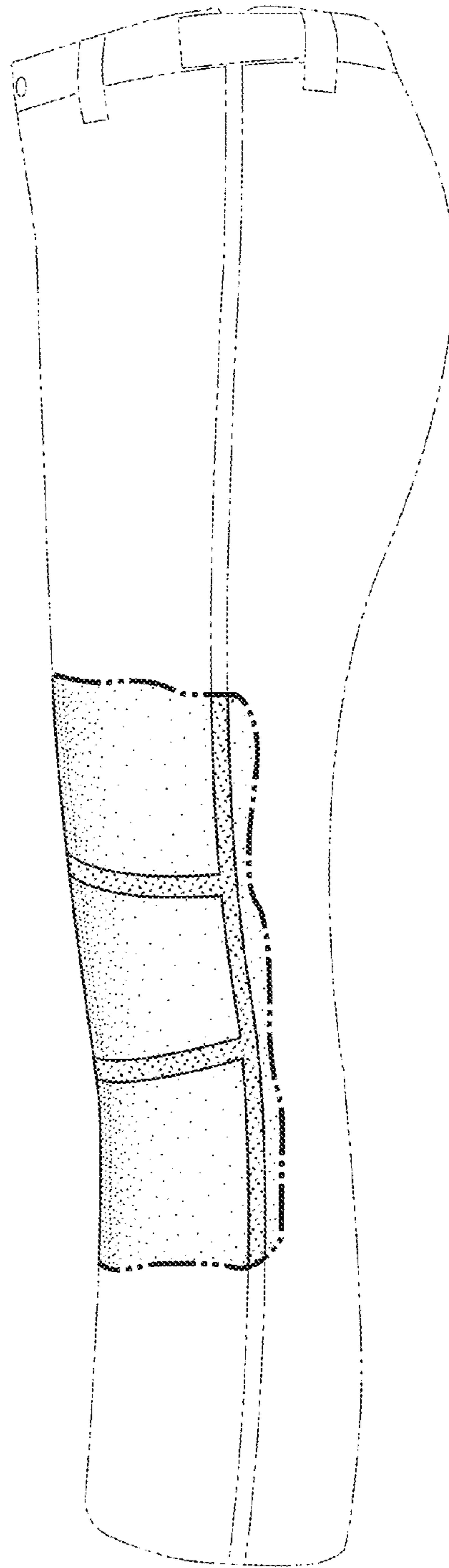
