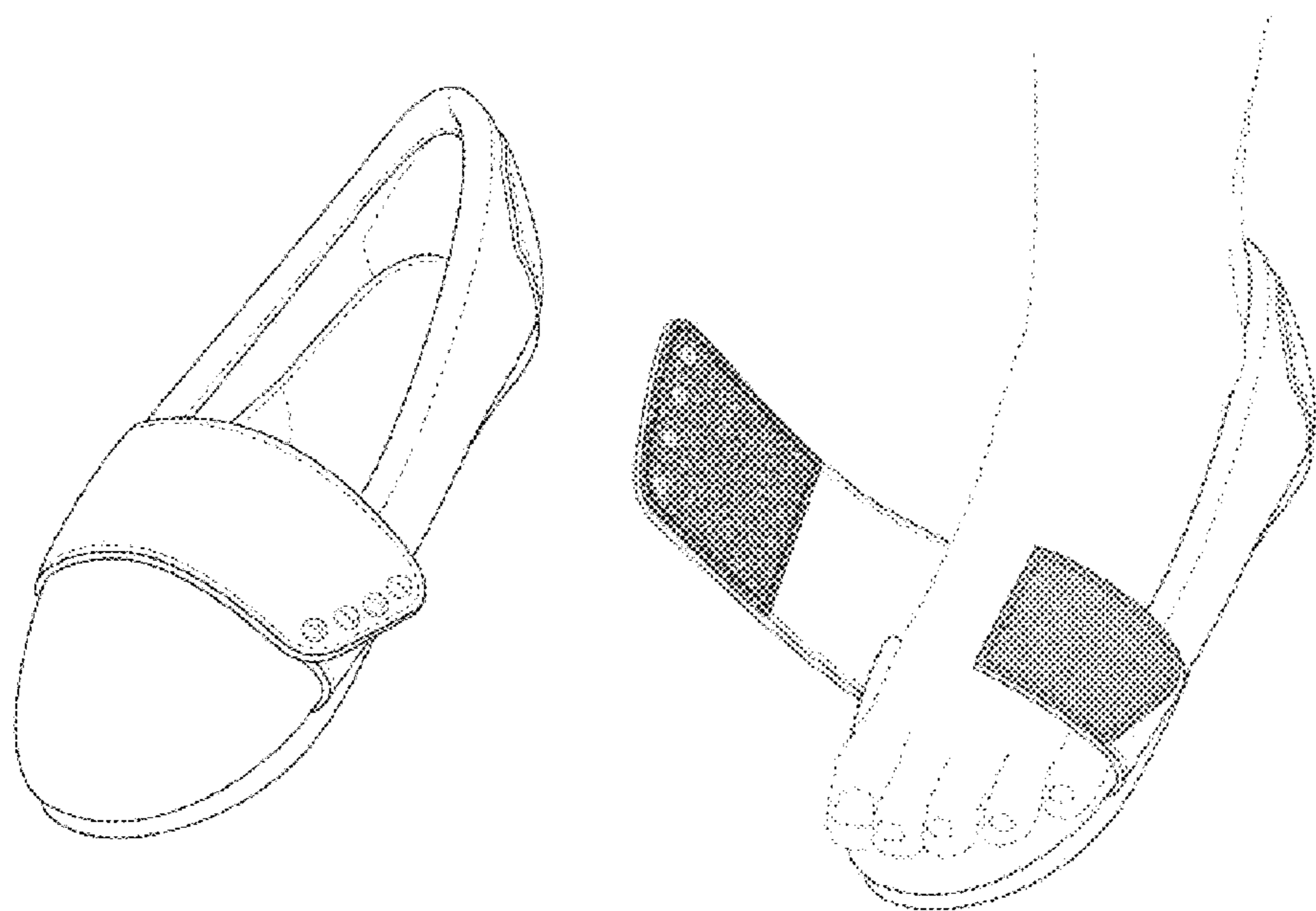

(57) **CLAIM**
The ornamental design for a women's convertible shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a women's convertible shoe showing my new design;
FIG. 2 is a front perspective view of a women's convertible shoe with the strap shown in an open orientation;
FIG. 3 is another view of FIG. 2 with a portion of the strap in an alternate position;
FIG. 4 is another view of FIG. 1, with a foot shown in broken lines for illustrative purposes;
FIG. 5 is a front perspective view of a women's convertible shoe with a removable toe portion removed and a foot shown in broken lines for illustrative purposes;
FIG. 6 is another view of FIG. 5 with a strap shown in an open orientation and a foot shown in broken lines for illustrative purposes;
FIG. 7 is another view of FIG. 6 with a portion of the strap in an alternate position and a foot shown in broken lines for illustrative purposes;
FIG. 8 is a left side view thereof;
FIG. 9 is a right side view thereof;
FIG. 10 is a front view thereof; and,
FIG. 11 is a rear view thereof.
The foot shown in broken lines forms no part of the claimed design.

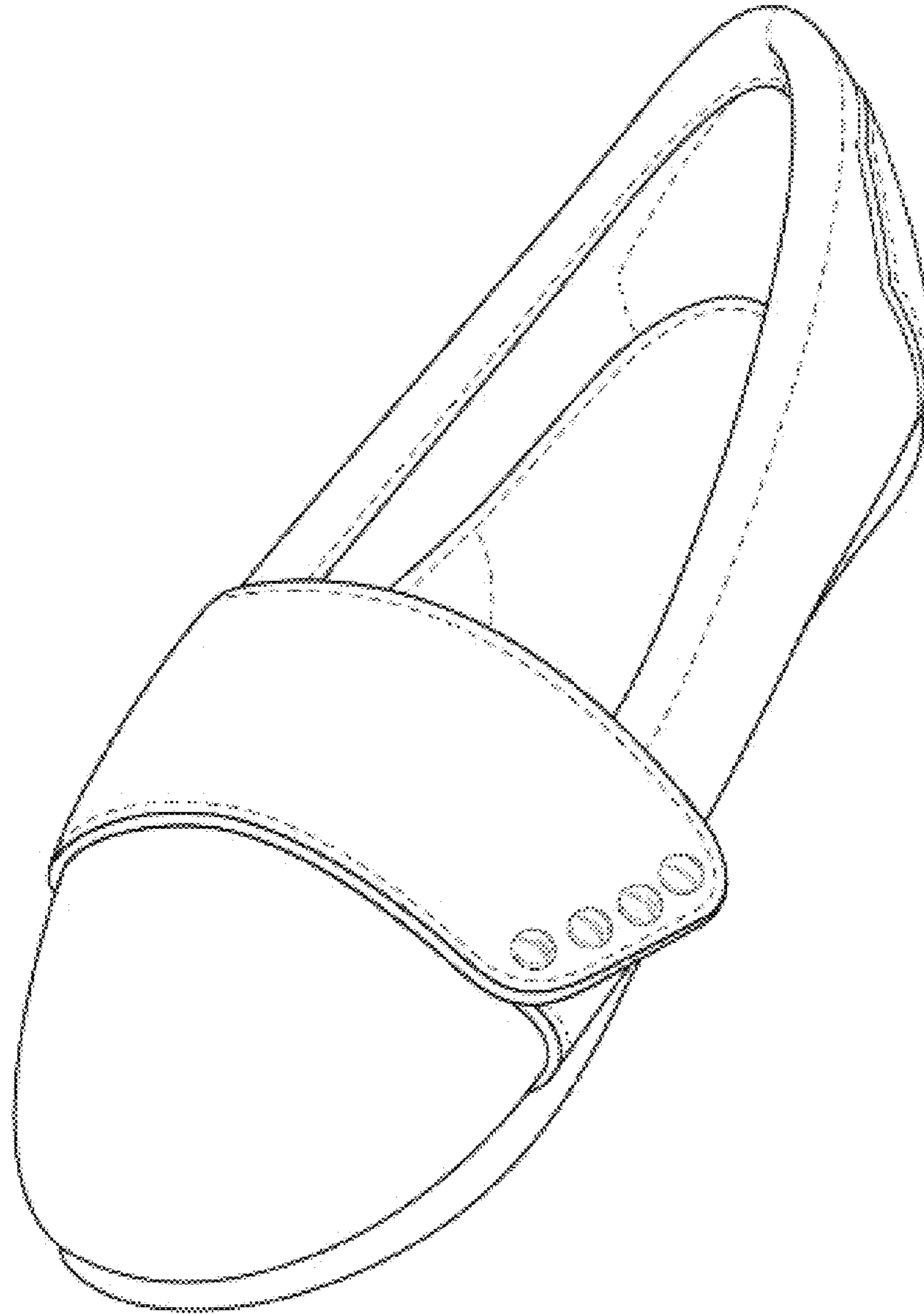

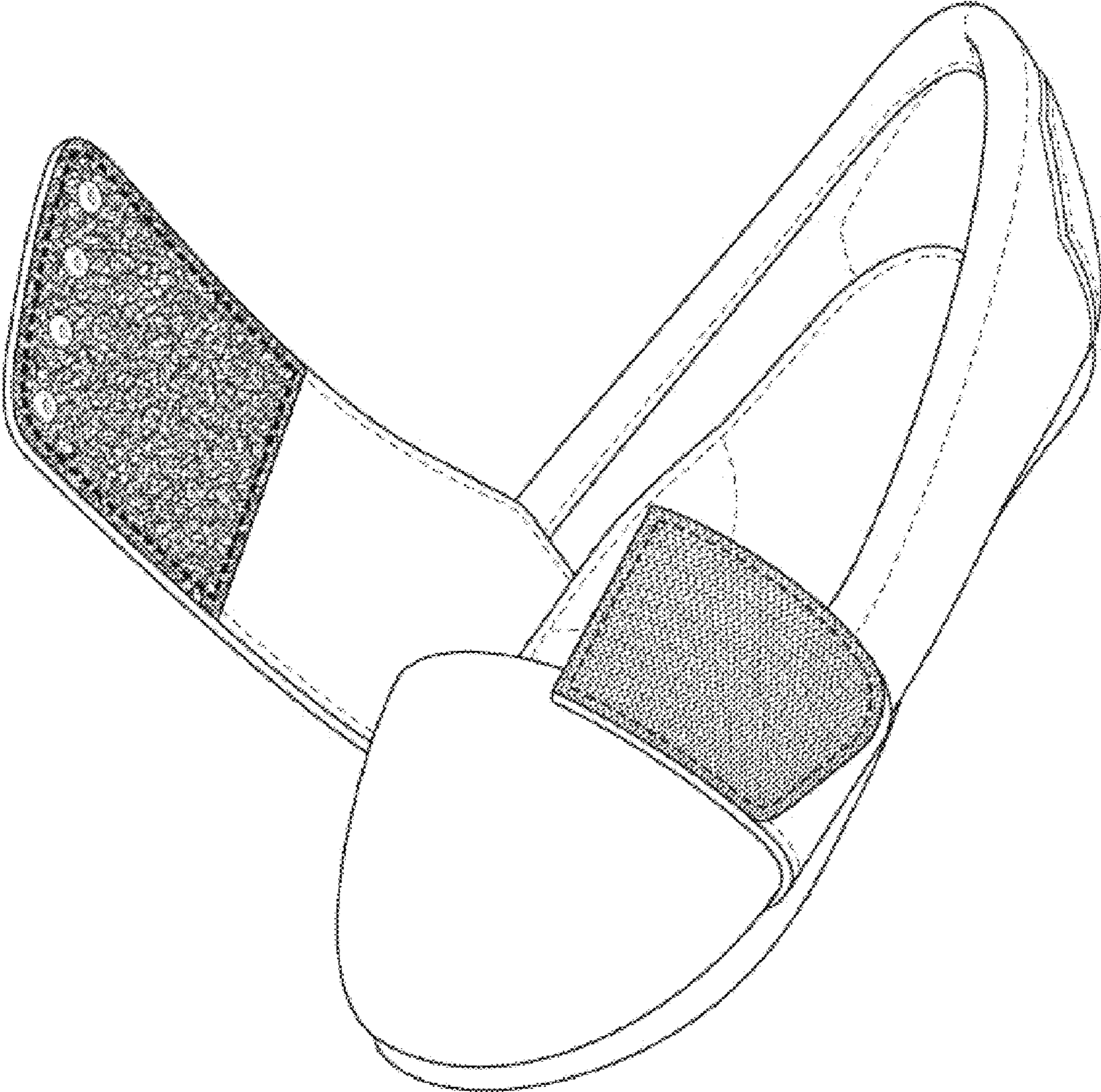

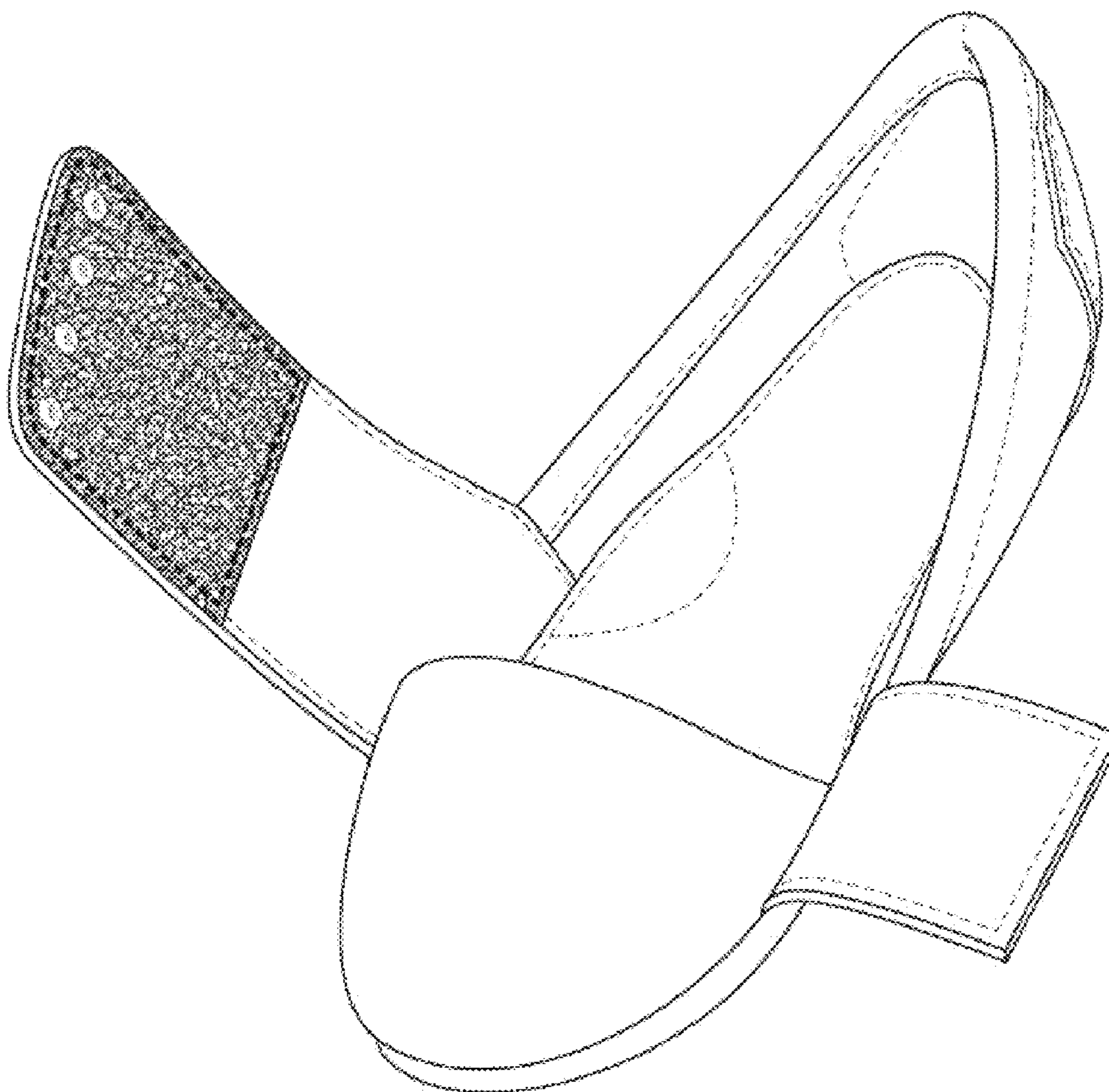

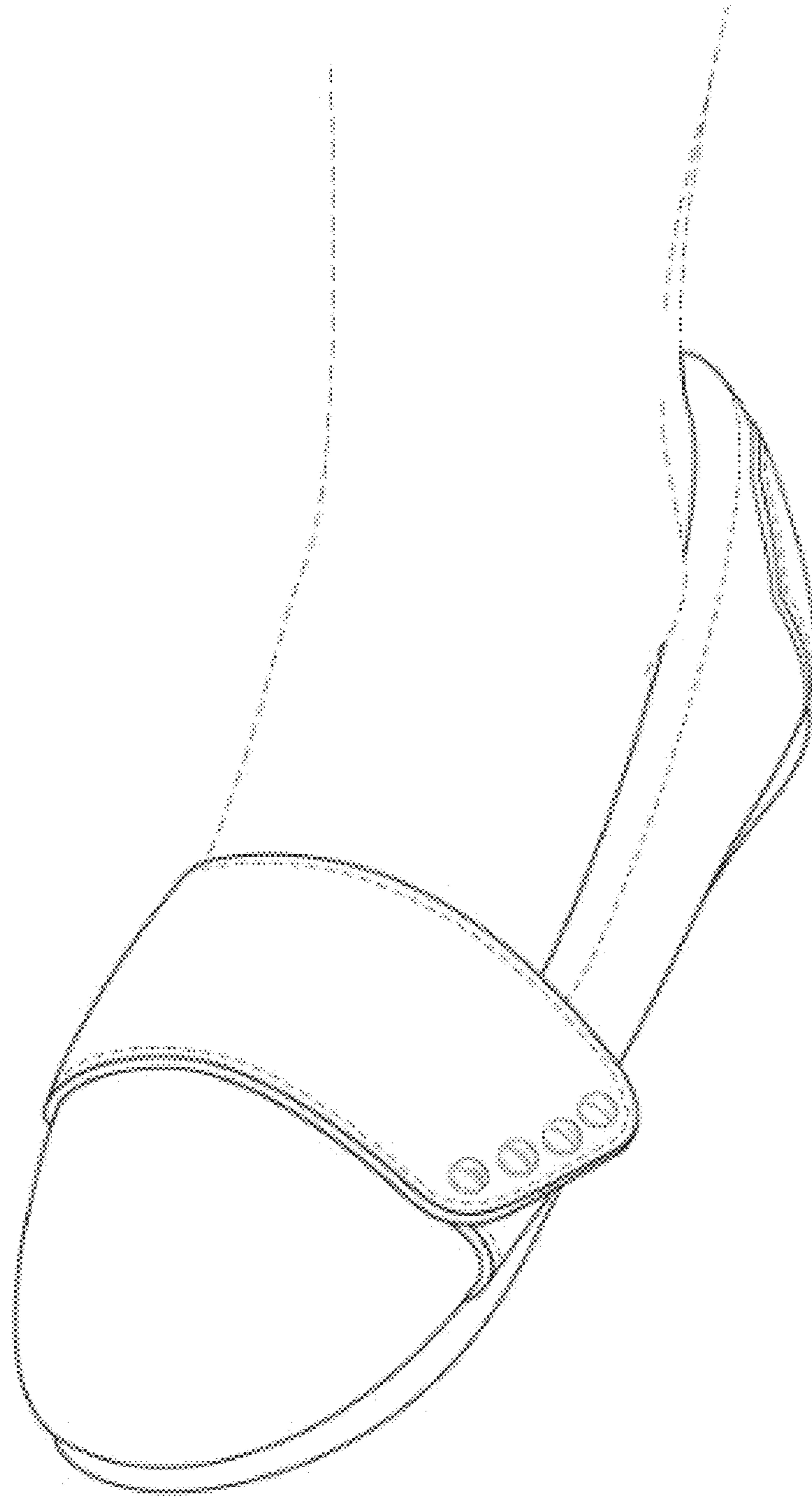

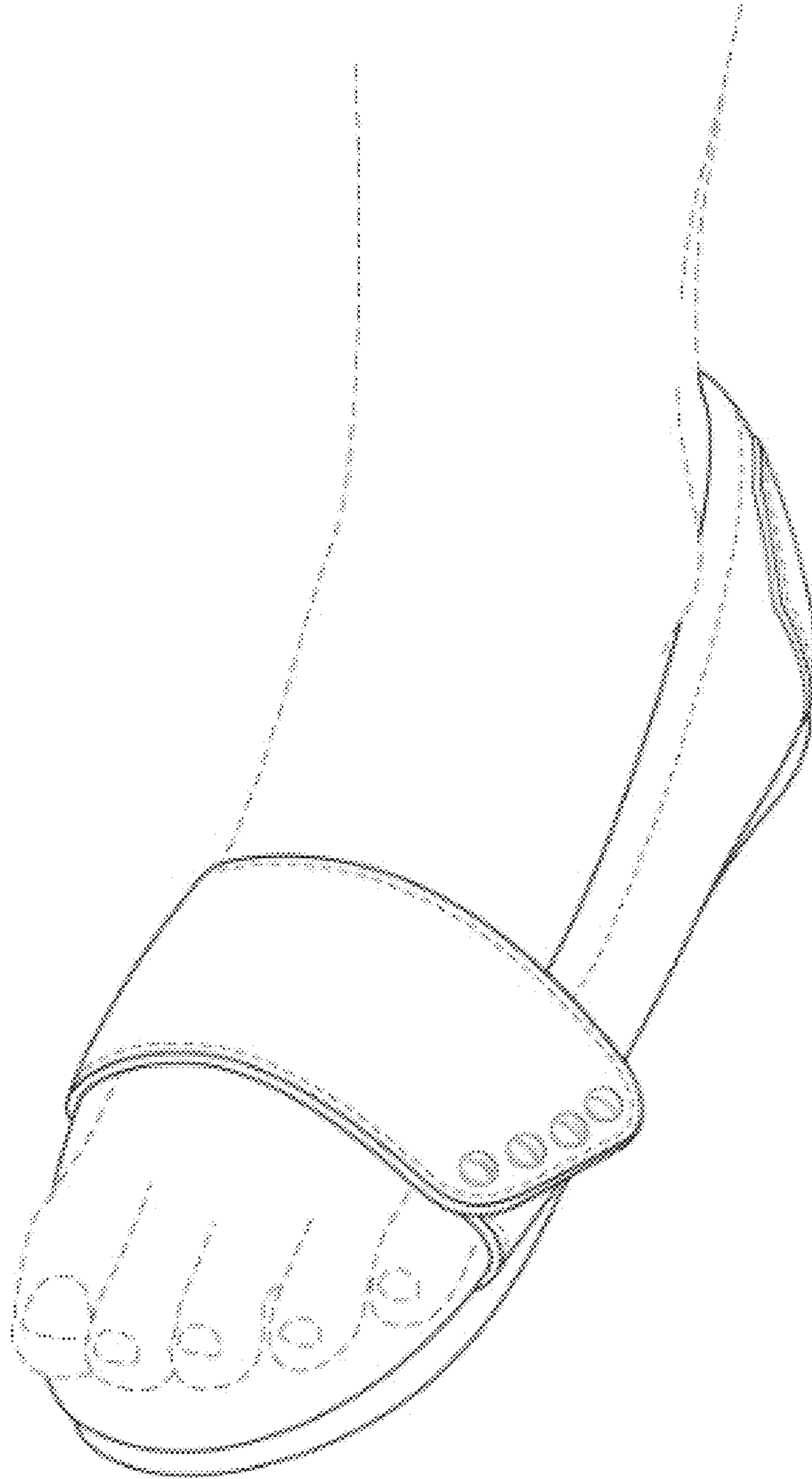

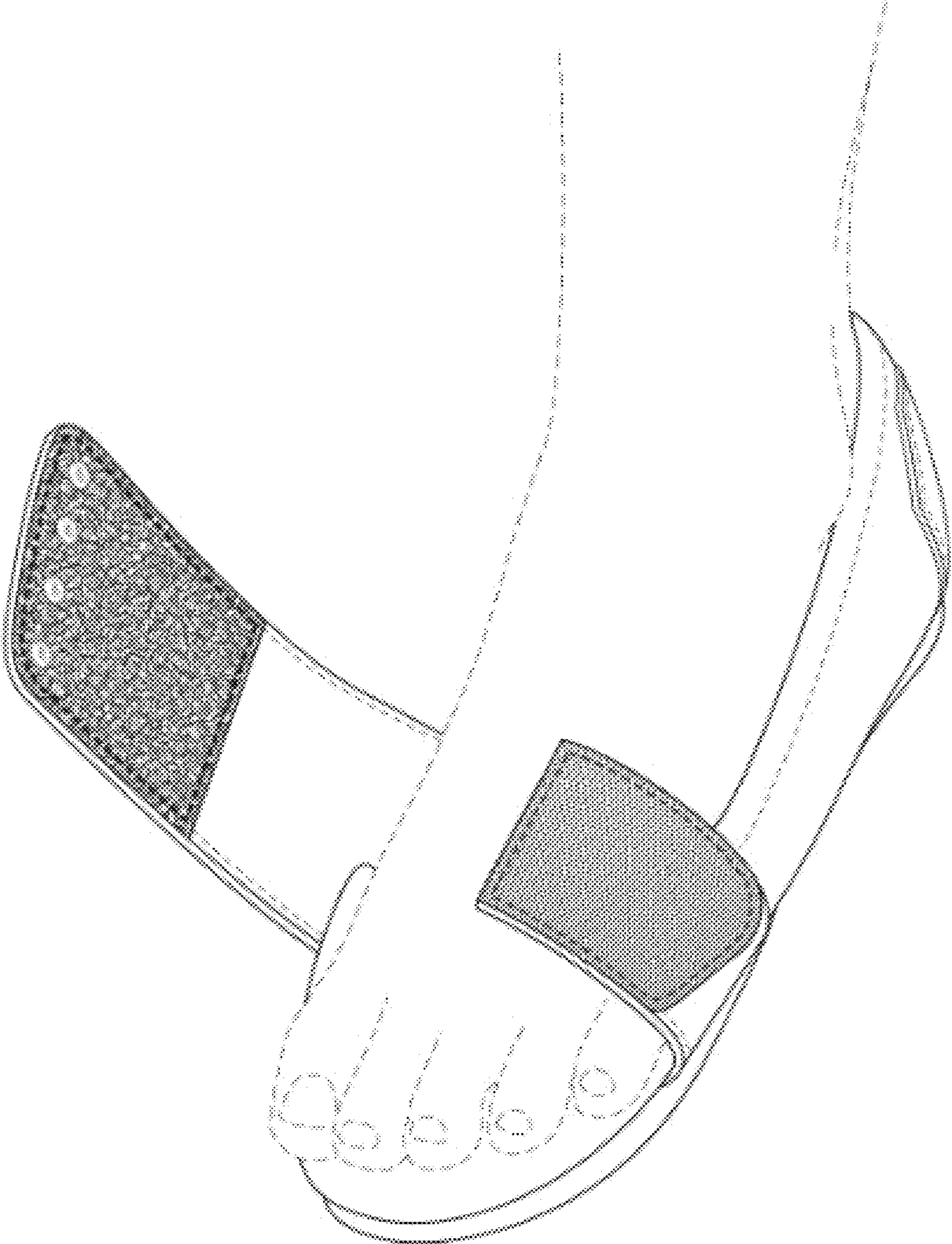

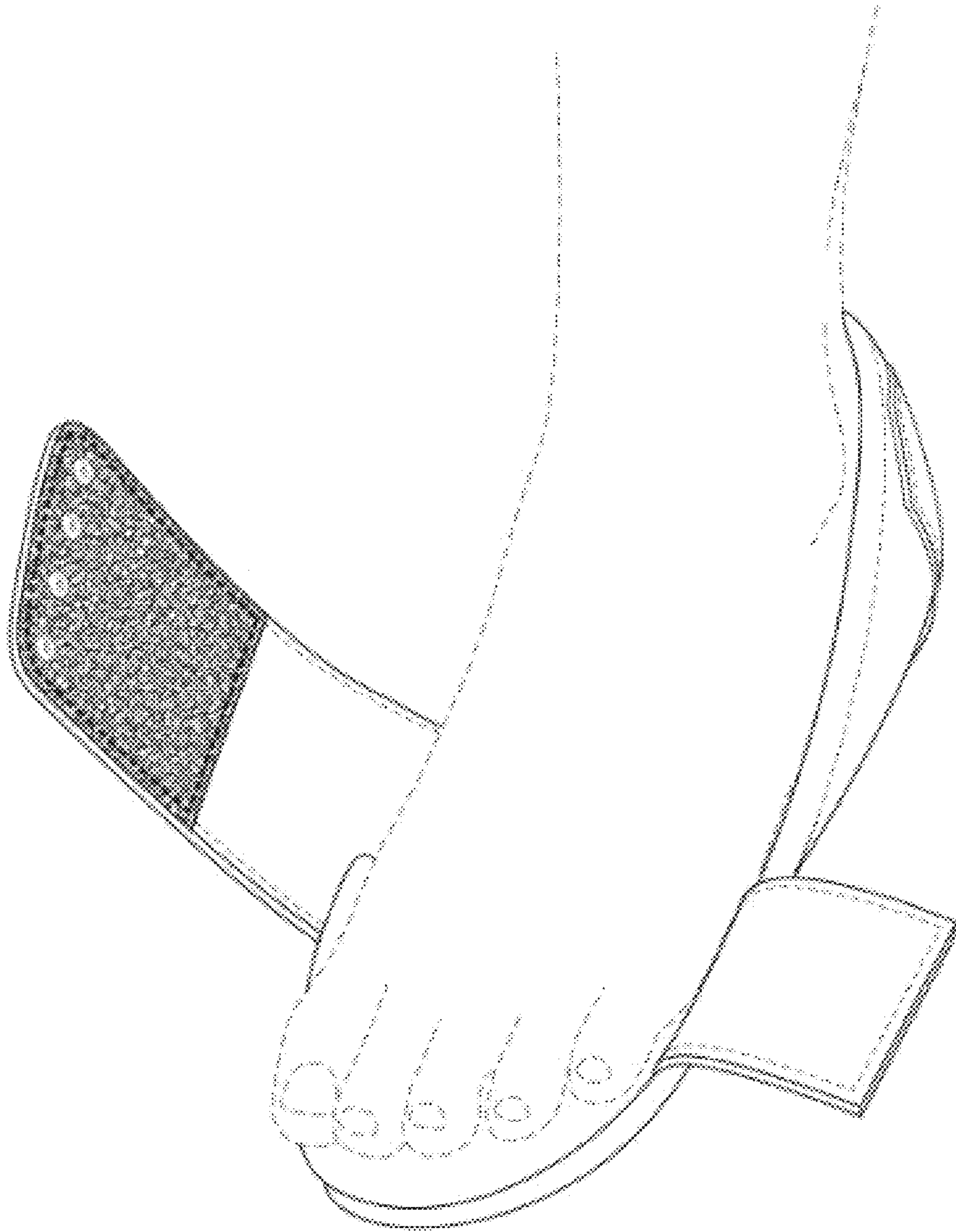

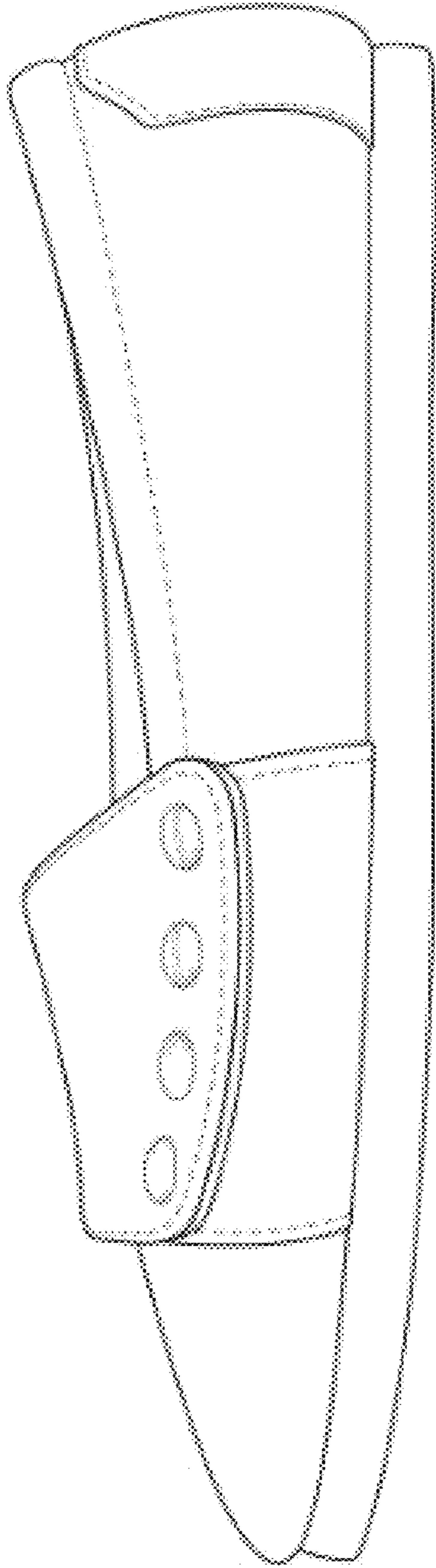

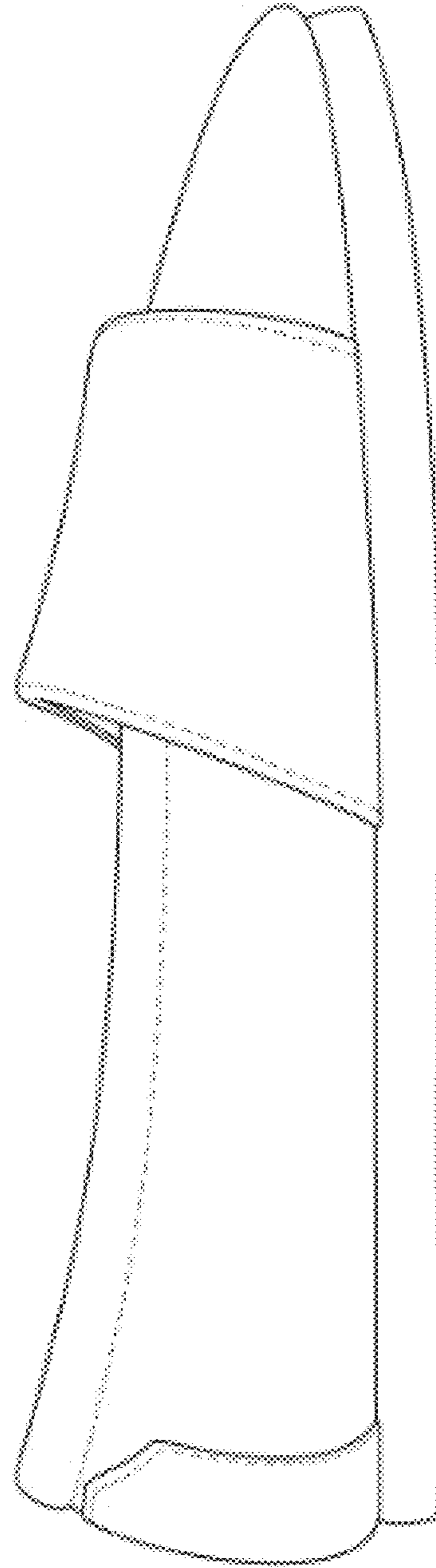

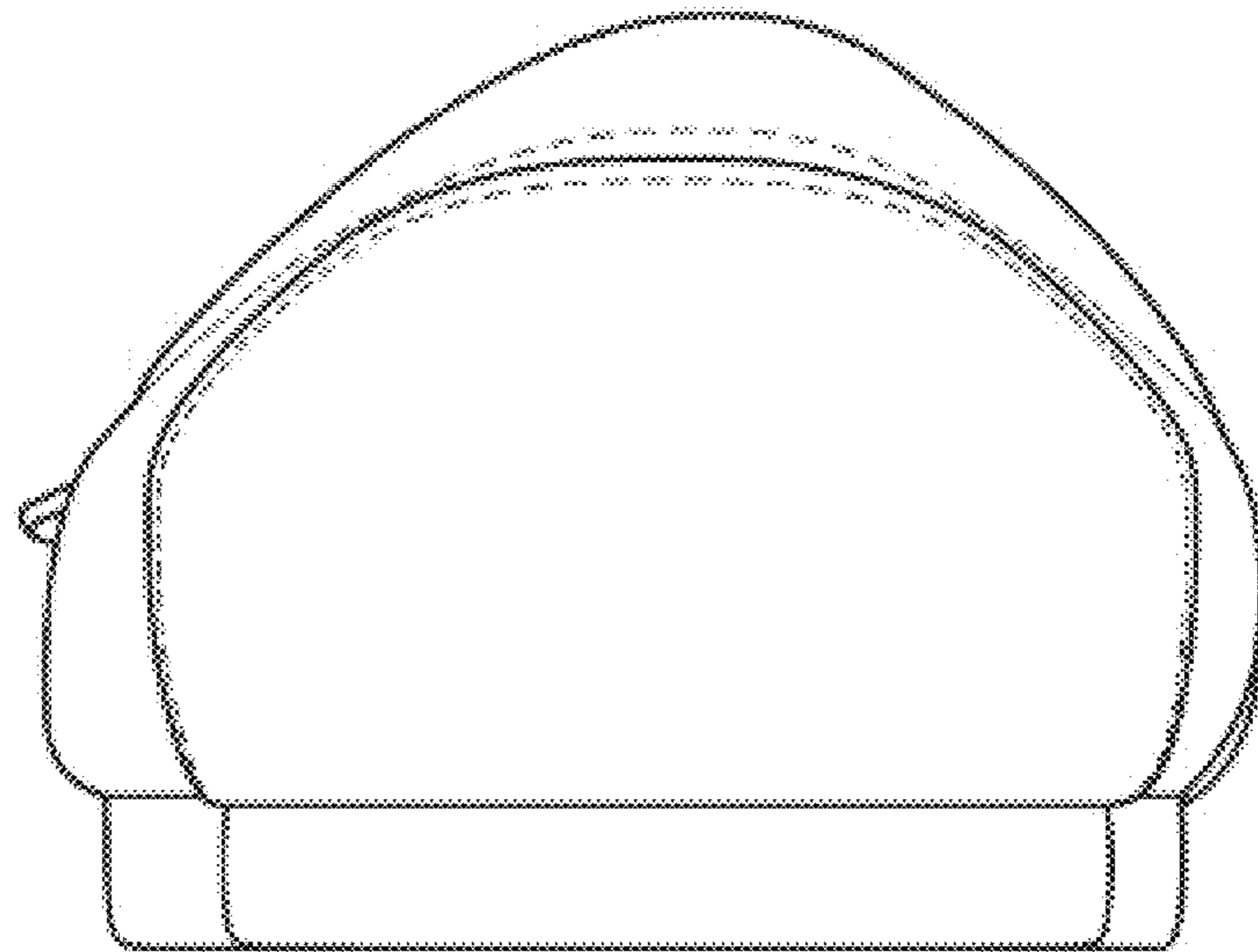
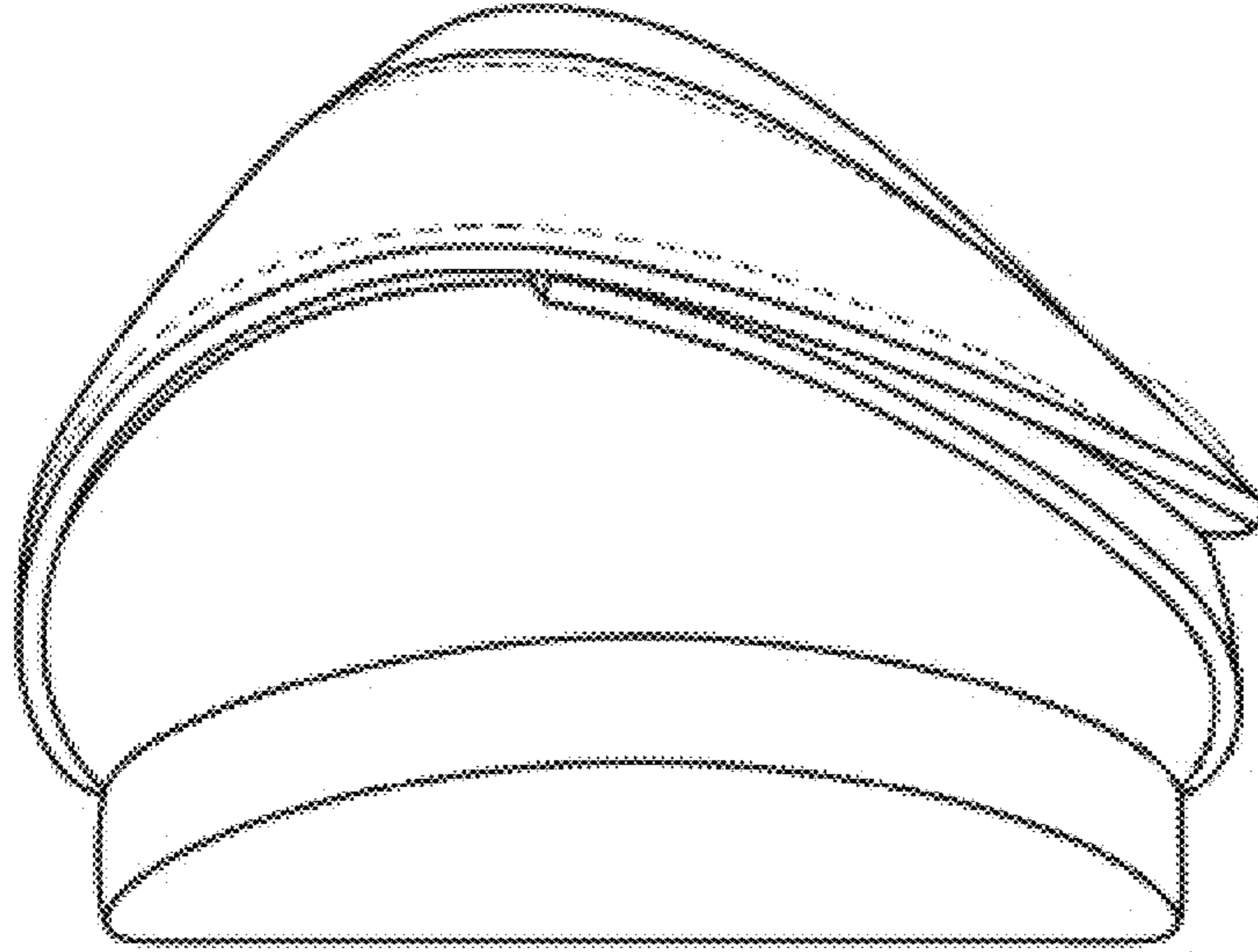
