DESCRIPTION

FIG. 1 is a front perspective view of a shoe outsole showing my new design;

FIG. 3 is a rear perspective view thereof;

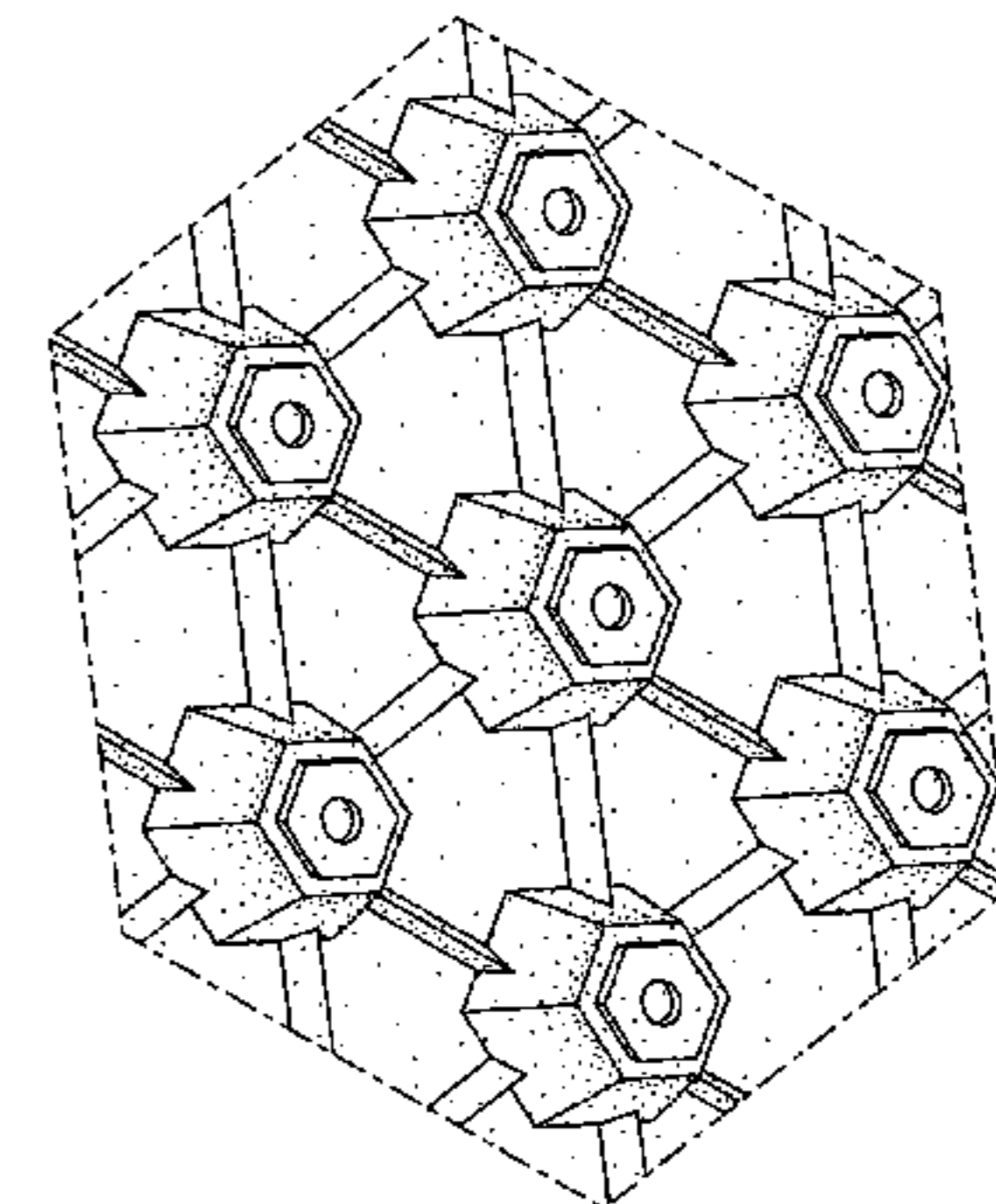
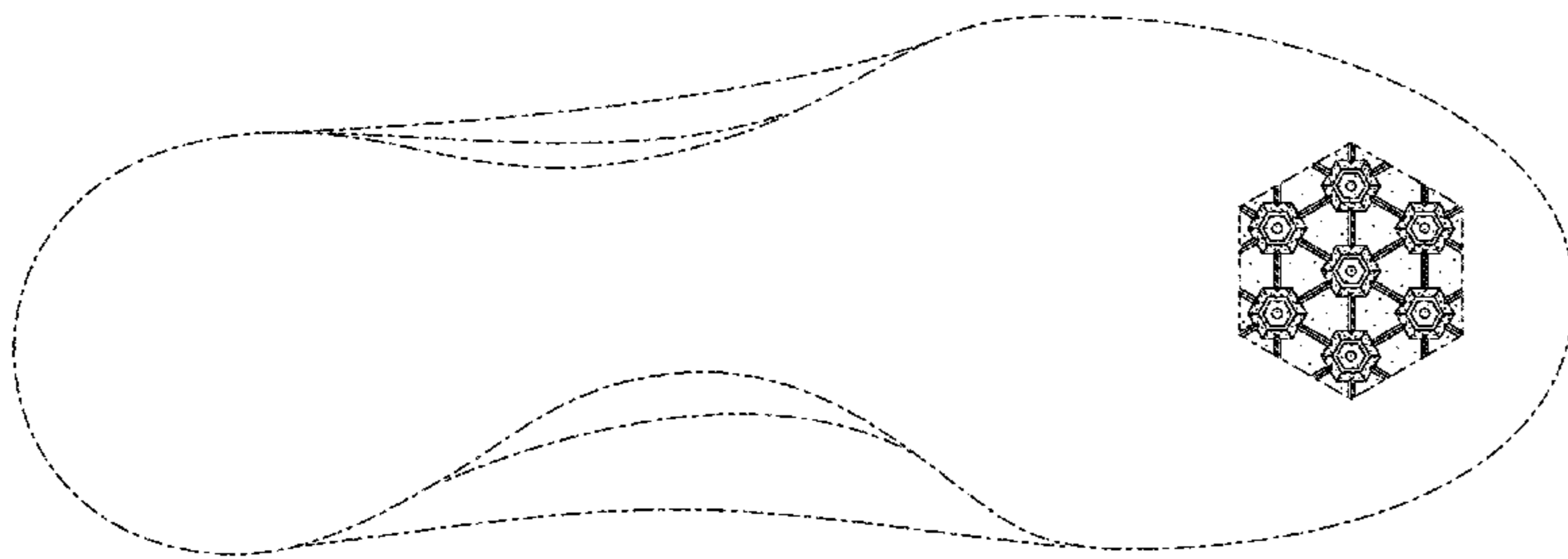
FIG. 4 is an enlarged view of FIG. 1 with disclaimed features removed for clarity;

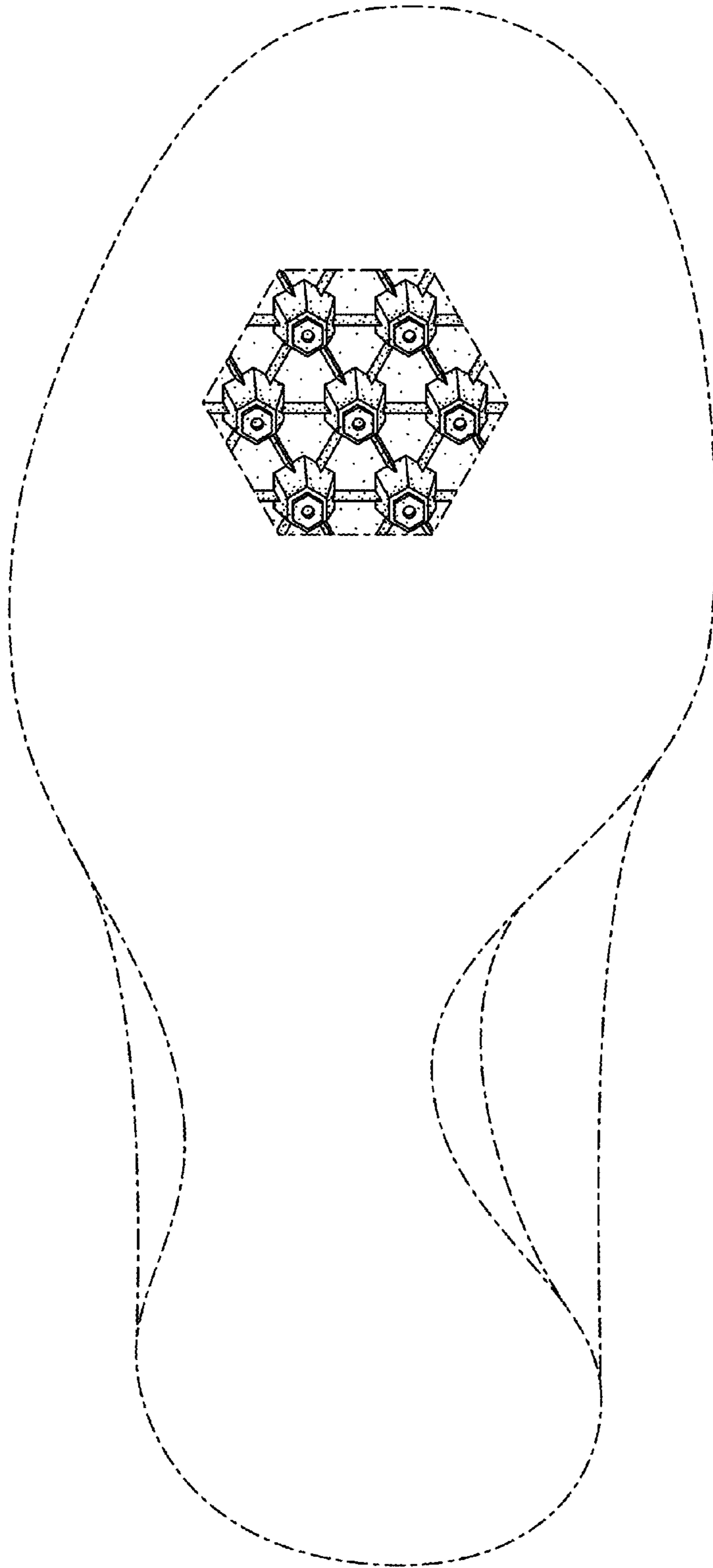

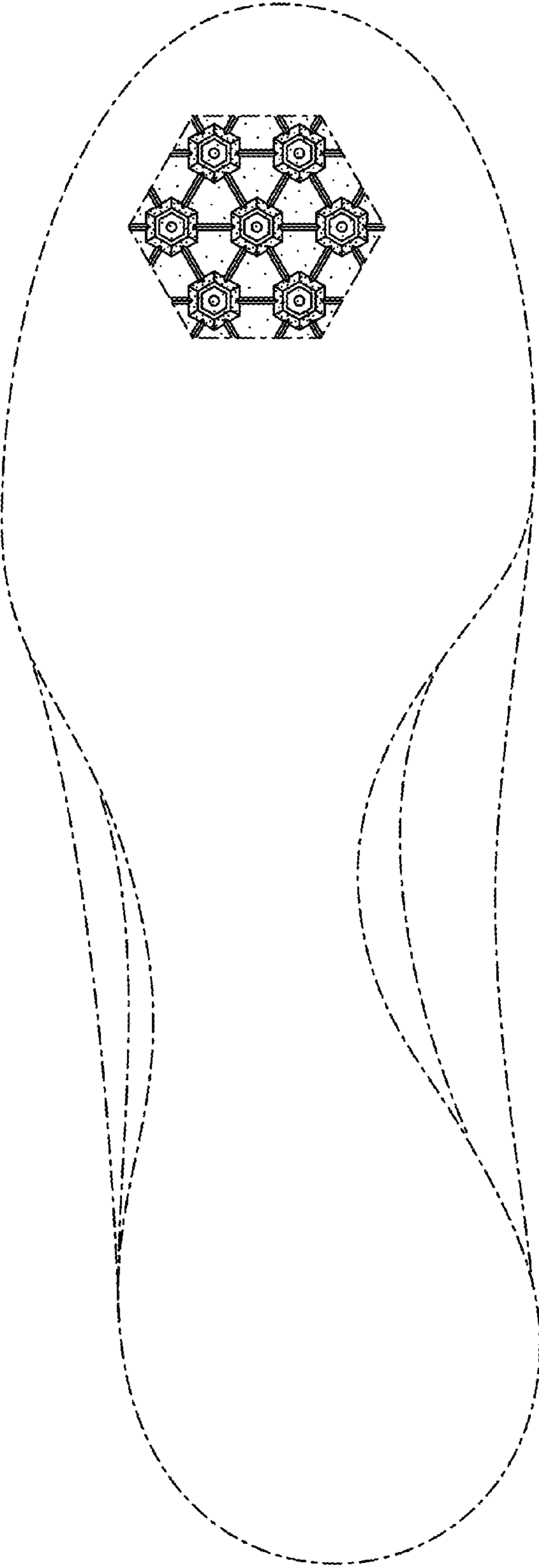

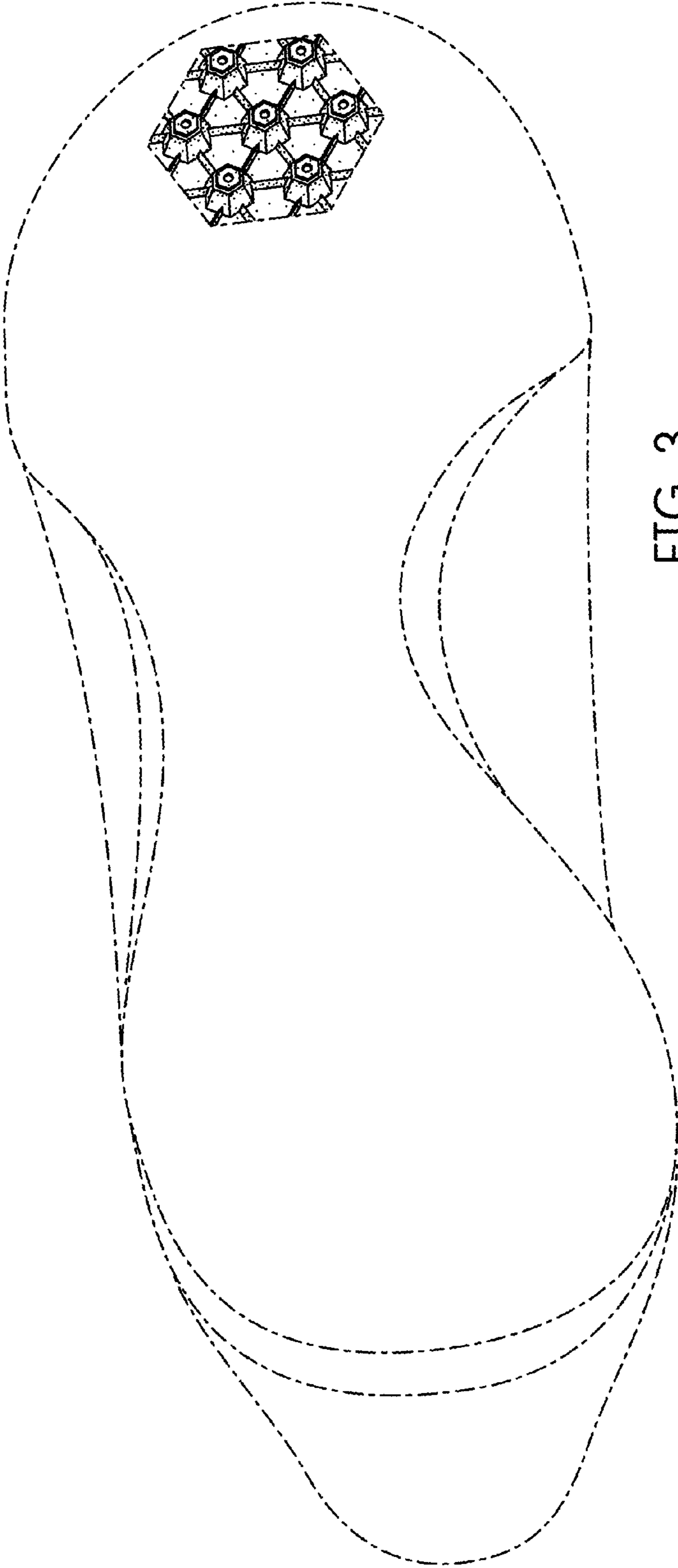

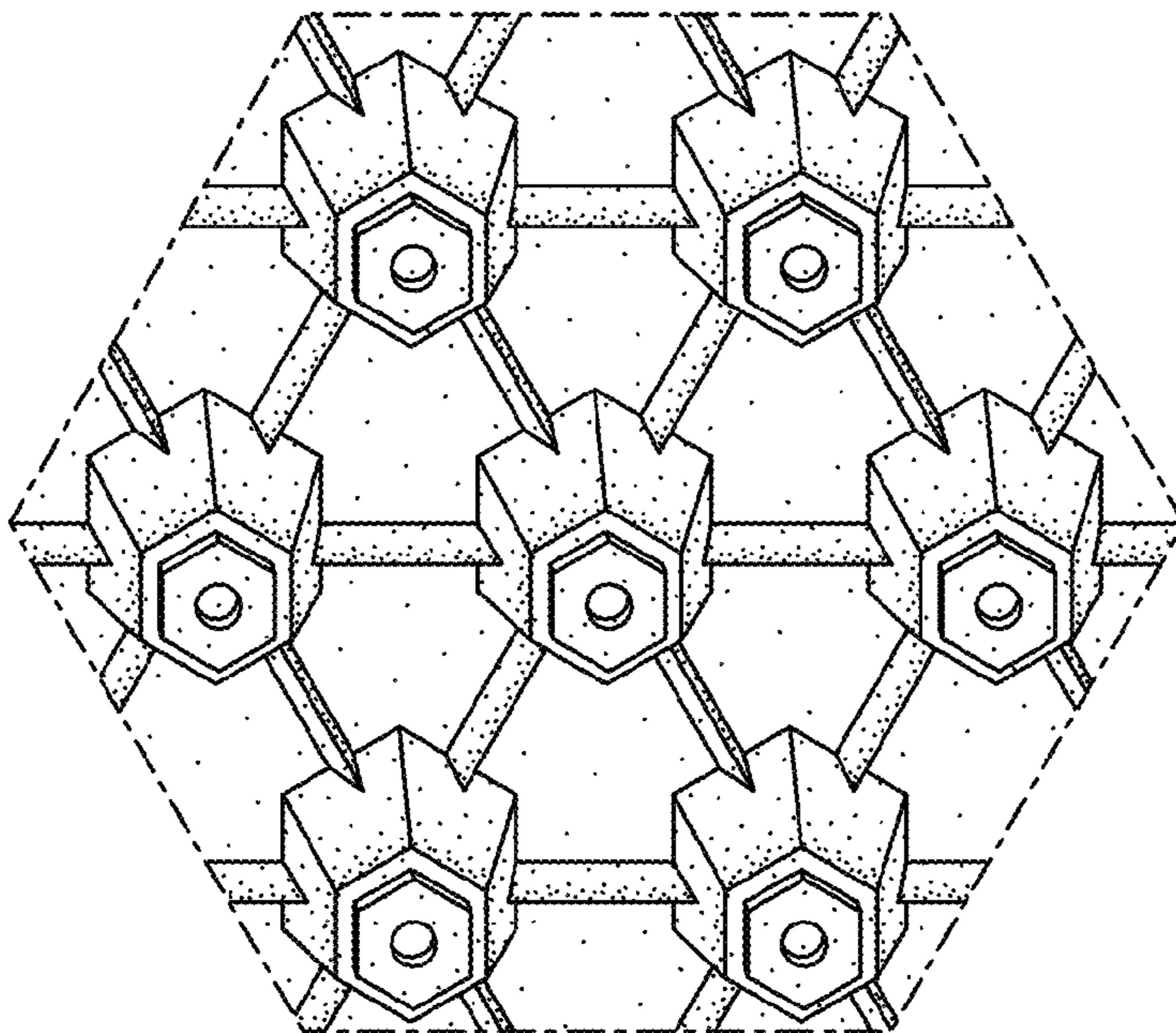

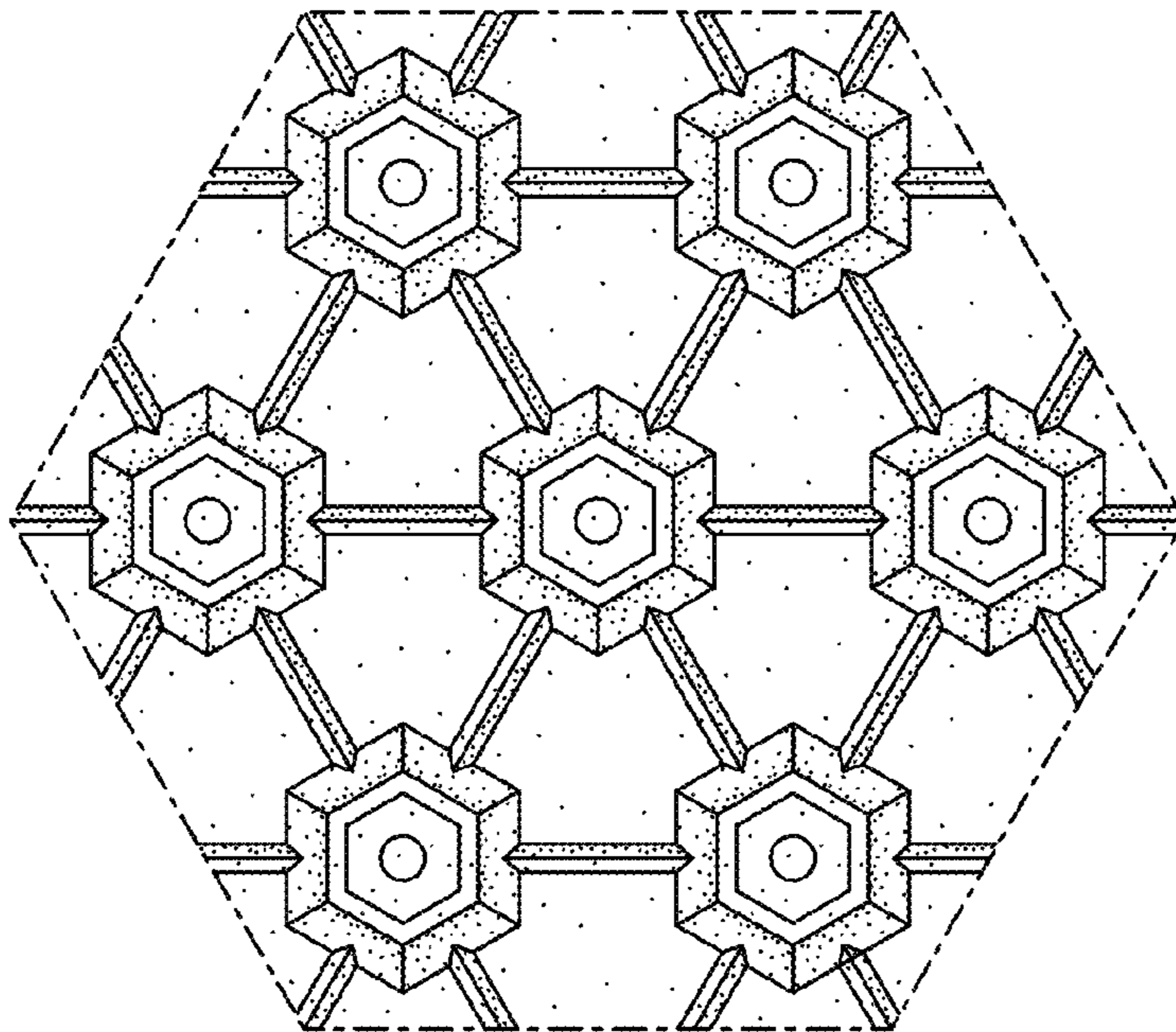

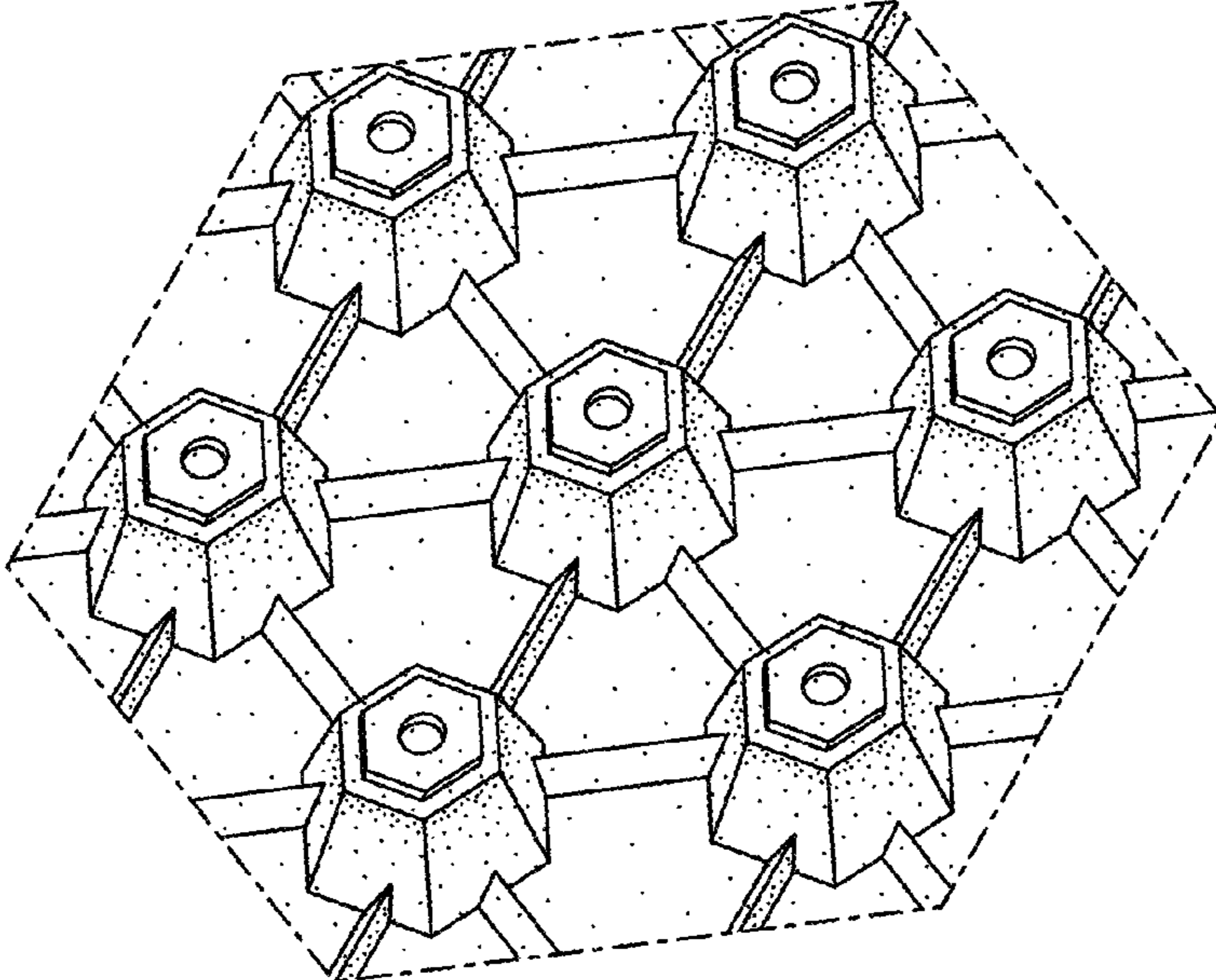
