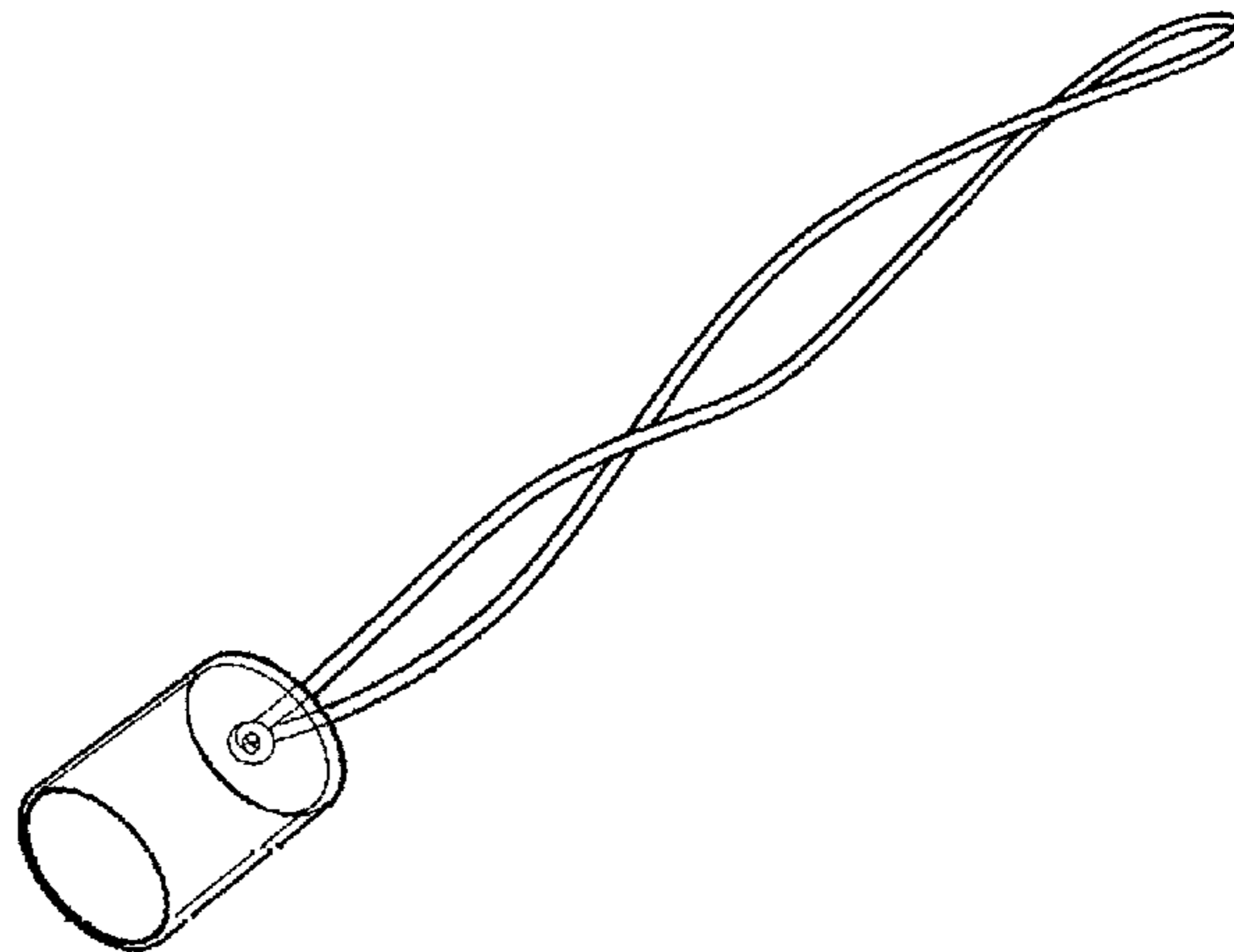
(57) **CLAIM**

The ornamental design for a bottle holder, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a bottle holder in accordance with the design;
 FIG. 2 is a rear perspective view thereof;
 FIG. 3 is a side view thereof;
 FIG. 4 is a front end view thereof, with the string element shown in an alternate state; and,
 FIG. 5 is a rear end view thereof, with the string element shown in an alternate state.

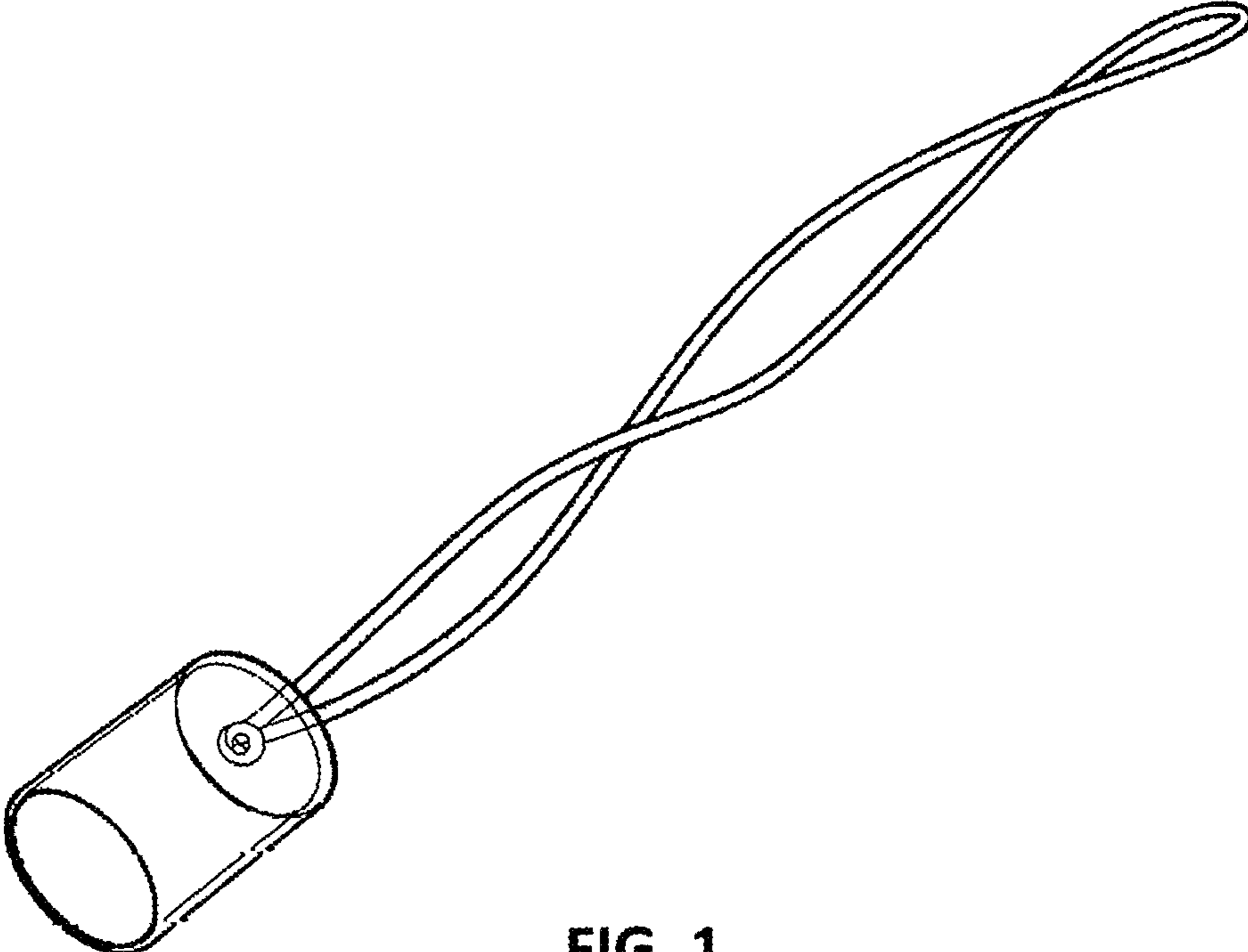

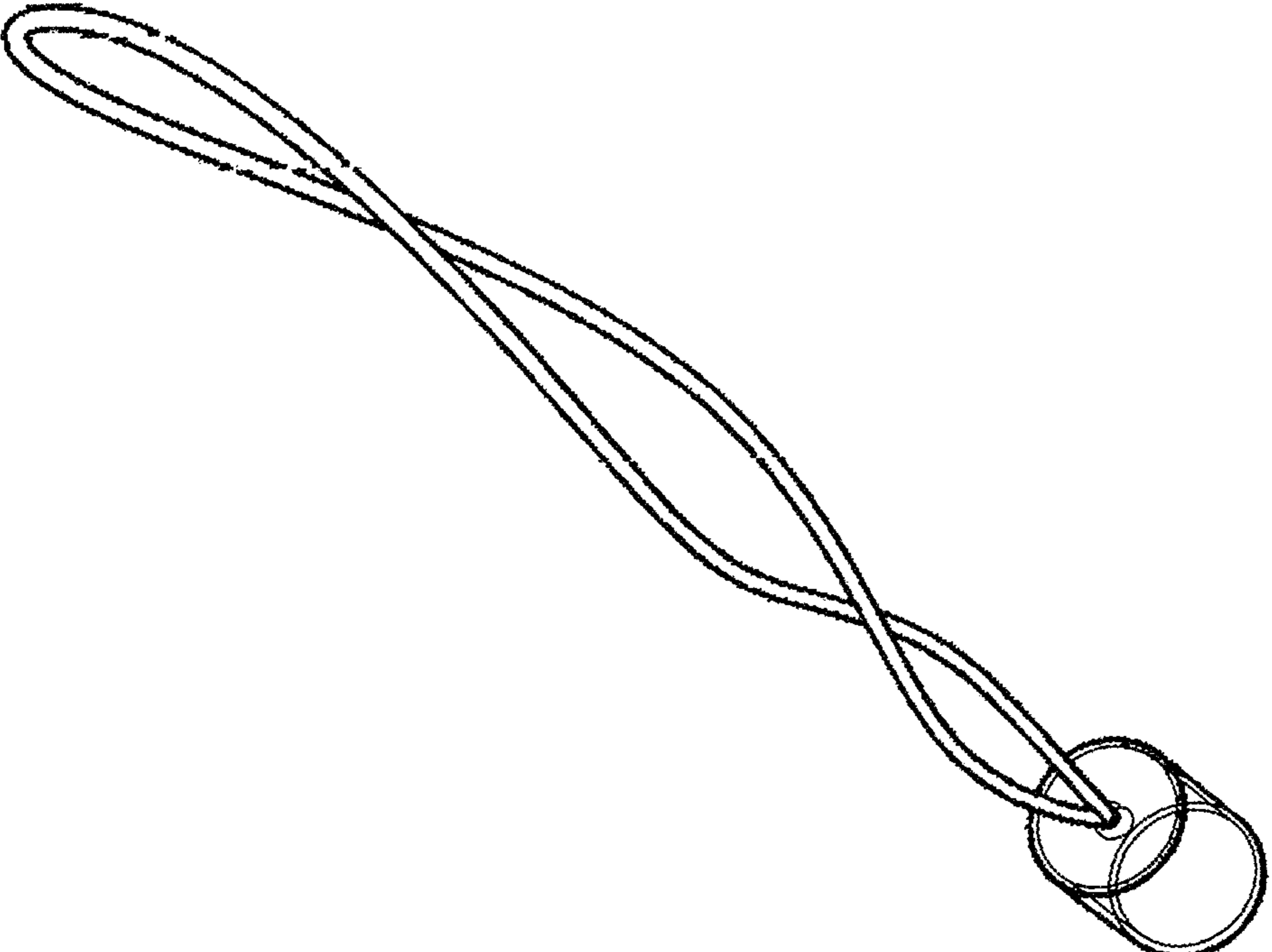

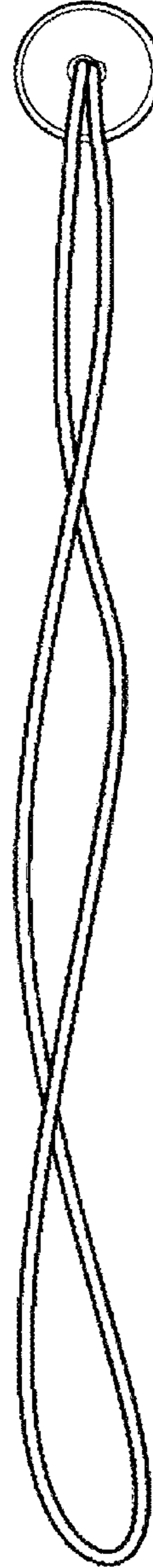
