(57) **CLAIM**

The ornamental design for a flexible carry and display bag, as shown and described.

DESCRIPTION

FIG. 1 is a top, perspective view of a flexible carry and display bag, showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof, opposite that shown in FIG. 2;

FIG. 4 is a side view thereof;

FIG. 5 is a side view thereof, opposite that shown in FIG. 4;

FIG. 6 is an end view thereof;

FIG. 7 is an end view thereof, opposite that shown in FIG. 6;

FIG. 8 is a top, front perspective view of the flexible carry and display bag of FIGS. 1-7 in a display/carry configuration and illustrating exemplary contents (shown as pillows) therewithin;

FIG. 9 is a front view thereof;

FIG. 10 is a rear view thereof, opposite that shown in FIG. 9;

FIG. 11 is a top view thereof;

FIG. 12 is a bottom view thereof;

FIG. 13 is a side view thereof;

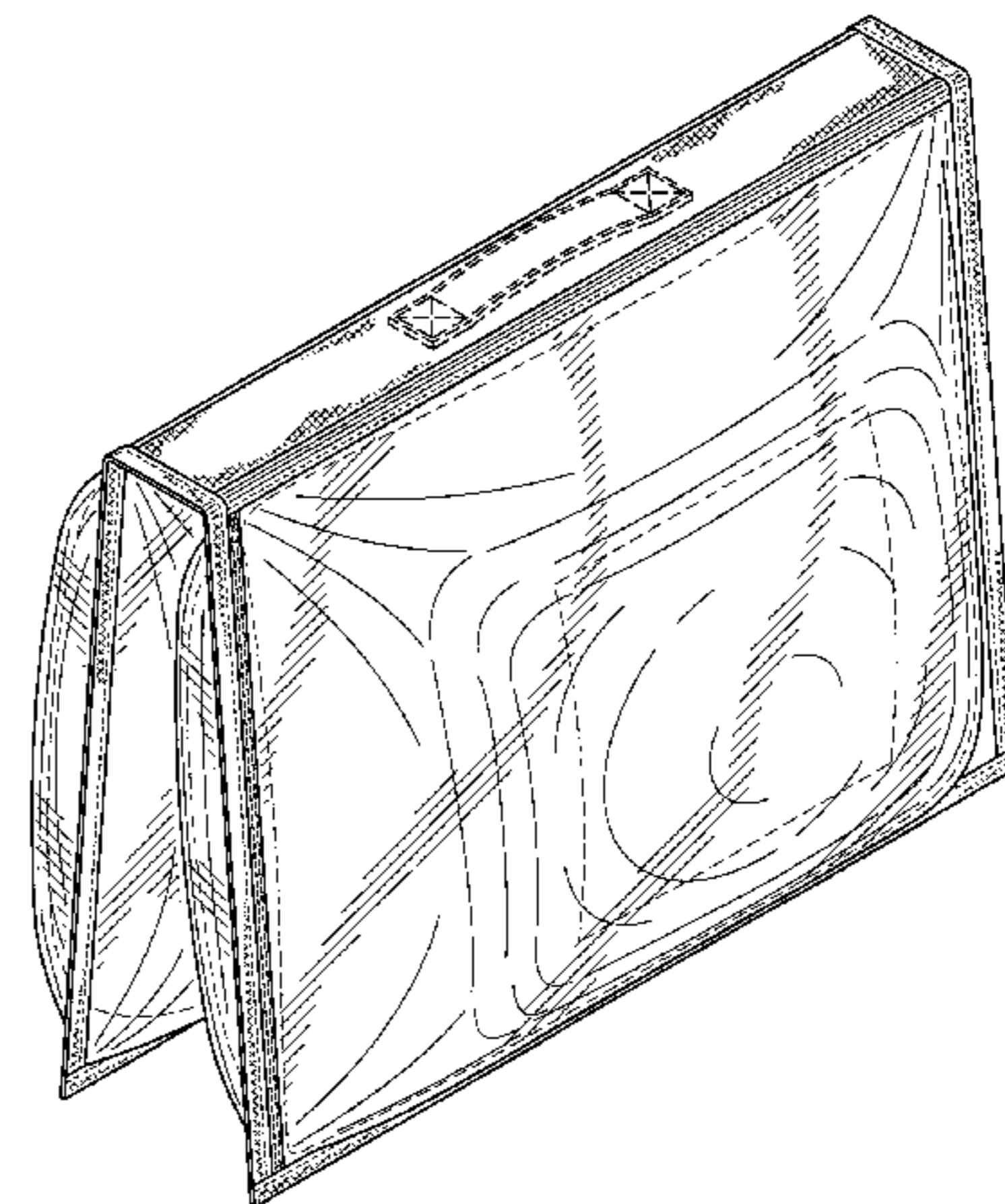
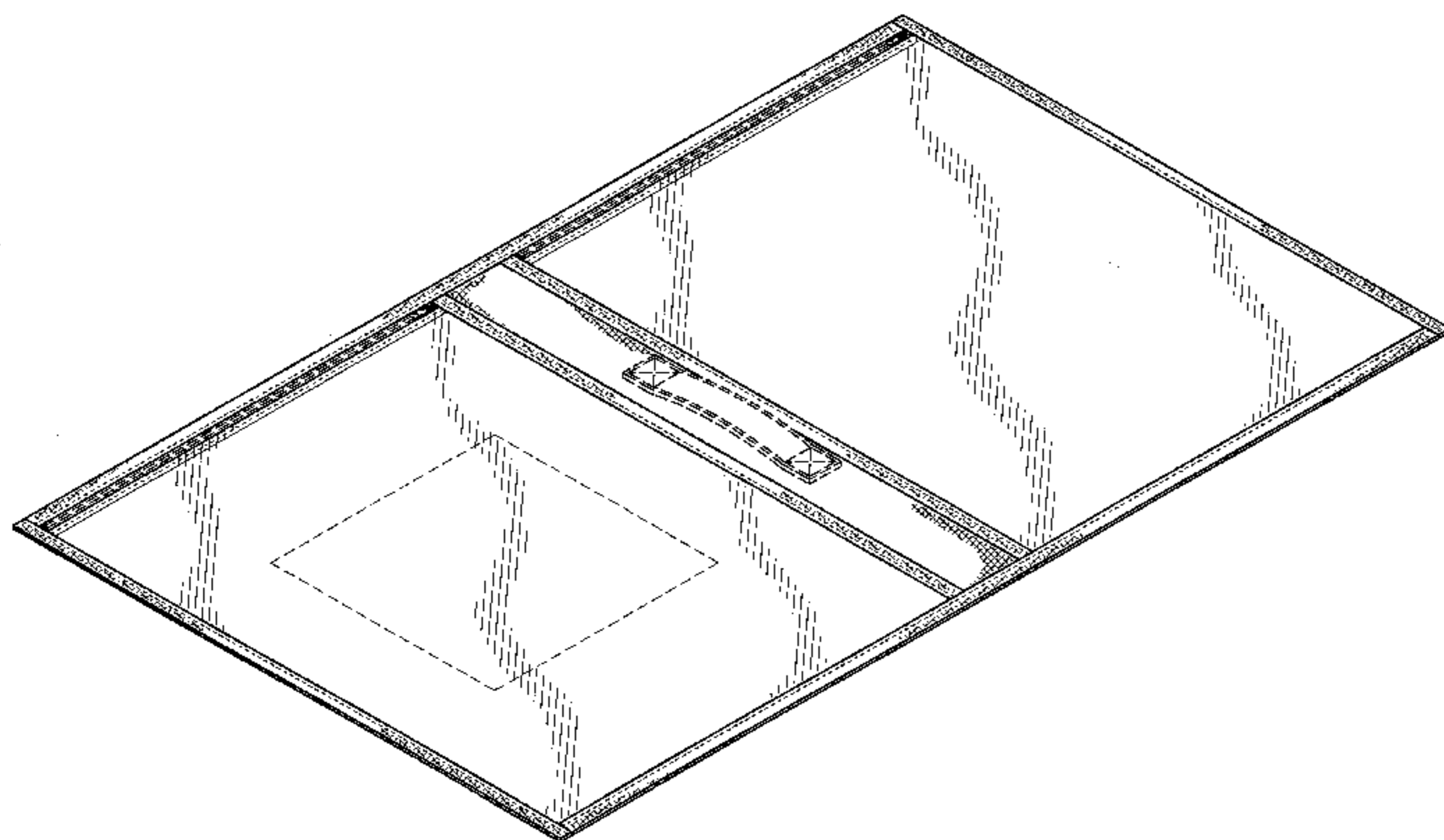
FIG. 14 is a side view thereof, opposite that shown in FIG. 13; and,

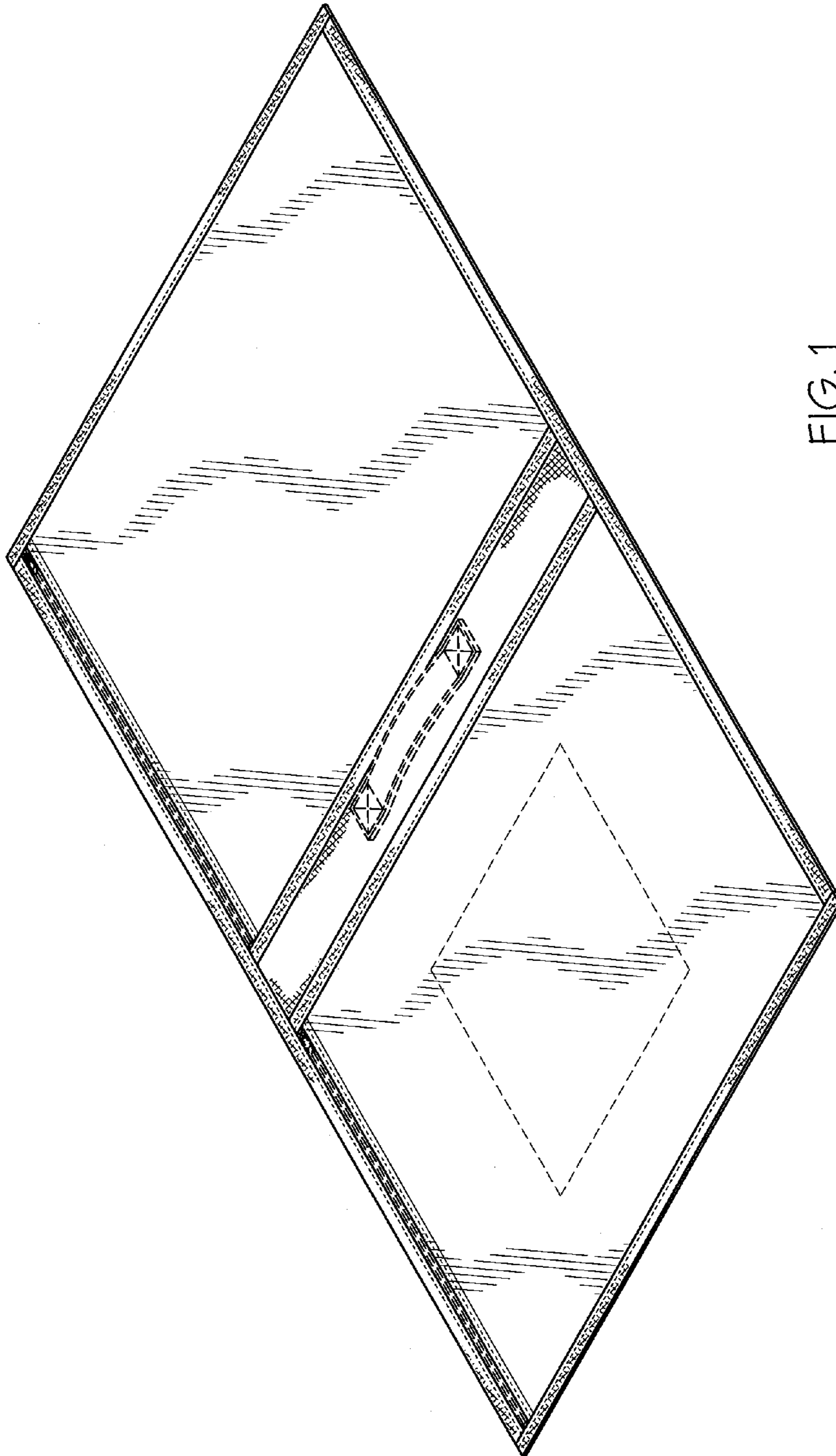

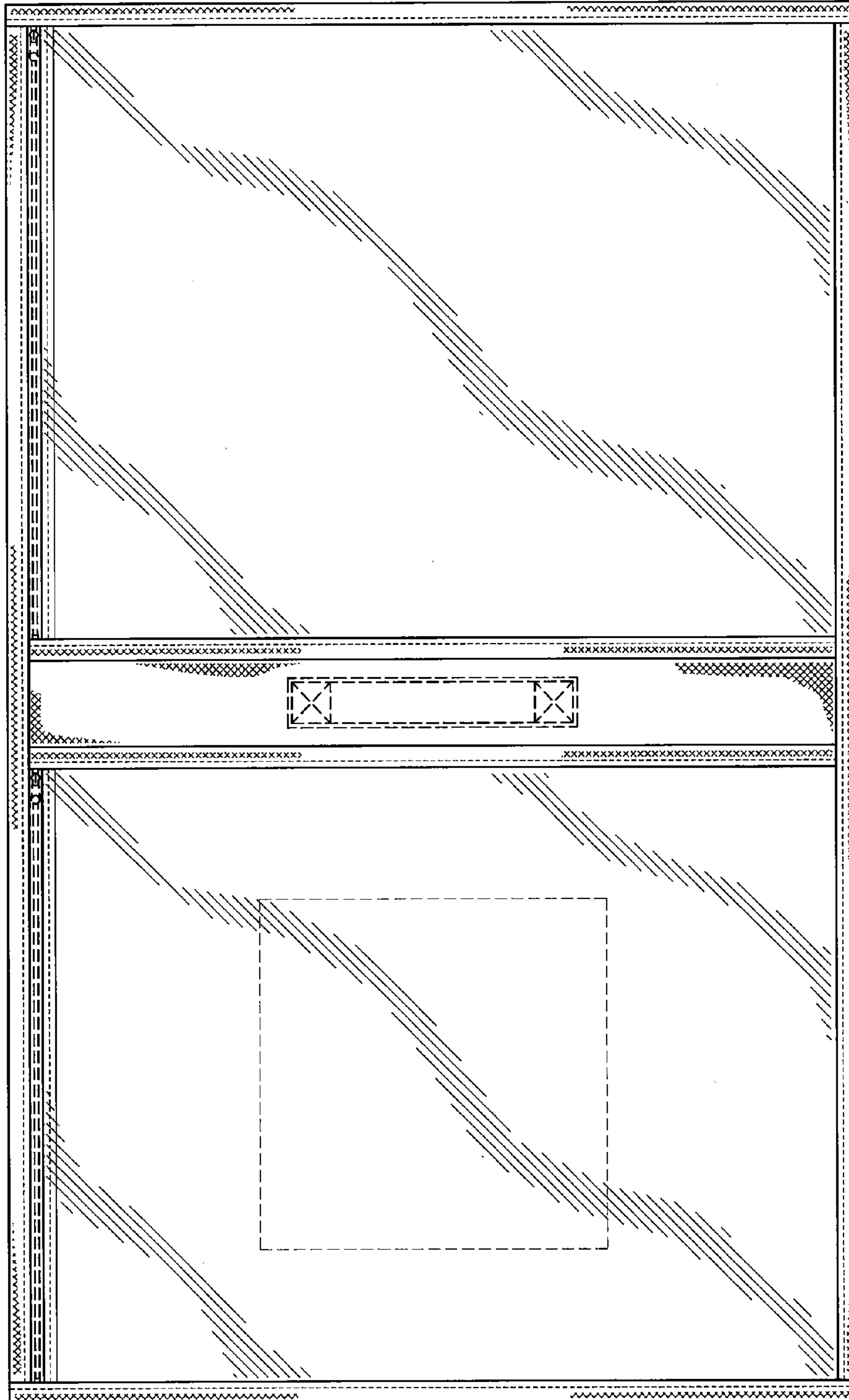

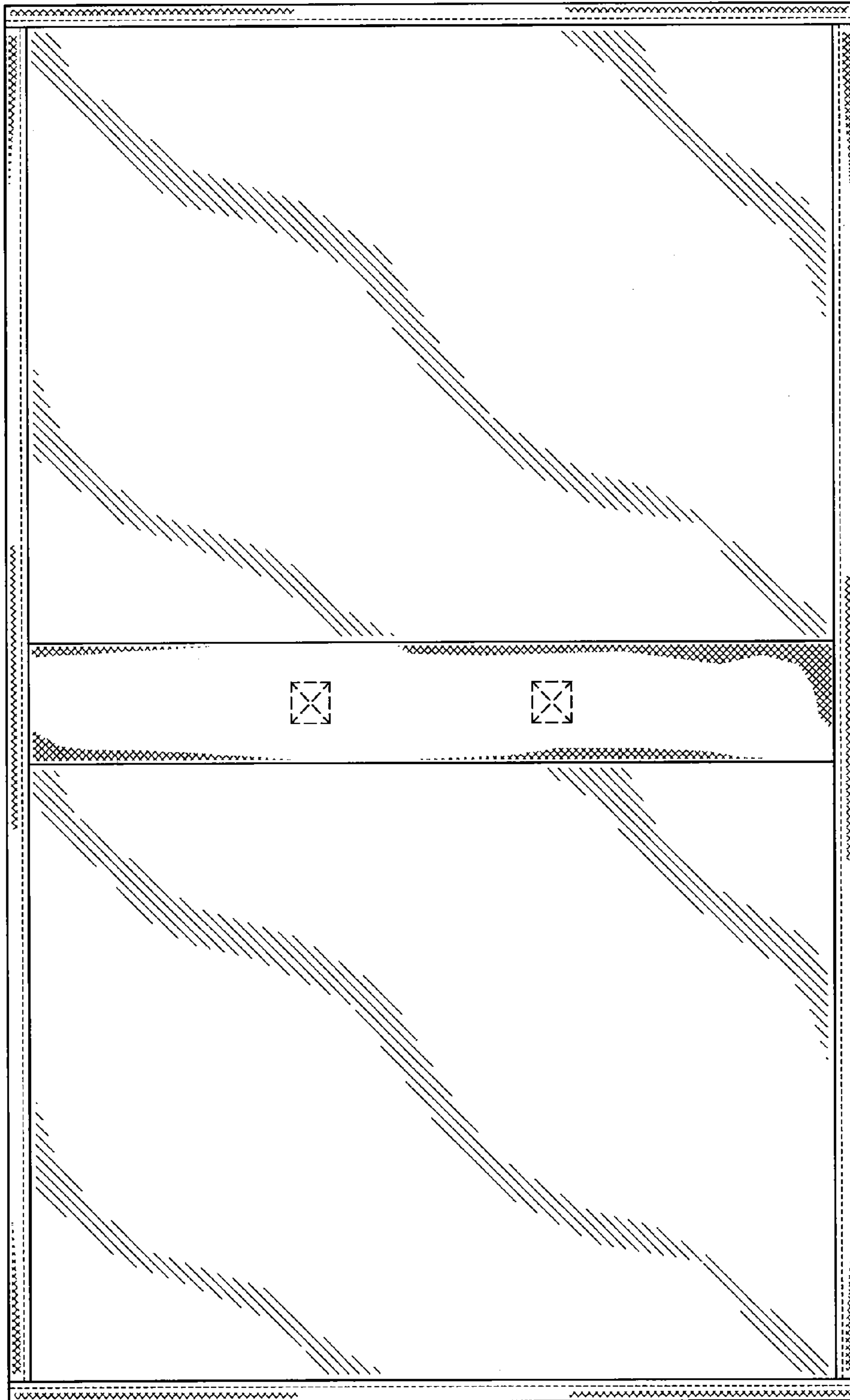

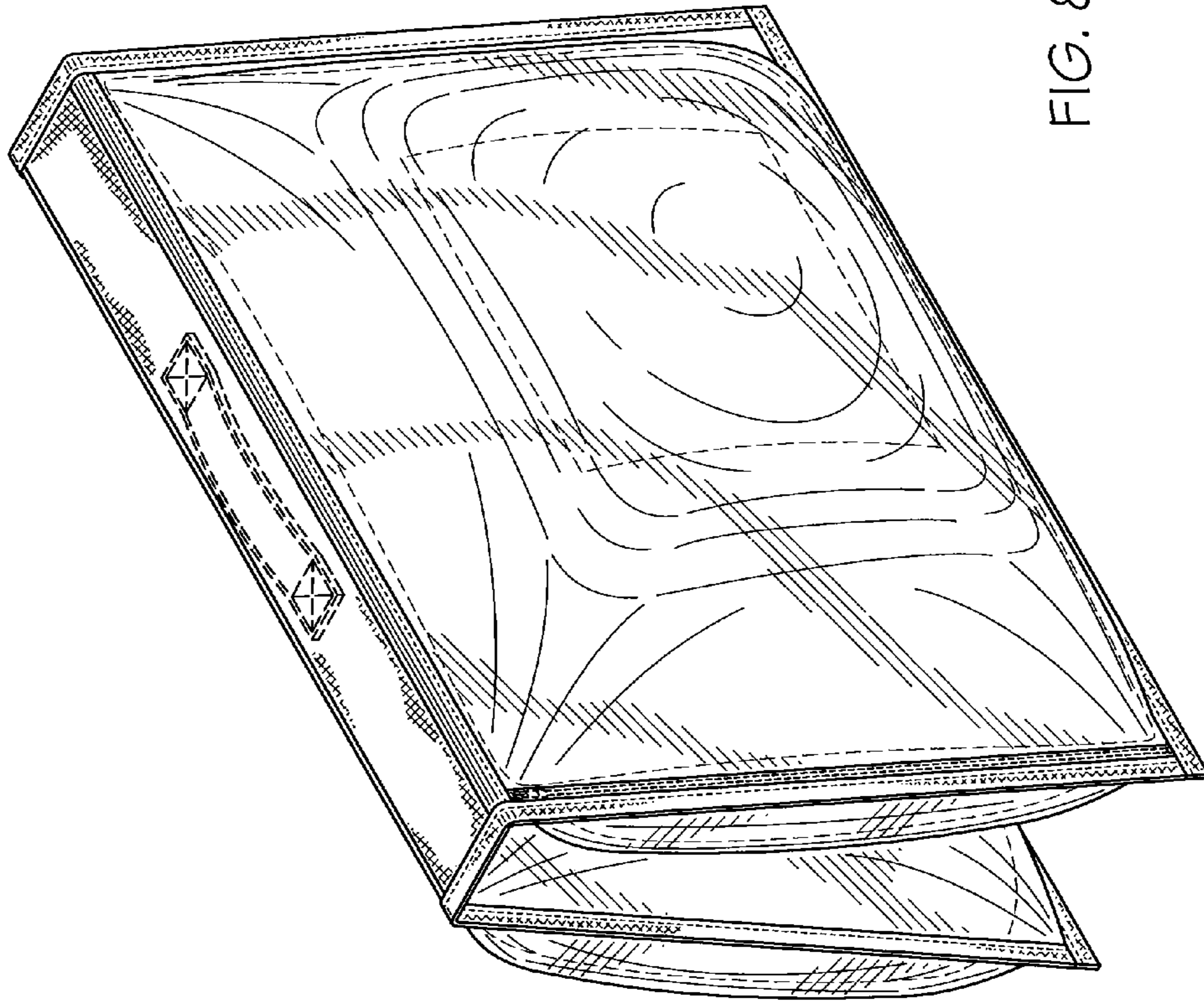

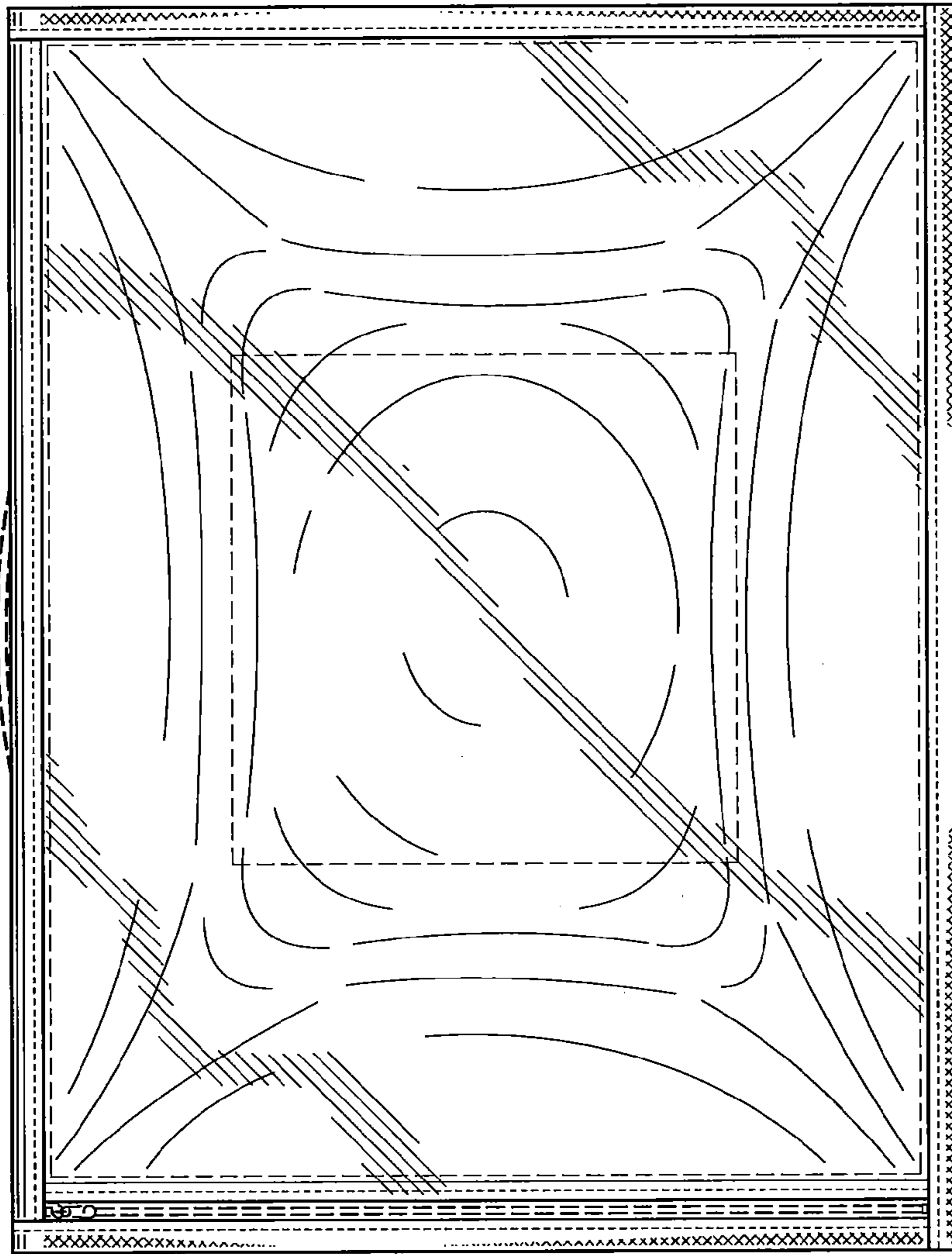

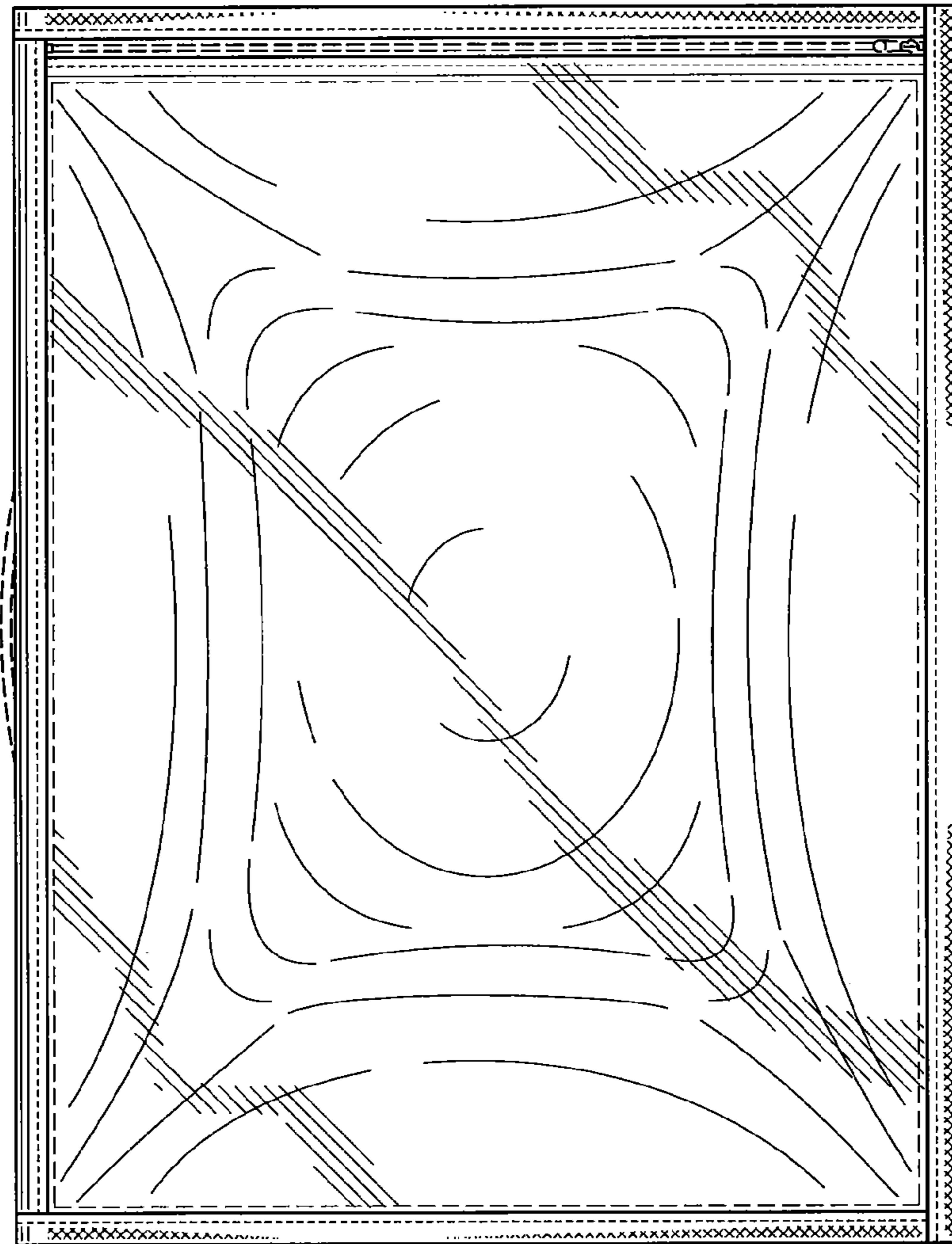

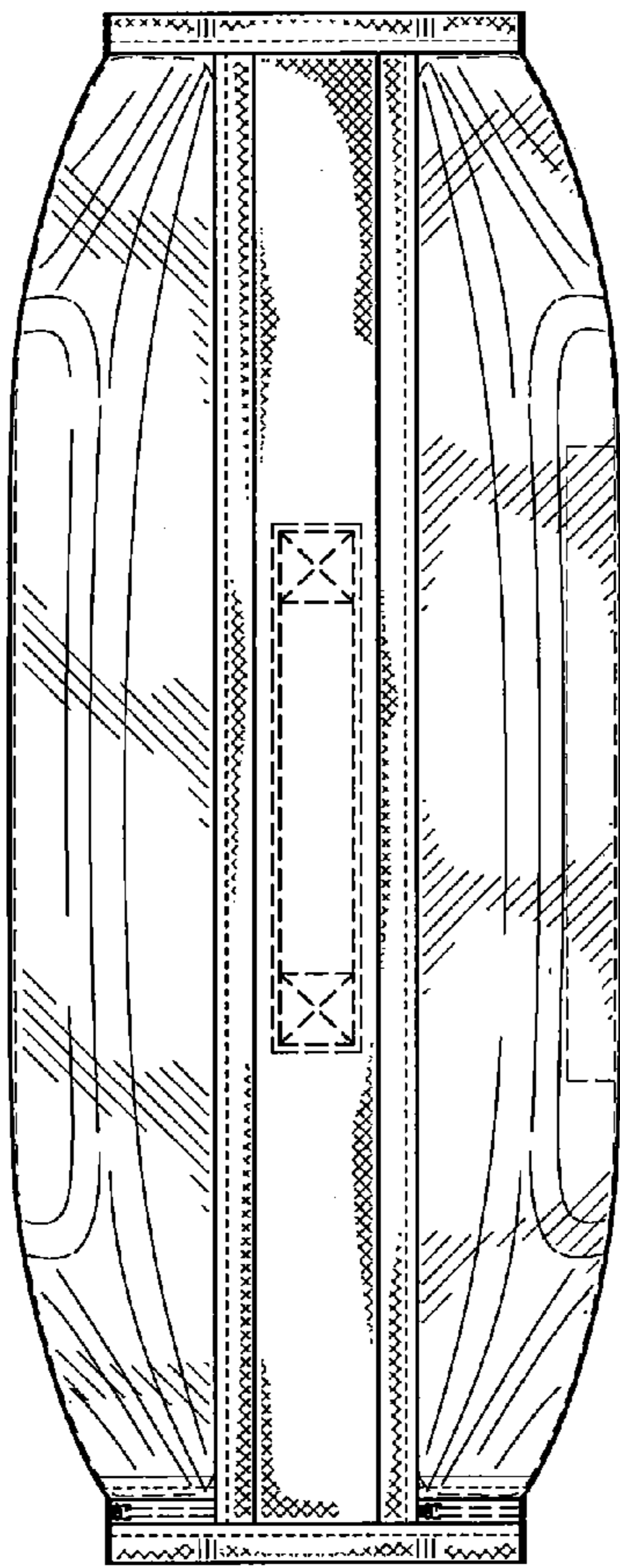

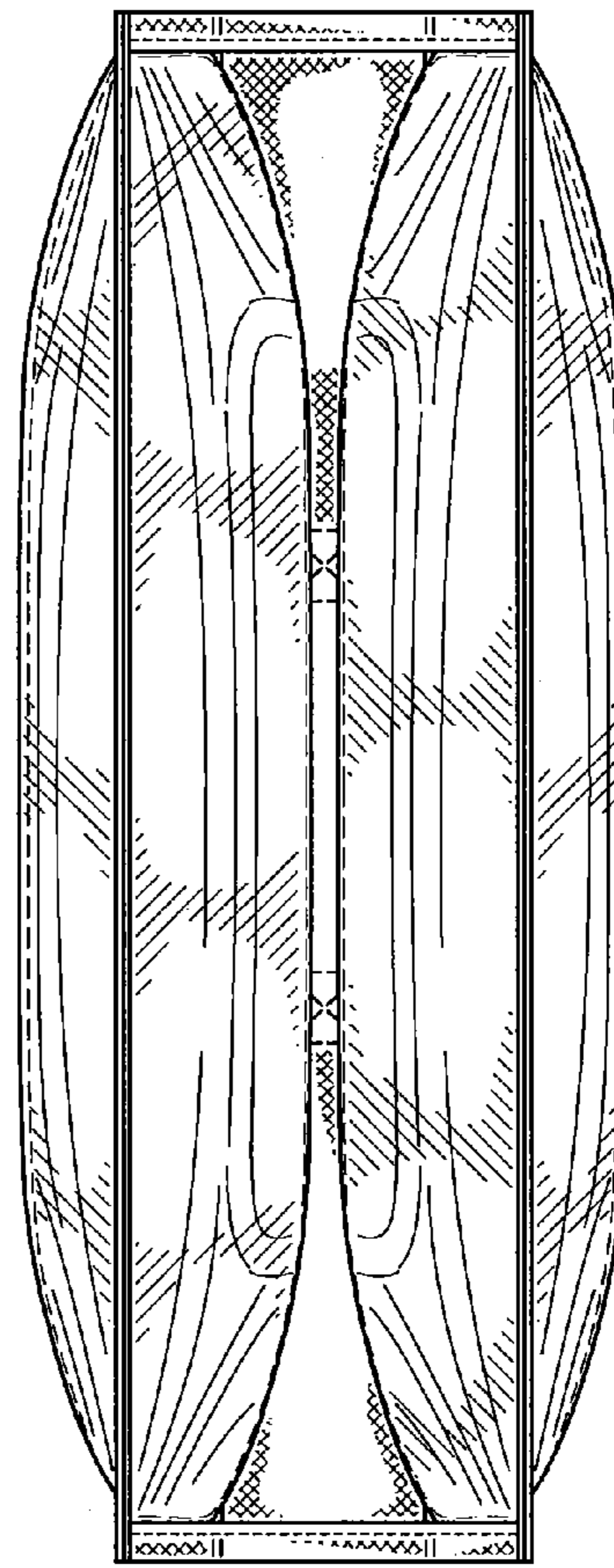

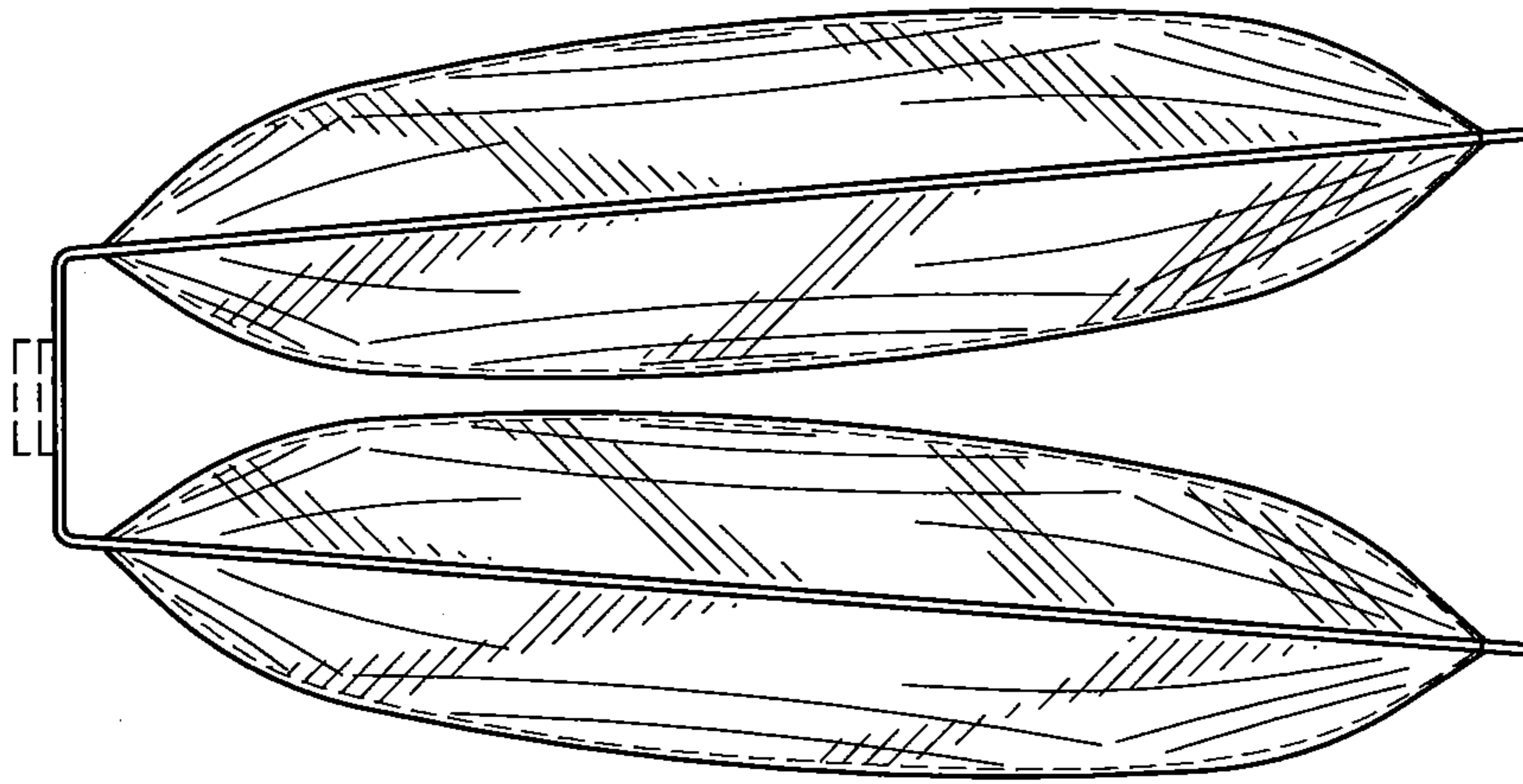

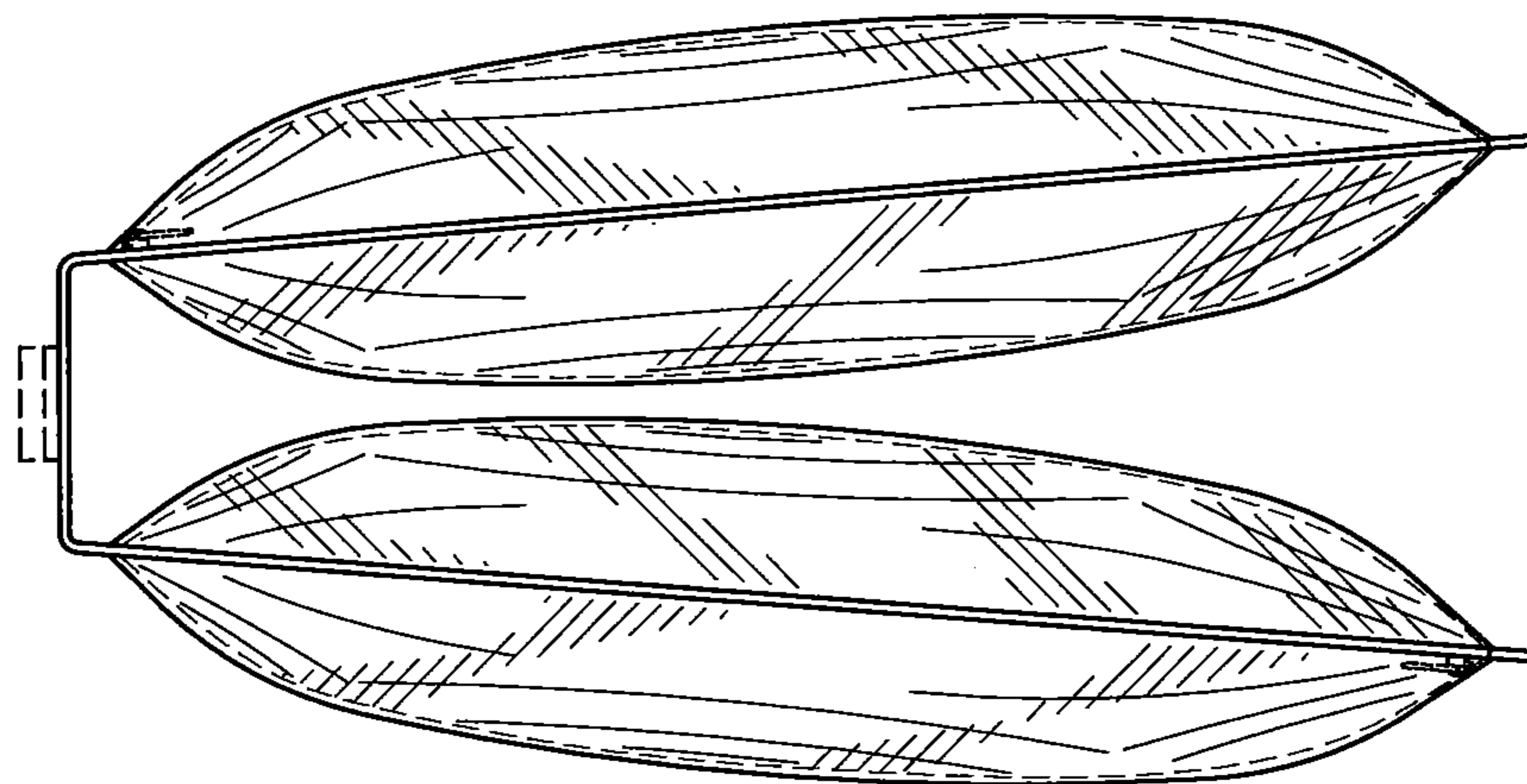

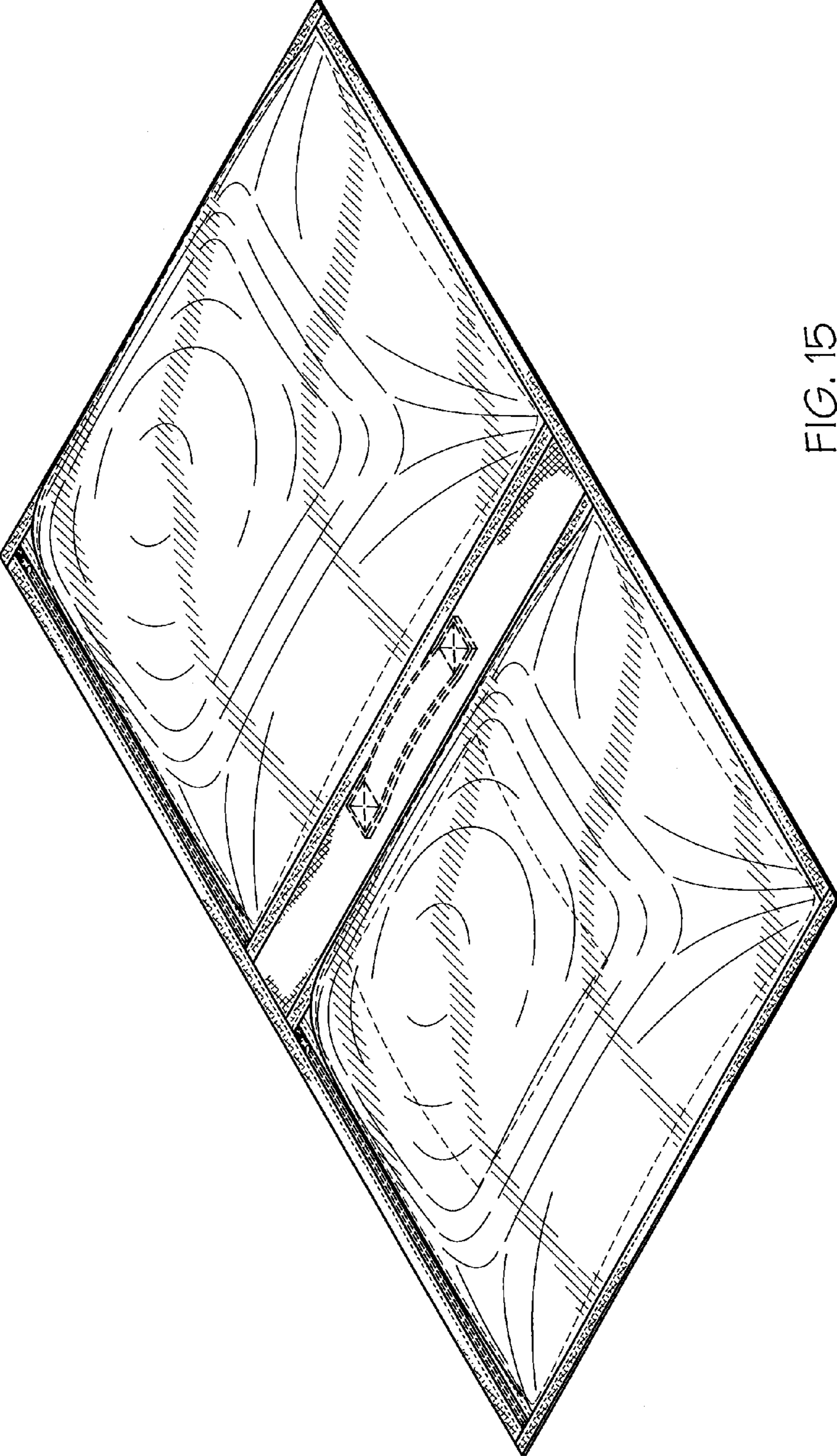
