(57) **CLAIM**

The ornamental design for a ring box, as shown and described.

**DESCRIPTION**

FIG. 1 is an elevated front right perspective view of an assembled ring box, the shading illustrates a plush fabric outer covering.

FIG. 2 is a right side elevation view thereof;

FIG. 3 is a left side elevation view thereof;

FIG. 4 is a rear elevation view thereof;

FIG. 5 is a front elevation view thereof;

FIG. 6 is a bottom plan view thereof;

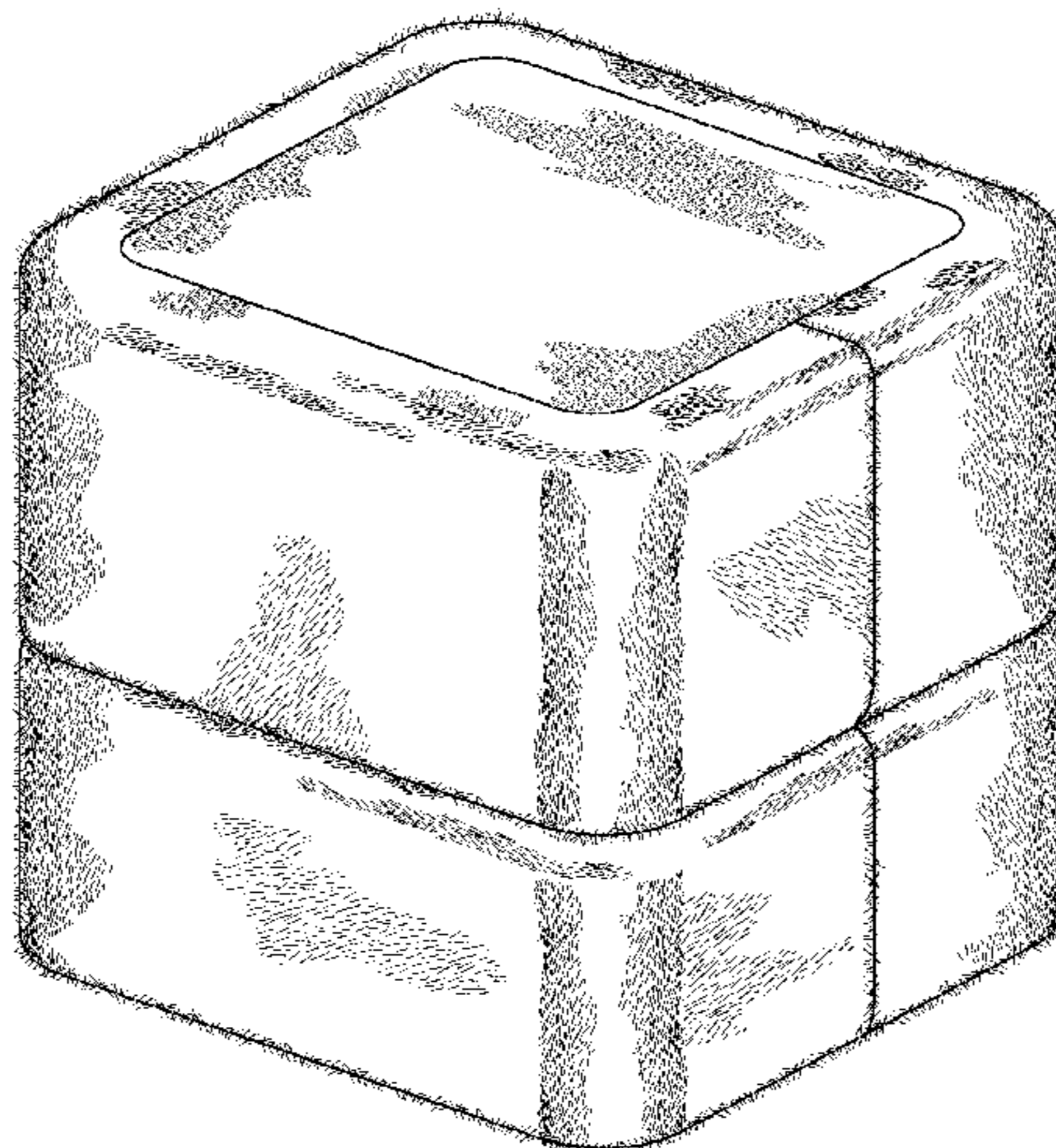
FIG. 7 is a top plan view thereof;

FIG. 8 is a right side perspective view of the ring box in FIG. 1 with the lid shown removed and adjacent to the main body part of the box; and,

FIG. 9 is a top plan view thereof.

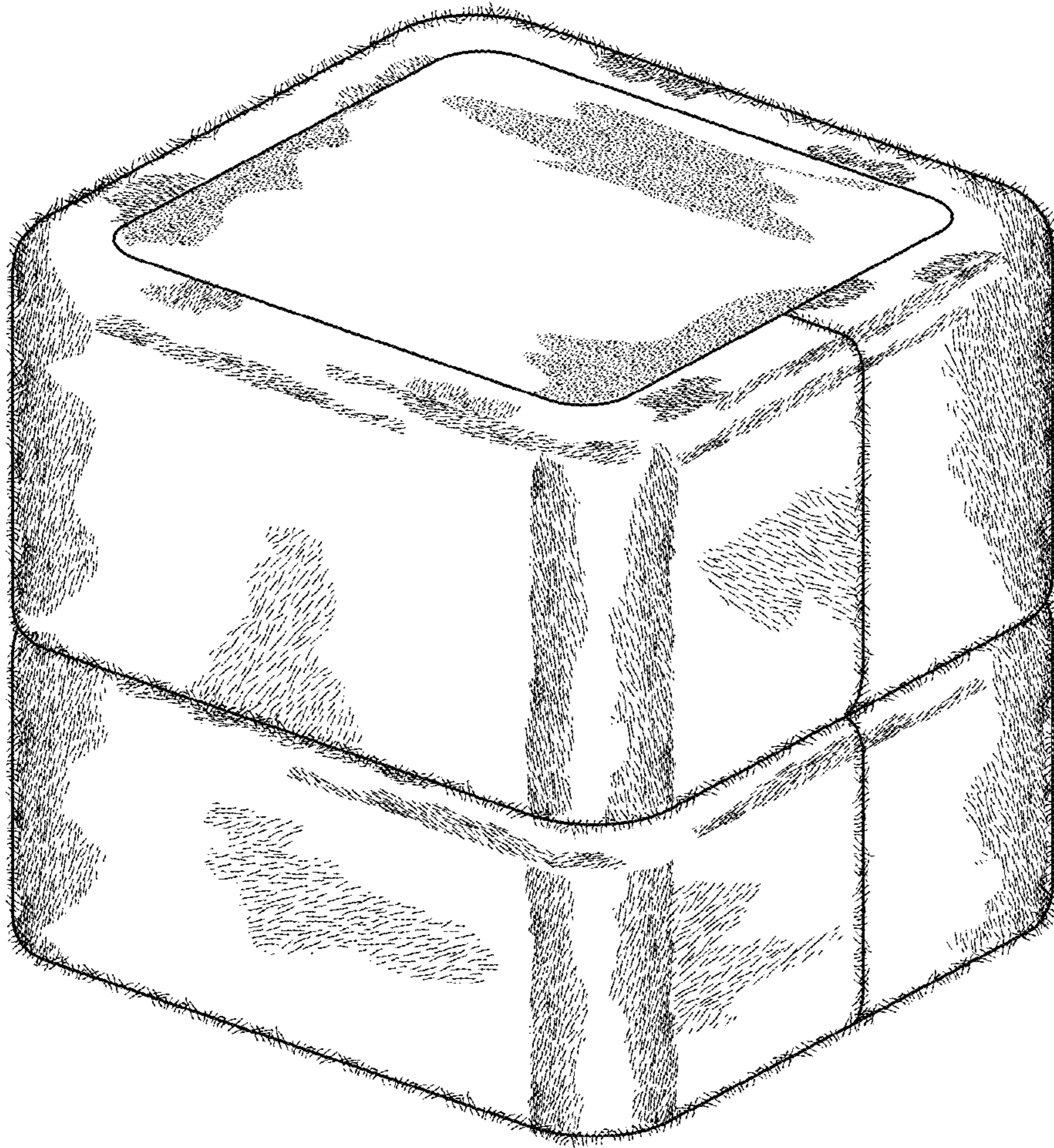

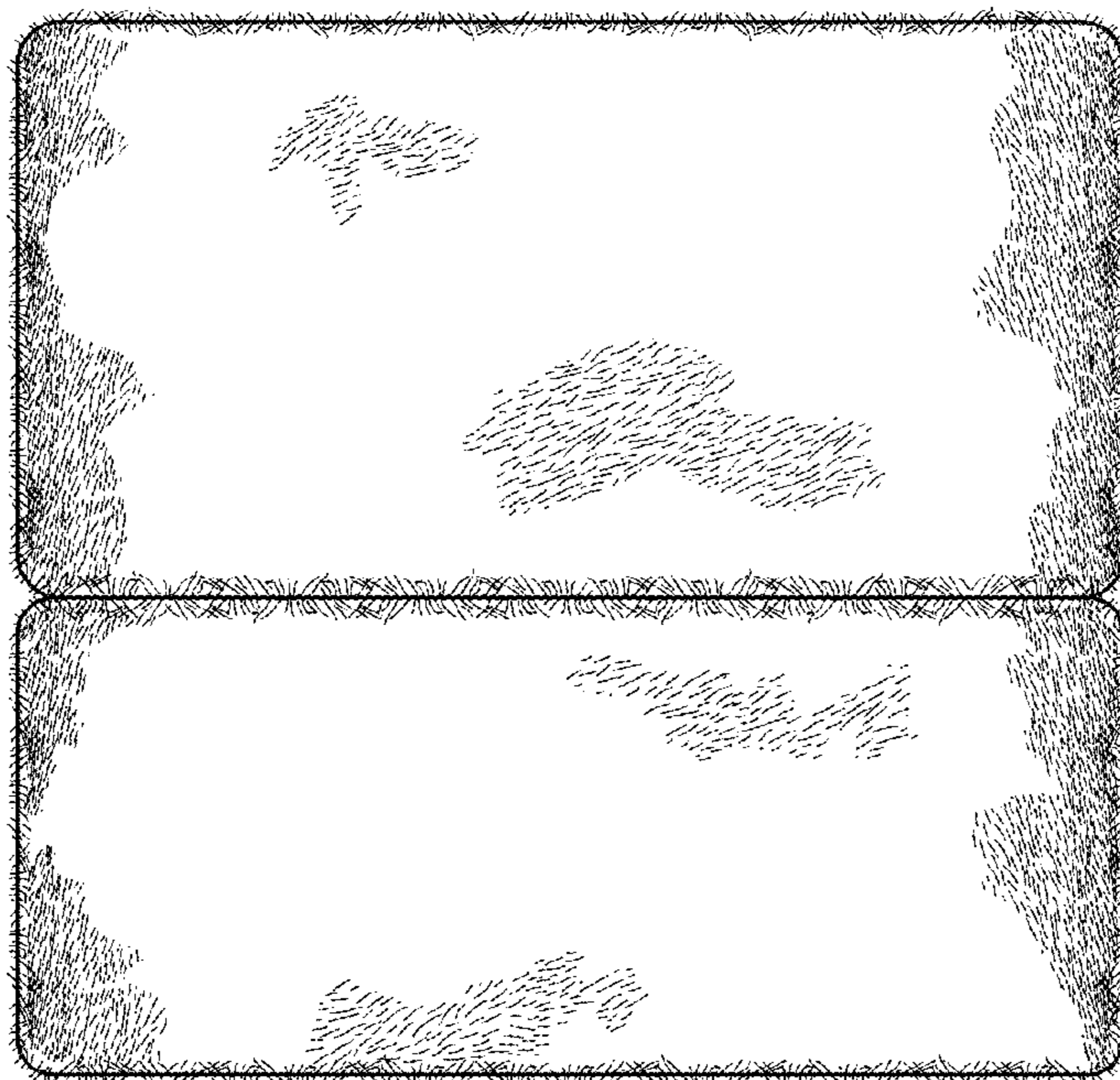

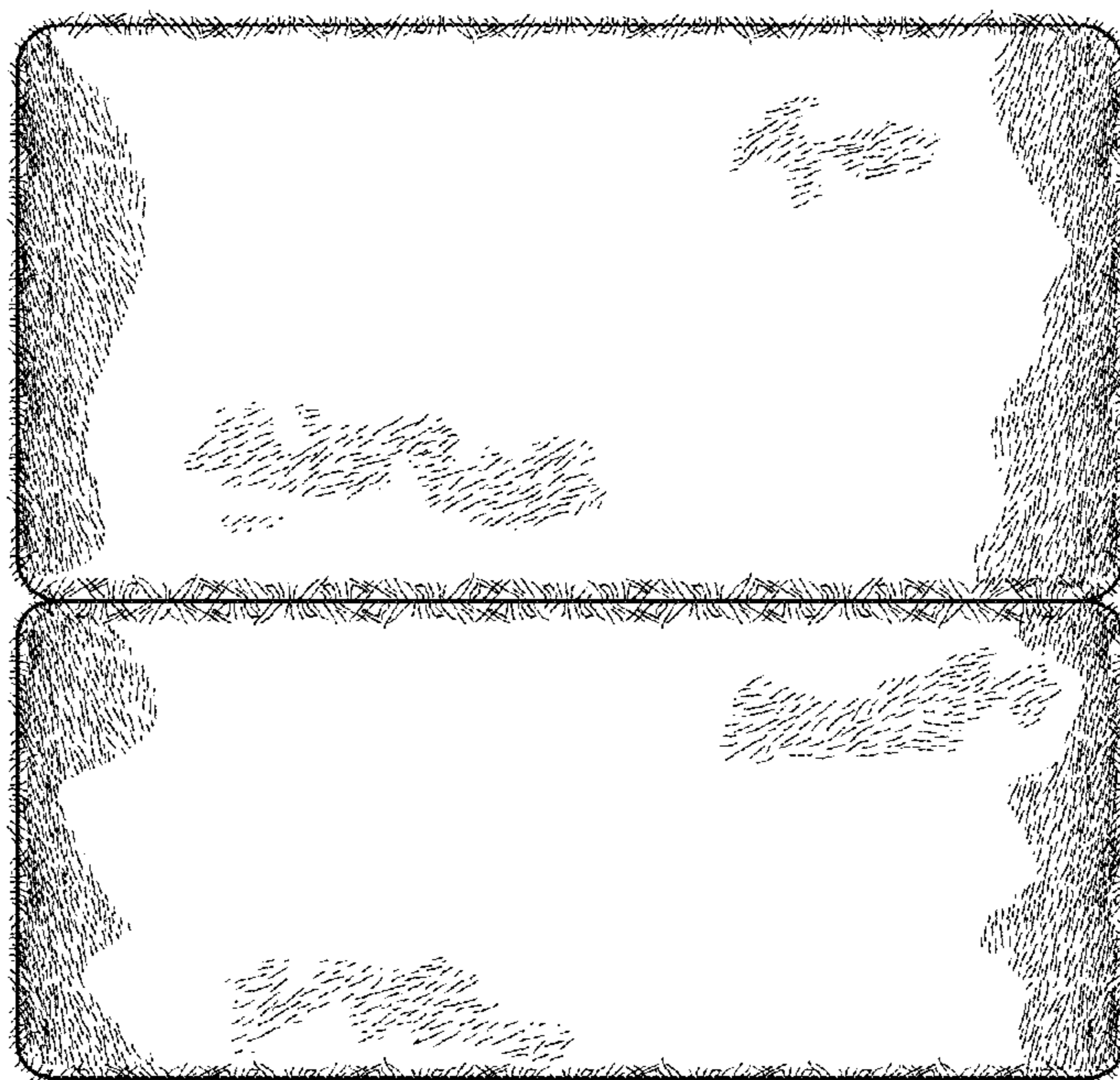

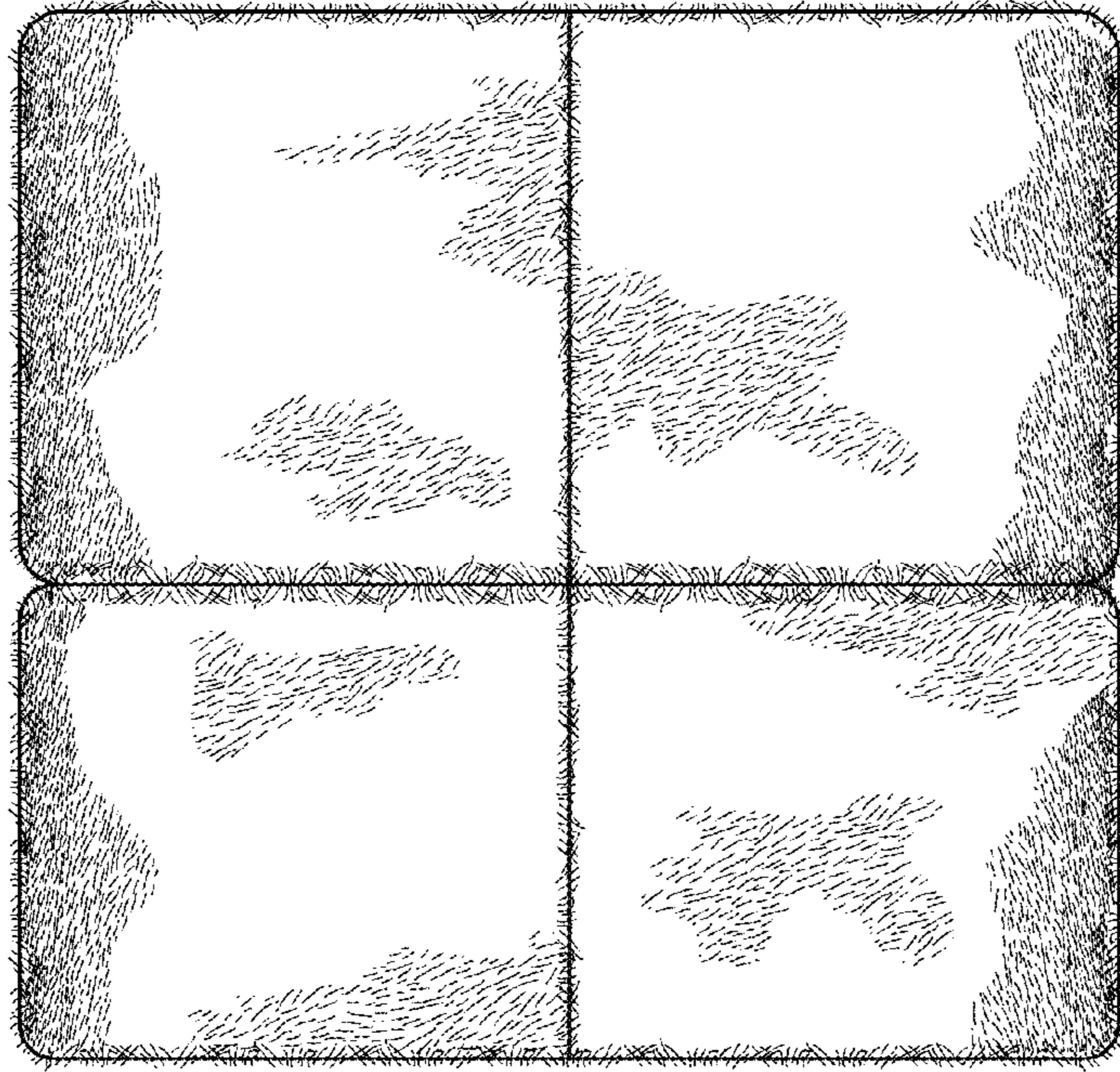

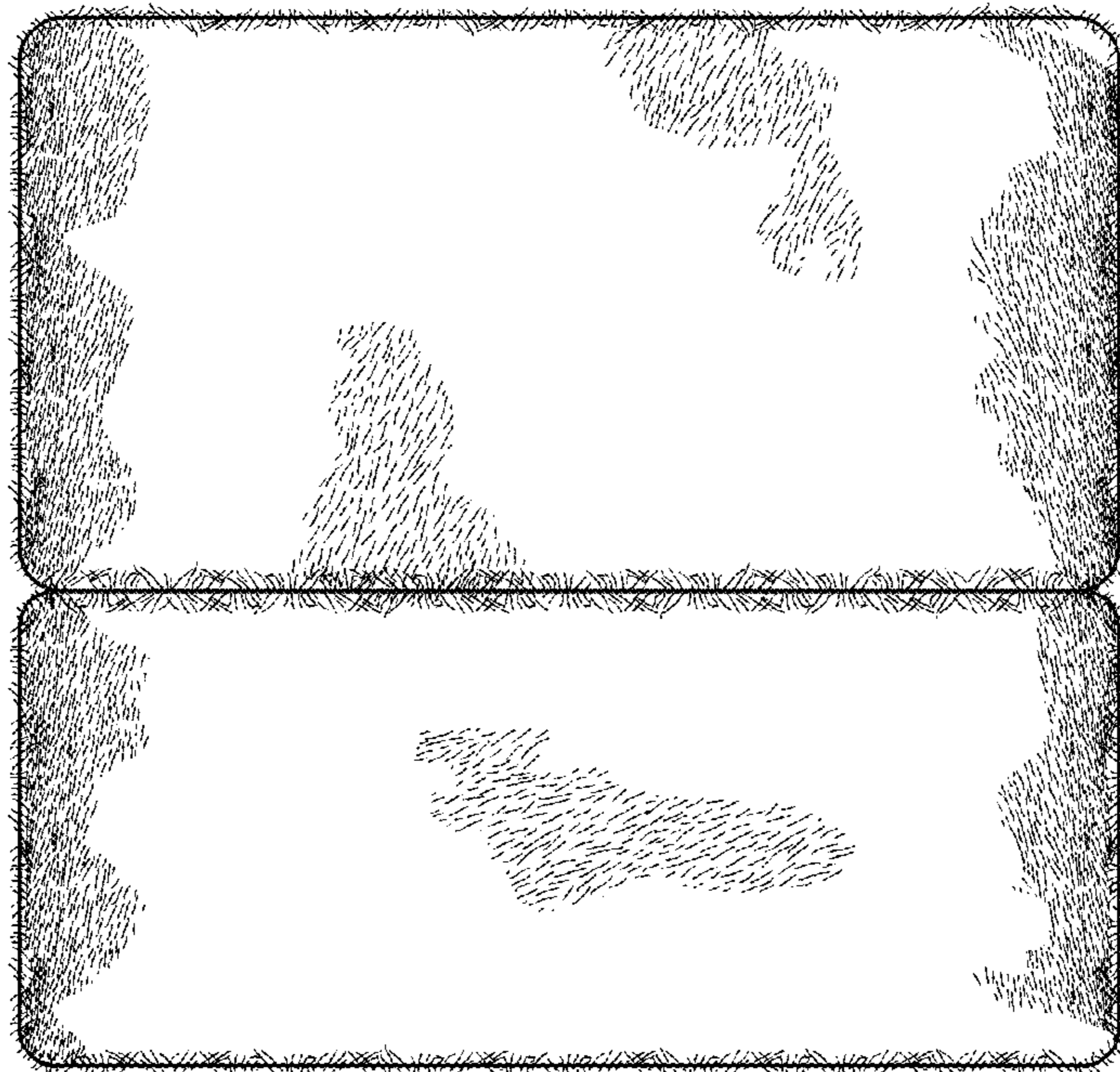

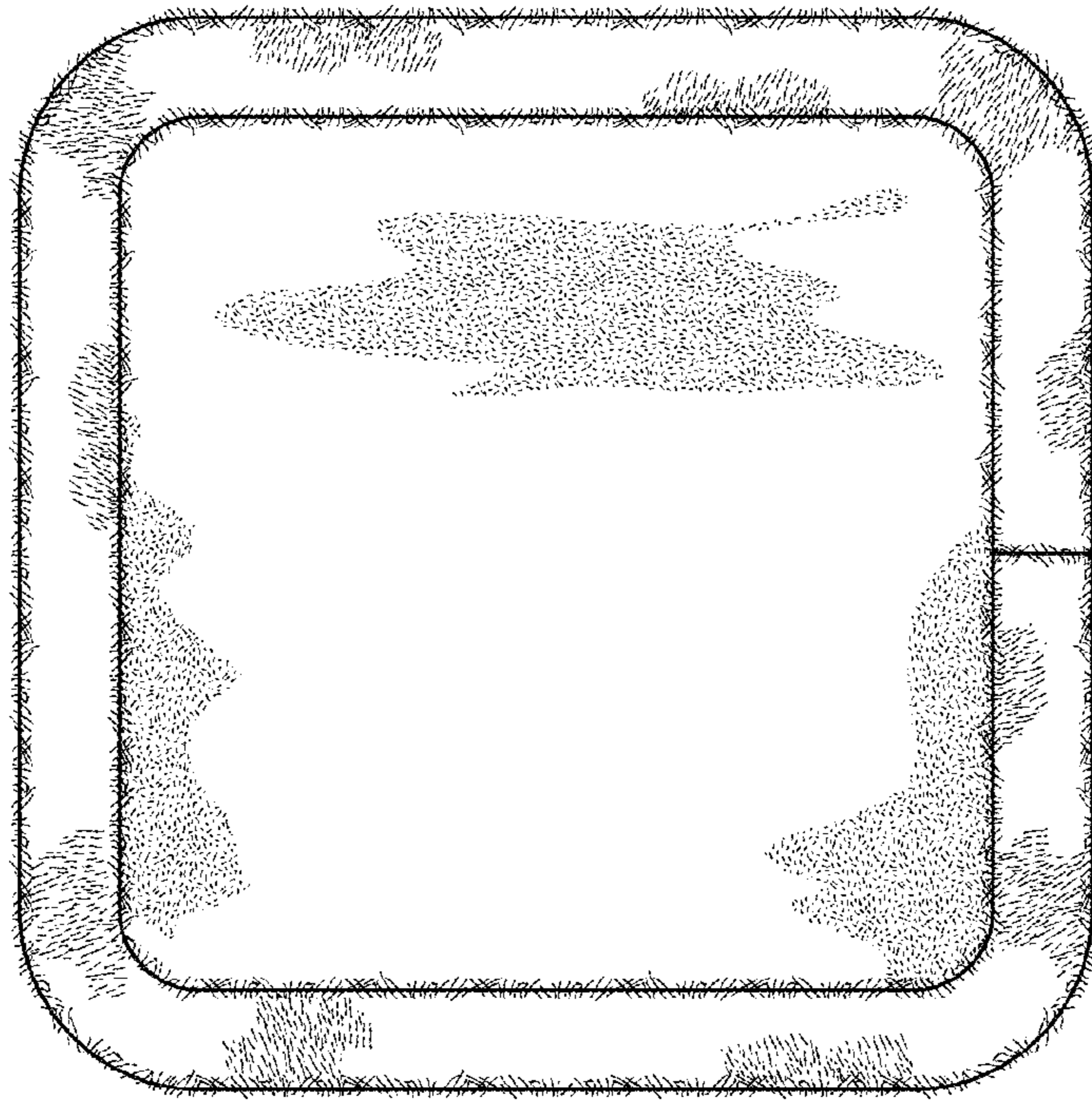

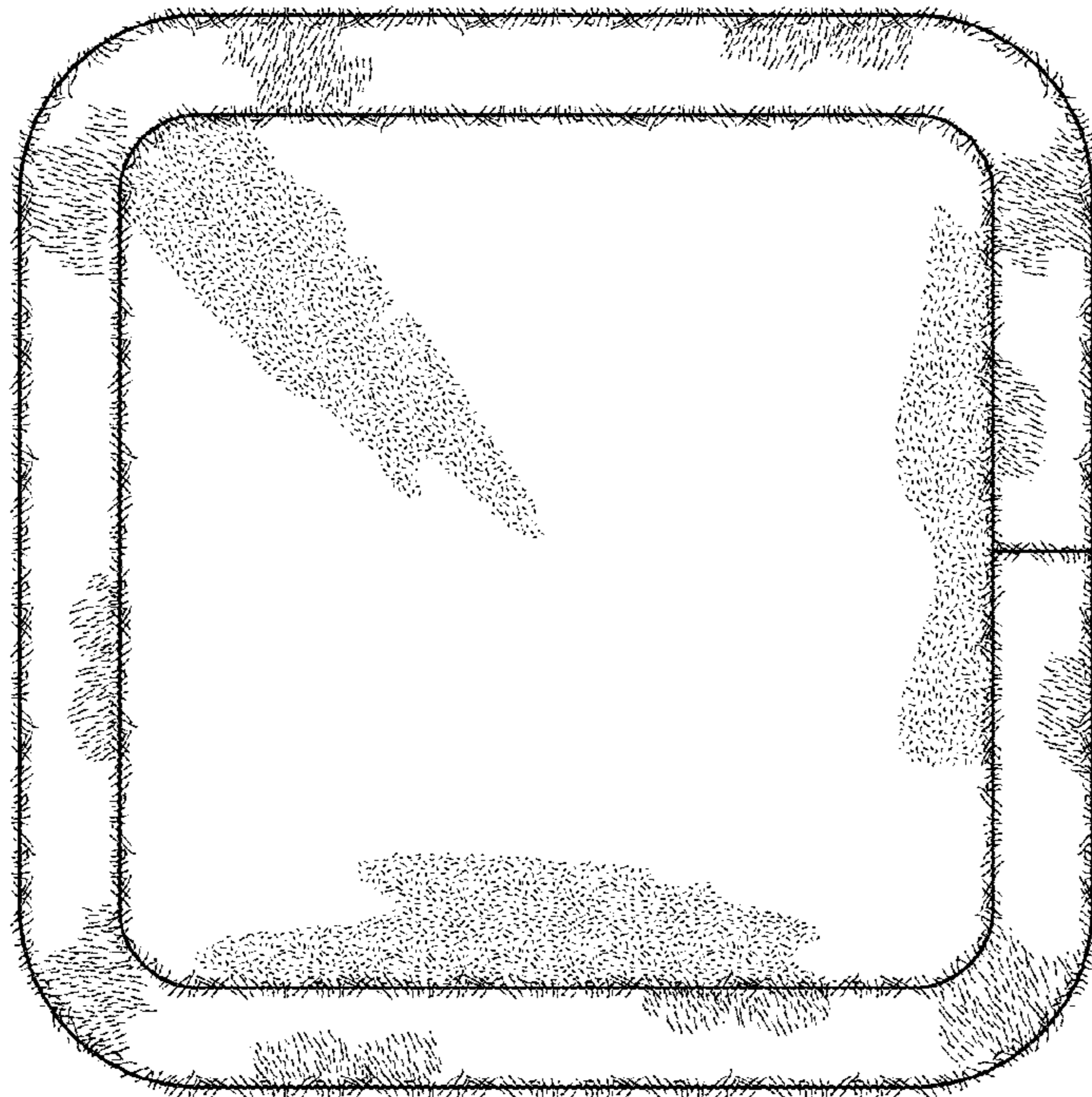

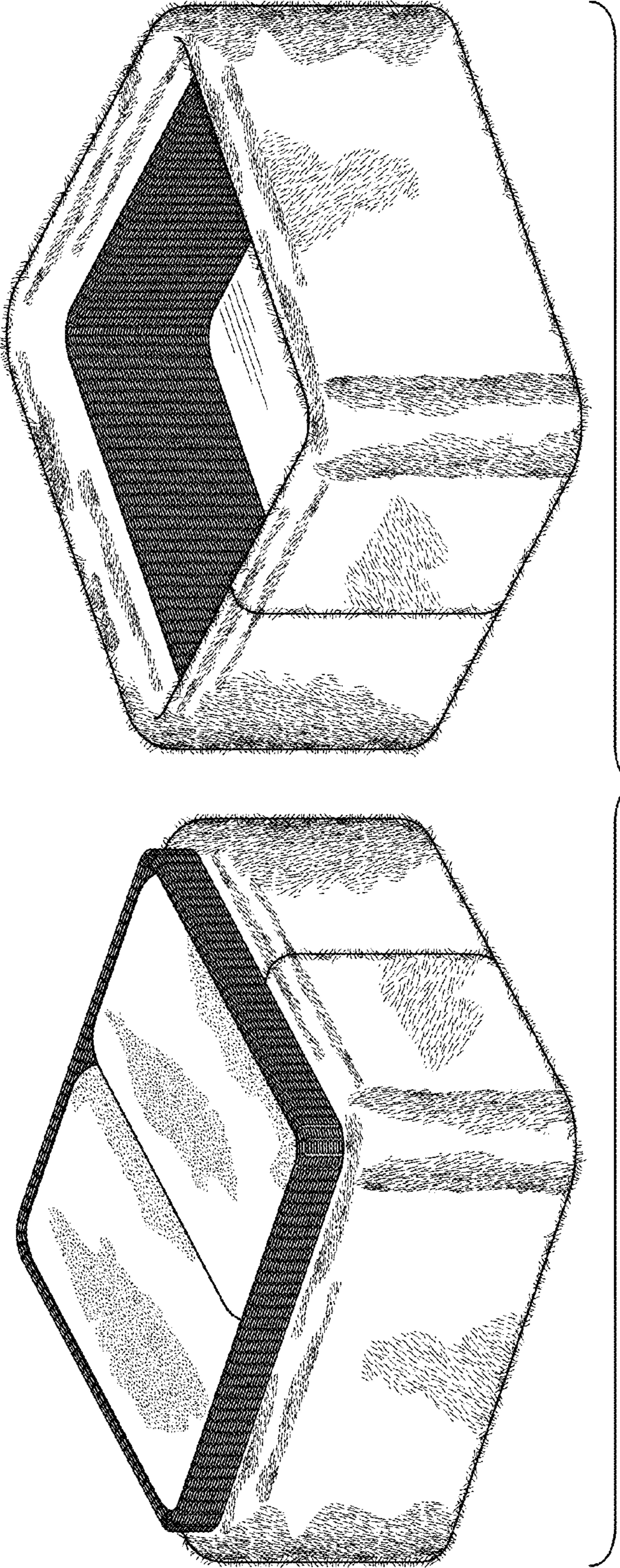

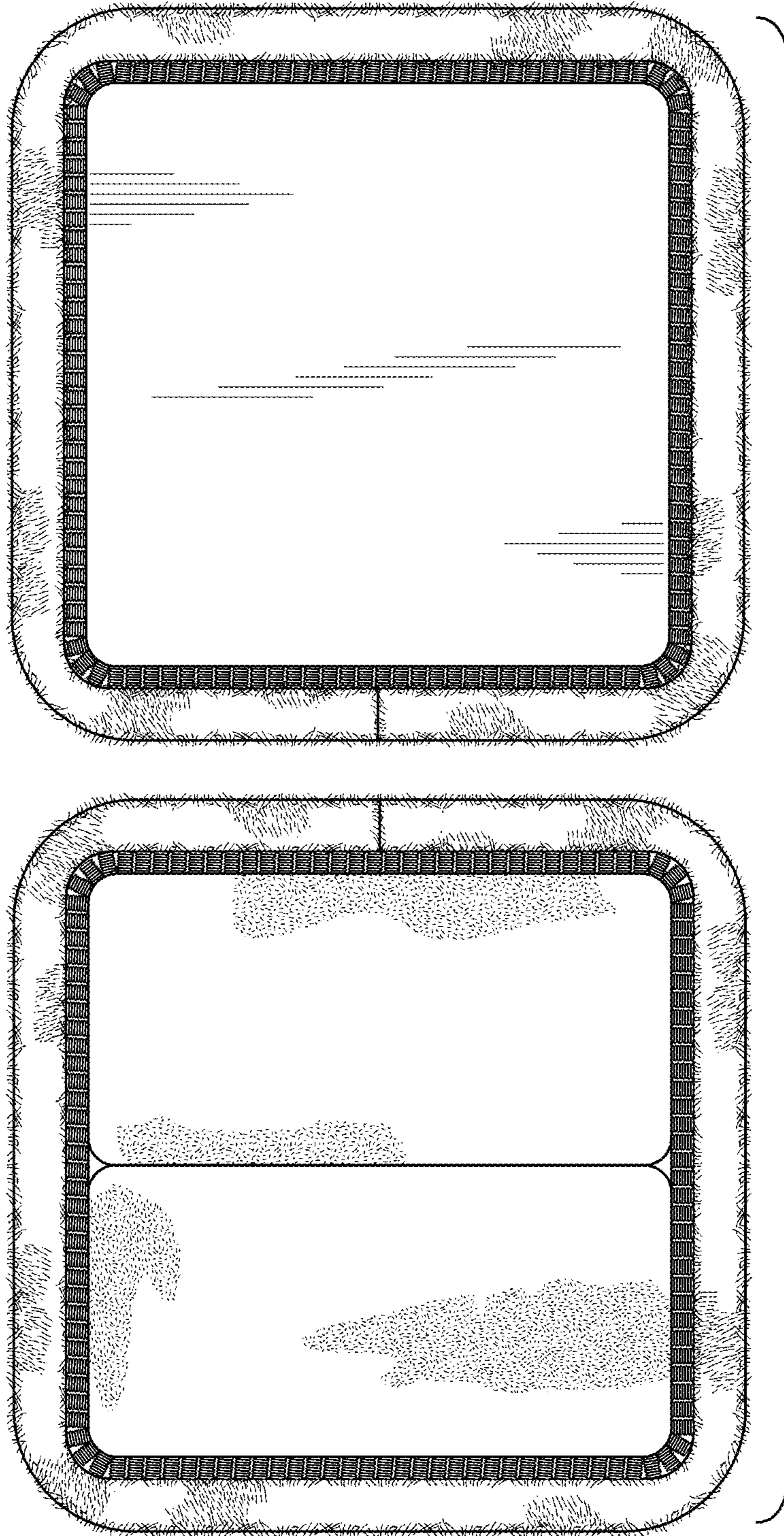
