The ornamental design for a belt organizer, as shown and described.

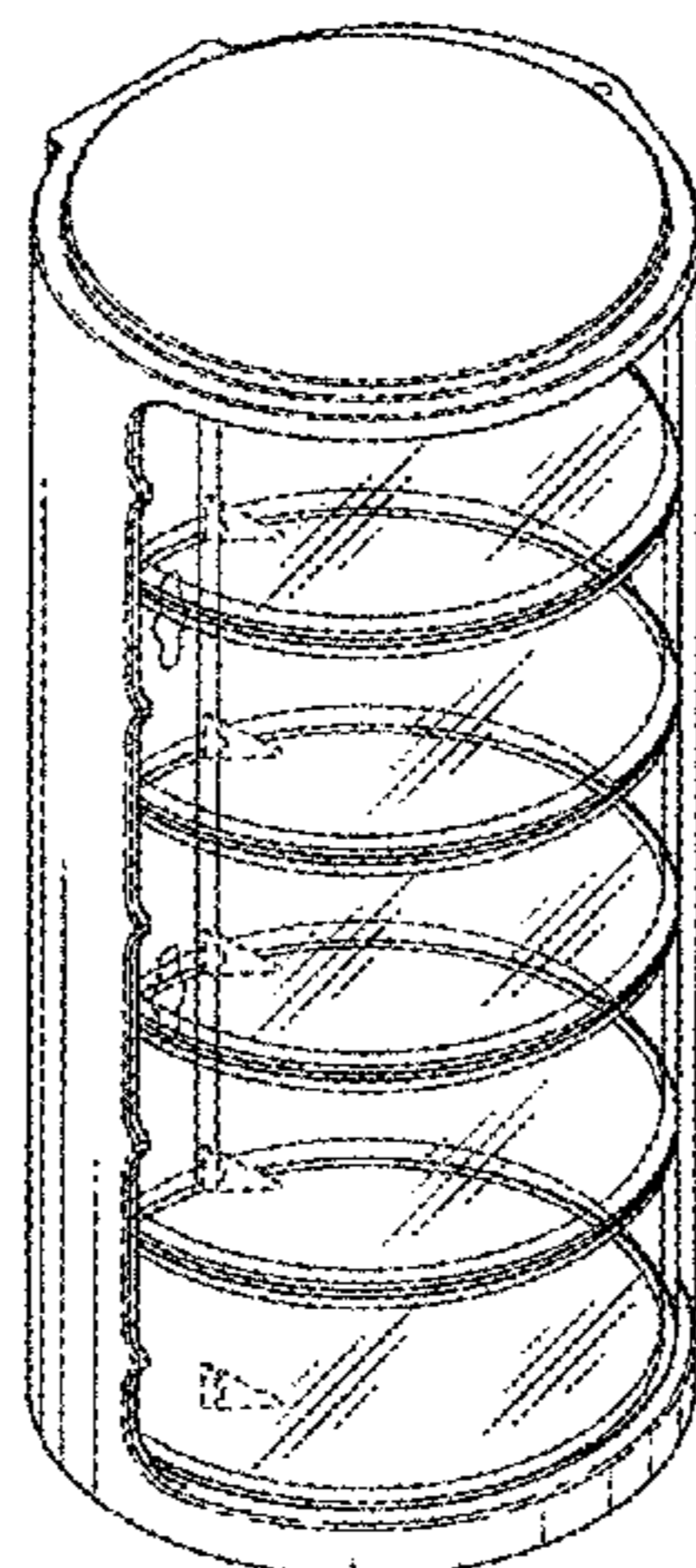

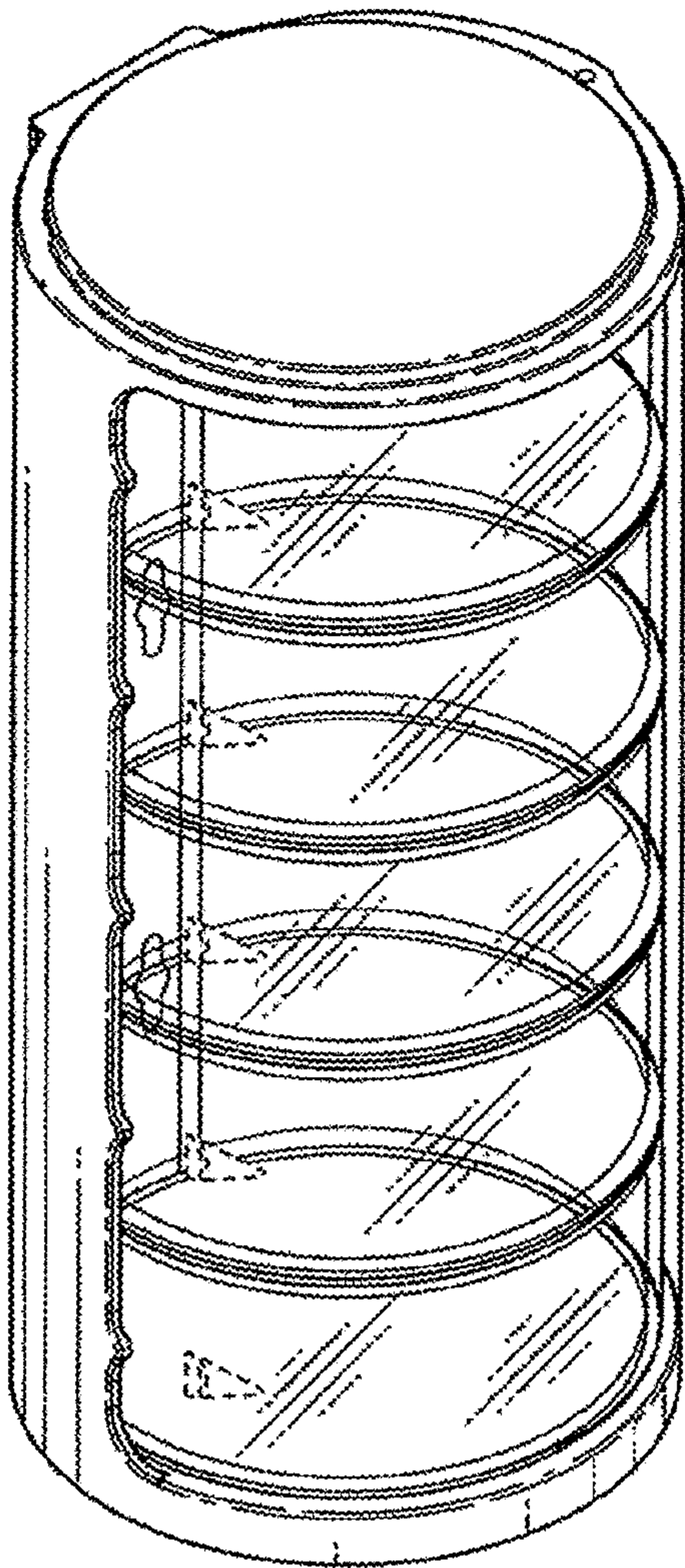

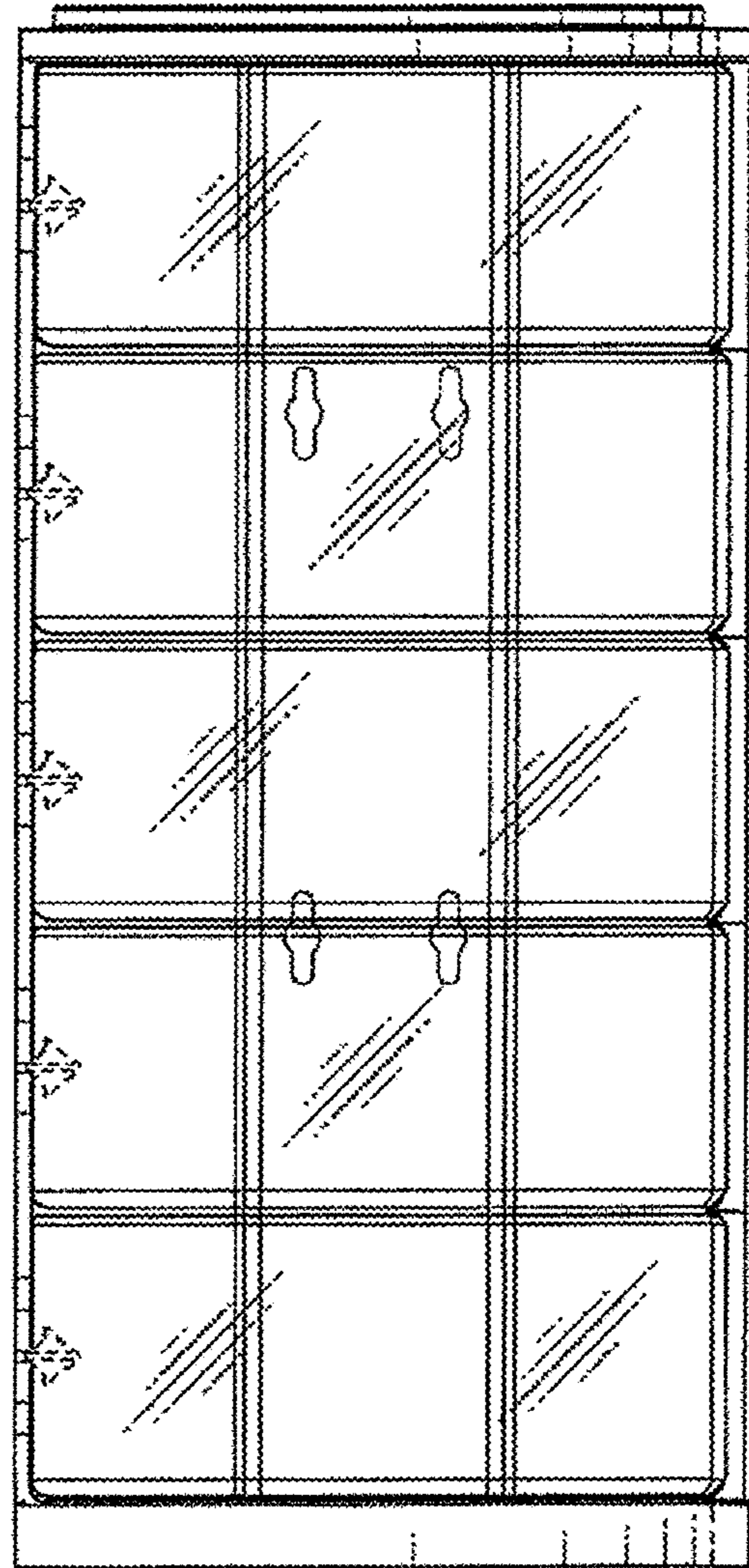

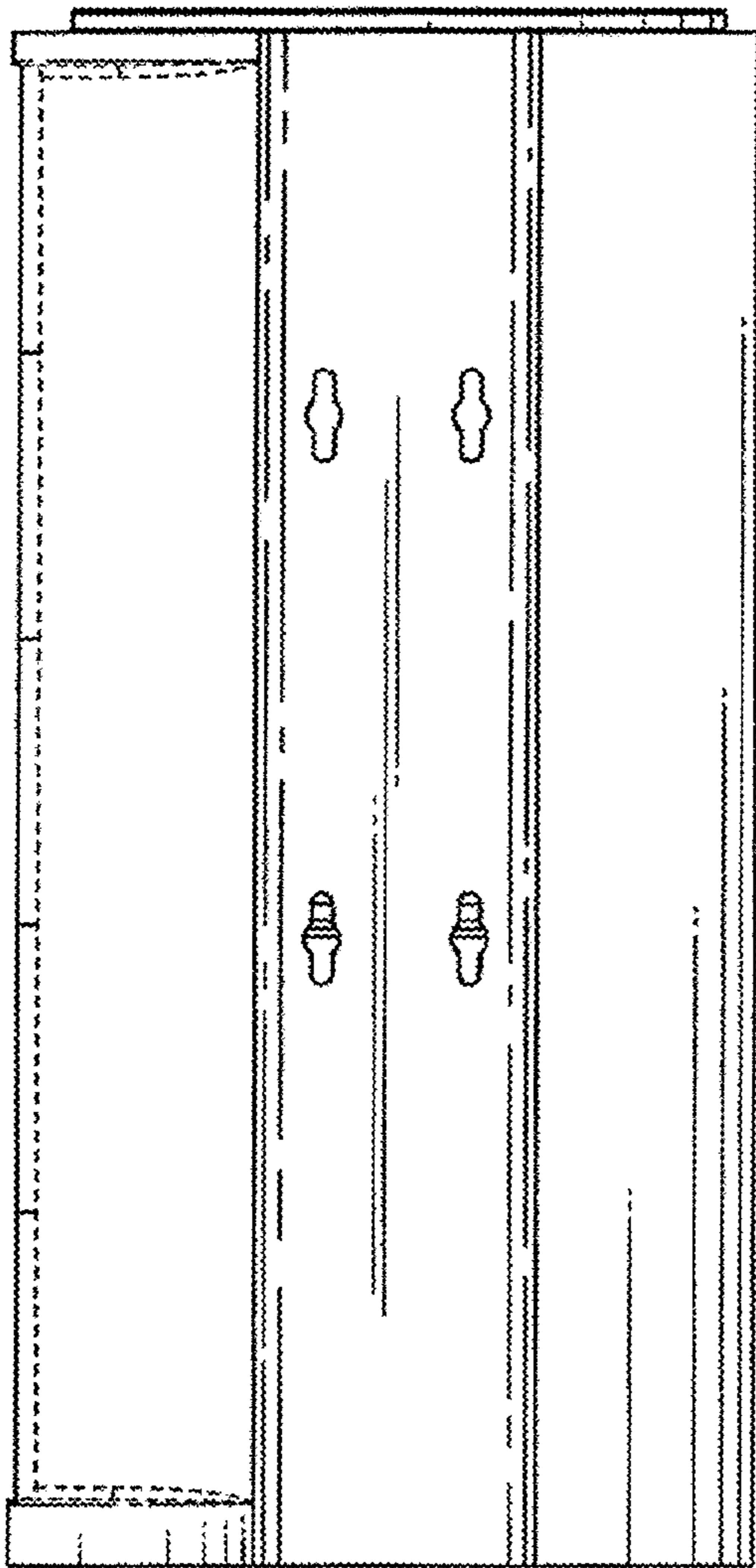

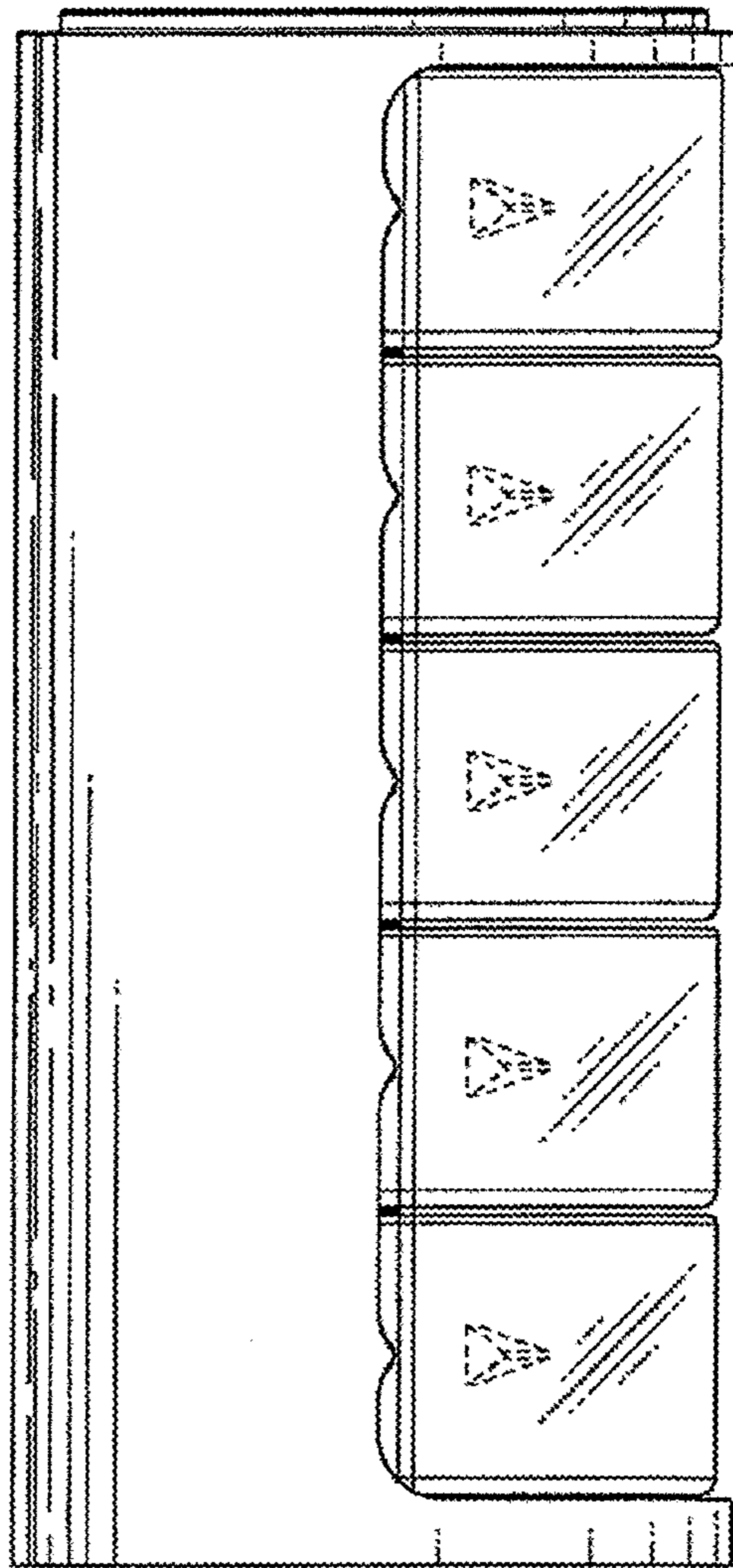

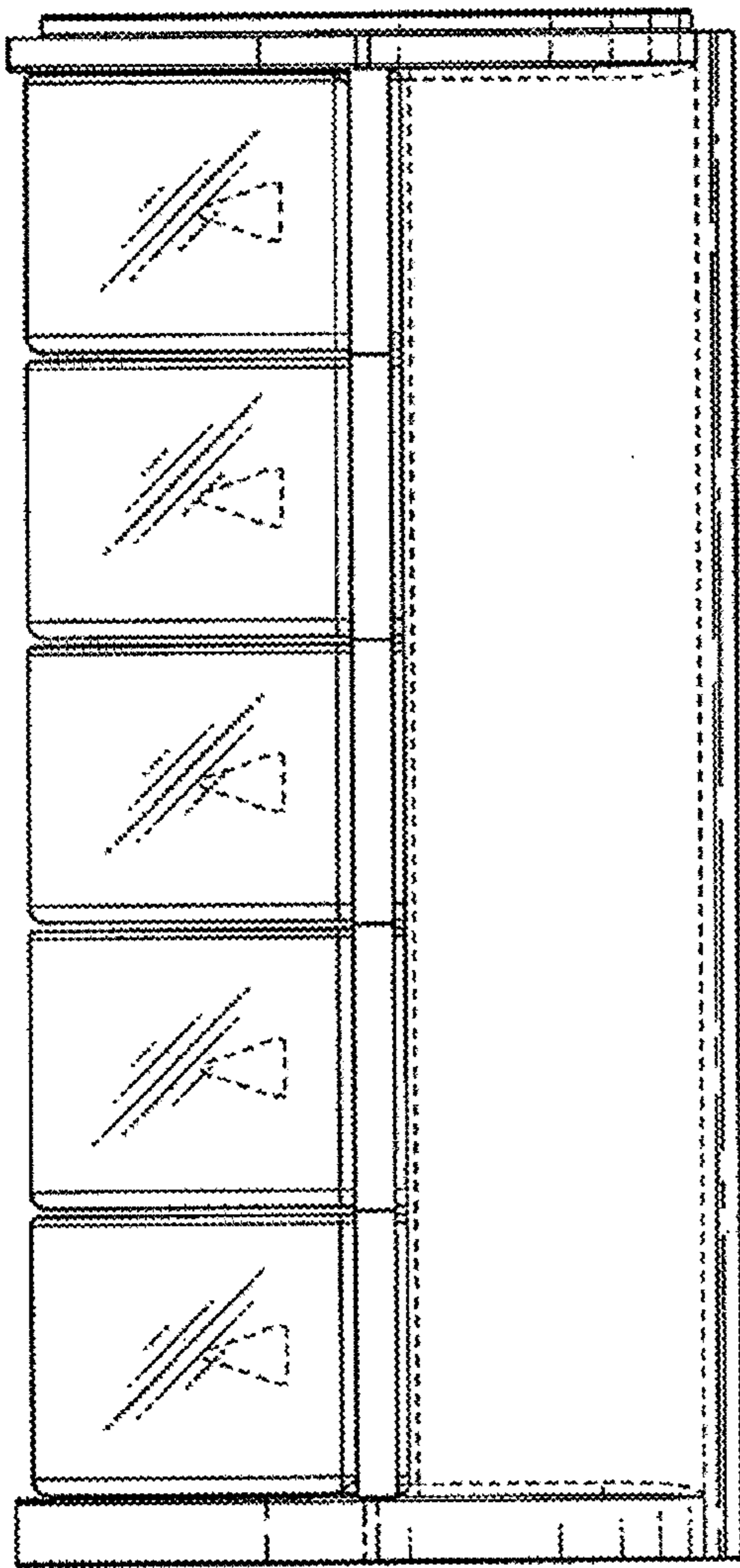

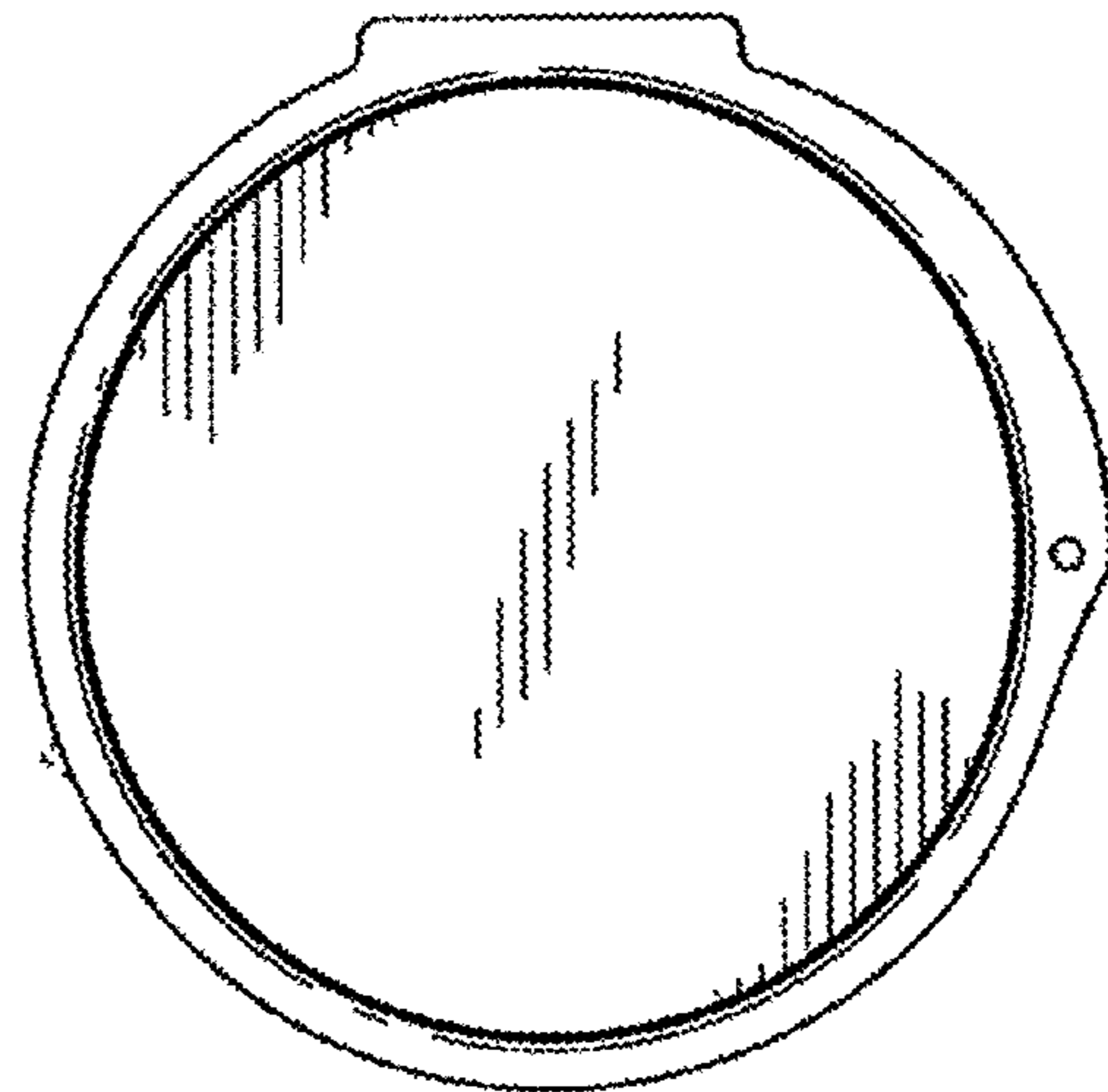

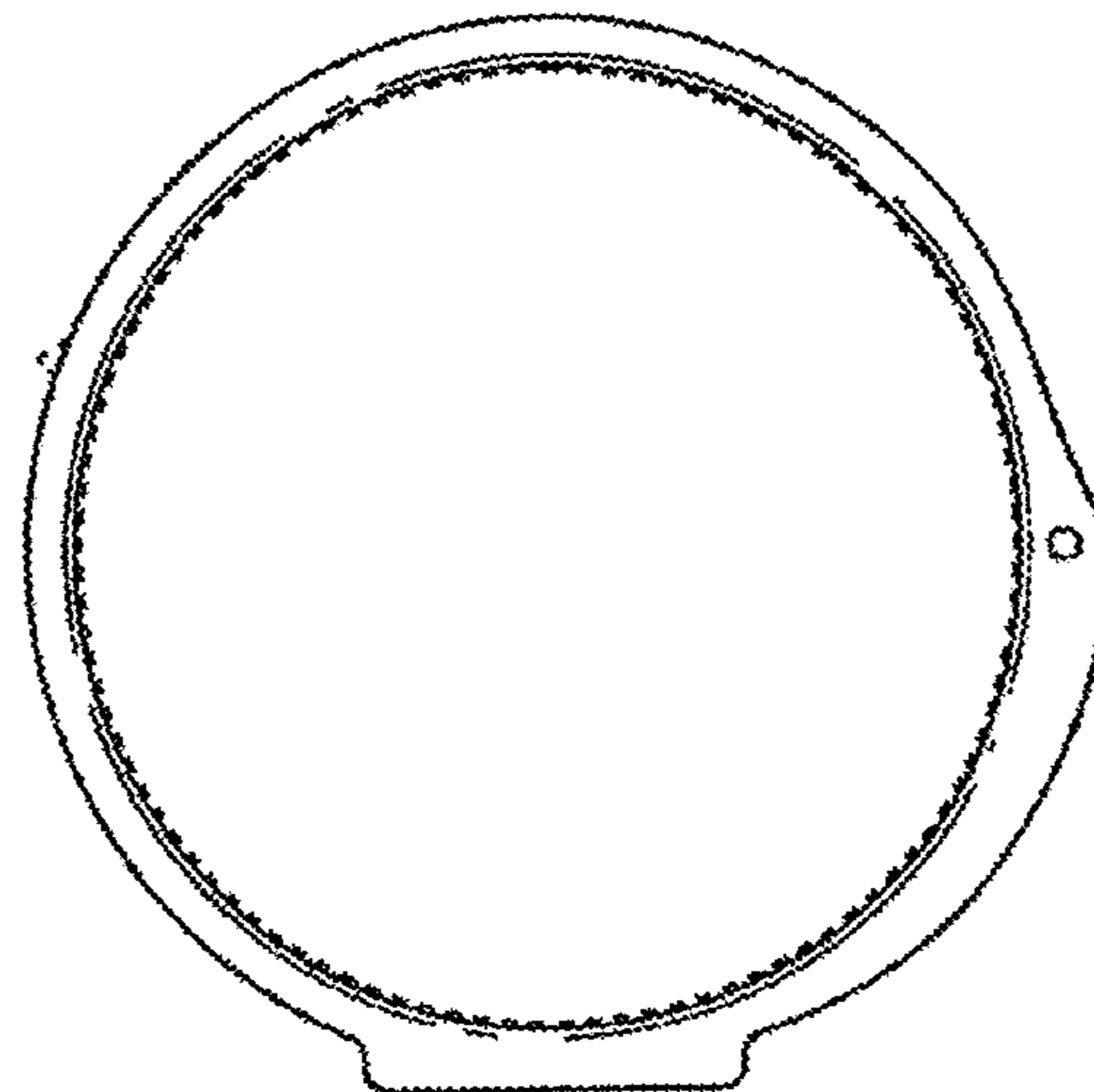
