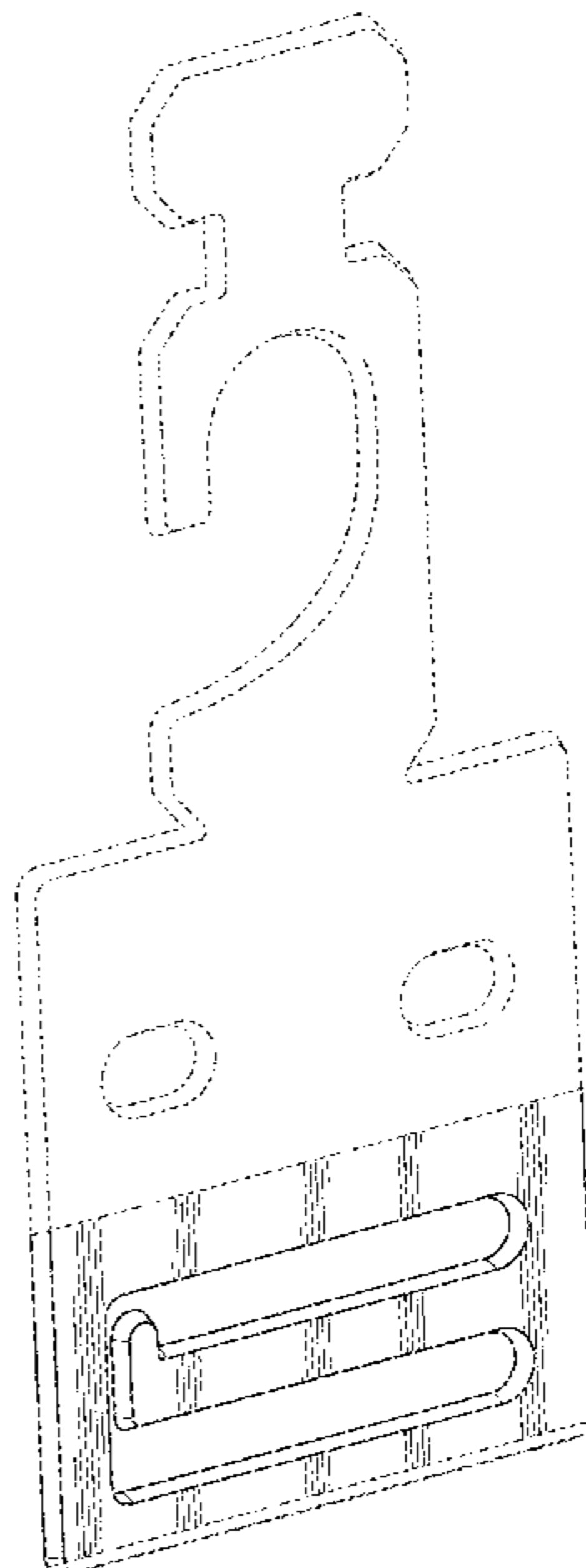
(57) **CLAIM**

The ornamental design for a holder for straight ties and bow ties, as shown and described.

DESCRIPTION

FIG. 1 is a front, top right perspective view of a tie hanger showing my new design therefor; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a right side elevational view thereof; and, FIG. 5 is a left side elevational view thereof. The broken lines throughout the drawings show environment and form no part of the design.

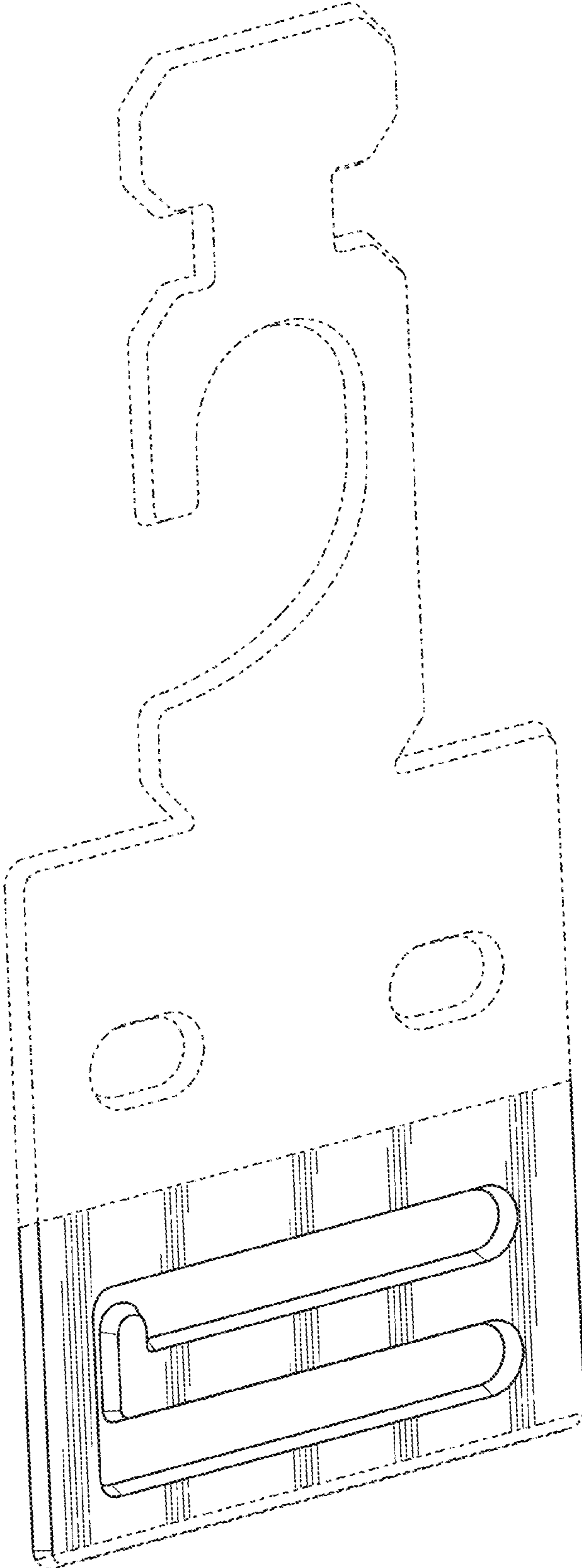

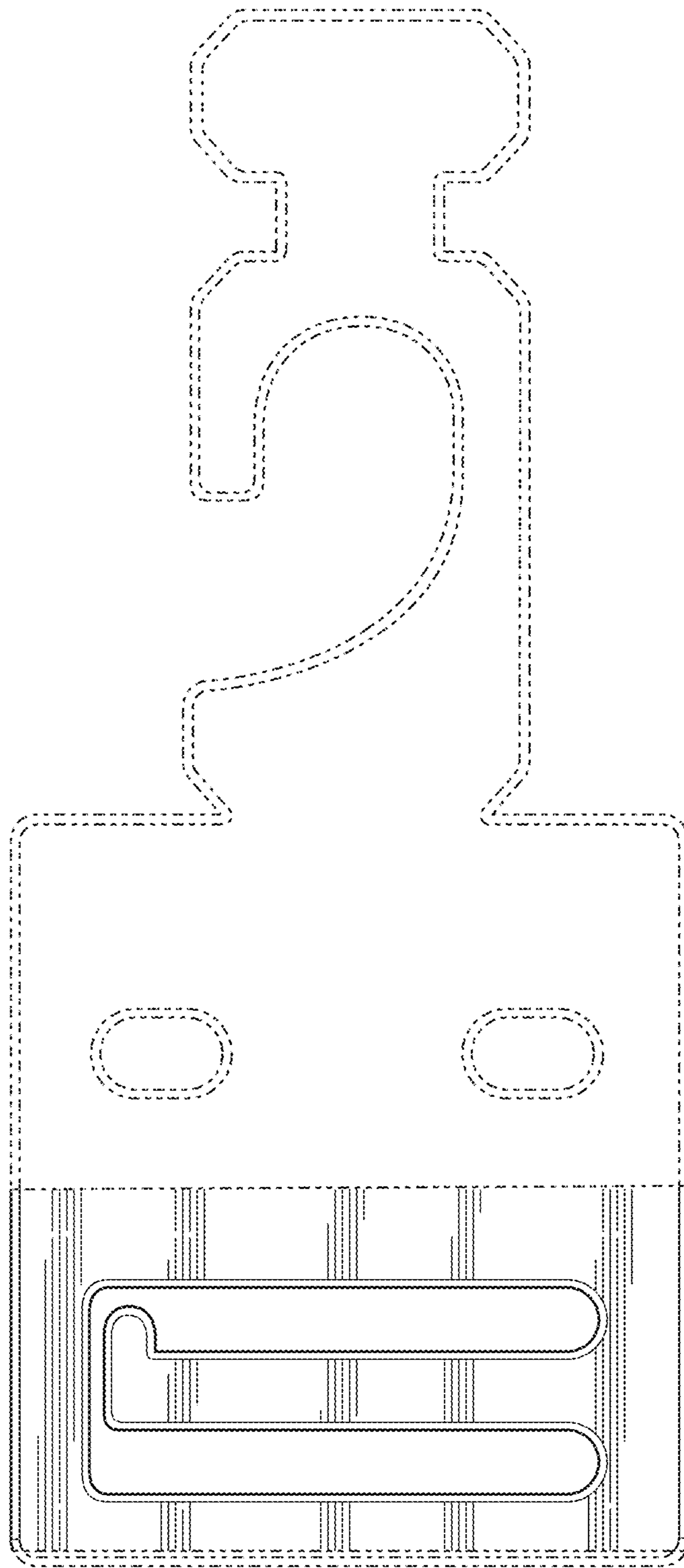

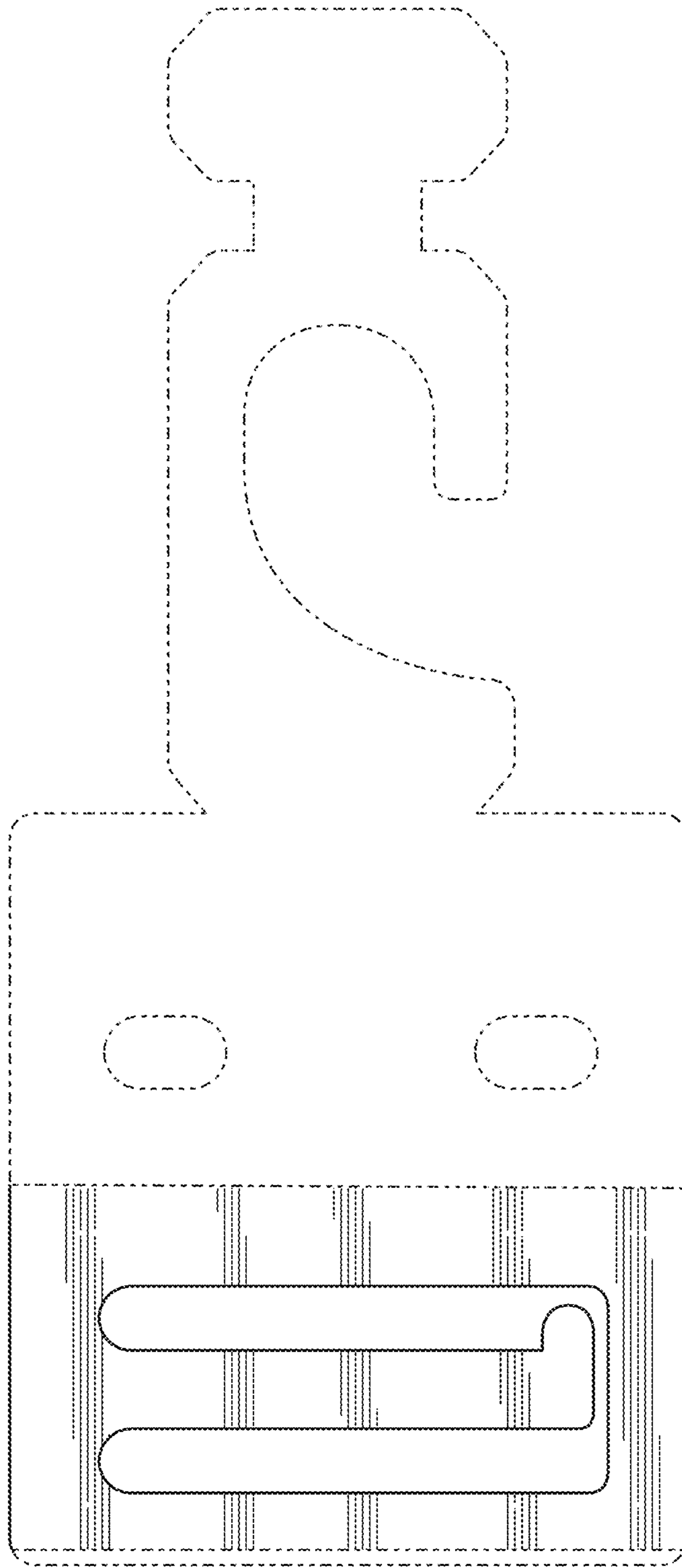

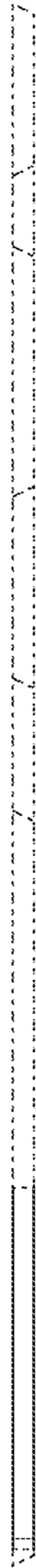

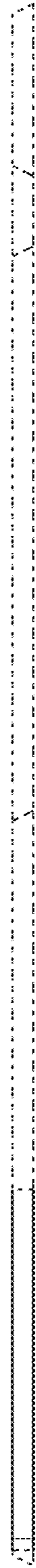
