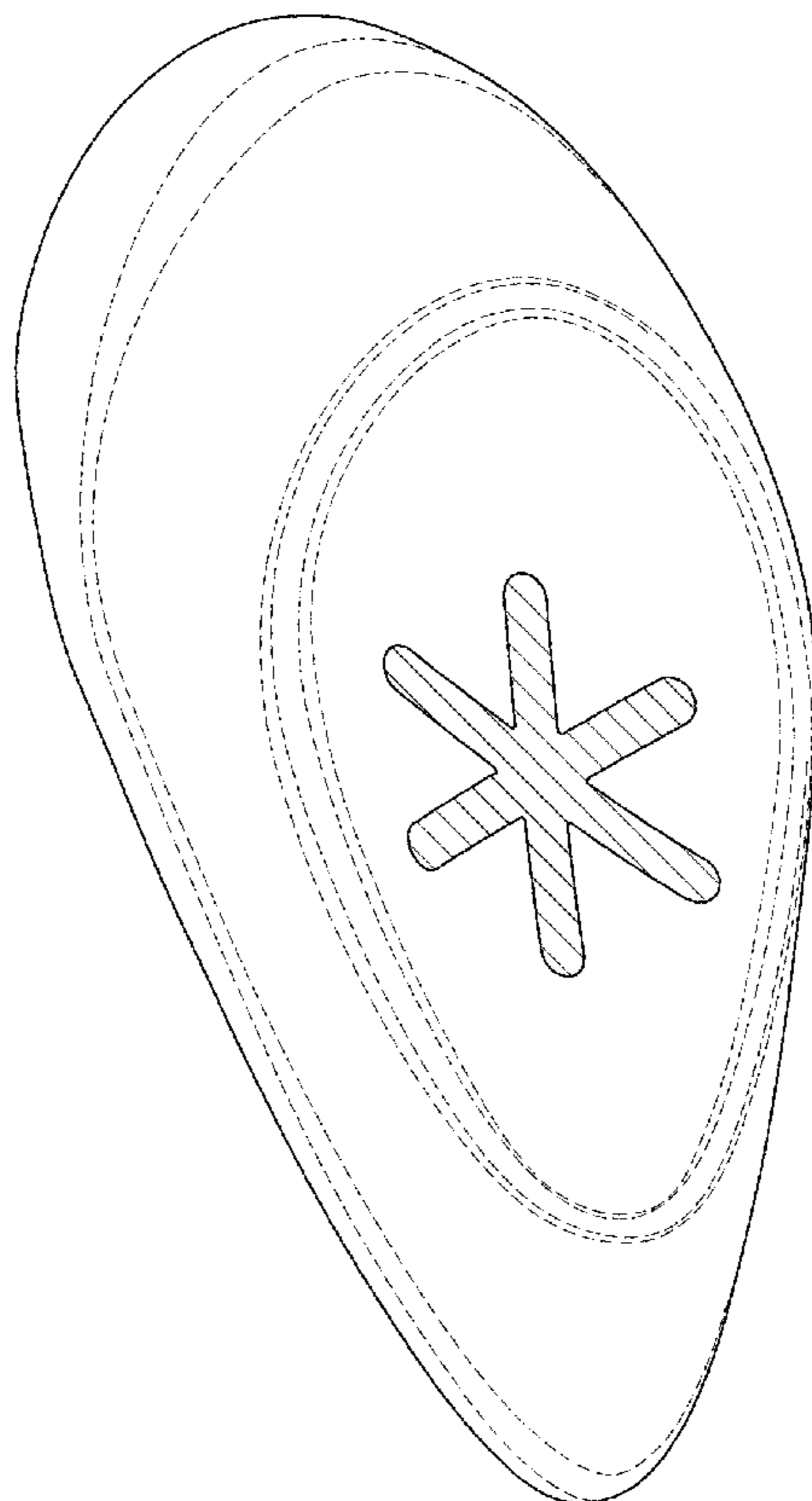
(57) **CLAIM**

The ornamental design for a button, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an embodiment of a button; FIG. 2 is a front view of an embodiment of a button; FIG. 3 is a back view of an embodiment of a button; FIG. 4 is a right side view of an embodiment of a button; FIG. 5 is a left side view of an embodiment of a button; FIG. 6 is a top view of an embodiment of a button; and, FIG. 7 is a bottom view of an embodiment of a button. All surfaces on the exterior of the button are claimed, excepting the broken lines. The interior of the button seen in FIGS. 3 and 7 forms no part of the claimed design.

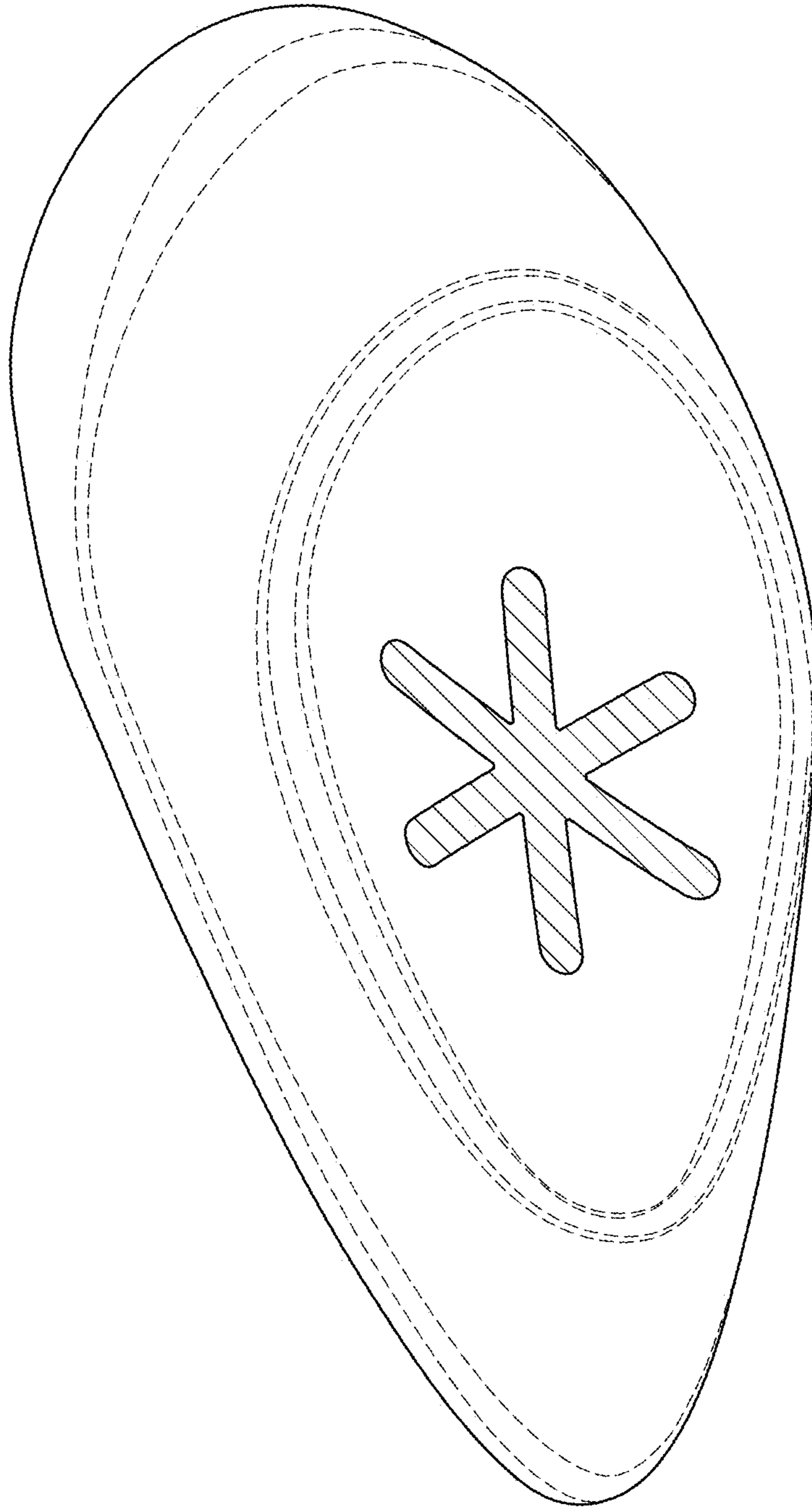

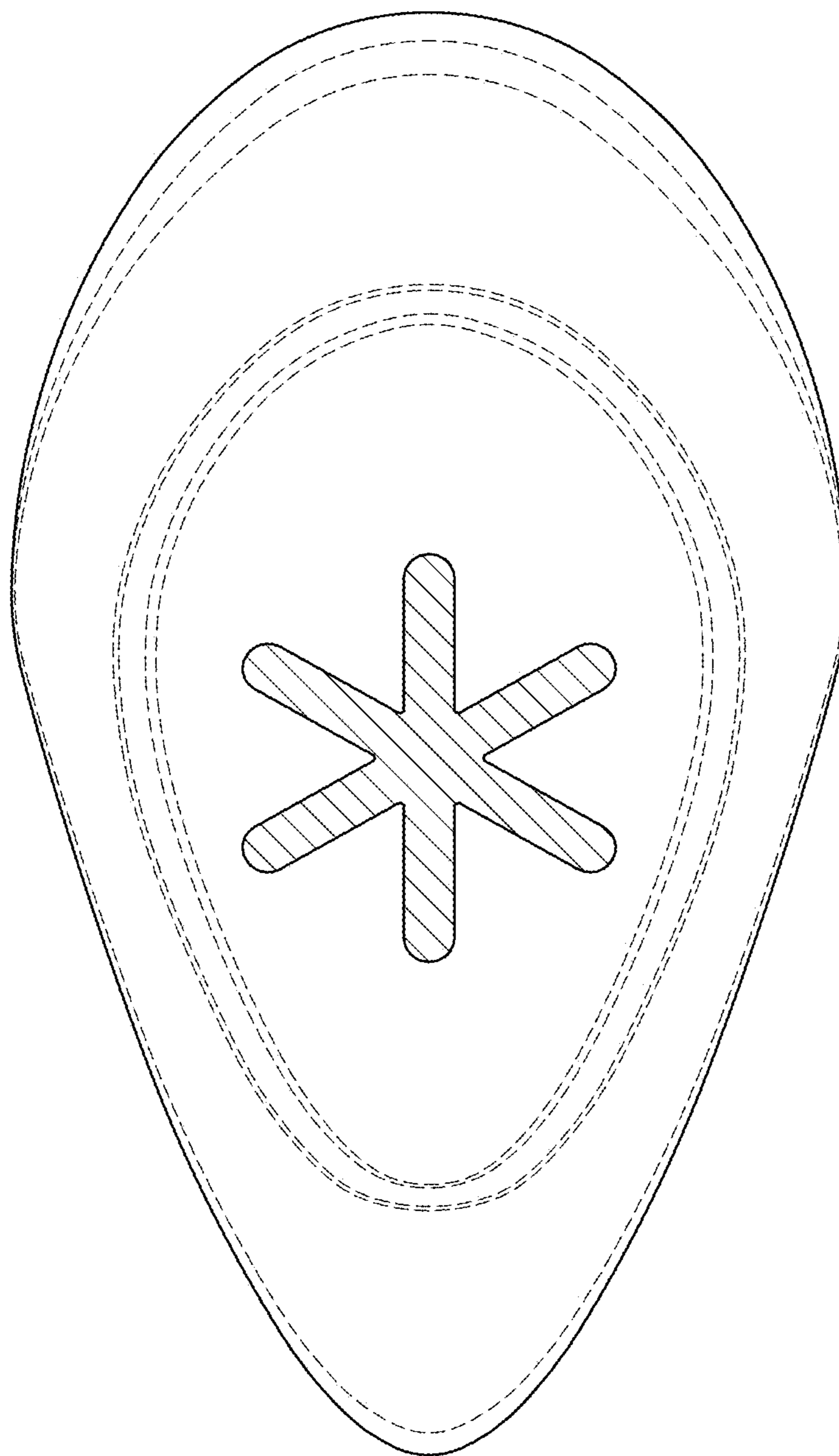

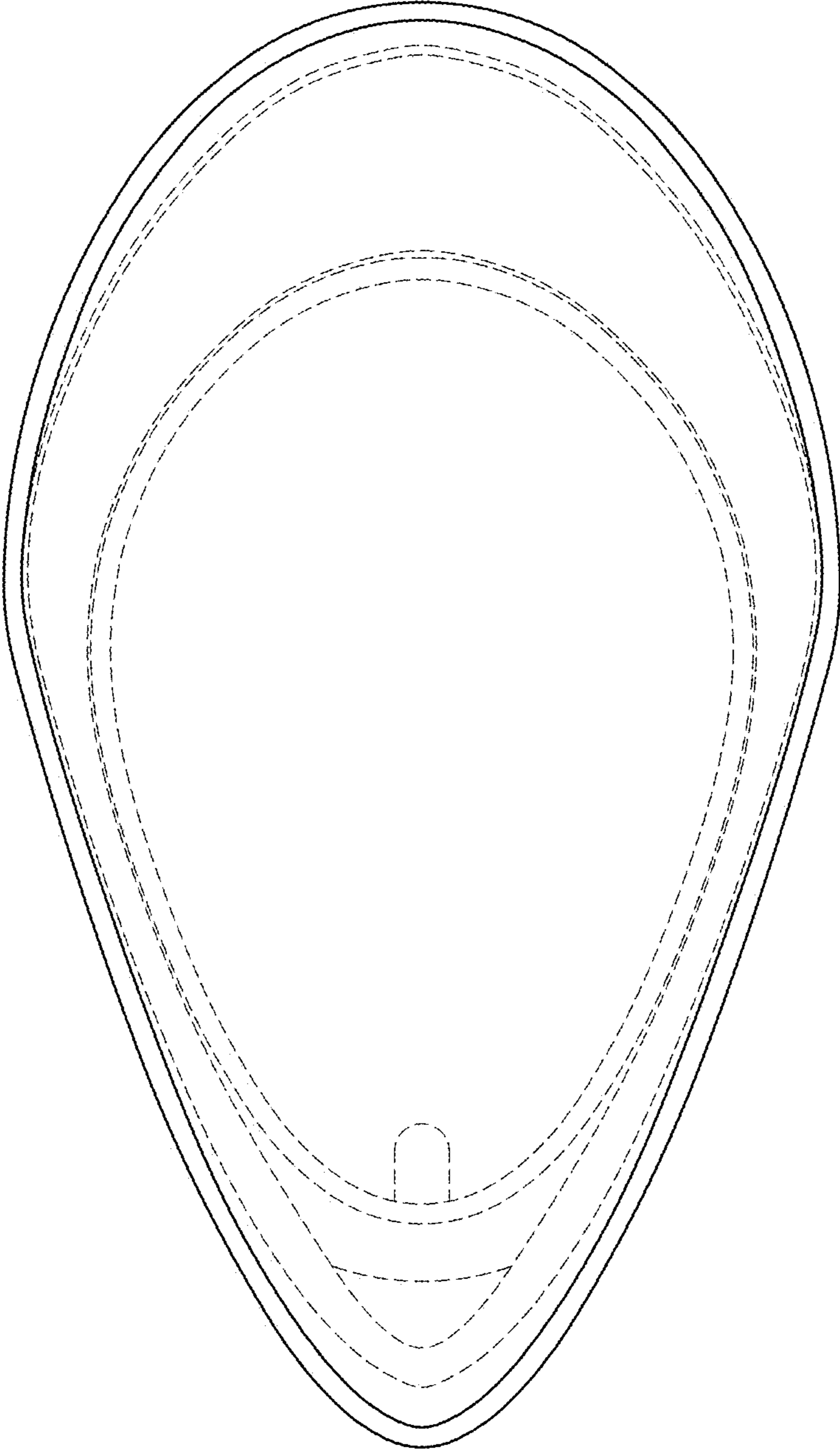

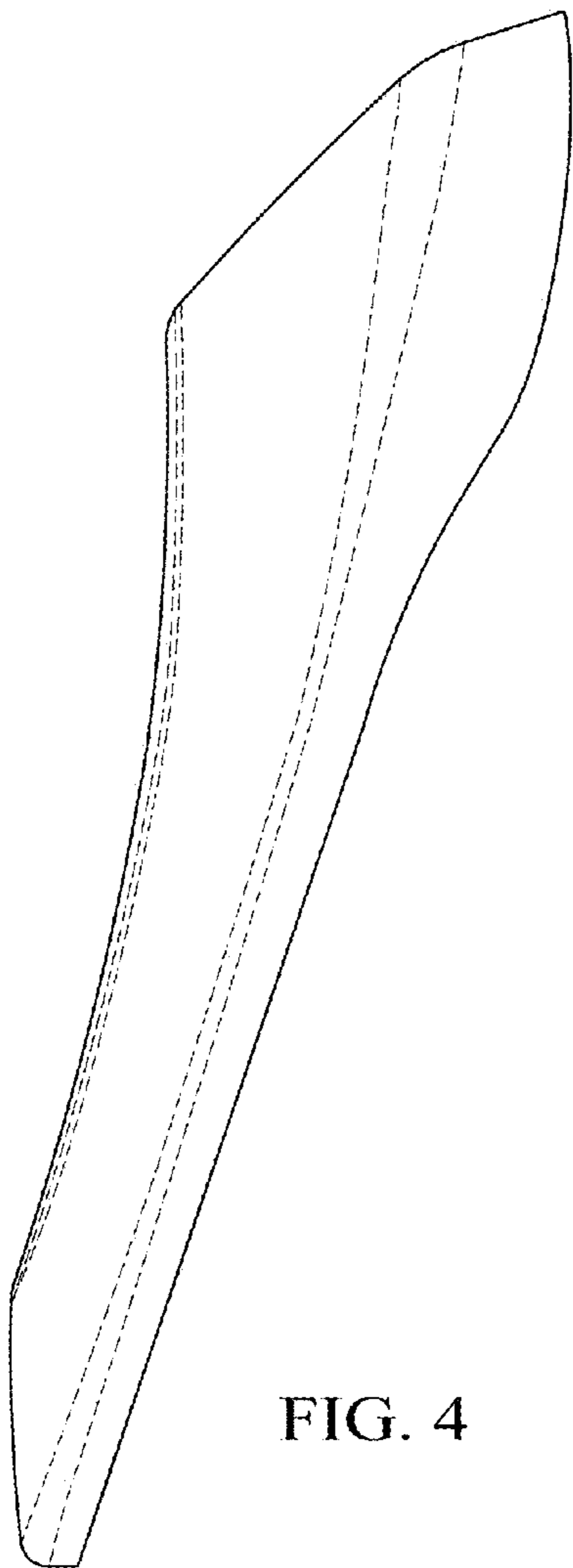

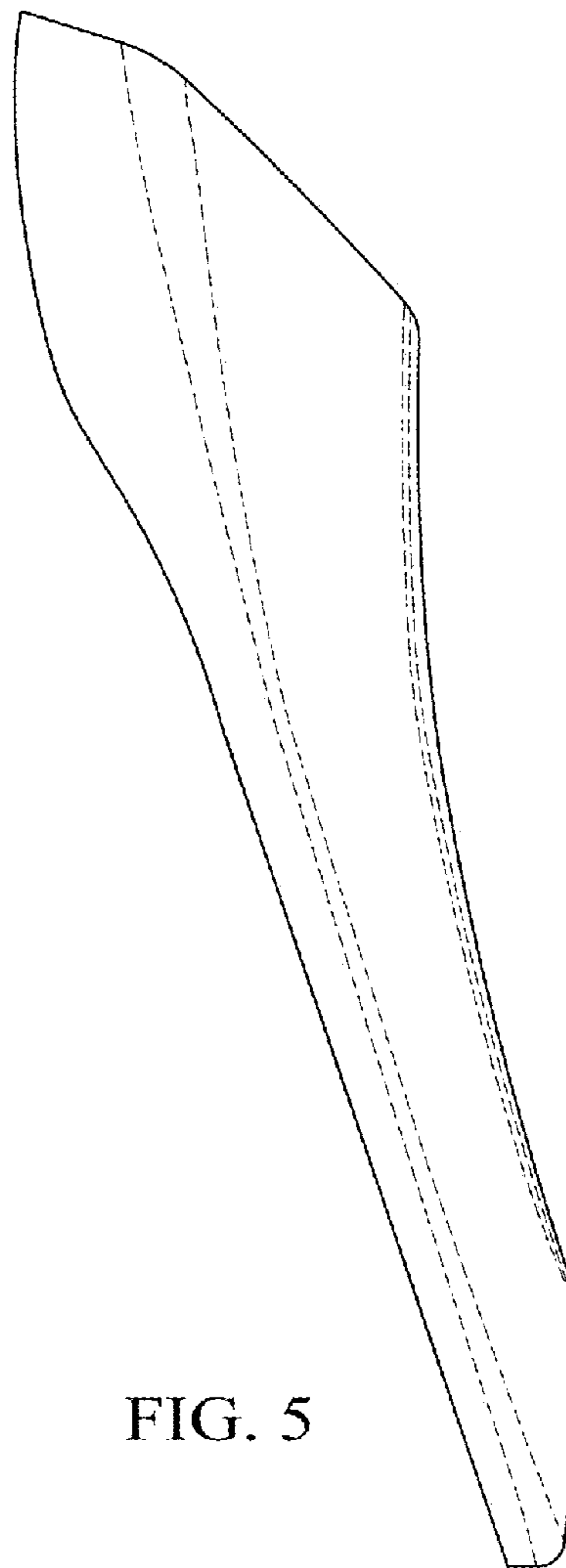

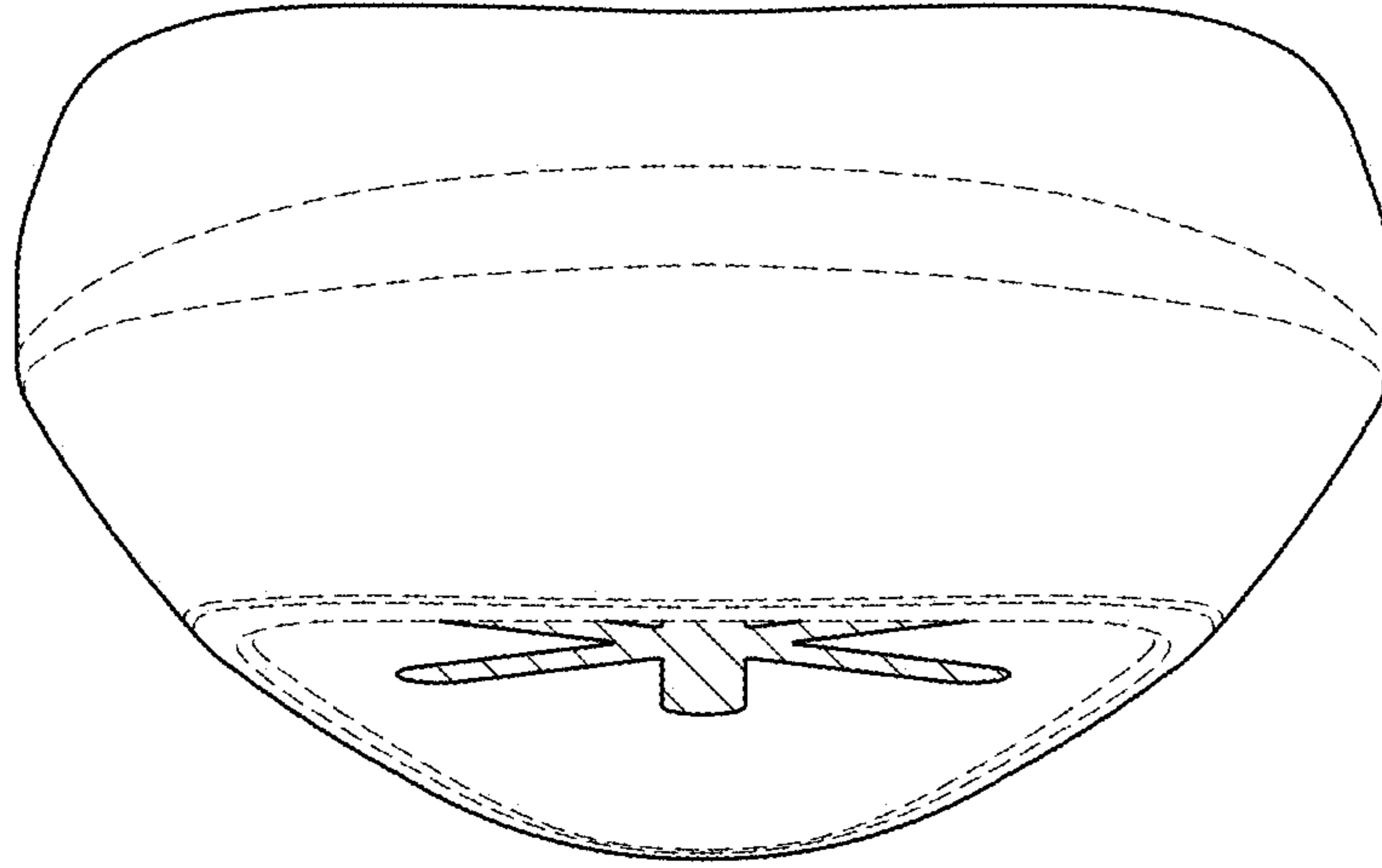

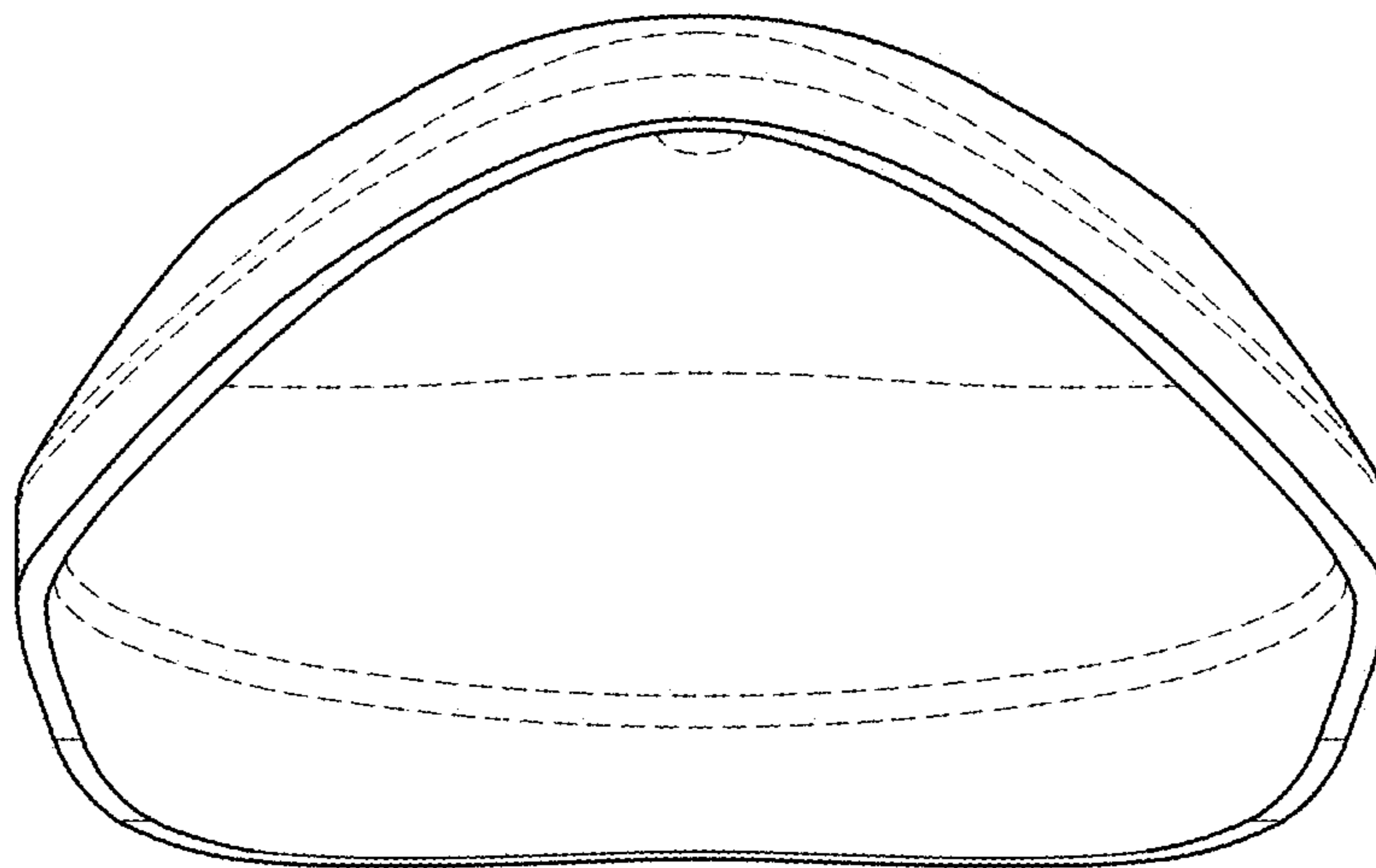
