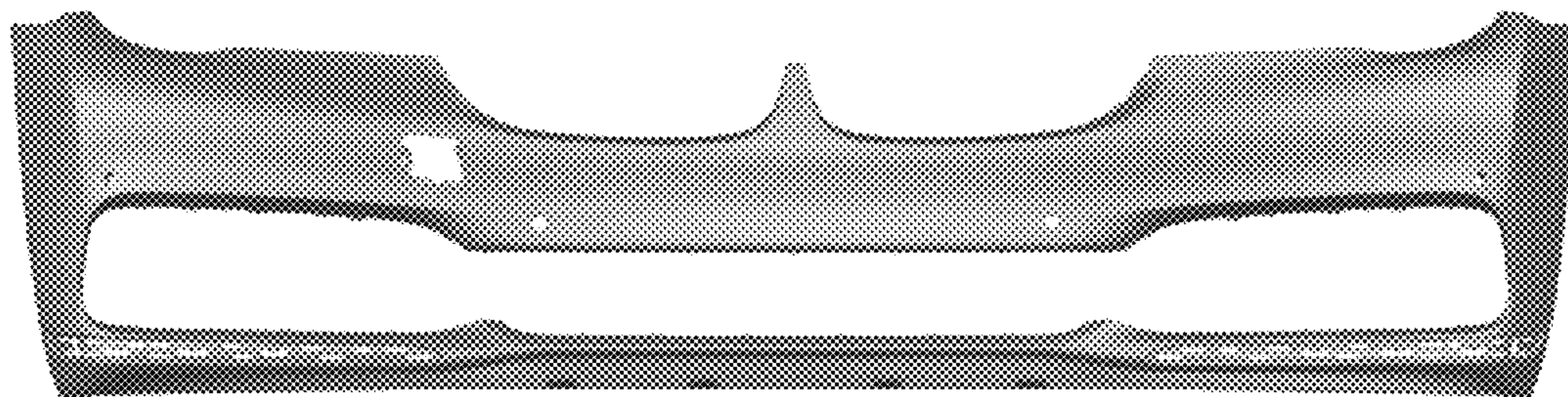

The ornamental design for a front bumper for a vehicle, as shown and described.

**DESCRIPTION**

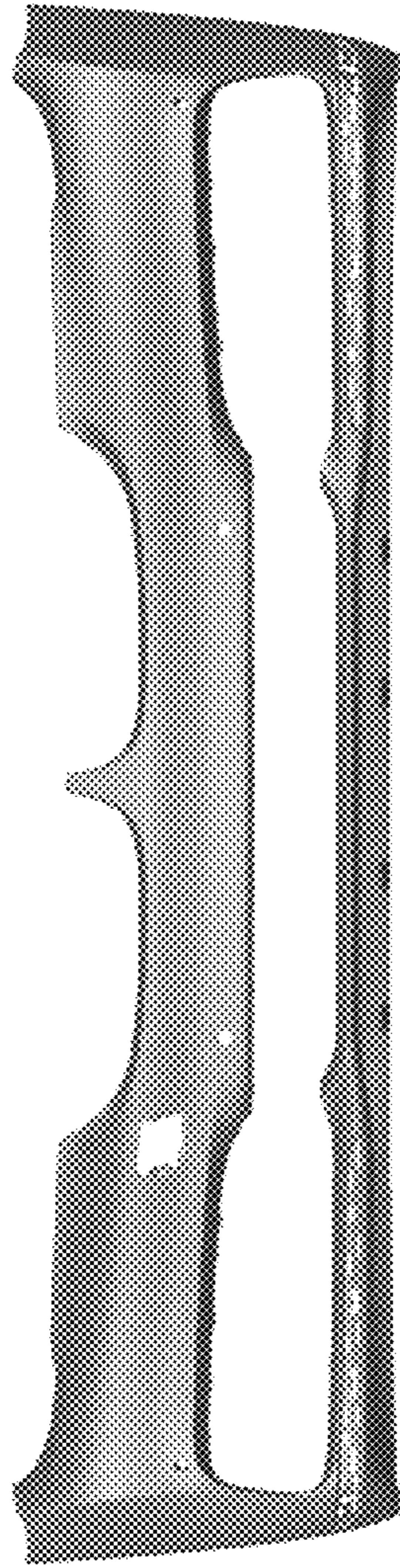

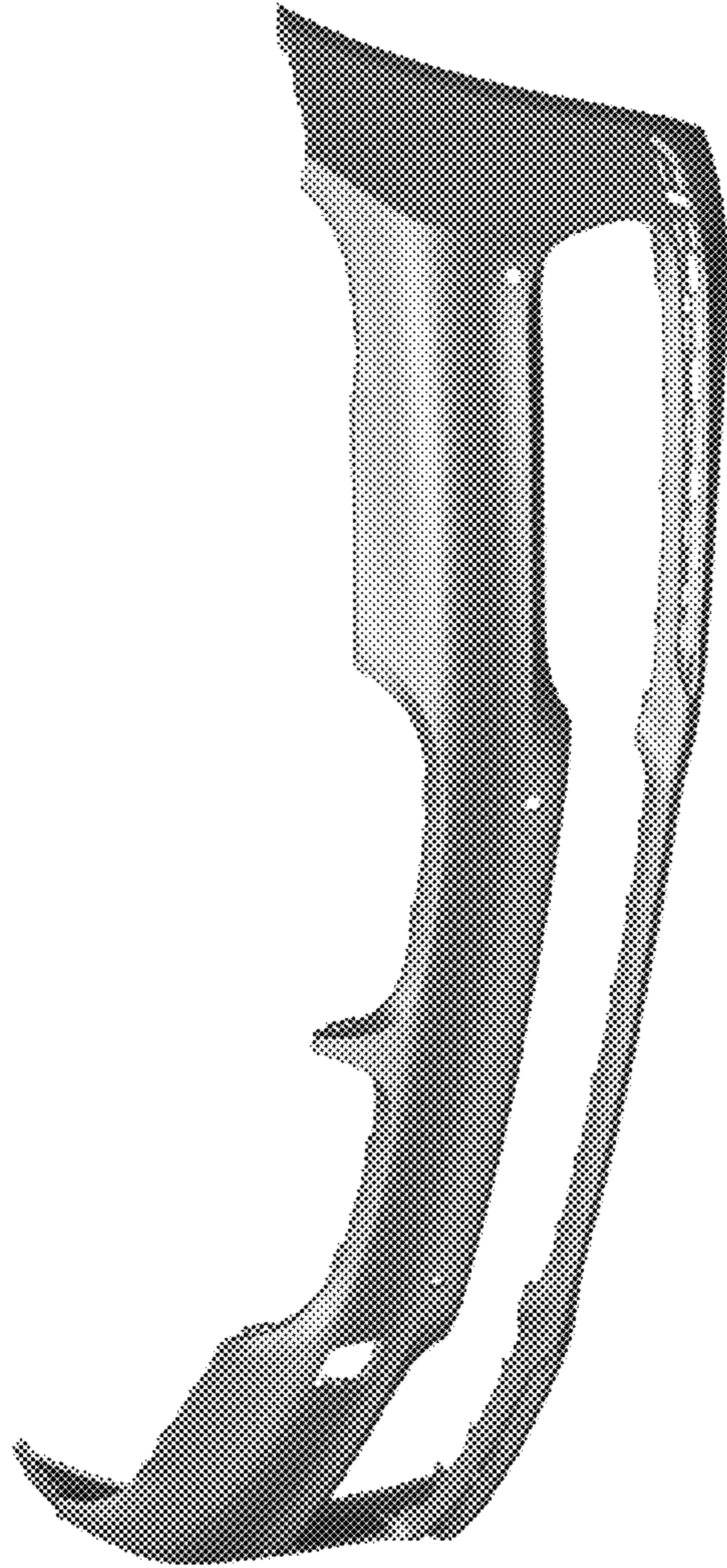

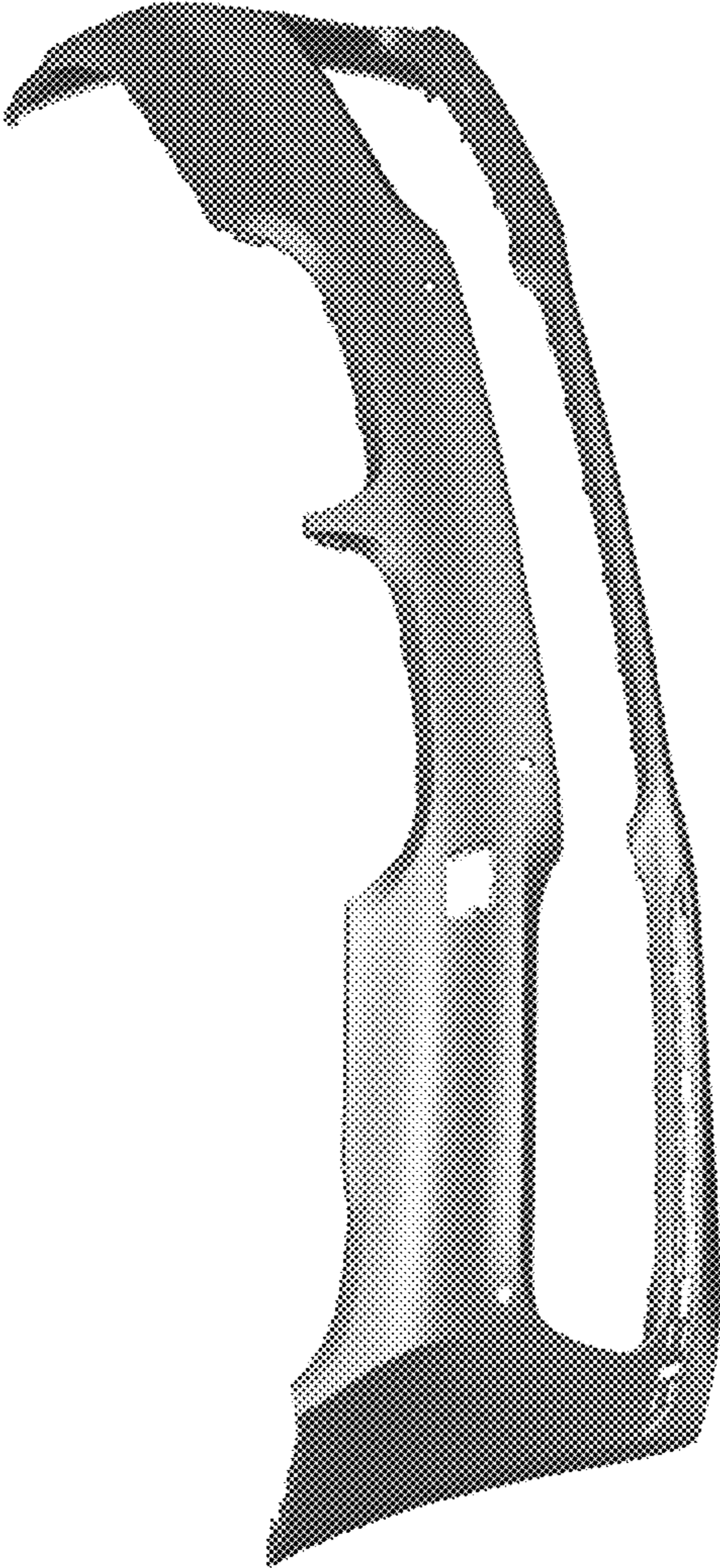

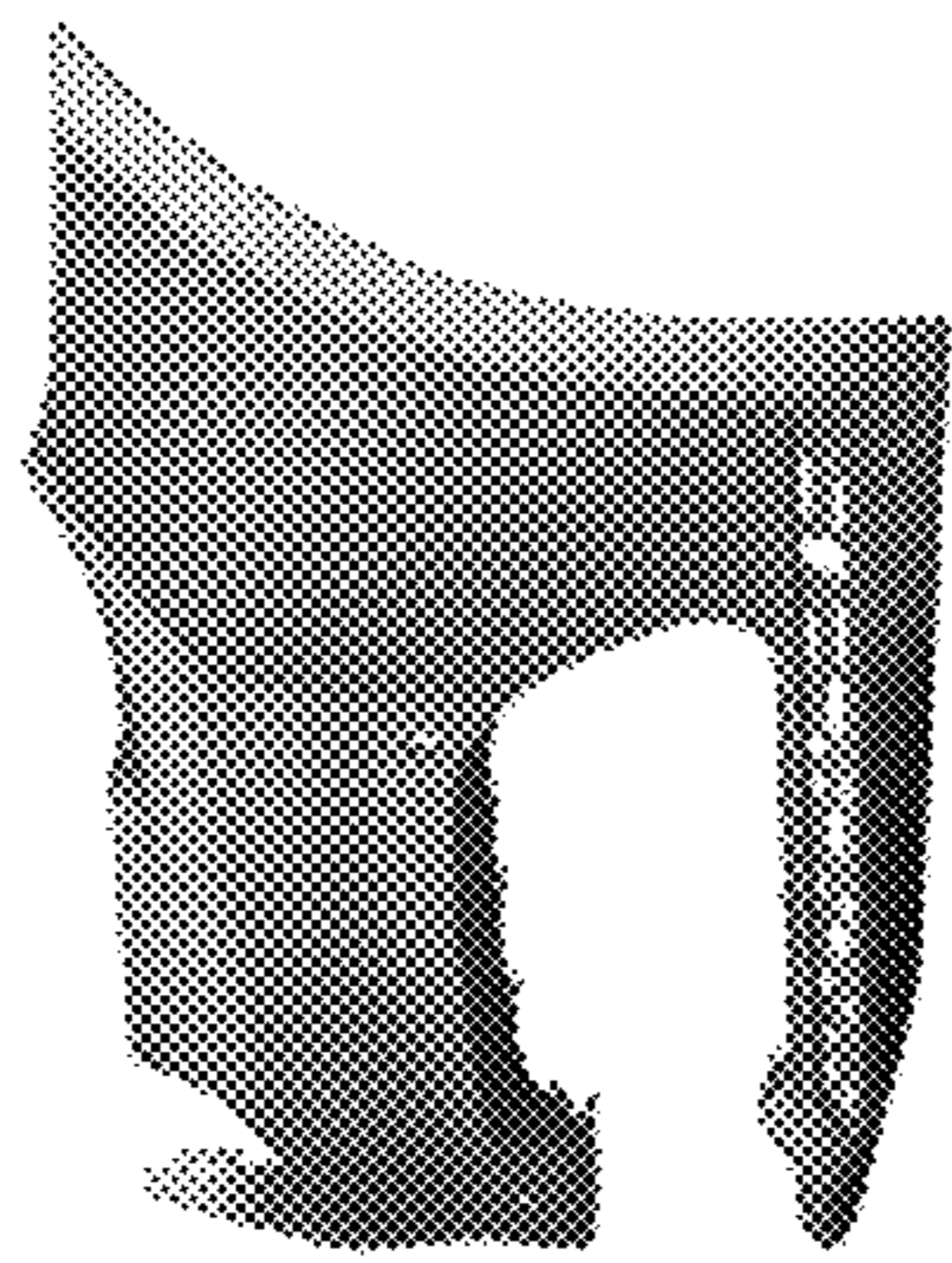

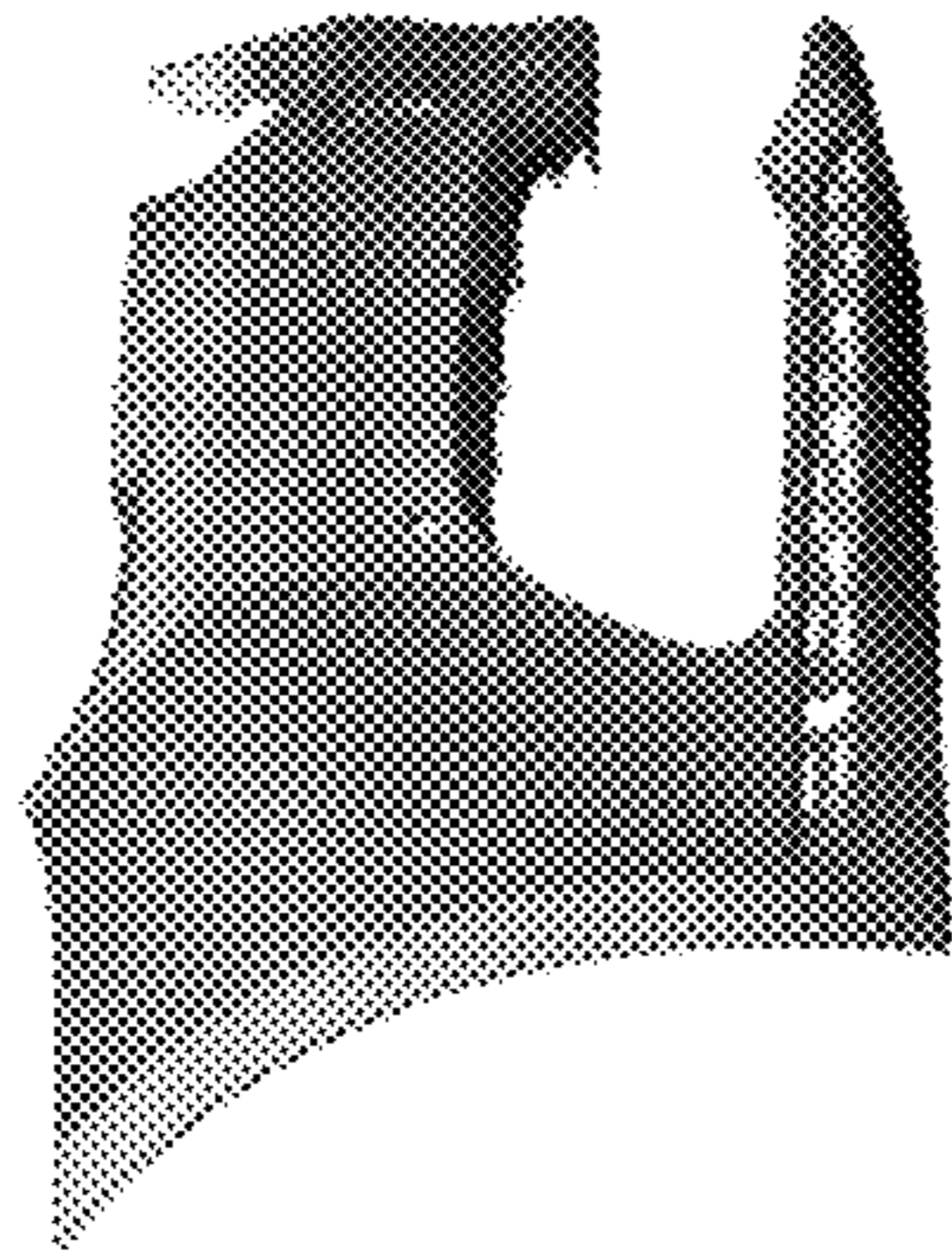

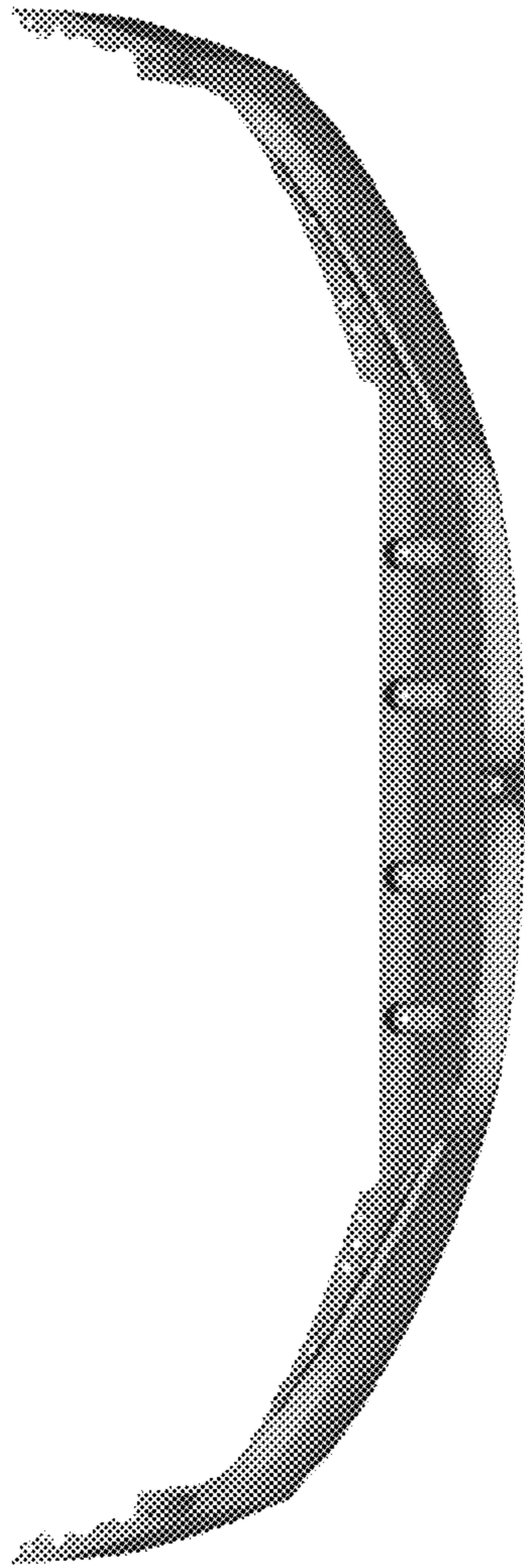

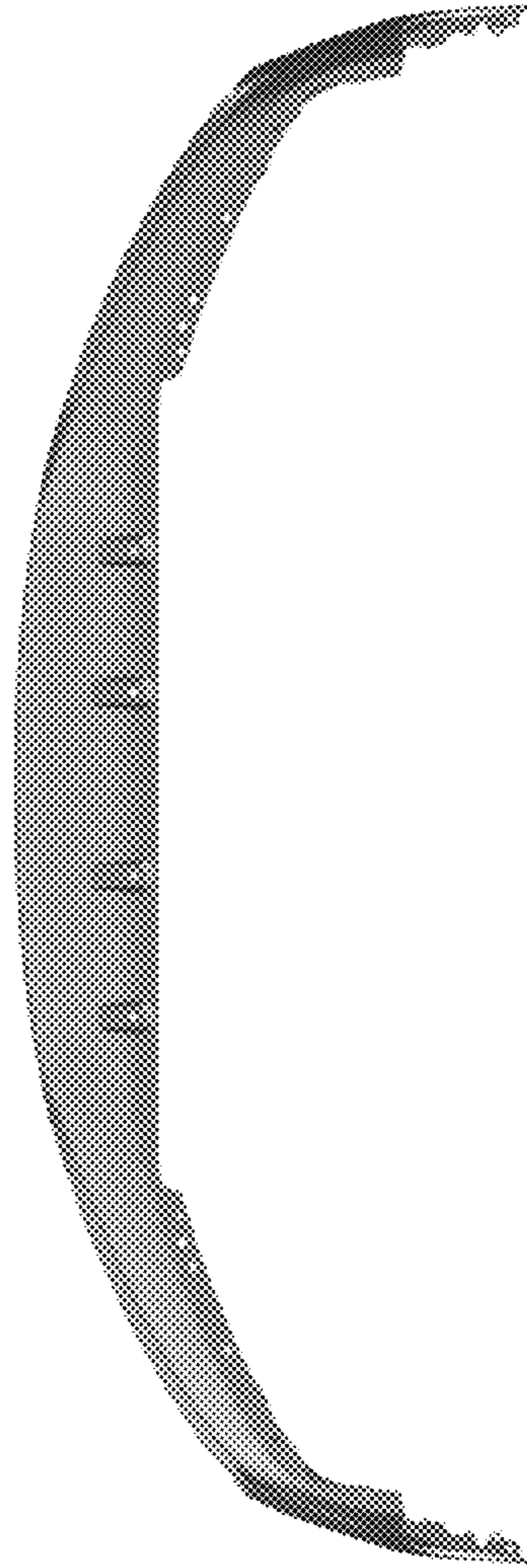

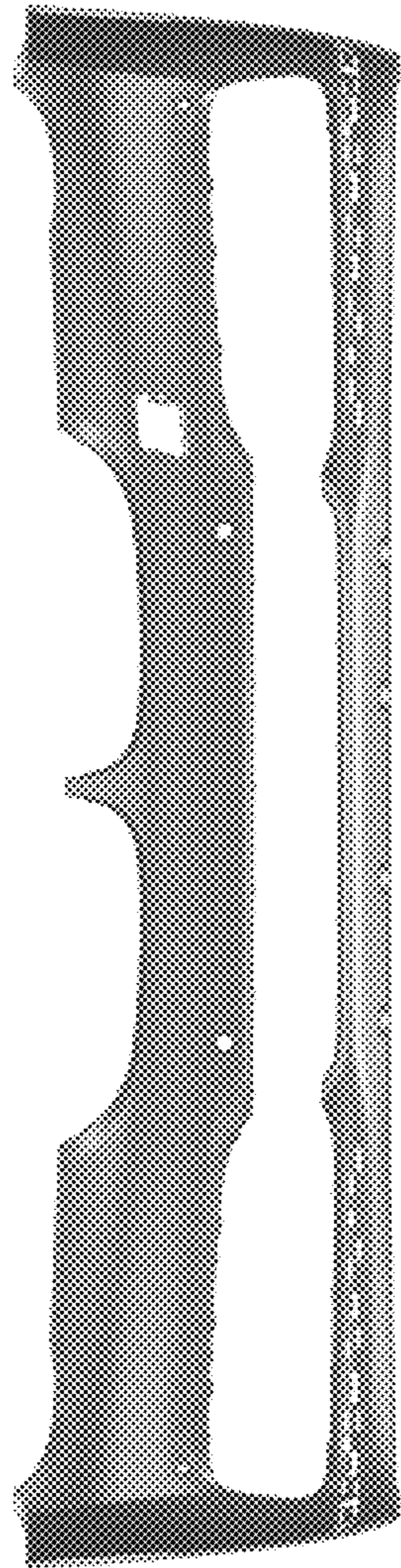
