DESCRIPTION

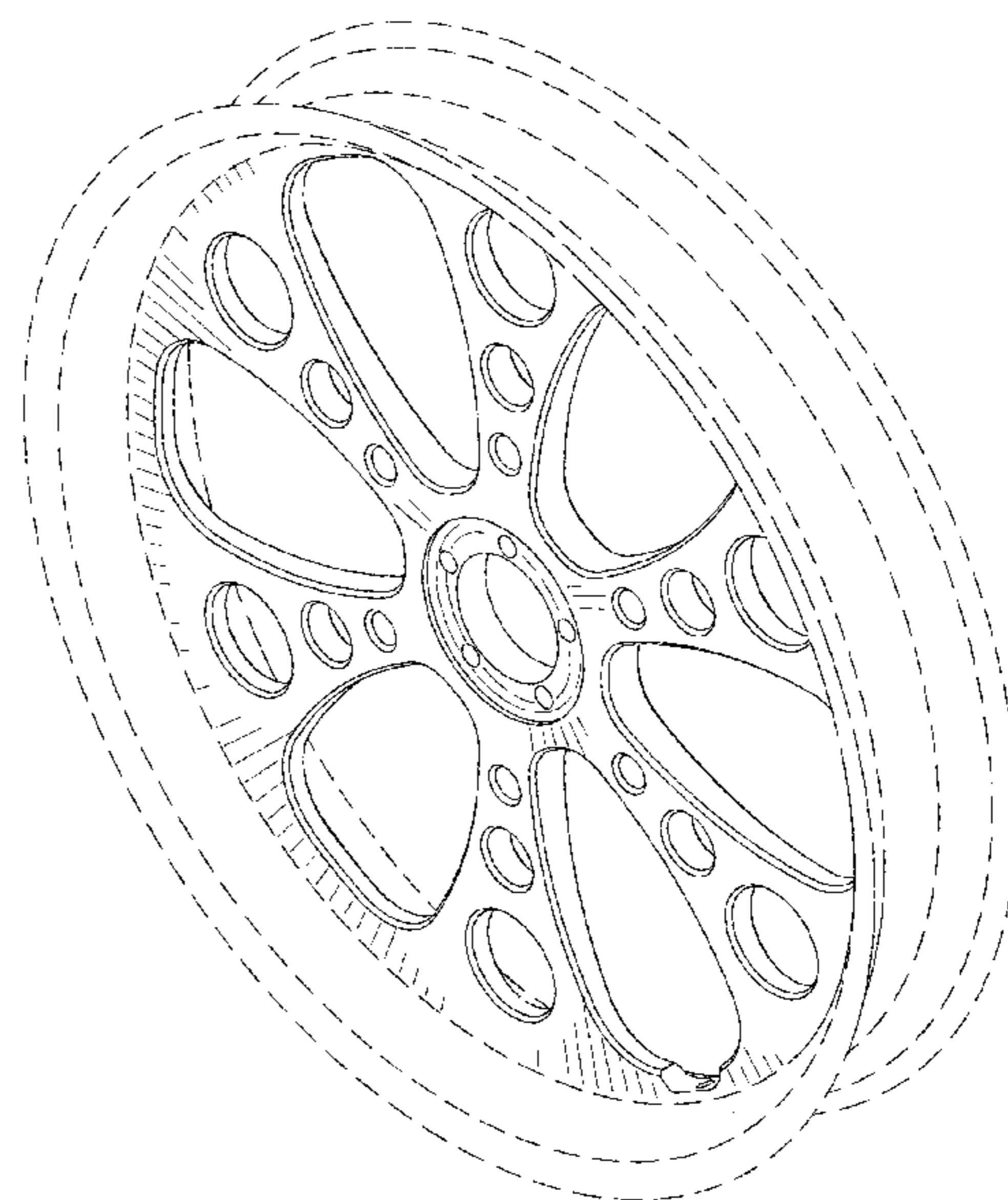
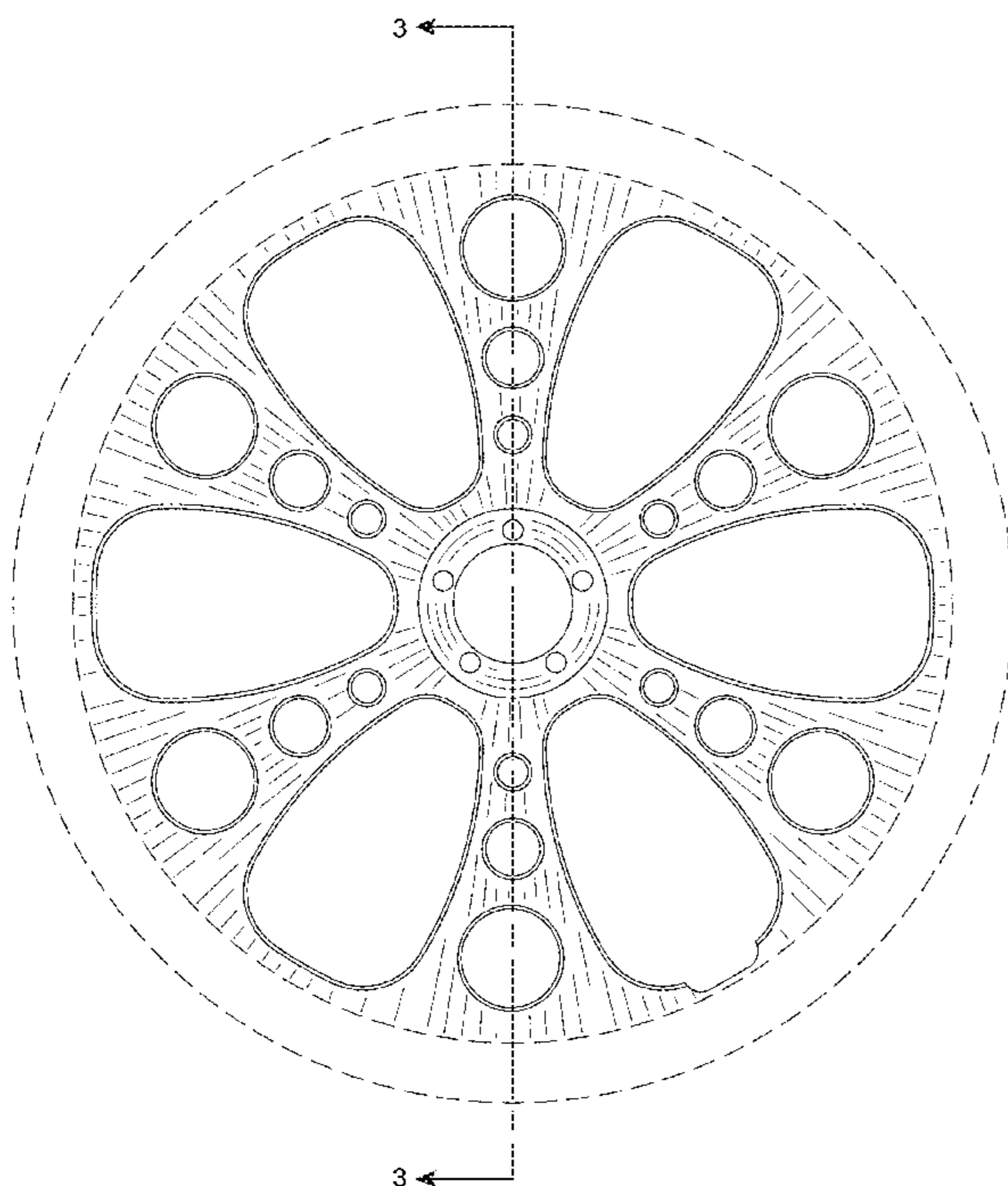
FIG. 1 is a front view of a motorcycle wheel, showing my new design;

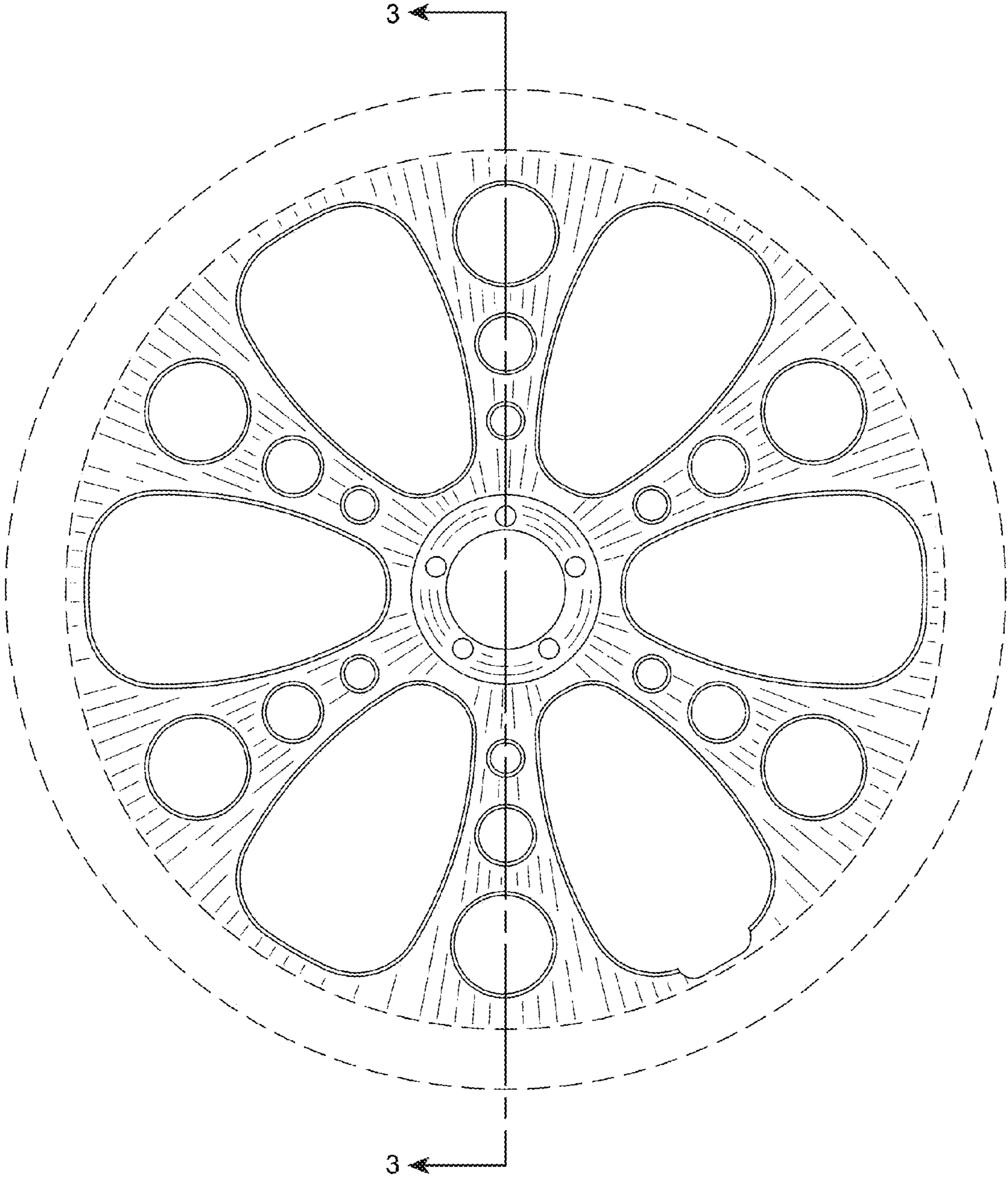

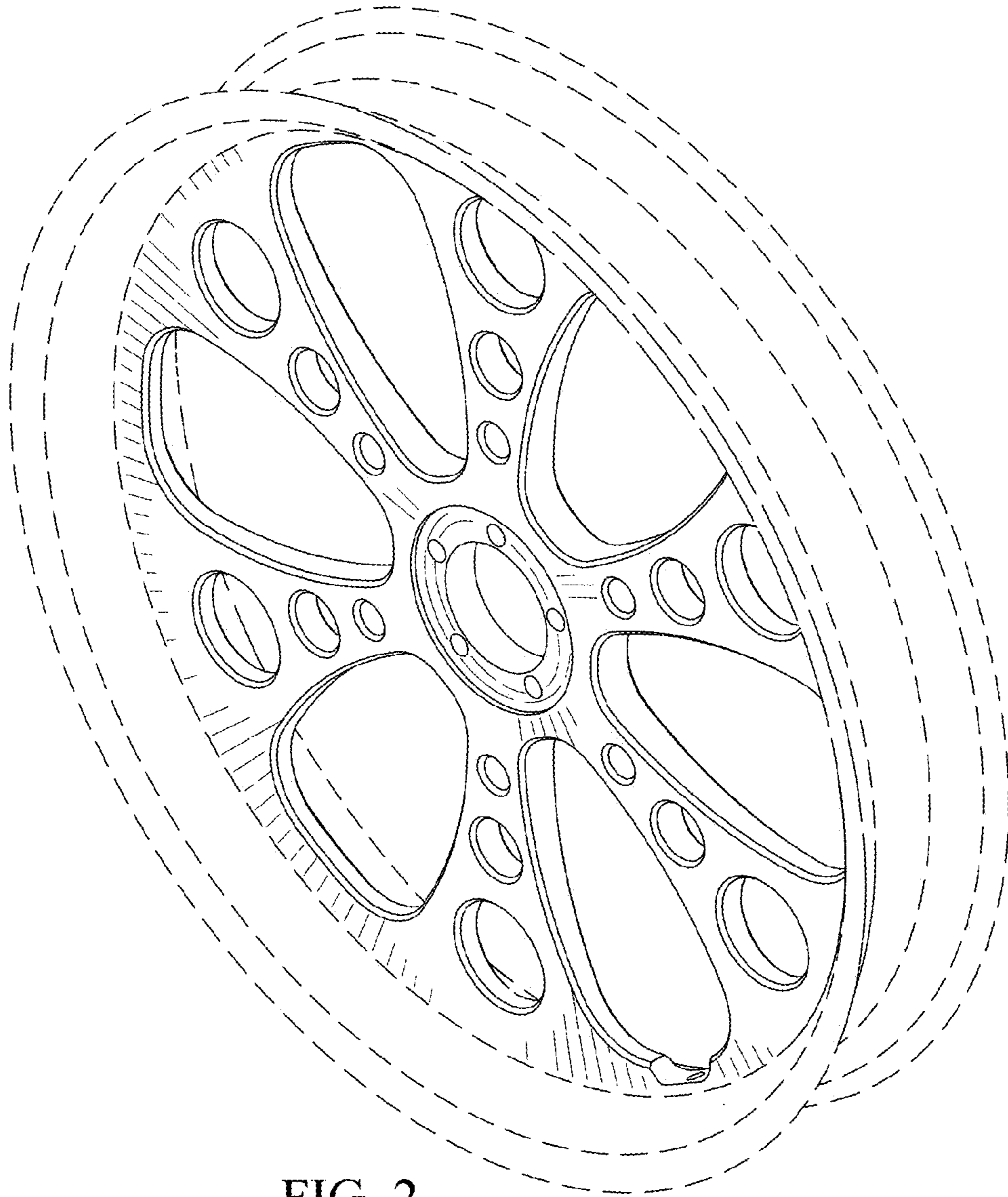

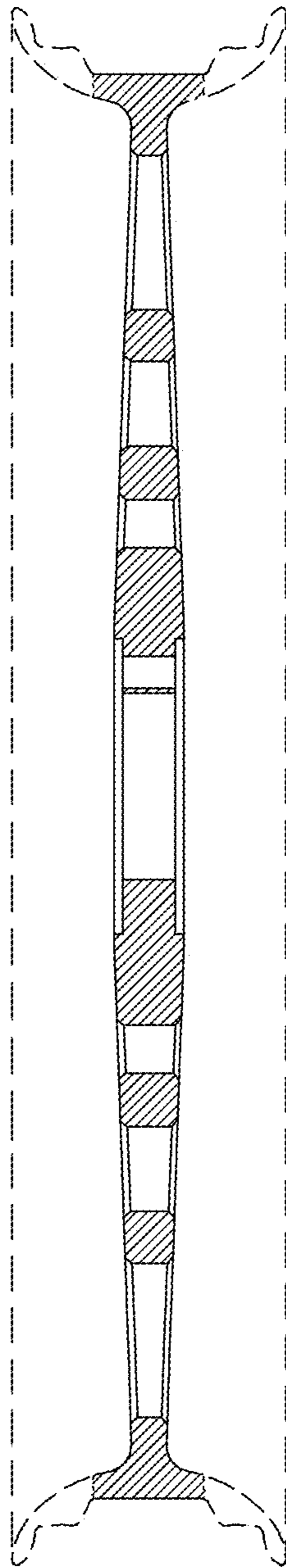
