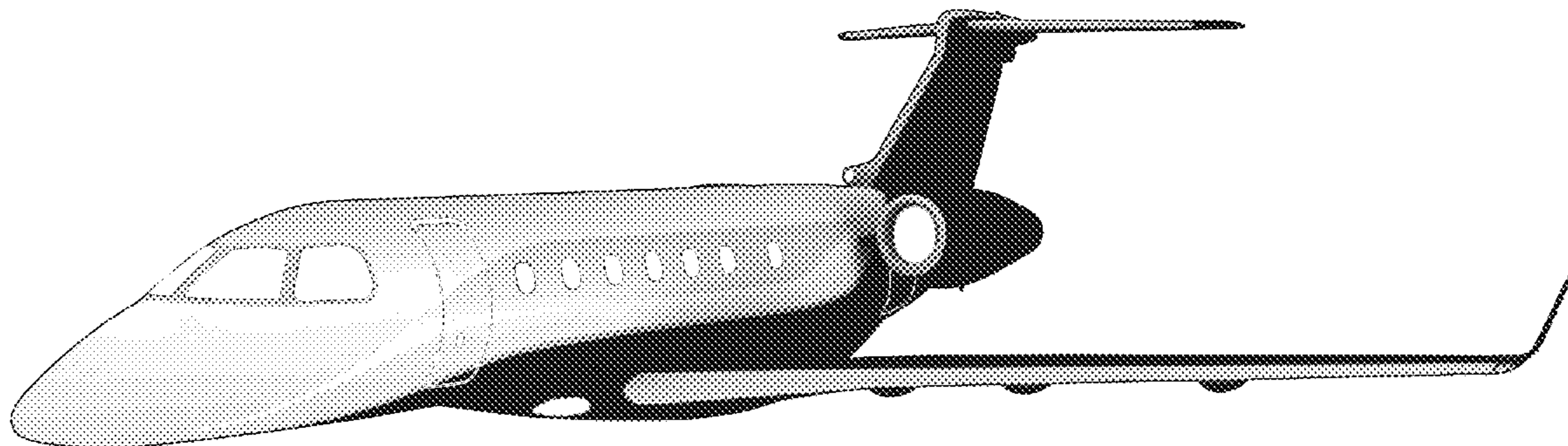
(57) **CLAIM**

The ornamental design for “aircraft with applied surface pattern,” as shown and described.

DESCRIPTION

FIG. 1 is front elevational view of an aircraft with applied surface pattern showing our new design;
FIG. 2 is rear elevational view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is left side perspective view thereof; and,
FIG. 8 is right side perspective view thereof.
The structural features depicted by broken lines in the drawings have been shown for the purpose of illustrating portions of the aircraft with applied surface pattern that form no part of the claimed design.

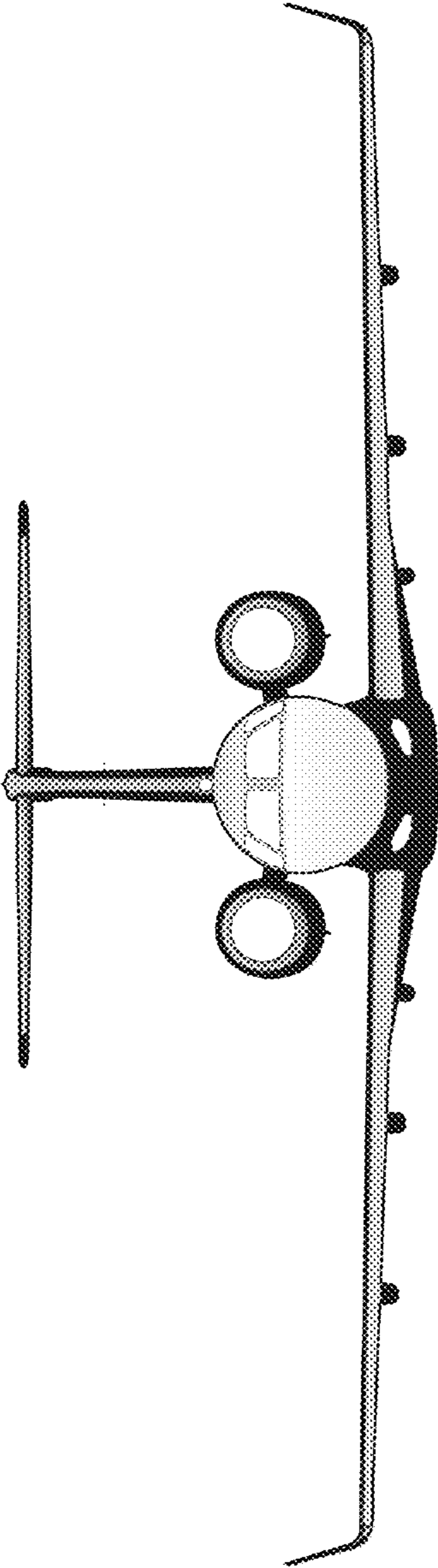

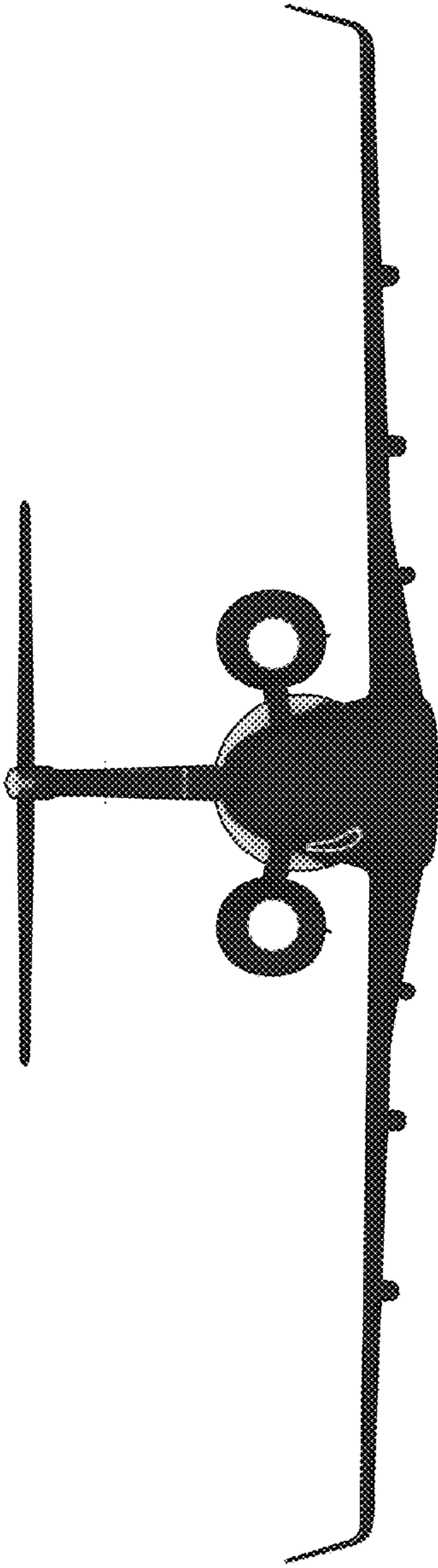

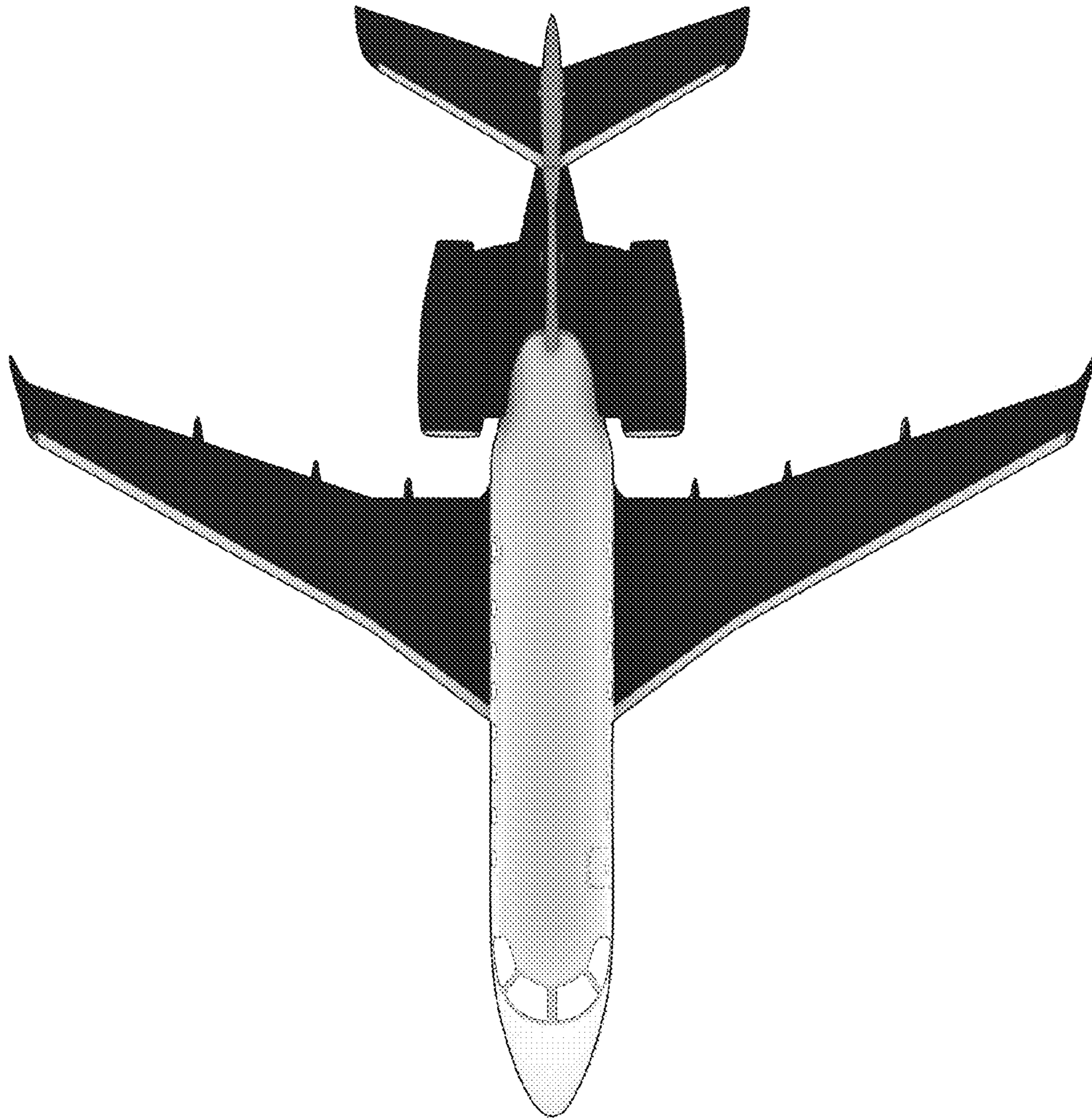

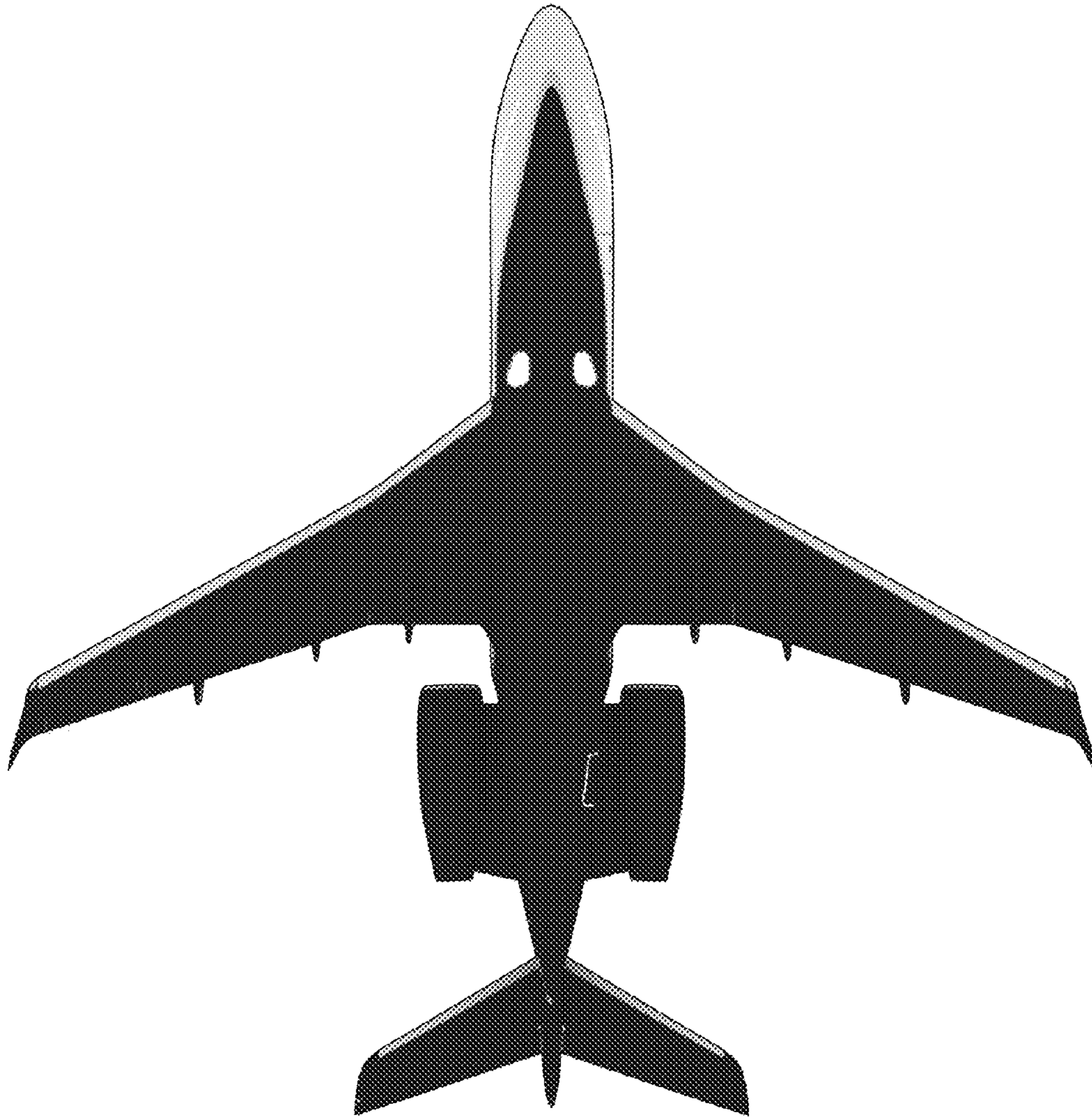

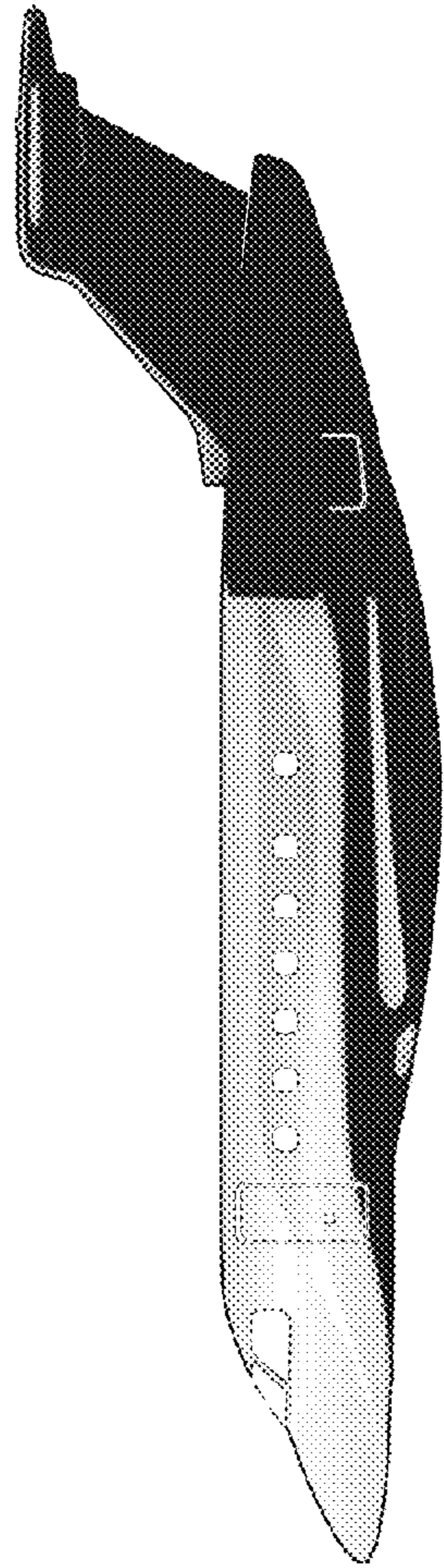

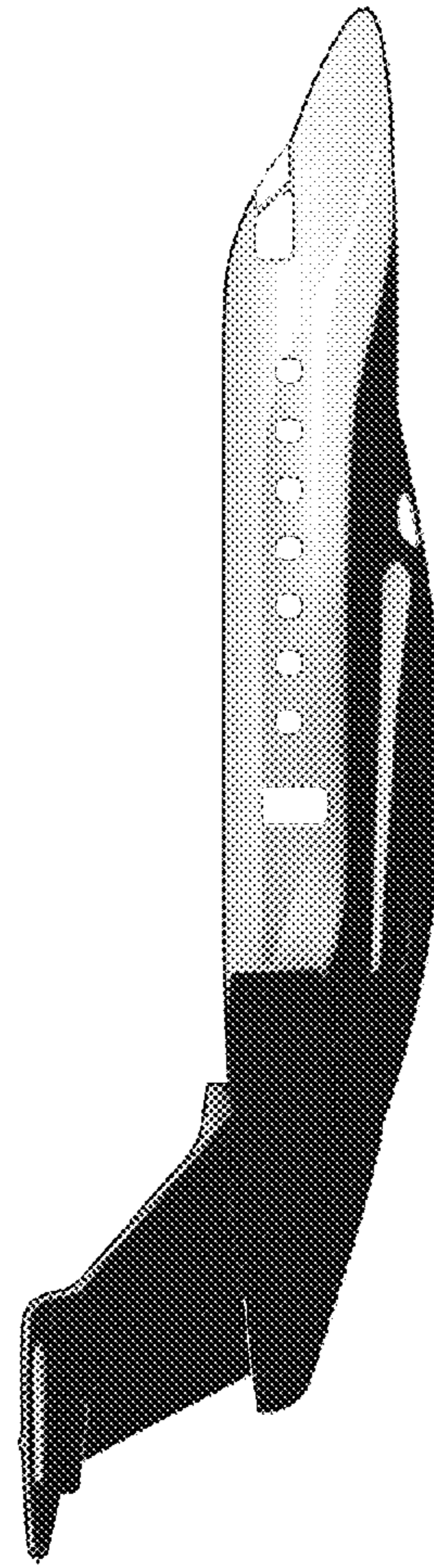

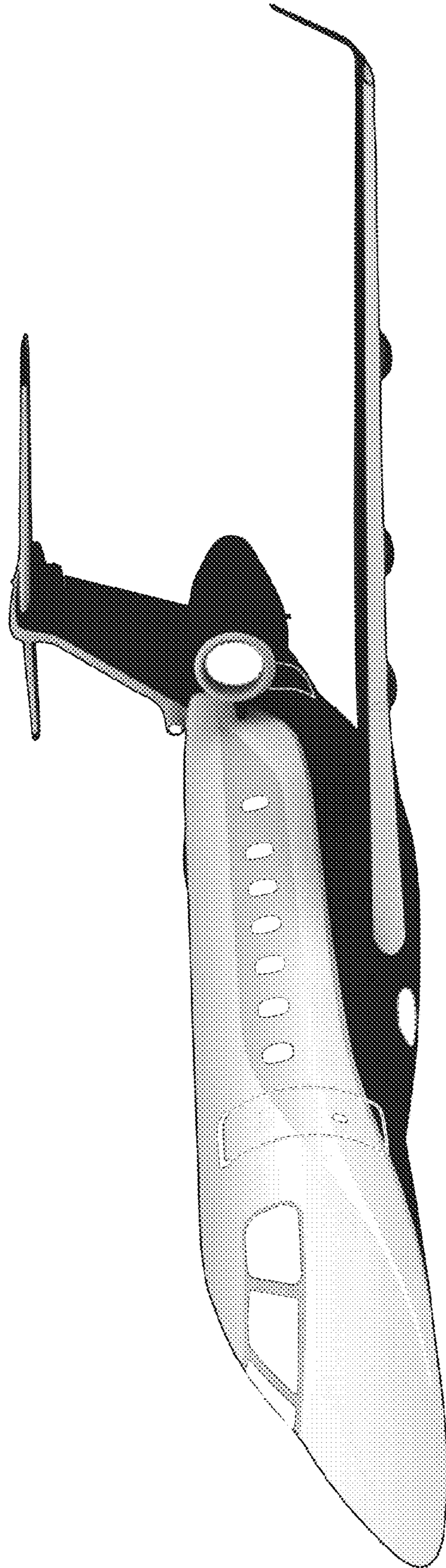

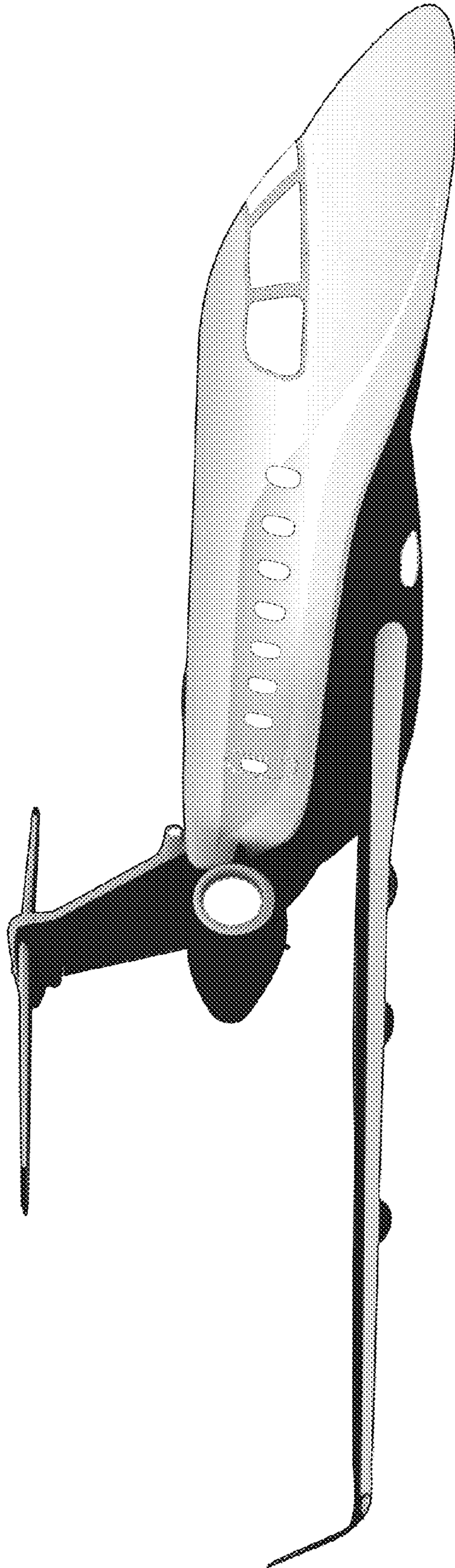
