DESCRIPTION

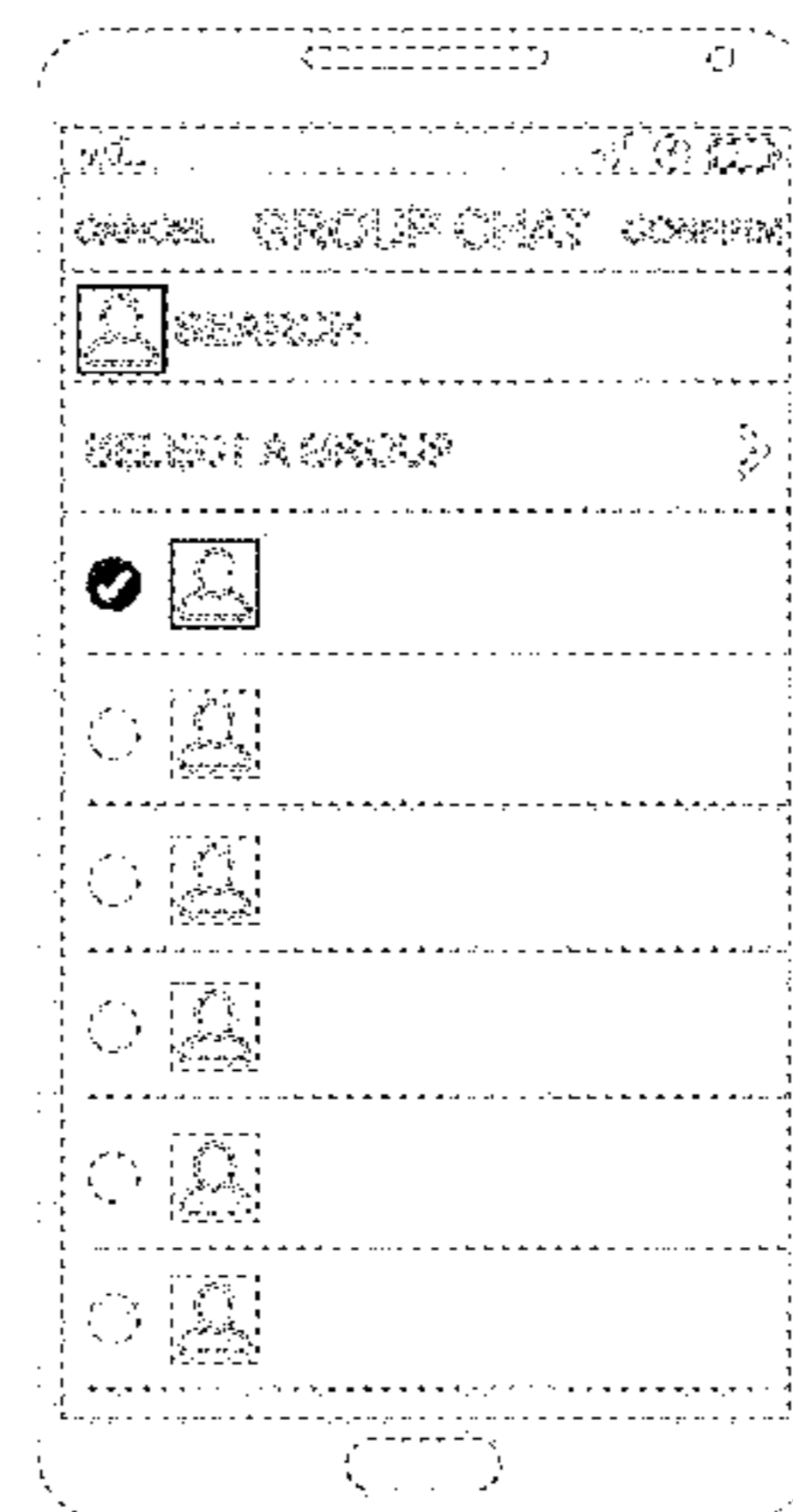
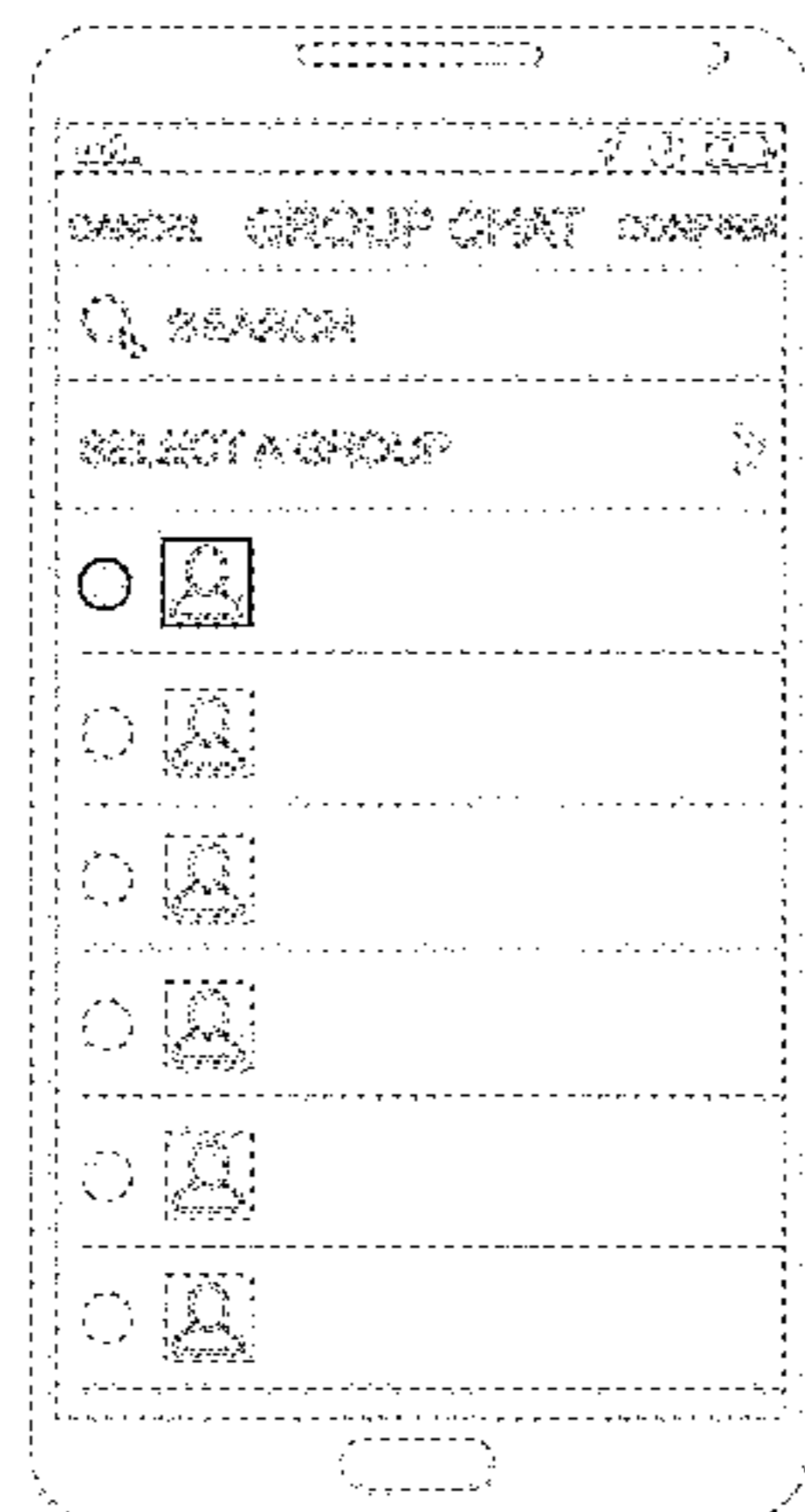
FIG. 1 is a front view of a first image of a portion of a display screen with animated graphical user interface showing my new design; and,

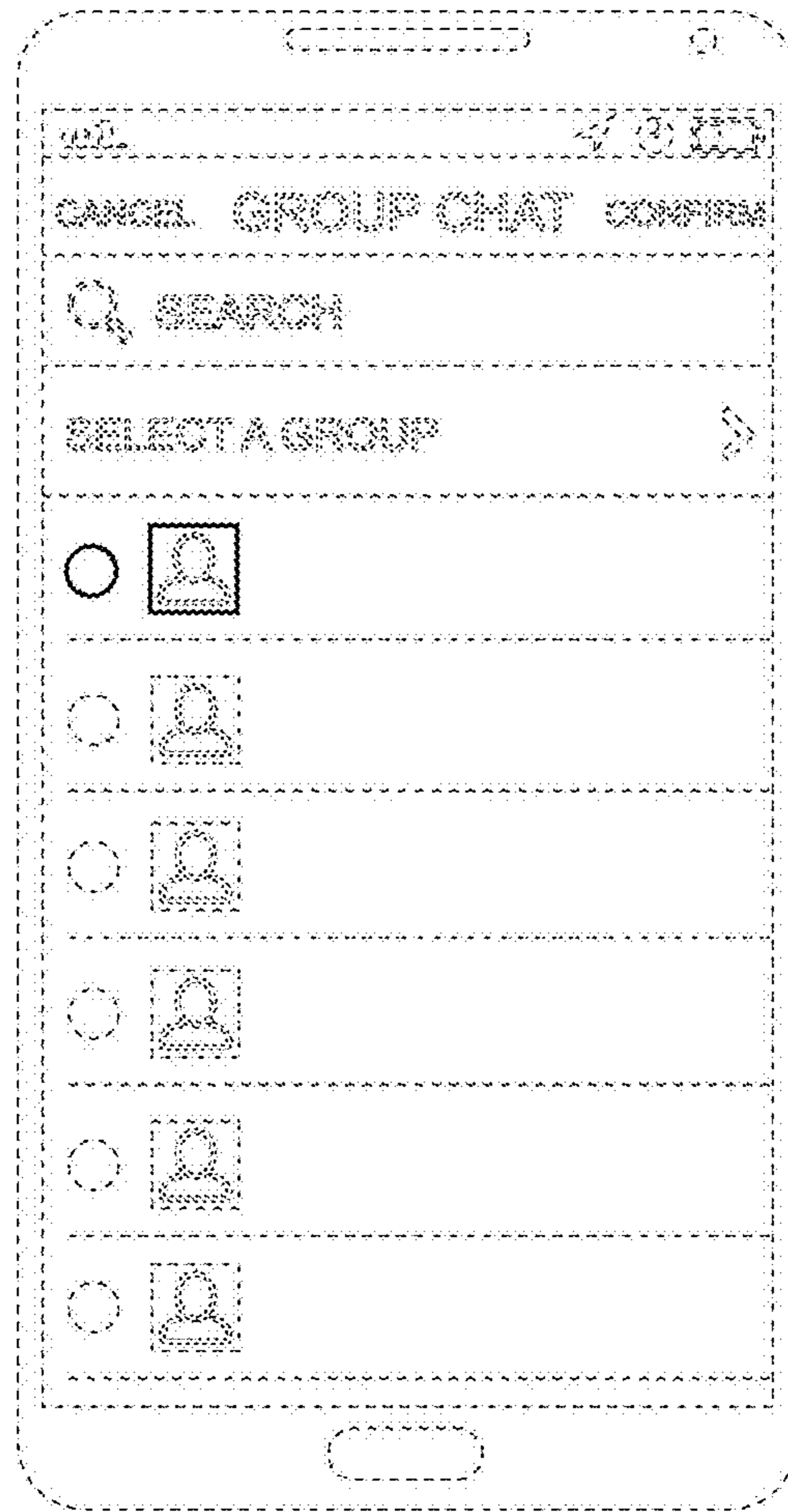

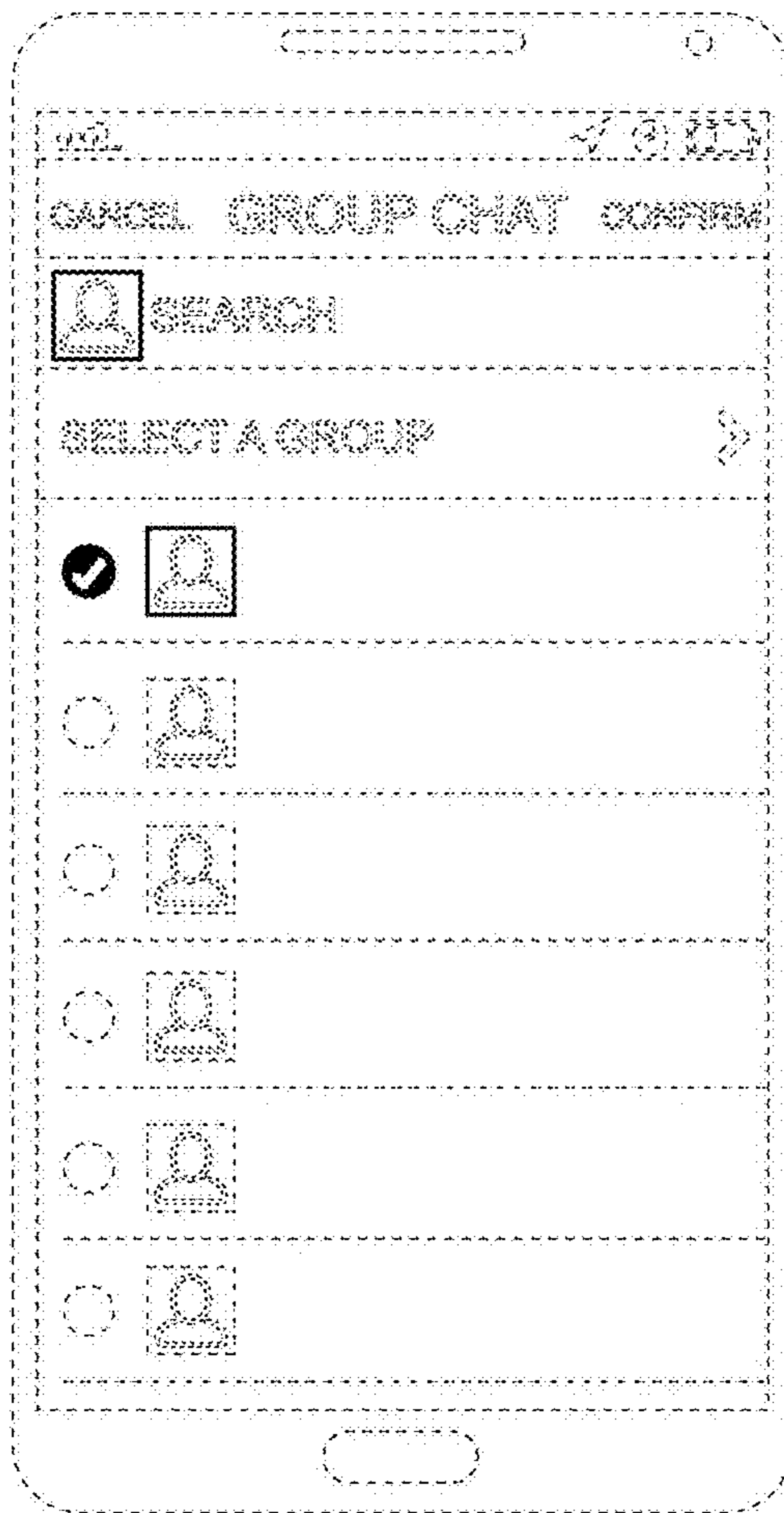
