FIG. 12 is the twelfth image thereof;

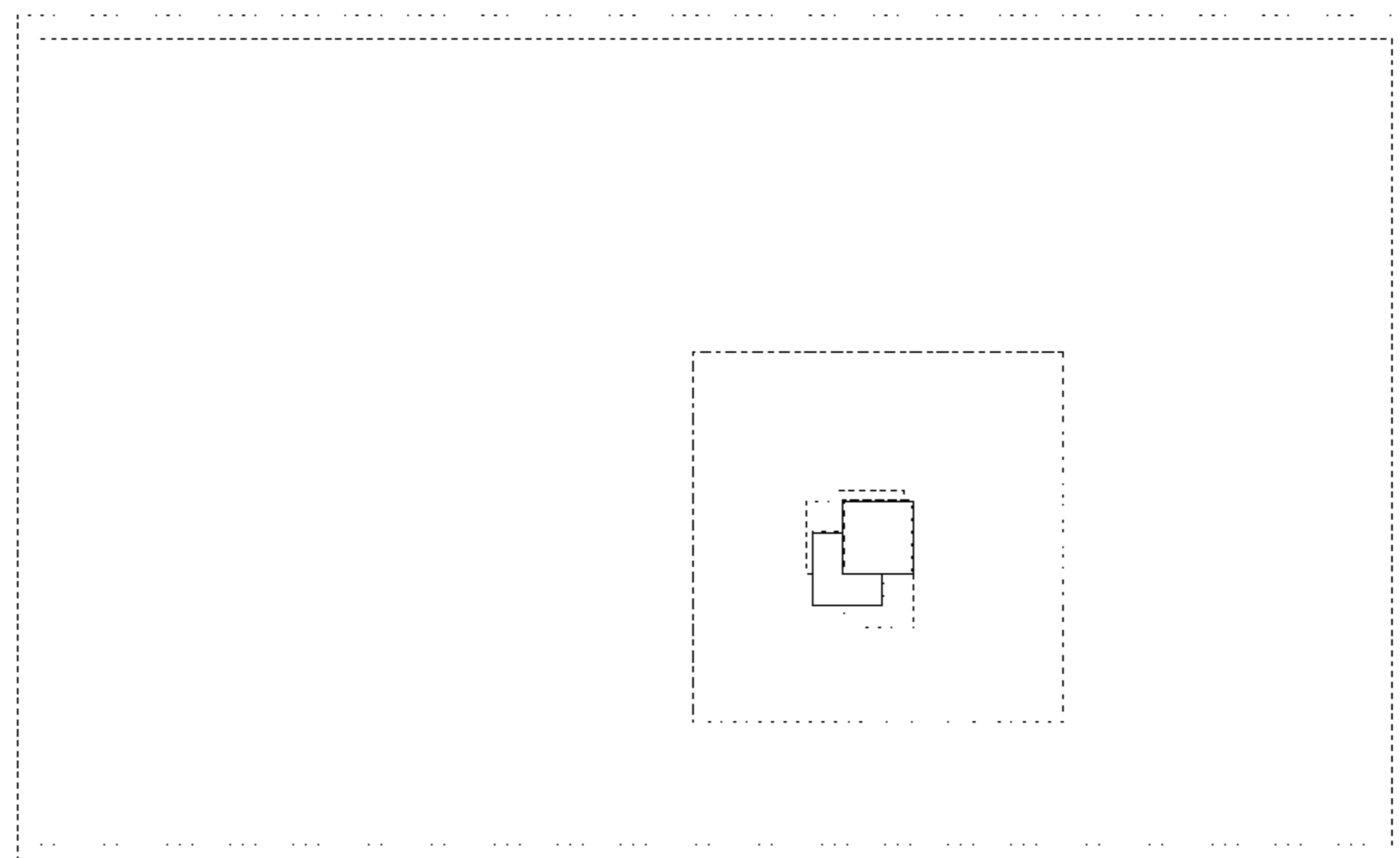
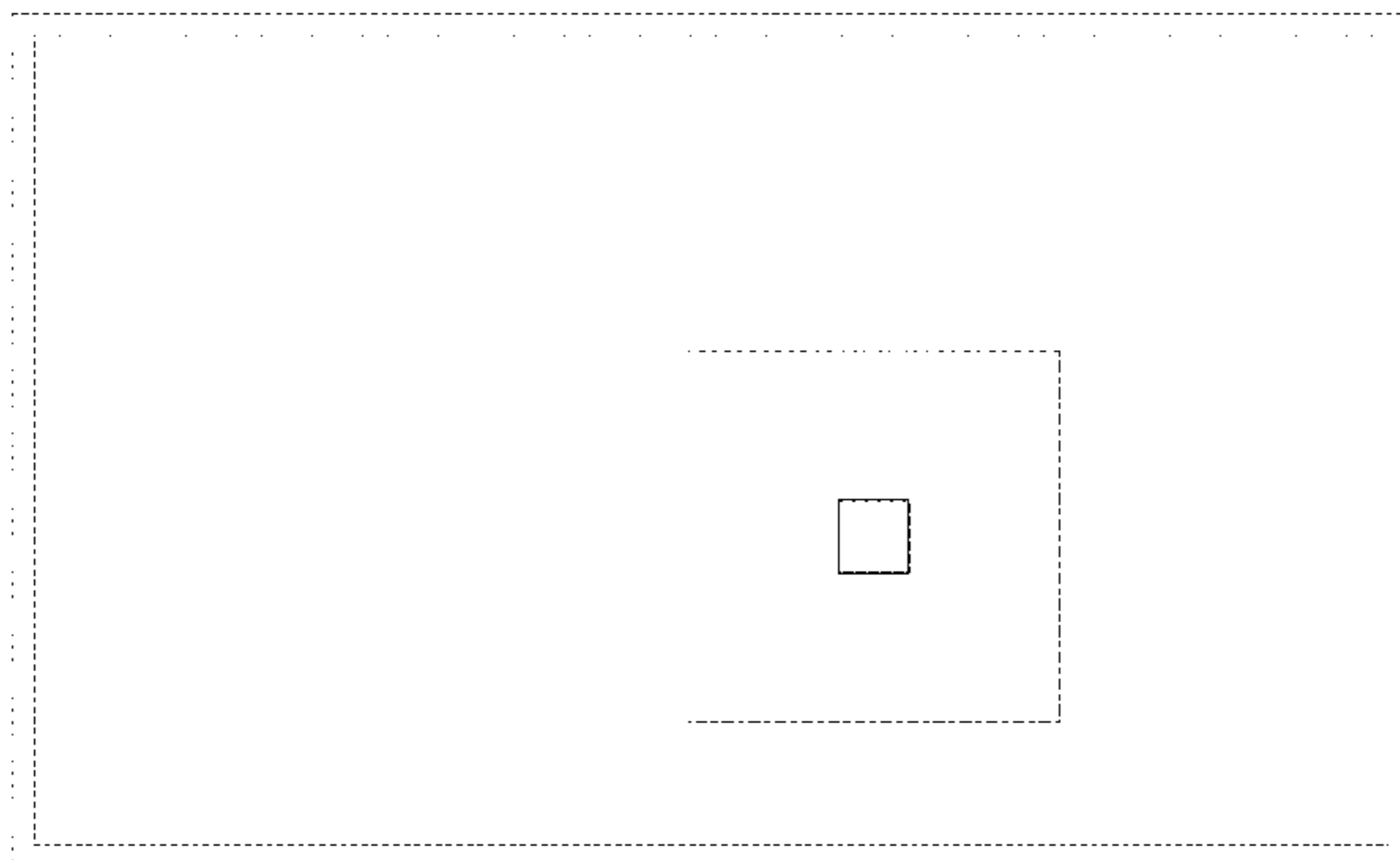
FIG. 13 is the thirteenth image thereof;

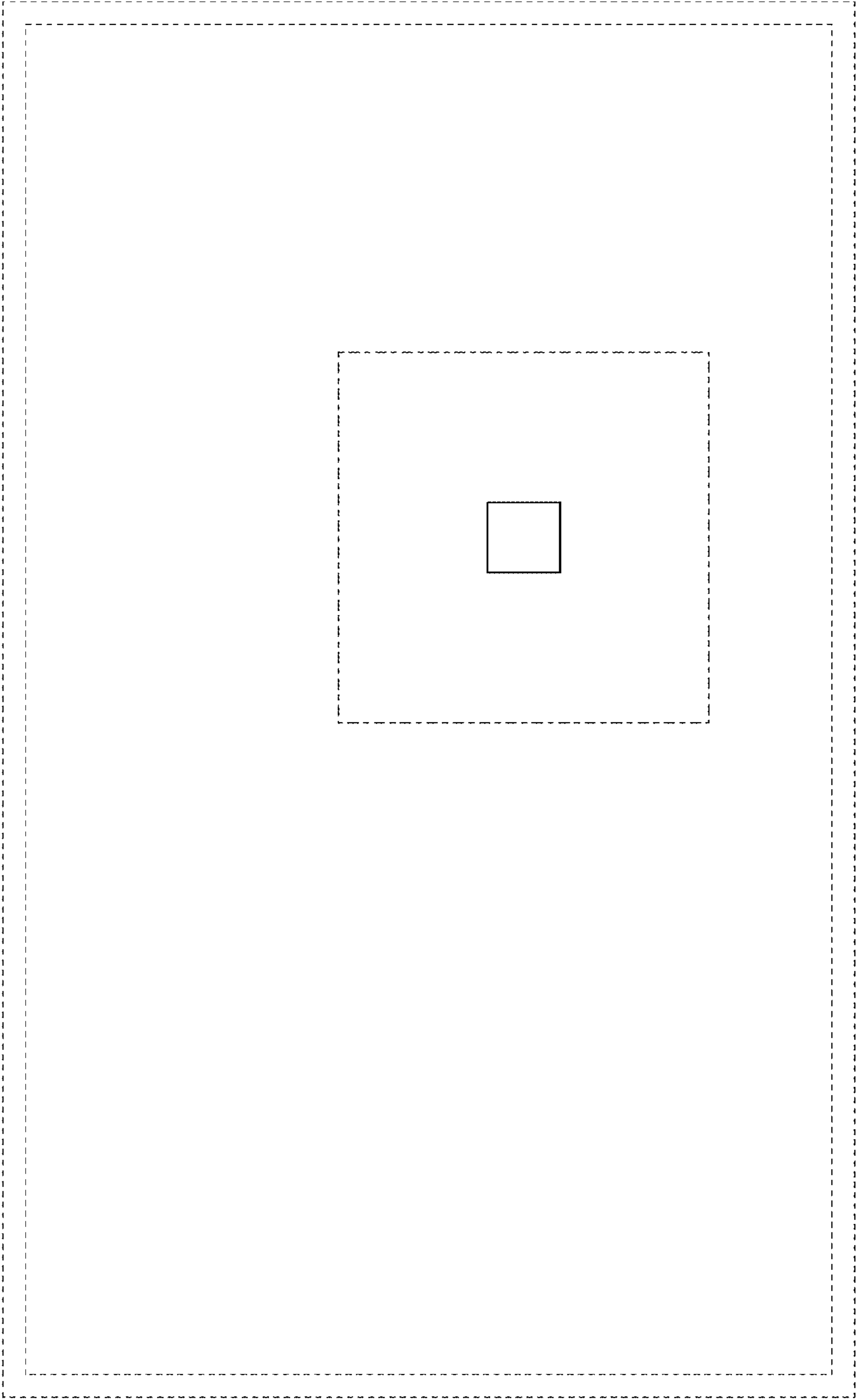

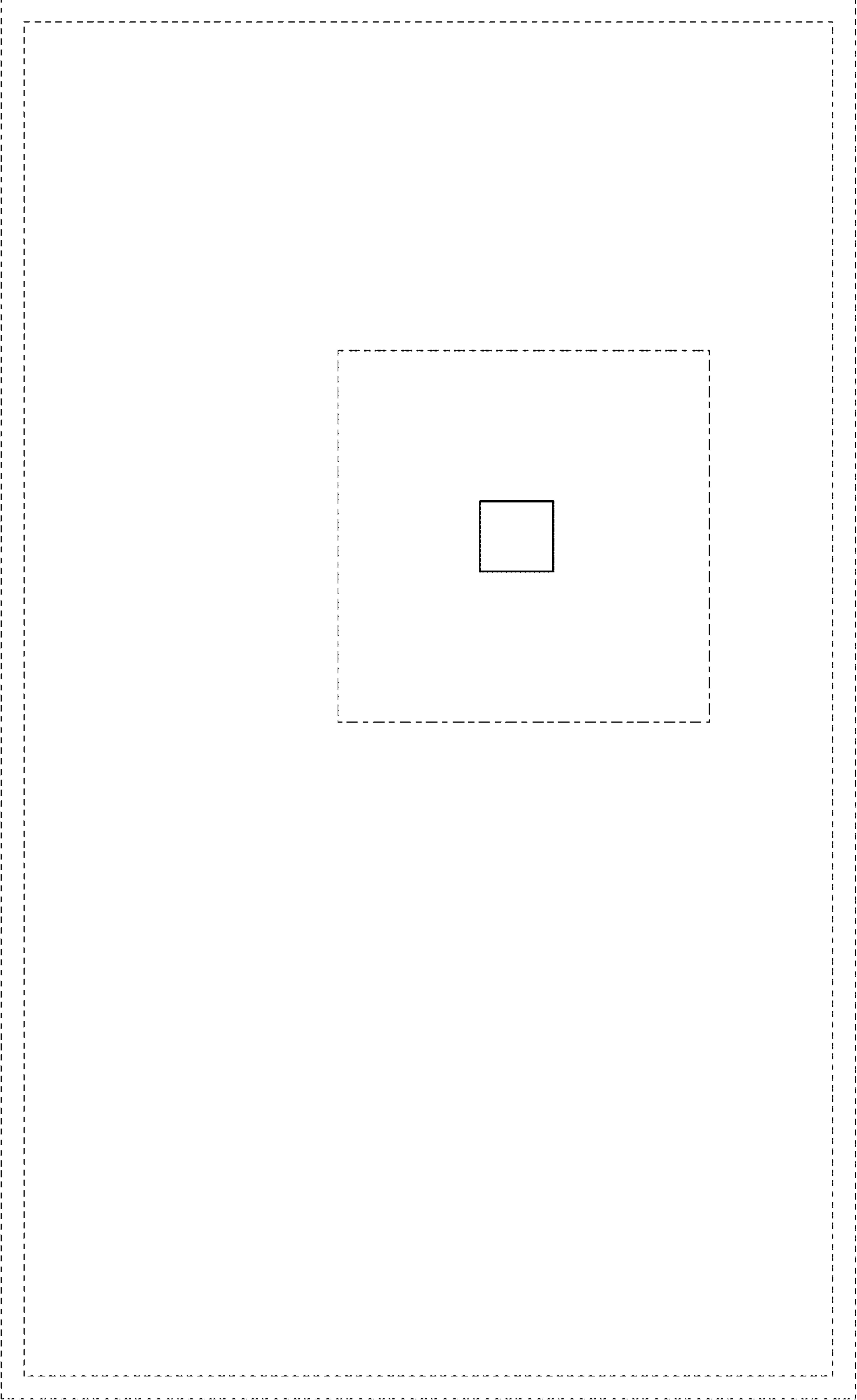

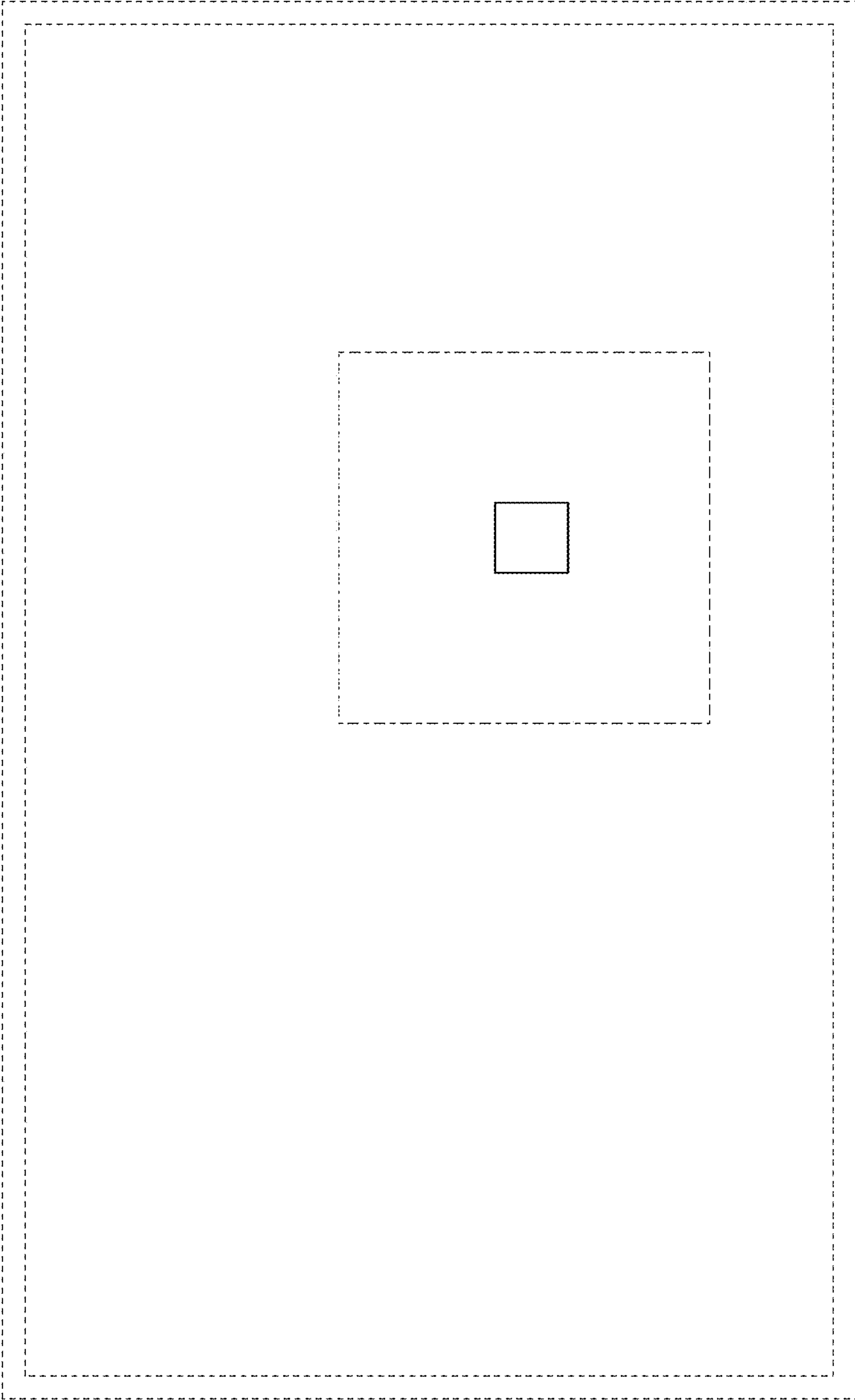

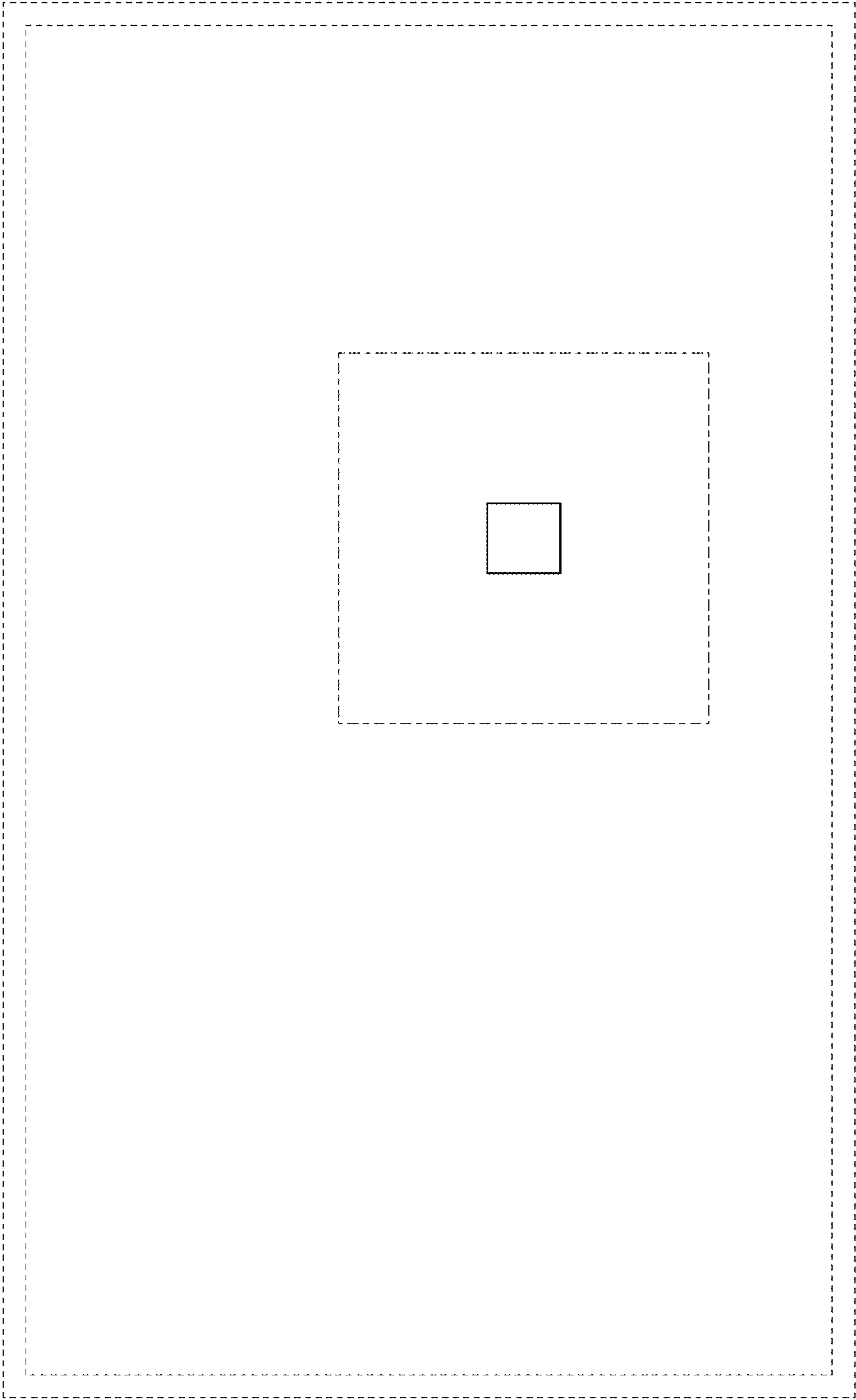

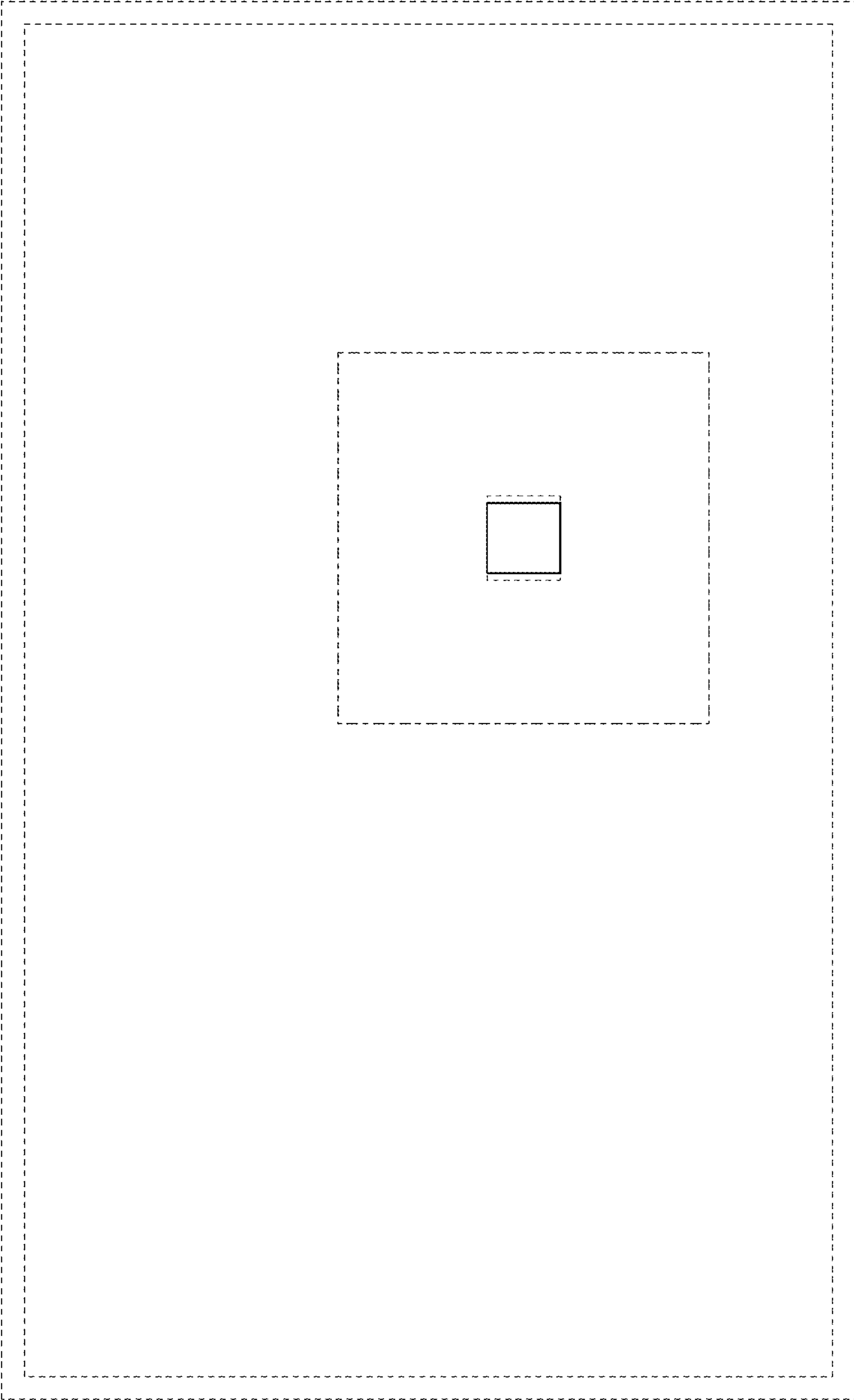

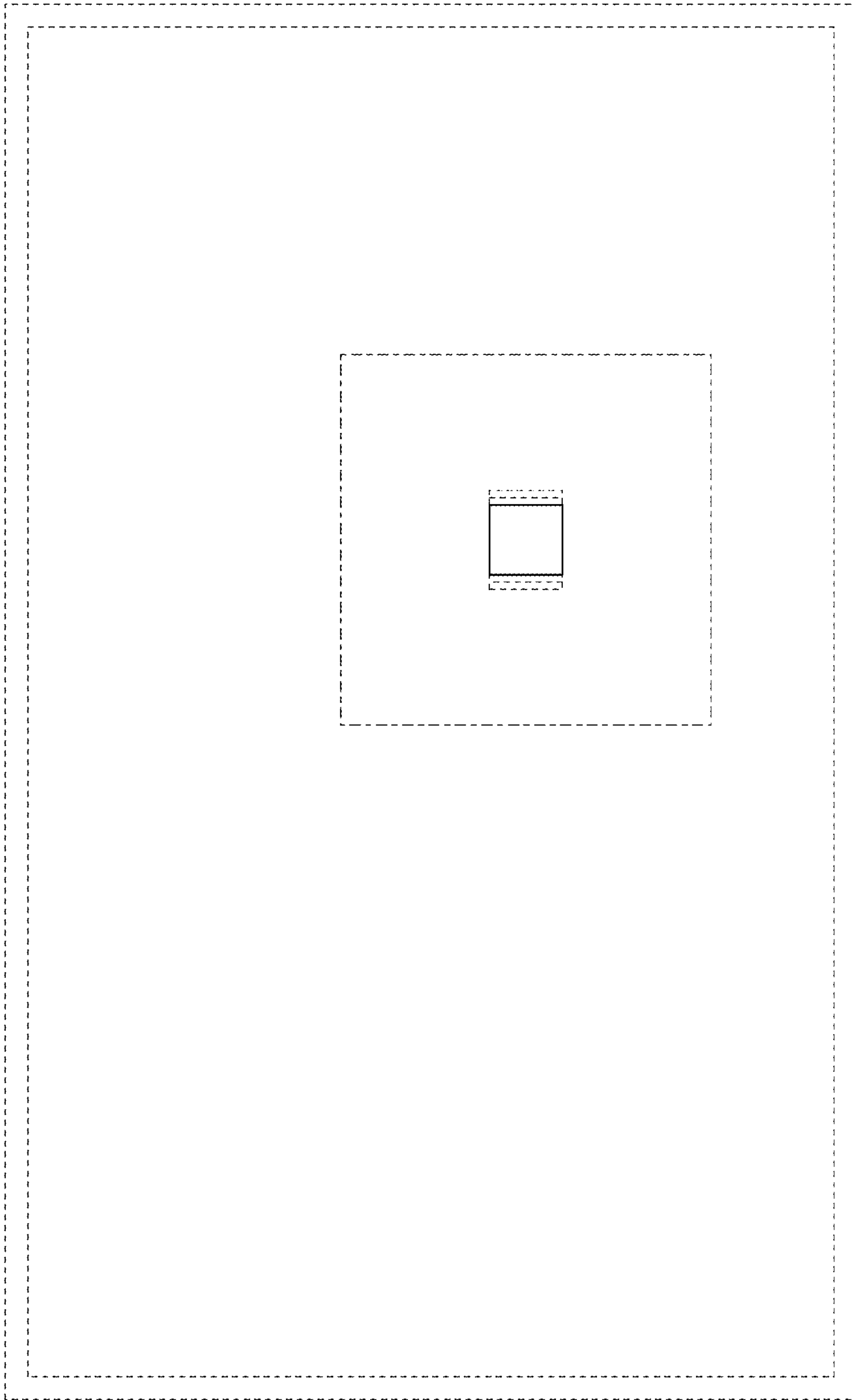

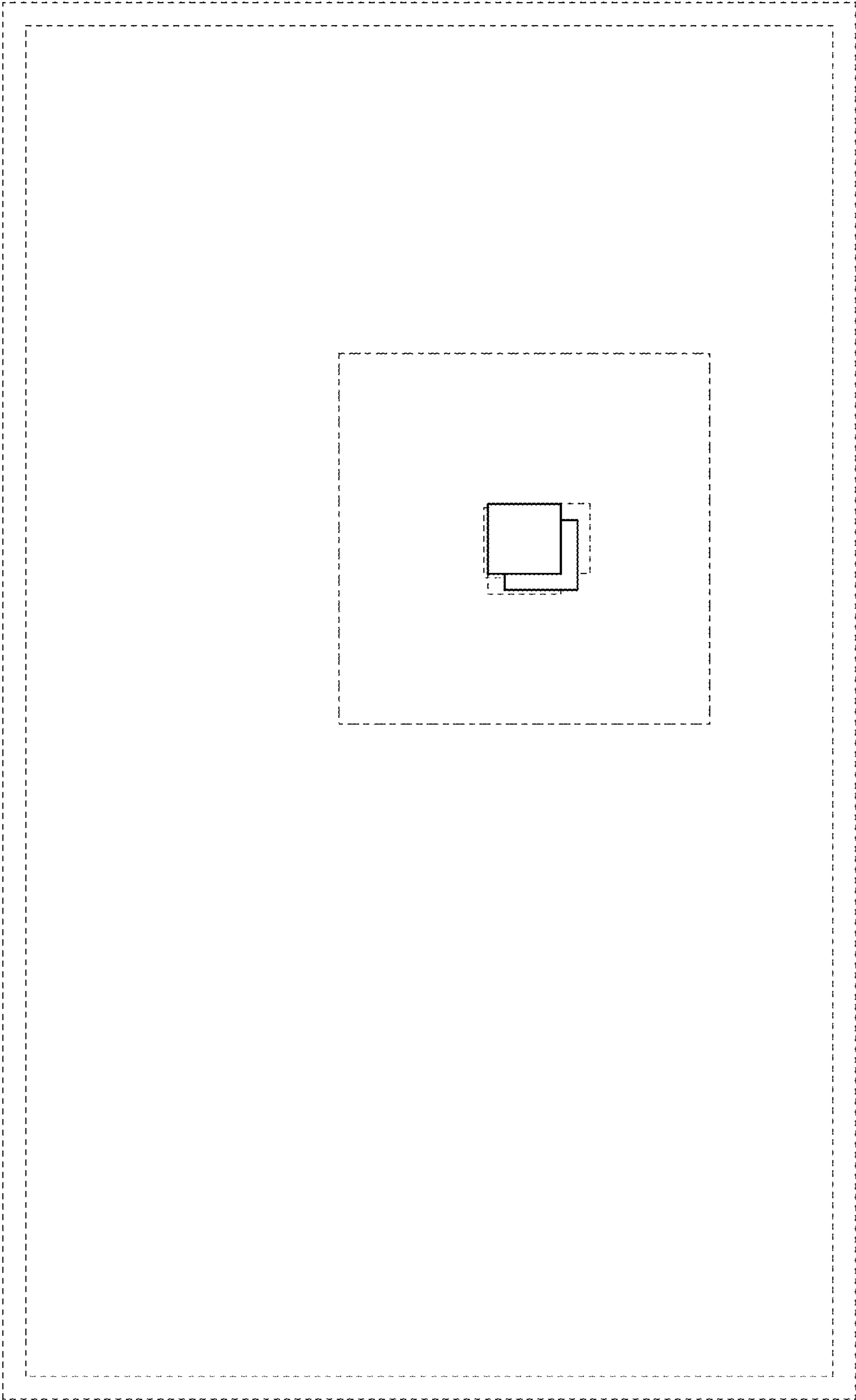

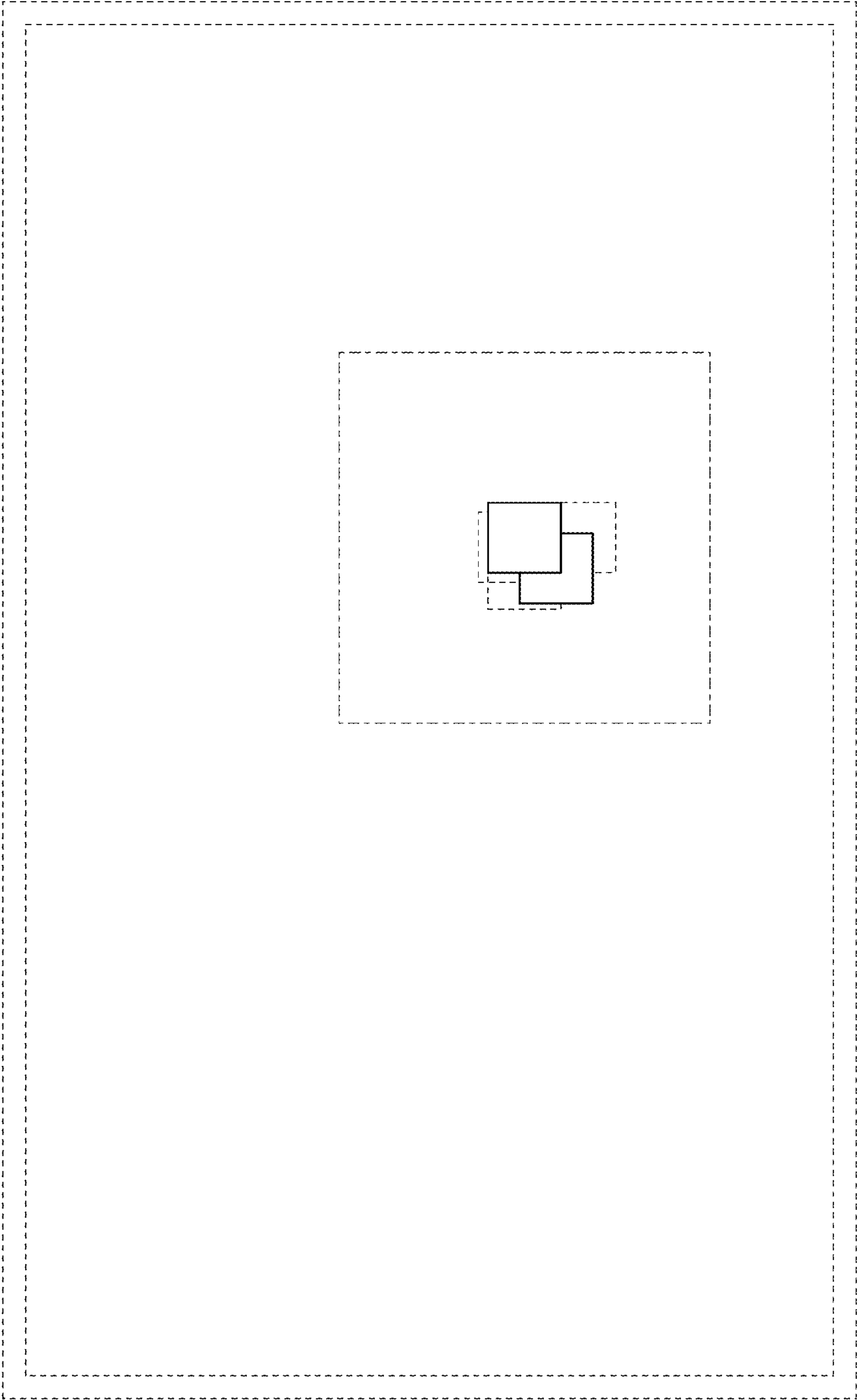

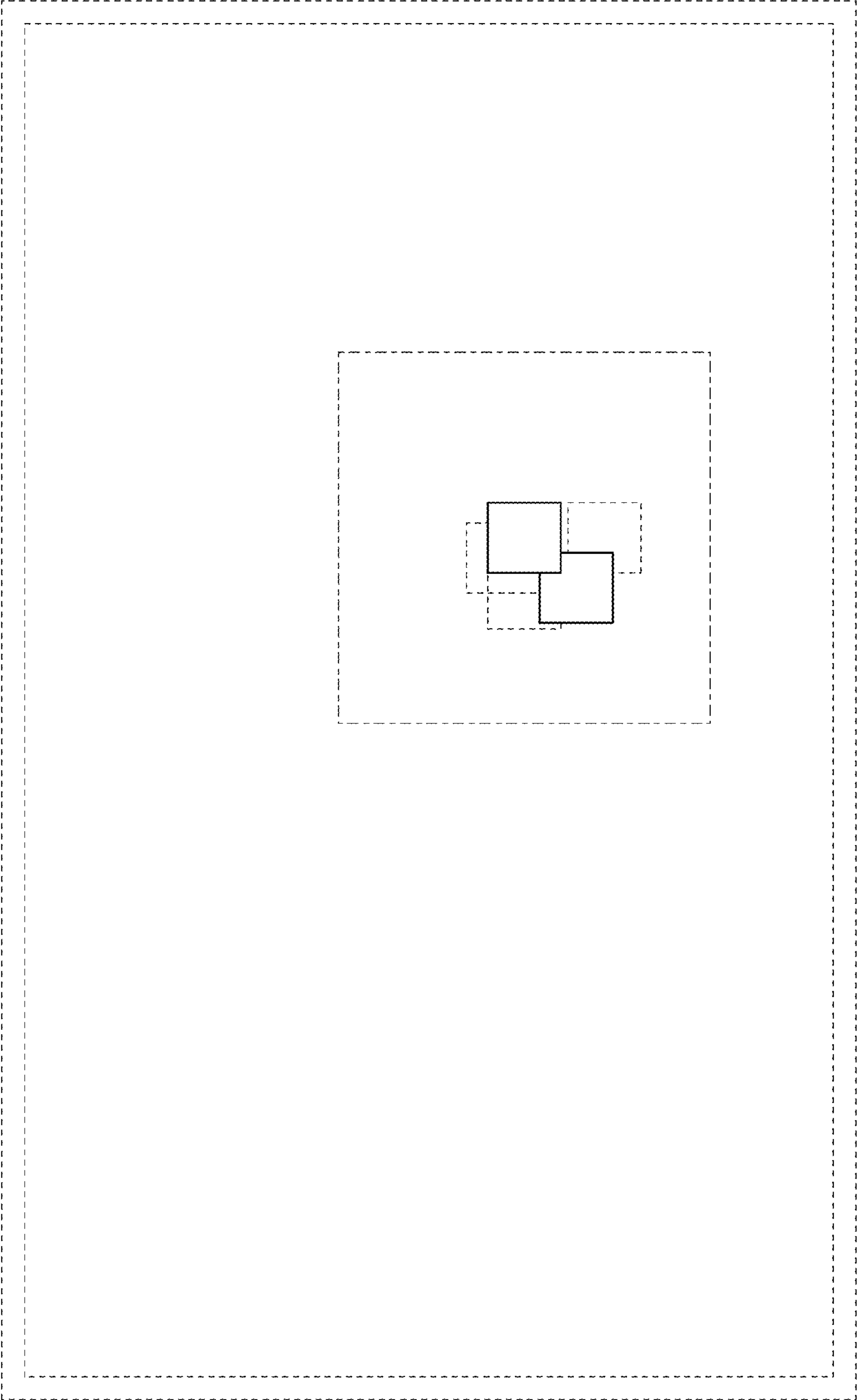

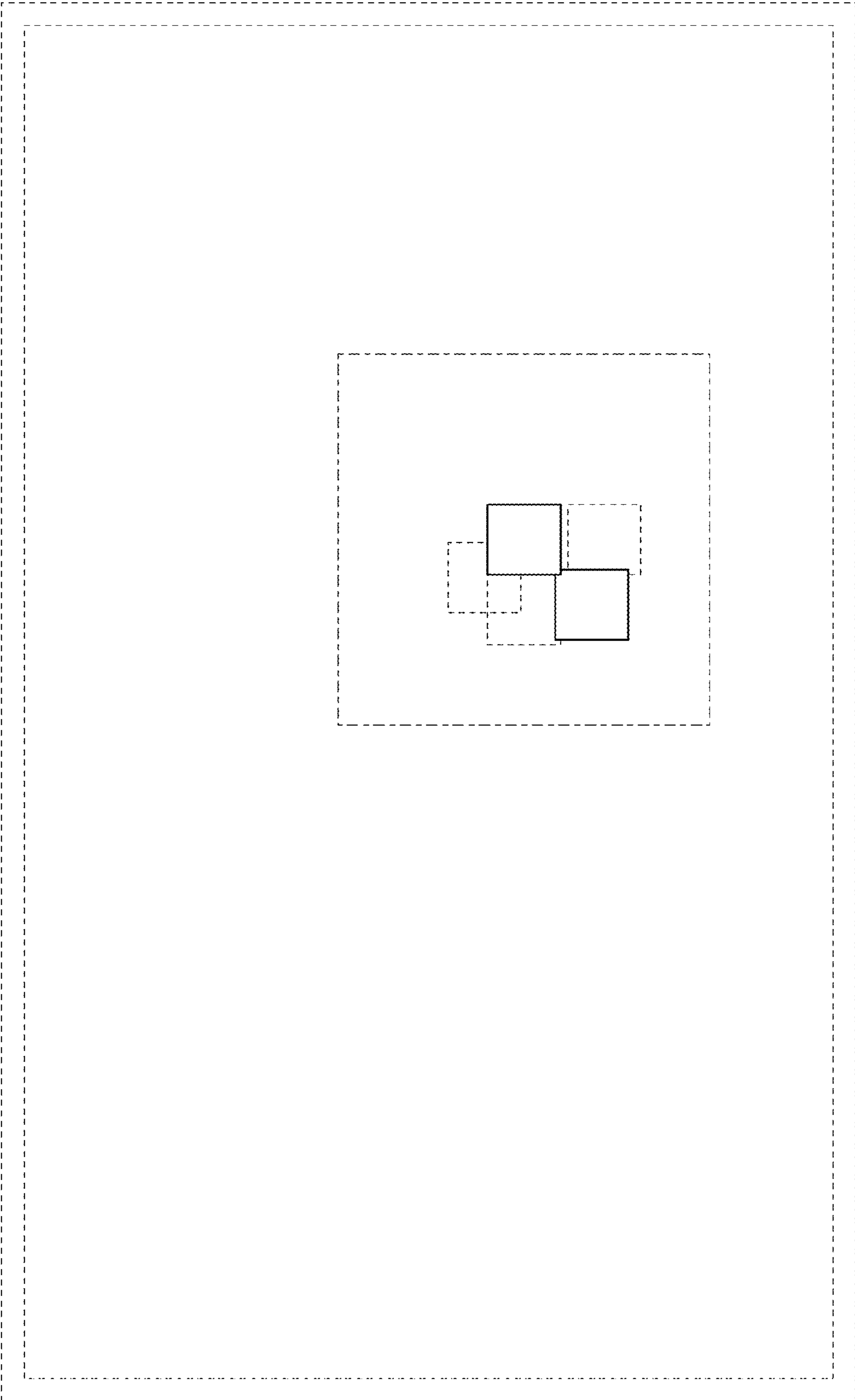

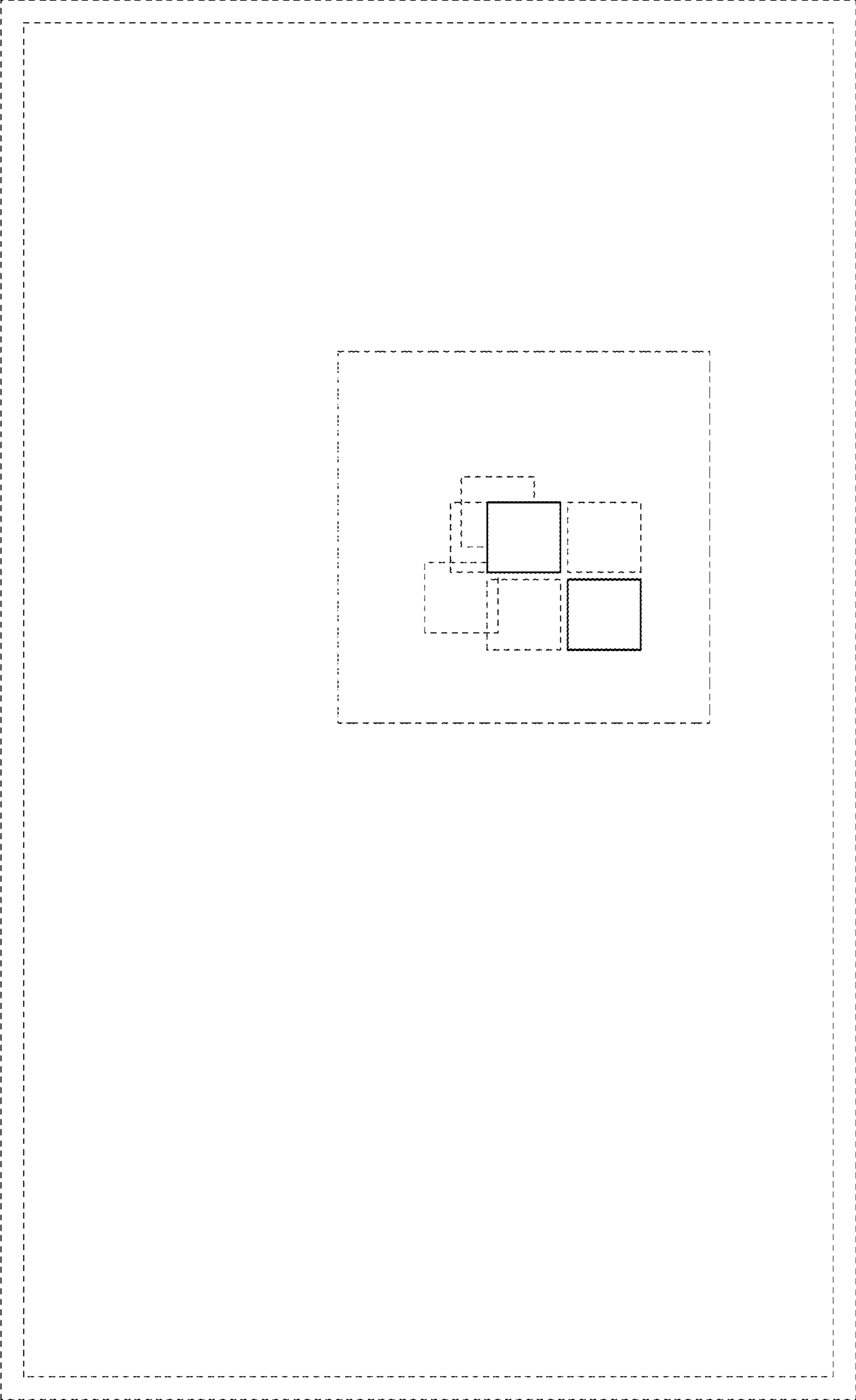

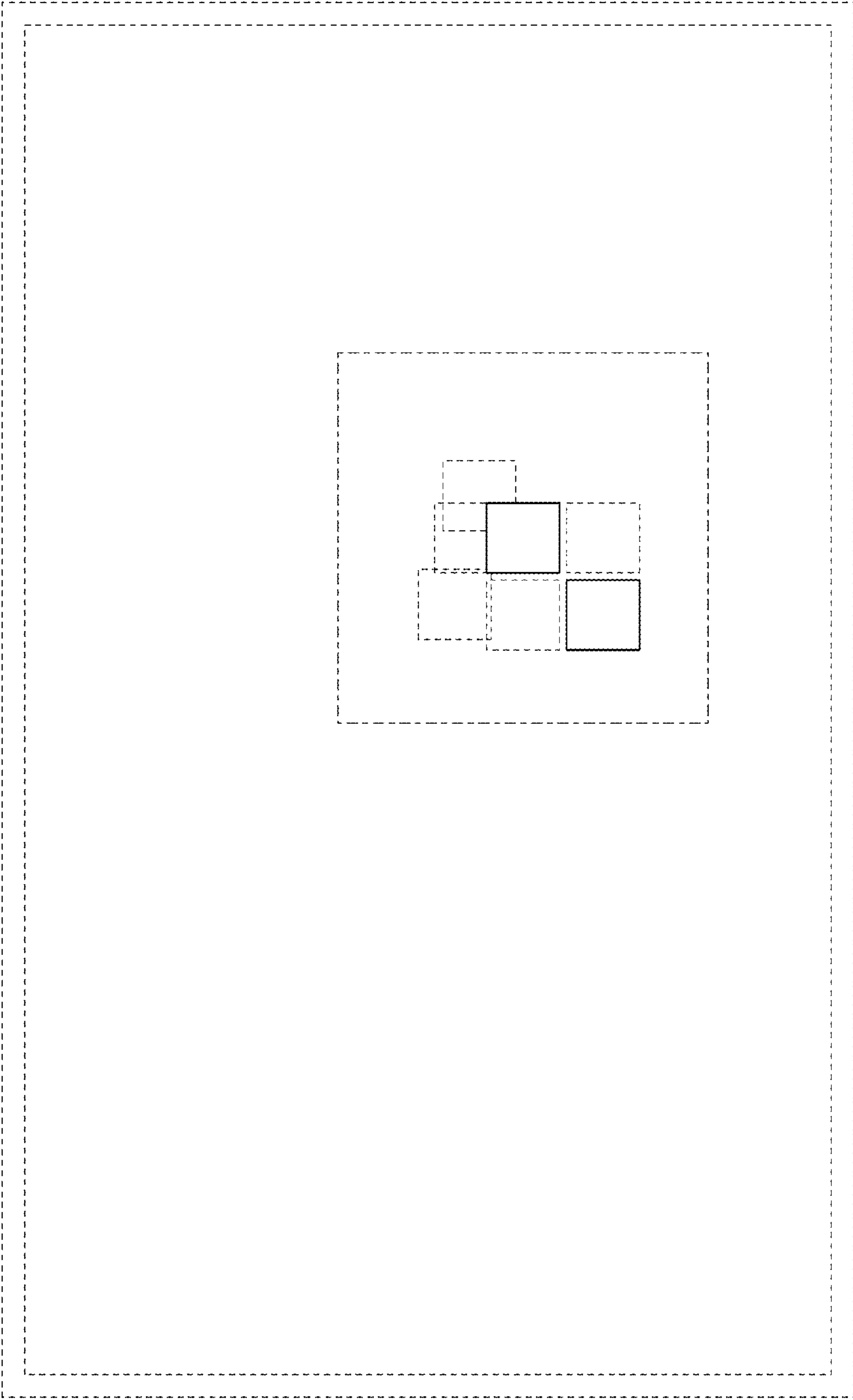

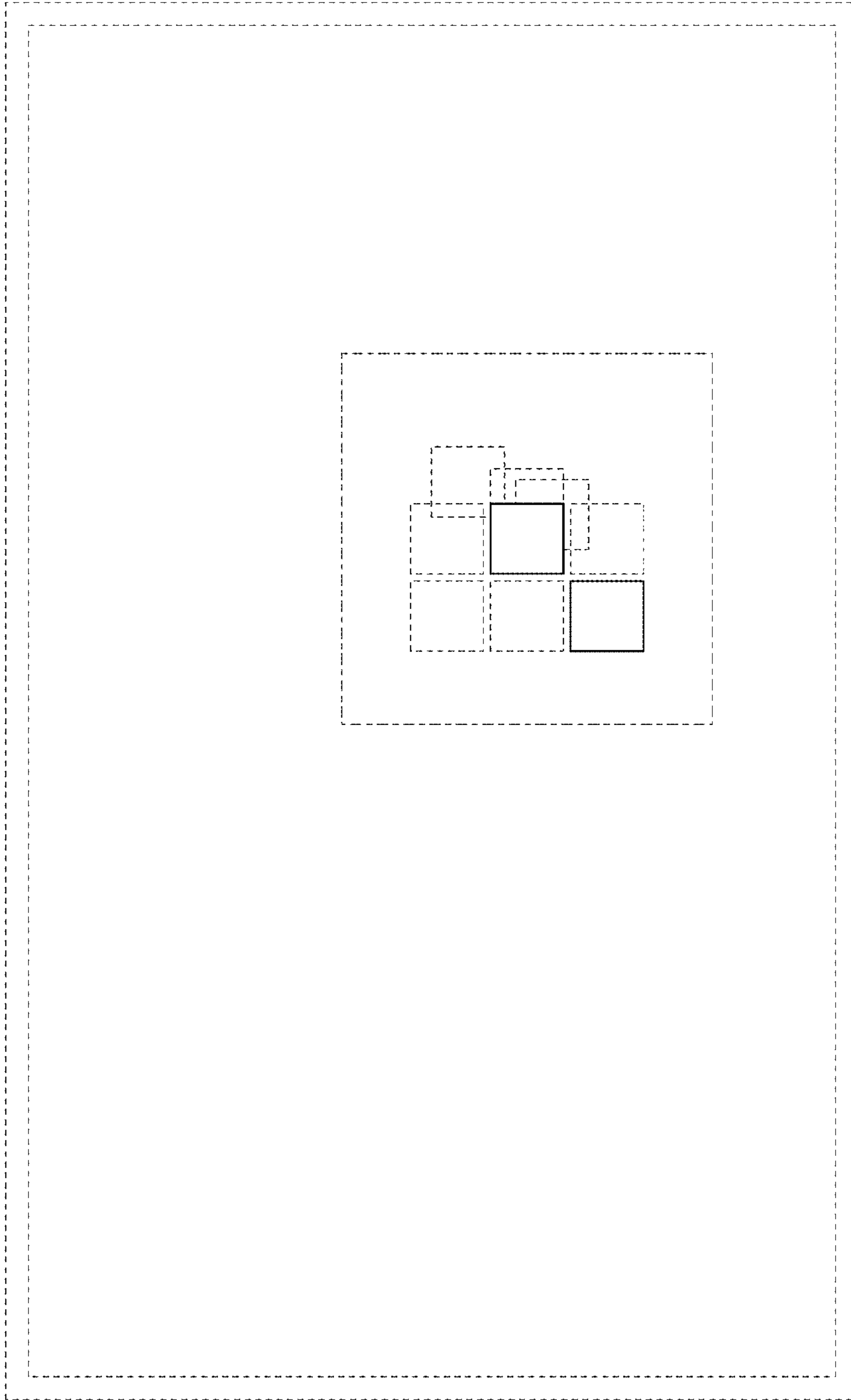

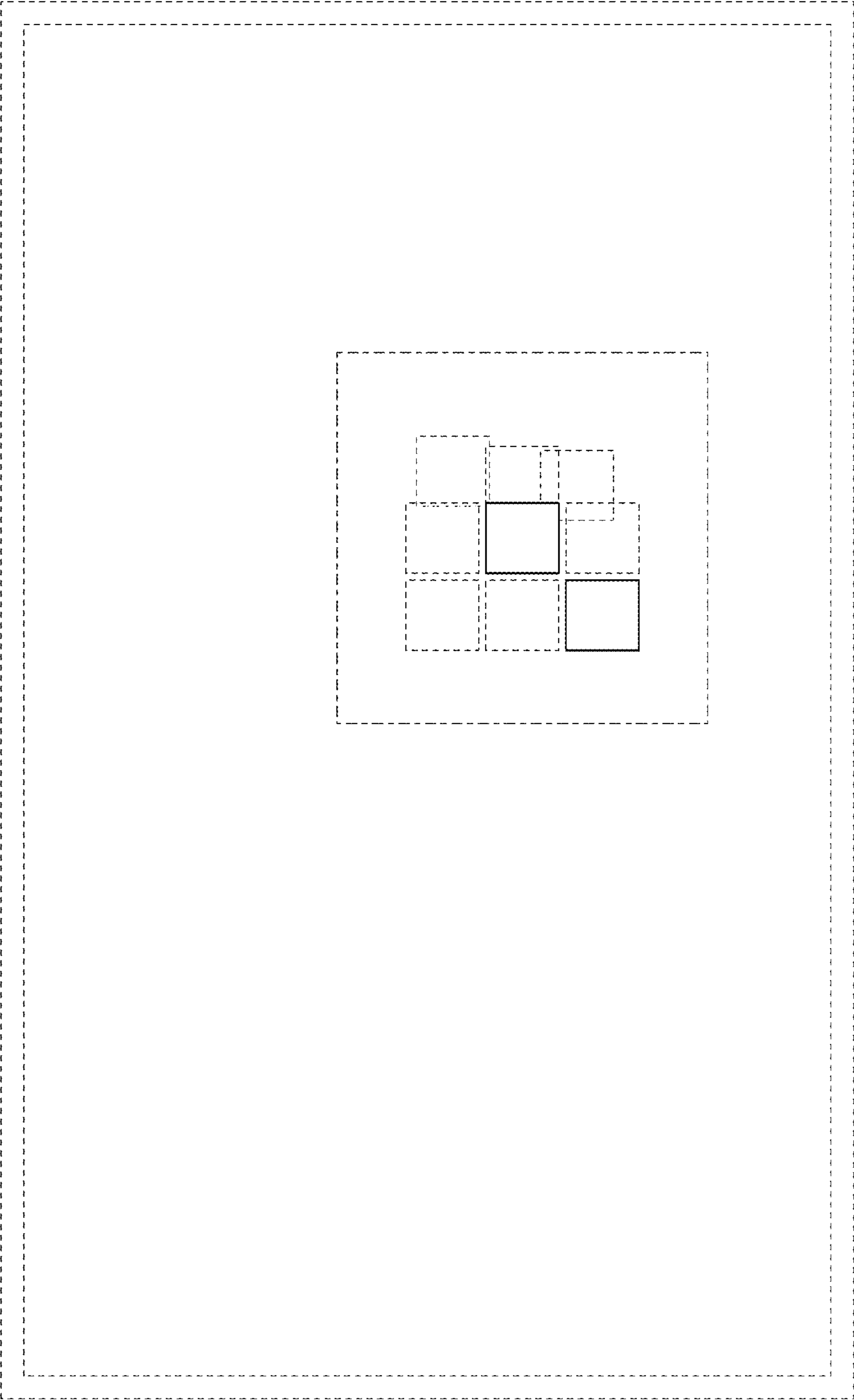

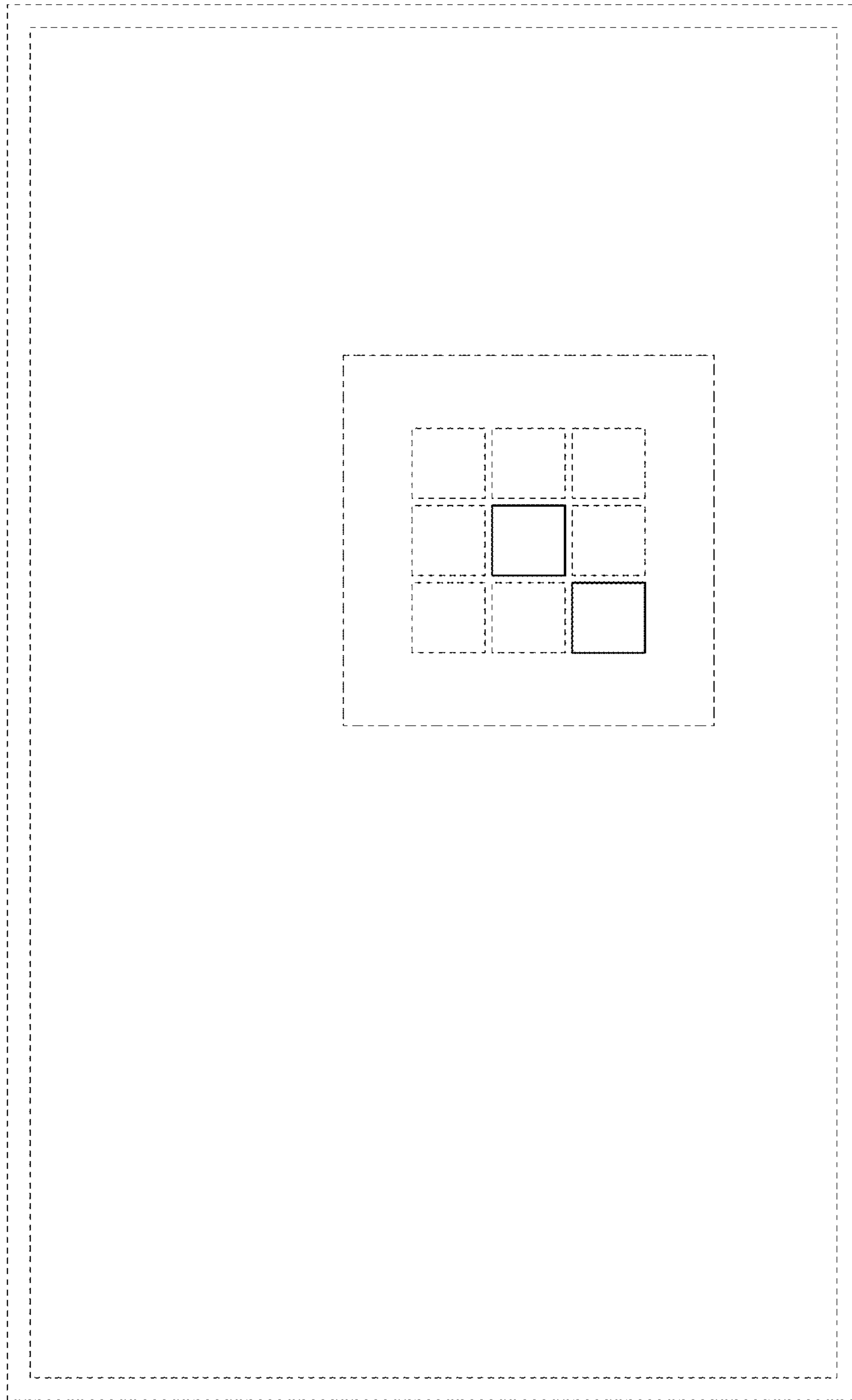
