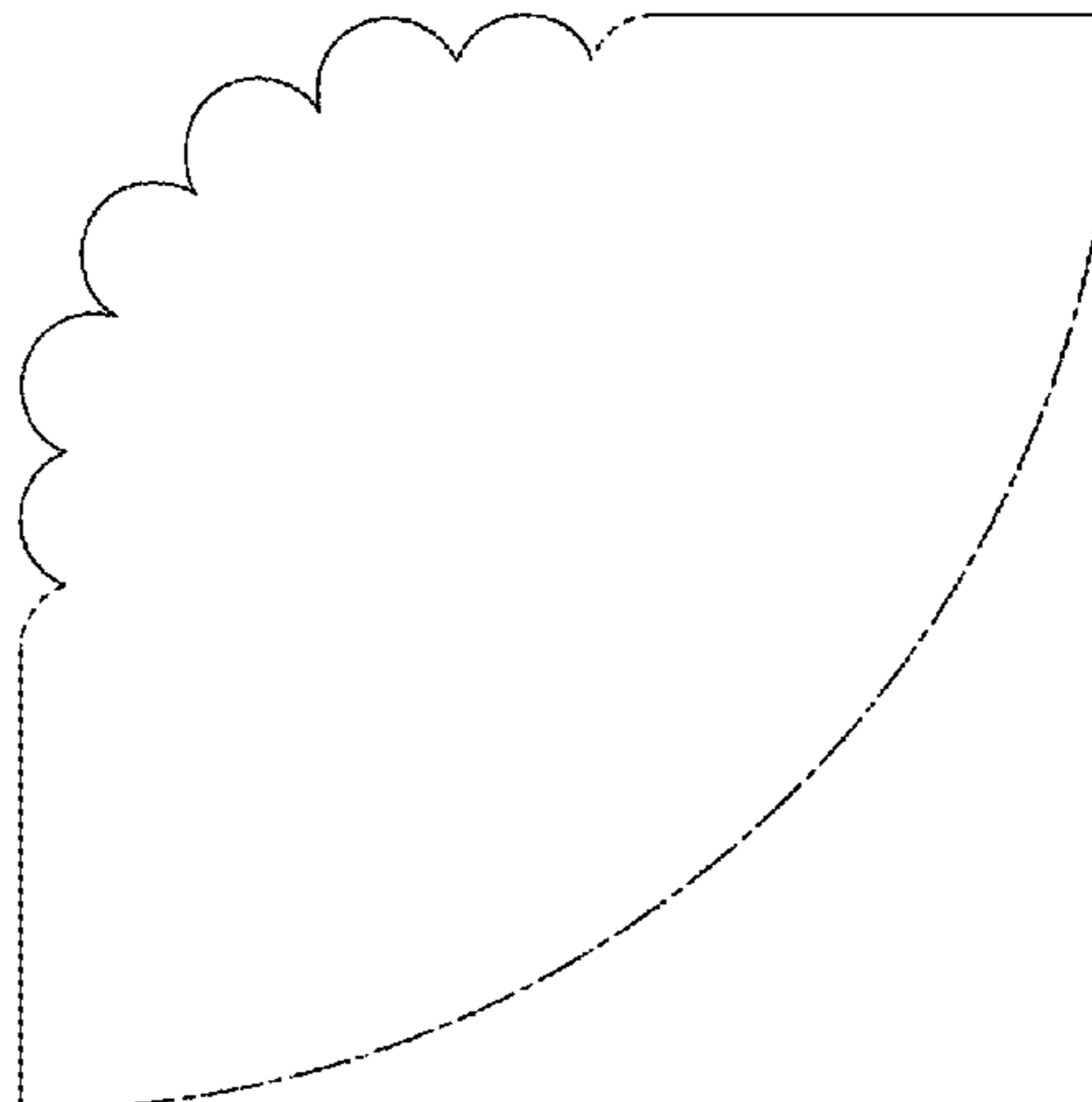
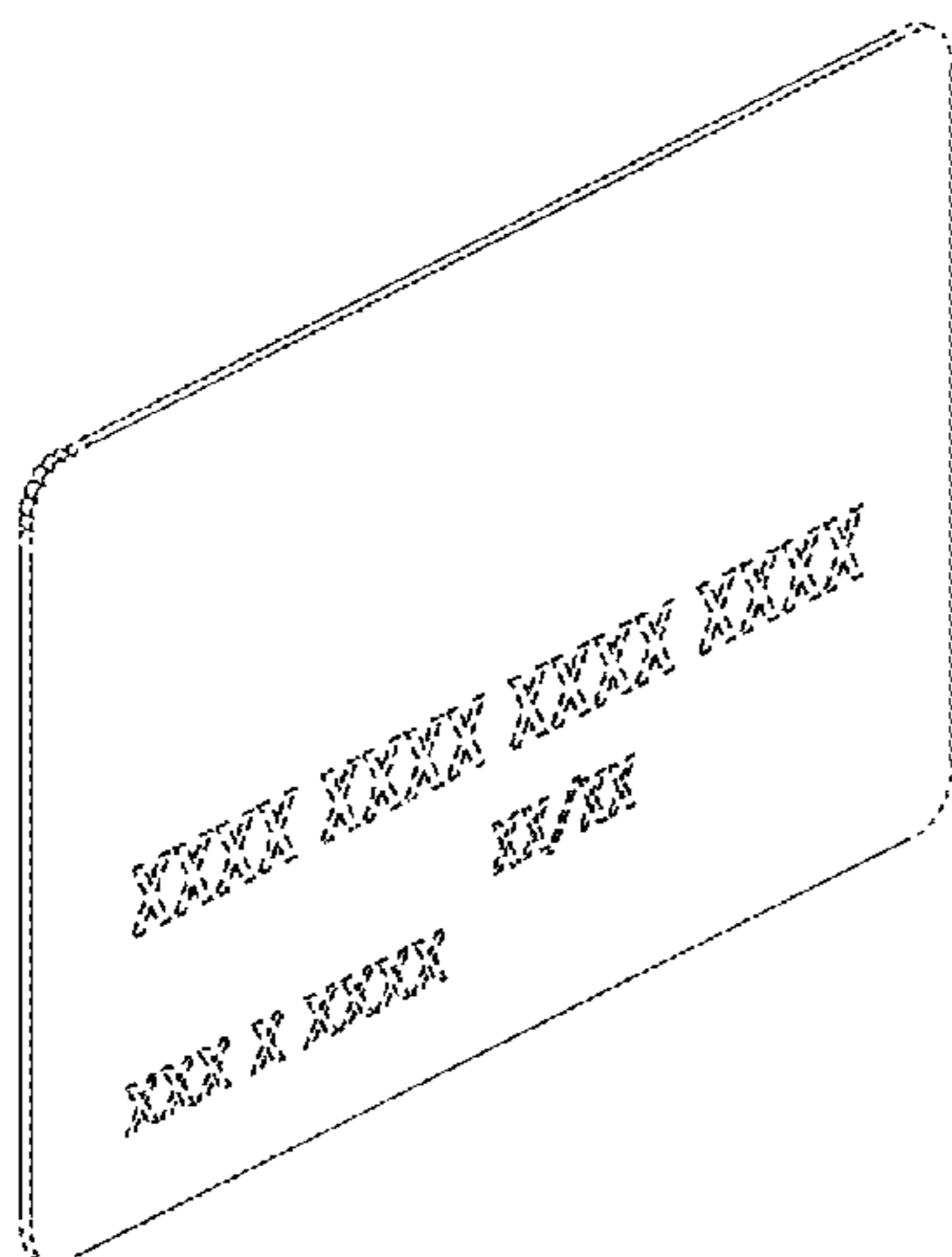

DESCRIPTION

FIG. 1 is a perspective view of the financial card with edge indicators, on which the claimed indicators are located at the left corner between the top and left side of the financial card; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a top thereof; FIG. 5 is a bottom view thereof; FIG. 6 is right side view thereof; FIG. 7 is a left side view thereof; and, FIG. 8 is an enlarged view of a portion of the front view of the financial card taken along line 8-8 of FIG. 2.

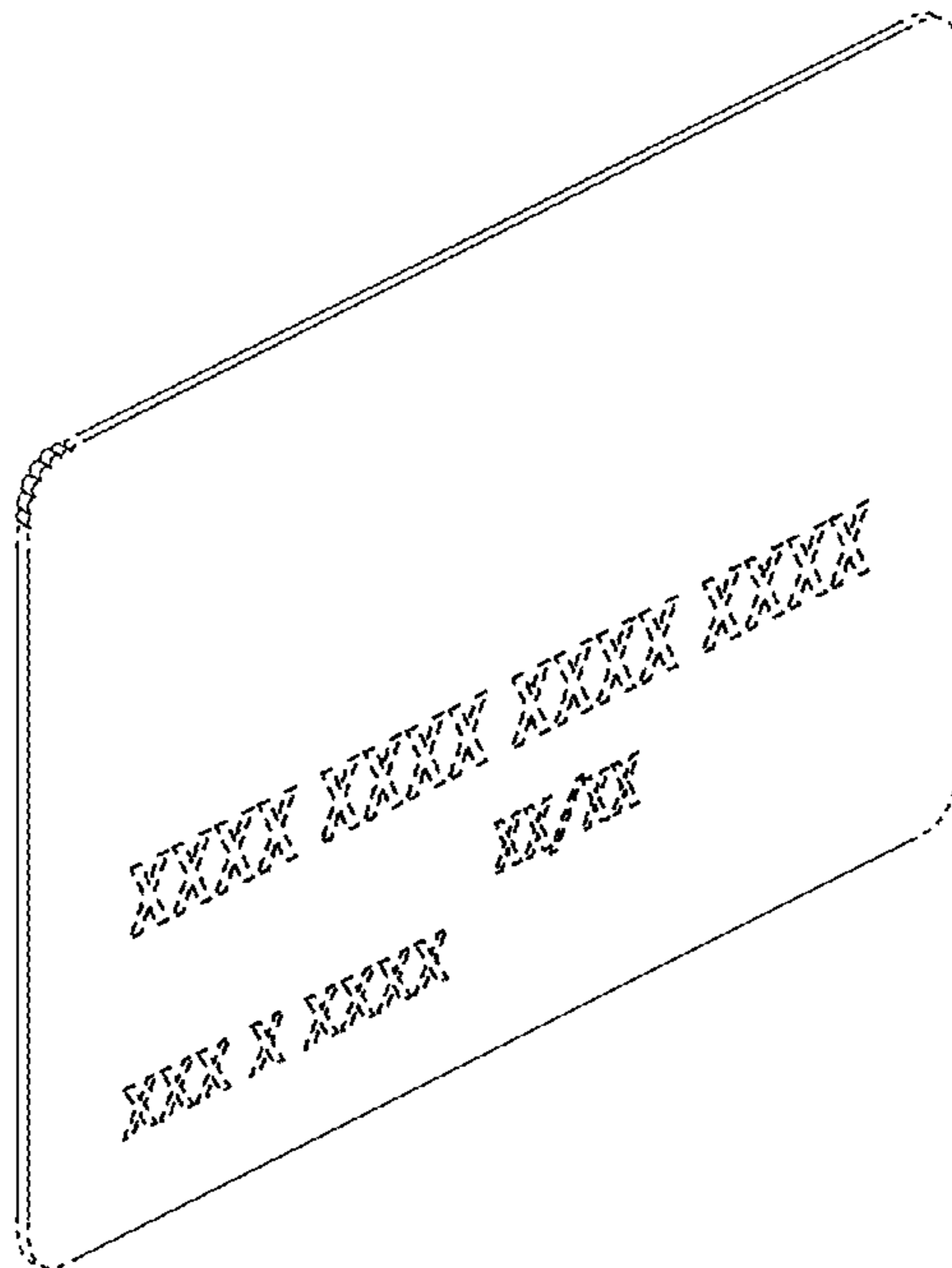

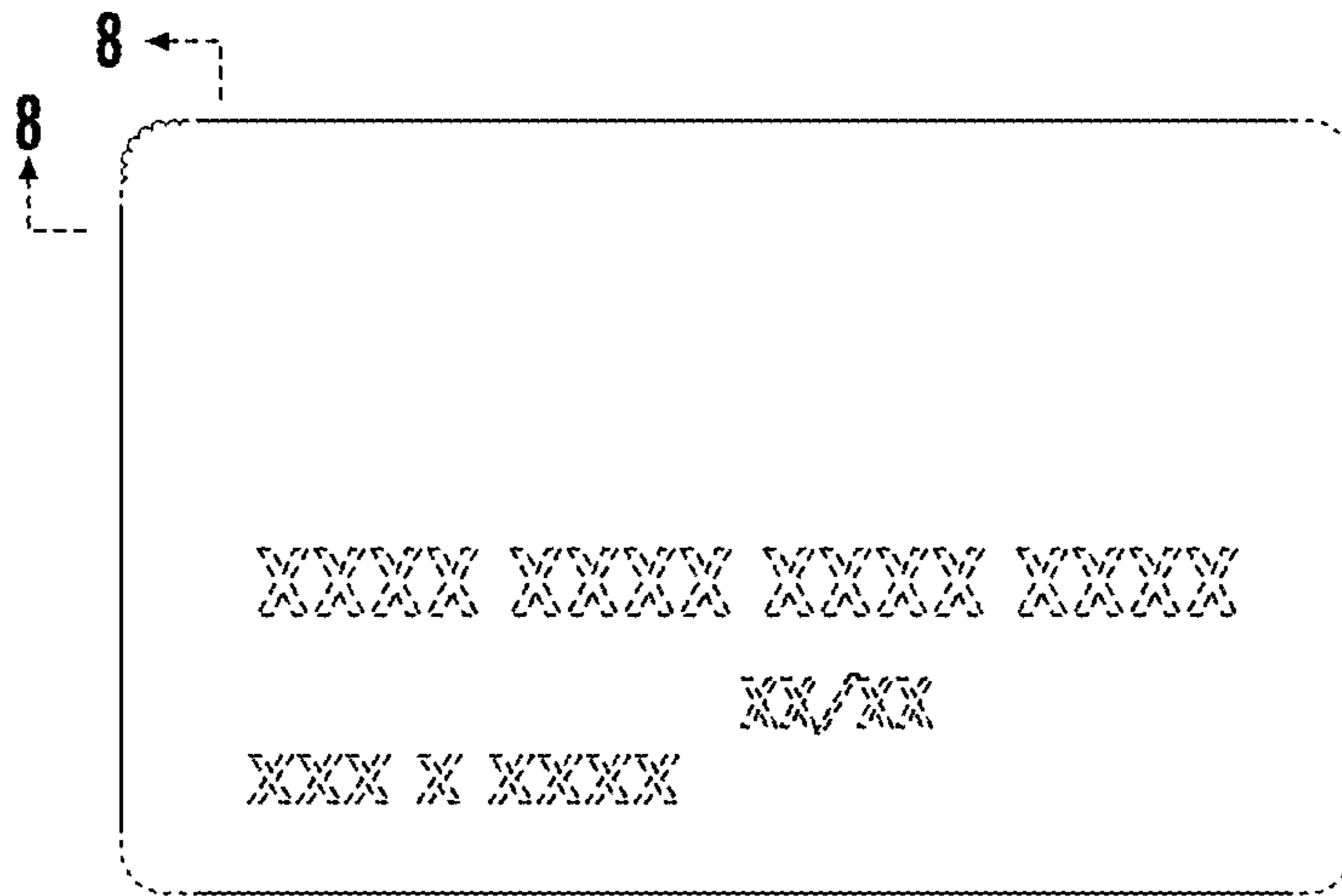

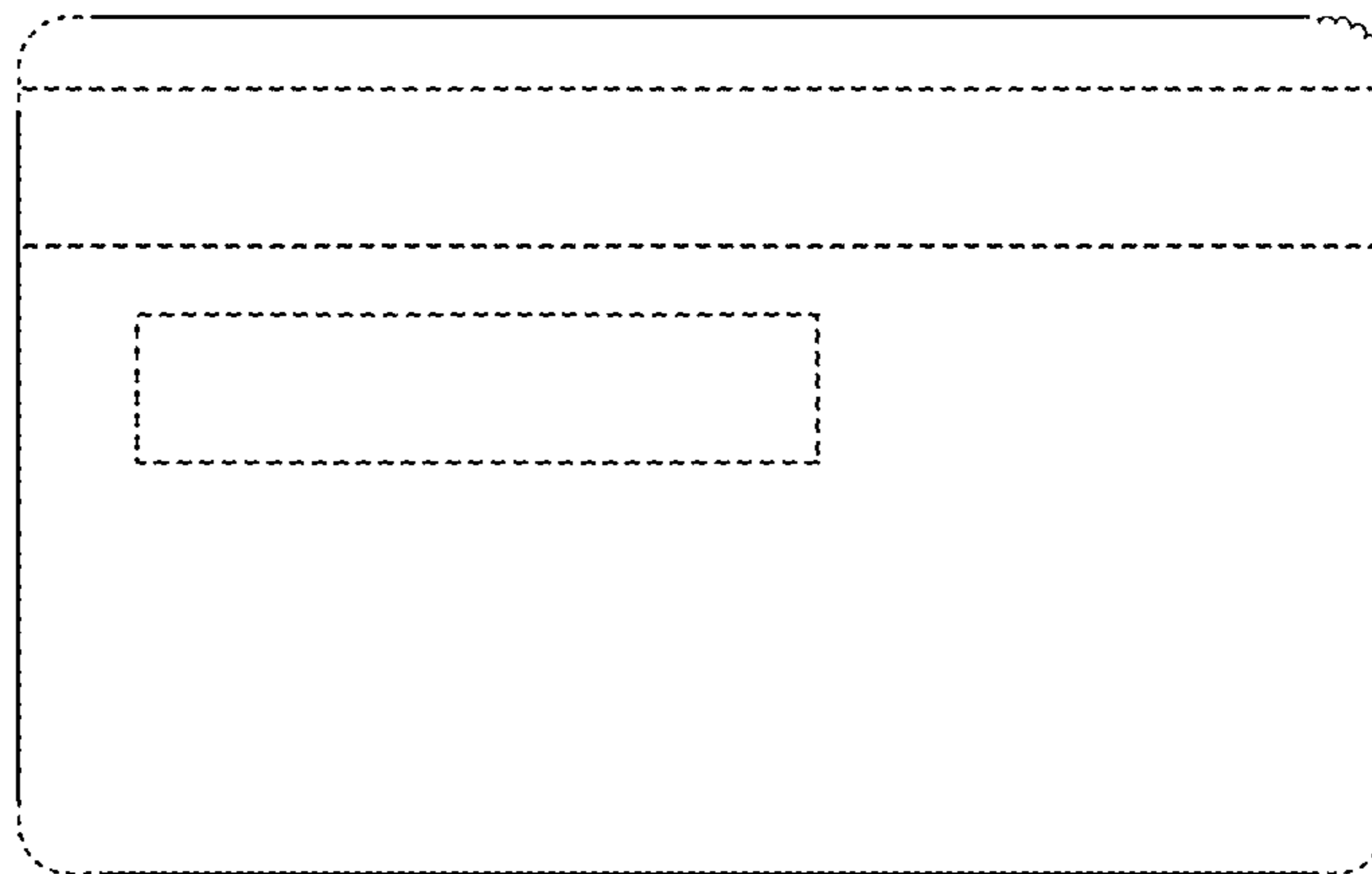

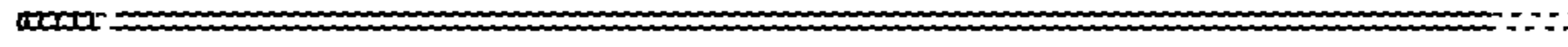

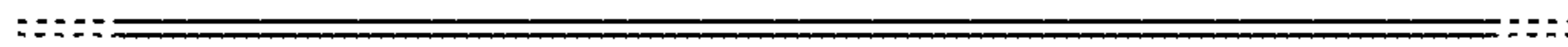

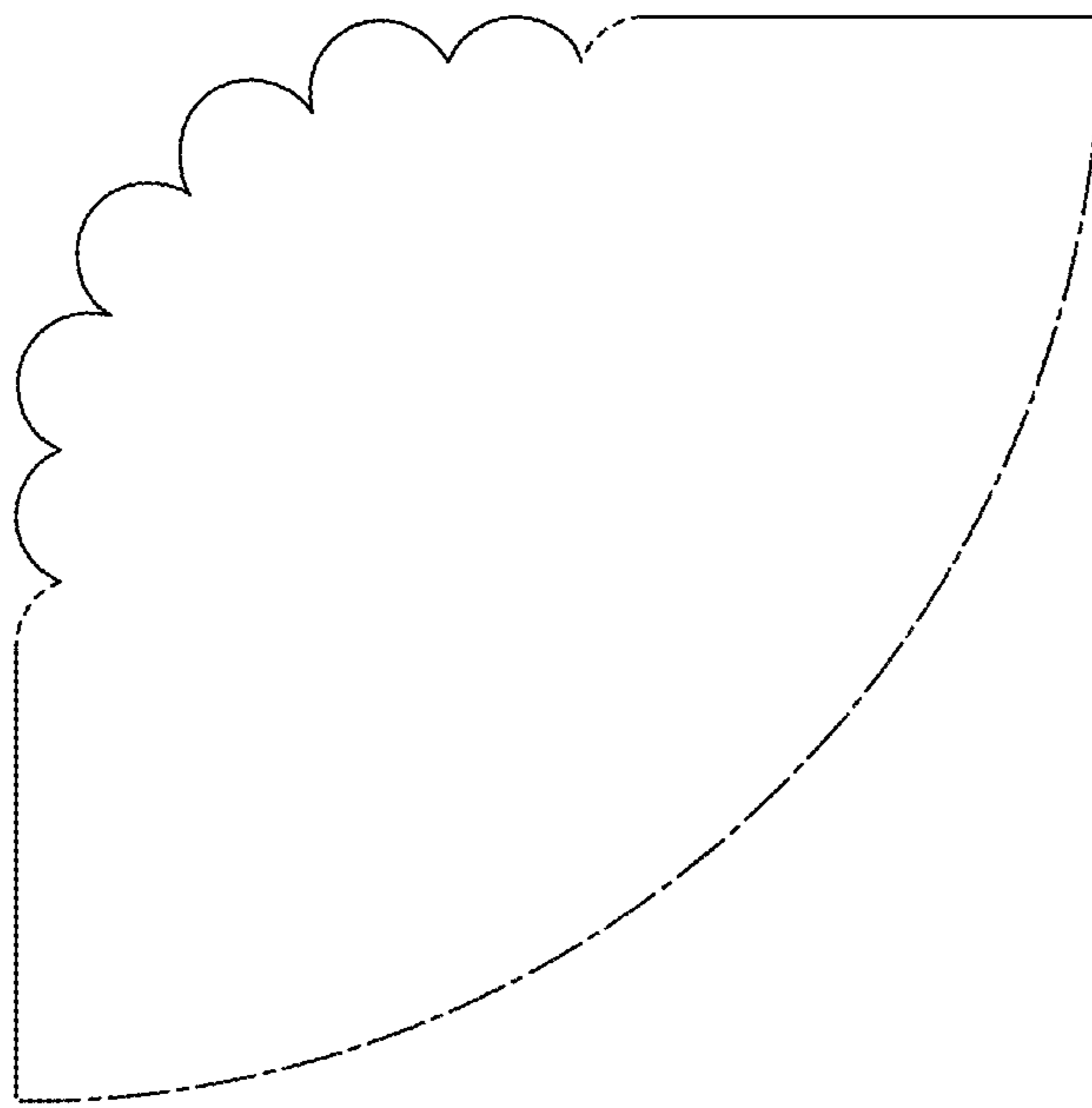
