FIG. 1 is a front perspective view of a first embodiment of a financial transaction card;

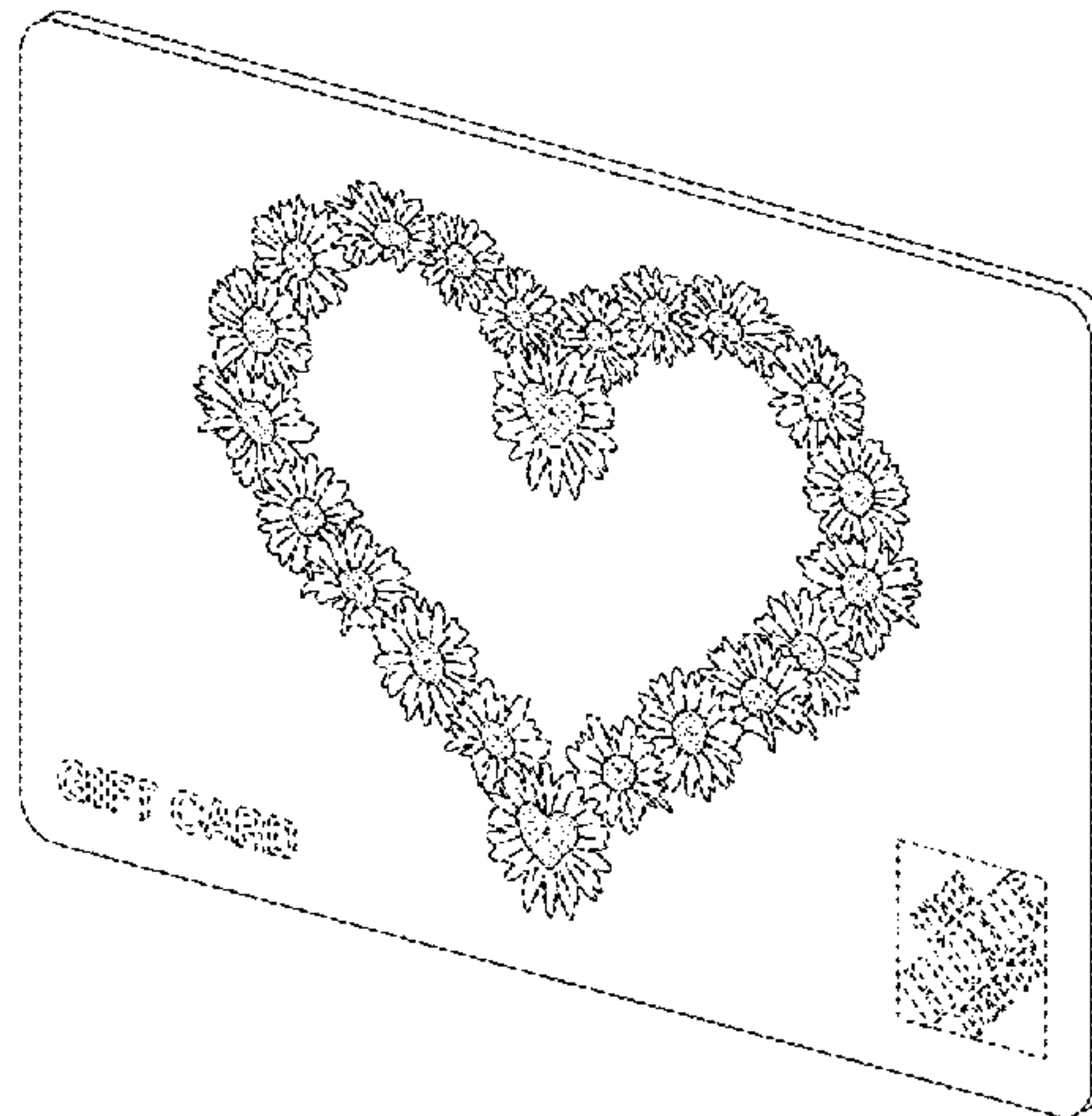
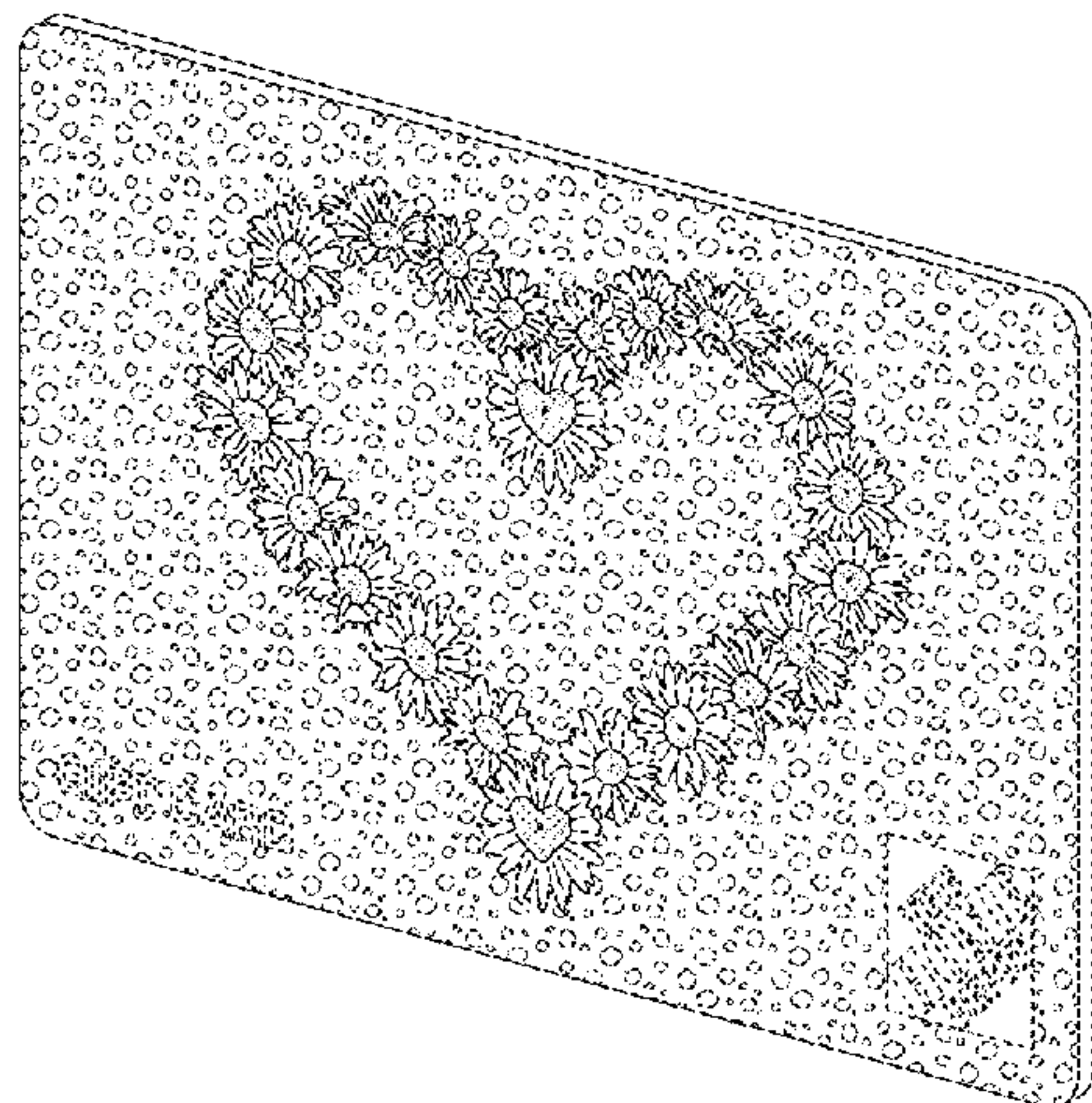
FIG. 2 is a front view of the financial transaction card shown in FIG. 1;

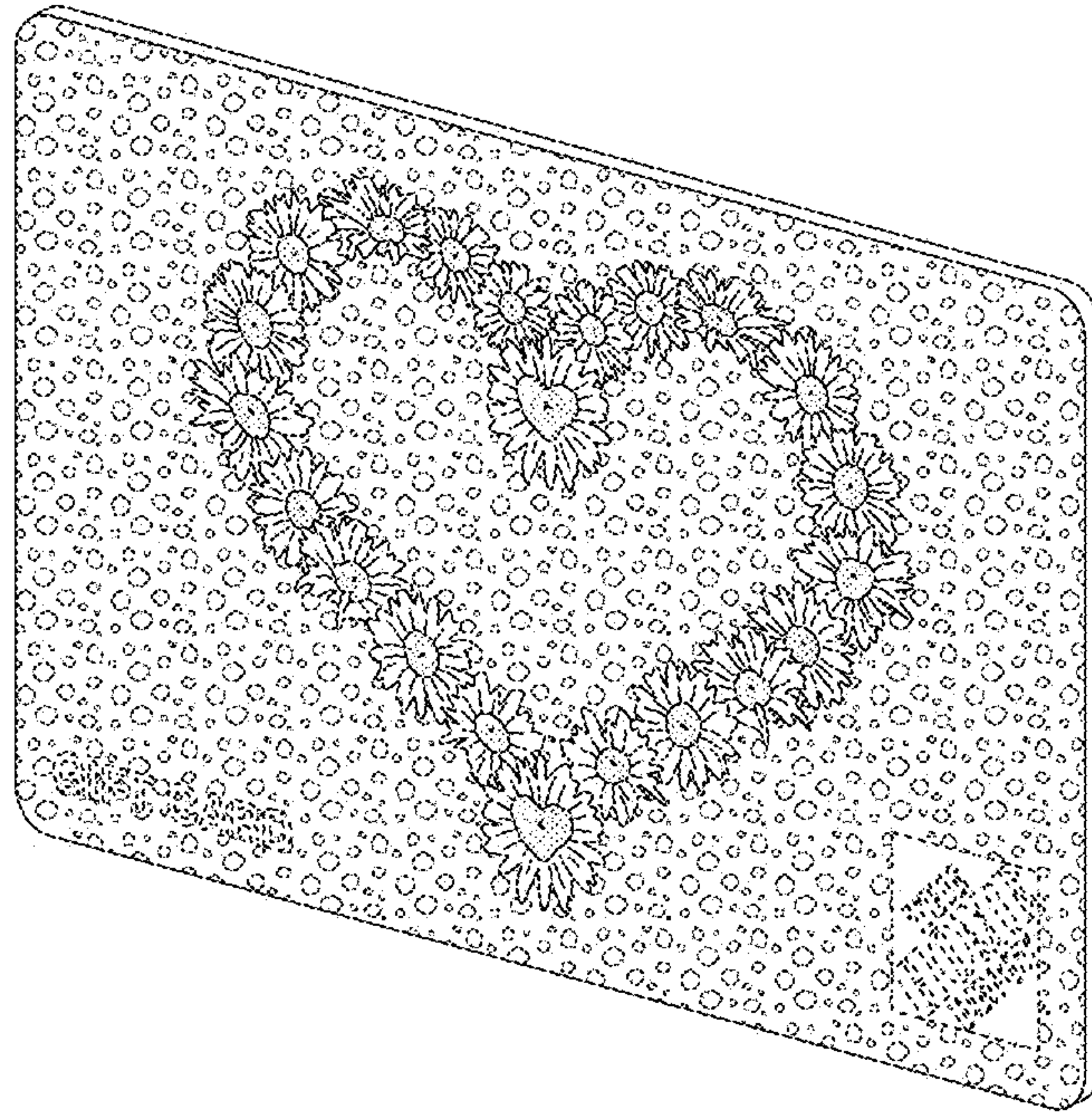

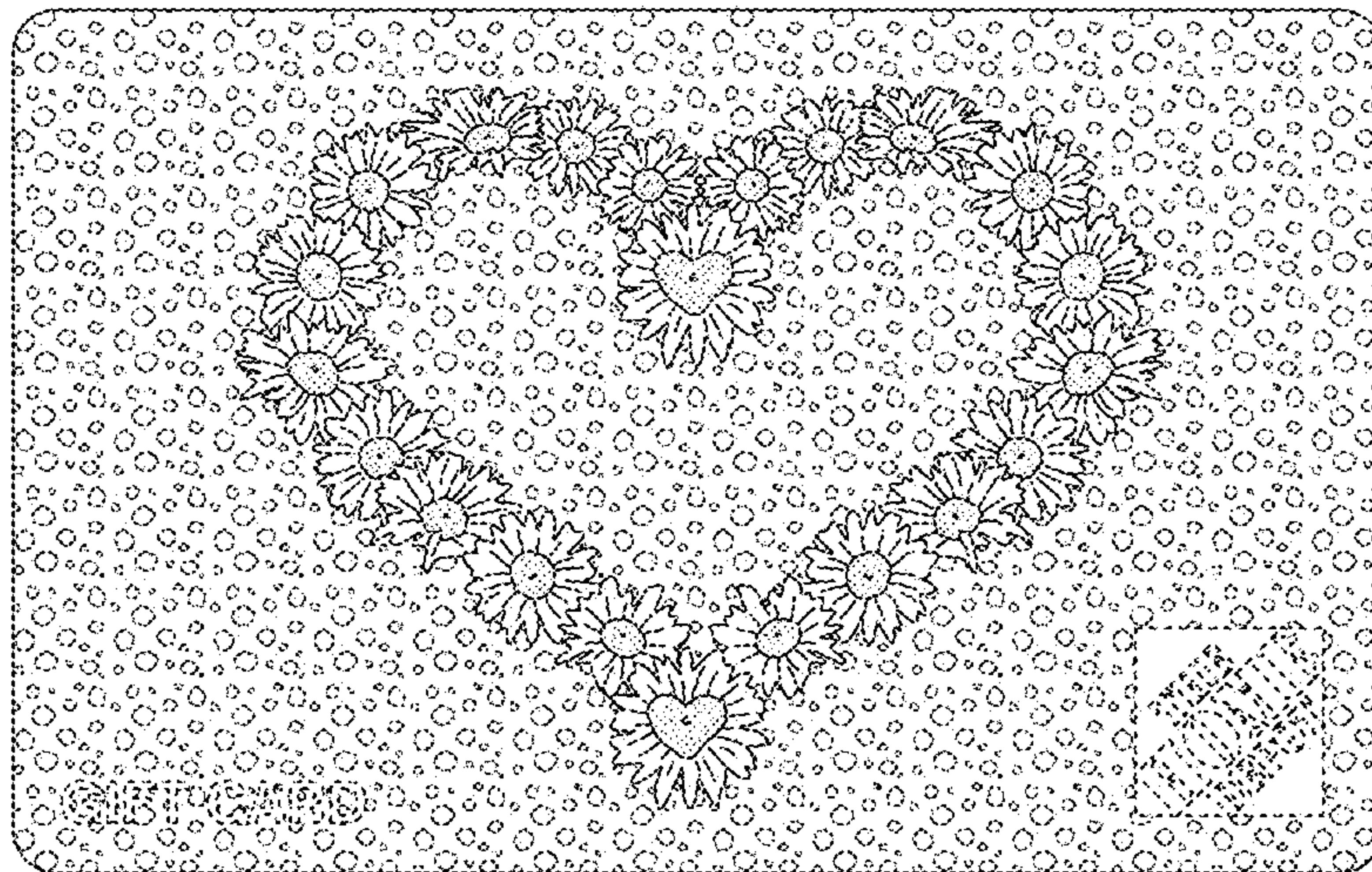

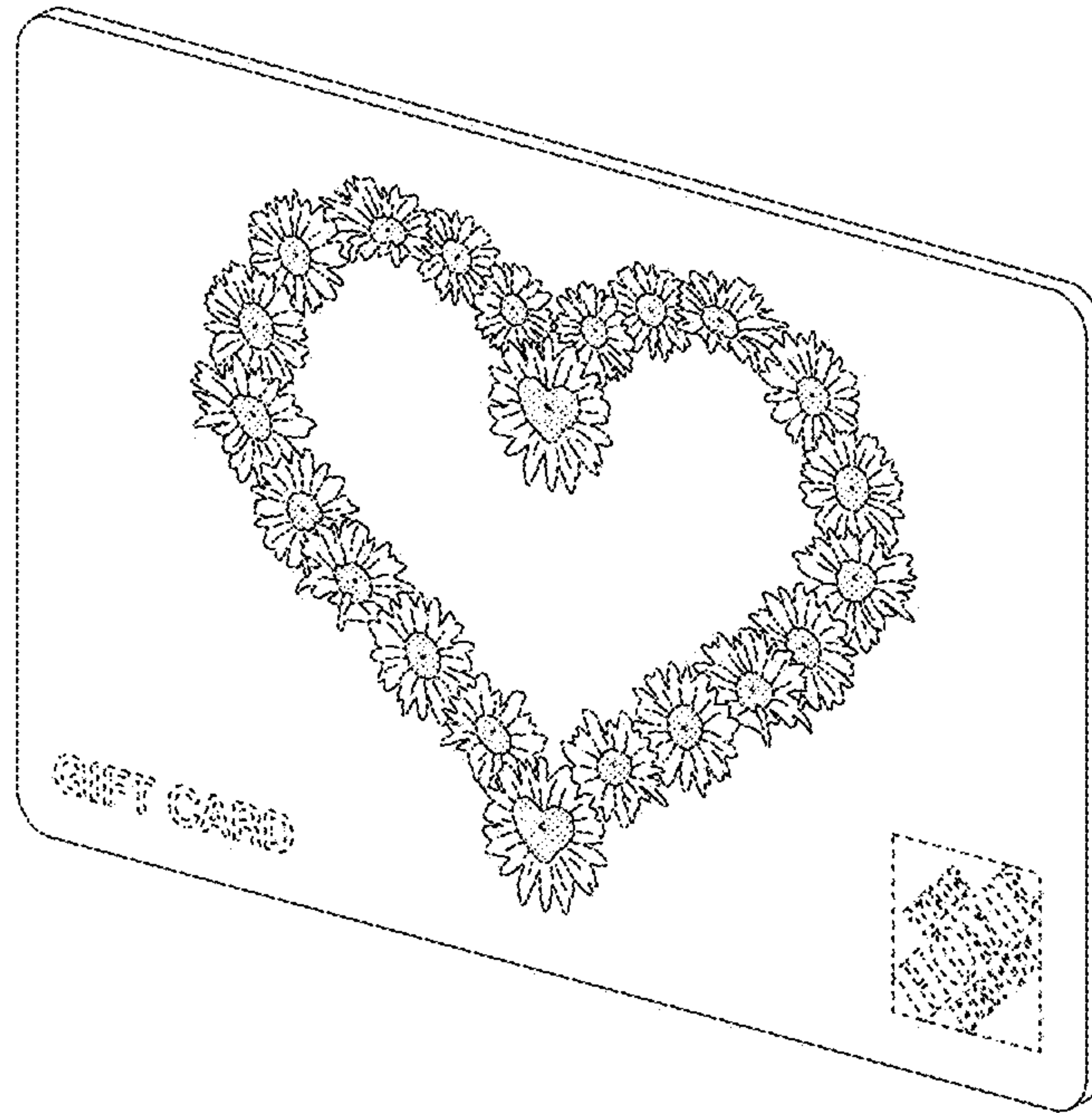

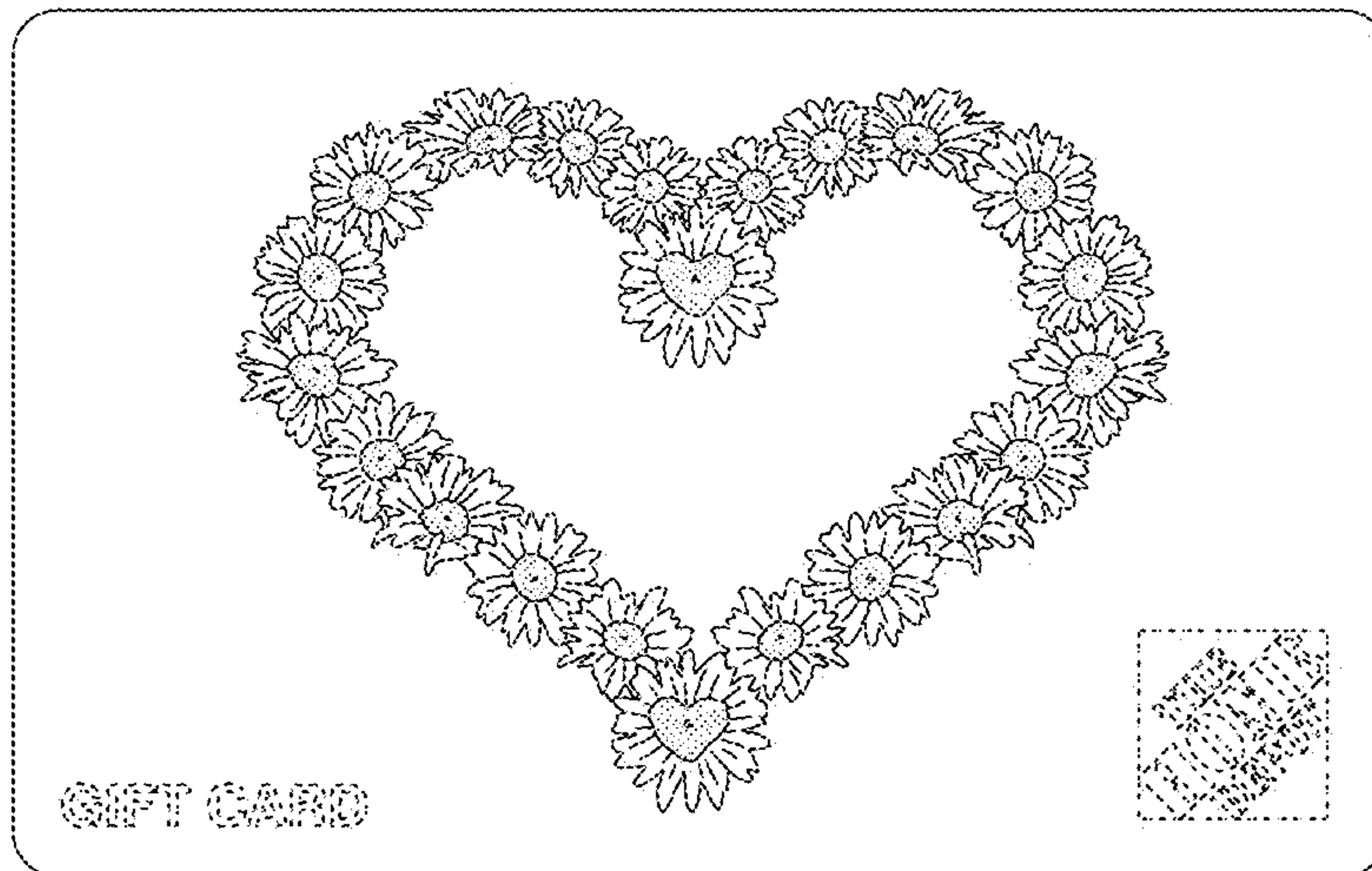
