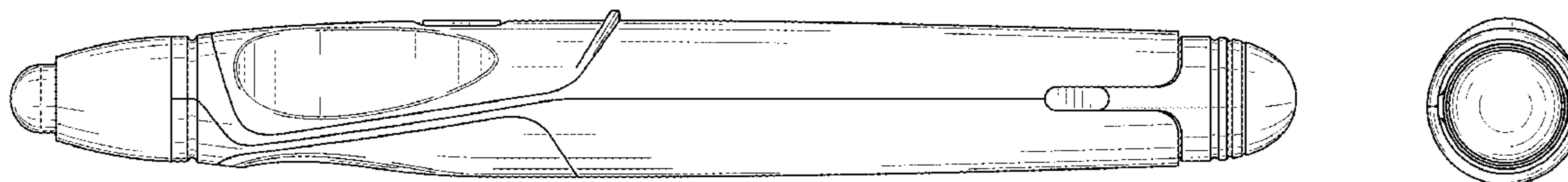
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the new design for a pen;
 FIG. 2 is a side view in elevation of the new design;
 FIG. 3 is a side view in elevation of the new design oriented at a position 90° from the view depicted in FIG. 2;
 FIG. 4 is a side view in elevation of the new design oriented at a position 90° from the view depicted in FIG. 3;
 FIG. 5 a side view in elevation of the new design oriented at a position 90° from the view depicted in FIG. 4;
 FIG. 6 is a top view of the pen; and,
 FIG. 7 is a bottom view of the pen.

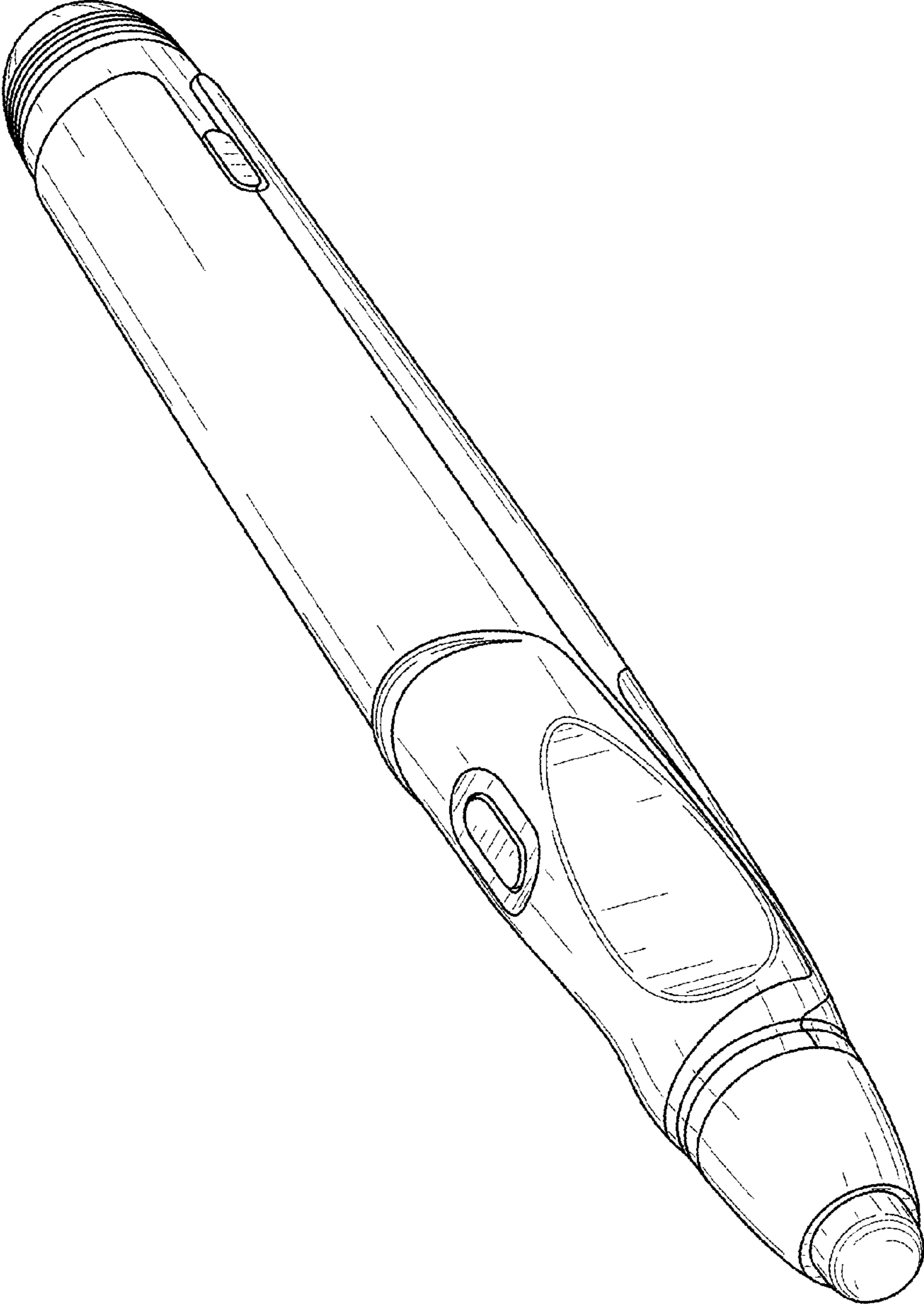

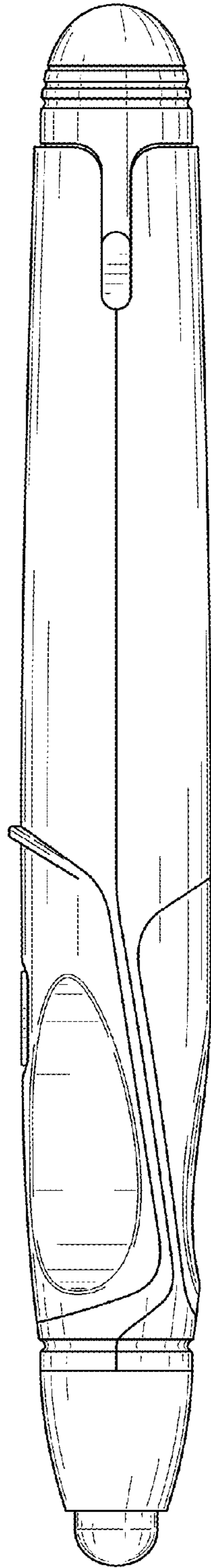

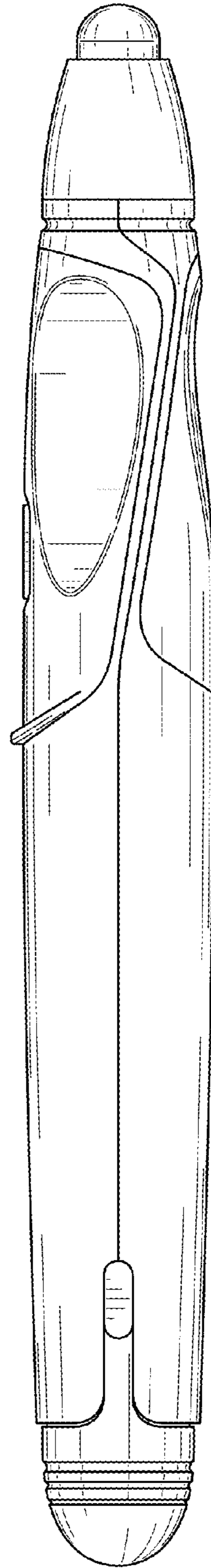

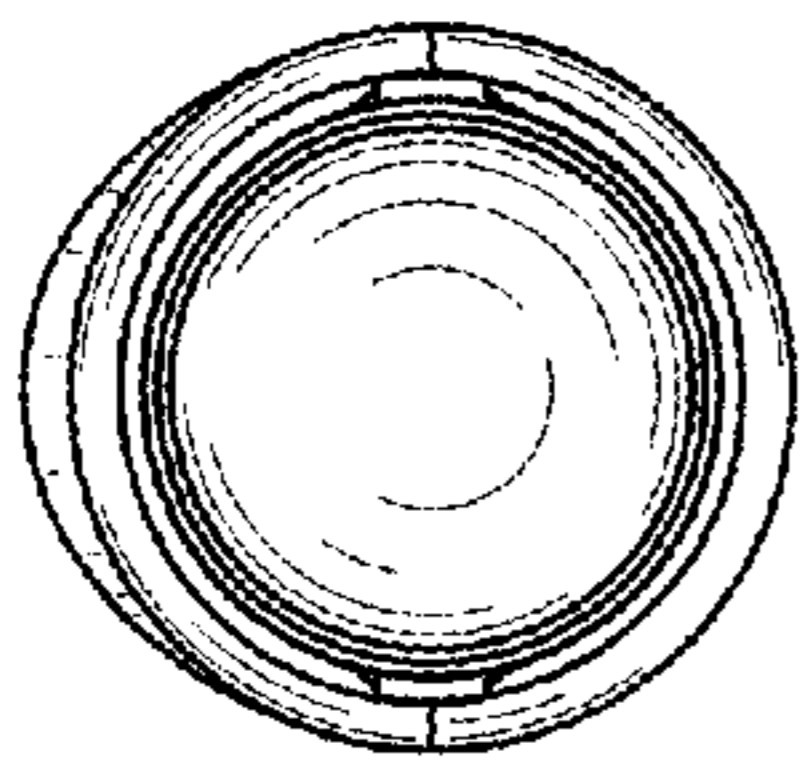

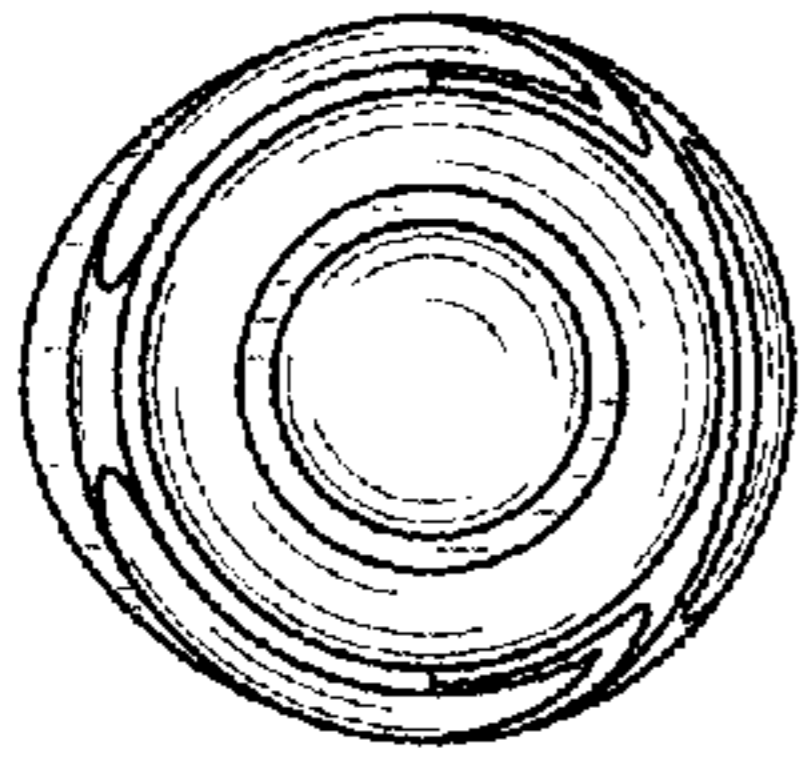

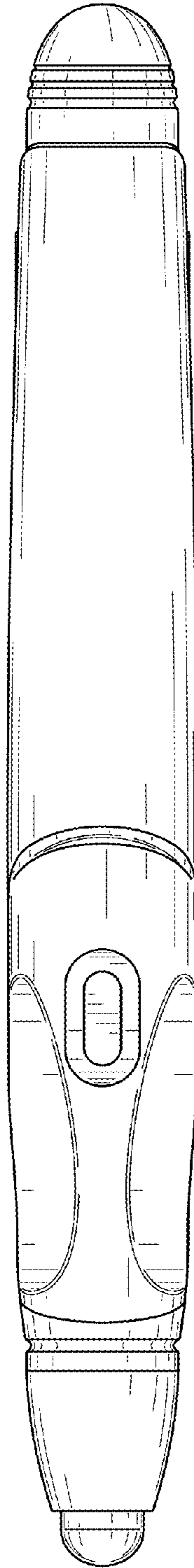

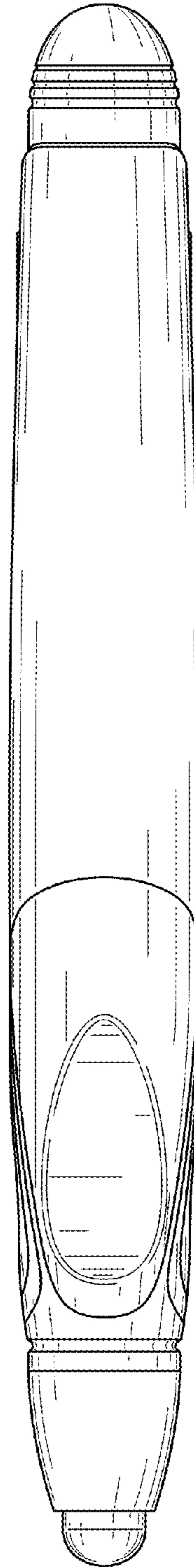
