The ornamental design for an outdoor lighting fixture, as shown and described.

DESCRIPTION

FIG. 1 is a front, left side, and top, perspective view of an outdoor lighting fixture as seen from above according to my new design.

FIG. 2 is a top plan view thereof.

FIG. 3 is a left side elevational view thereof.

FIG. 4 is a right side elevational view thereof.

FIG. 5 is an enlarged front elevational view thereof.

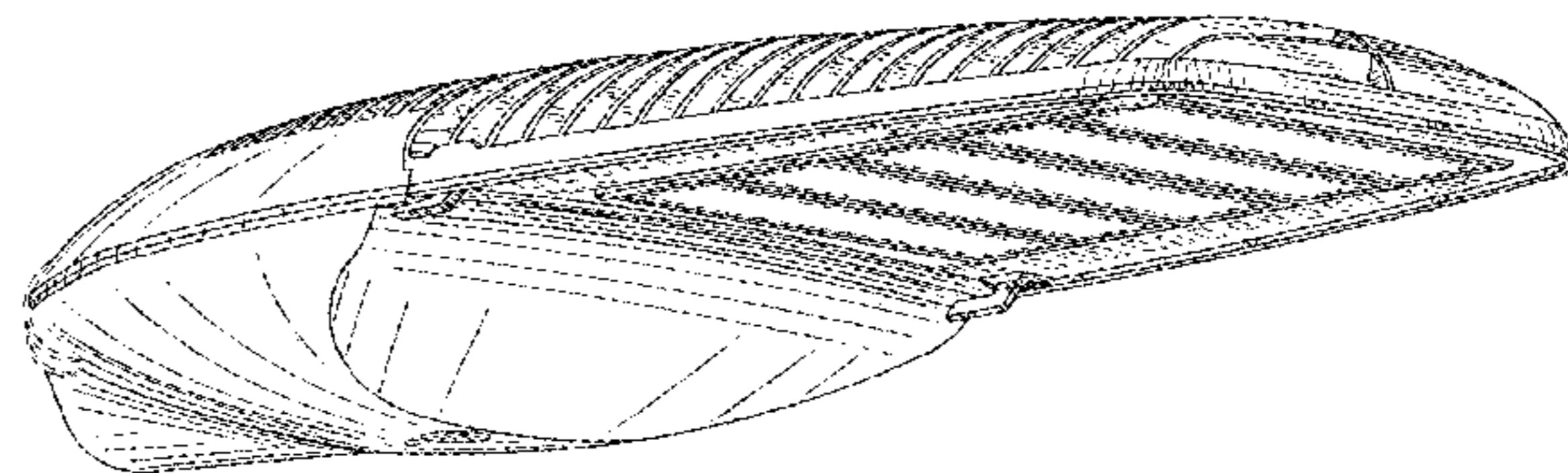
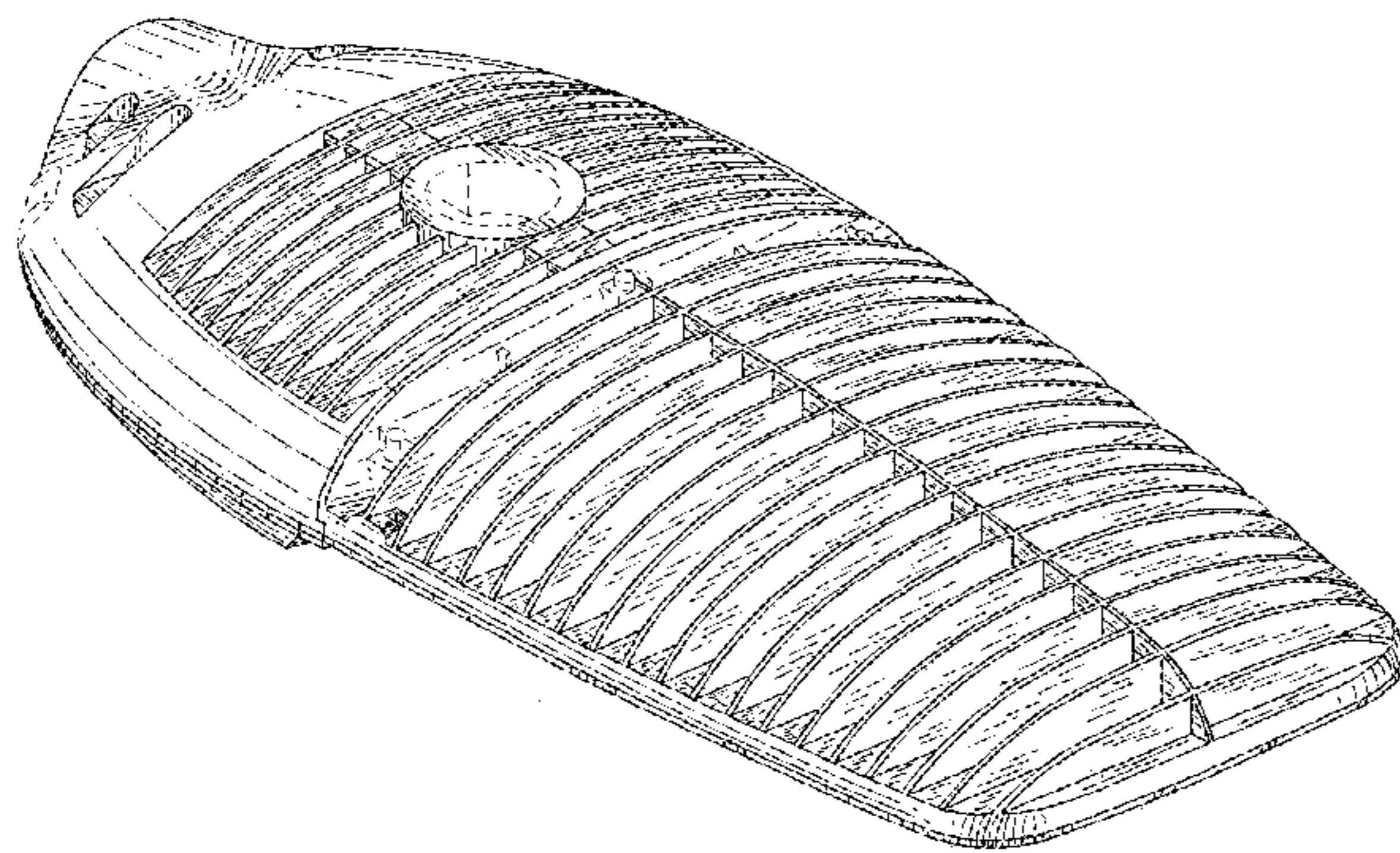
FIG. 6 is an enlarged rear elevational view thereof.

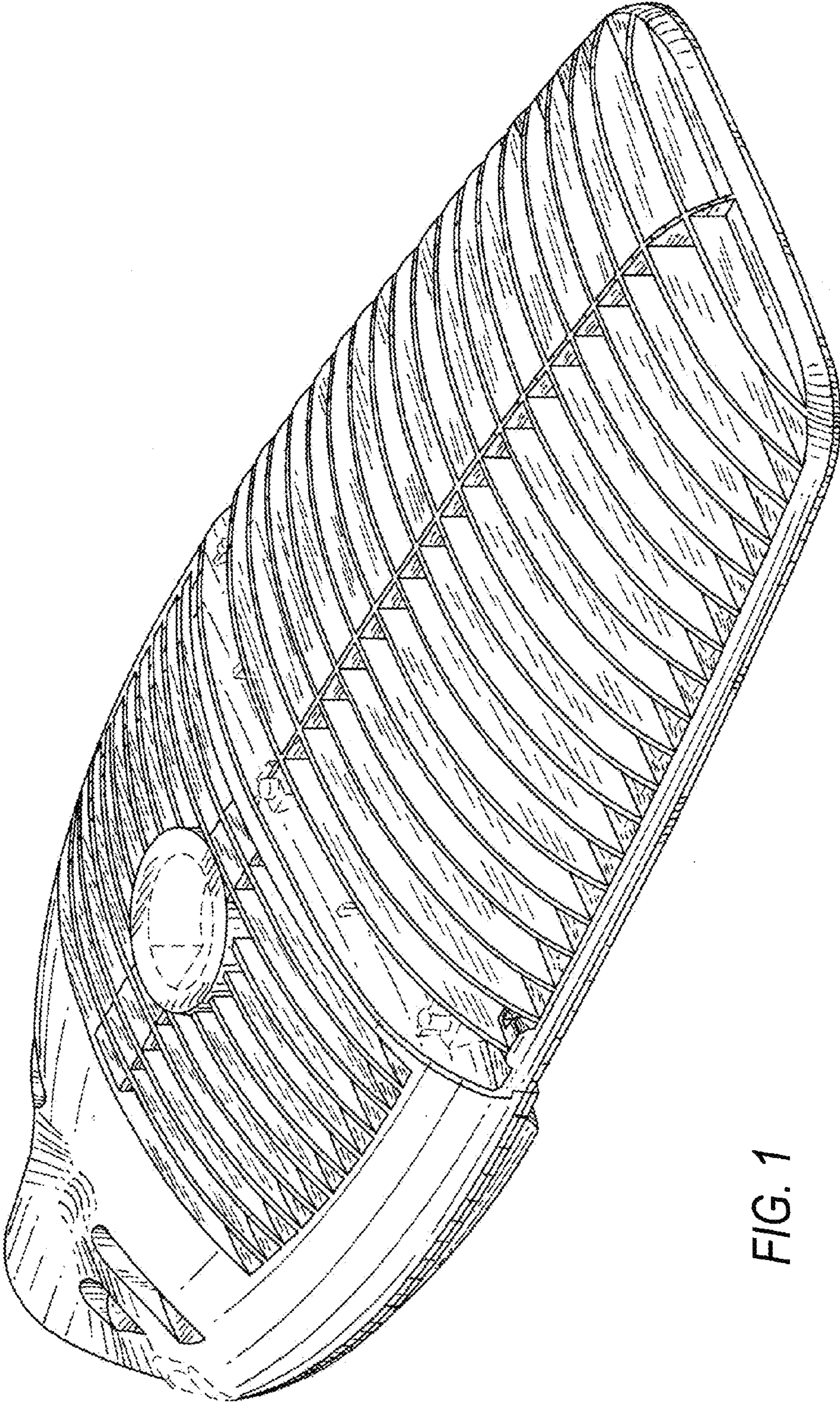

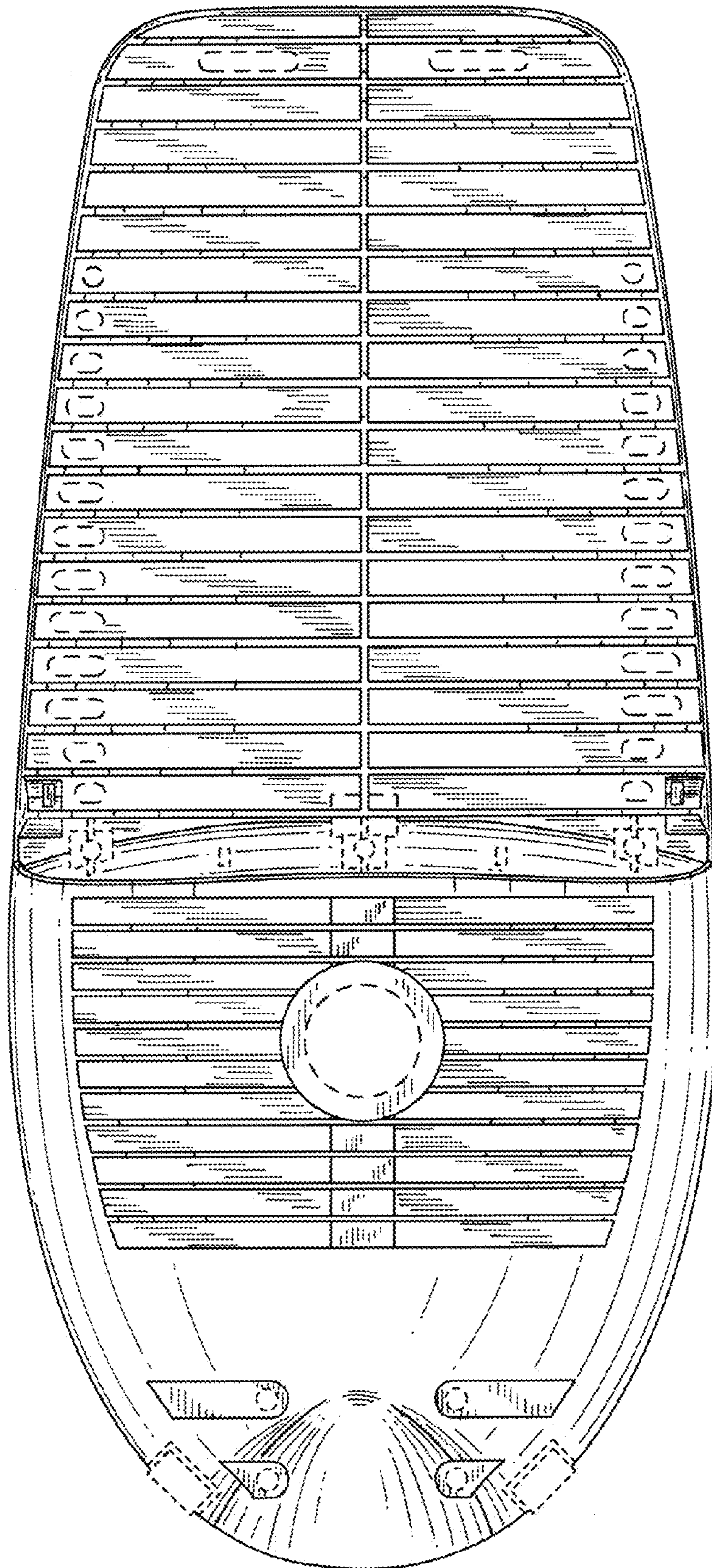

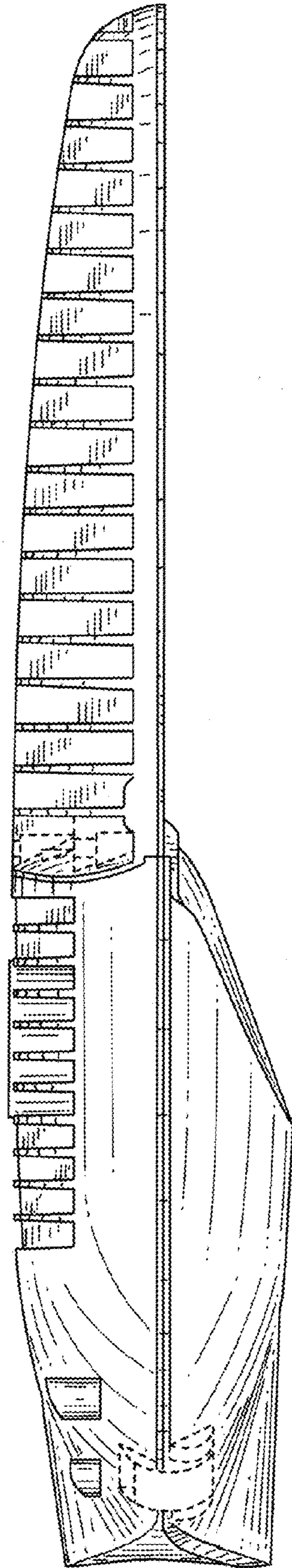

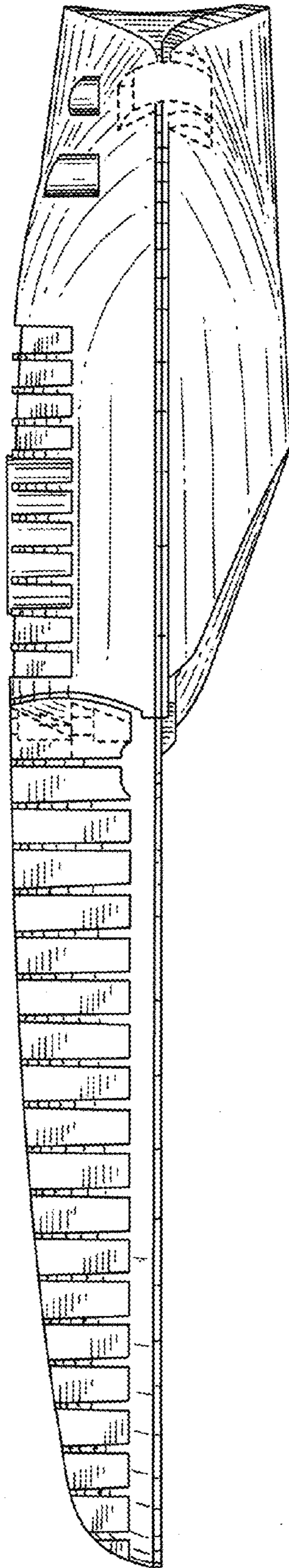

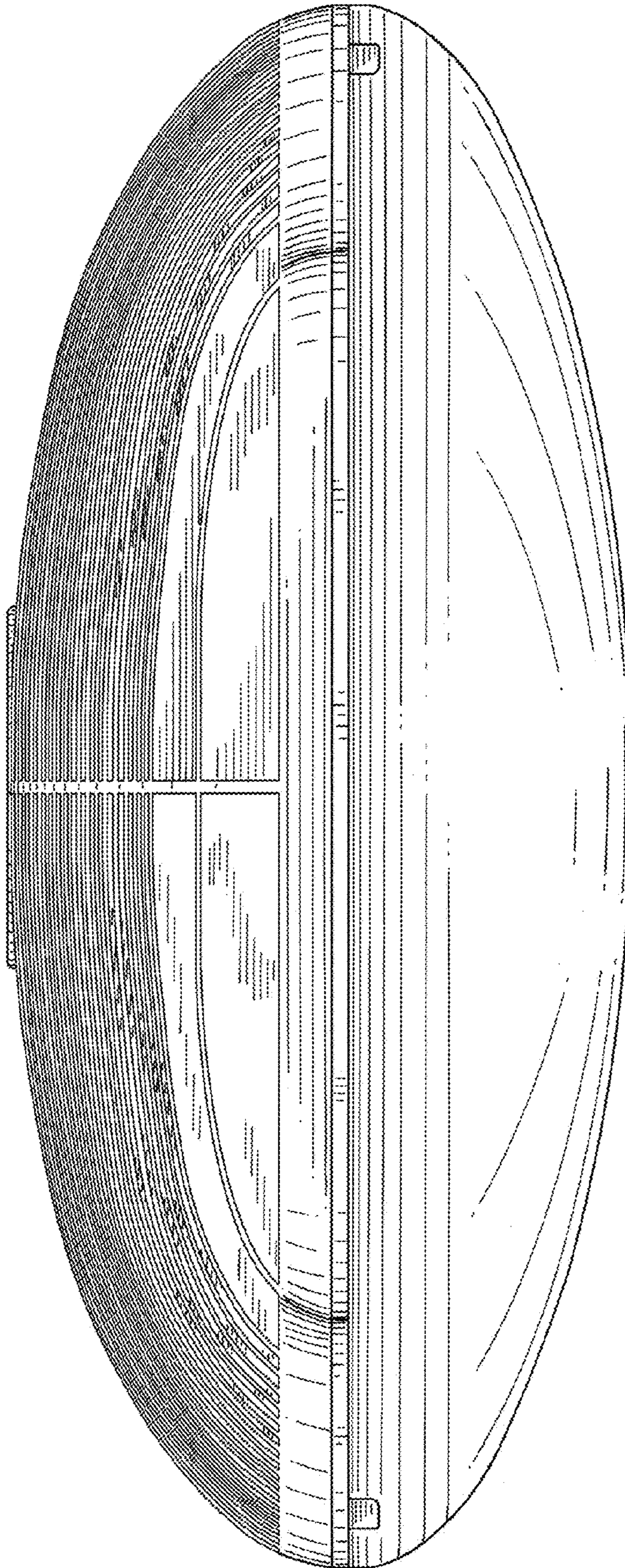

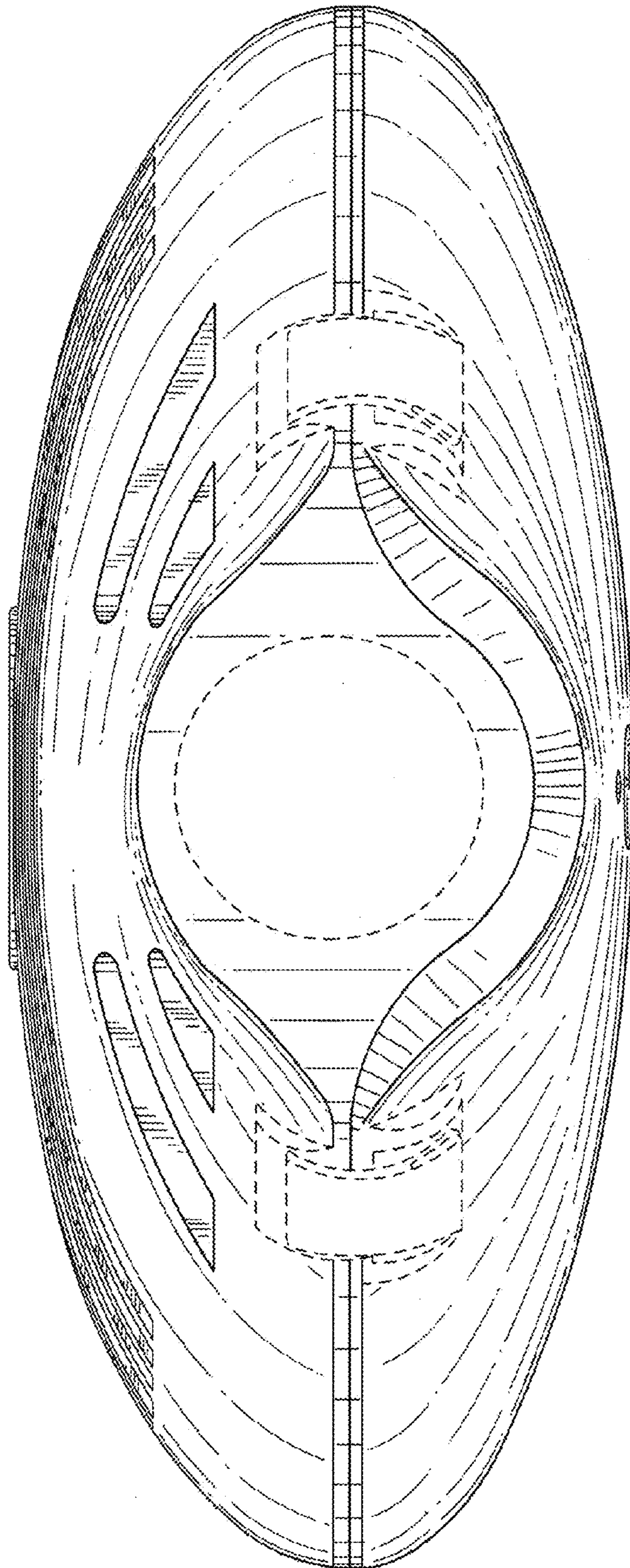

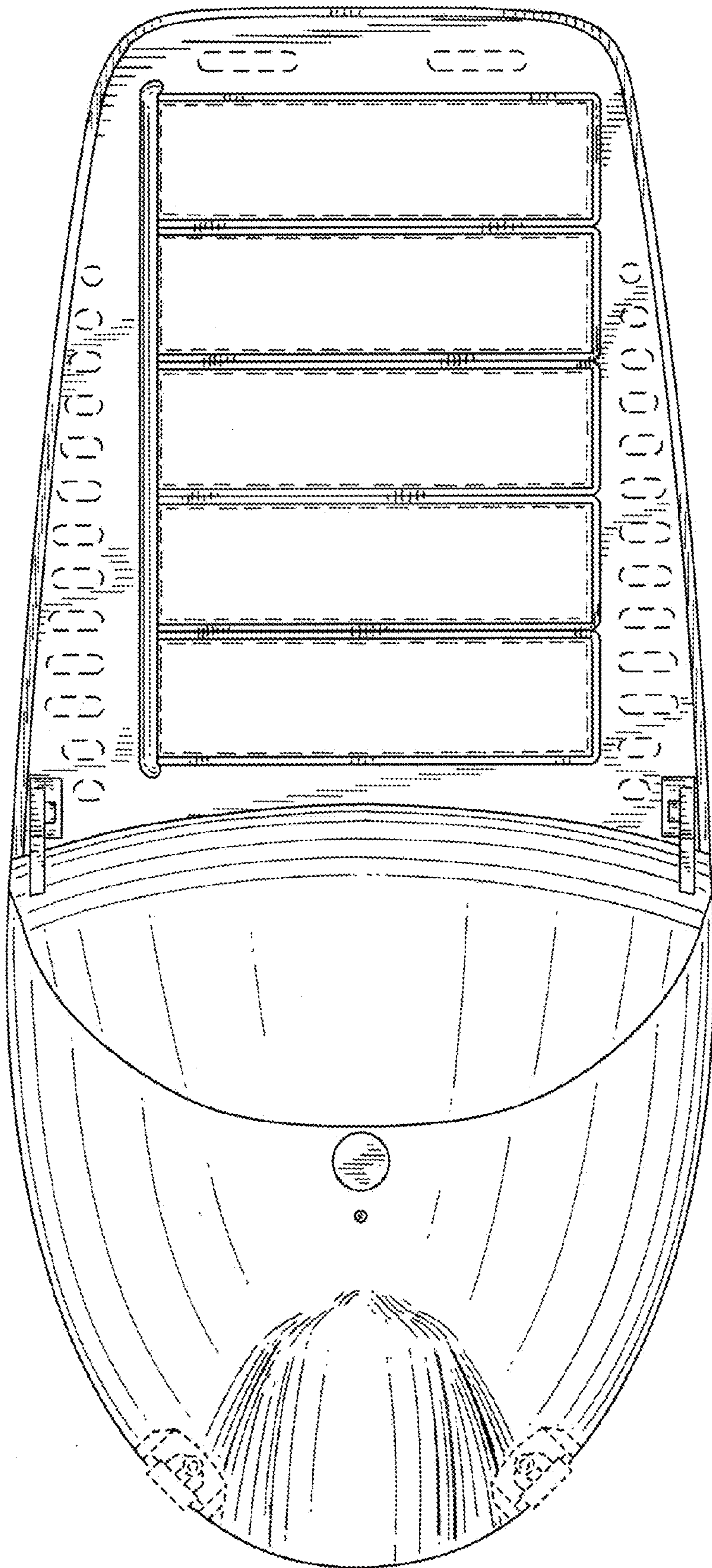

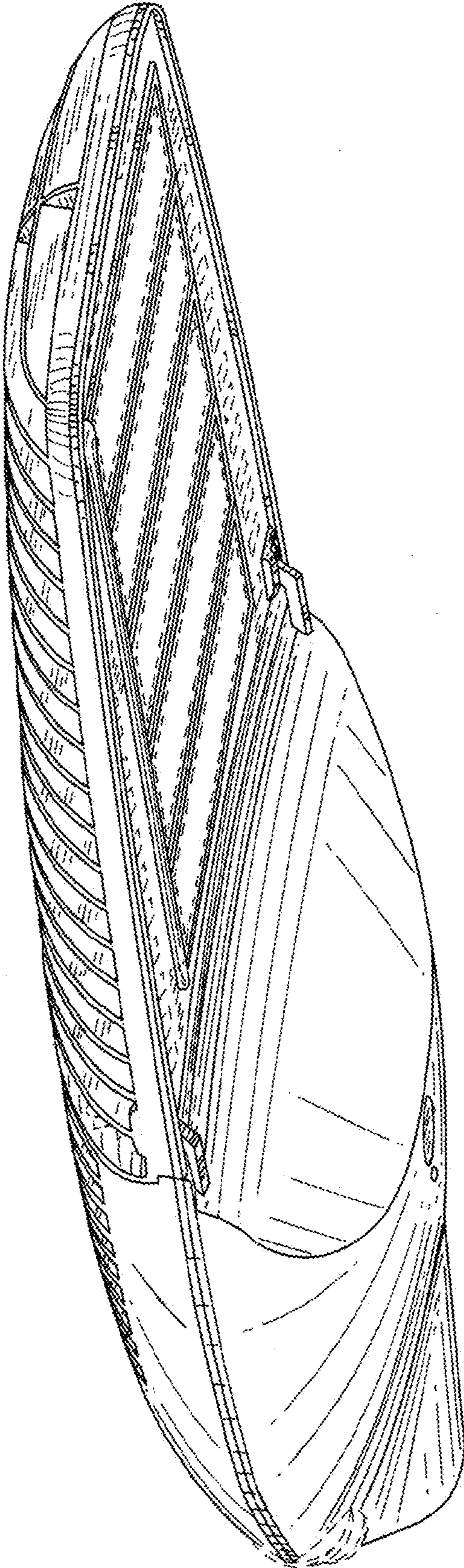
