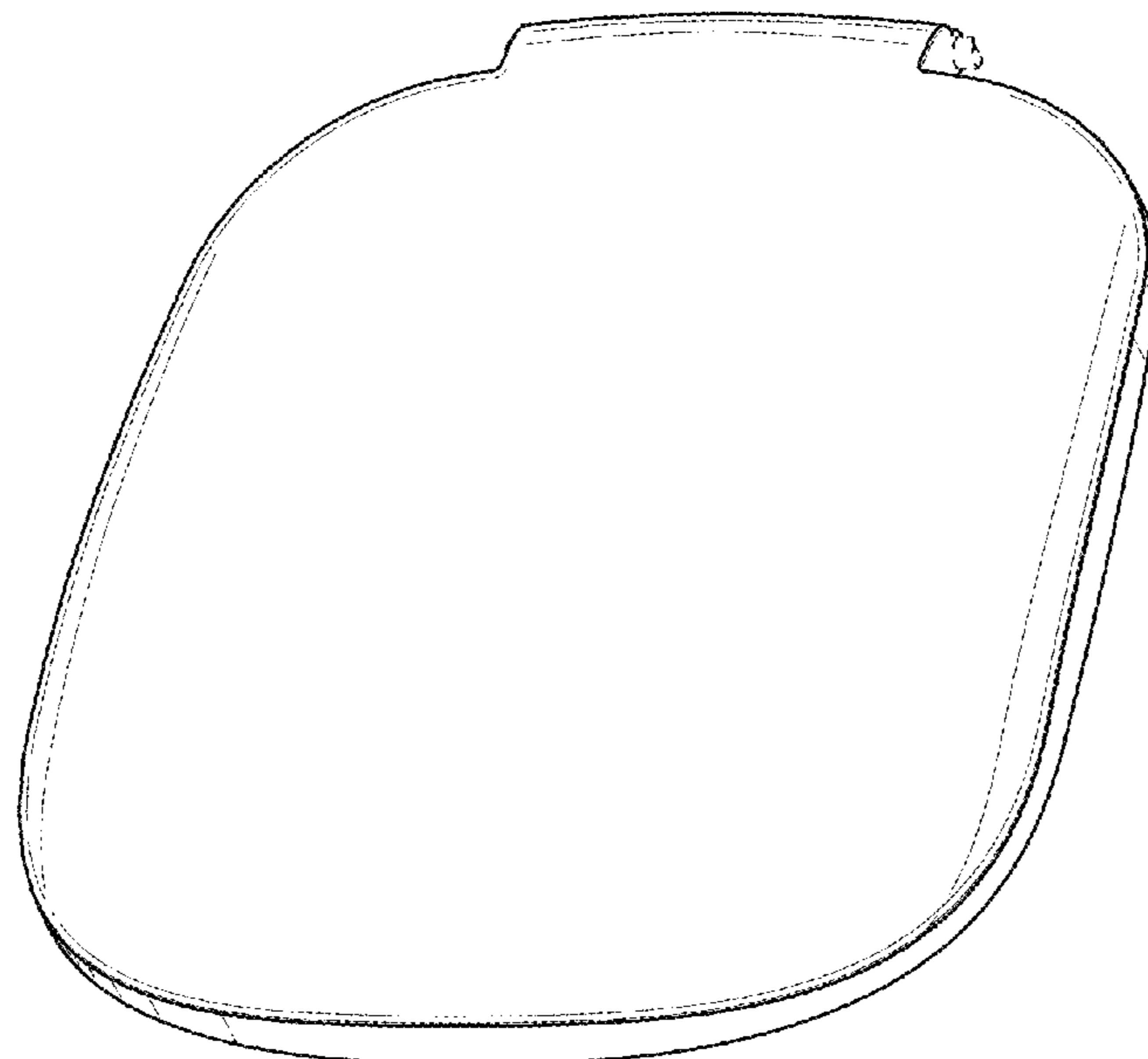
We claim the ornamental design for the lid, as shown and described.

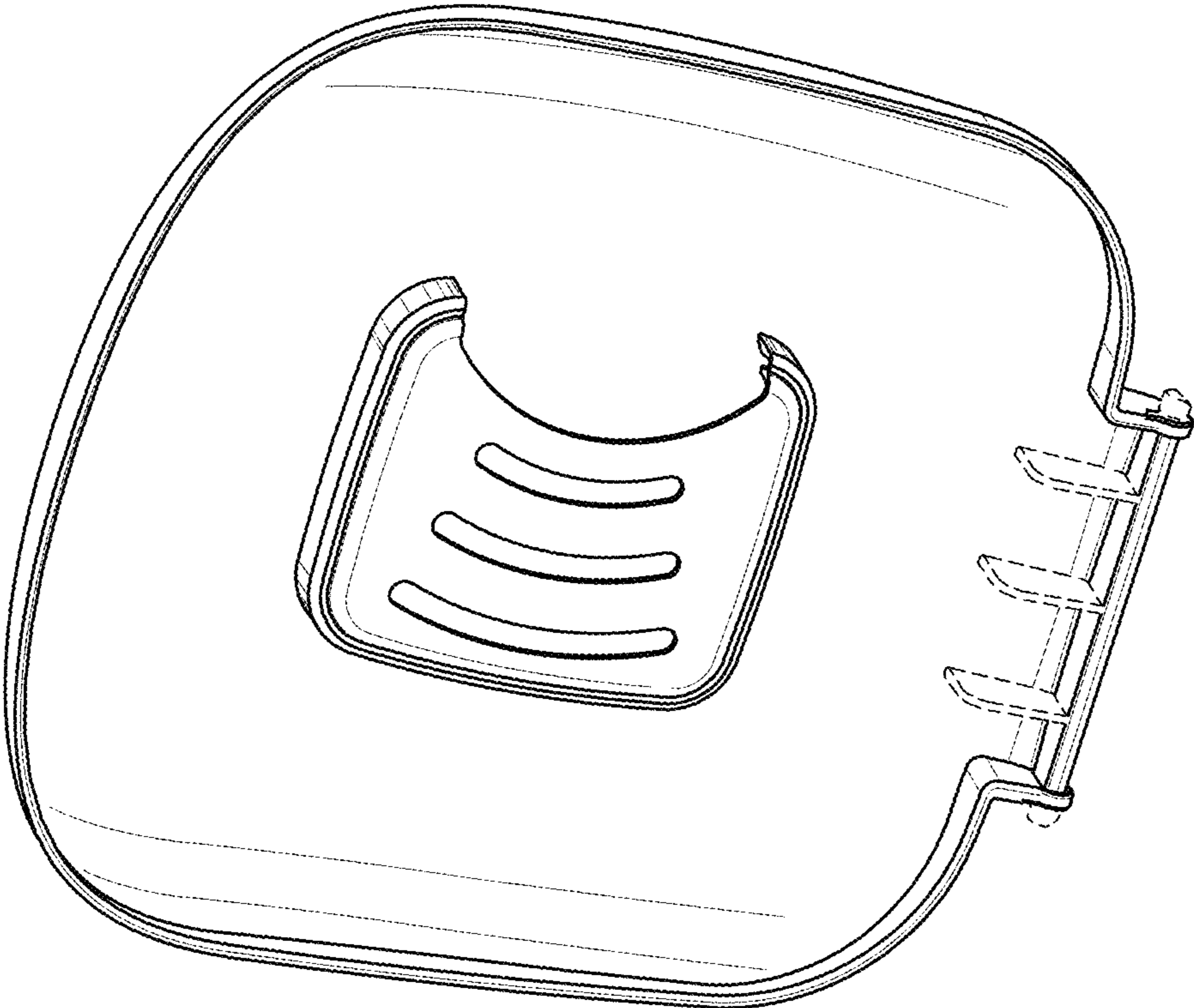

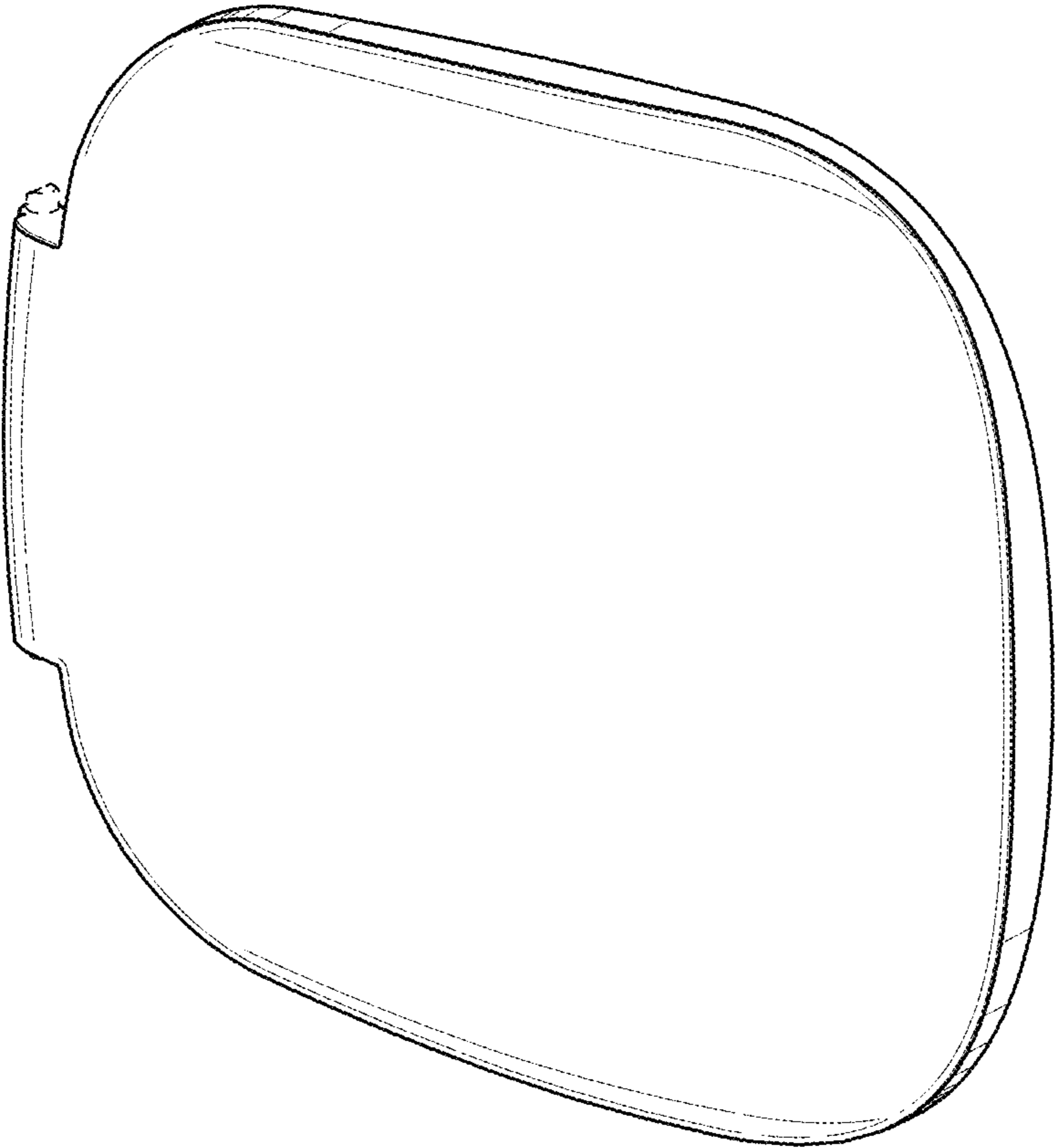

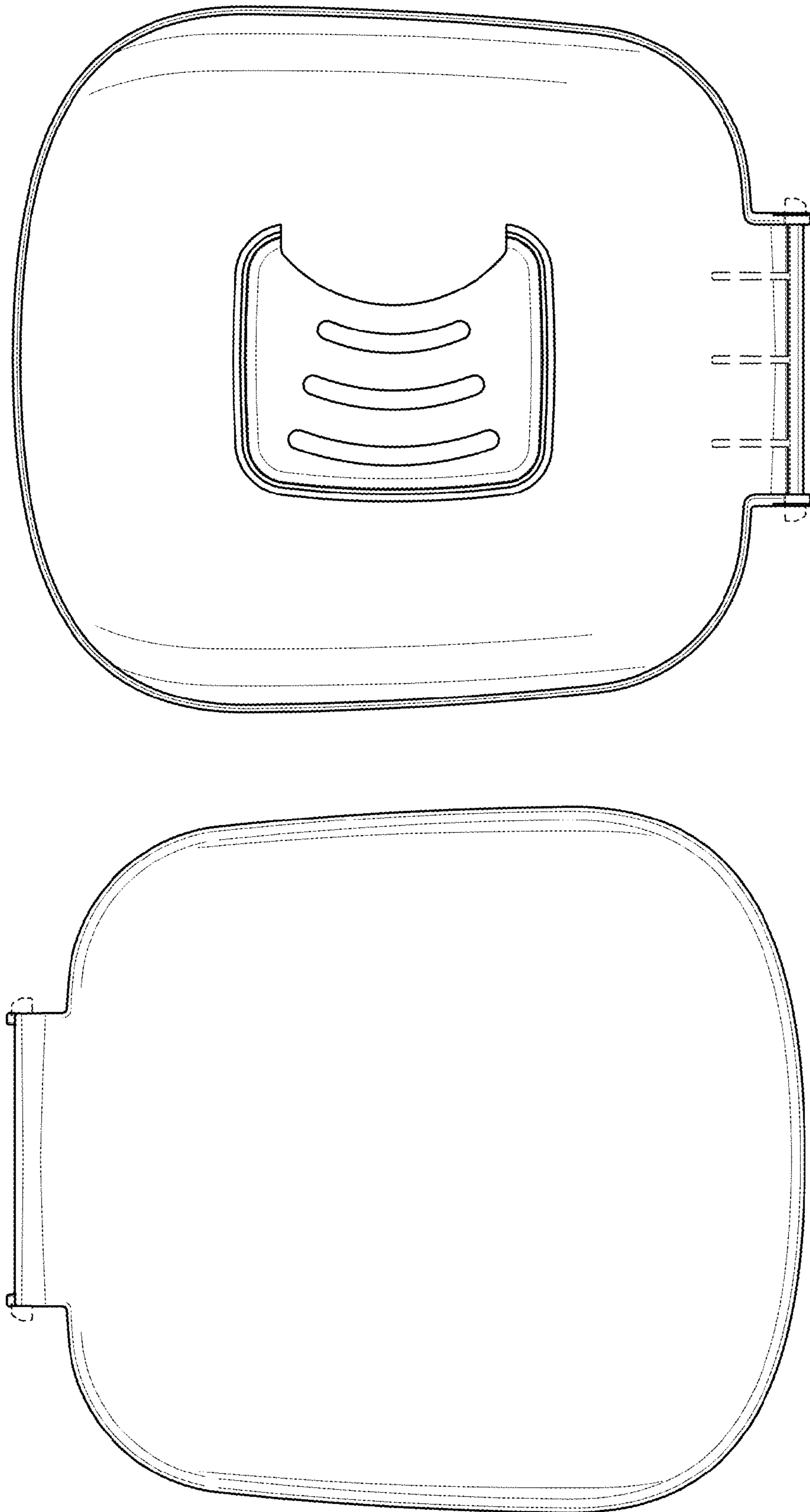

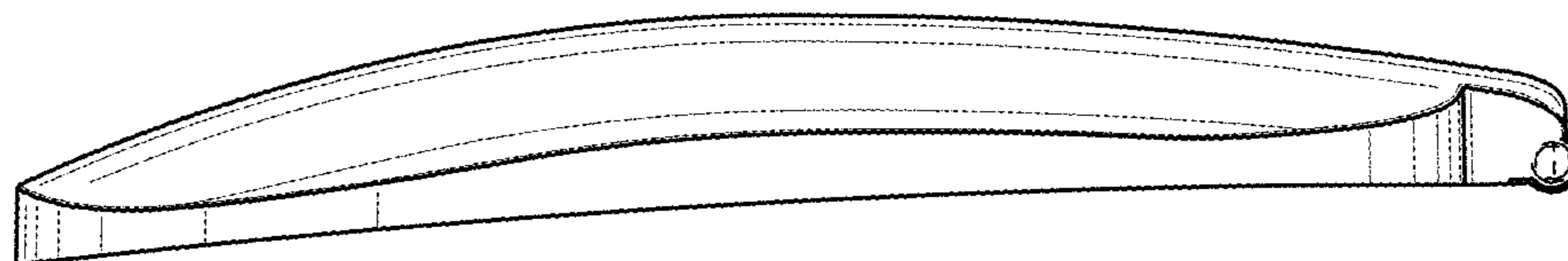

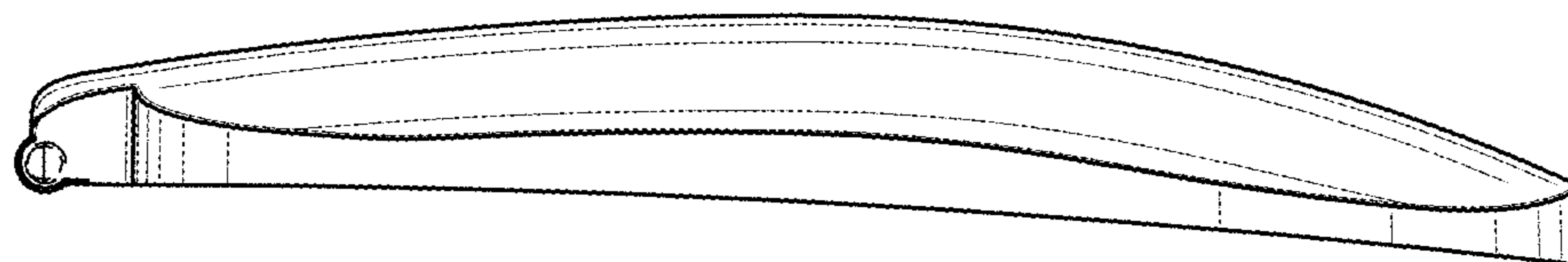

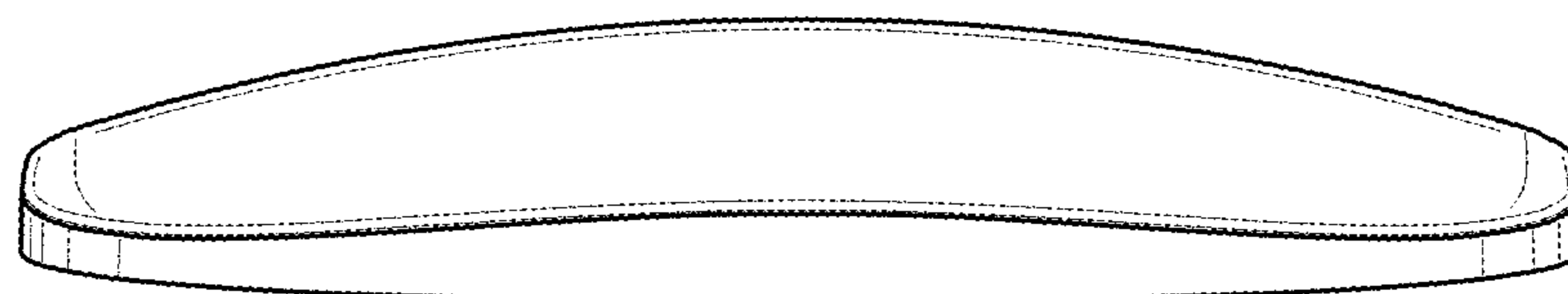

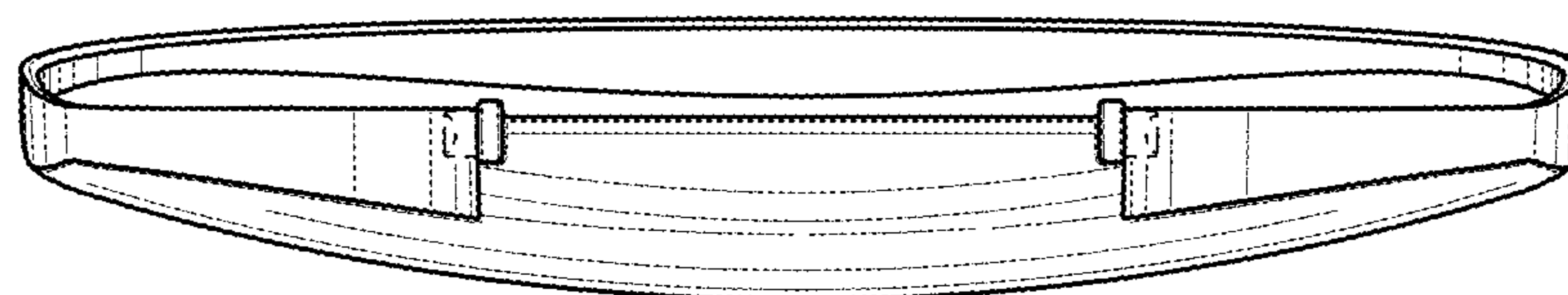
