(57) **CLAIM**

We claim the ornamental design for an inflatable mattress, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first inflatable mattress, where a body of the first inflatable mattress is shown in broken lines;

FIG. 2 is a top plan view of the first inflatable mattress of FIG. 1;

FIG. 3 is a bottom plan view of the first inflatable mattress of FIG. 1;

FIG. 4 is a side elevational view of the first inflatable mattress of FIG. 1;

FIG. 5 is an end elevational view of the first inflatable mattress of FIG. 1;

FIG. 6 is a perspective view of a second inflatable mattress different in size than the first inflatable mattress of FIG. 1, where a body of the second inflatable mattress is shown in broken lines;

FIG. 7 is a top plan view of the second inflatable mattress of FIG. 6;

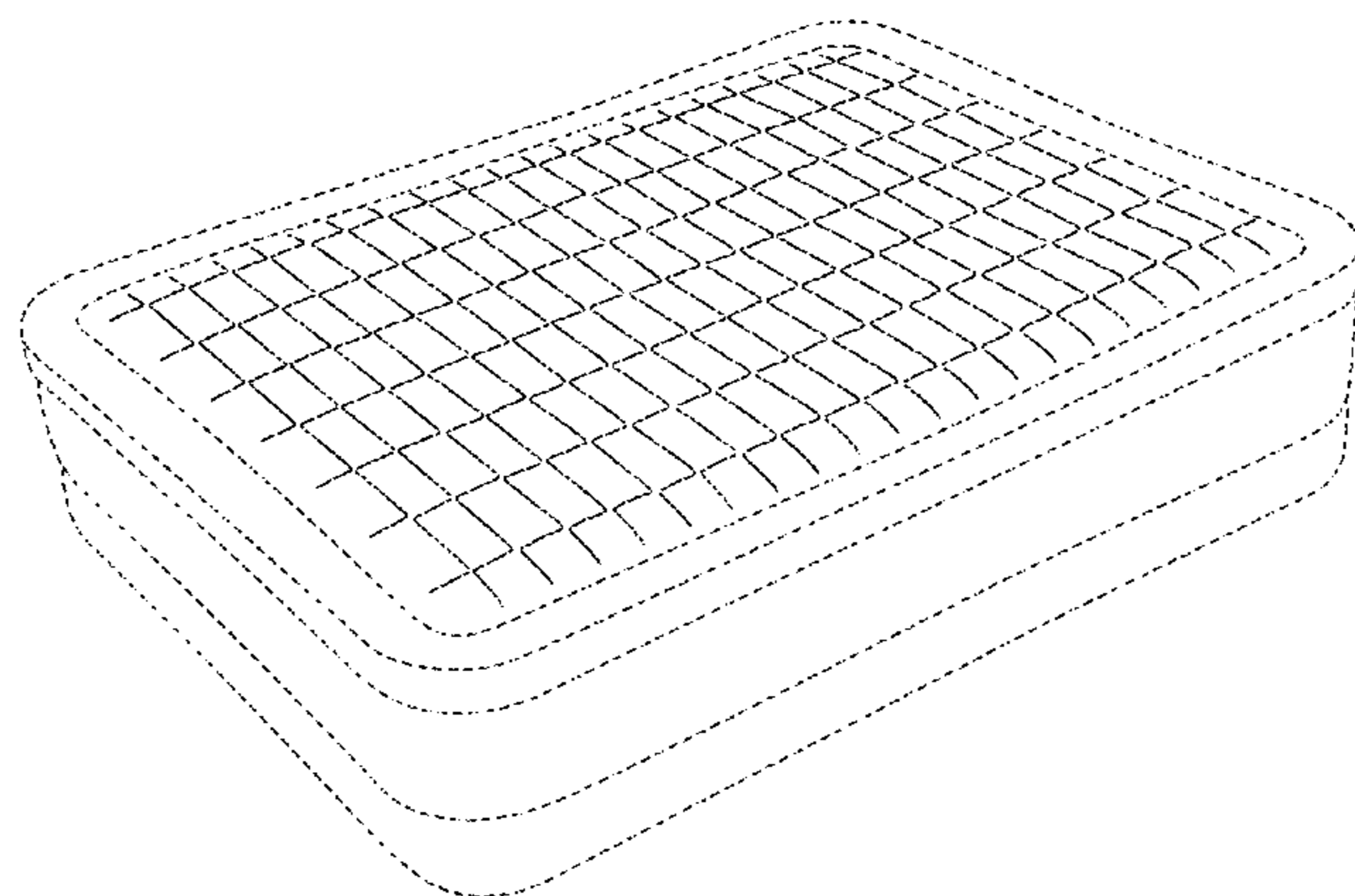
FIG. 8 is a bottom plan view of the second inflatable mattress of FIG. 6;

FIG. 9 is a side elevational view of the second inflatable mattress of FIG. 6; and,

FIG. 10 is an end elevational view of the second inflatable mattress of FIG. 6.

The broken lines in FIGS. 1-10 represent unclaimed portions of the inflatable mattress and form no part of the claimed design.

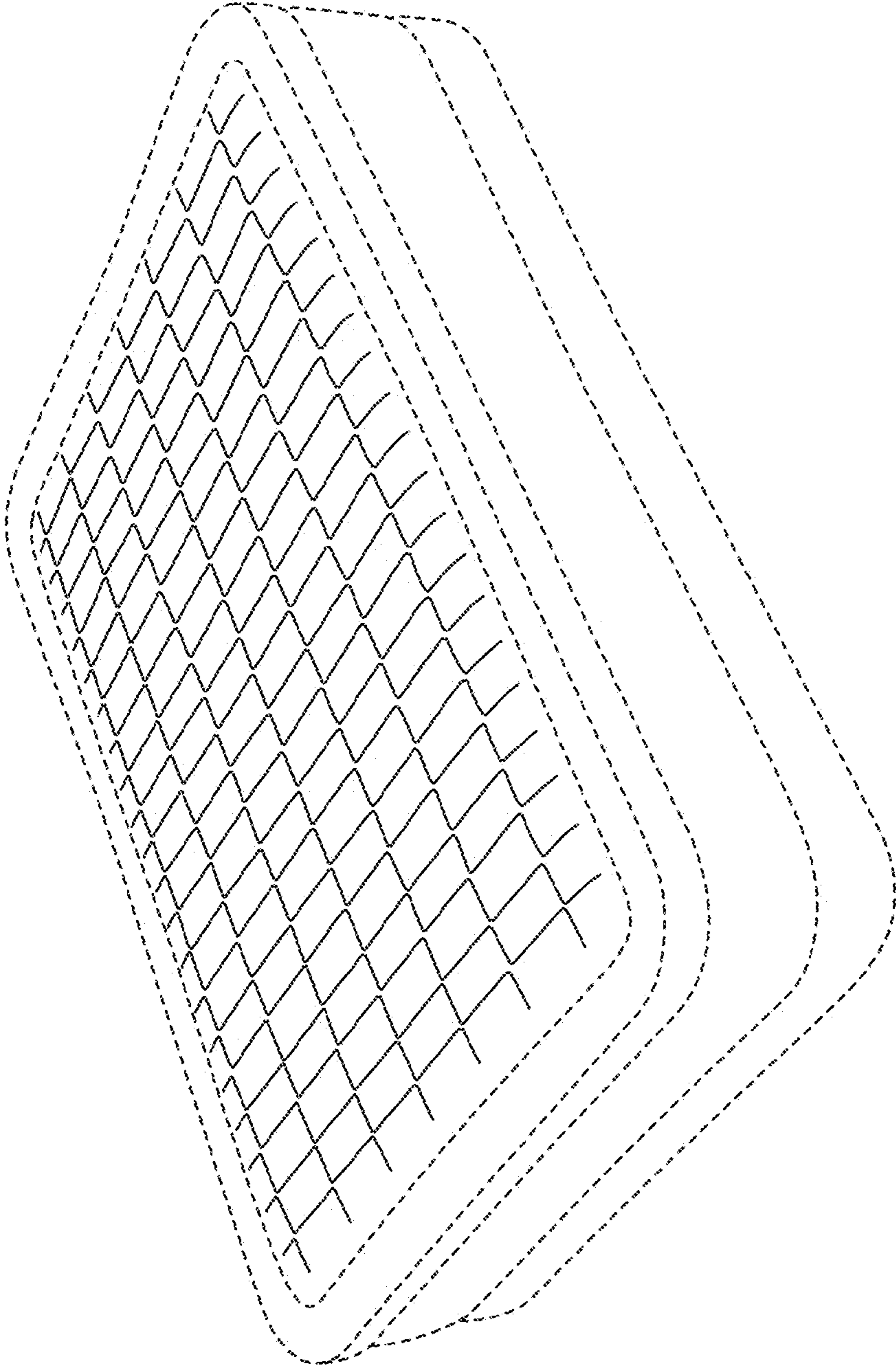

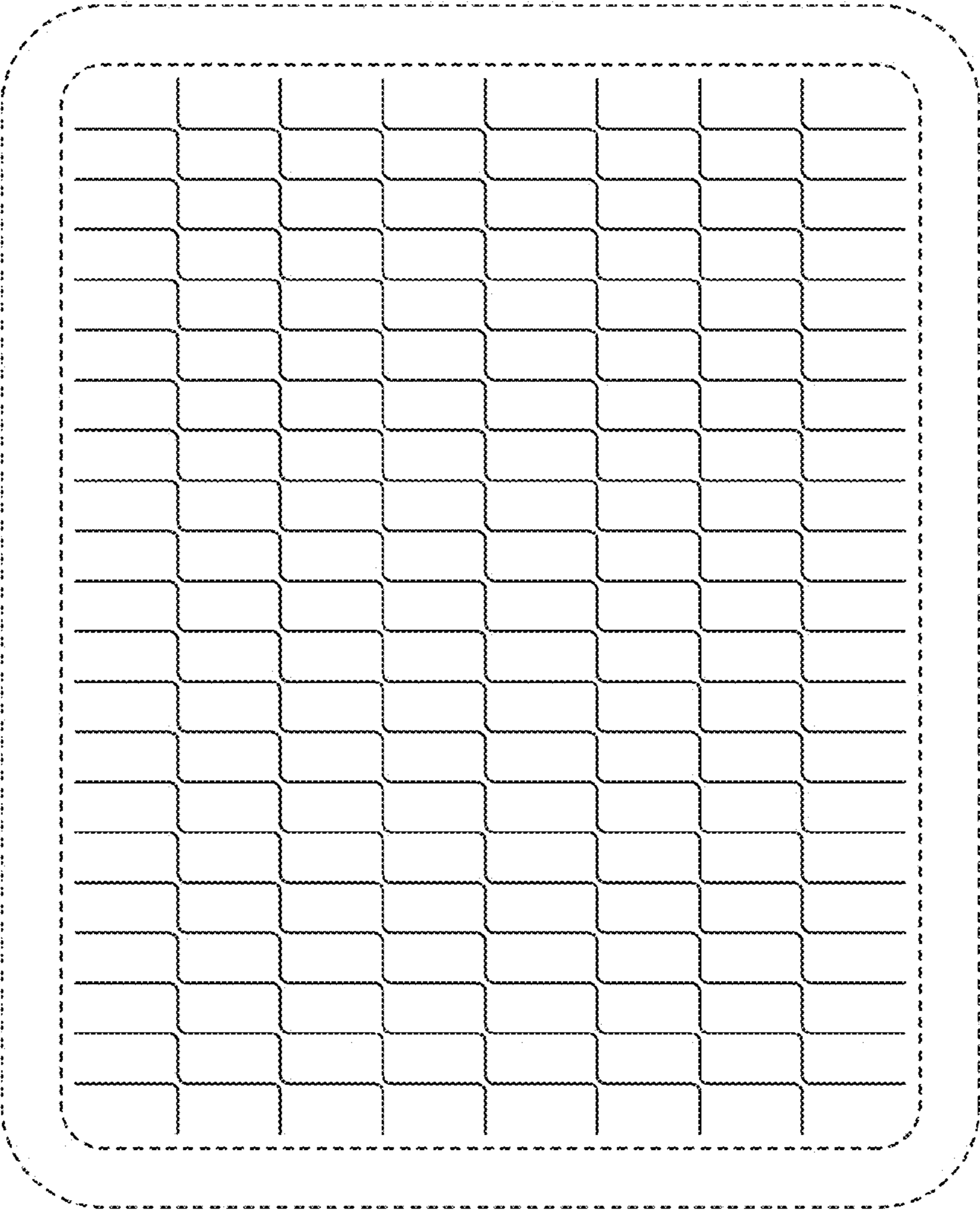

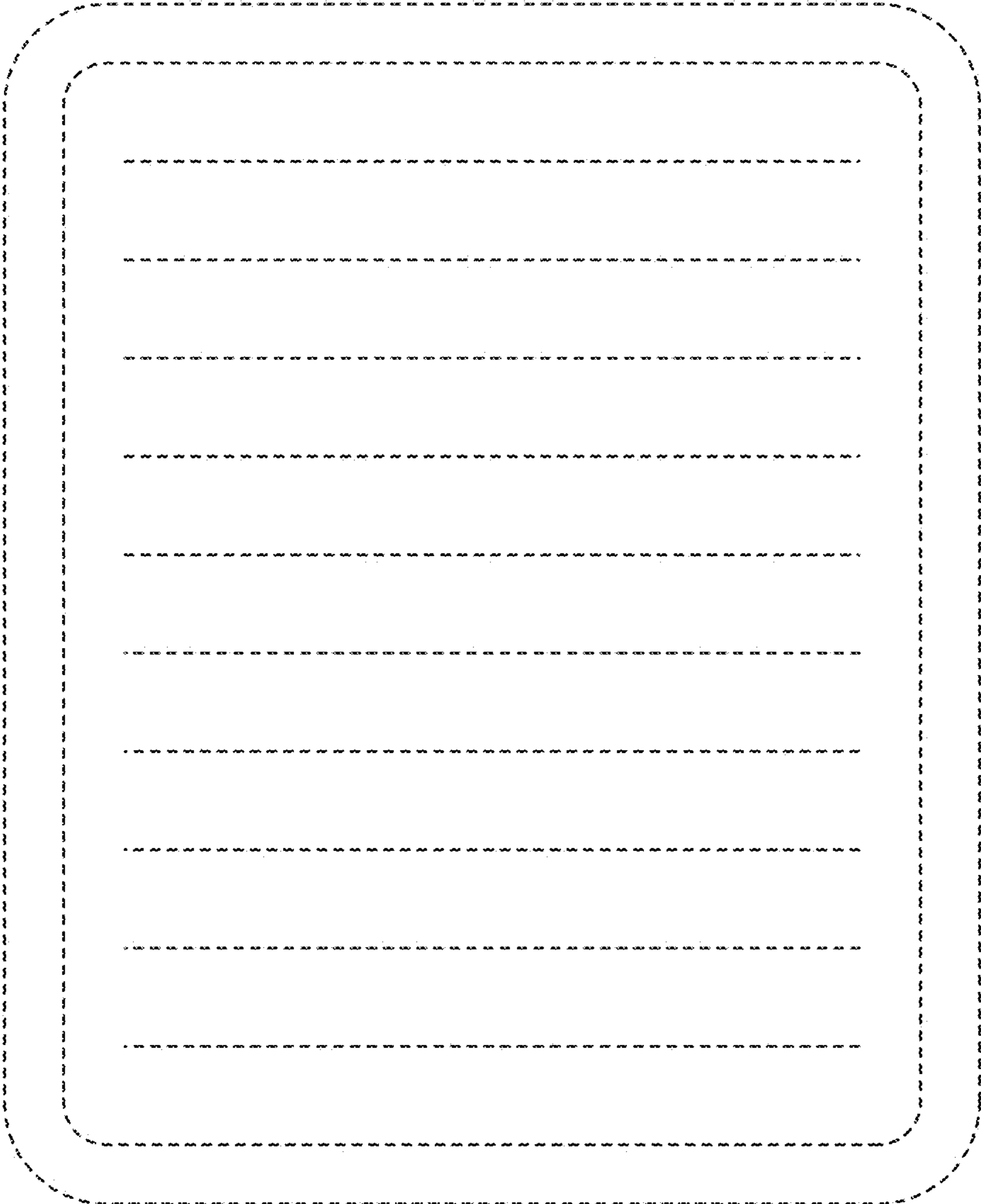

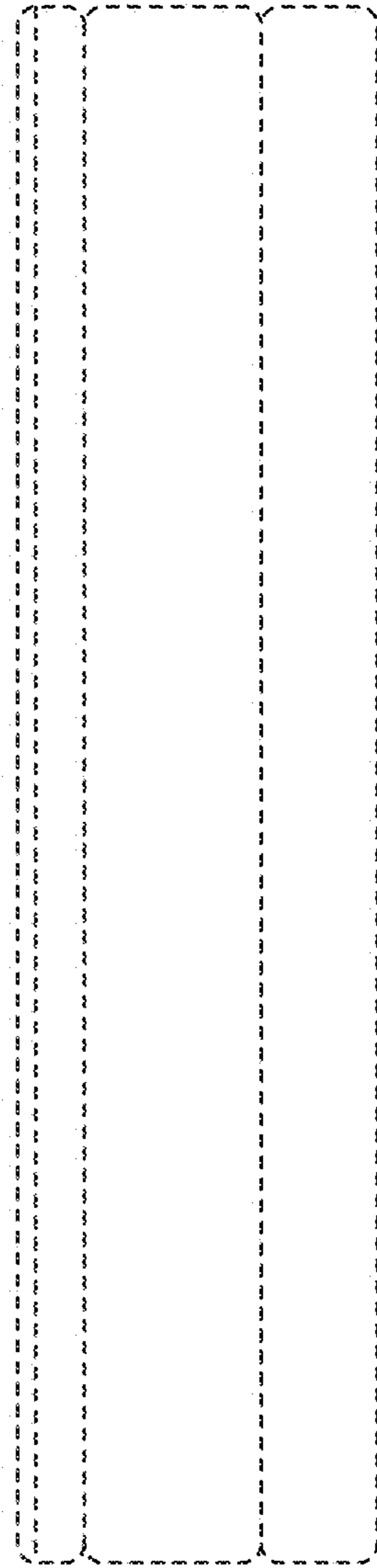

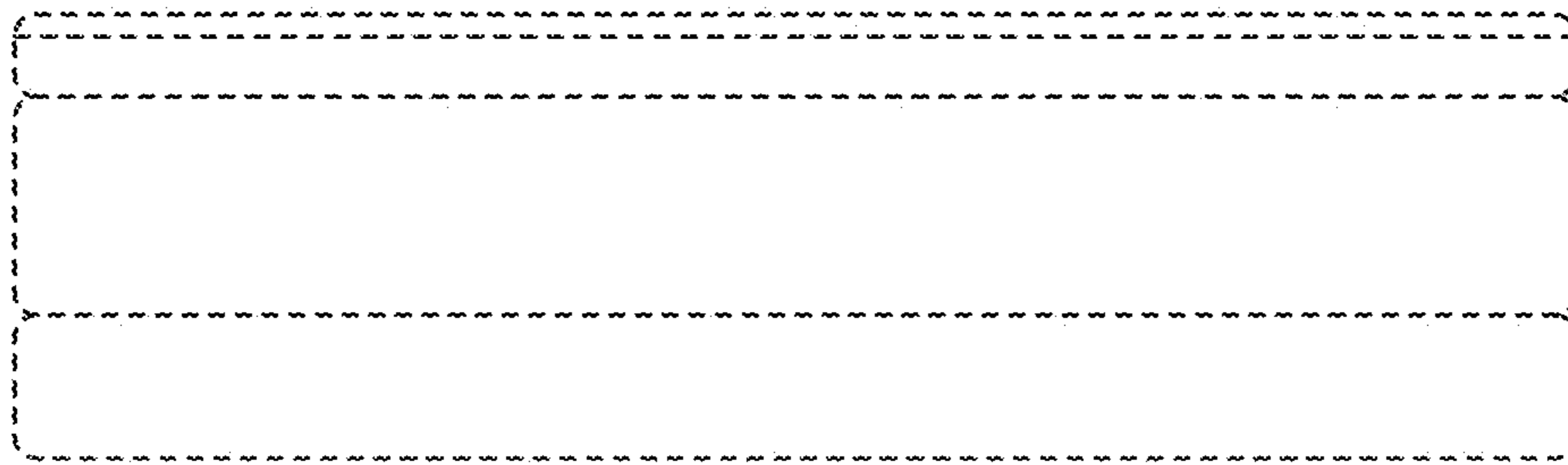

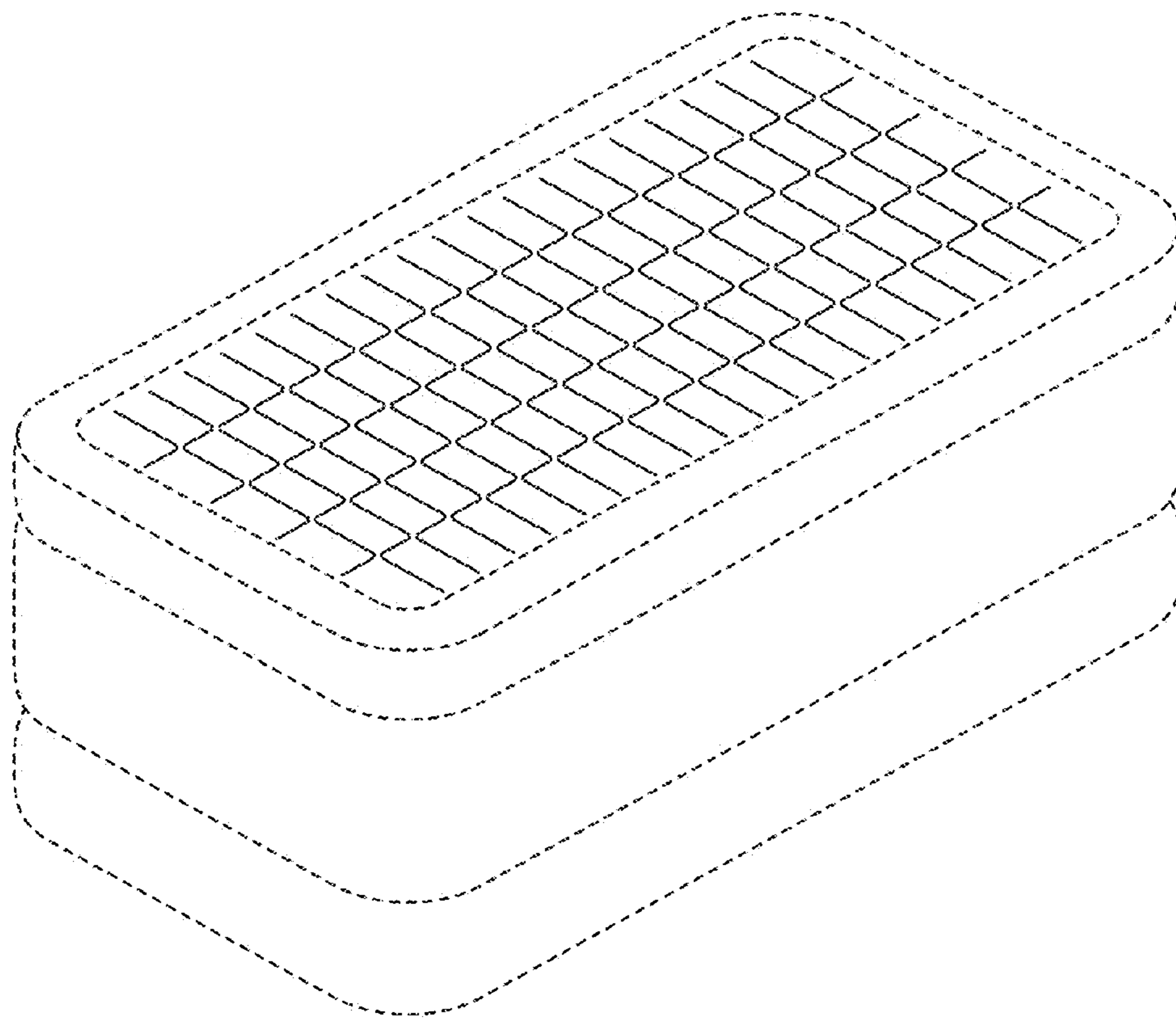

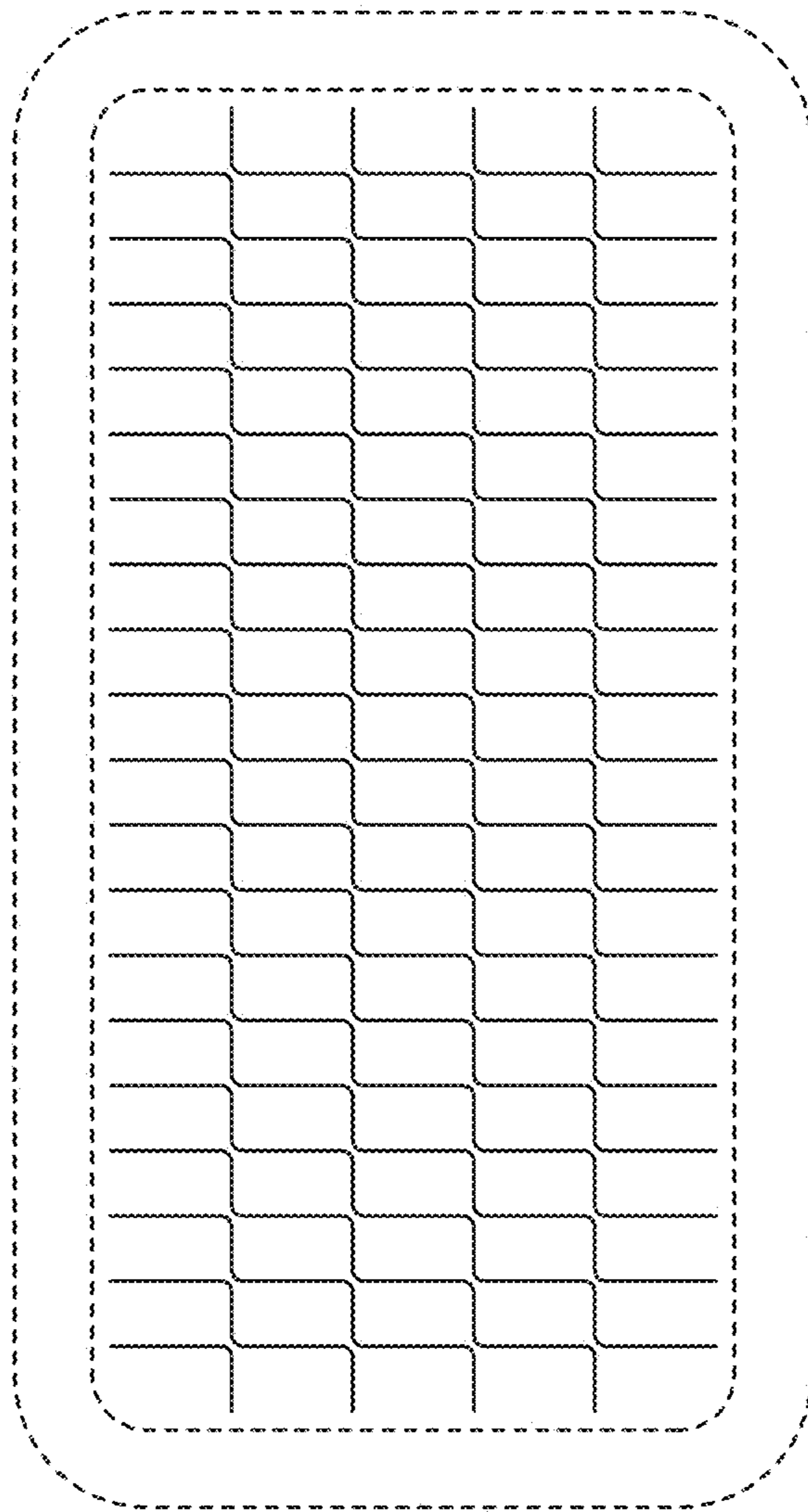

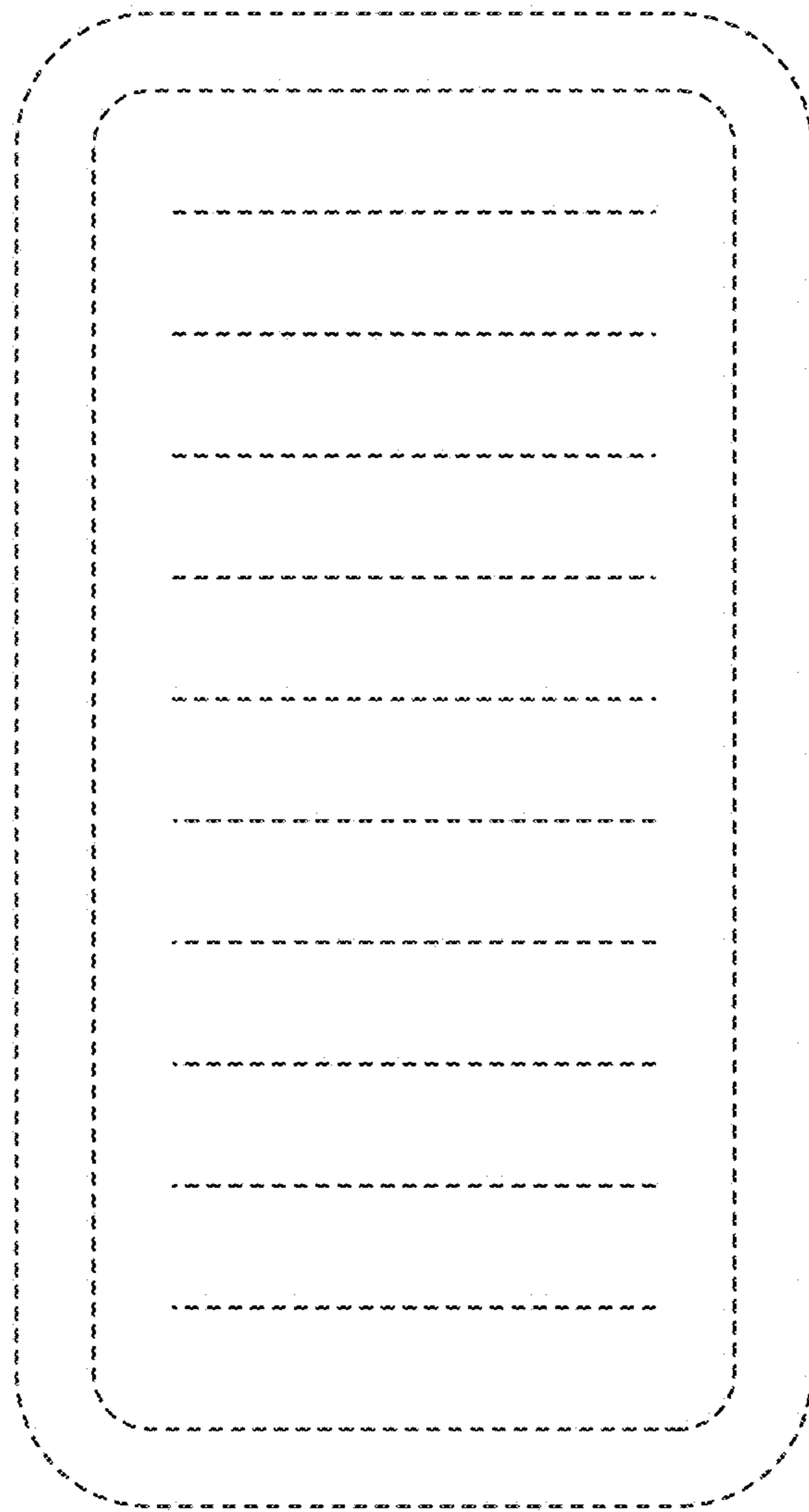

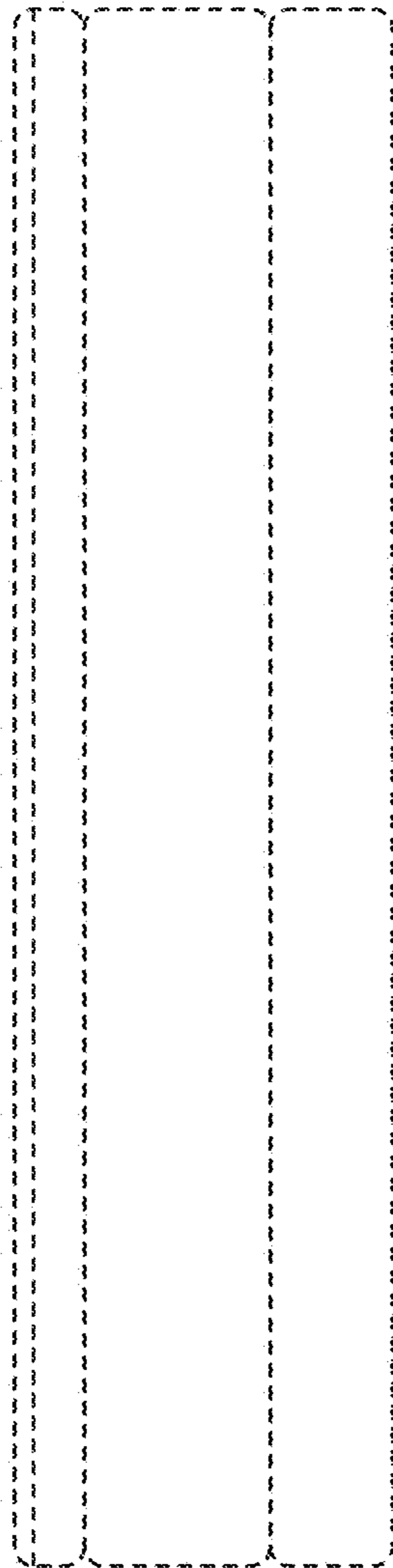

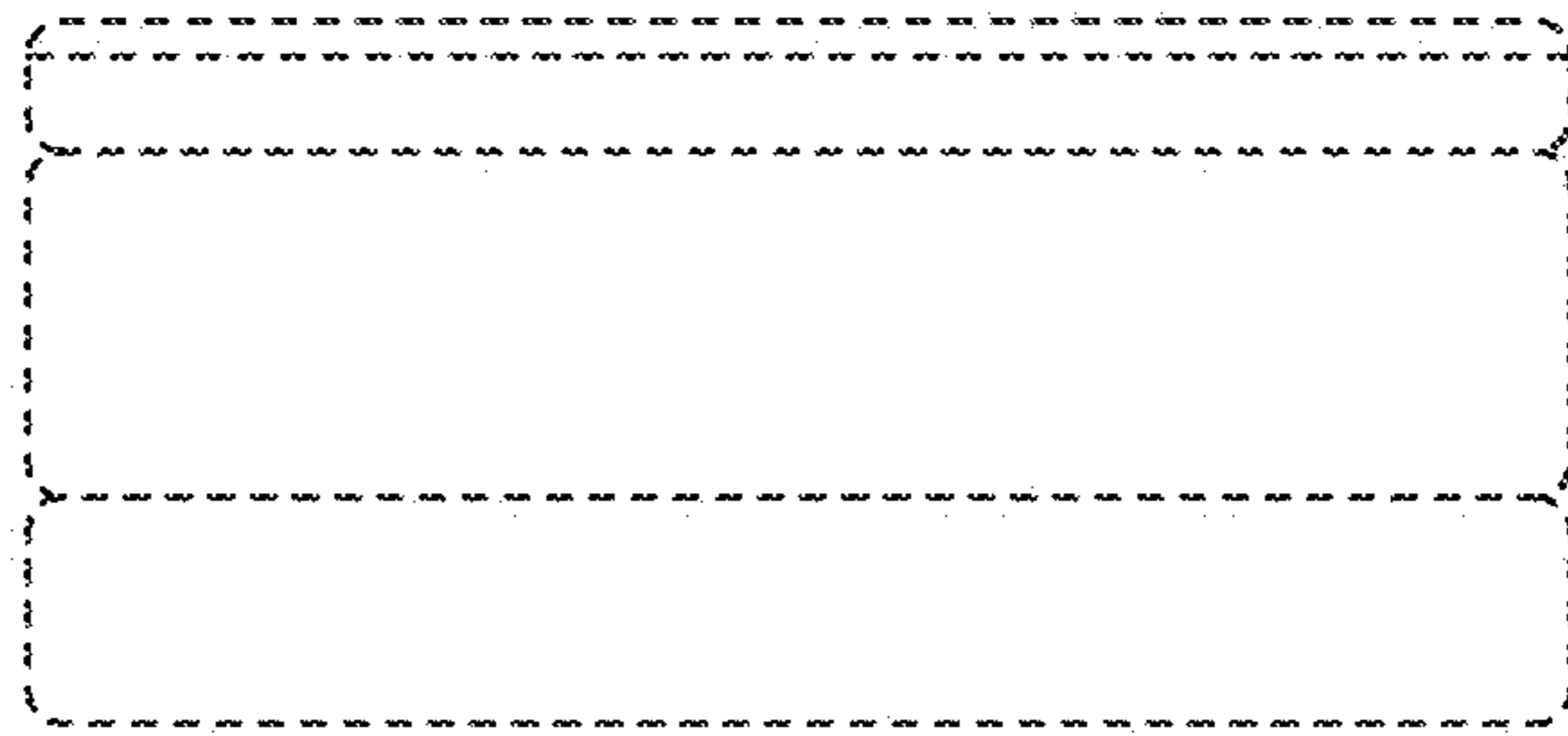
