(57) **CLAIM**

The ornamental design for a scarf organizer, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the scarf organizer; FIG. 2 is a front elevational view of the scarf organizer of FIG. 1; FIG. 3 is a back elevational view of the scarf organizer of FIG. 1; FIG. 4 is a left side elevational view of the scarf organizer of FIG. 1; FIG. 5 is a right side elevational view of the scarf organizer of FIG. 1; FIG. 6 is top plan view of the scarf organizer of FIG. 1; and, FIG. 7 is a bottom plan view of the scarf organizer of FIG. 1.

The broken lines in the drawings showing the portion of the hooks attached to the scarf organizer are environmental structure and form no part of the claimed design.

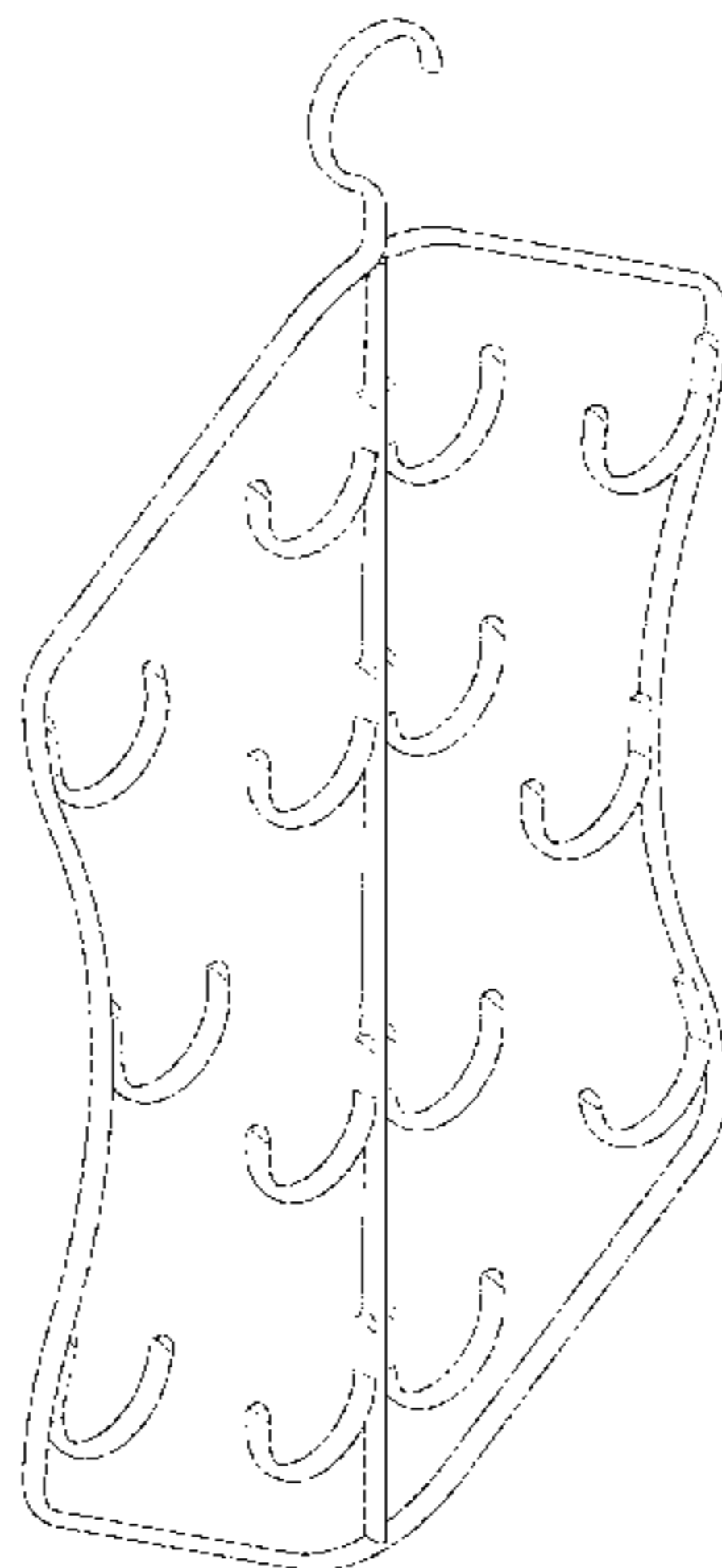
The dot-dot-dot broken line within each hook defines the bounds of the claimed design and forms no part of the claimed design.

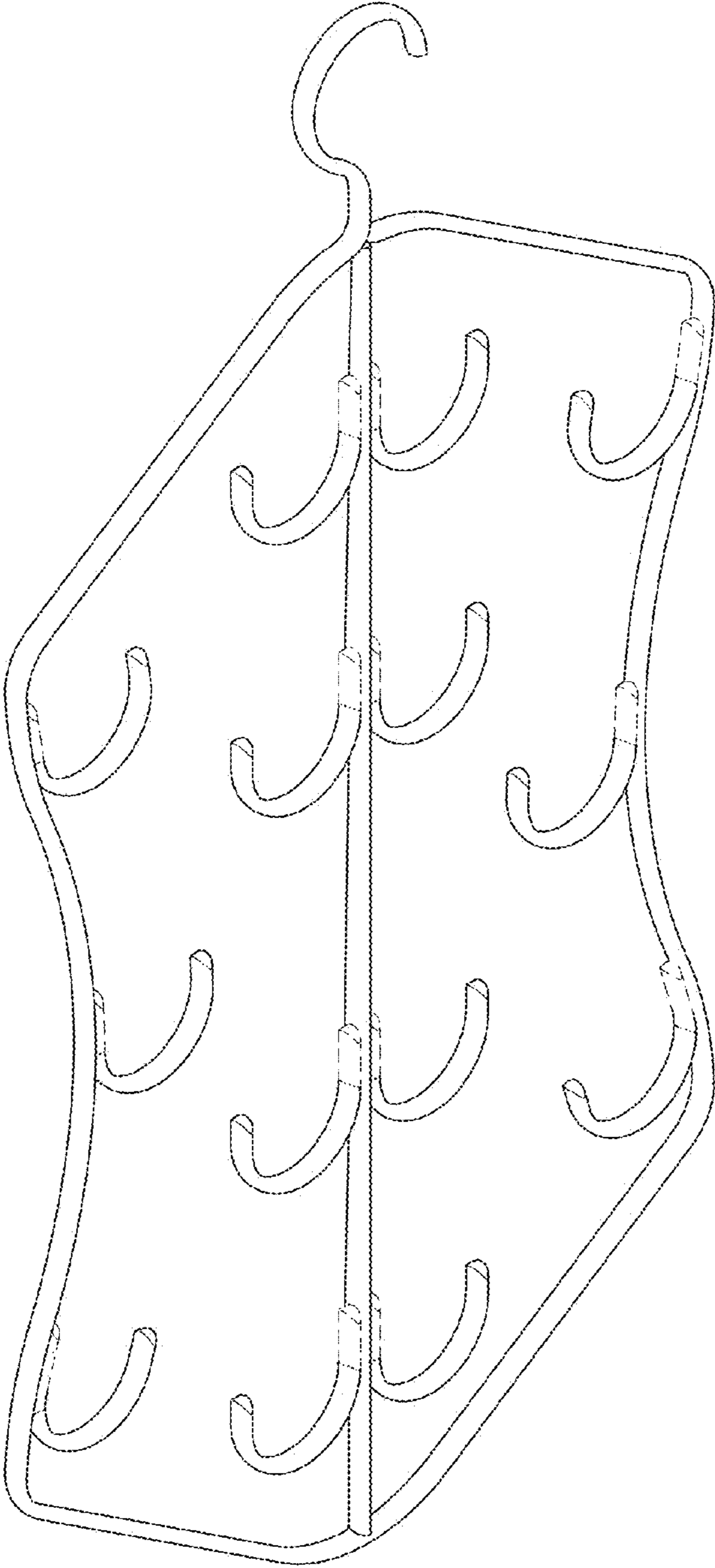

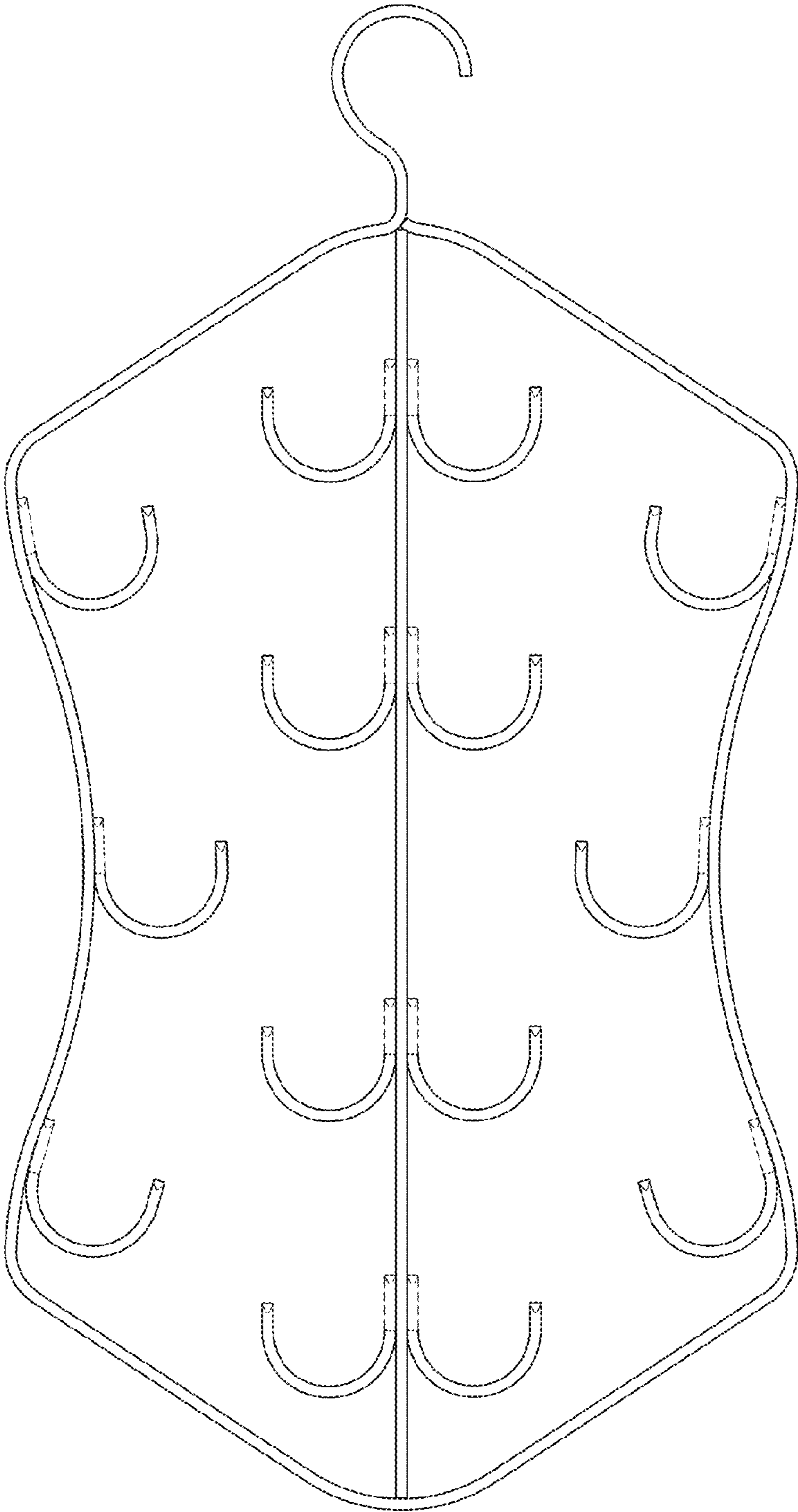

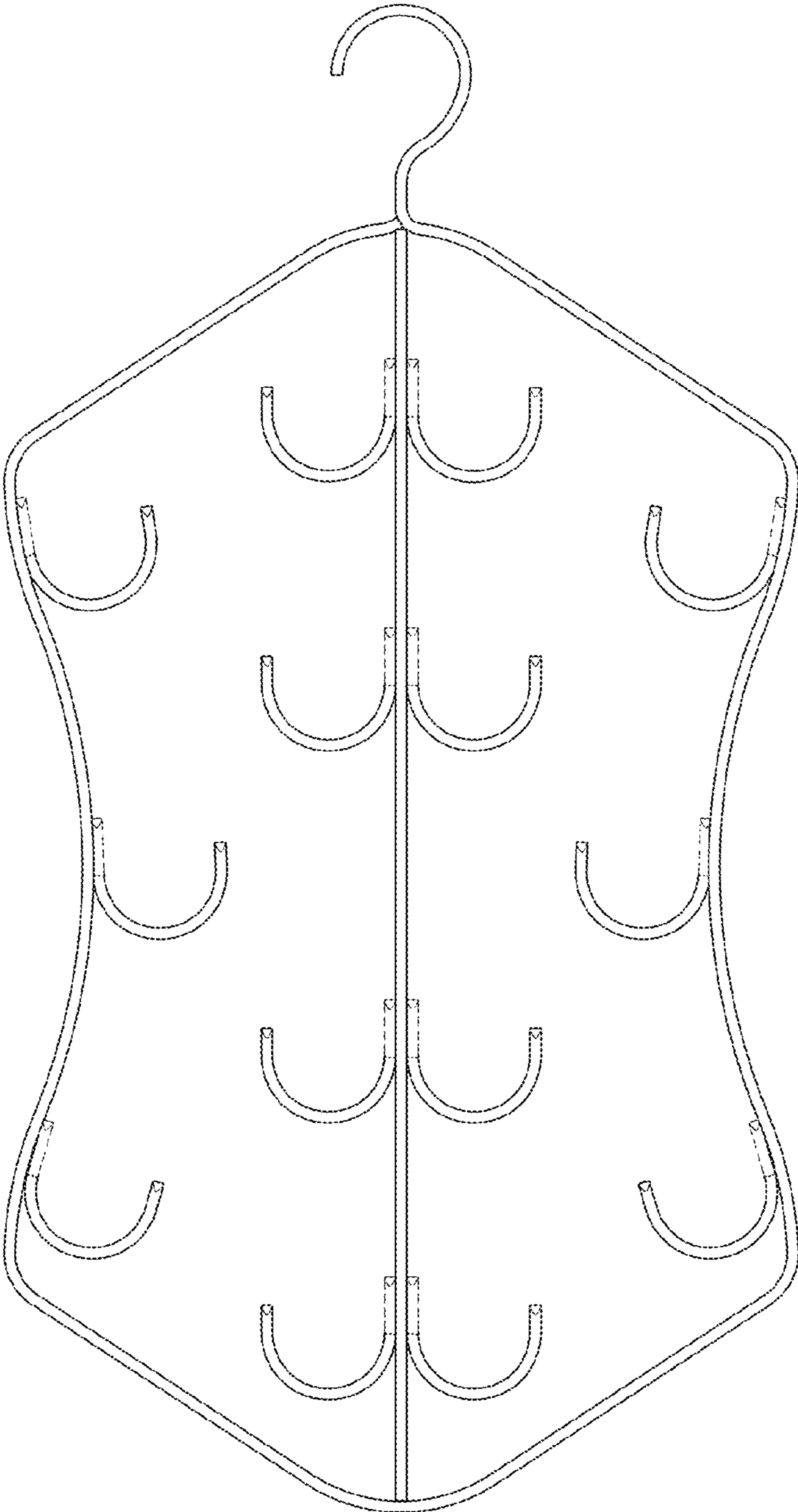

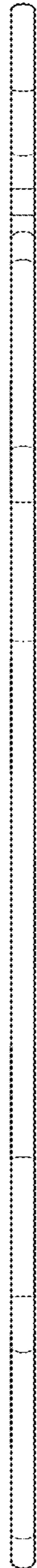

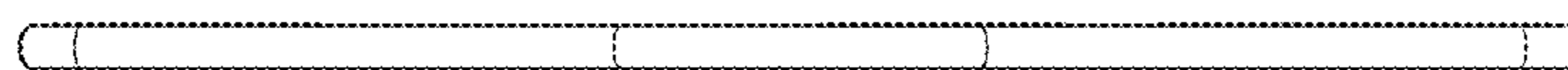
