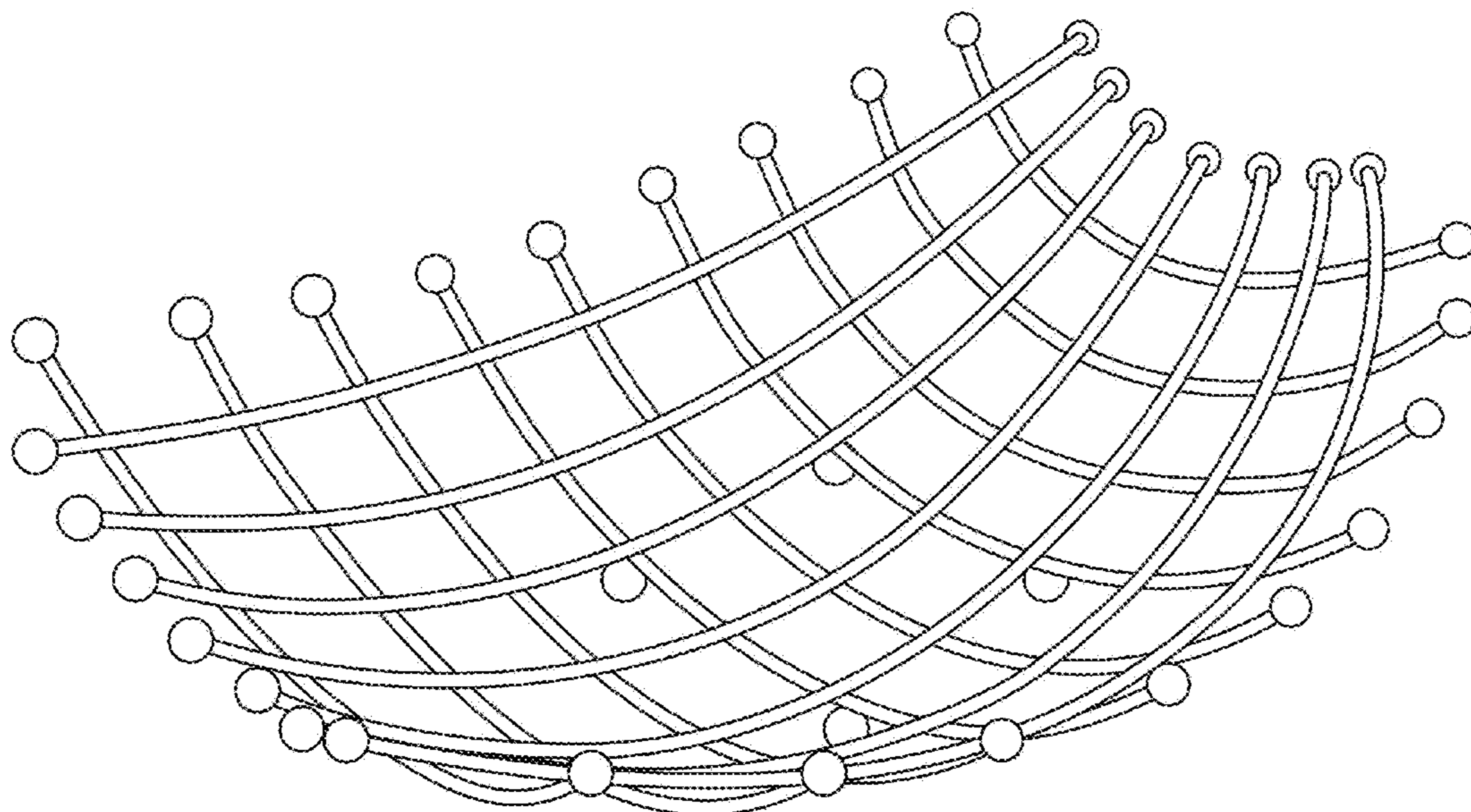

DESCRIPTION

FIG. 1 is a perspective view of an oval fruit bowl, showing my new design;

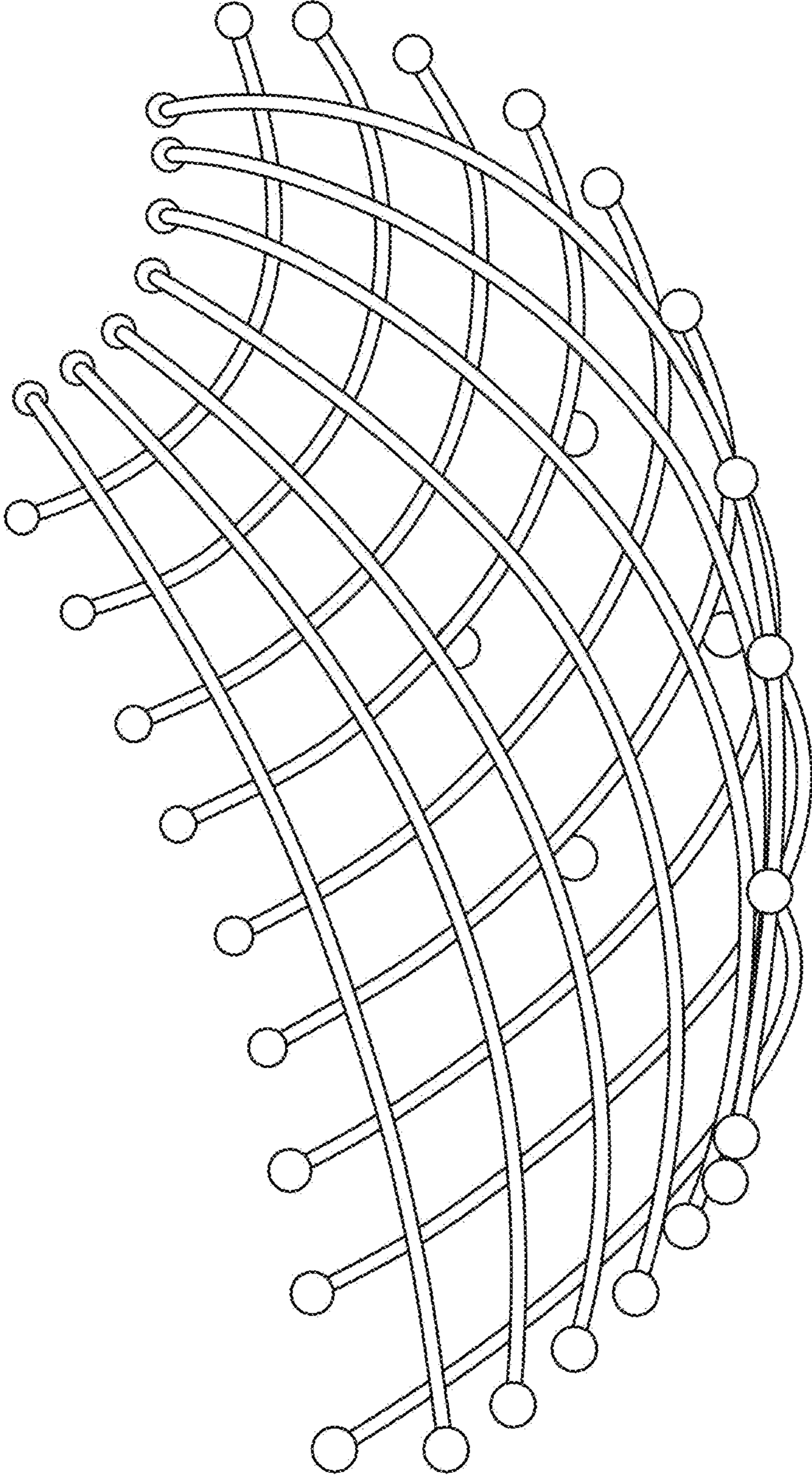

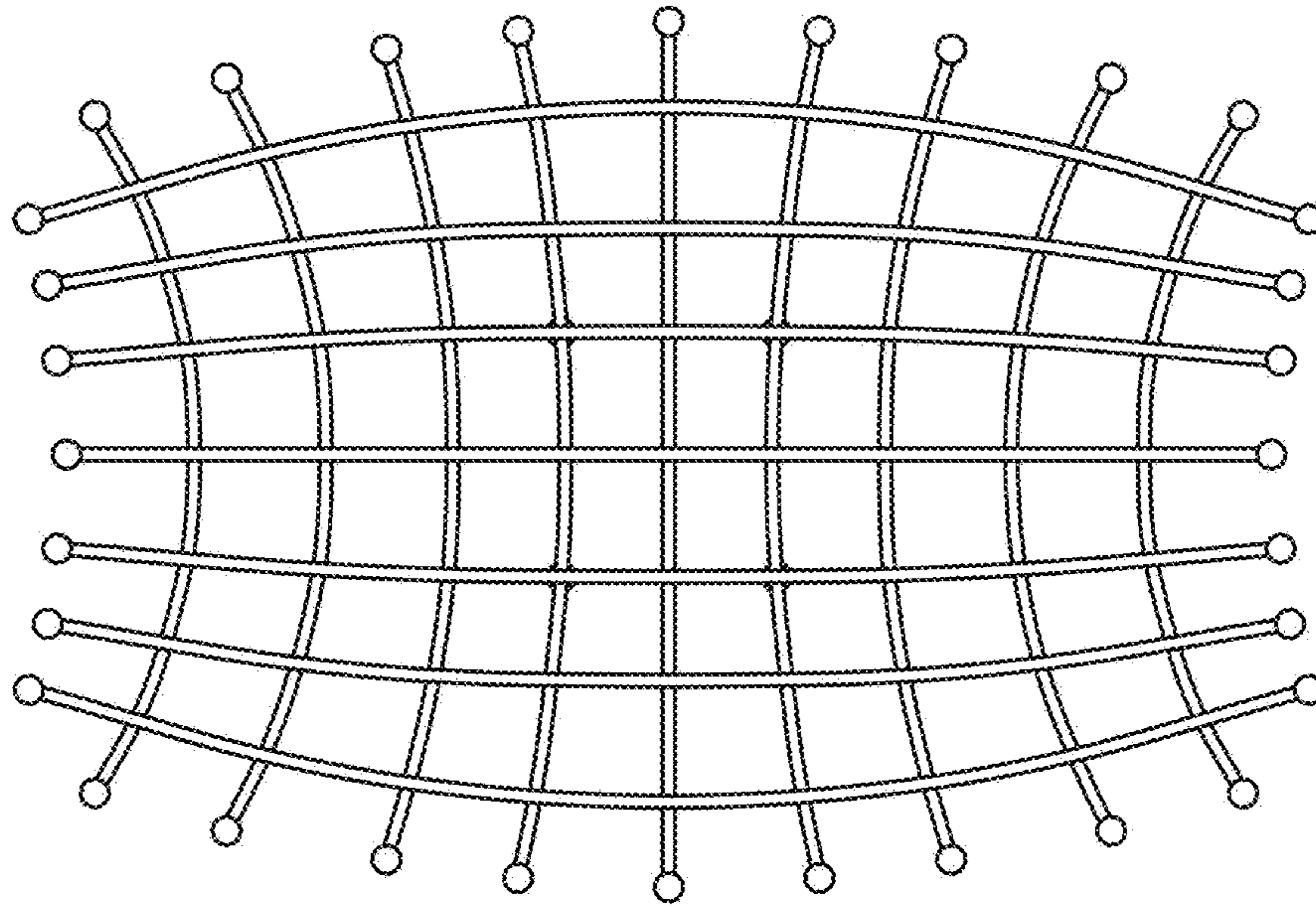

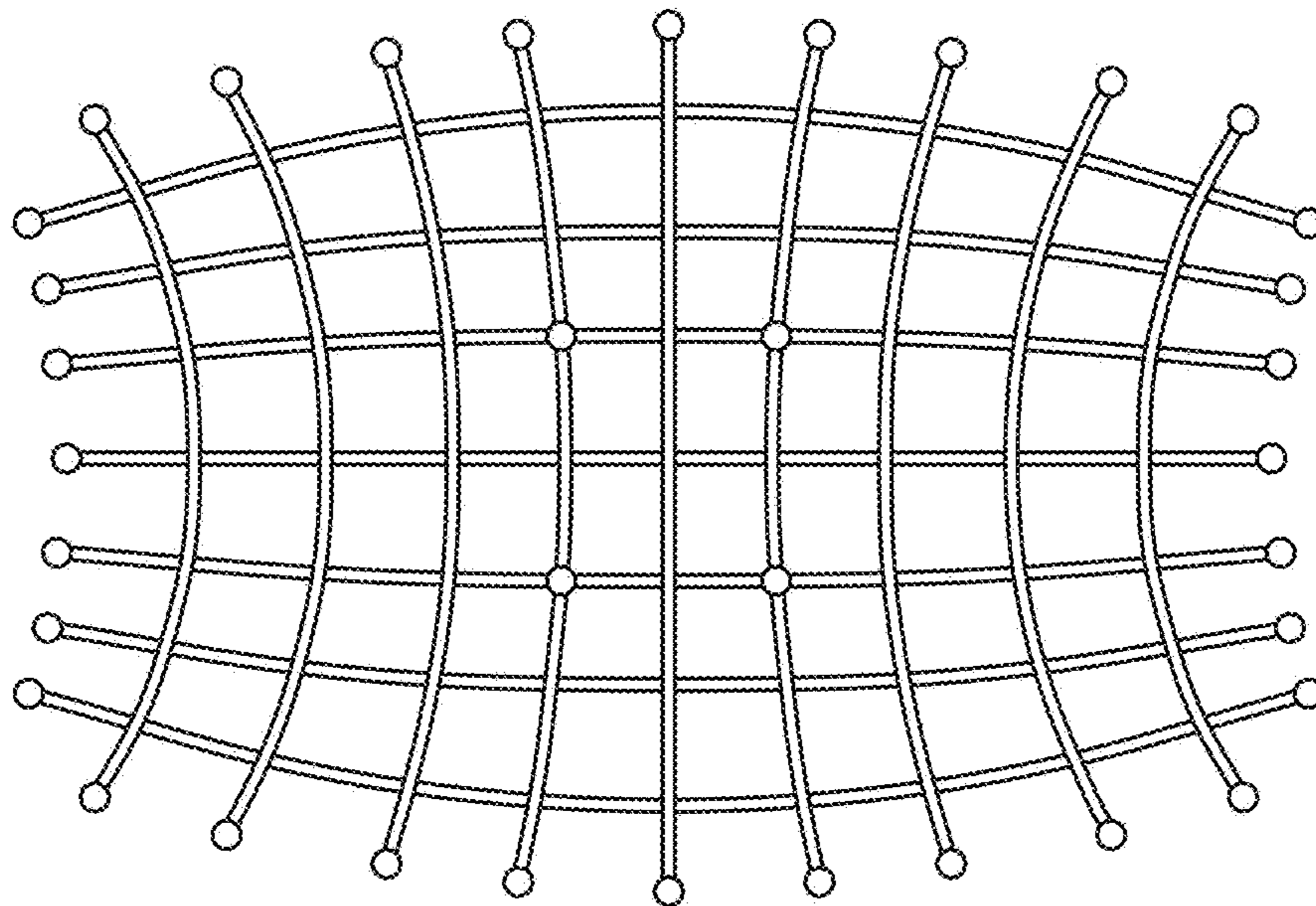

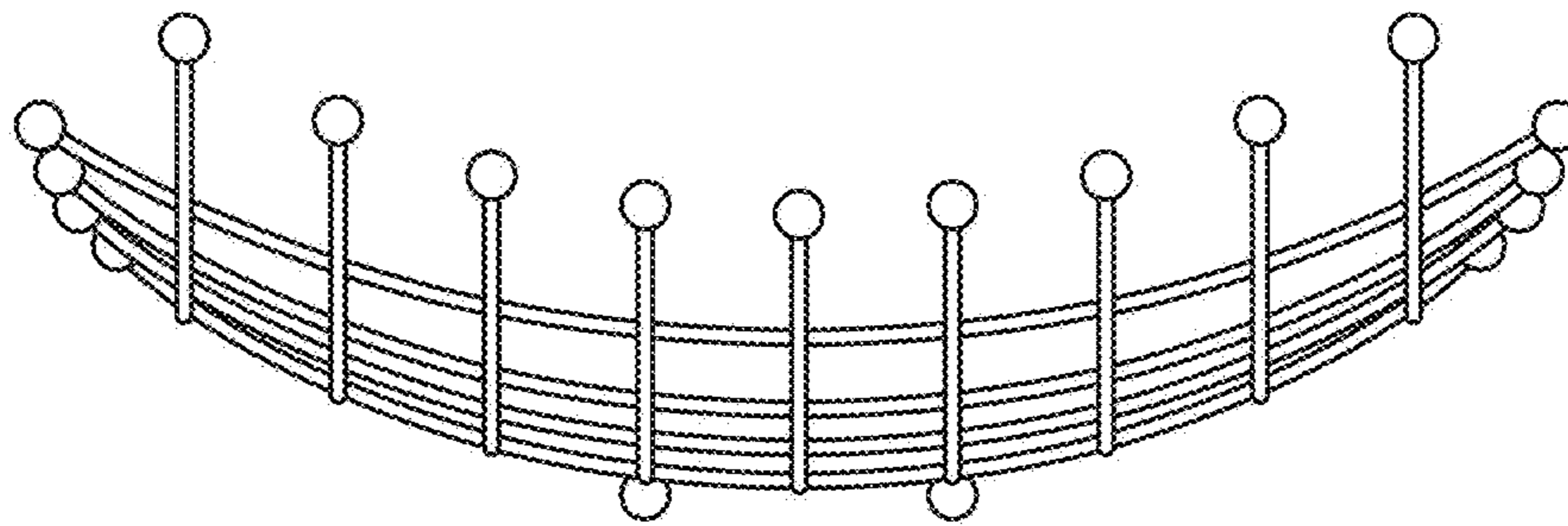

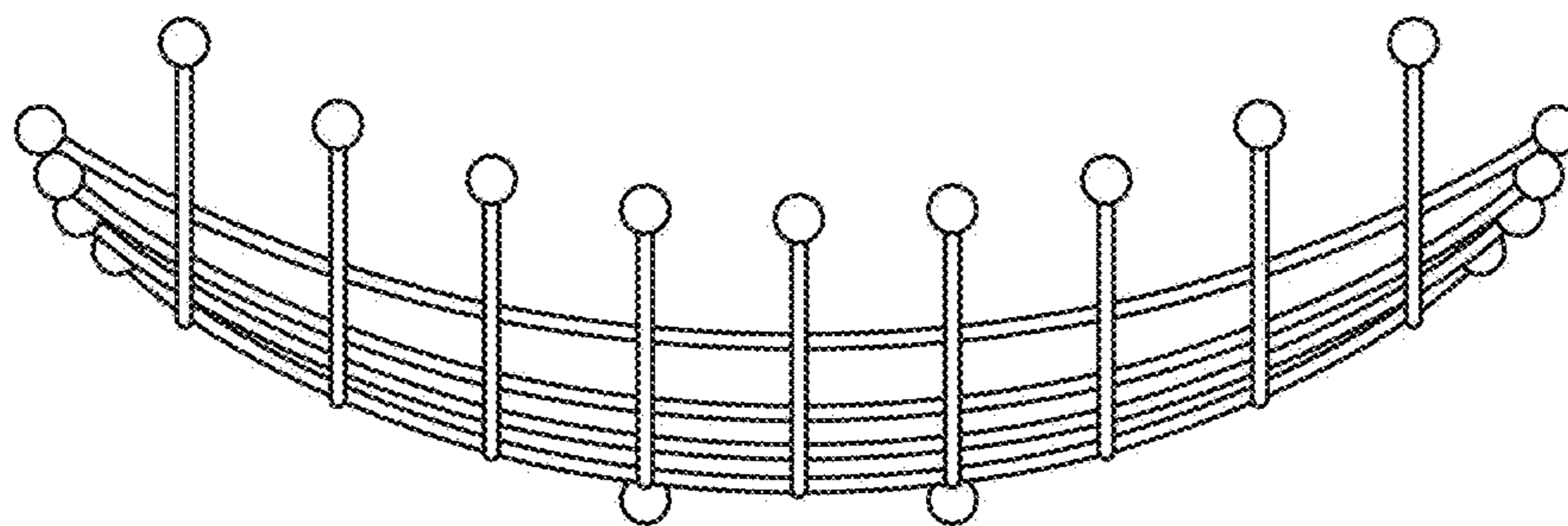

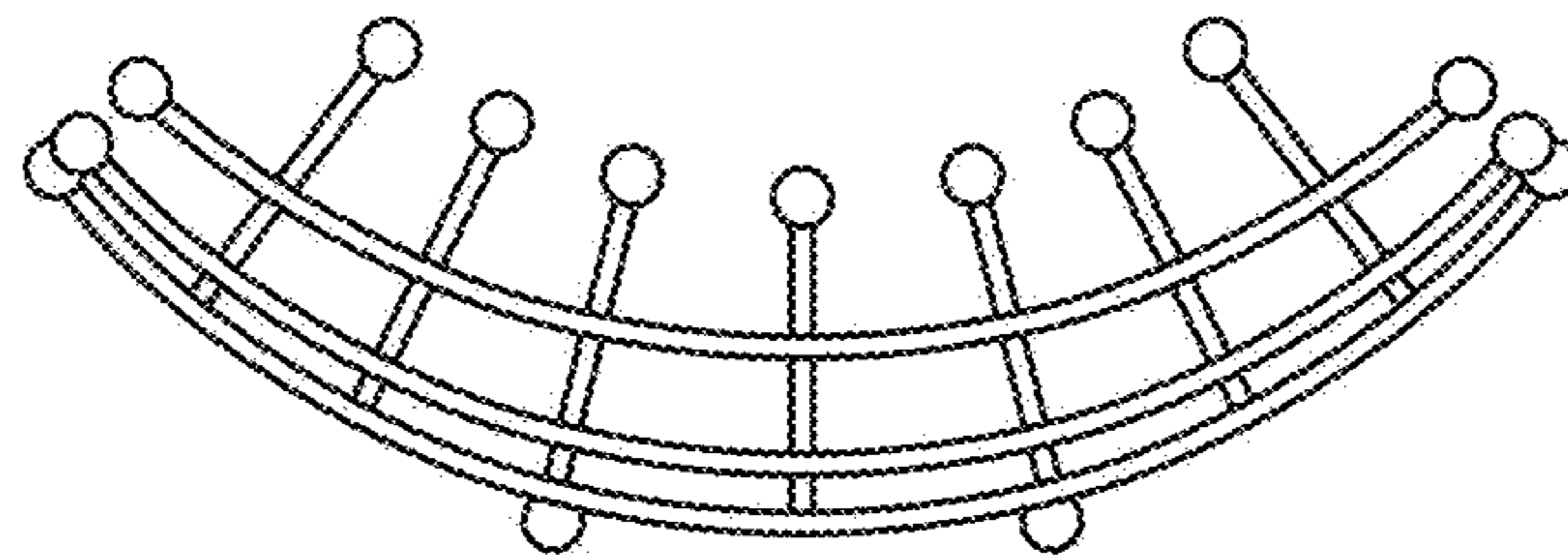

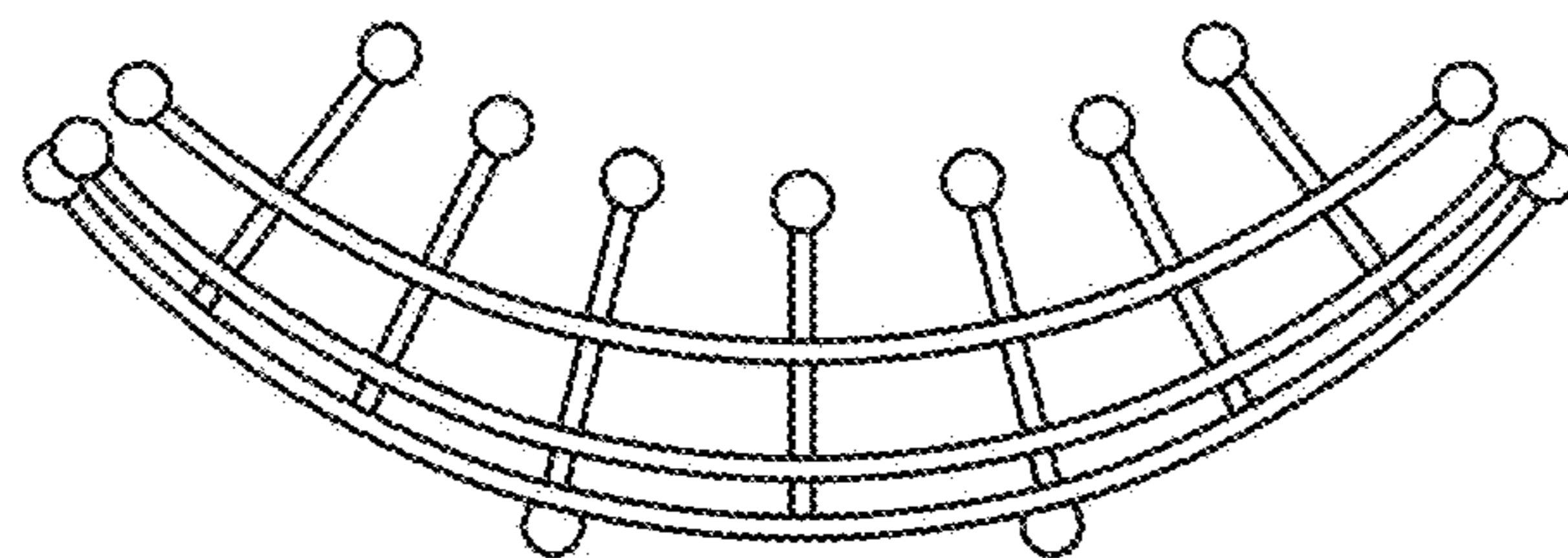
