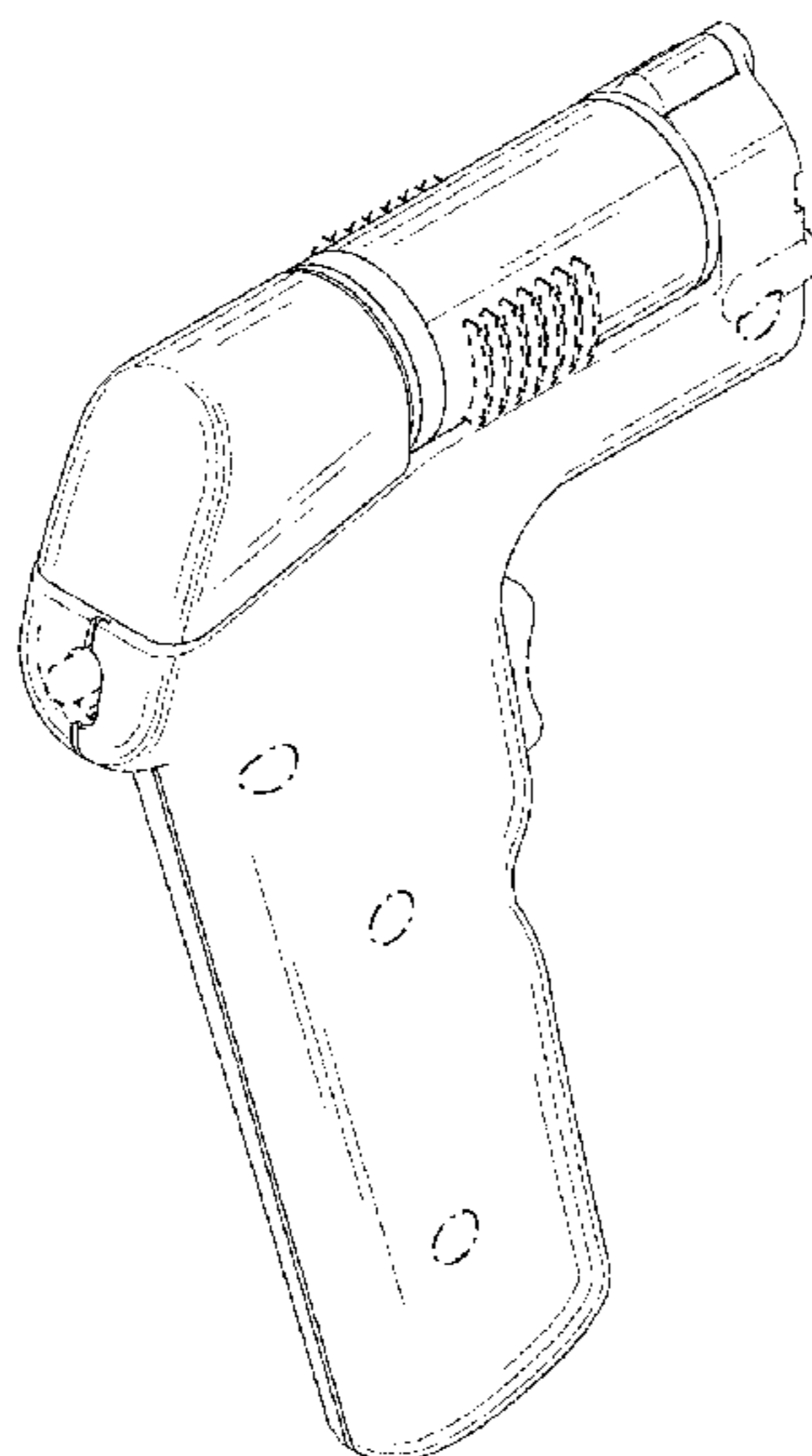

- (57) **CLAIM**  
The ornamental design for a grip for desoldering tool, as shown and described.

**DESCRIPTION**

FIG. 1 is a first perspective view of a grip for desoldering tool;  
FIG. 2 is a second perspective view thereof;  
FIG. 3 is a front view thereof;  
FIG. 4 is a rear view thereof;  
FIG. 5 is a left side view thereof;  
FIG. 6 is a right side view thereof;  
FIG. 7 is a top view thereof; and,  
FIG. 8 is a bottom view thereof.  
The broken lines depict portions of the grip for desoldering tool in which the design is embodied that are not considered part of the claimed design.

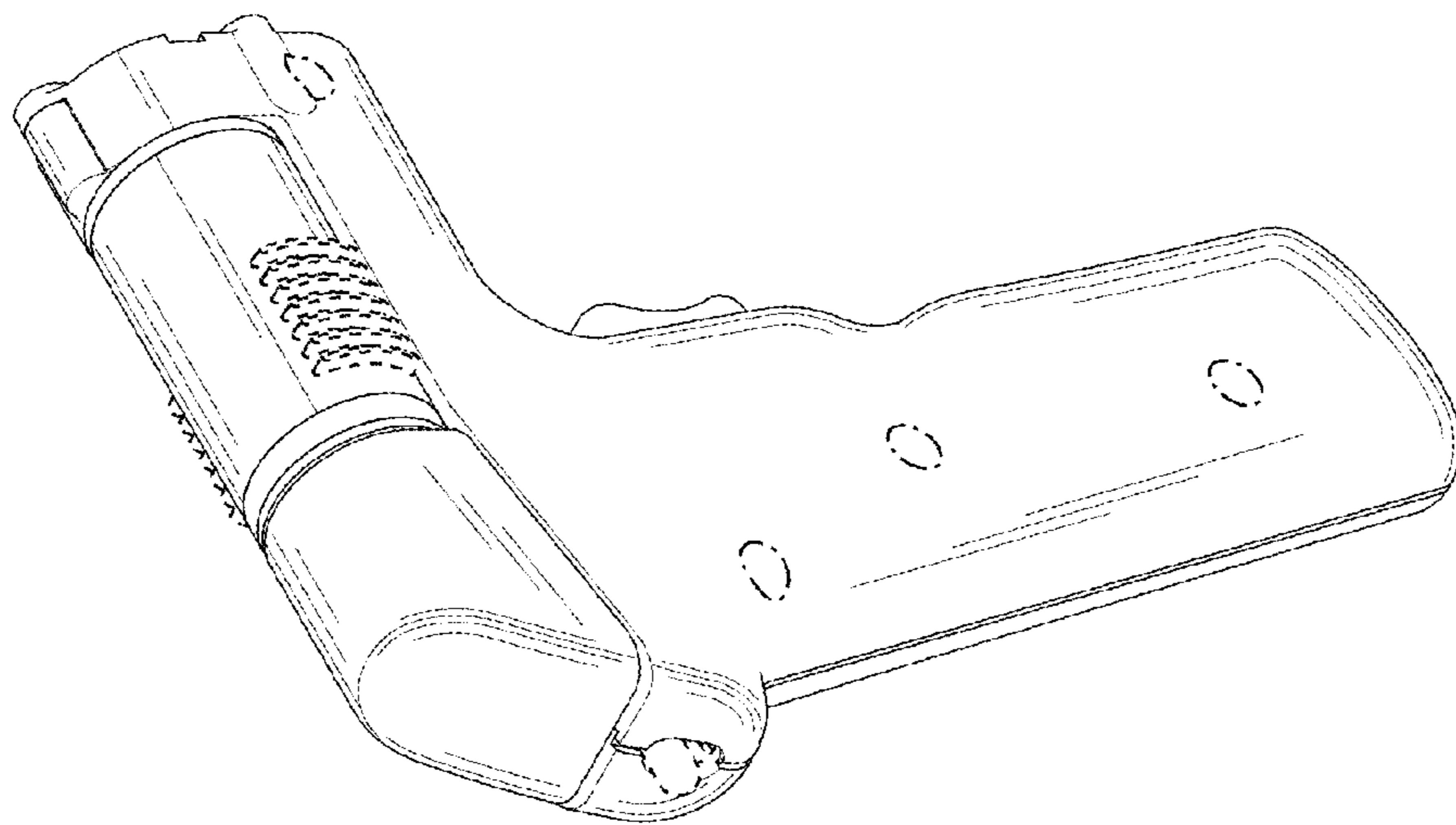

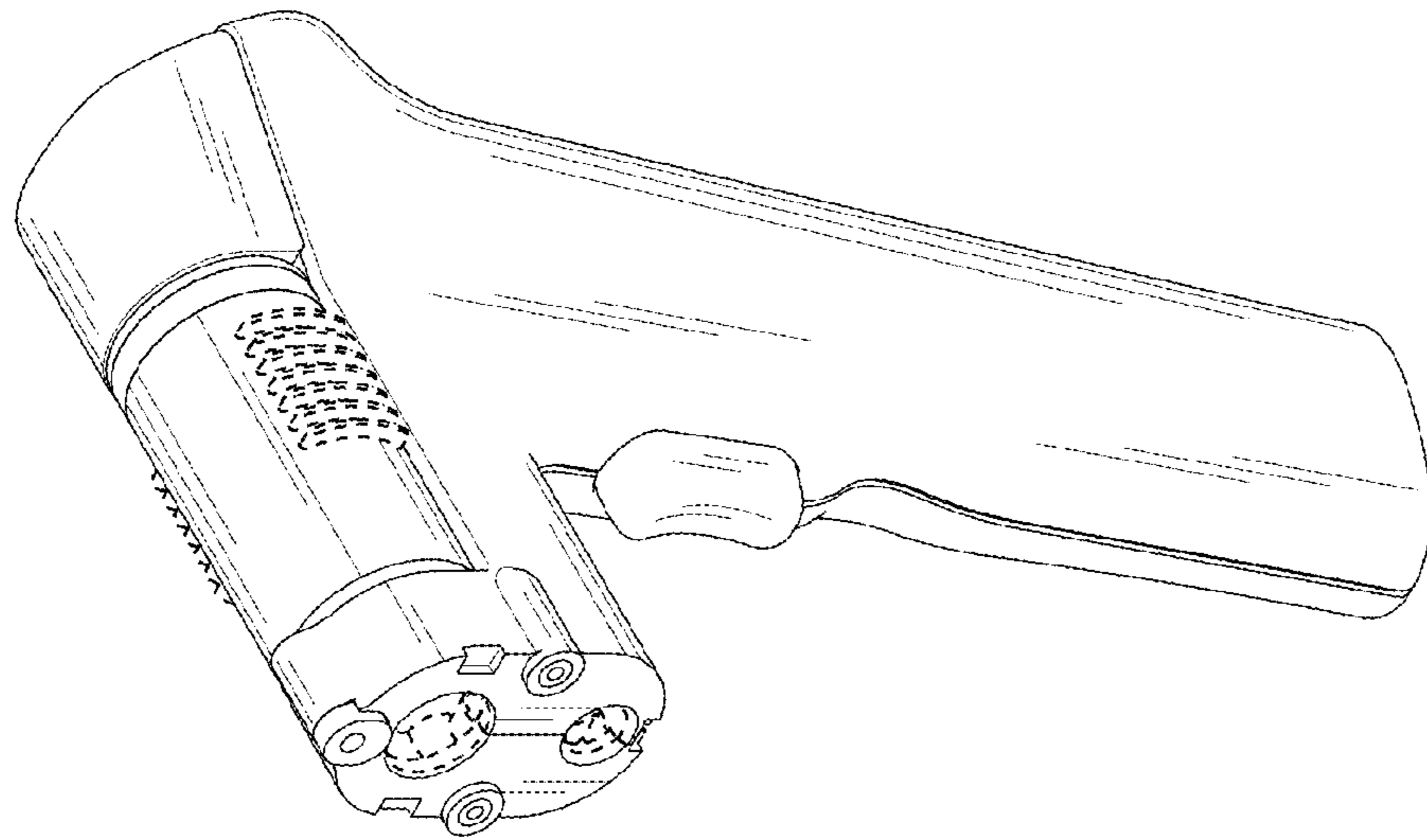

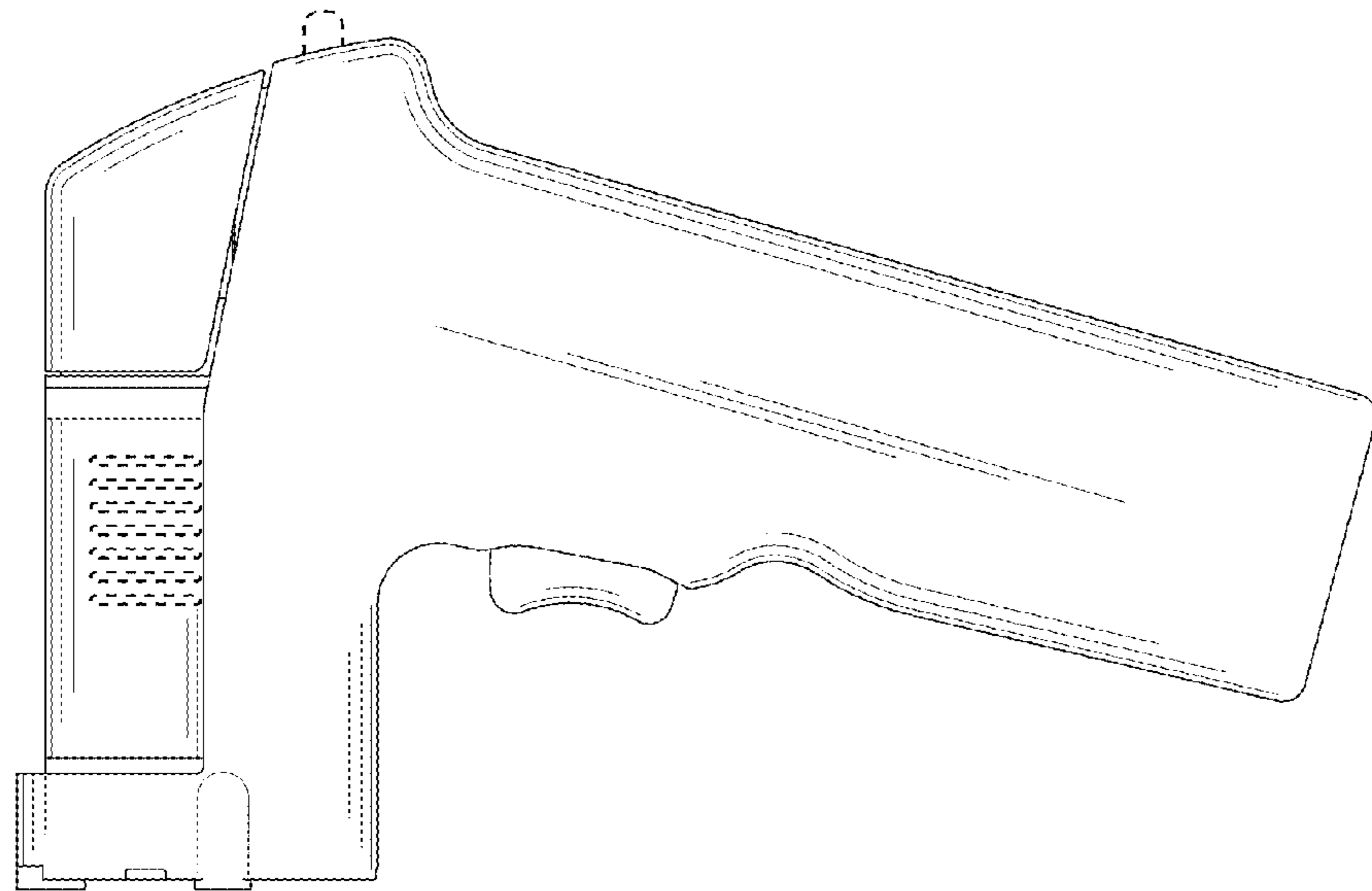

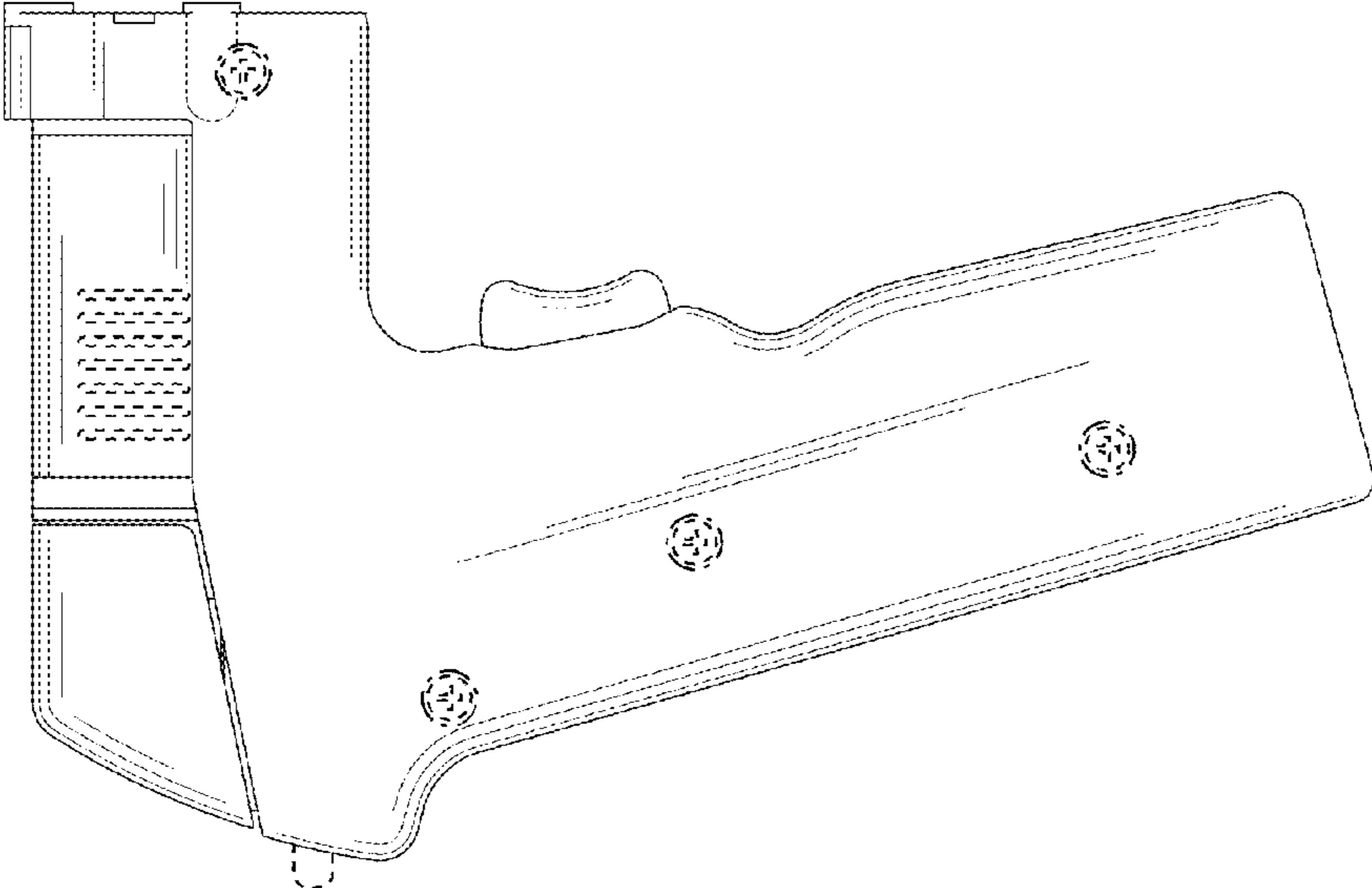

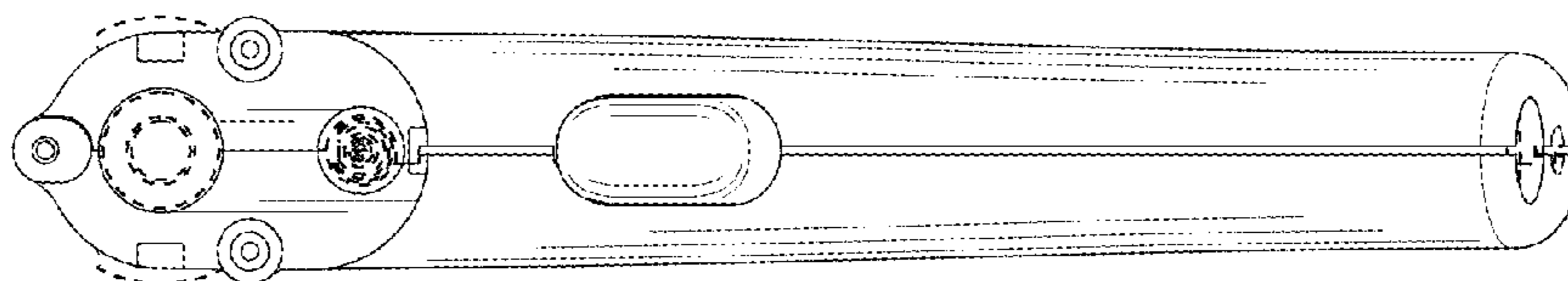

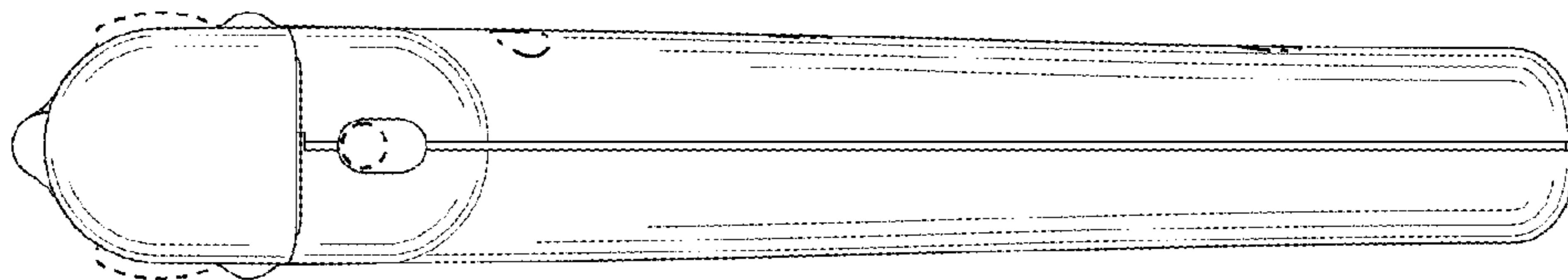

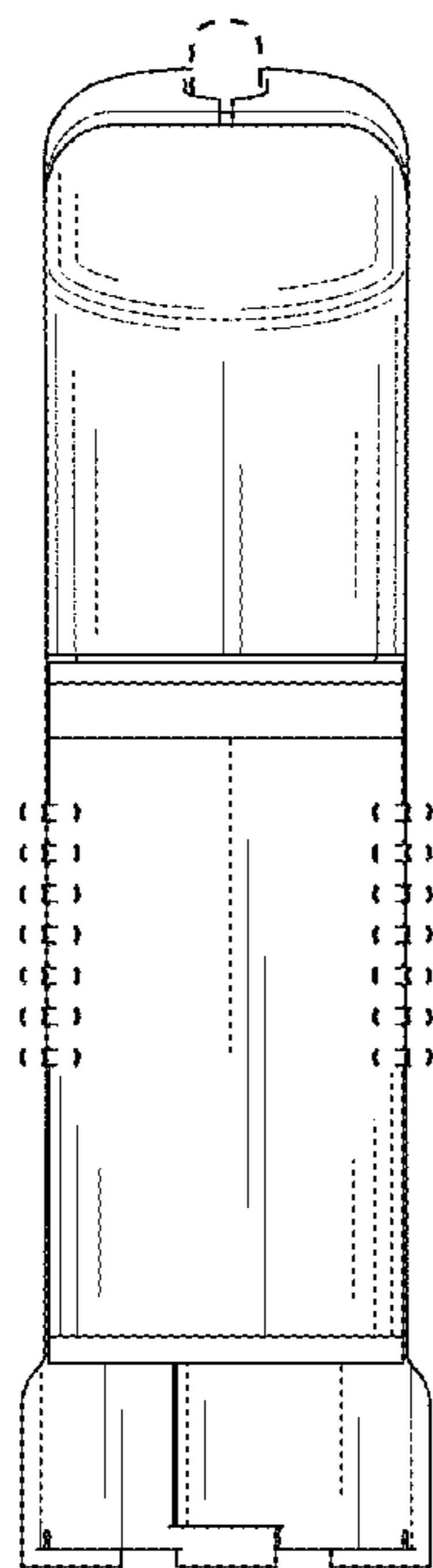

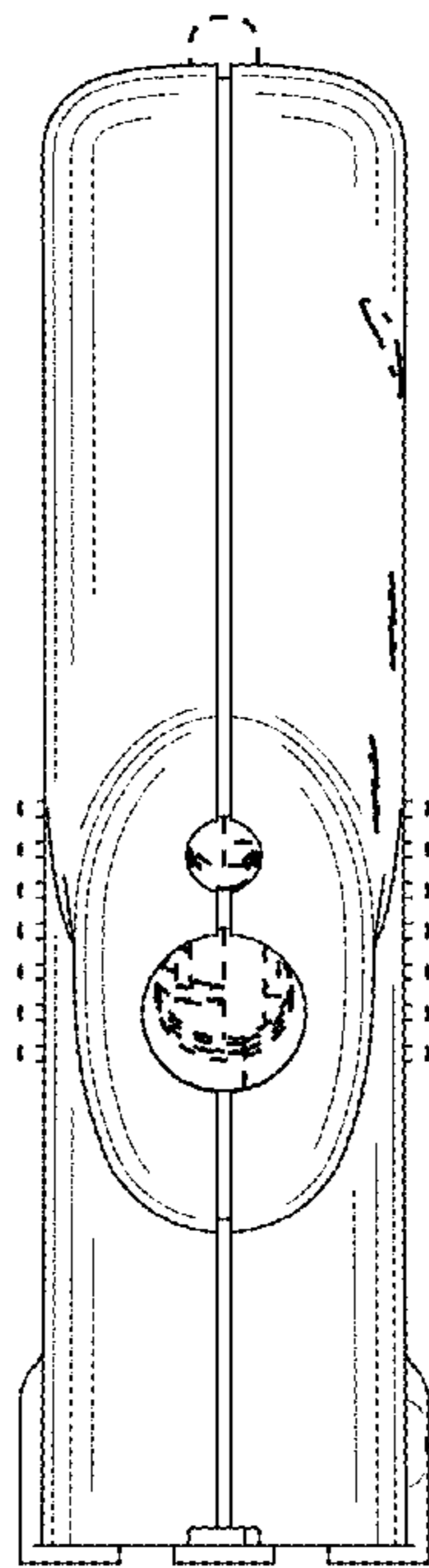
