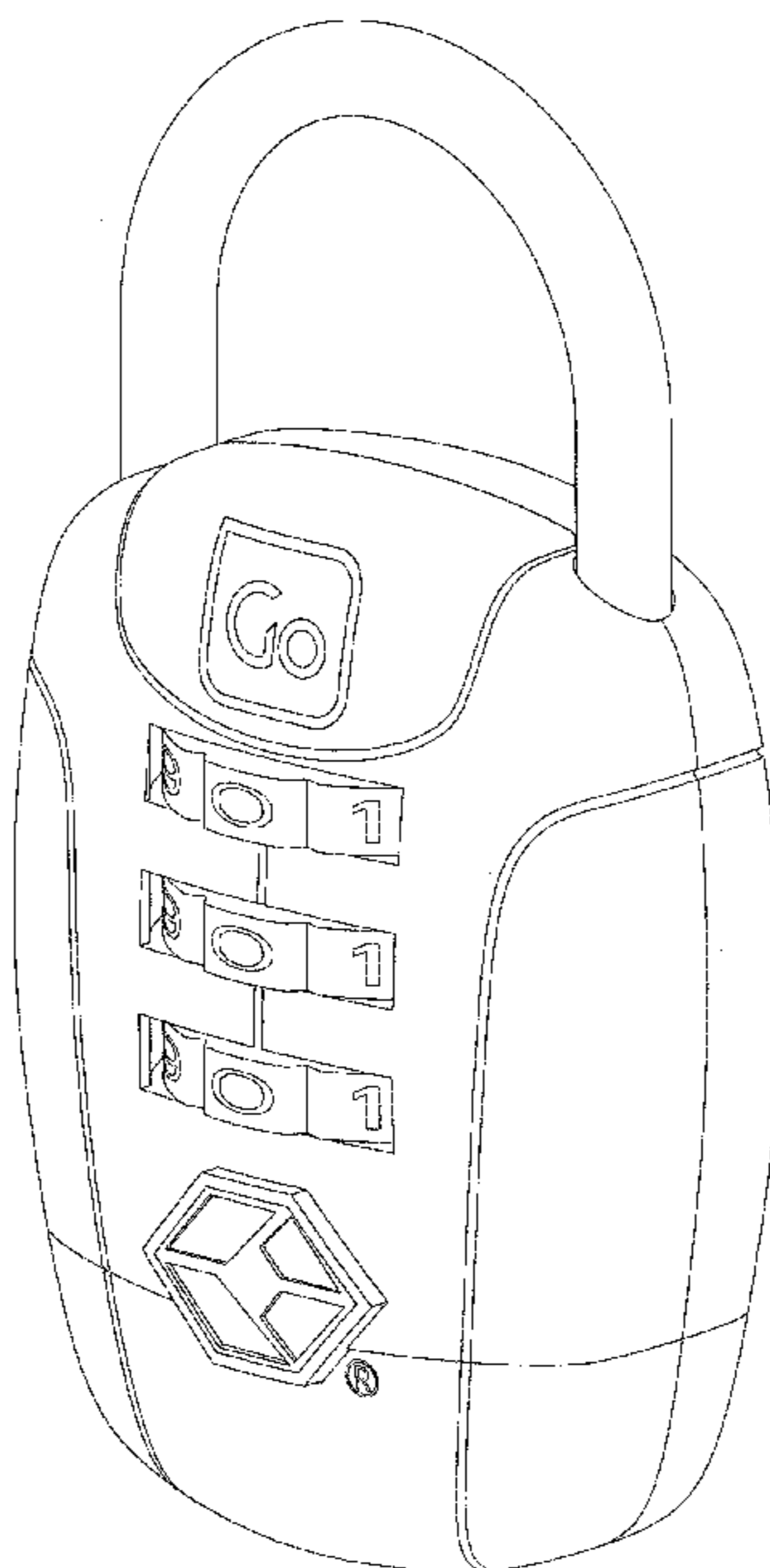
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front side view of the padlock.

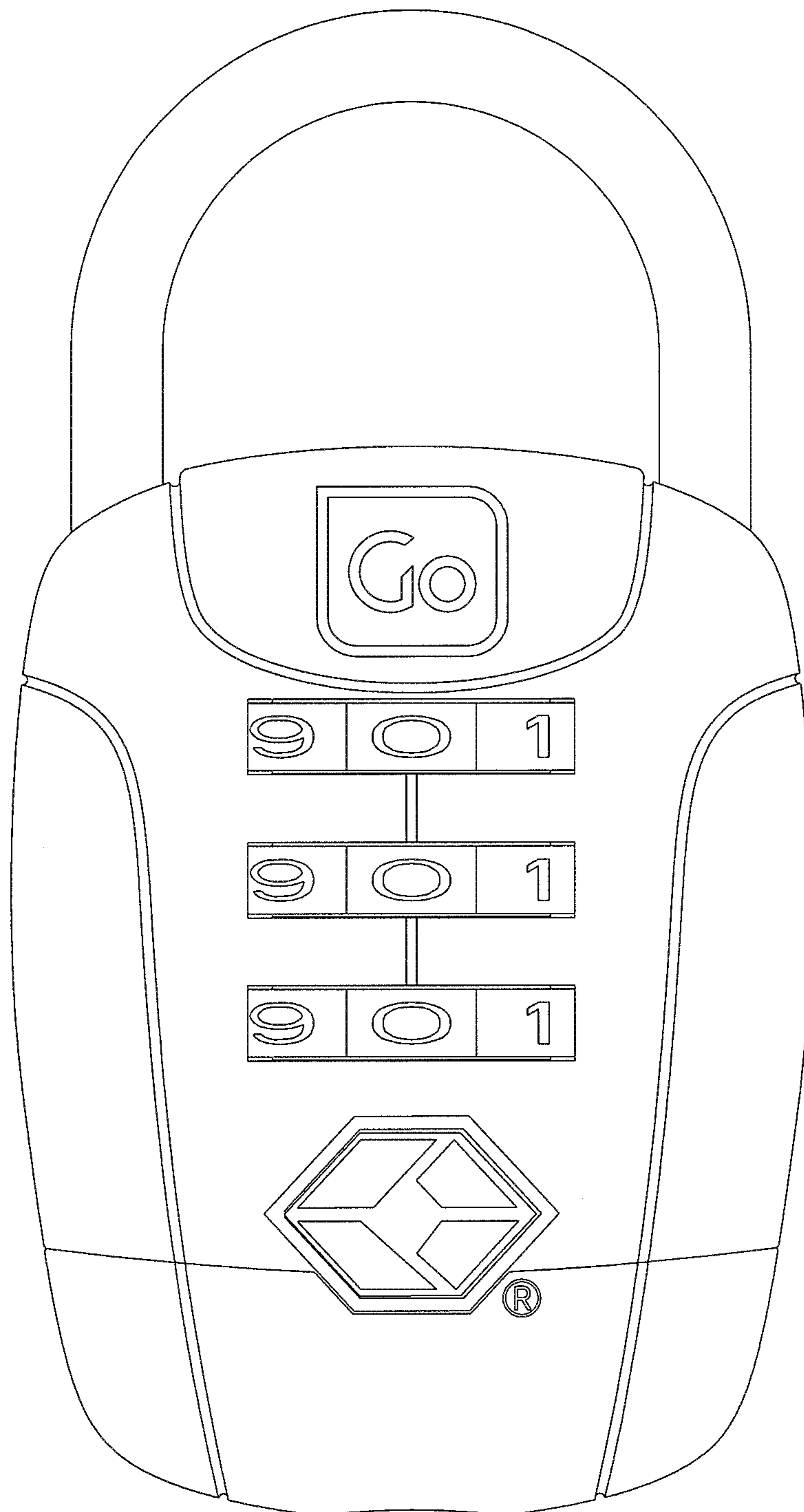

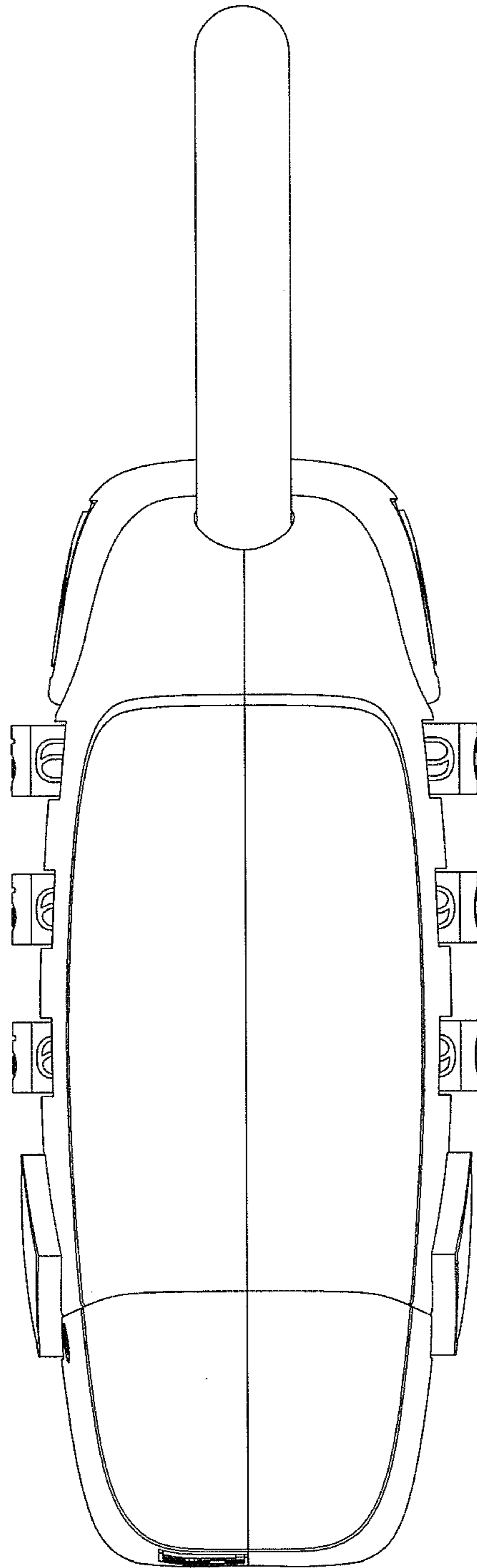

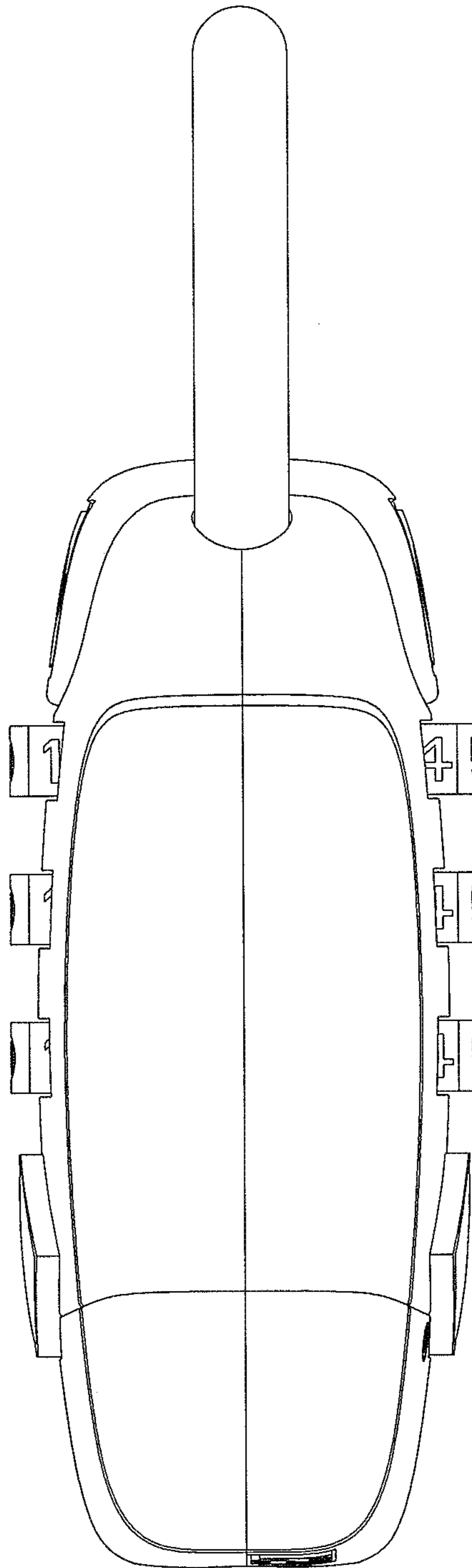

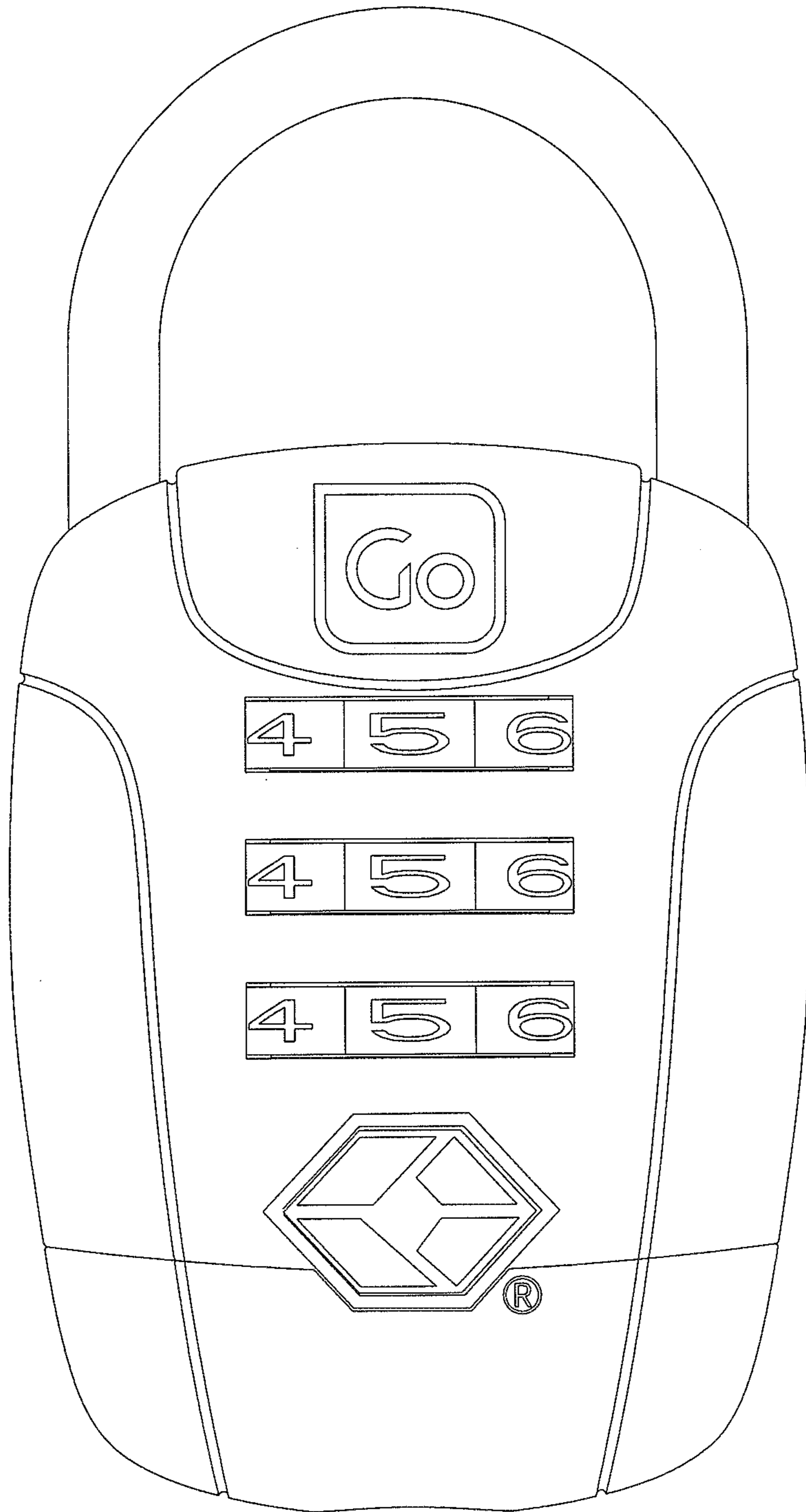

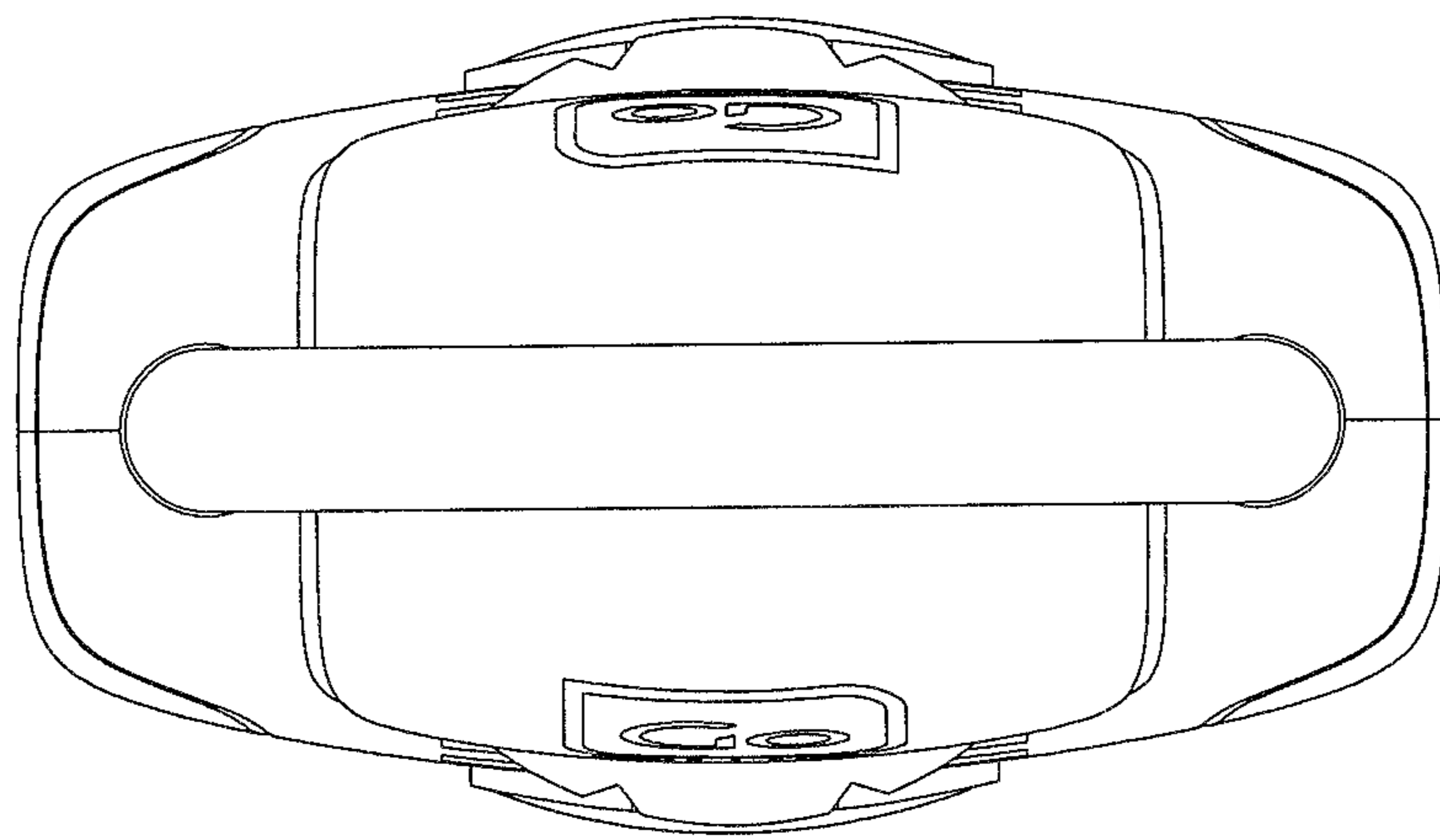

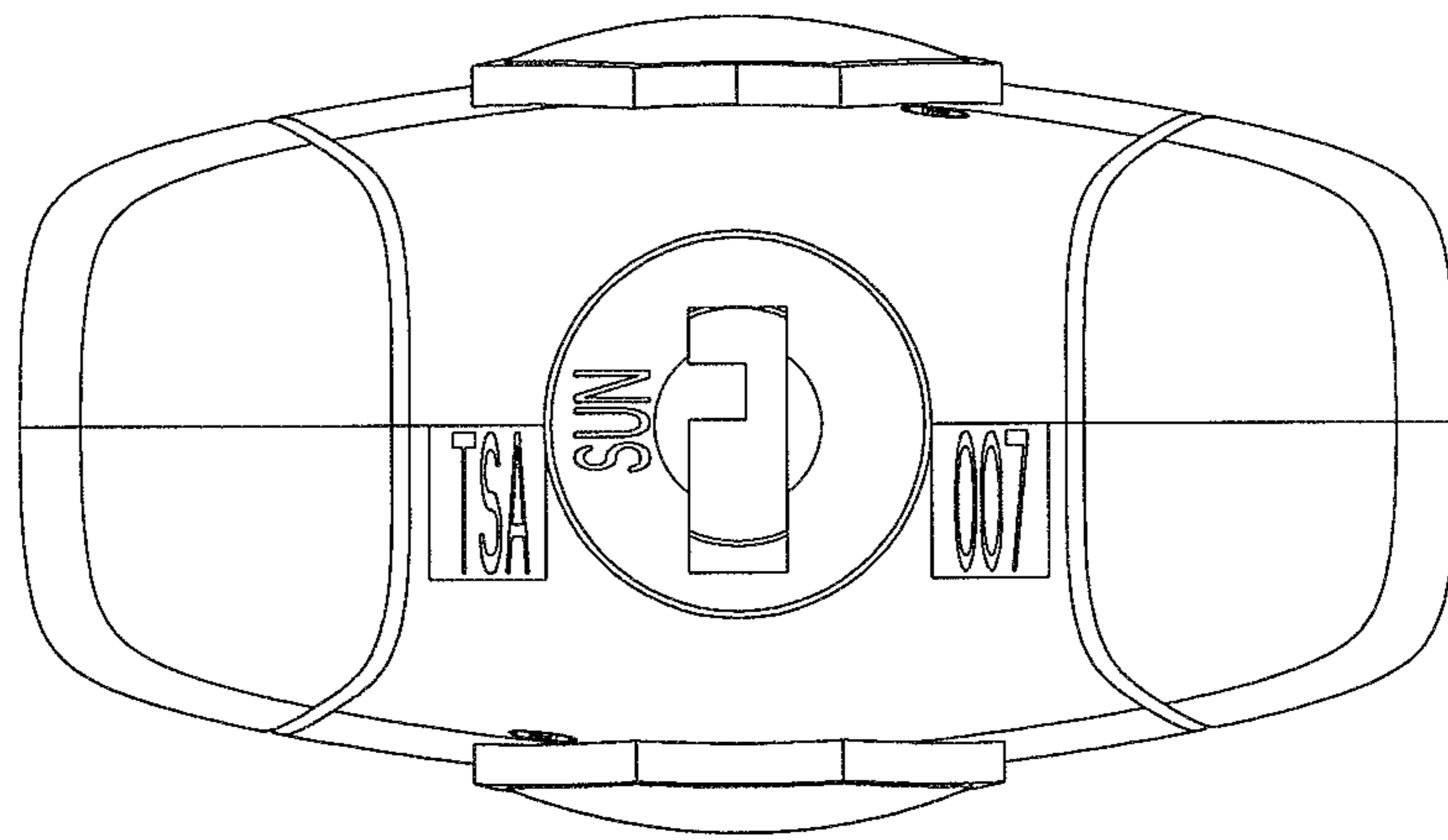

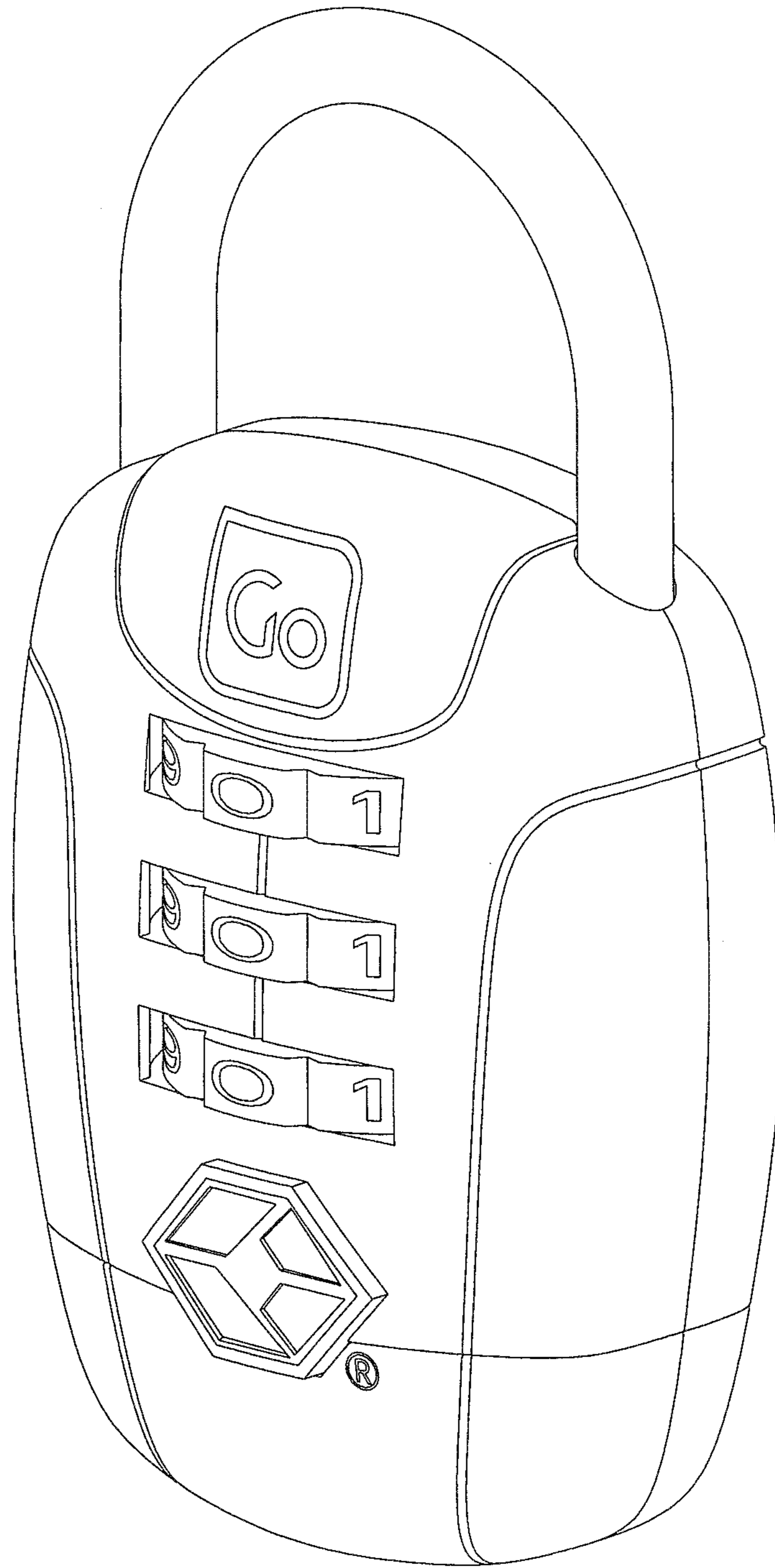

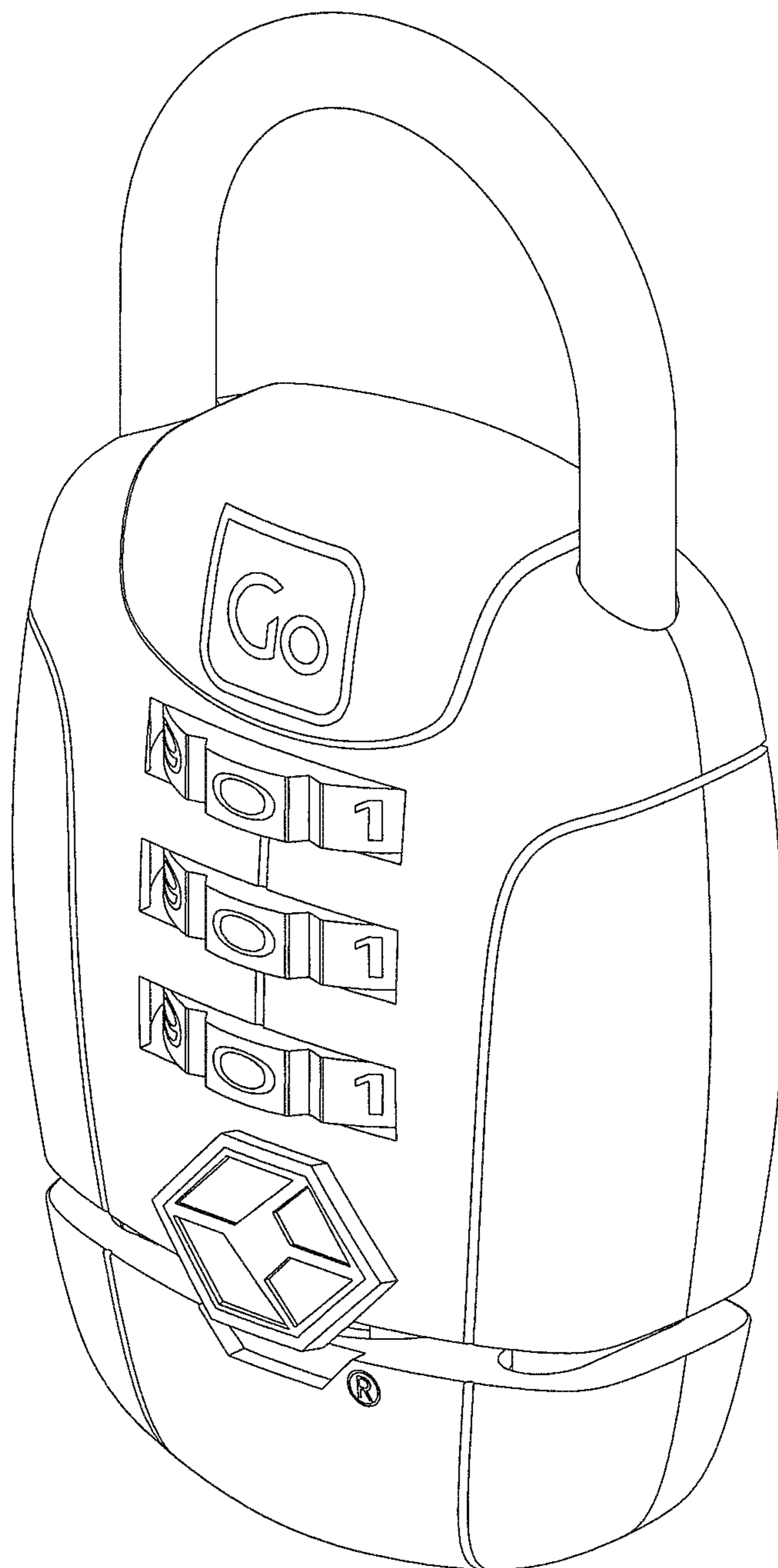

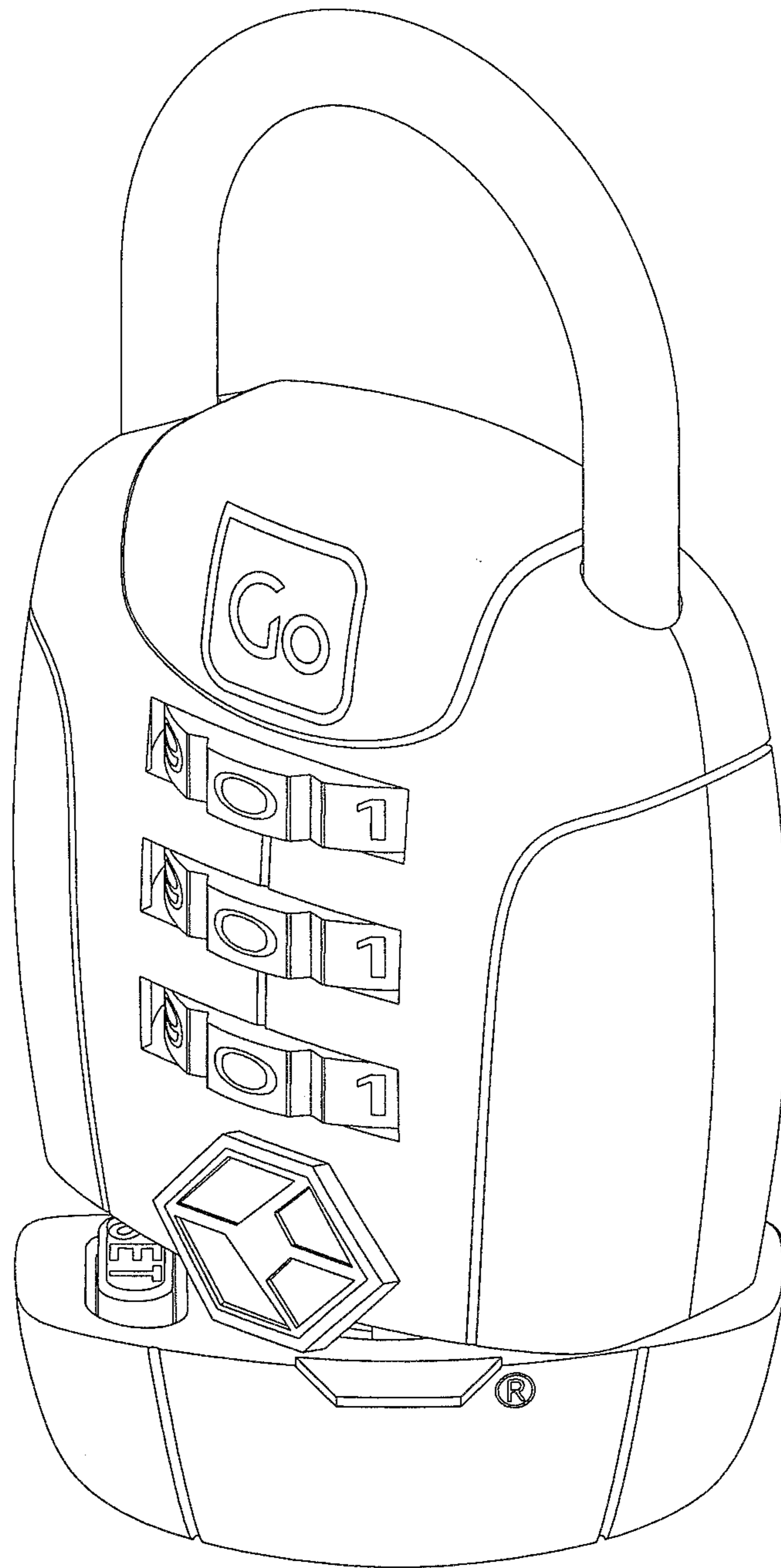

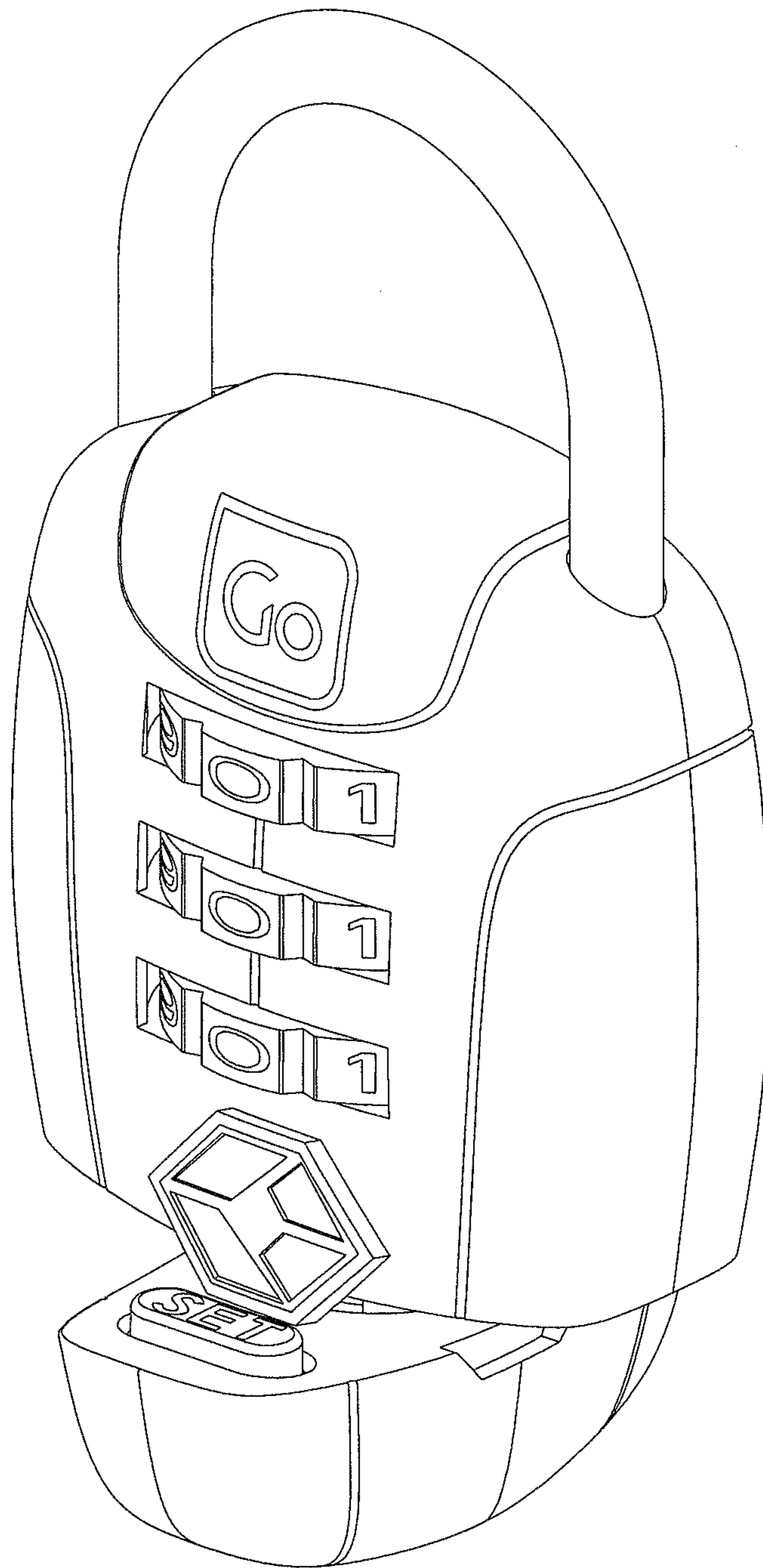
