(57) **CLAIM**

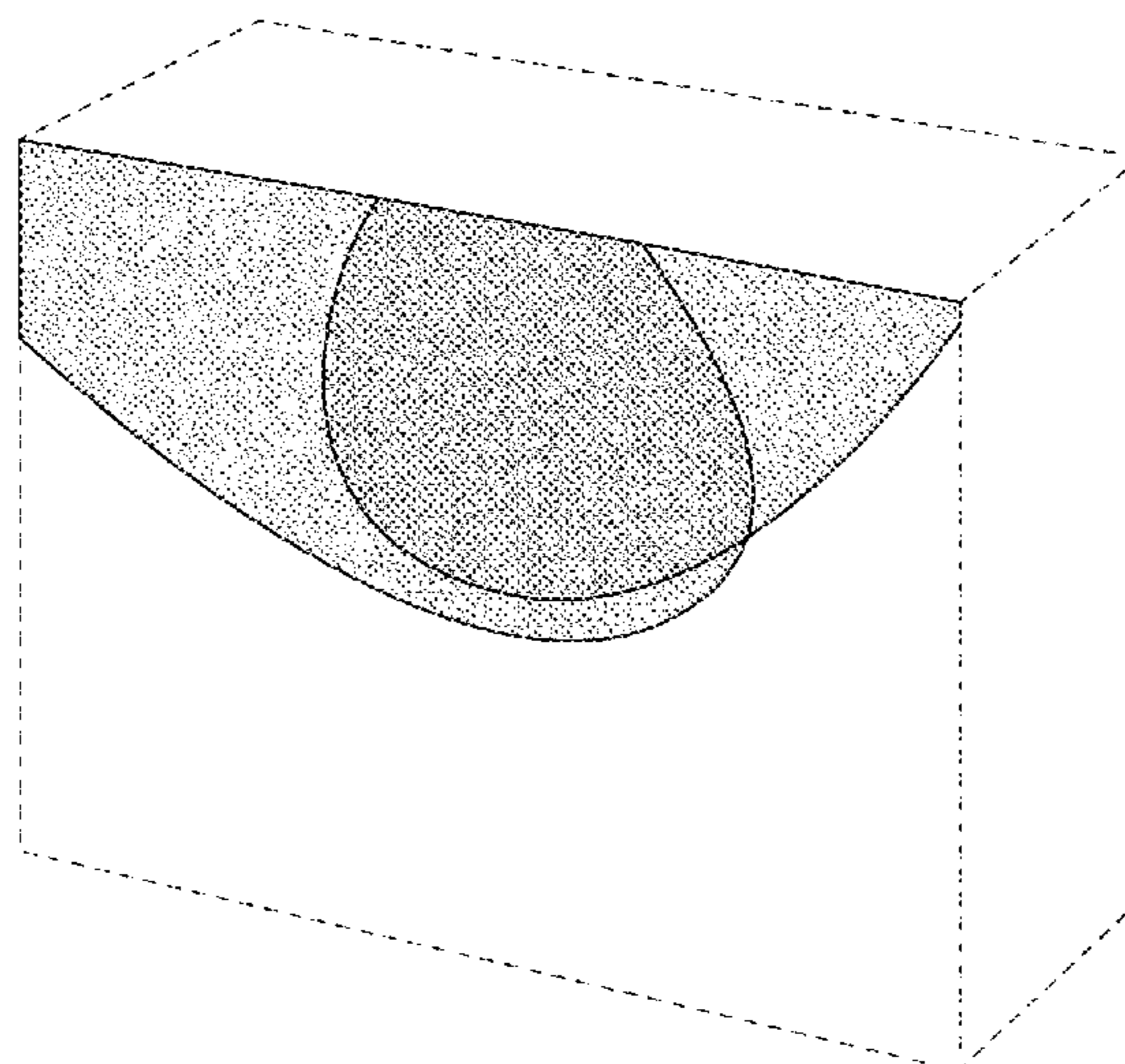
The ornamental design for a package with surface ornamentation, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a package with surface ornamentation embodying the new design as shown, wherein the grayscale shaded regions are regions of color; FIG. 2 is a front view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a back view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof.

The broken lines showing portions of the package depict environment and form no part of the claimed design.

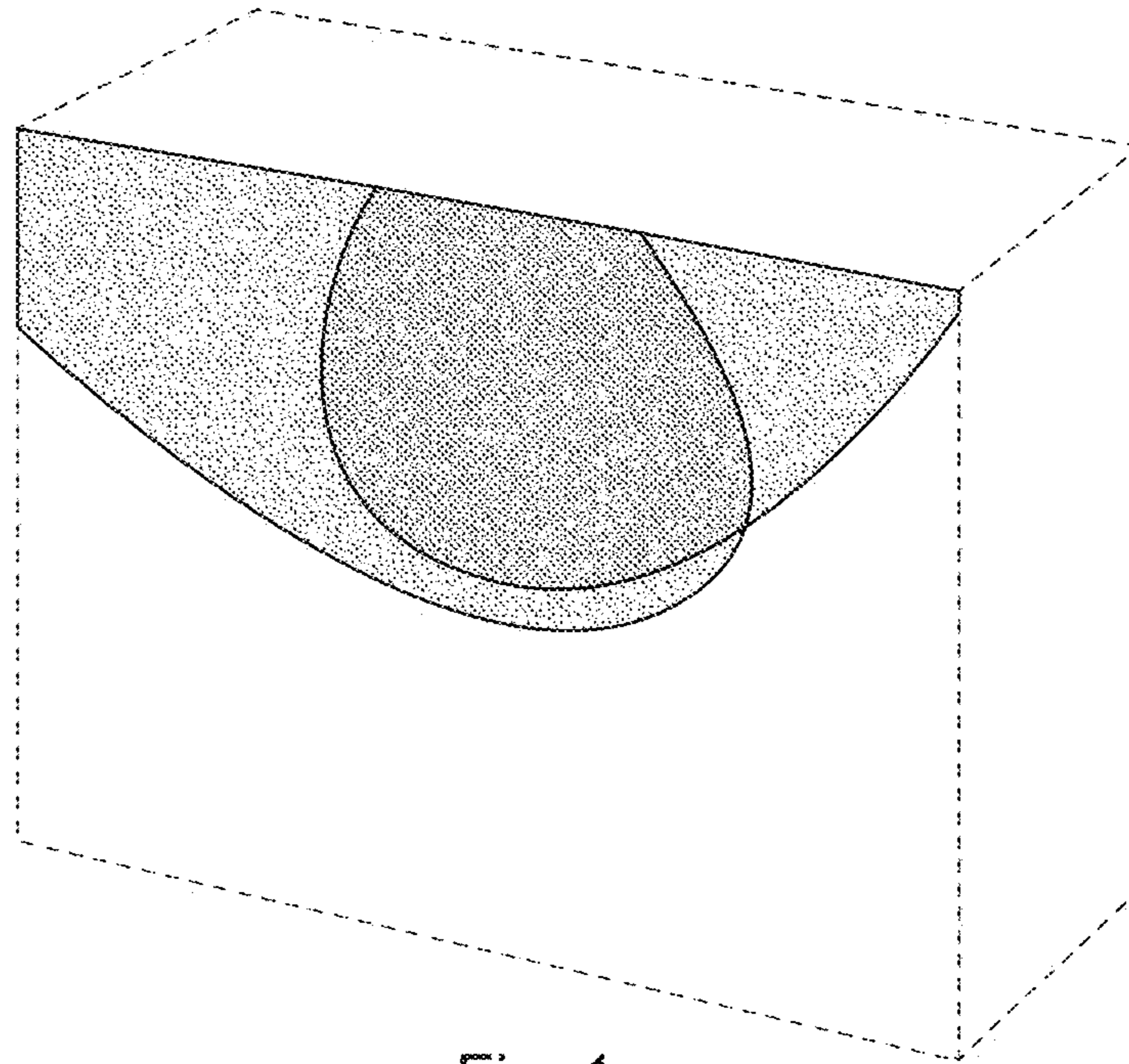

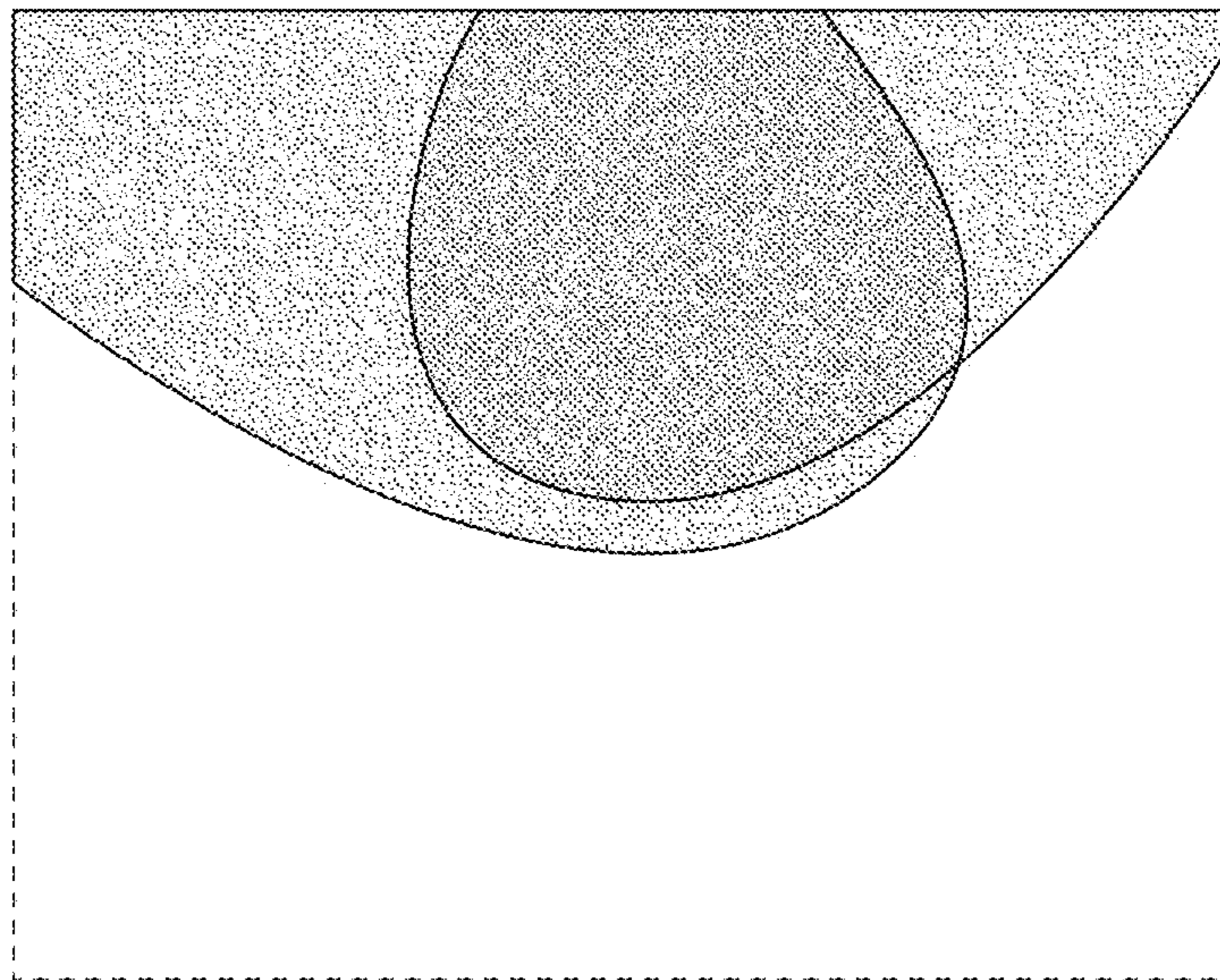

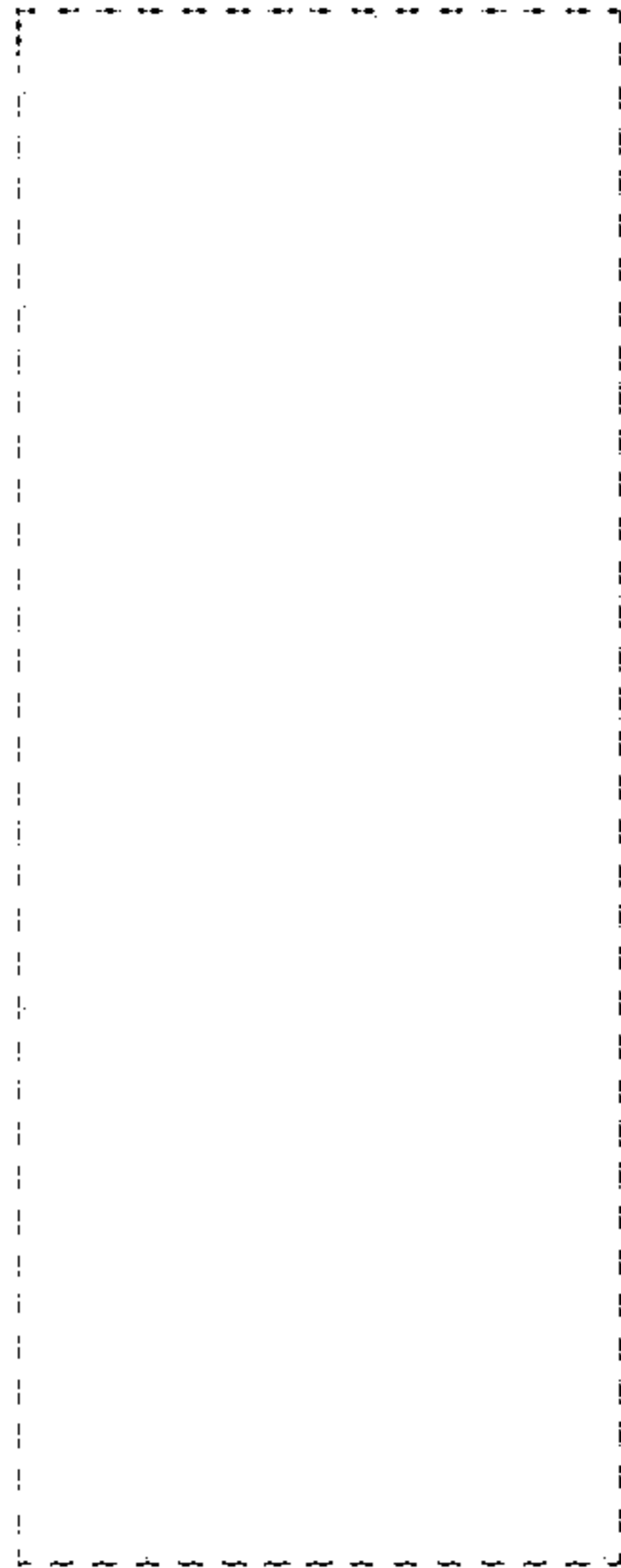

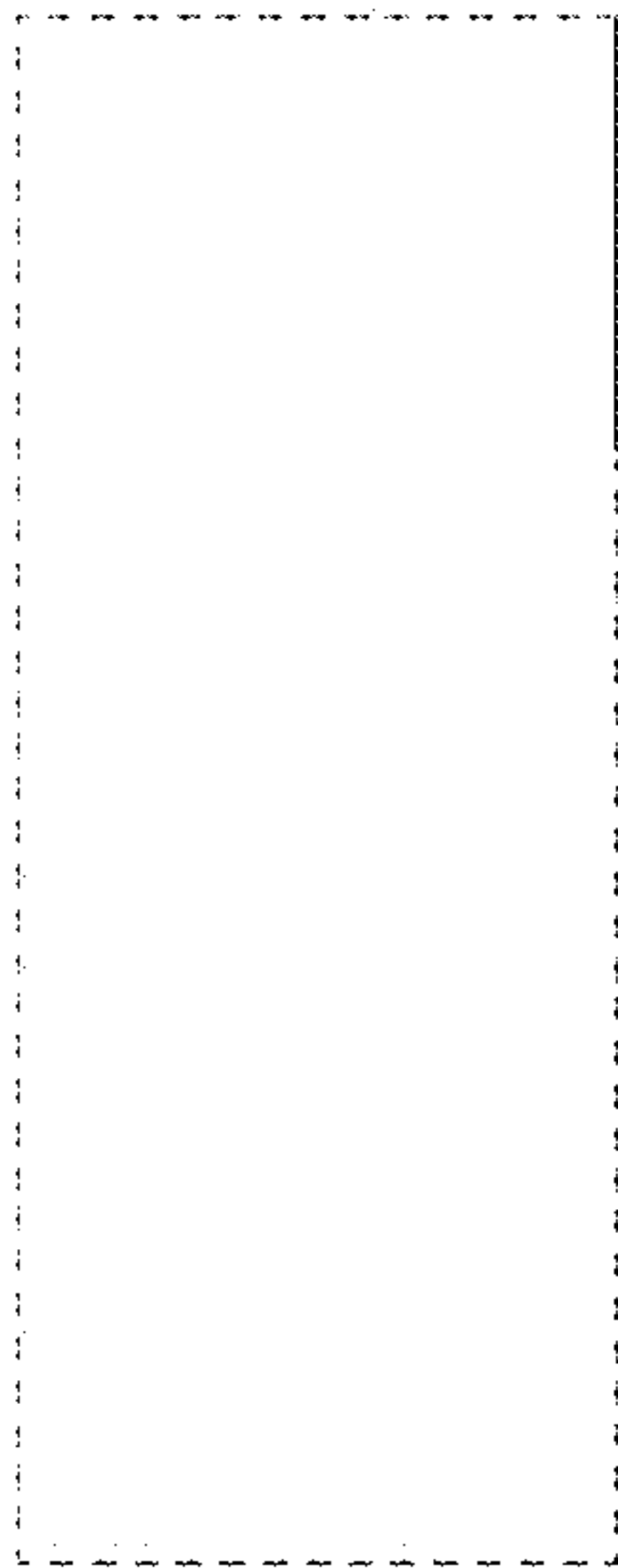
