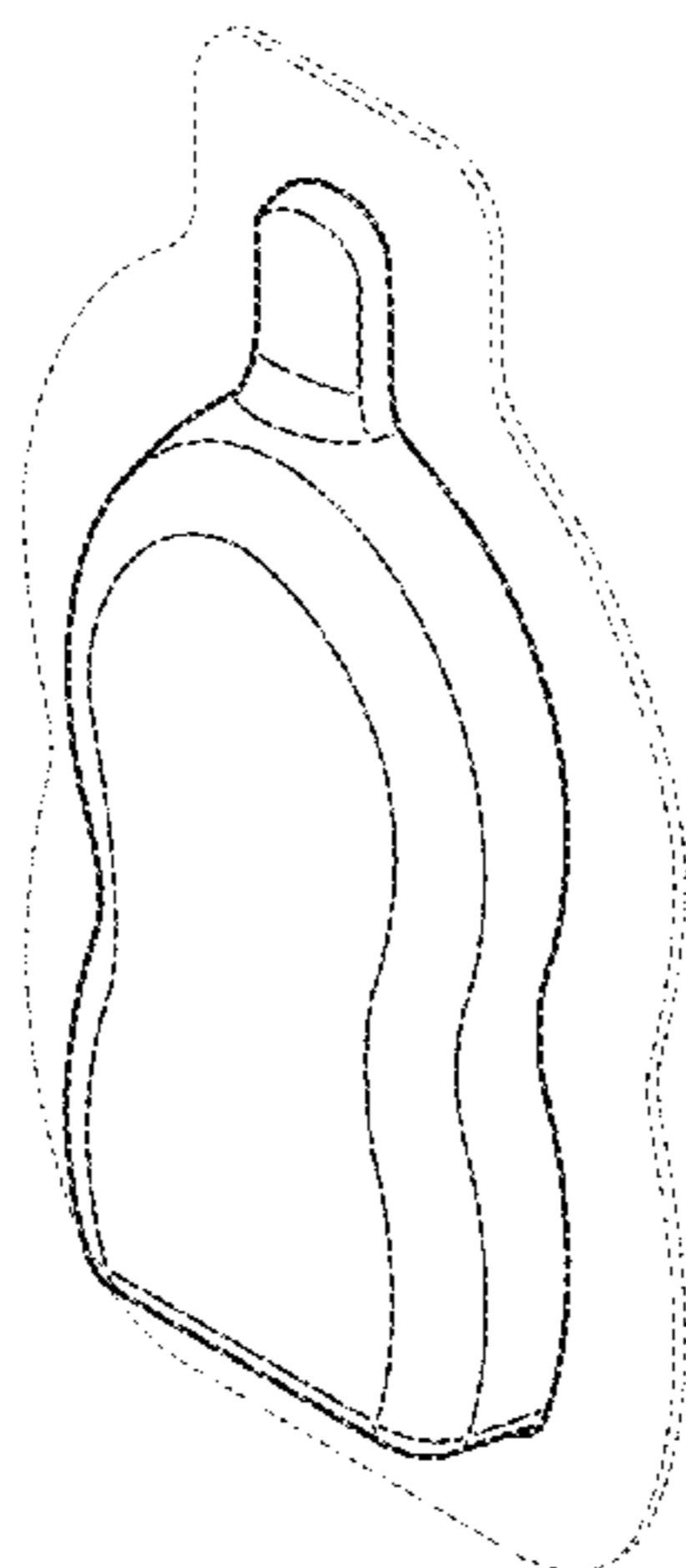

DESCRIPTION

FIG. 1 is a perspective view of a blister package in accordance with my design;

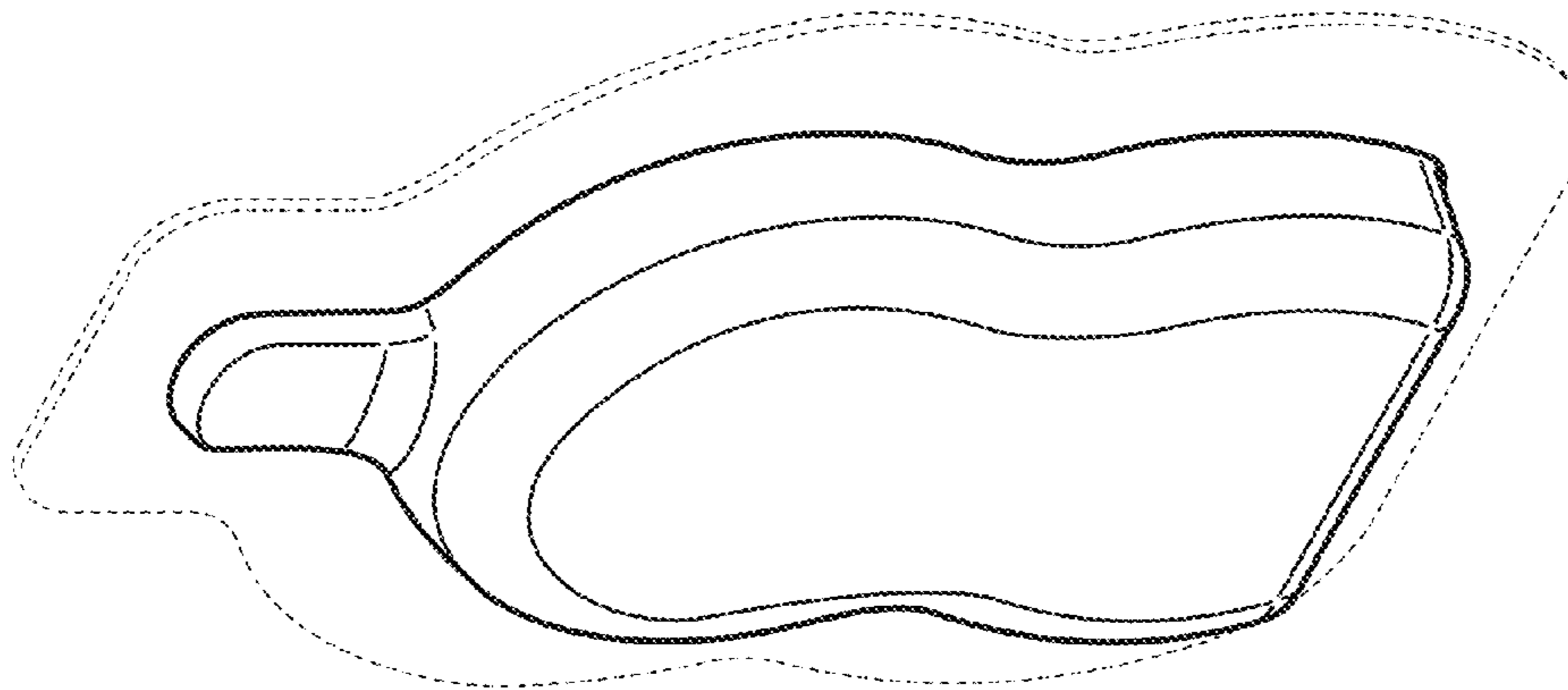

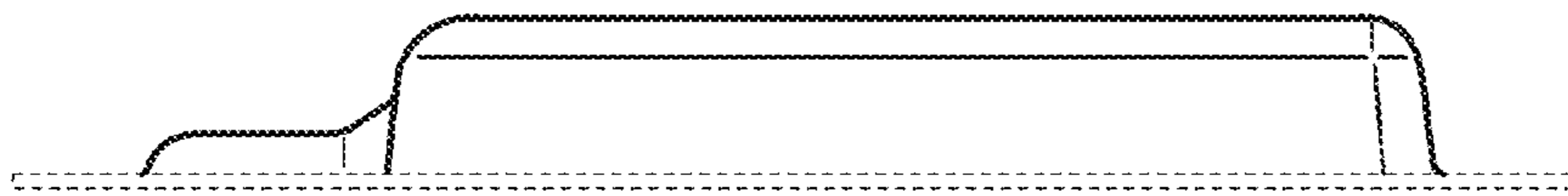

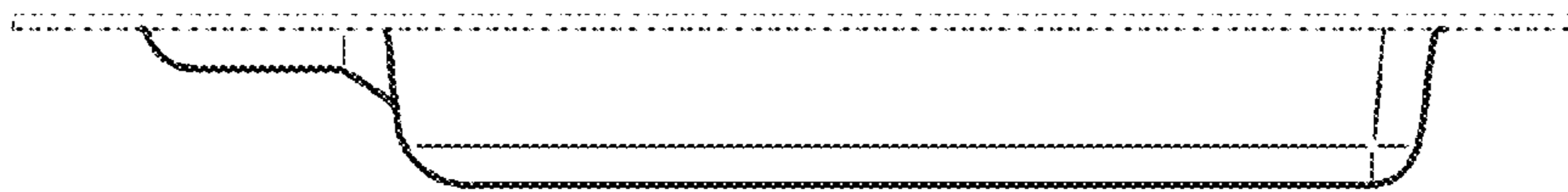

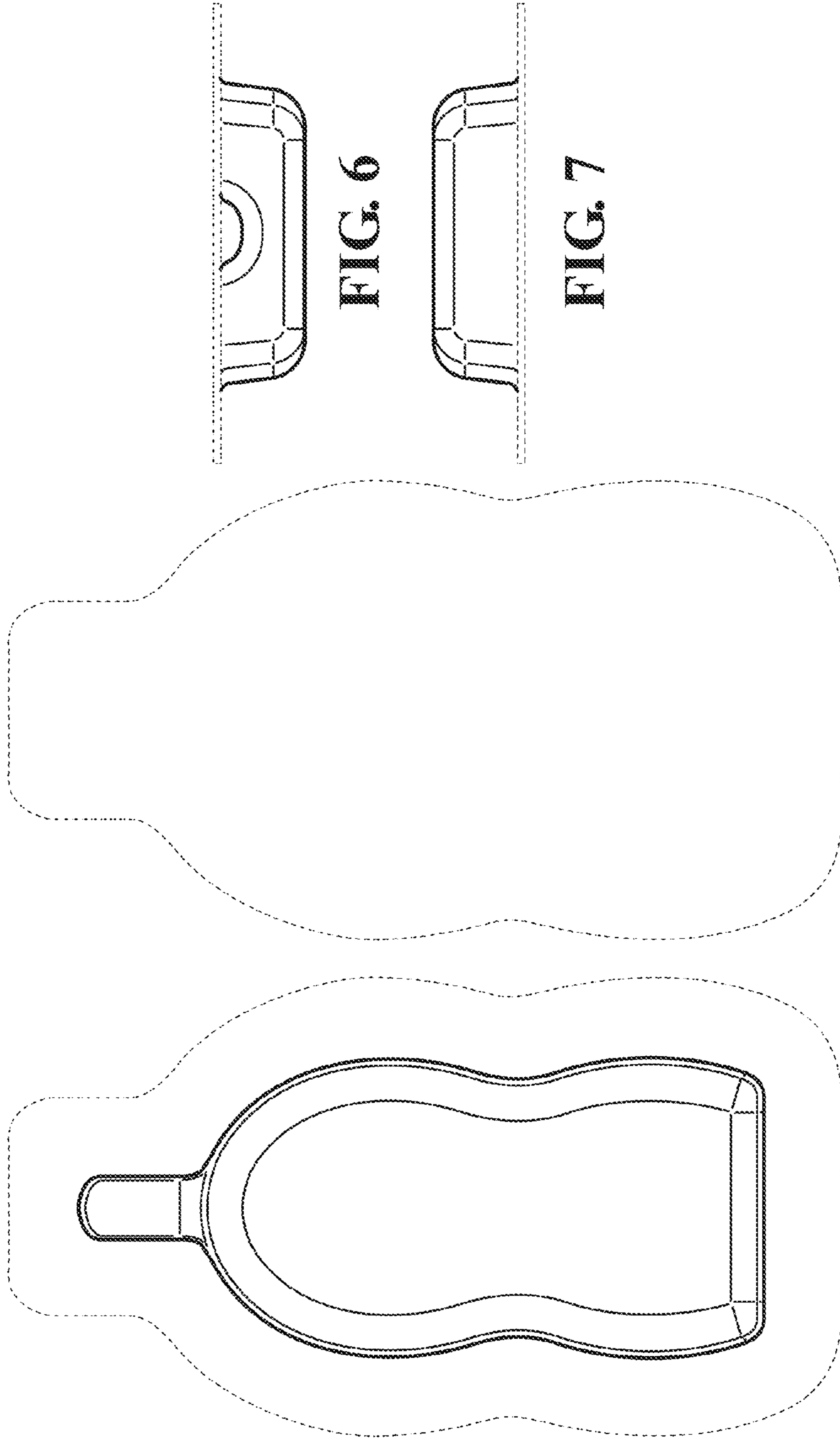

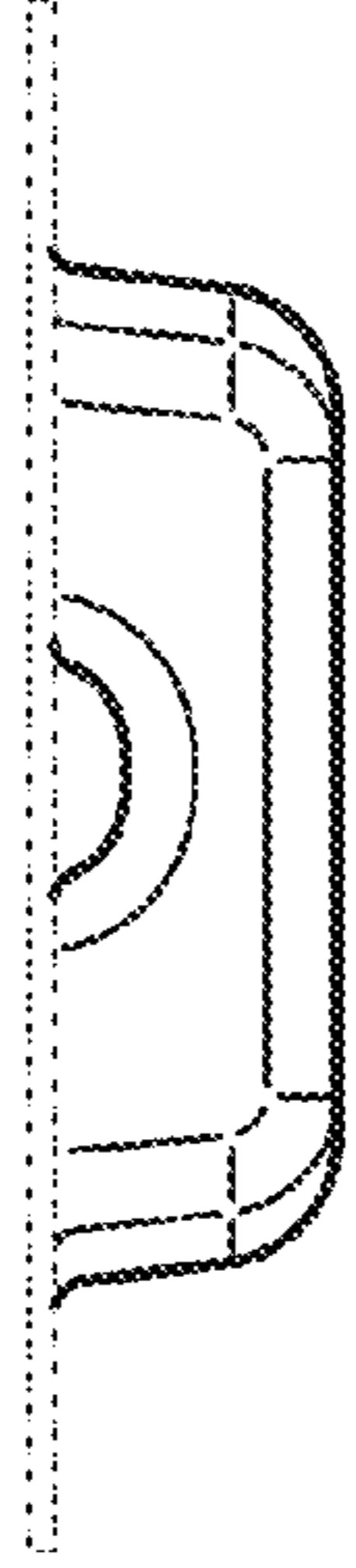

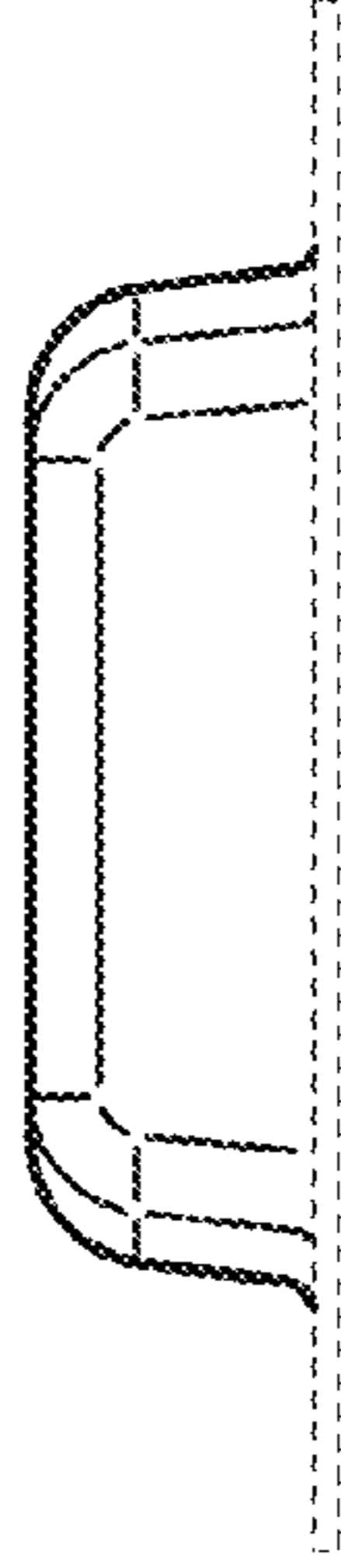
