The ornamental design for an airline tray hanger, as shown
and described.

DESCRIPTION

FIG. 1 is a perspective view of an airline tray hanger
showing my design;

FIG. 2 is a left or right side view thereof;

FIG. 3 is a top view thereof;

FIG. 4 is a bottom view thereof;

FIG. 5 is a front view thereof;

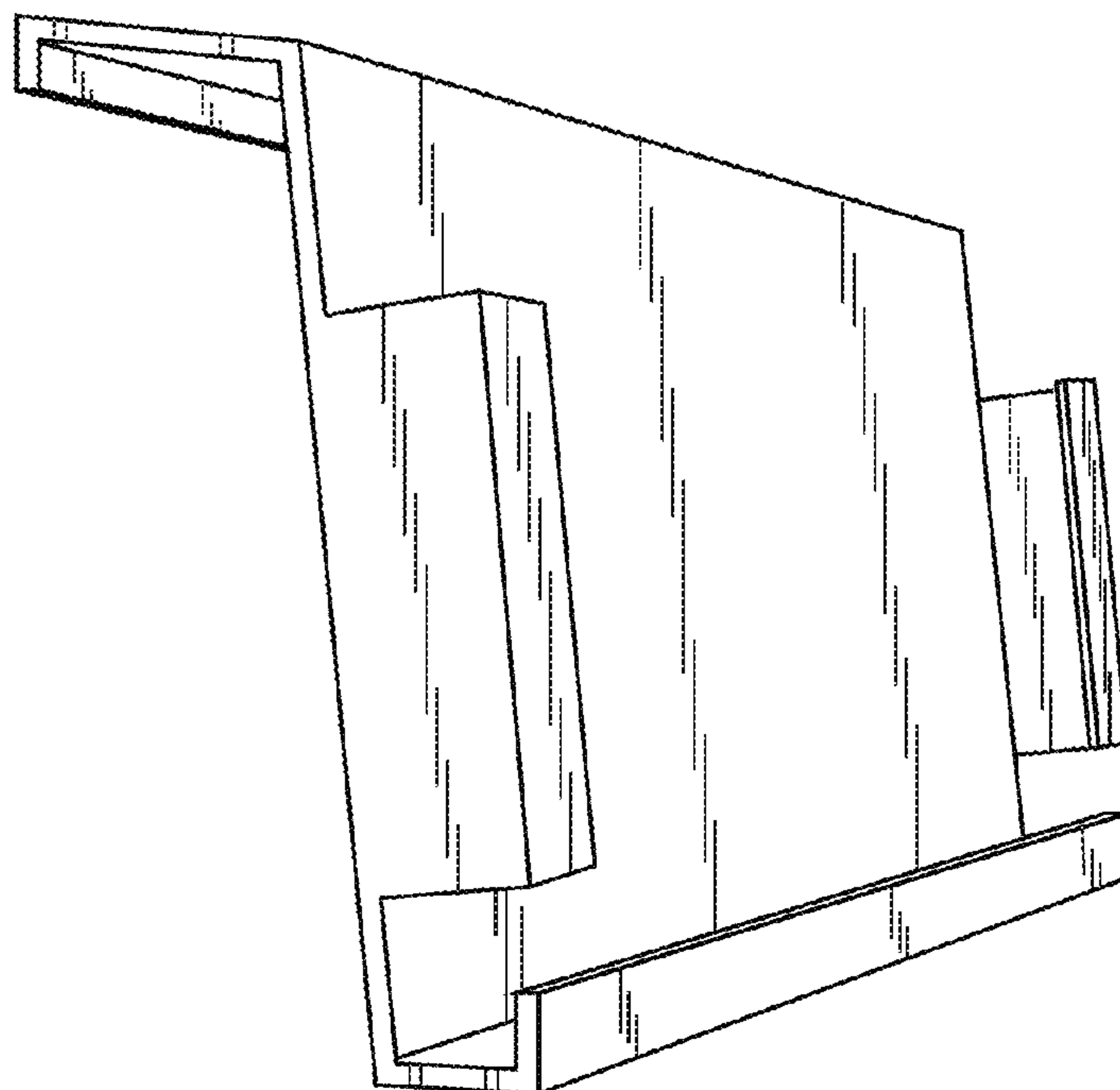
FIG. 6 is a back view thereof; and,

FIG. 7 is a perspective view of an airline seat tray shown in
the upright tray position with an airline tray hanger posi-
tioned thereon the airline seat tray holding a personal digital
device.

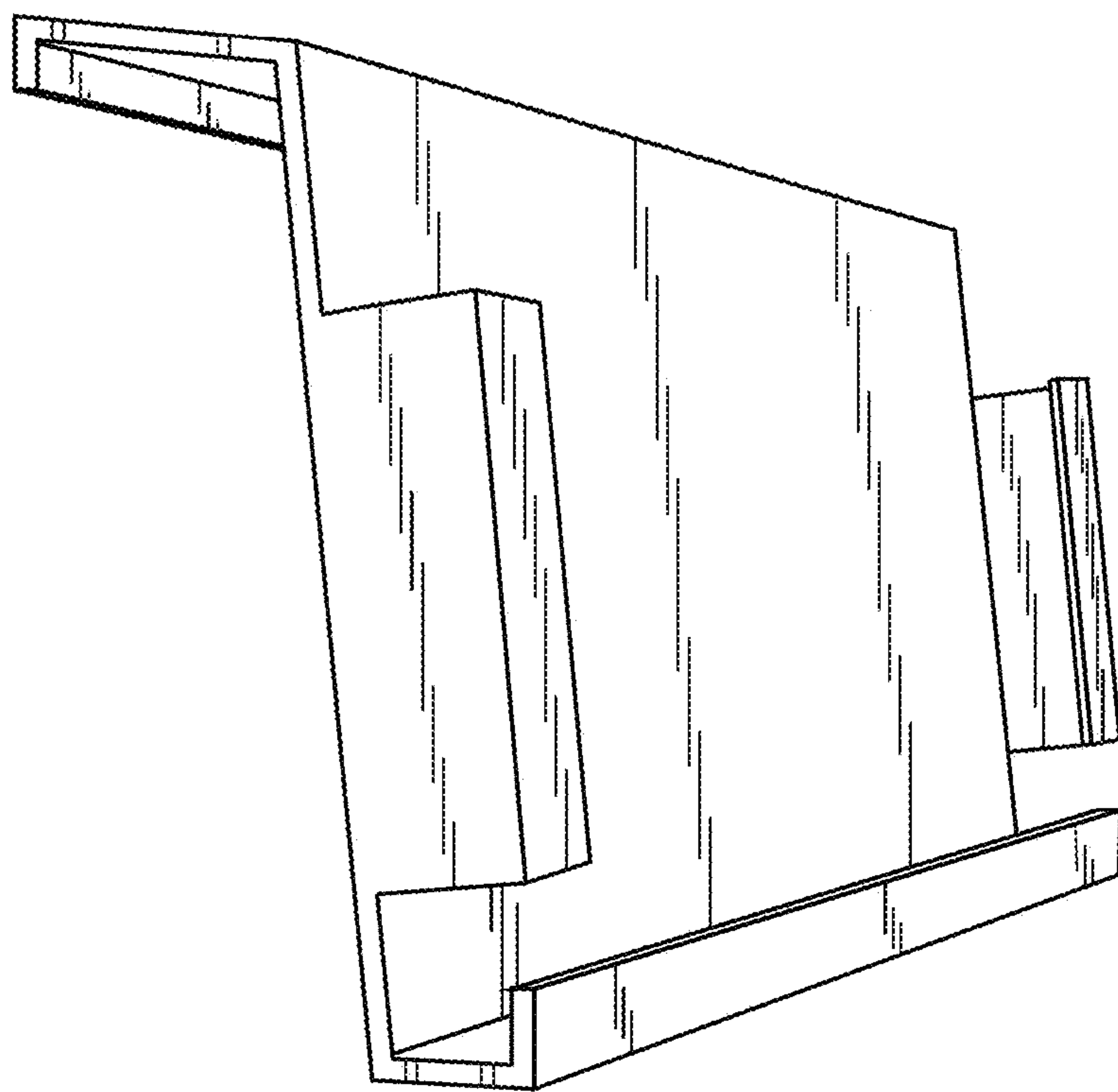

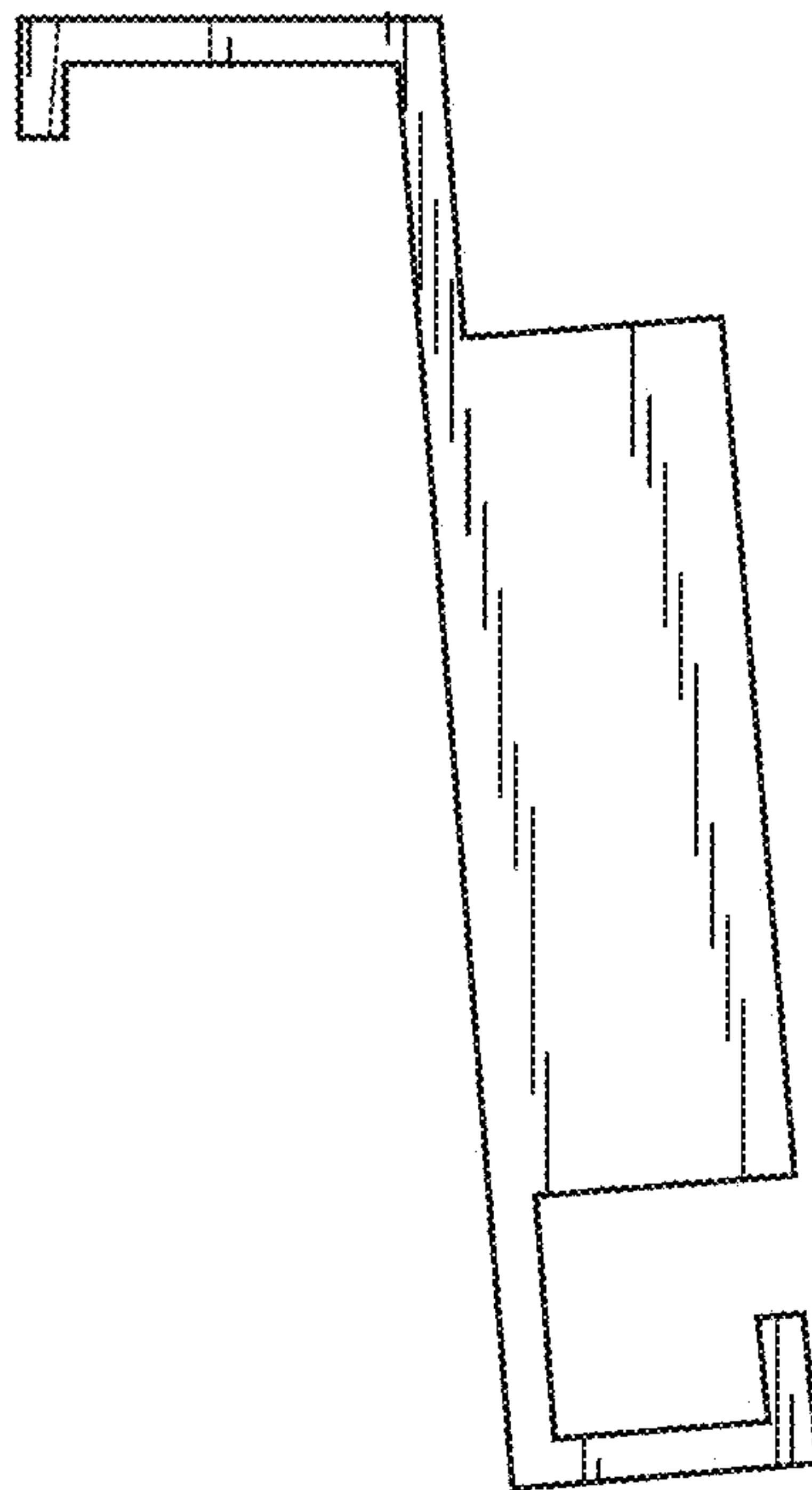

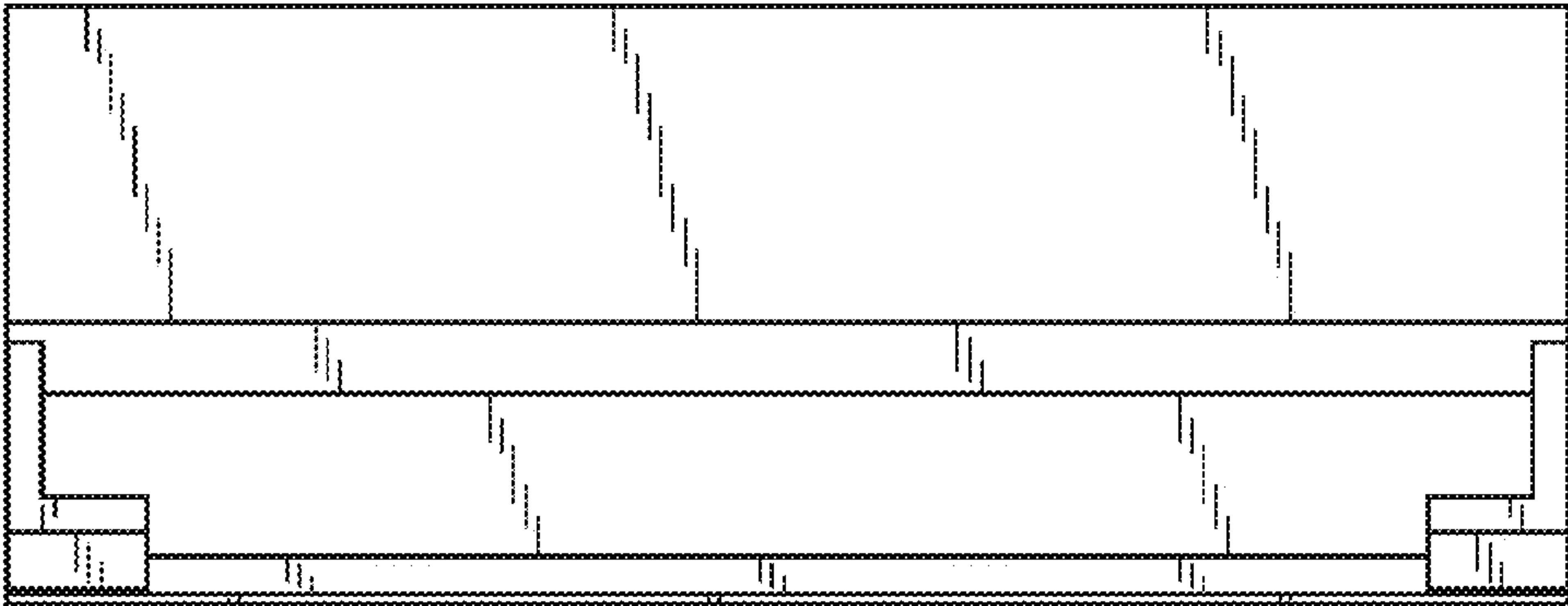

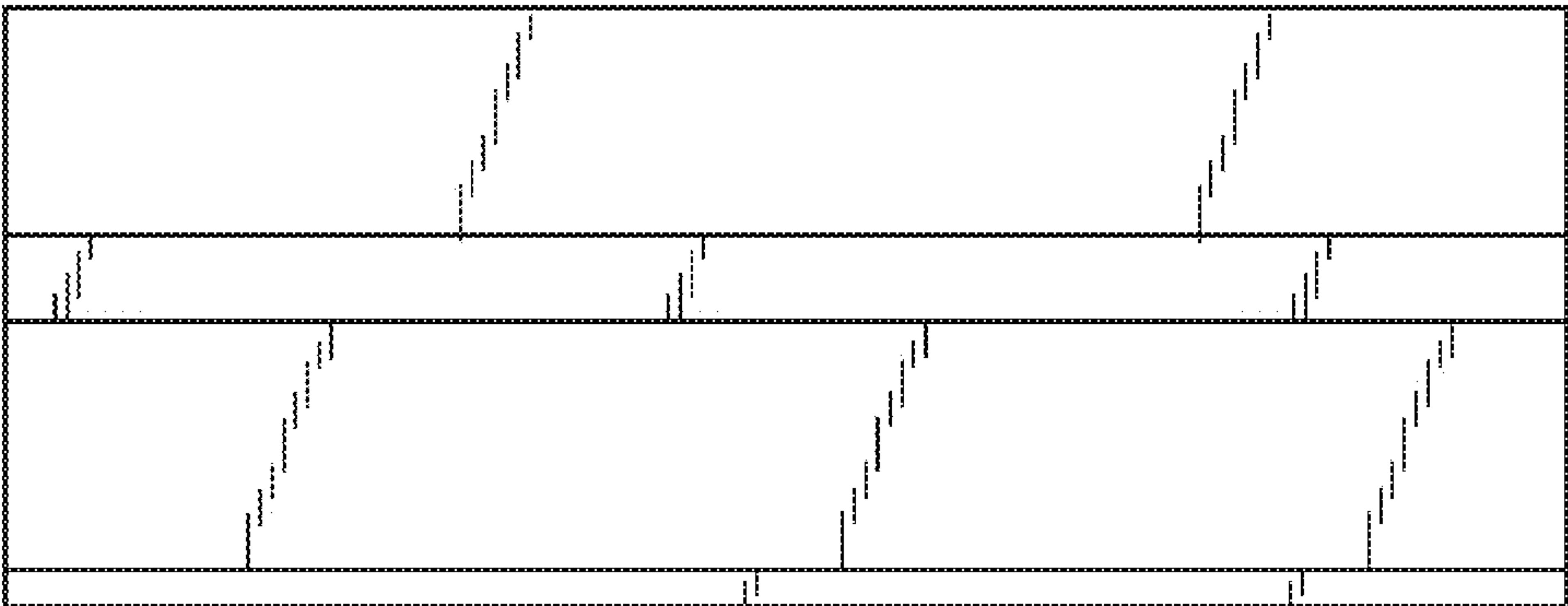

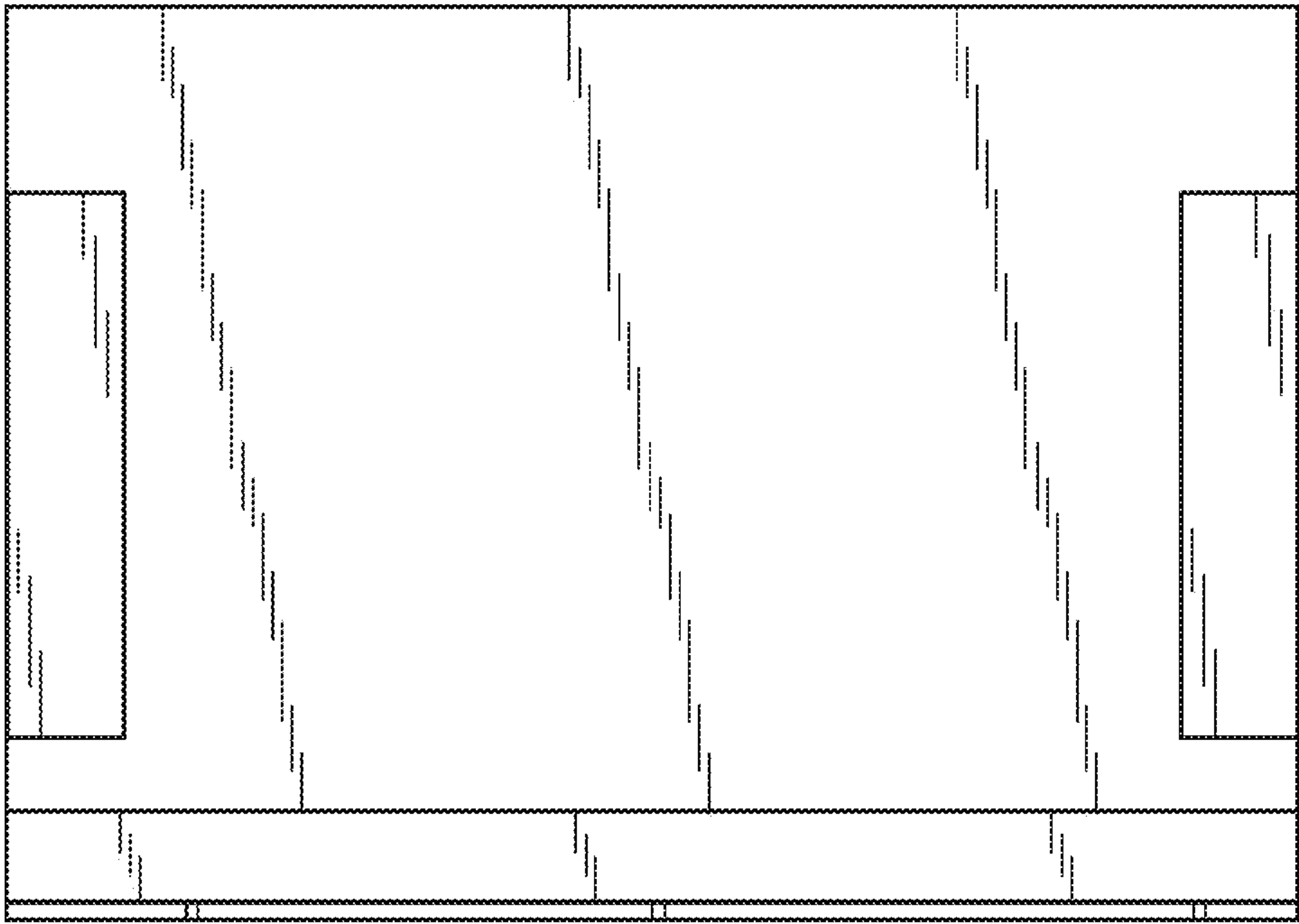

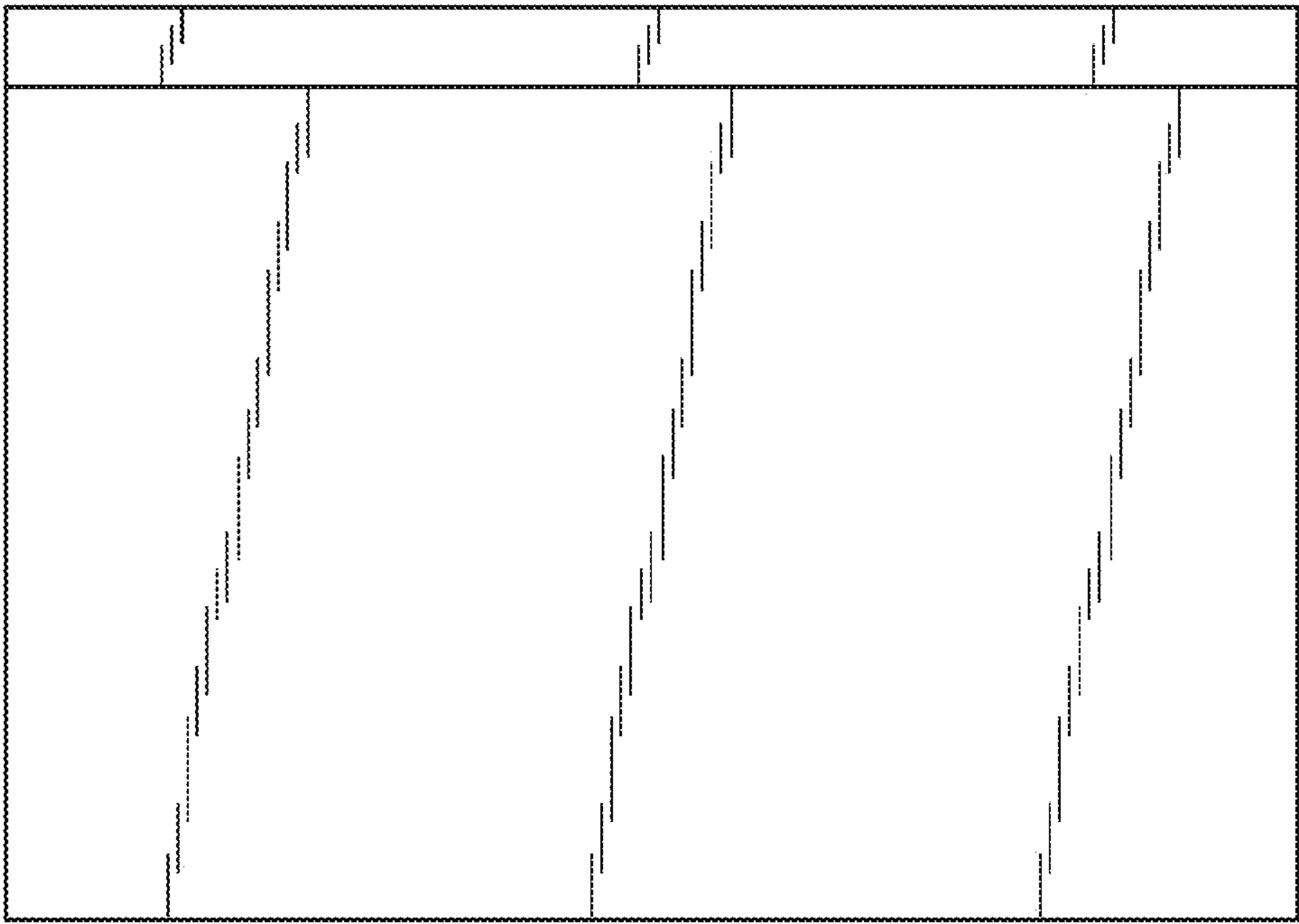

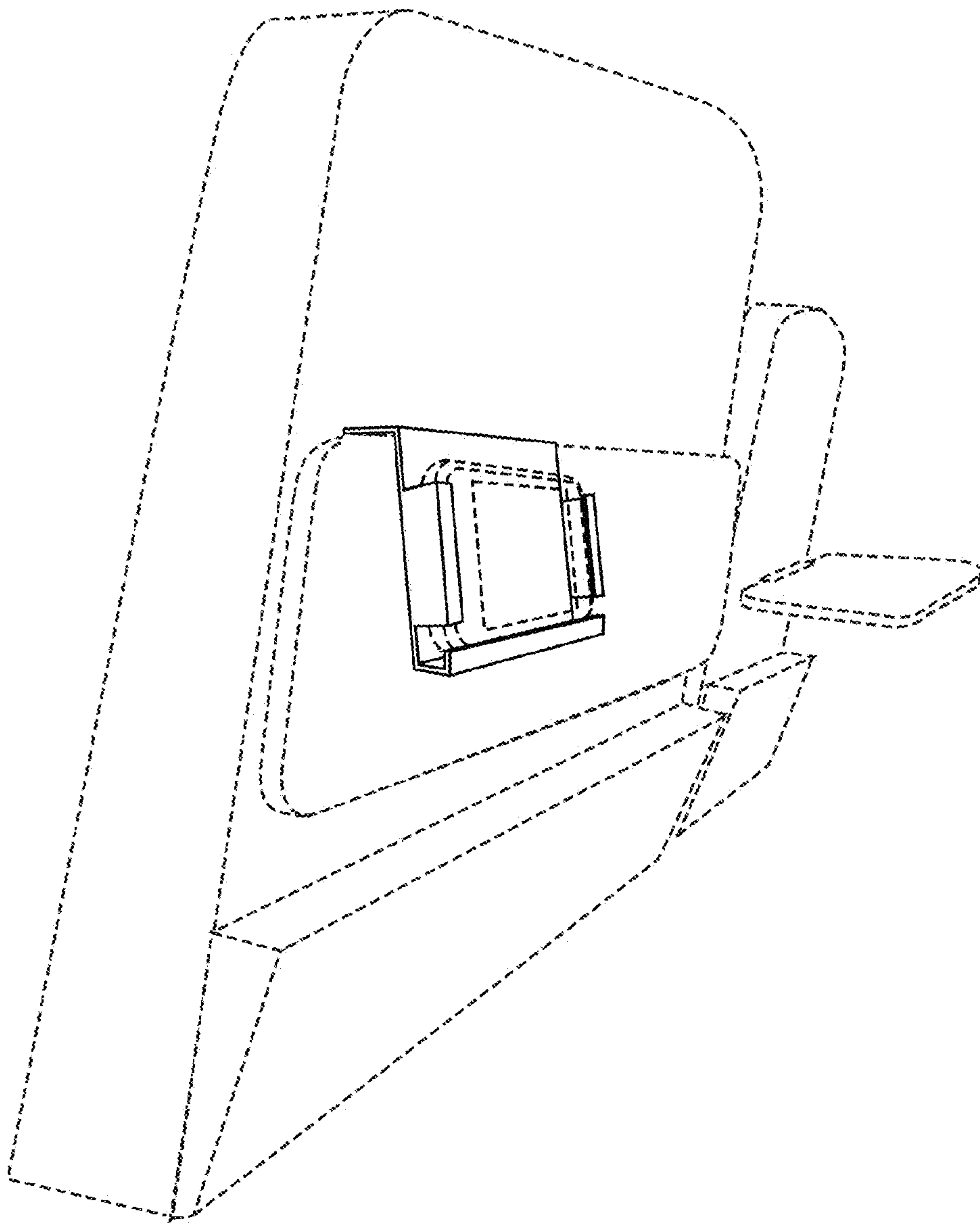
