(57) **CLAIM**

The ornamental design for a cover for portable electronic device, as shown and described.

DESCRIPTION

FIG. 1 is a bottom right front perspective view of a cover for portable electronic device showing our new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a left side elevation view thereof;
FIG. 5 is a right side elevation view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a bottom left rear perspective view thereof.
The broken lines in the figures represent unclaimed portions of the cover for portable electronic device and form no part of the claimed design.

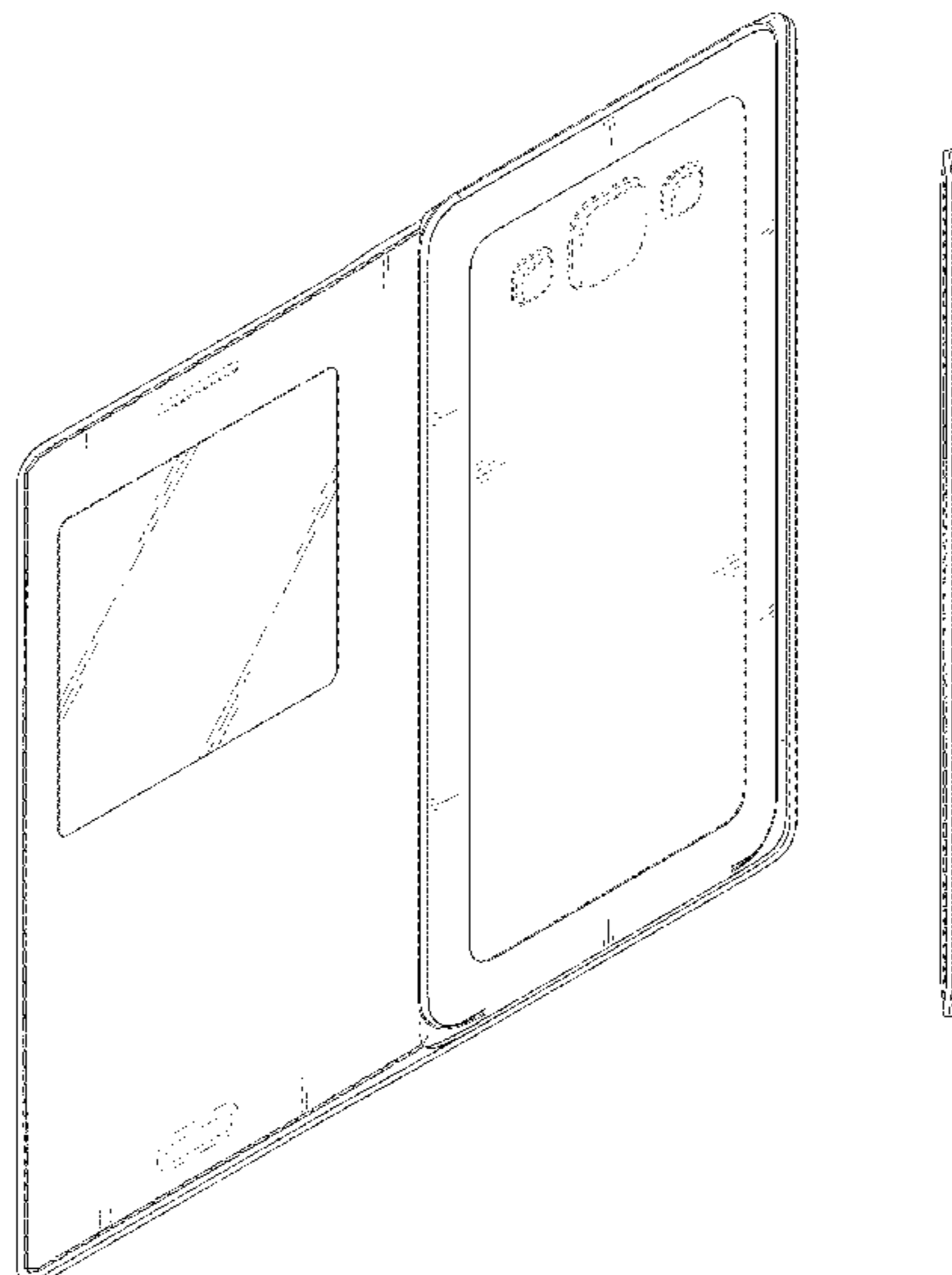

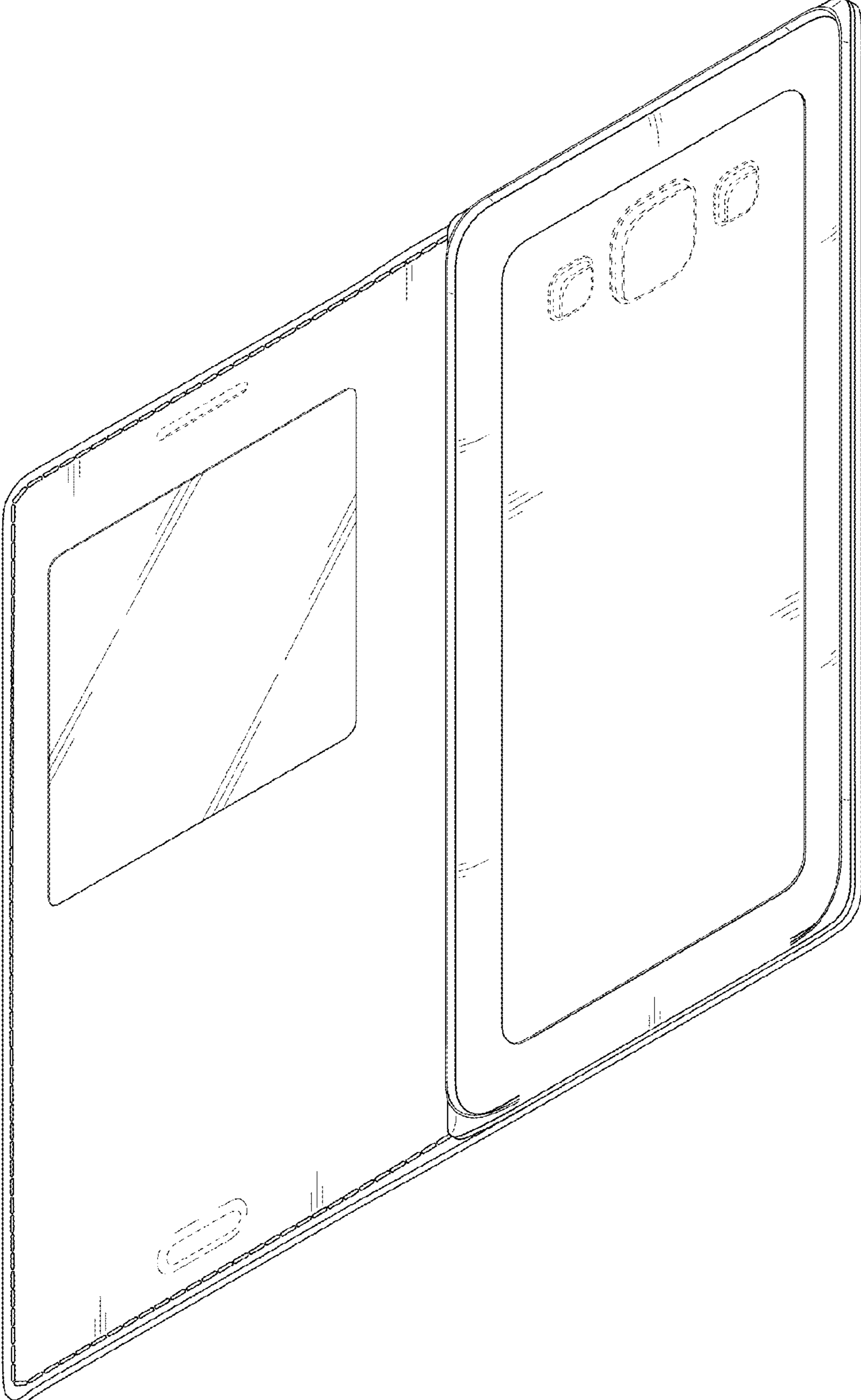

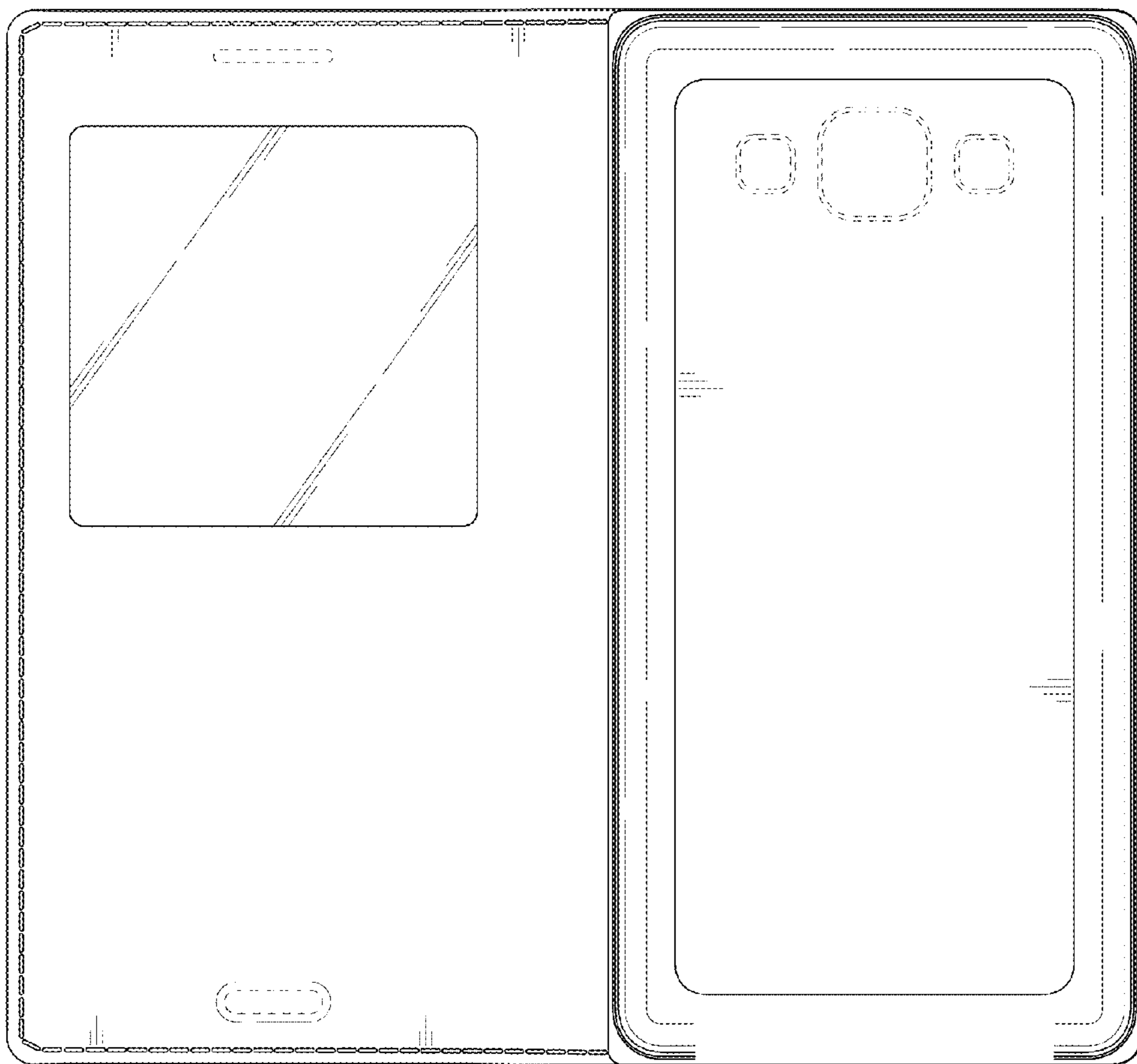

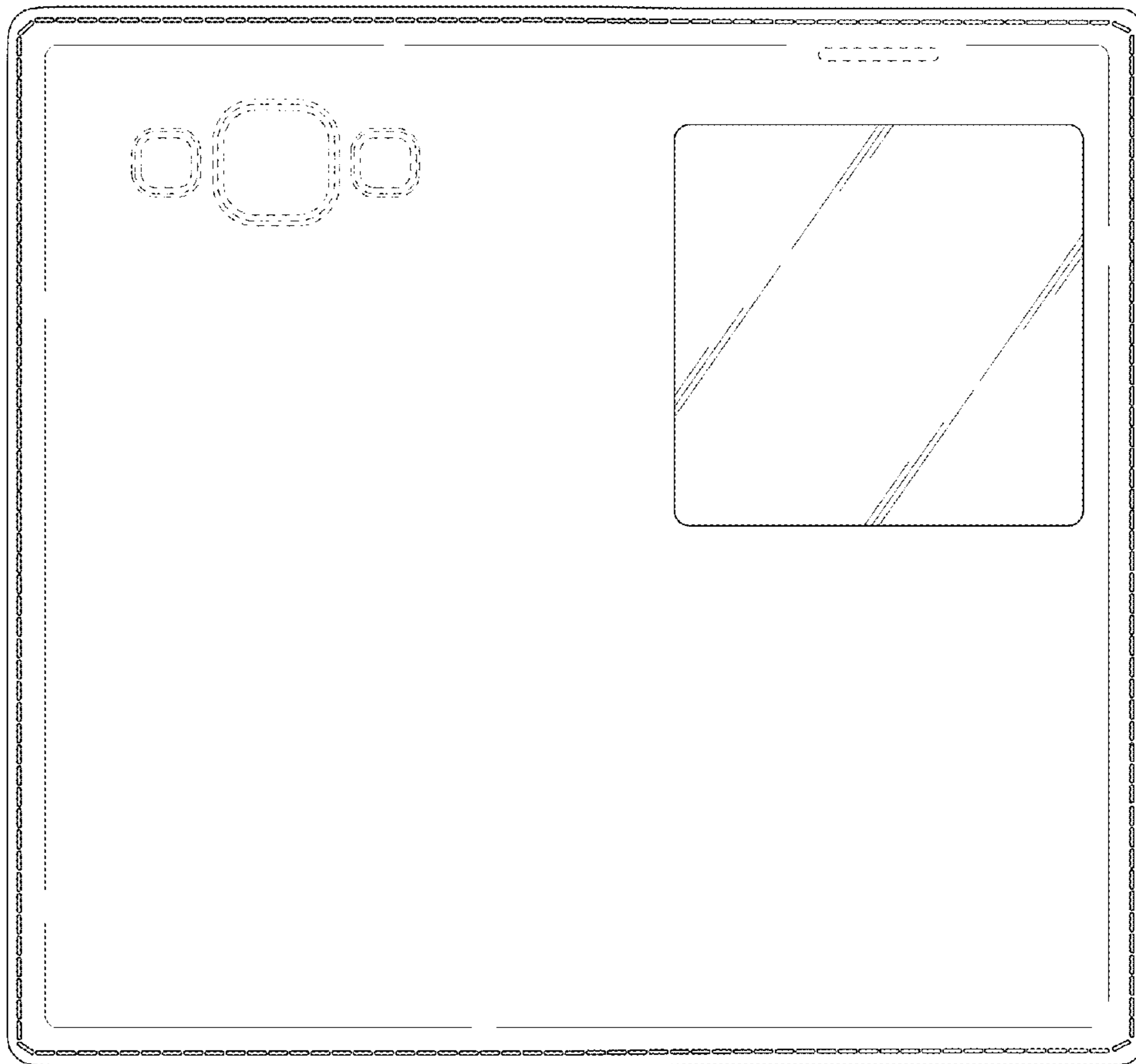

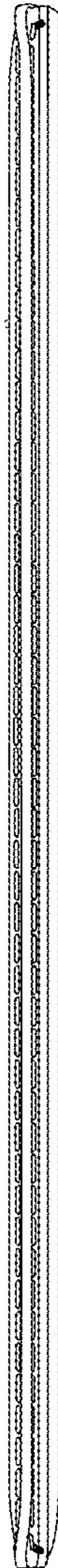

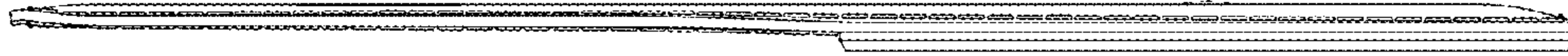

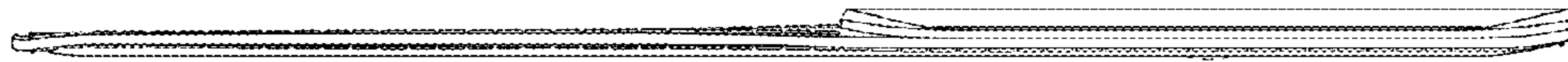
