(57) **CLAIM**

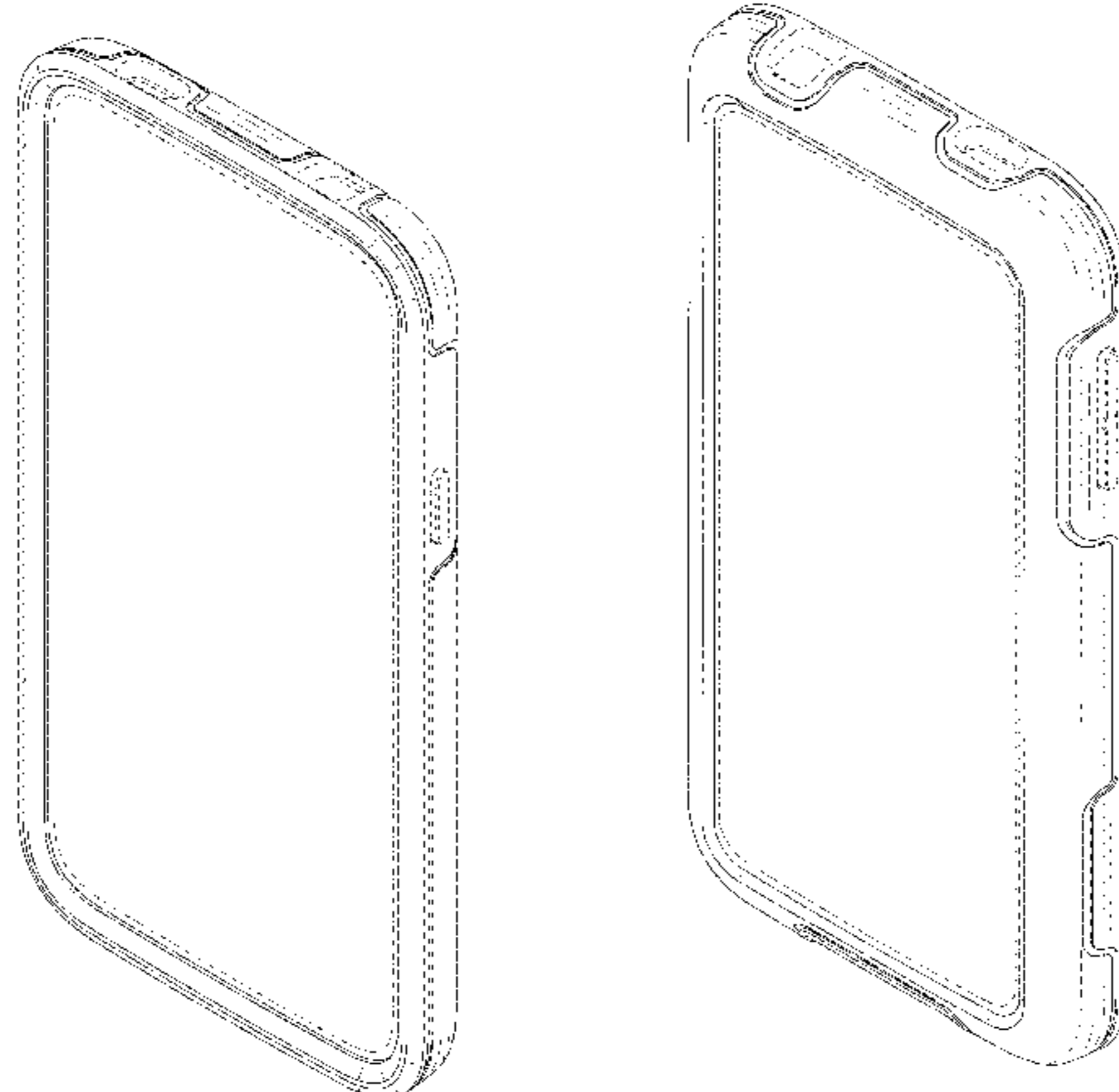
The ornamental design for a smartphone case, as shown and described.

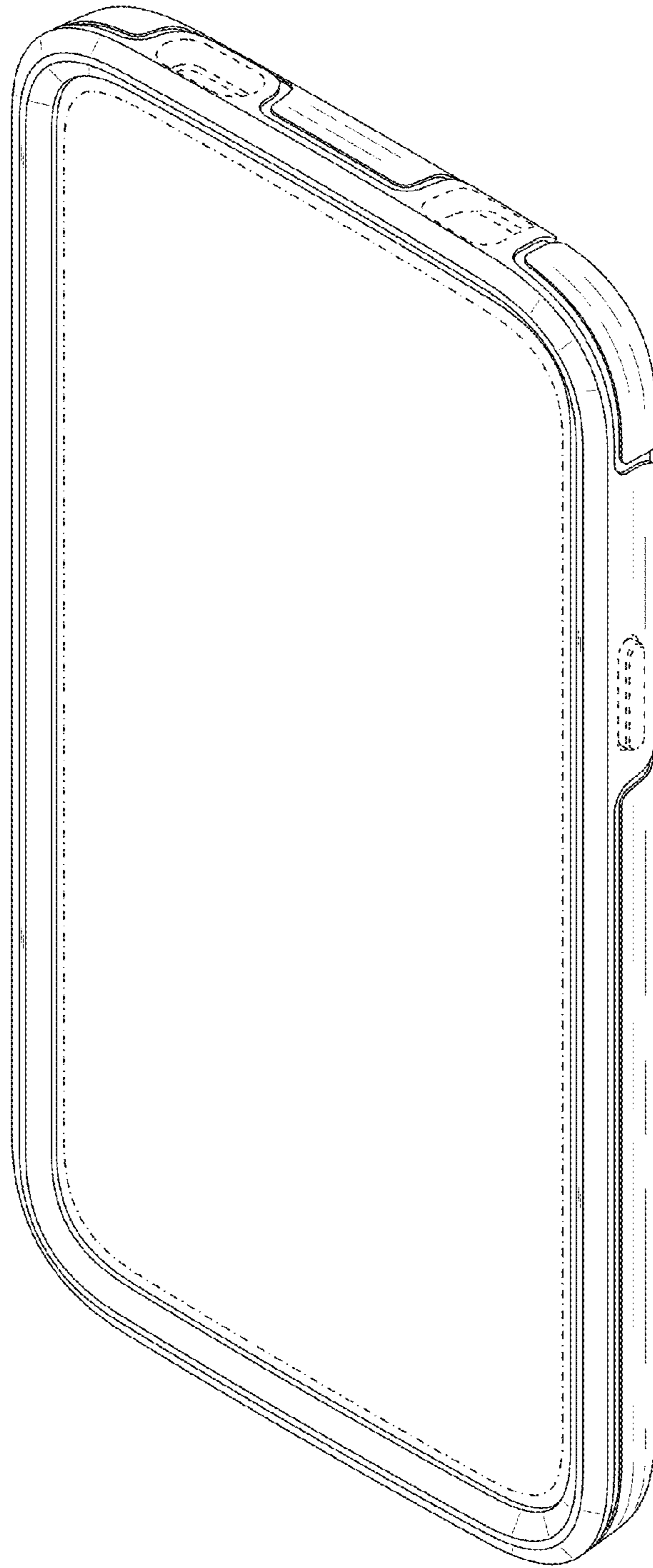

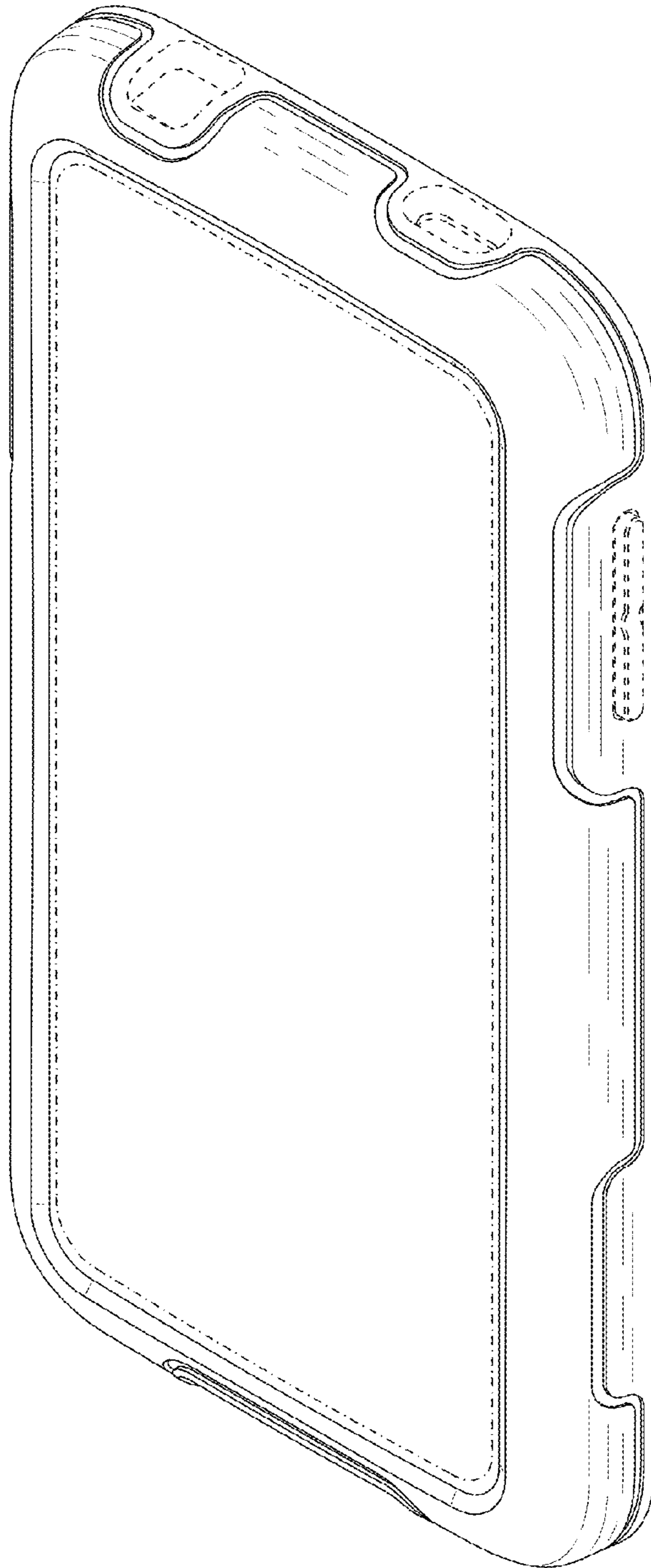

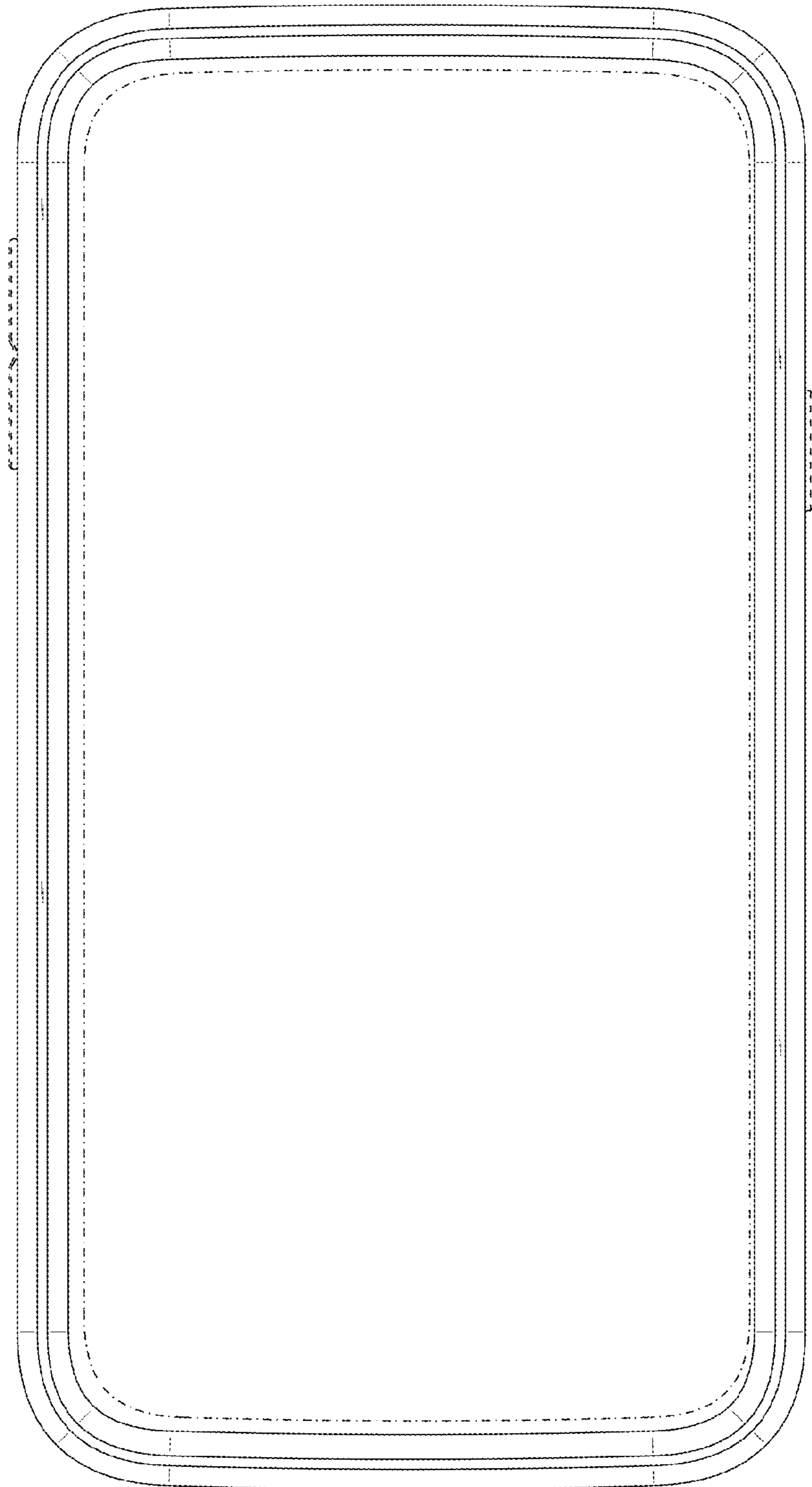

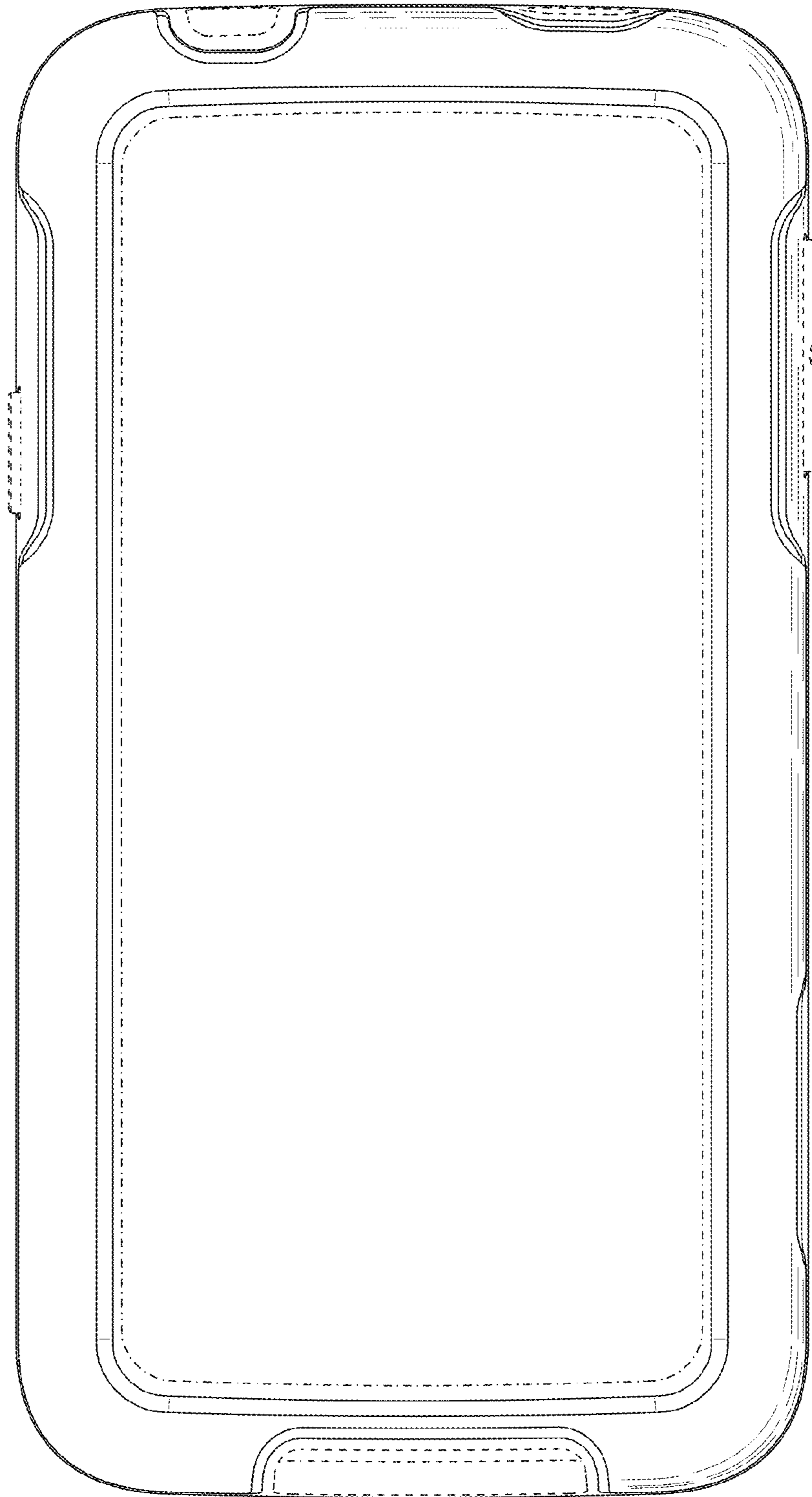

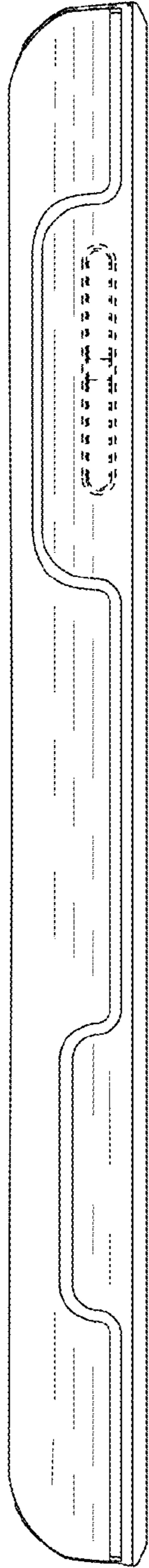

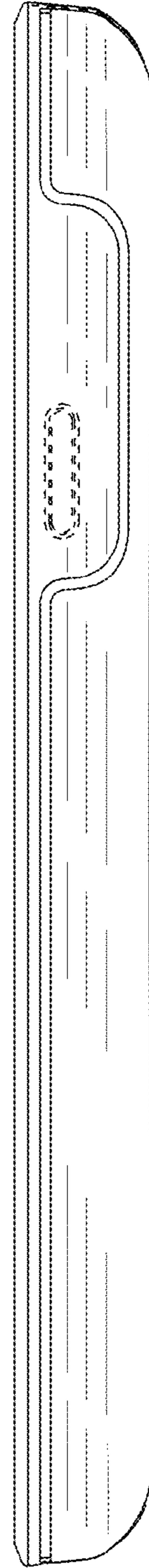

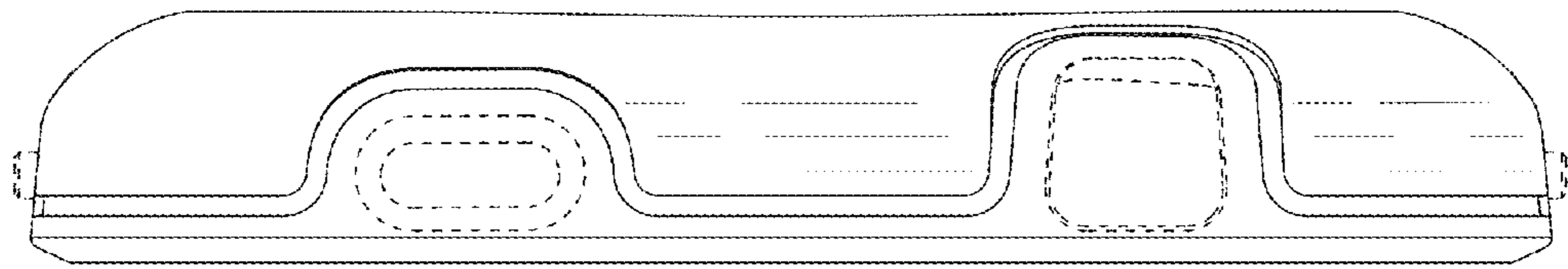

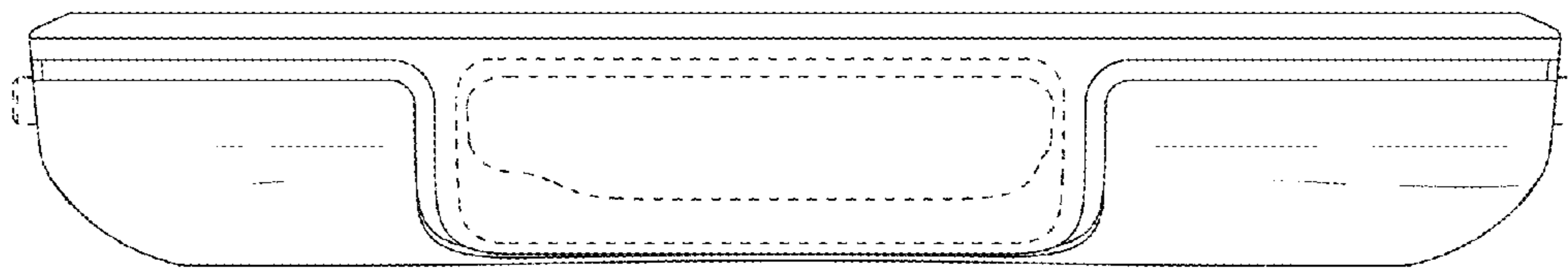
