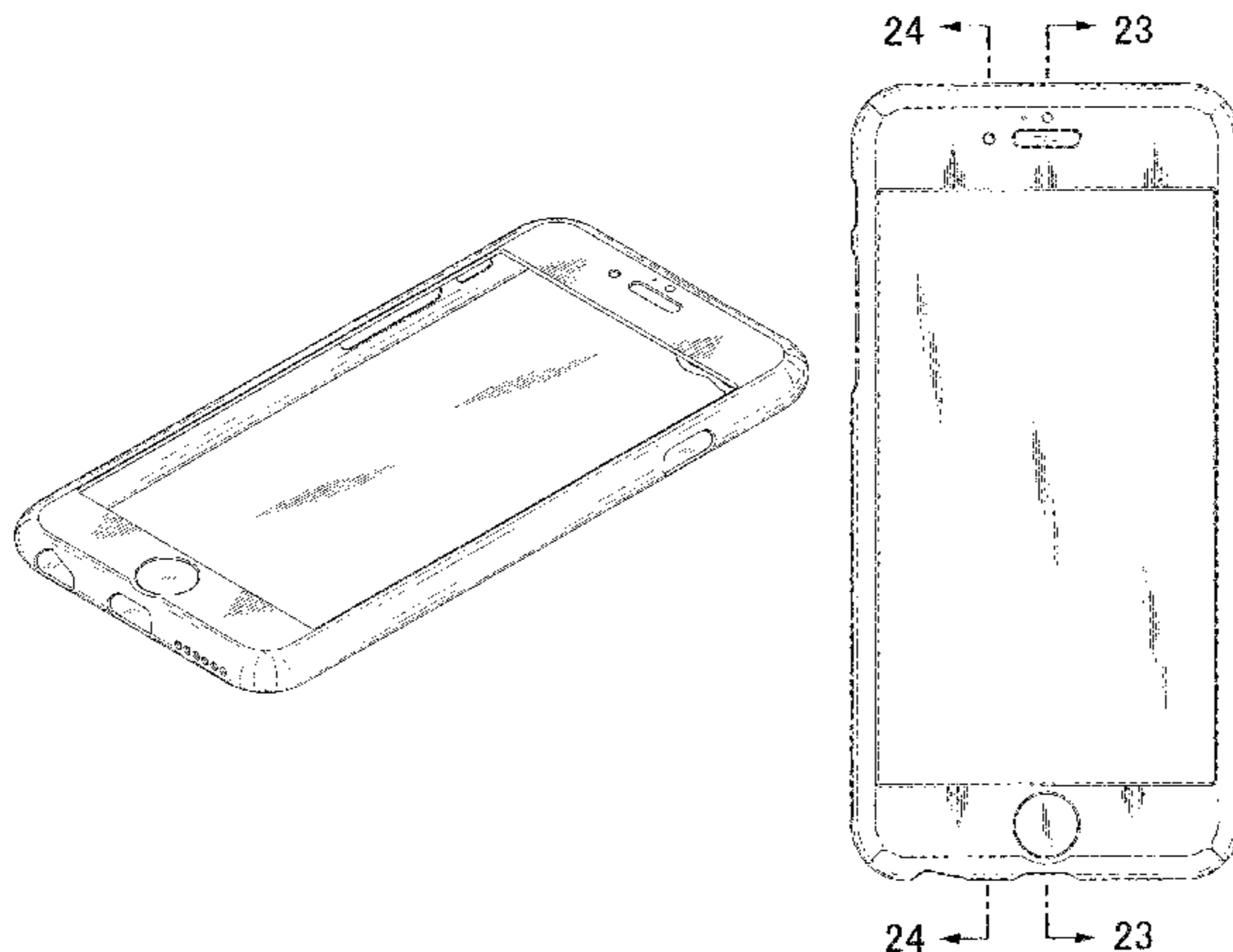

The ornamental design for a smartphone case, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a smartphone case showing my new design;

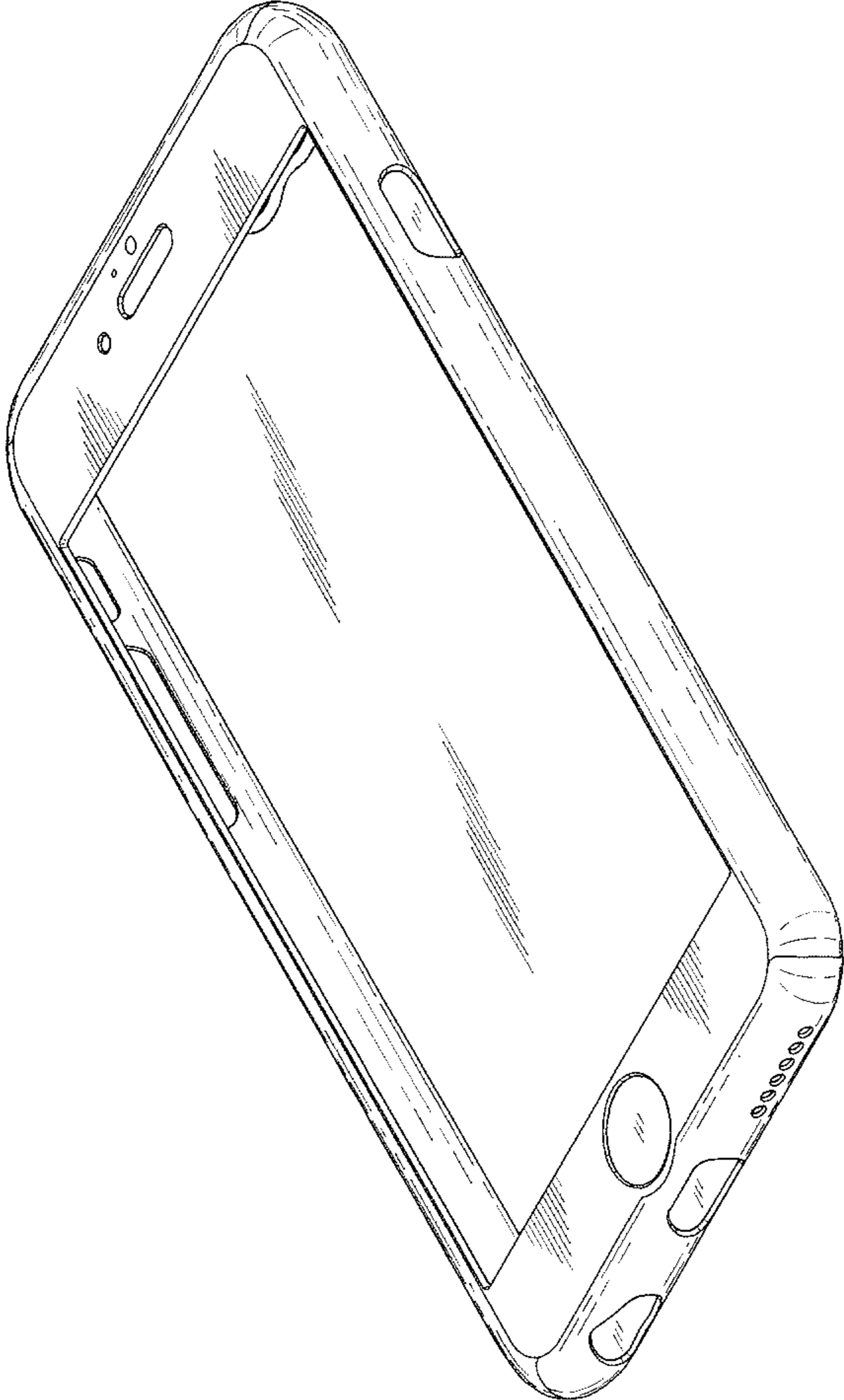

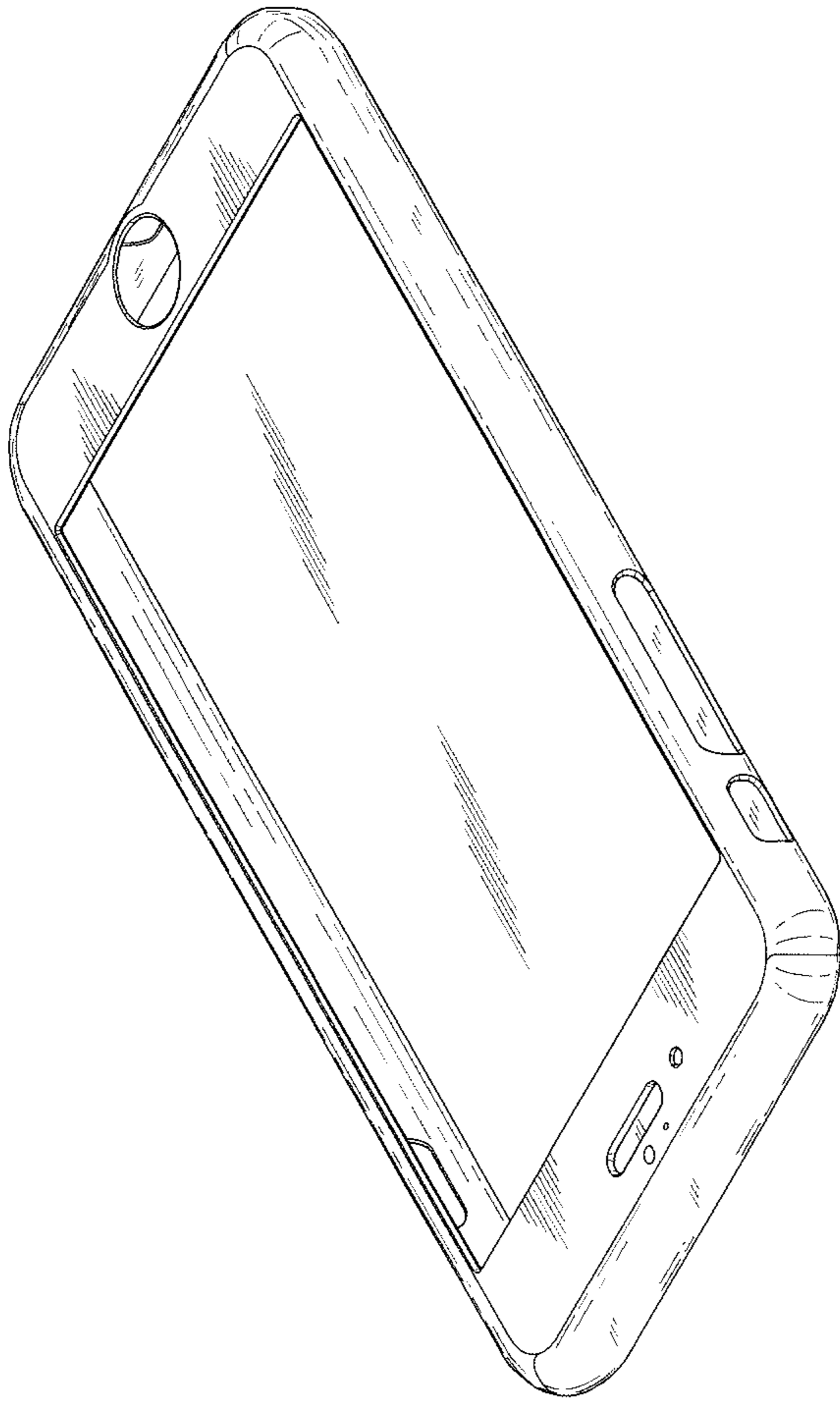

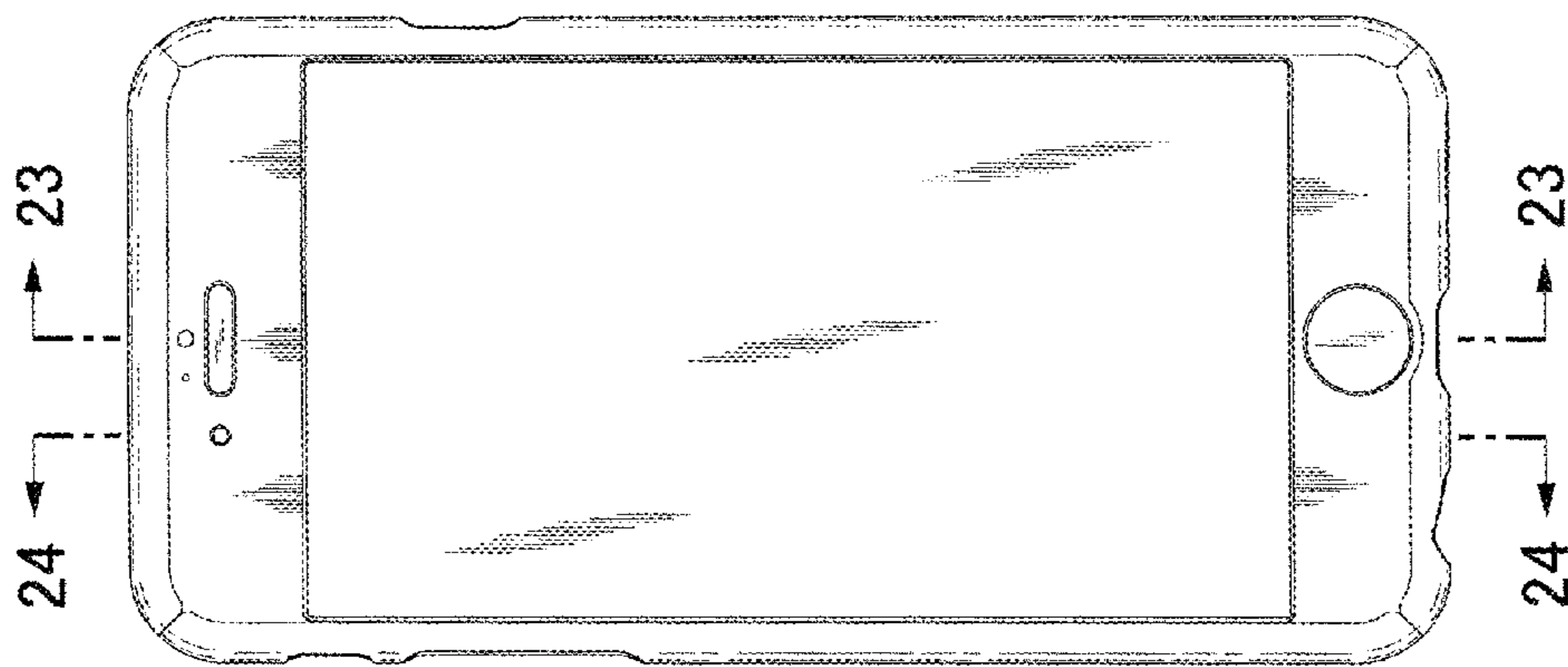

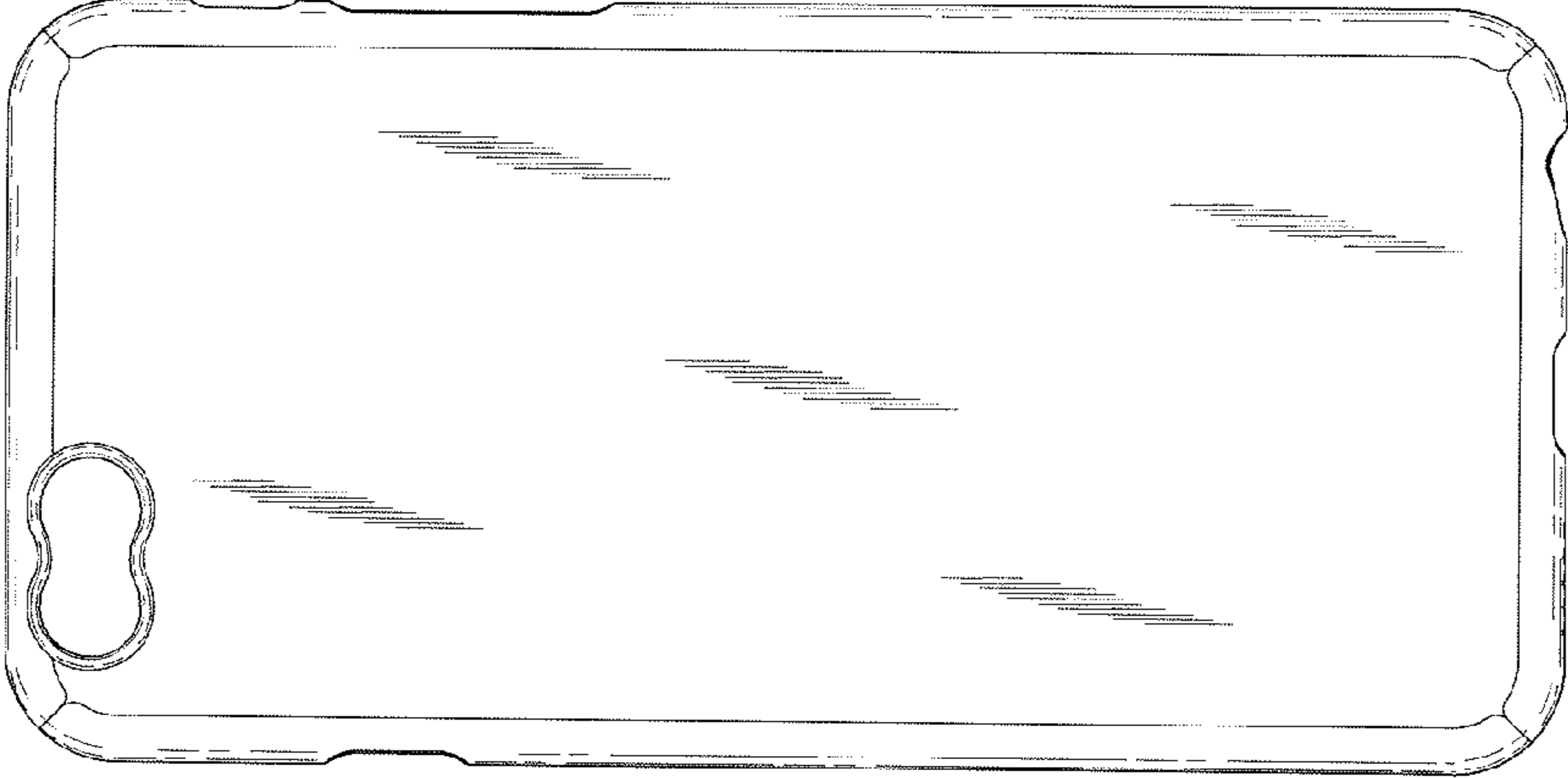

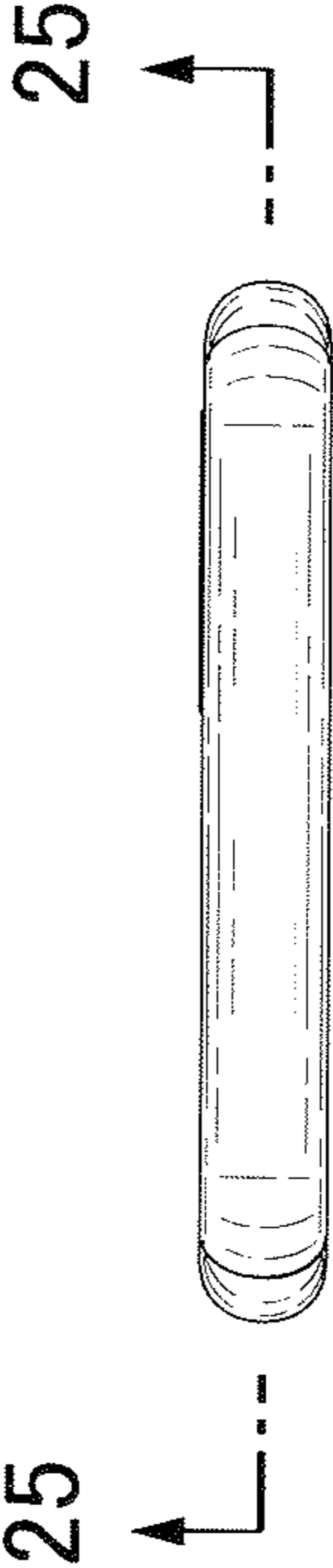

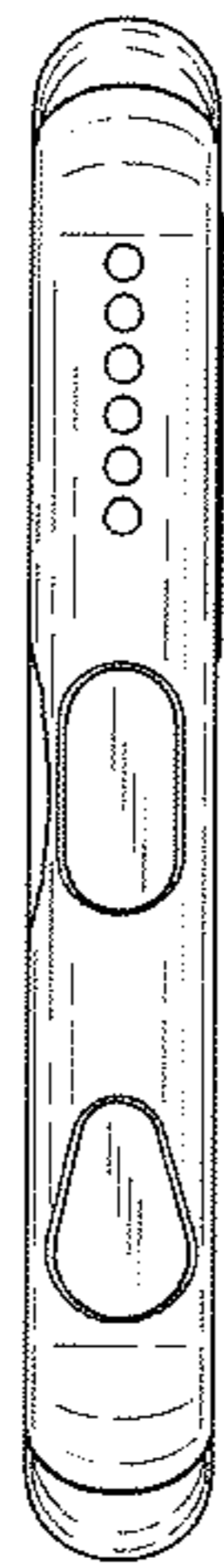

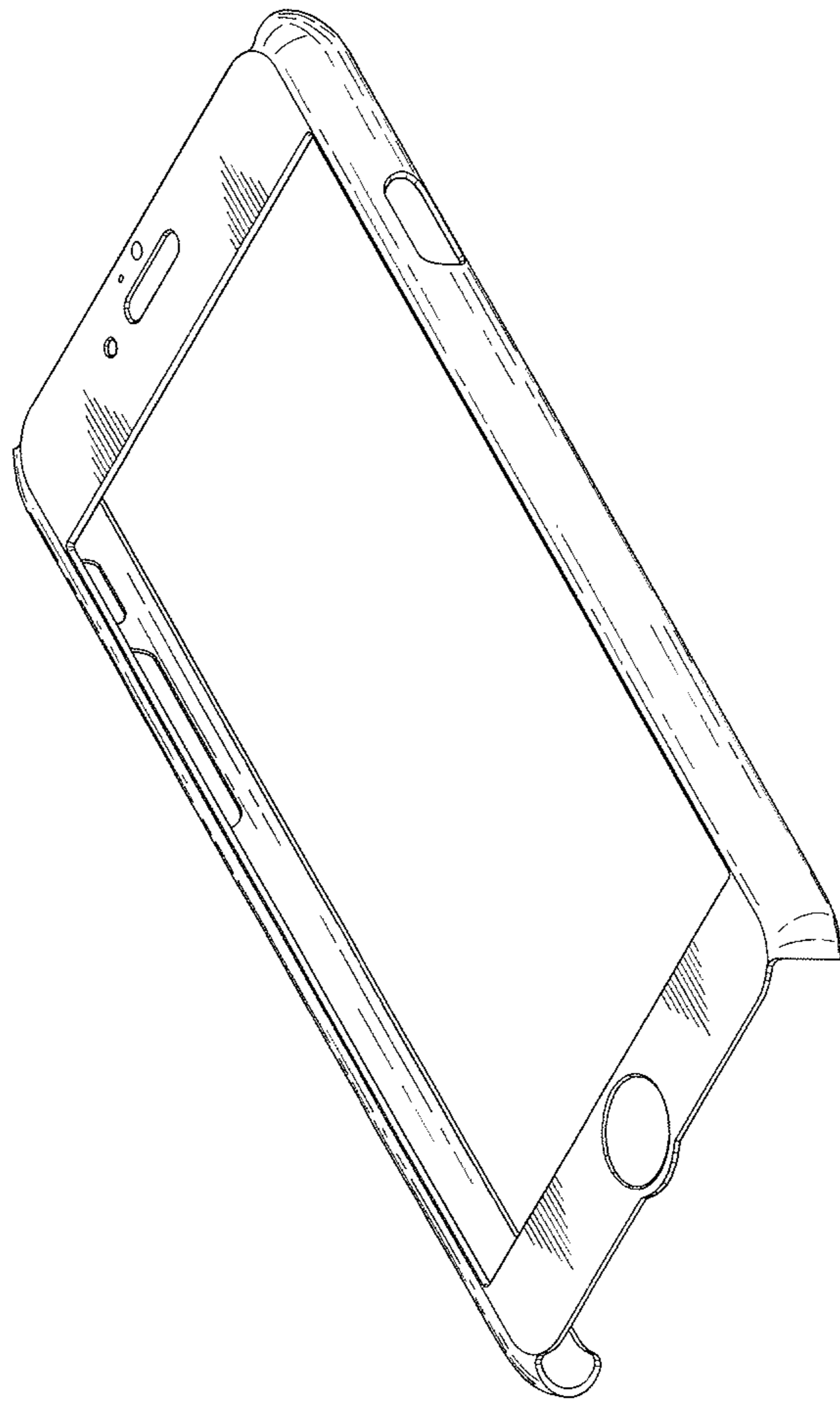

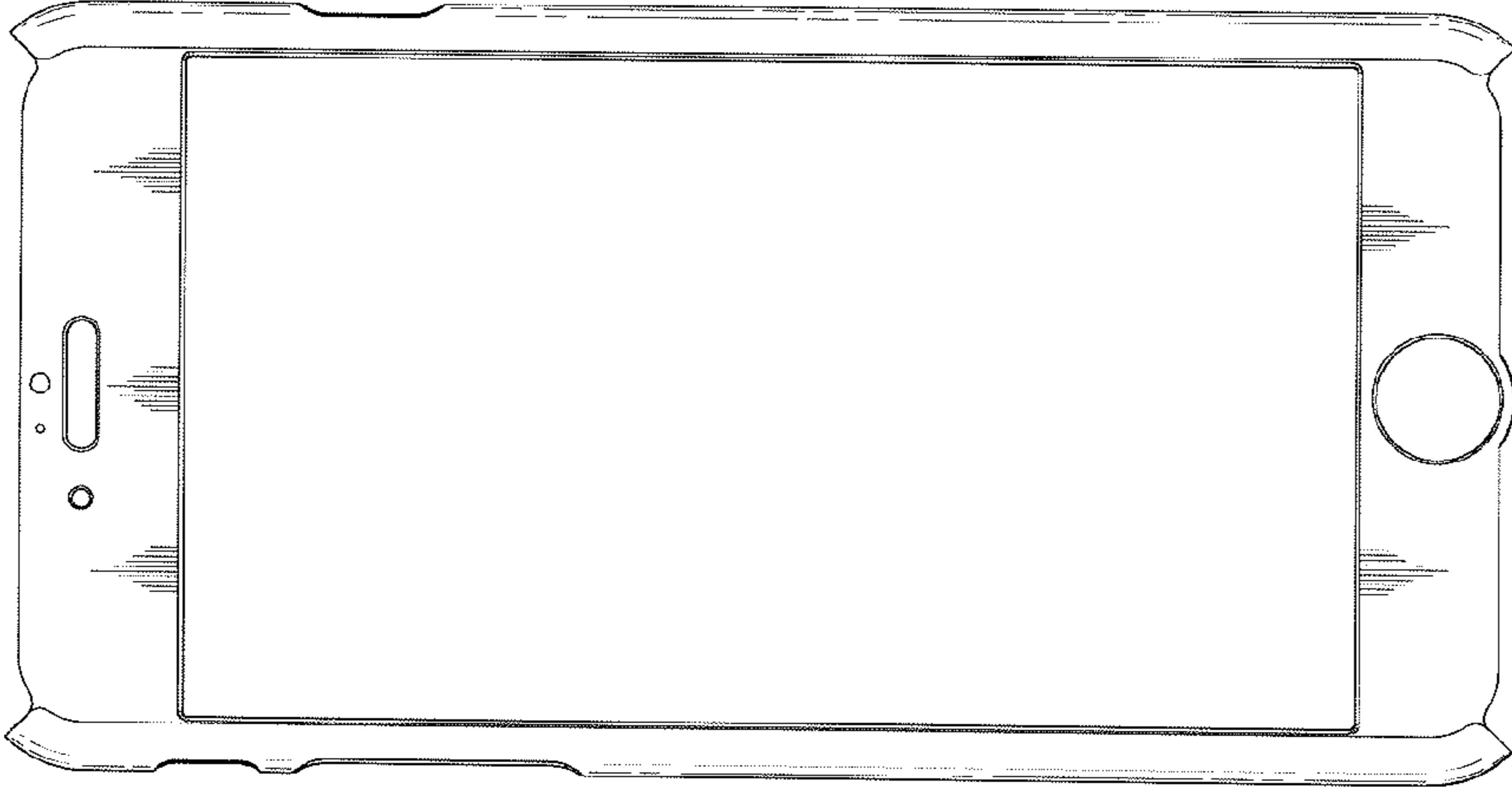

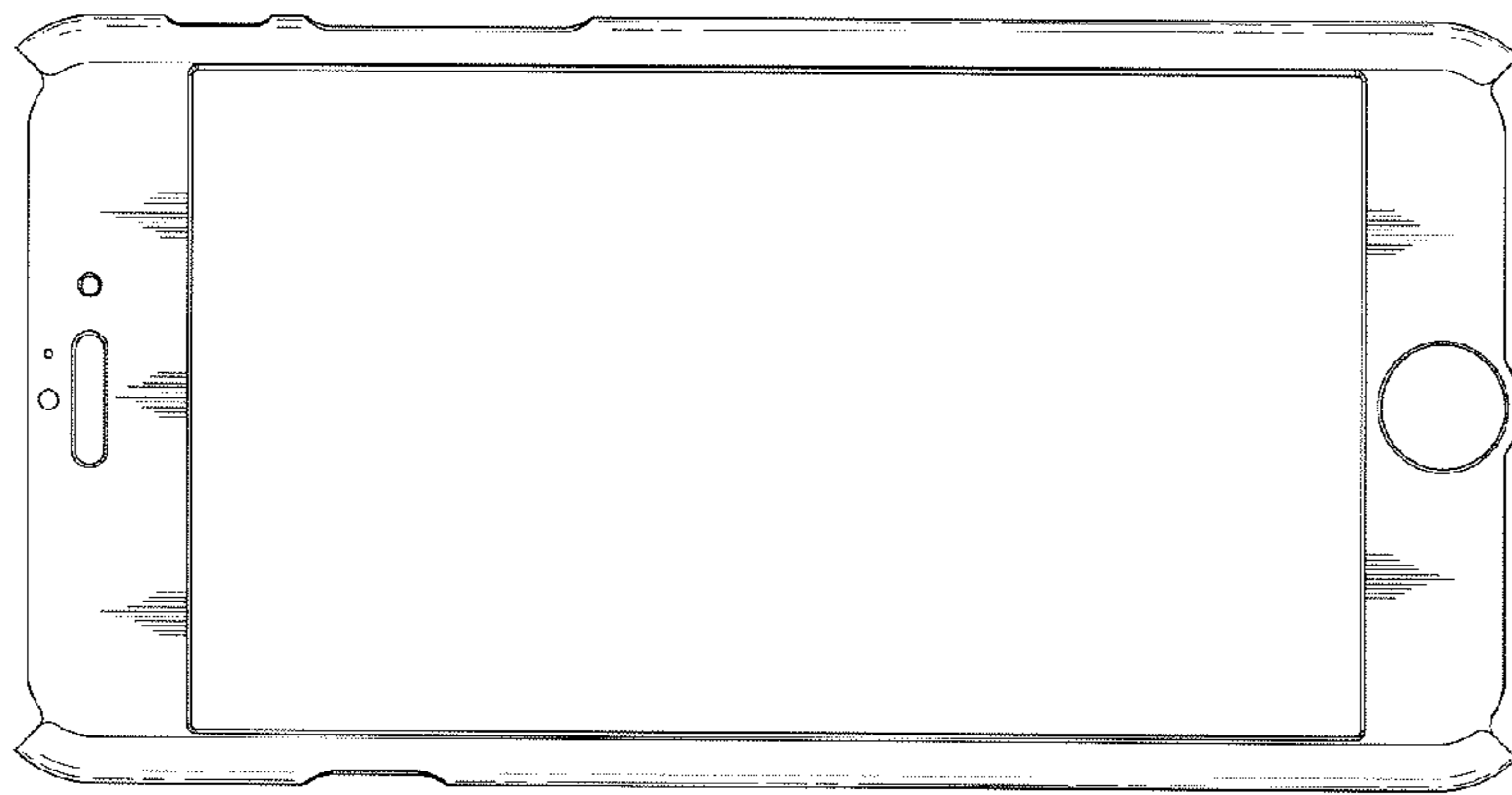

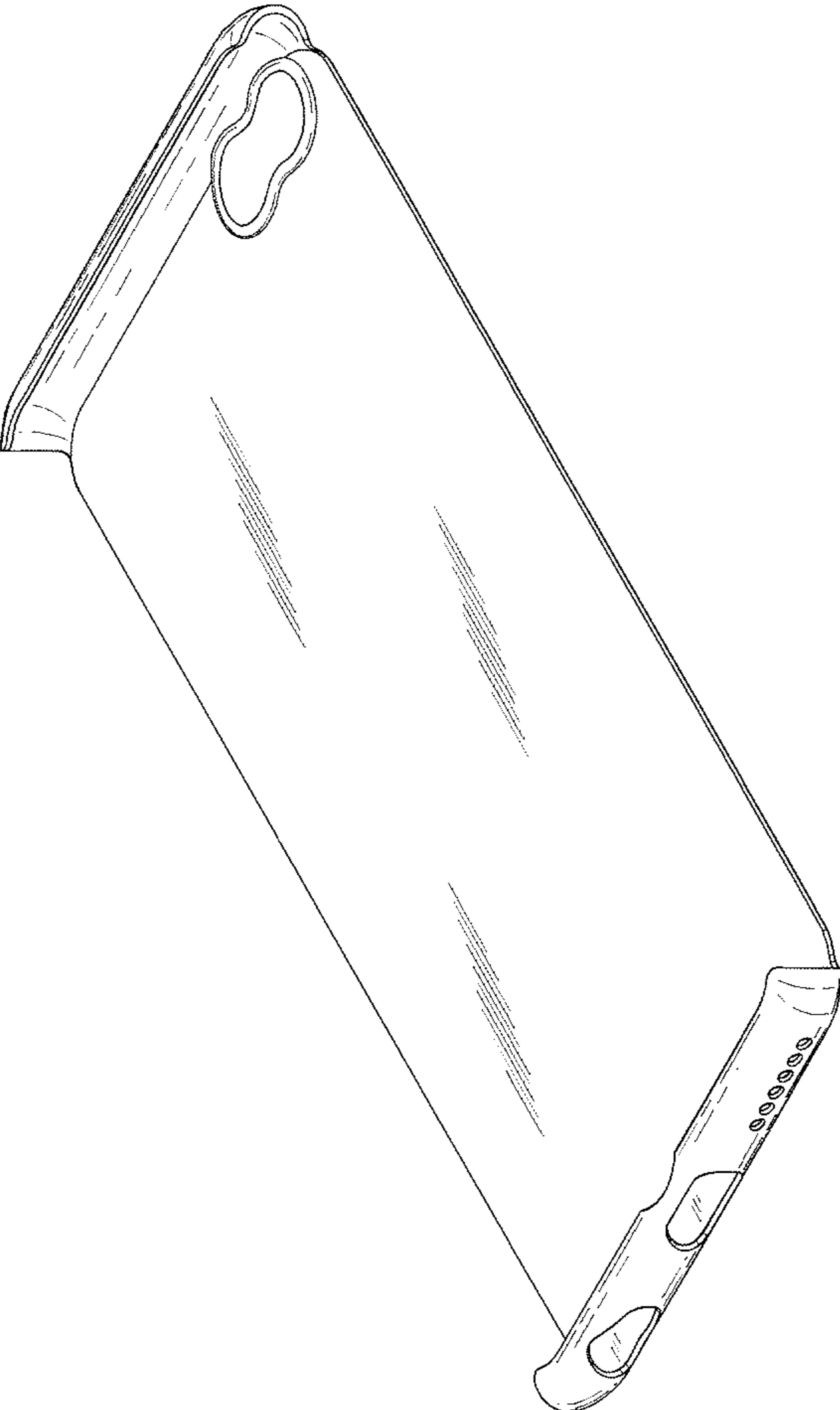

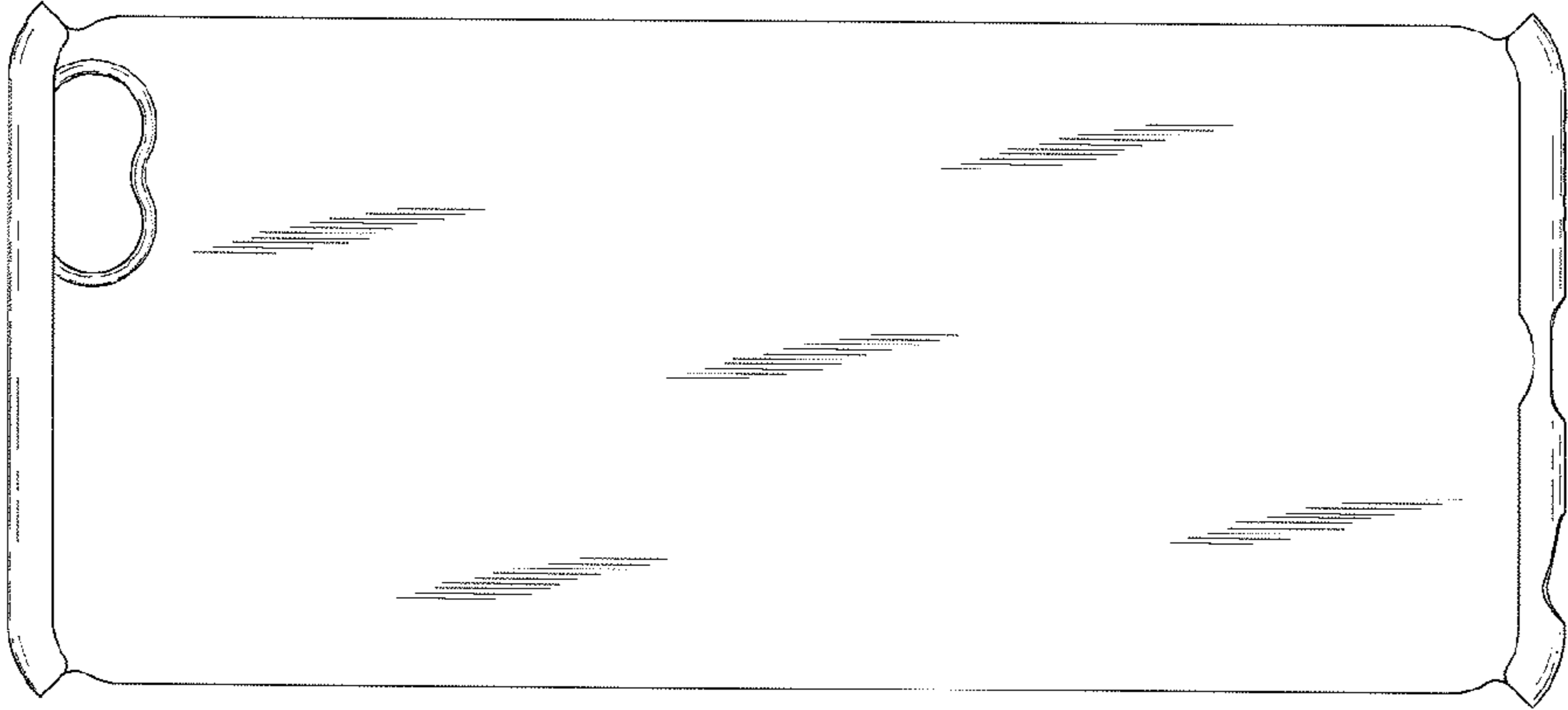

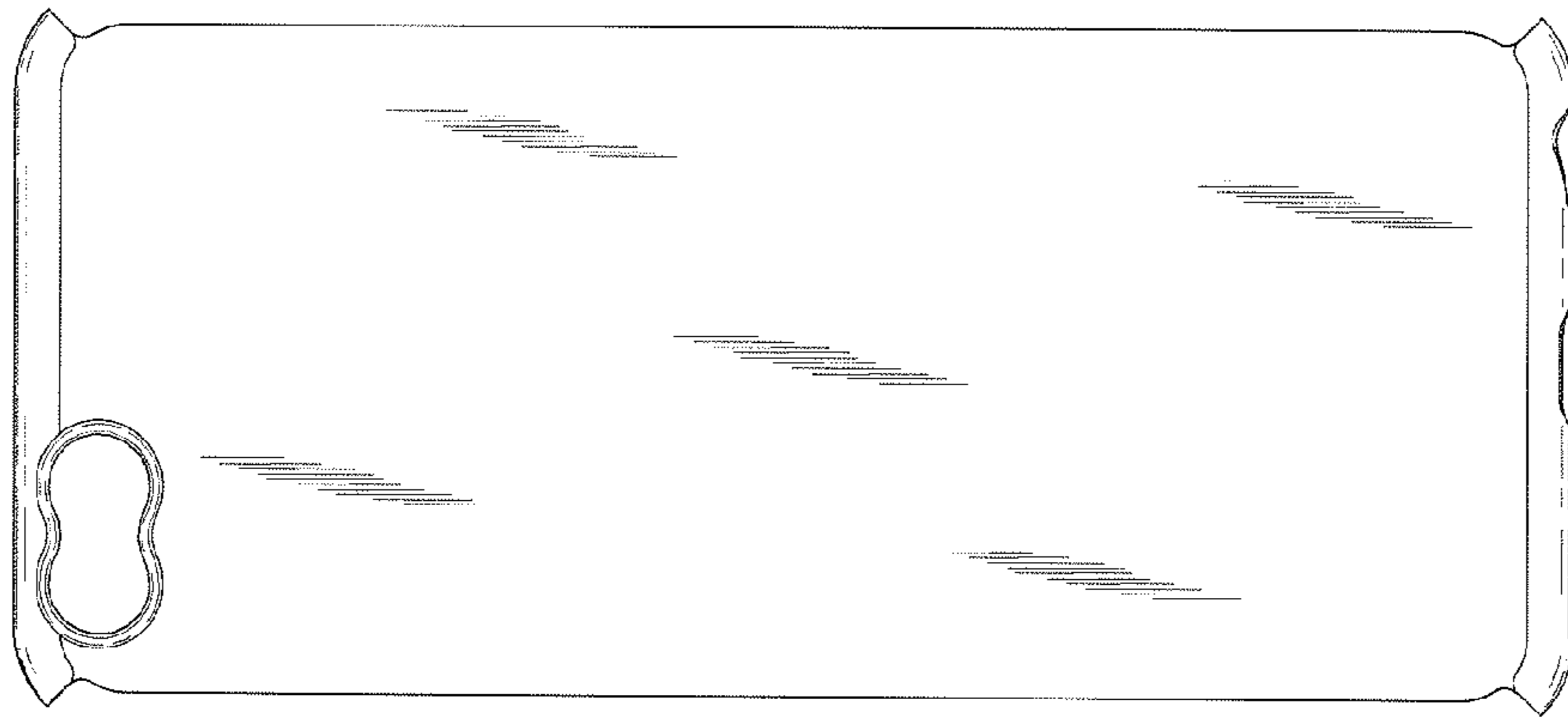

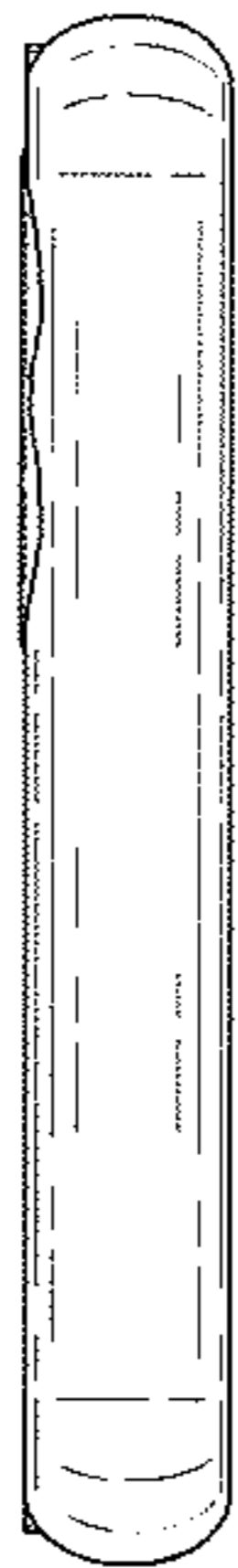

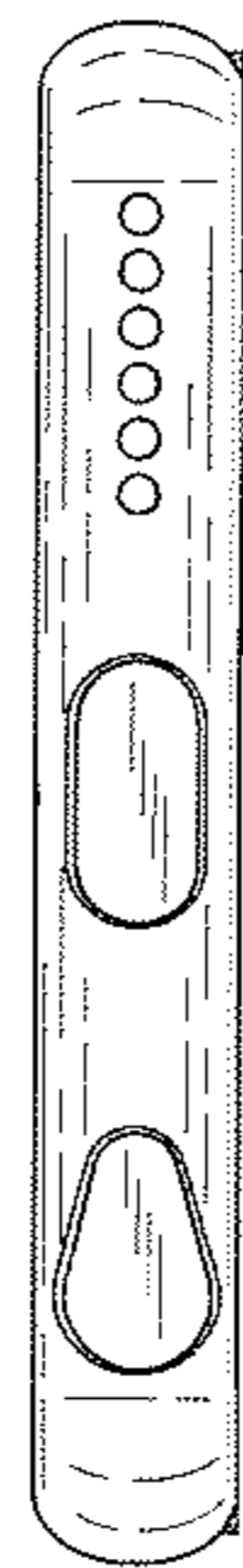

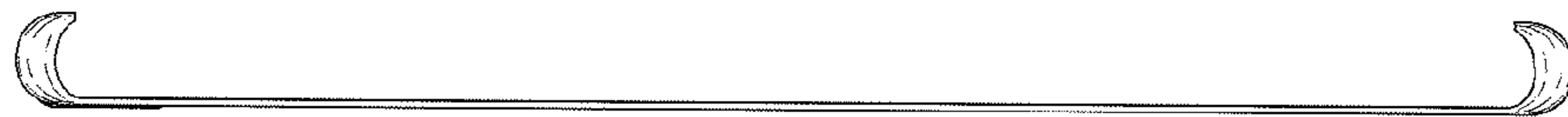

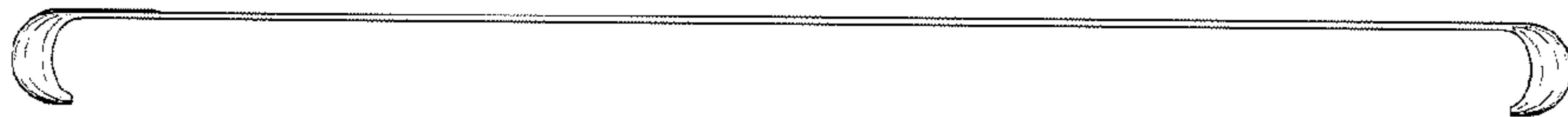

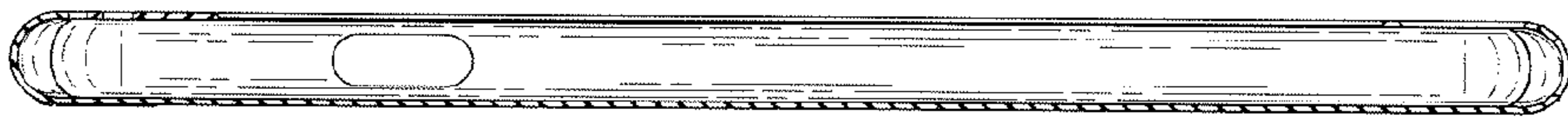

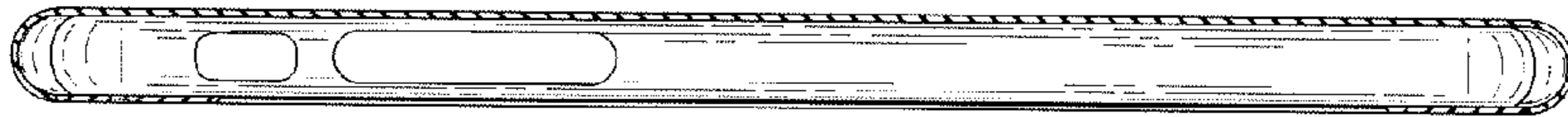

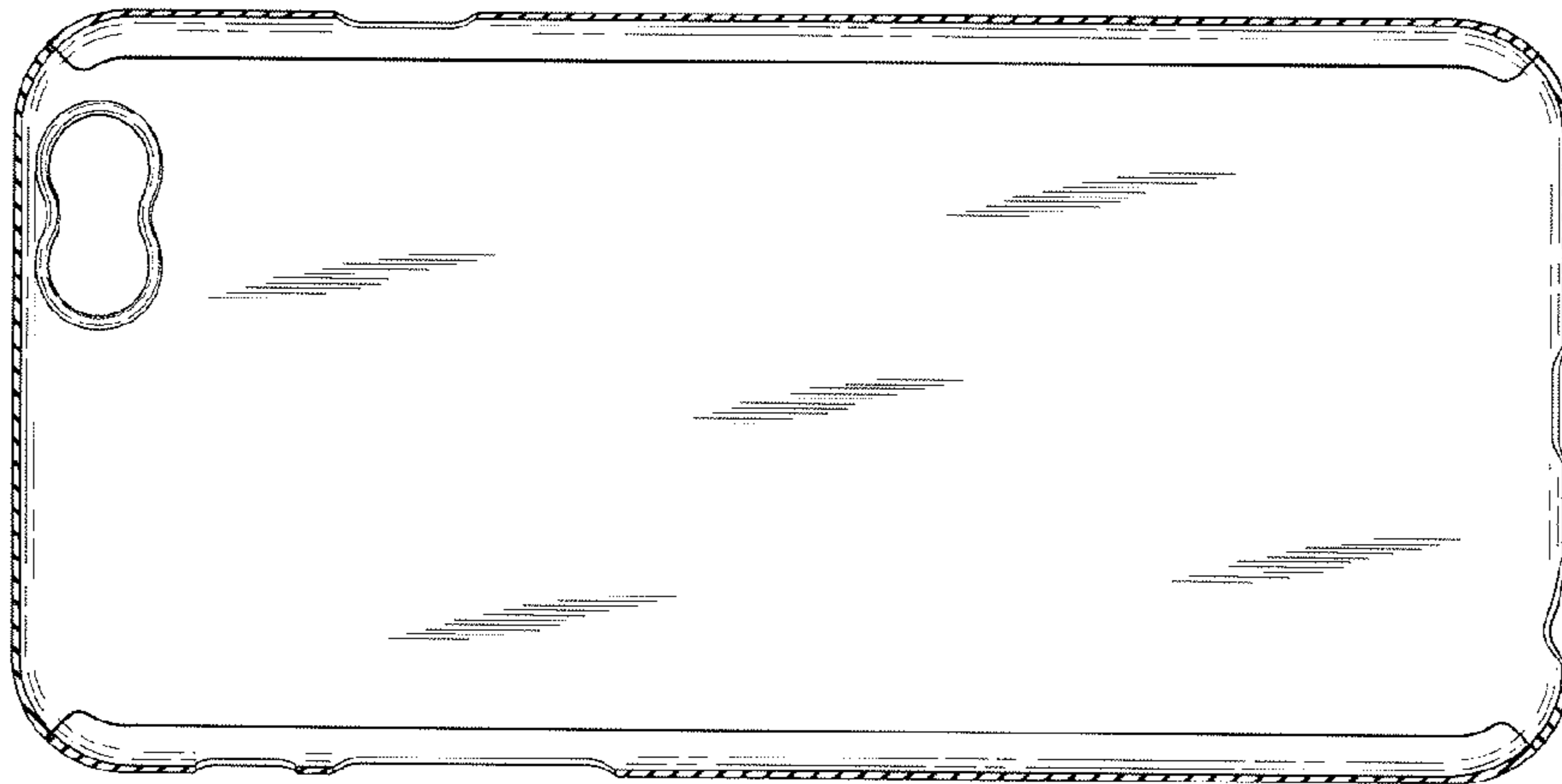
