The ornamental design for a cover for an electronic device, as shown and described.

DESCRIPTION

FIG. 1 is a top left front perspective view of a first embodiment of a cover for an electronic device showing my new design;

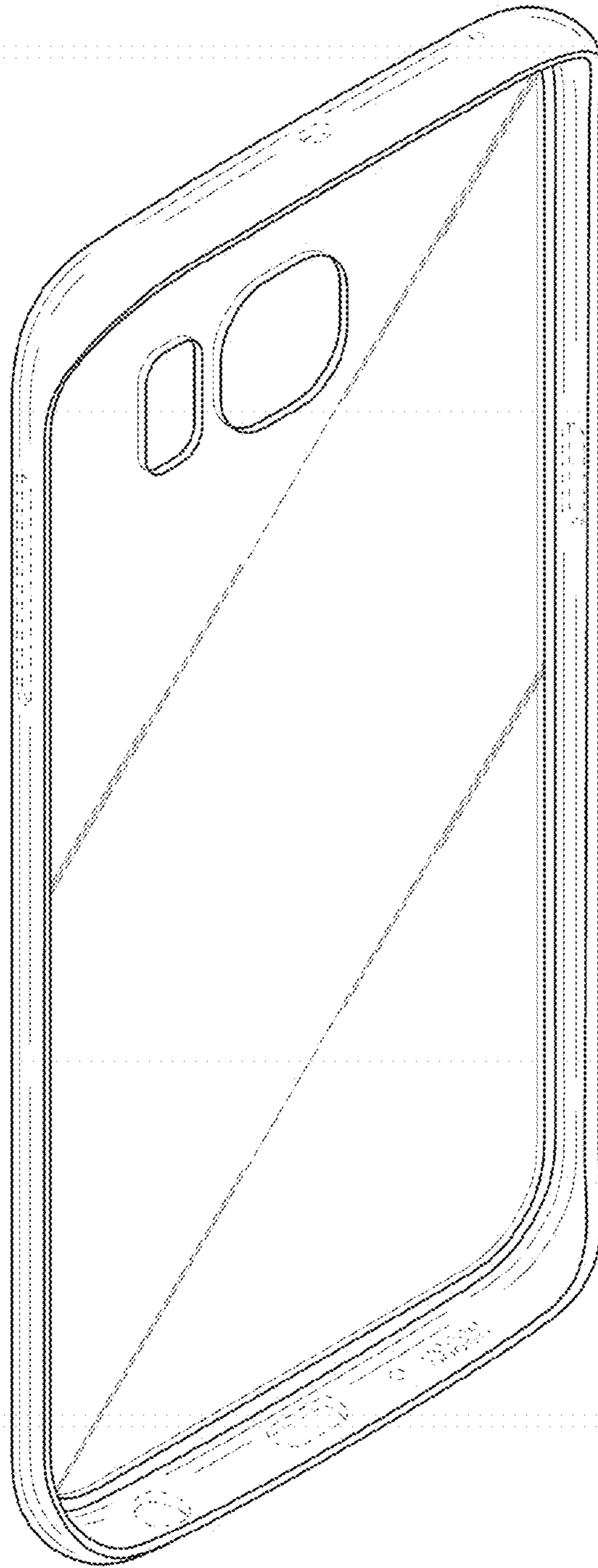

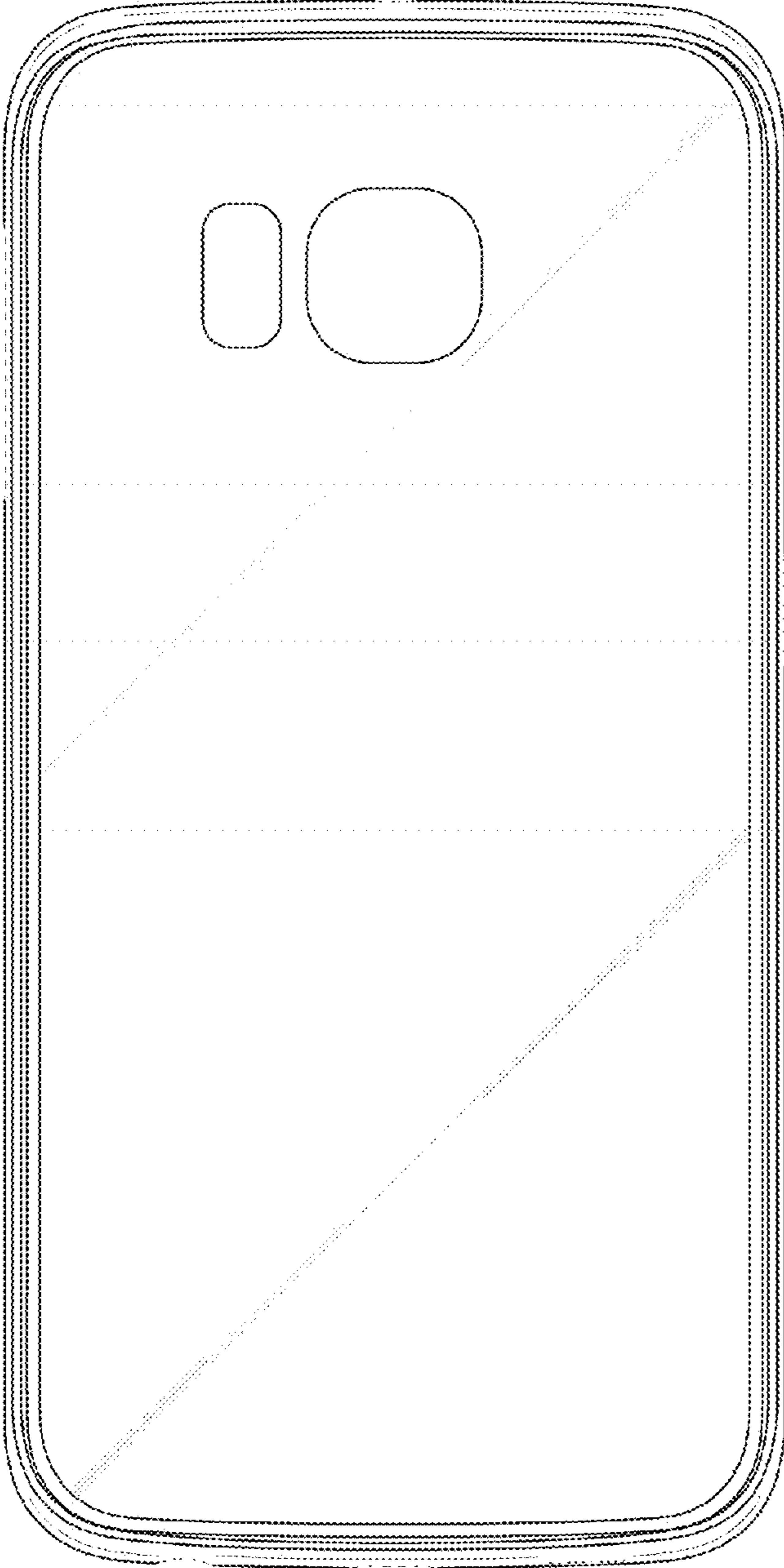

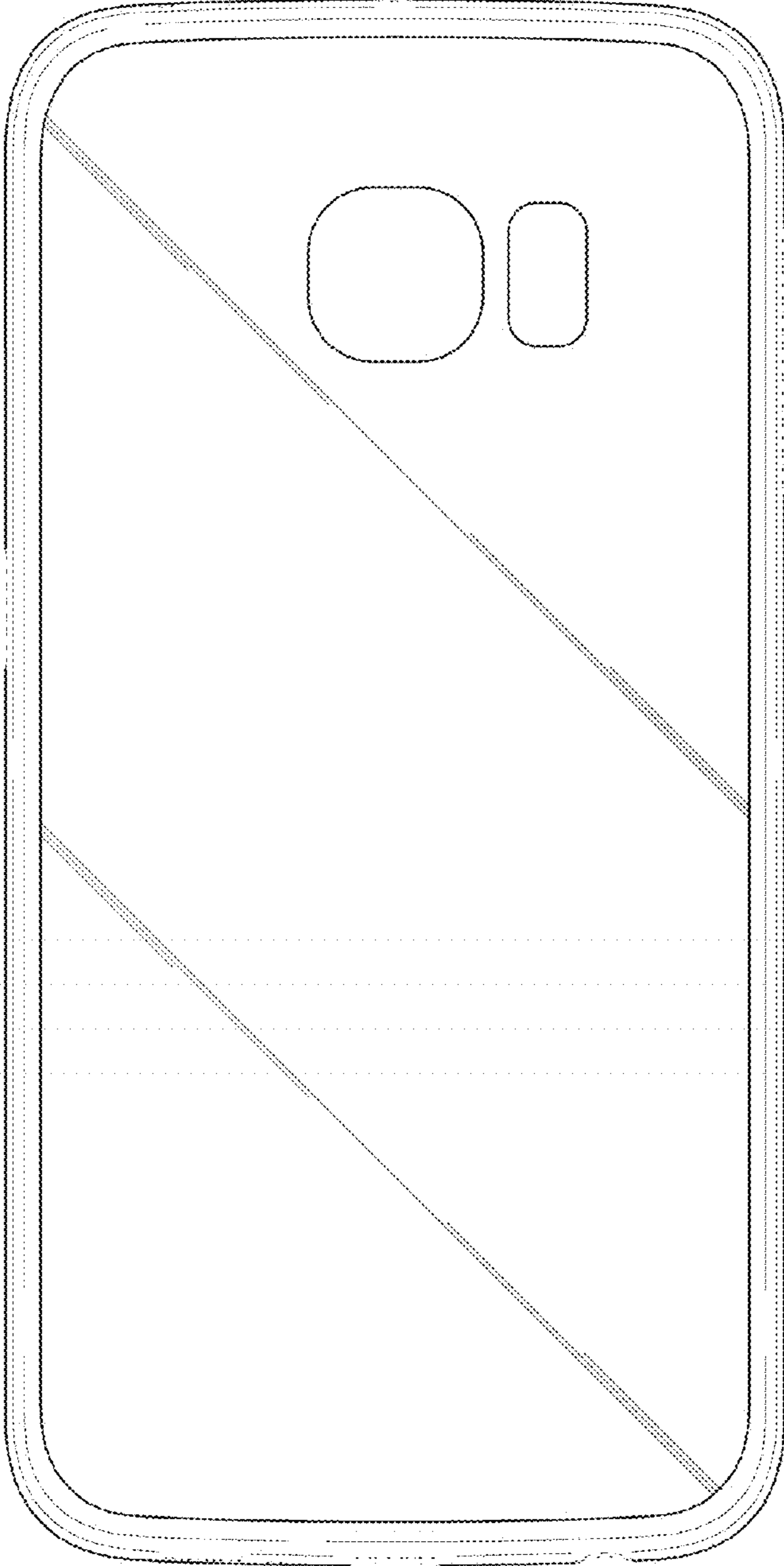

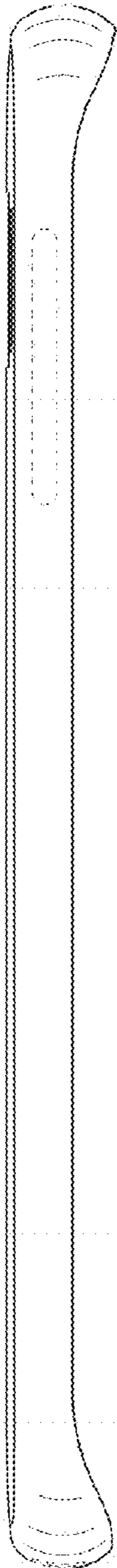

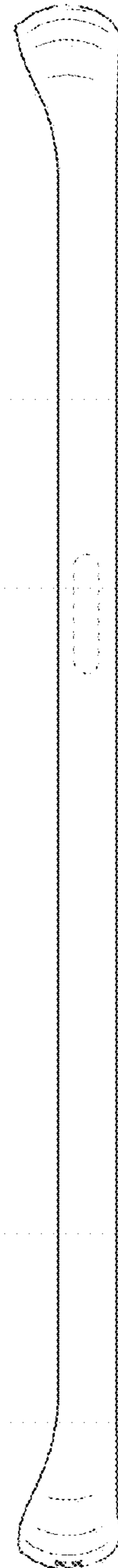

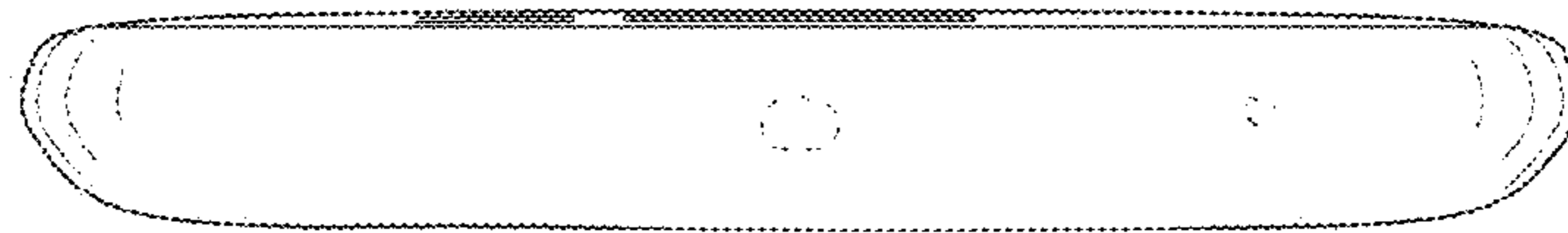

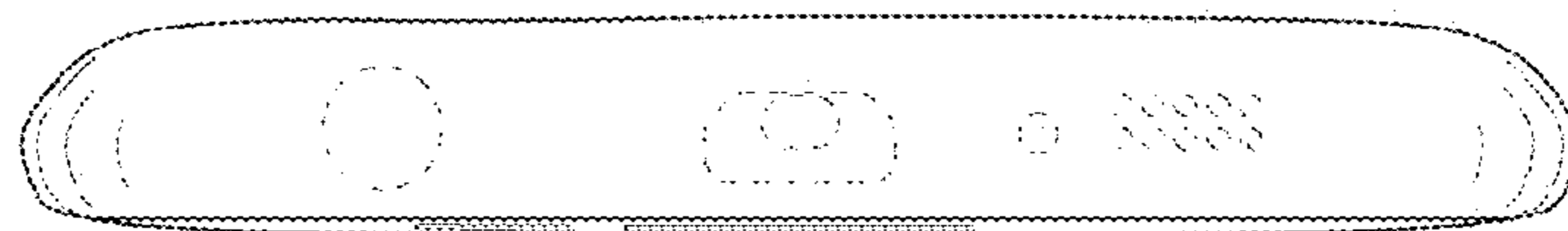

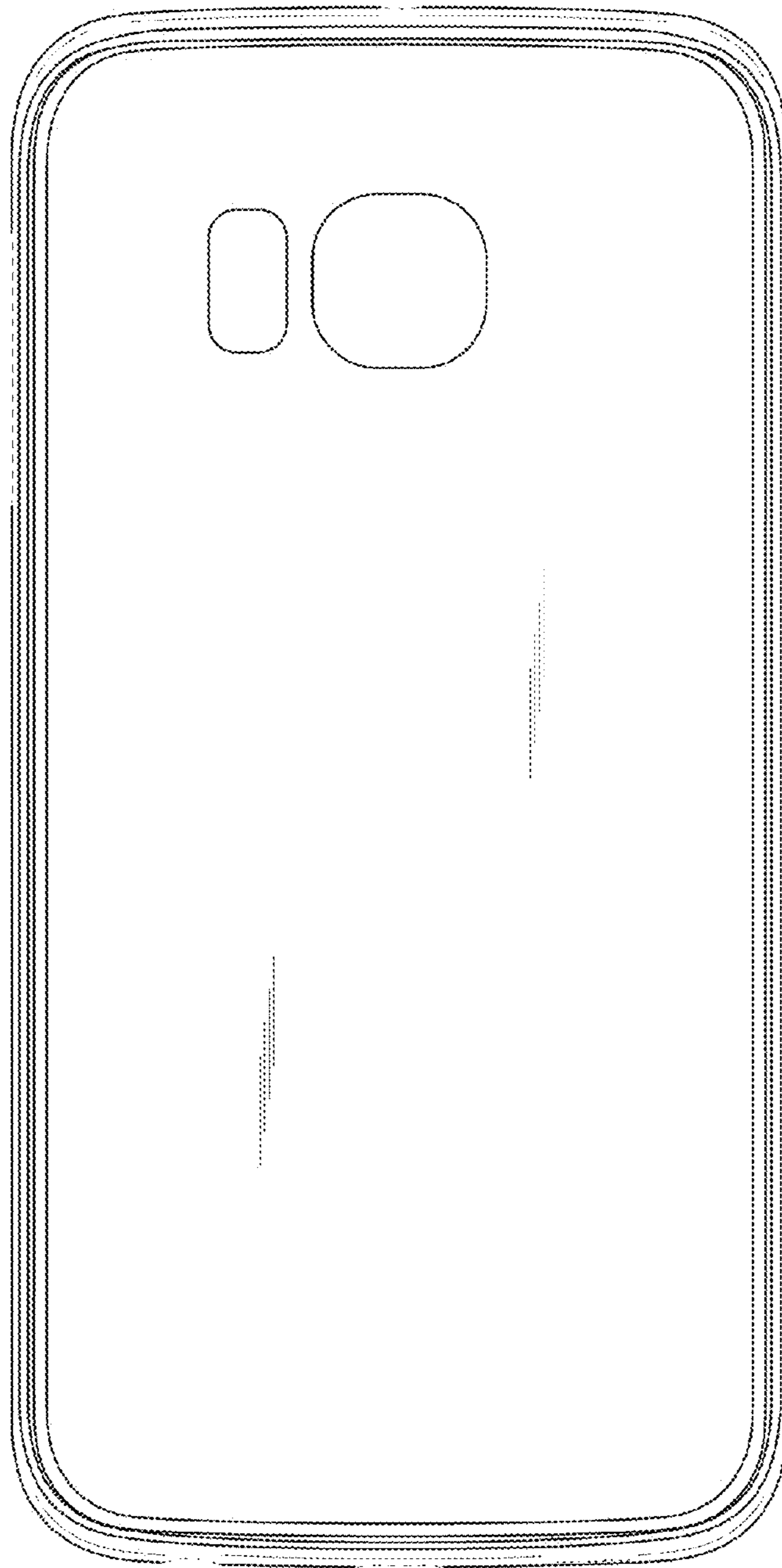

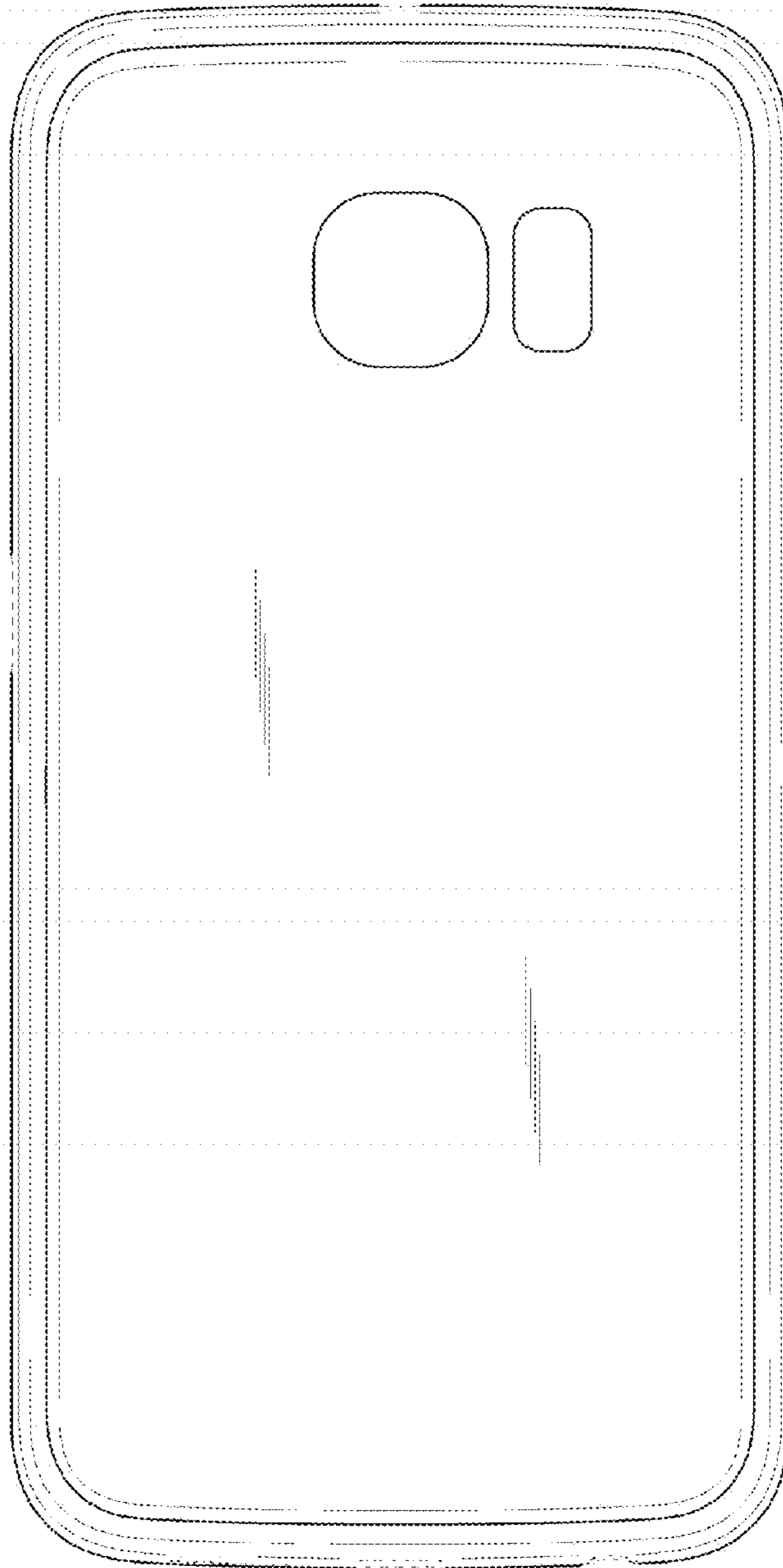

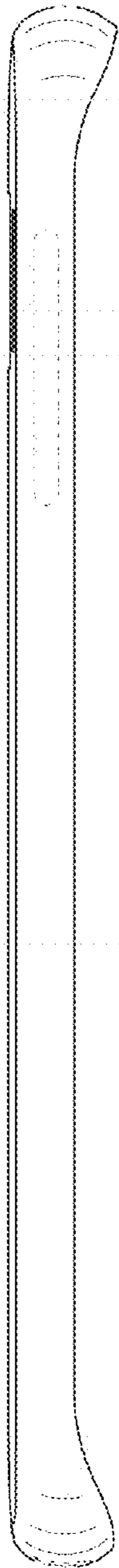

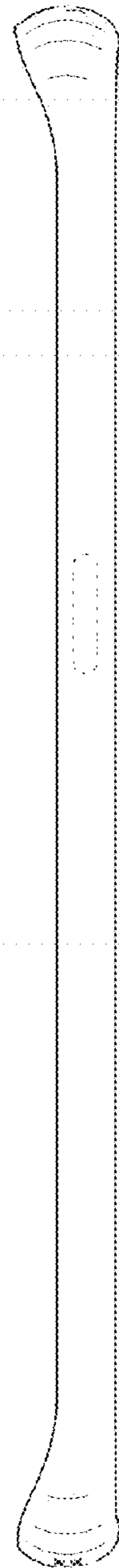

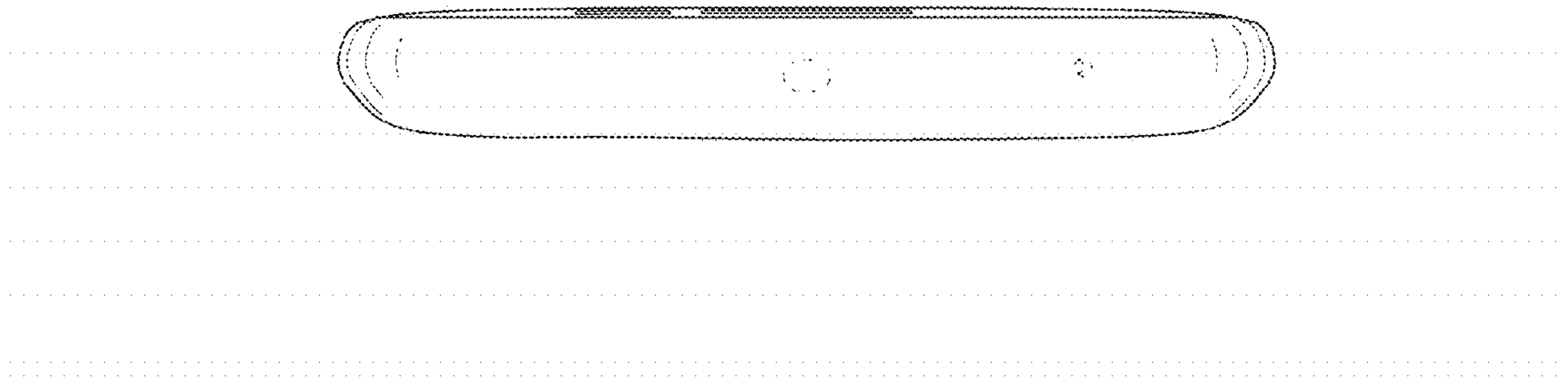
