The peripheral dashed broken lines represent a display screen or portion thereof which forms no part of the claimed design.

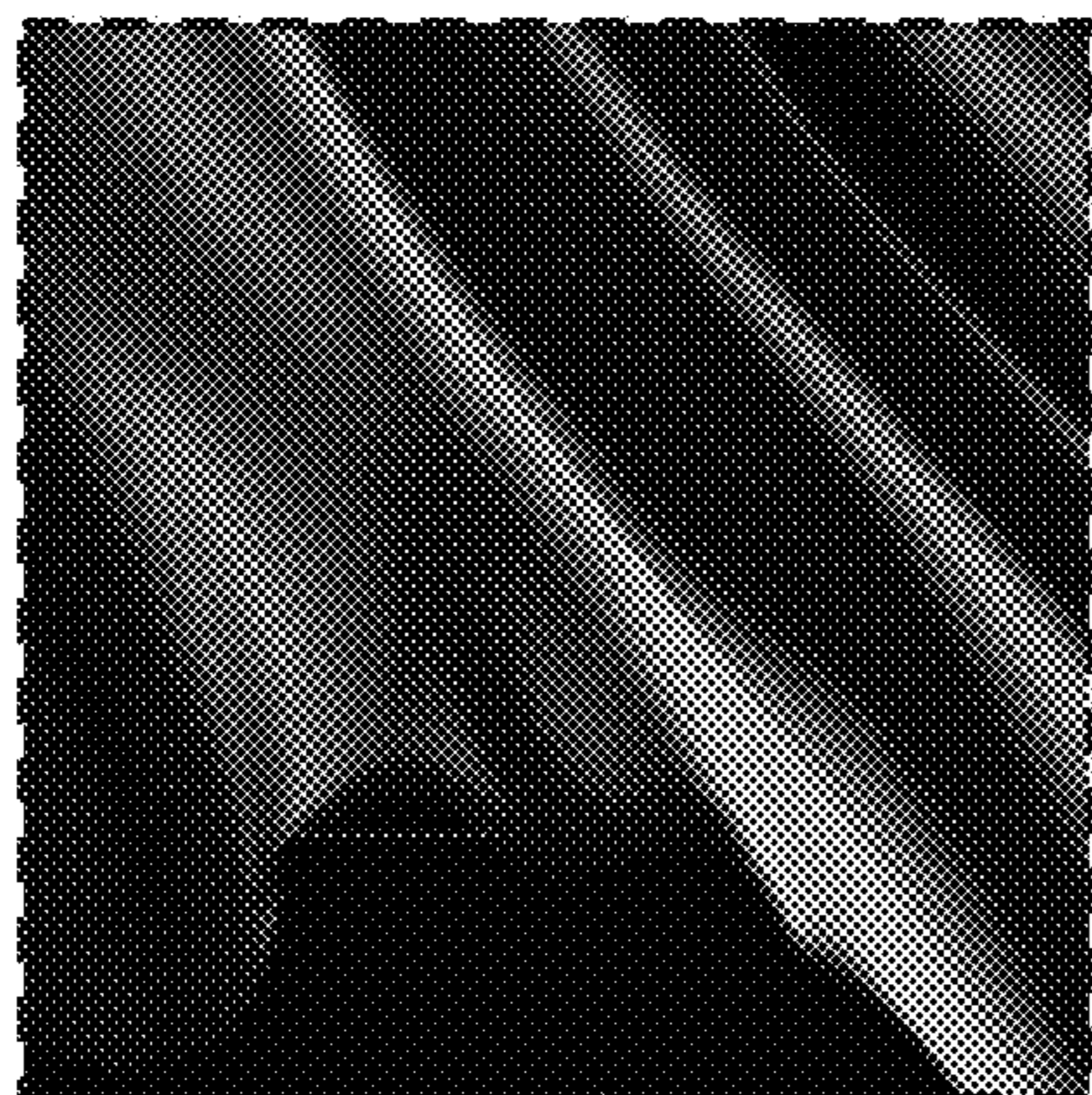

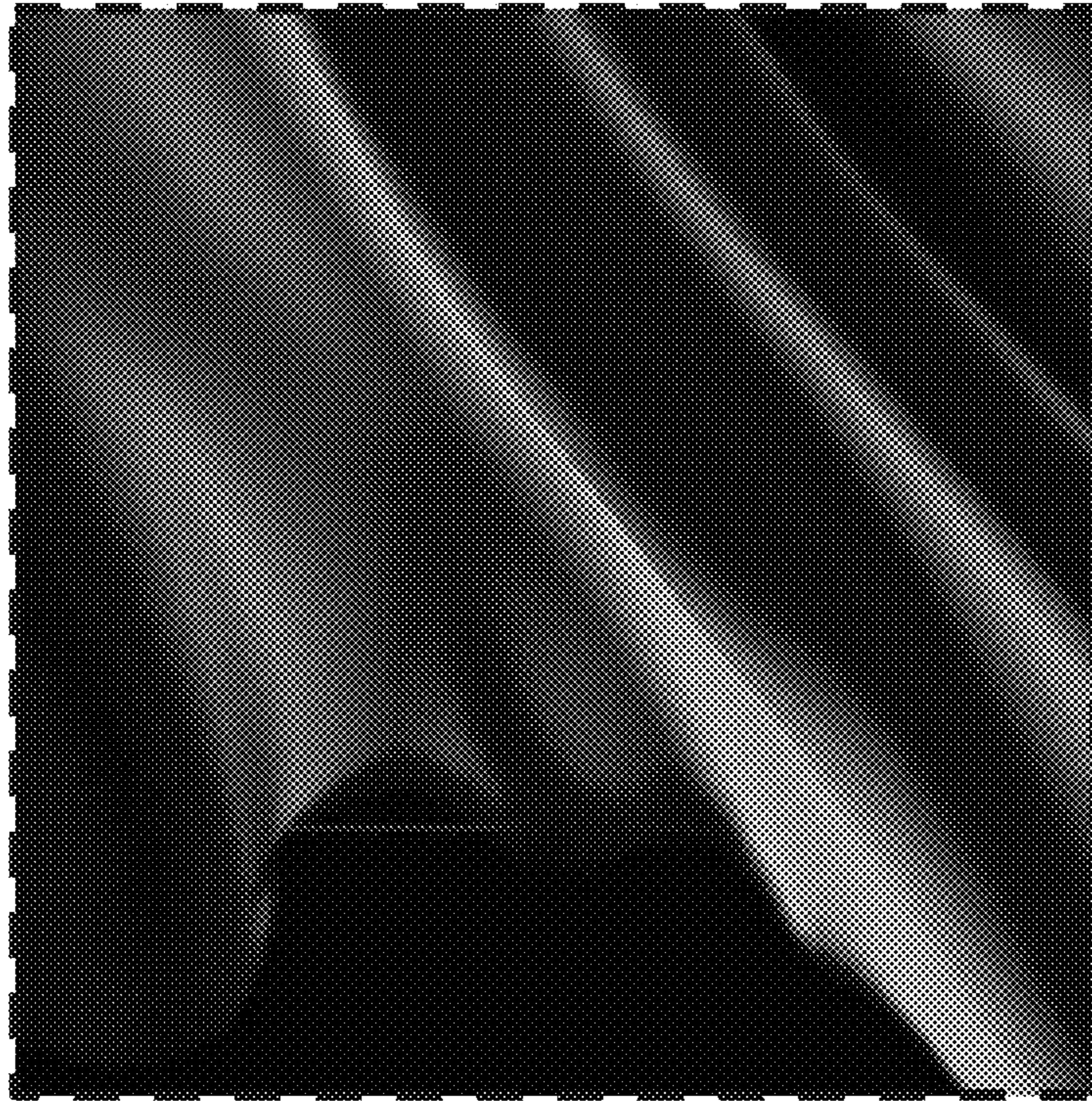

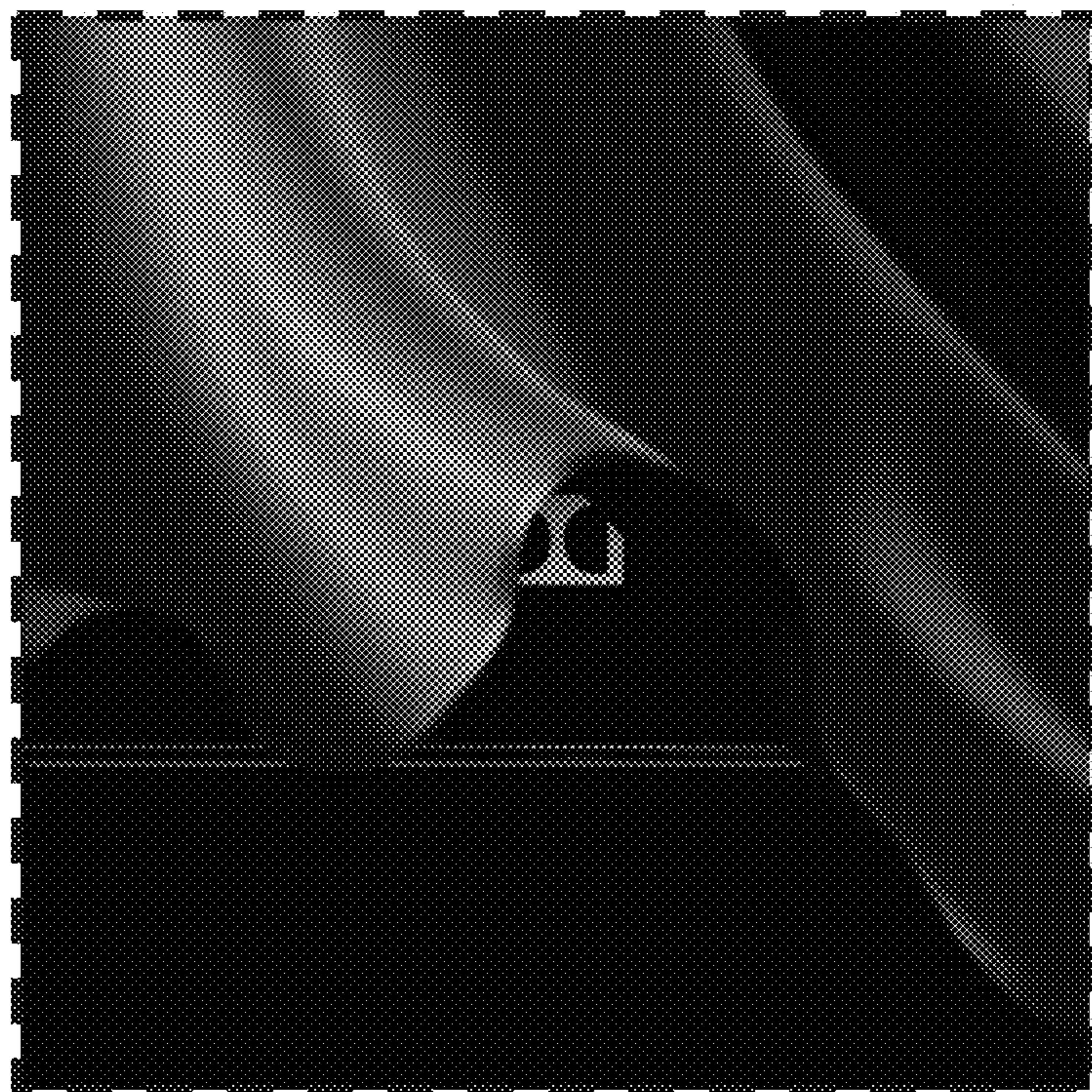

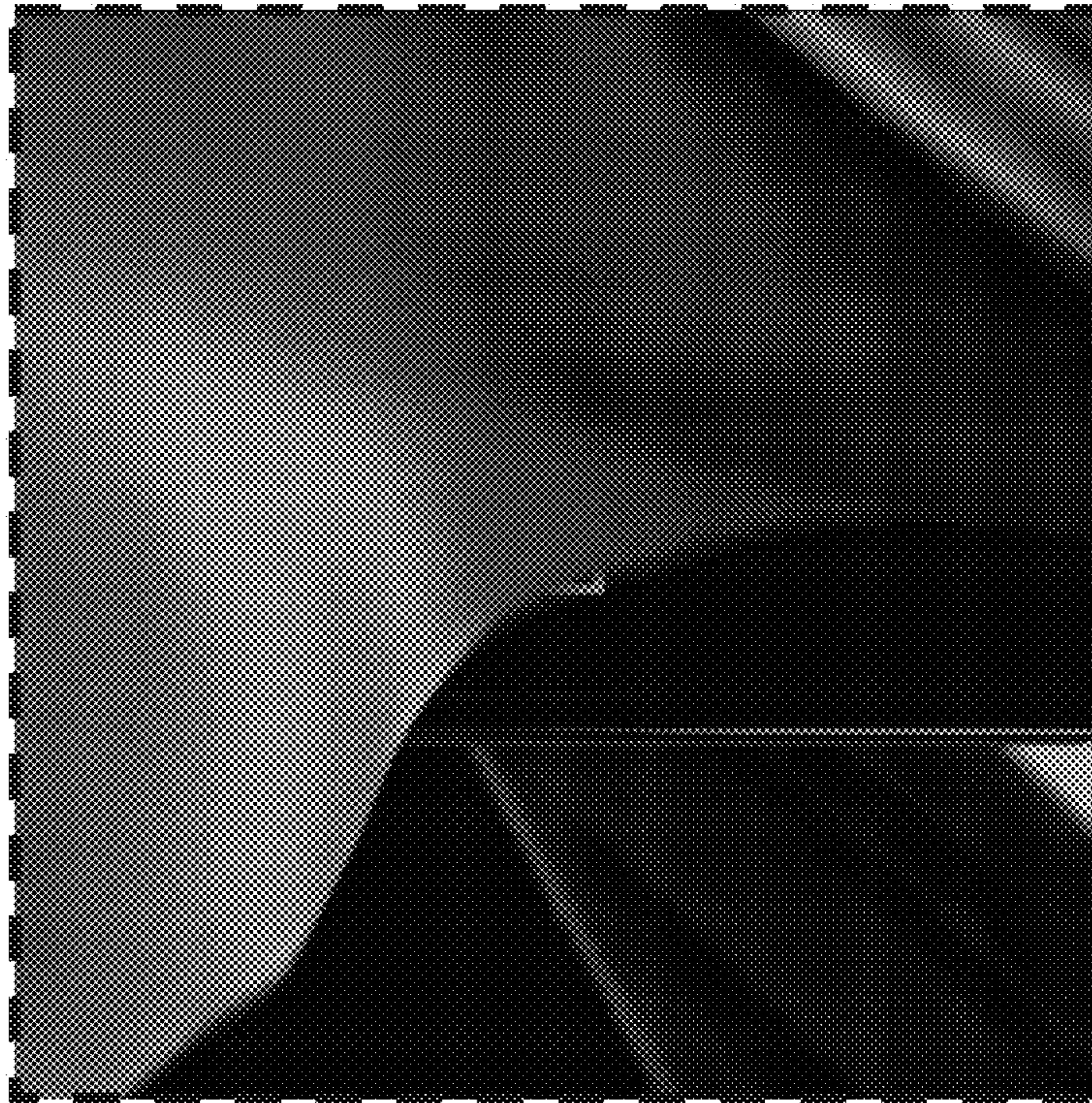

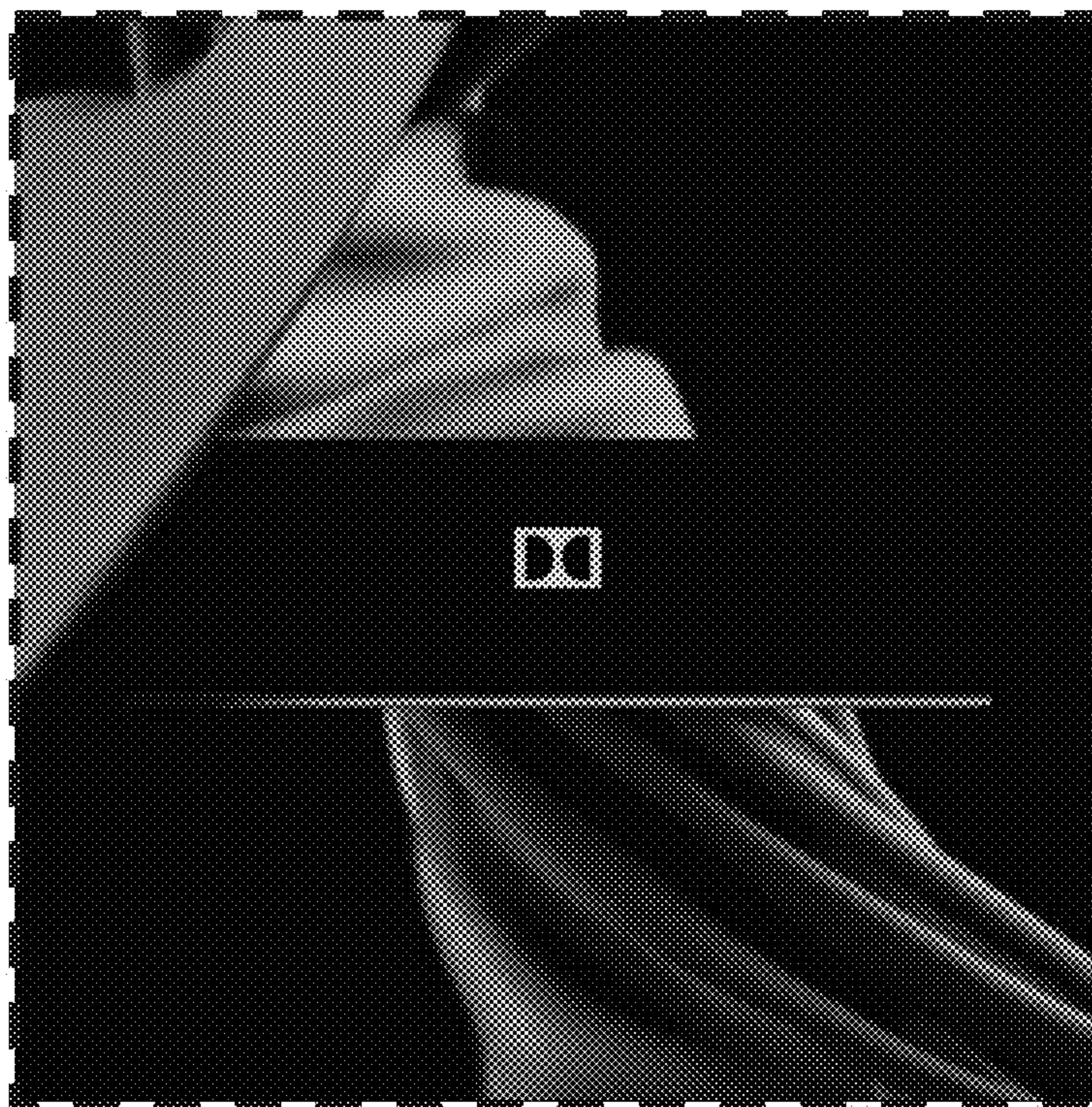

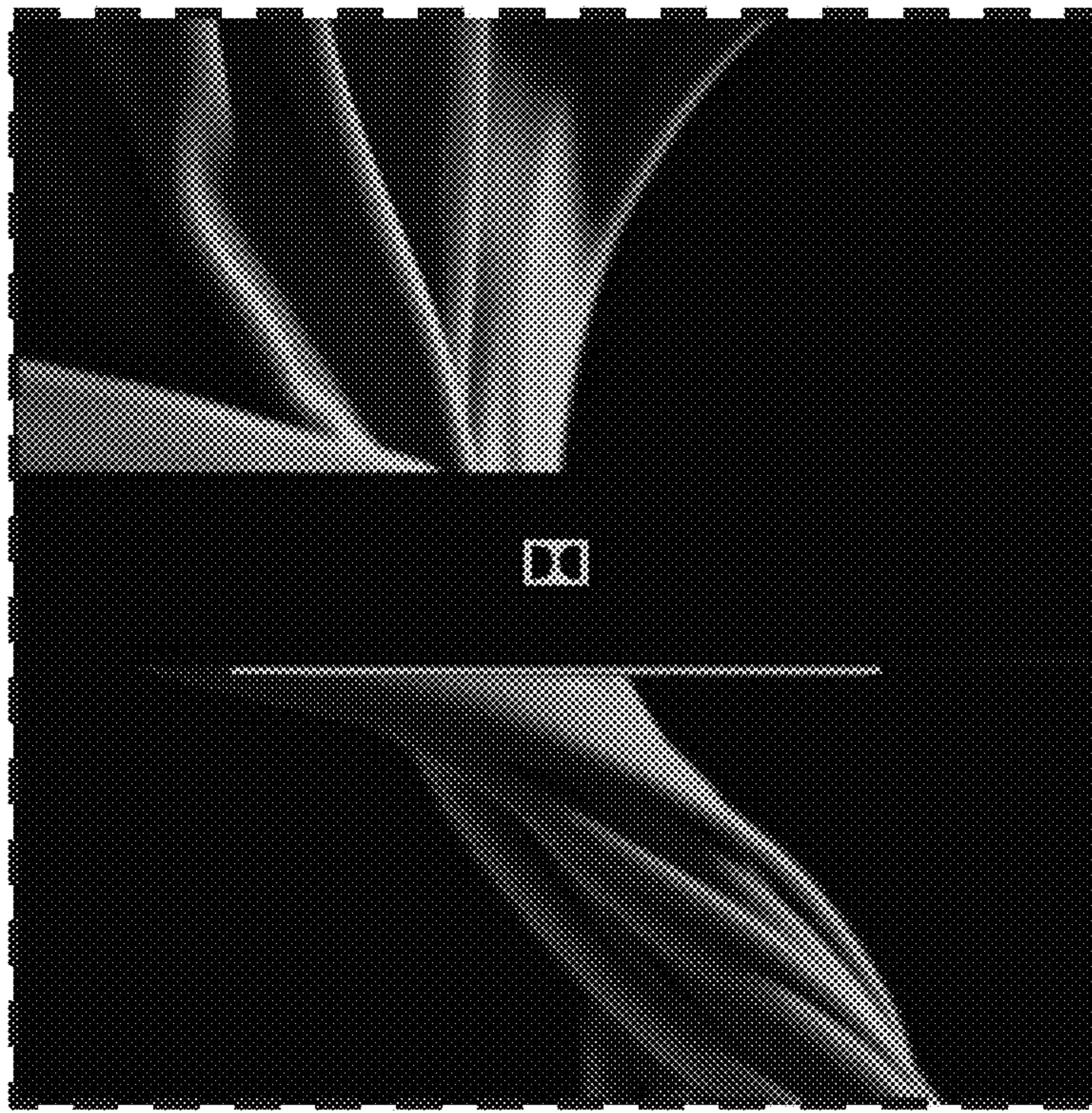
