FIG. 5 is a fifth image thereof;

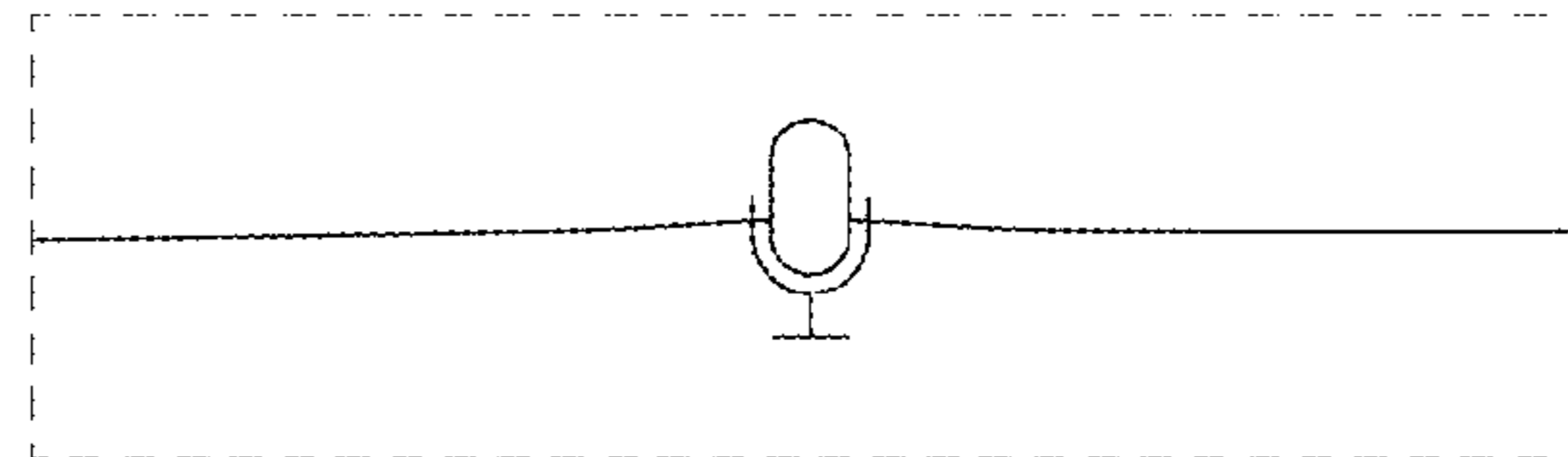
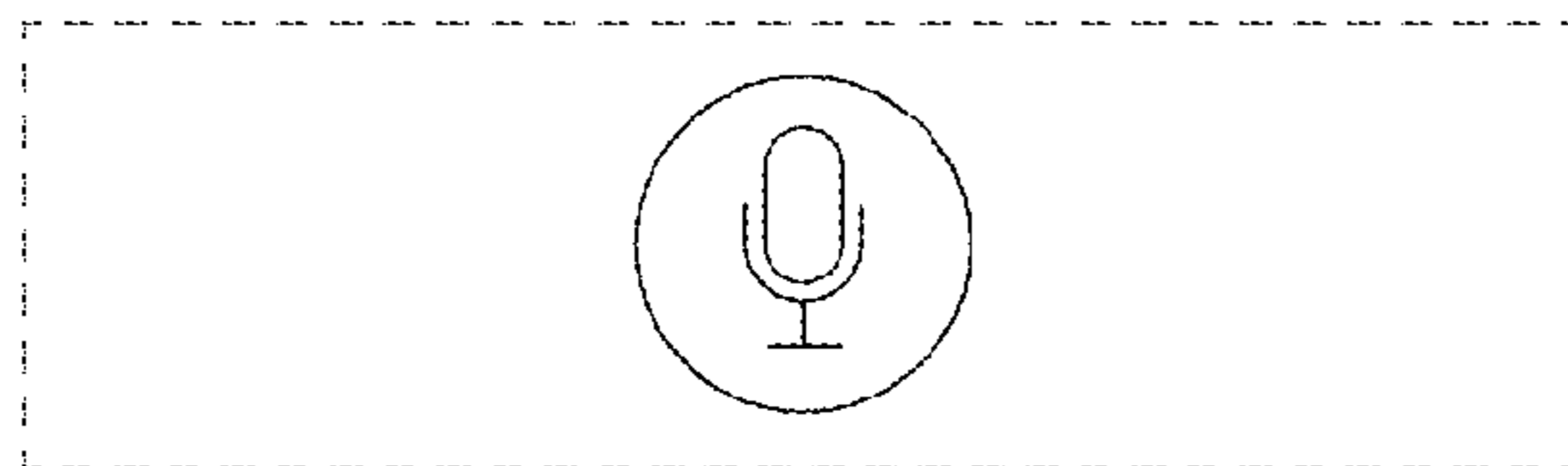
FIG. 6 is a sixth image thereof; and,

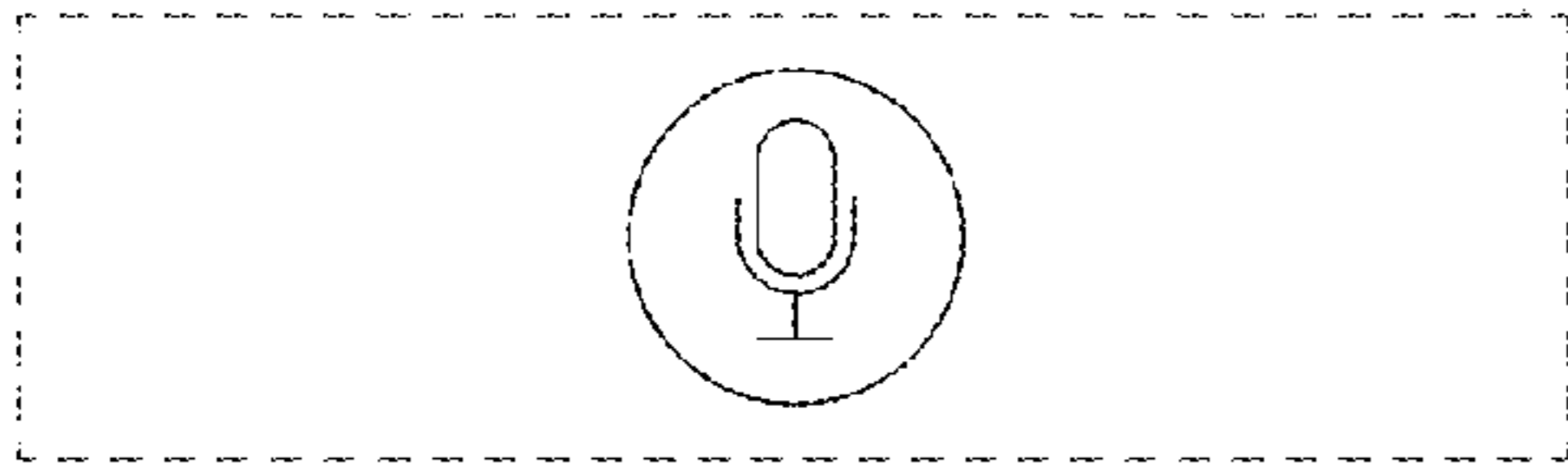

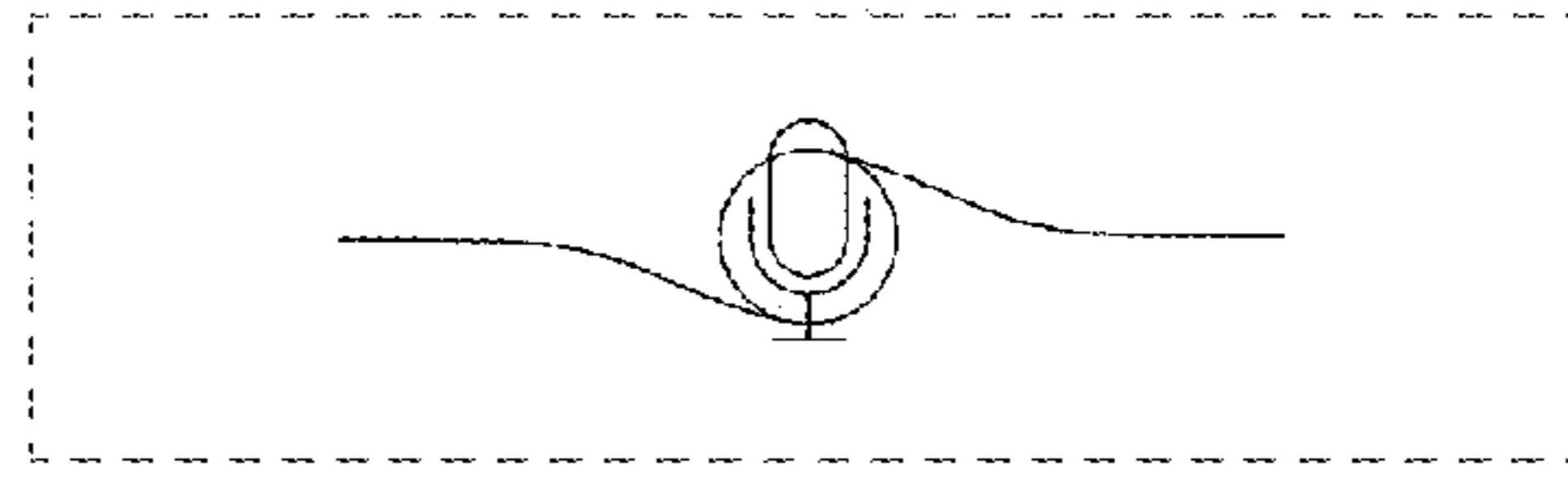

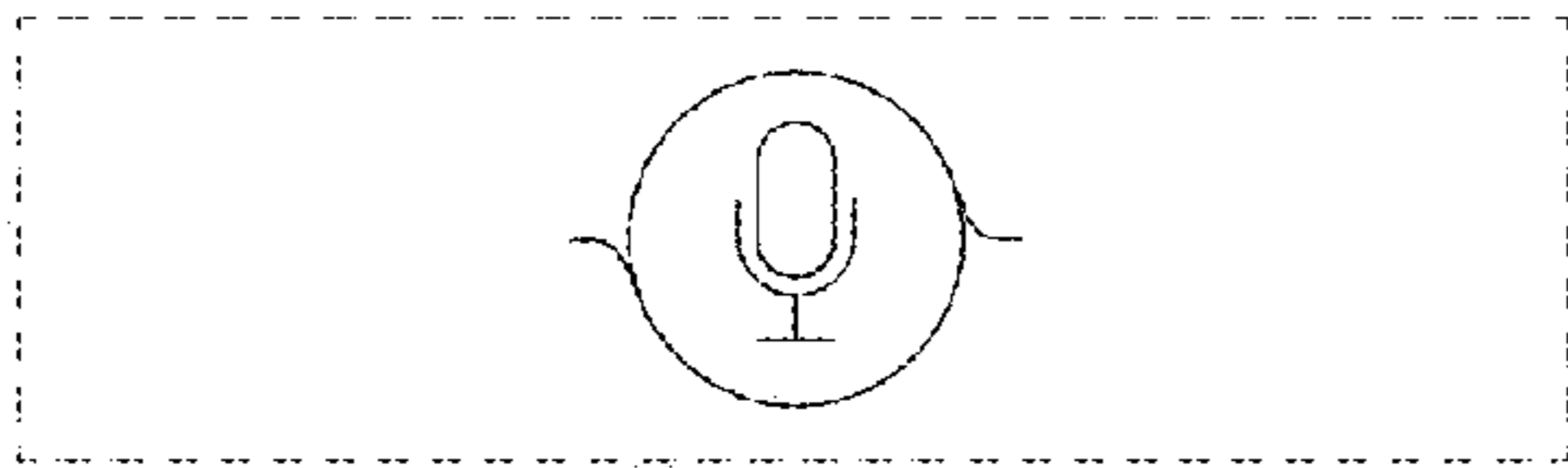

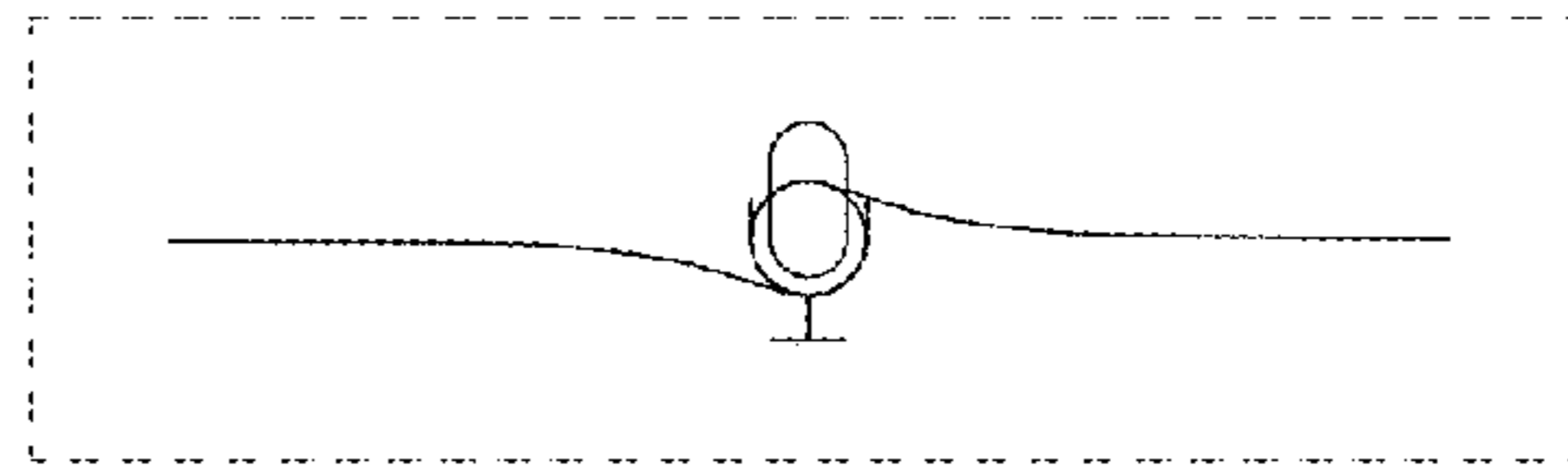

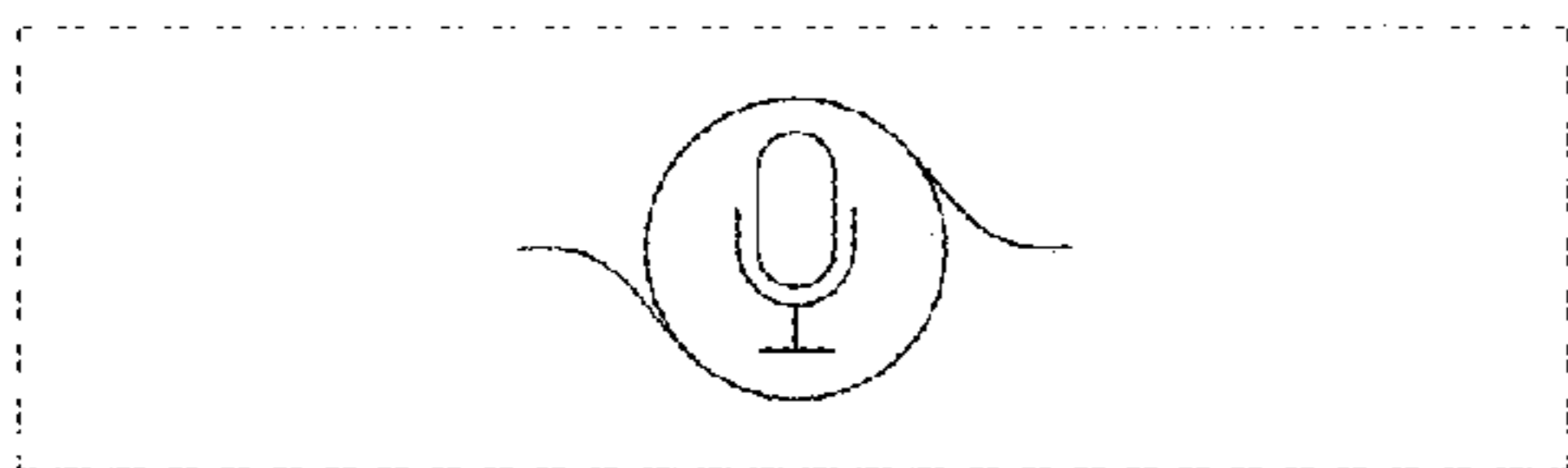

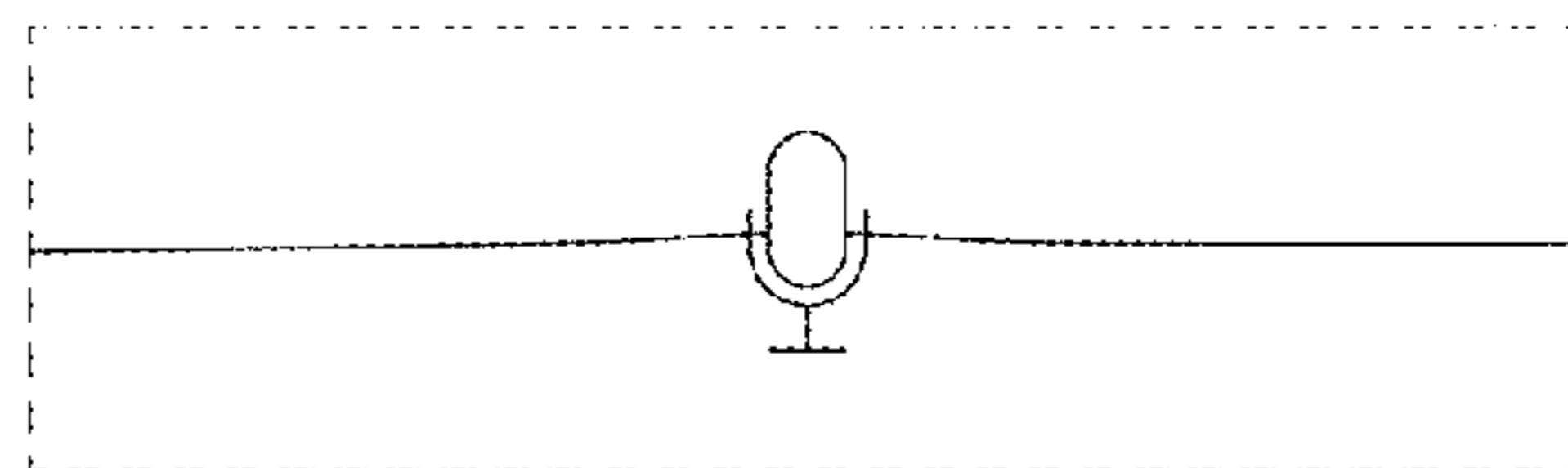

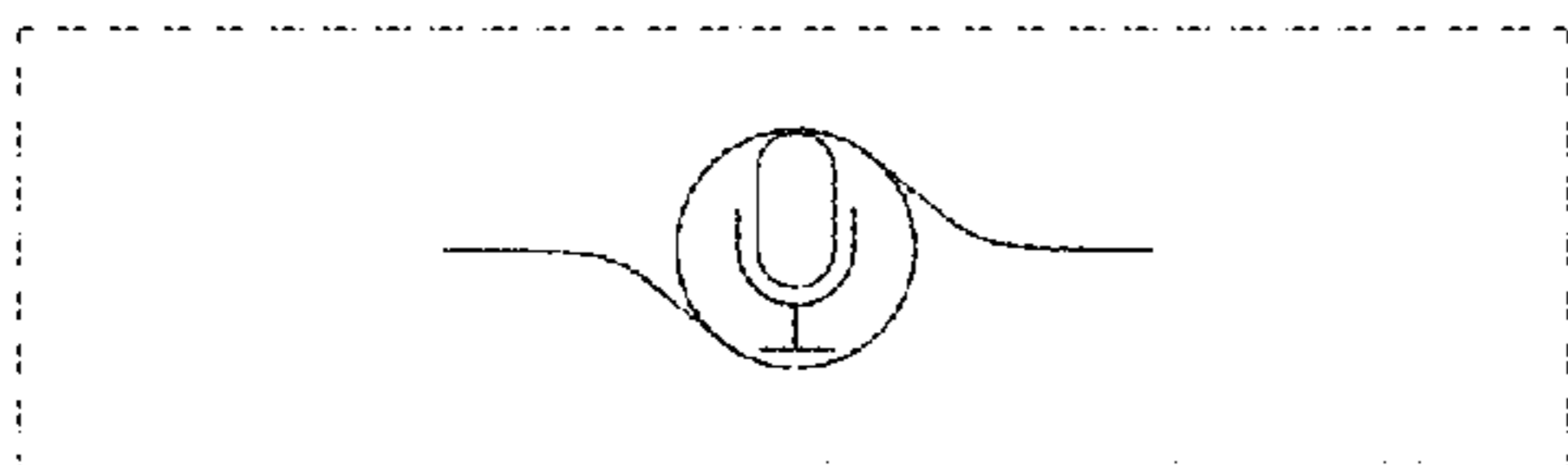
