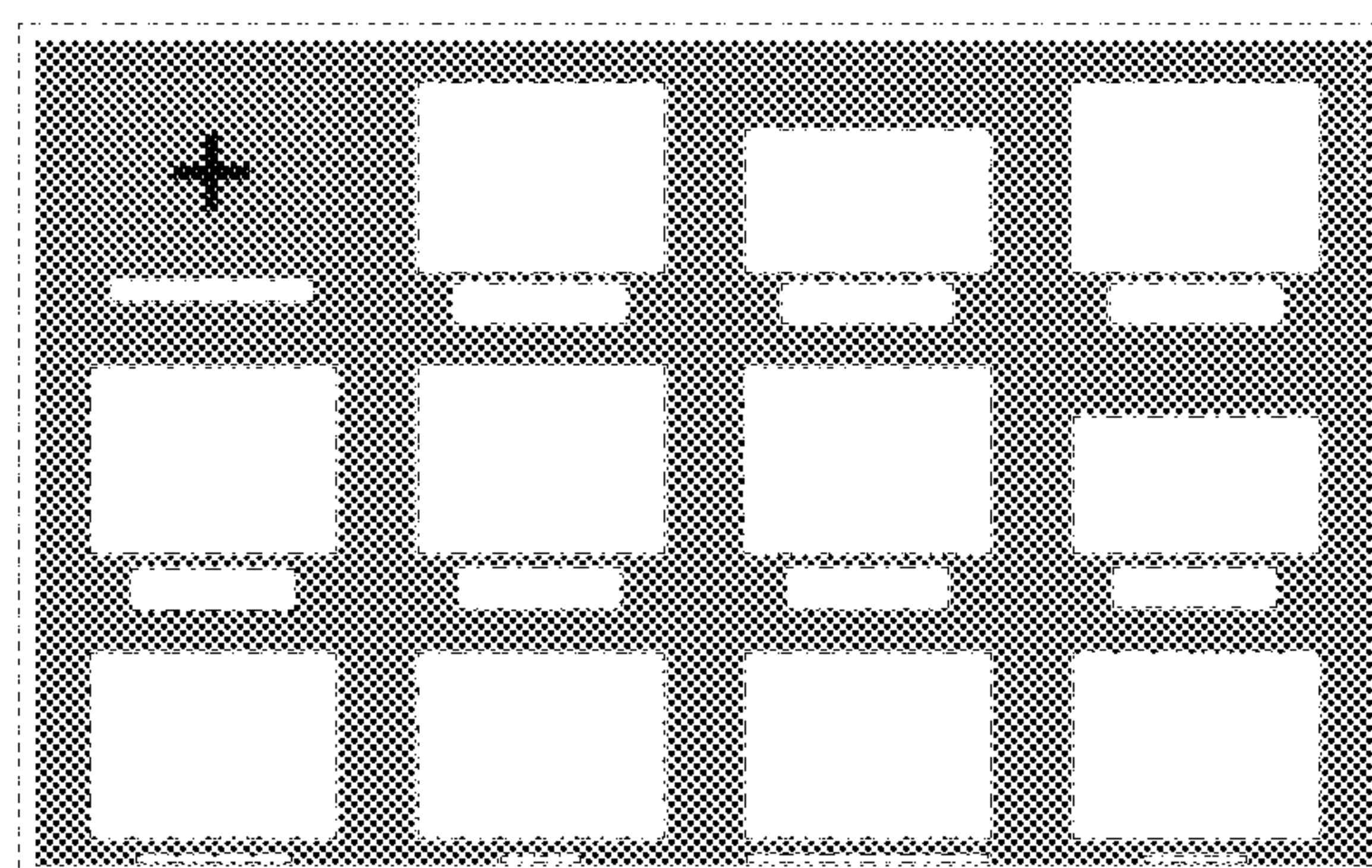
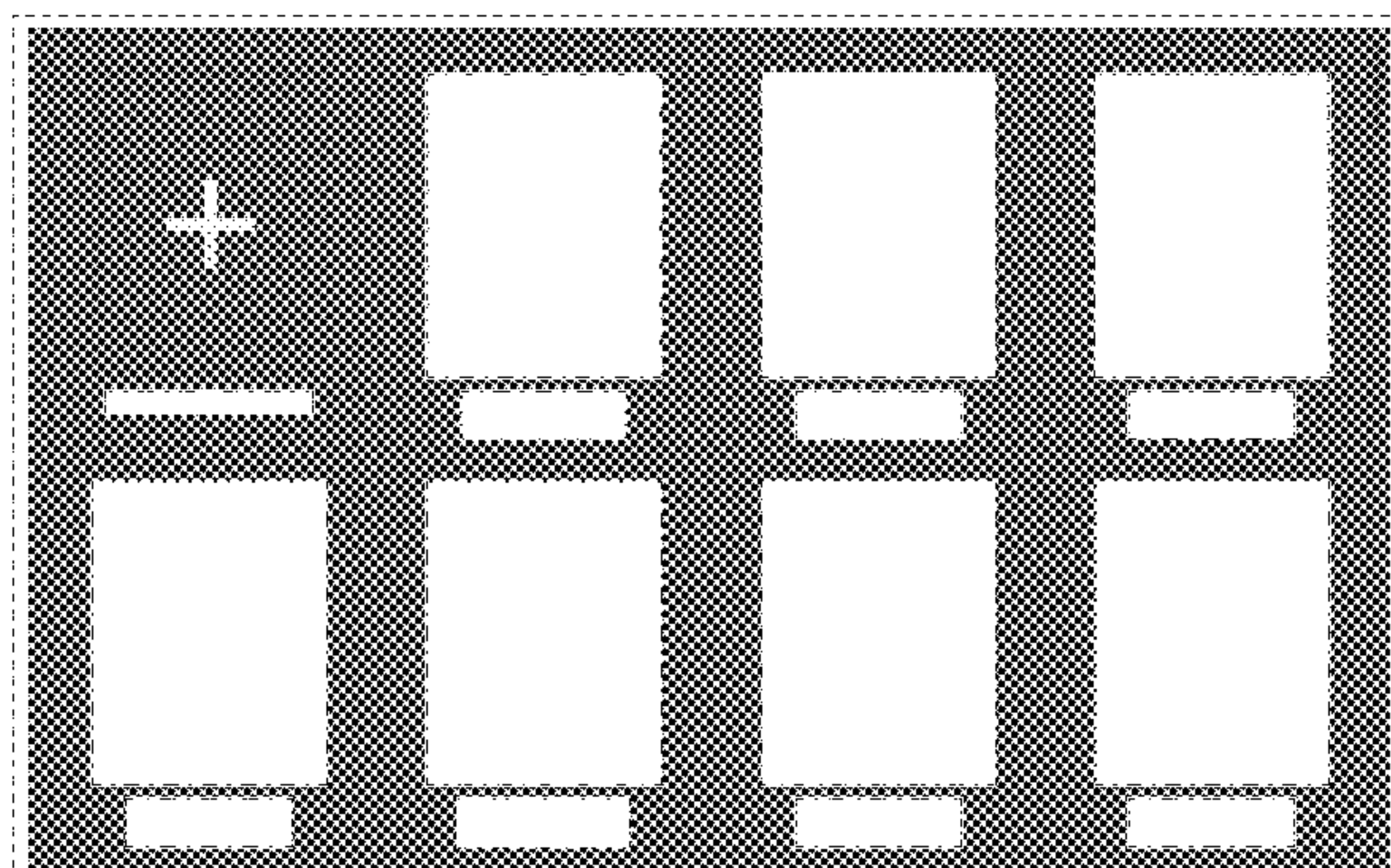
The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen or portion thereof with graphical user interface showing our new design; FIG. 2 is another embodiment thereof; FIG. 3 is another embodiment thereof; and, FIG. 4 is another embodiment thereof.

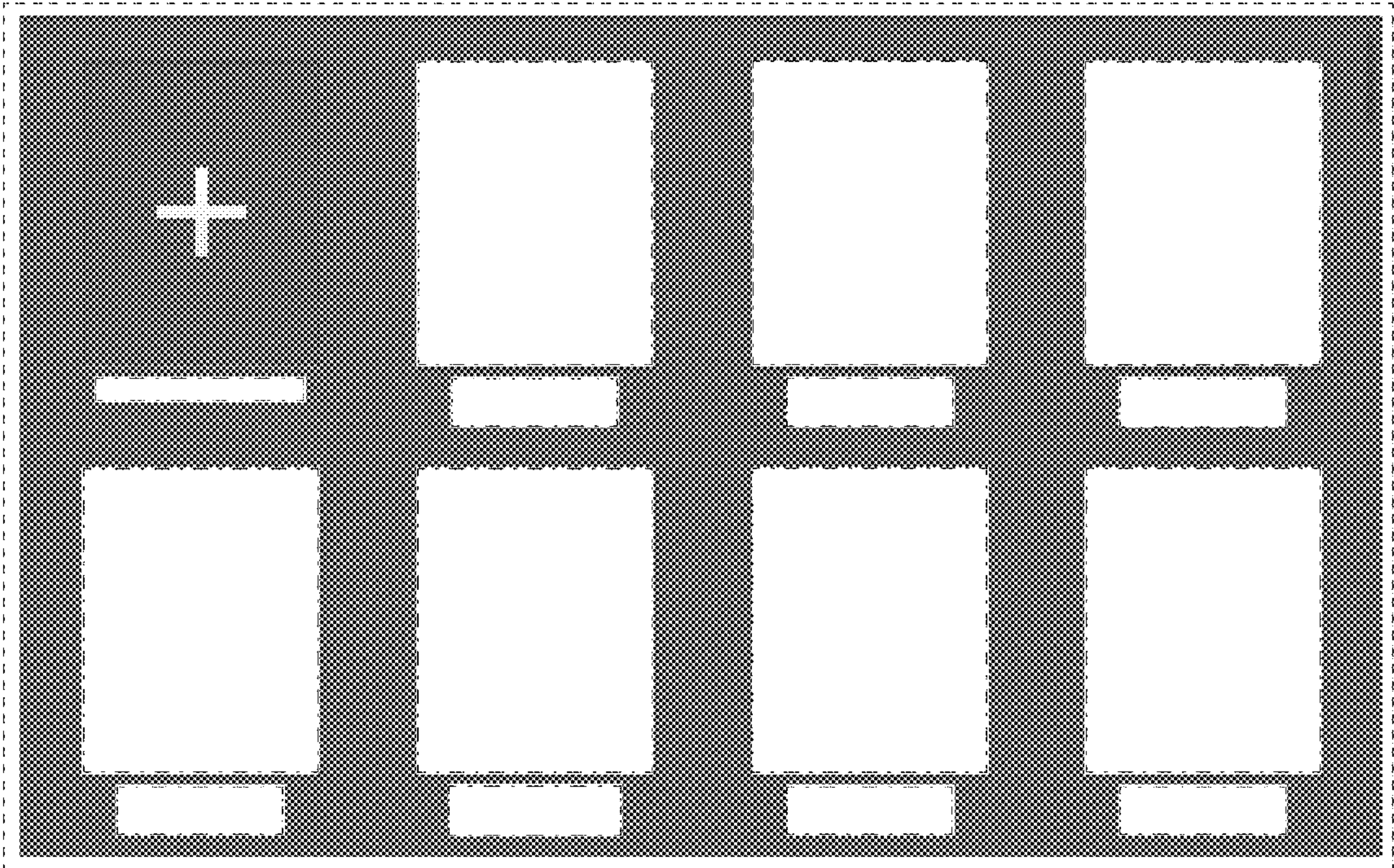

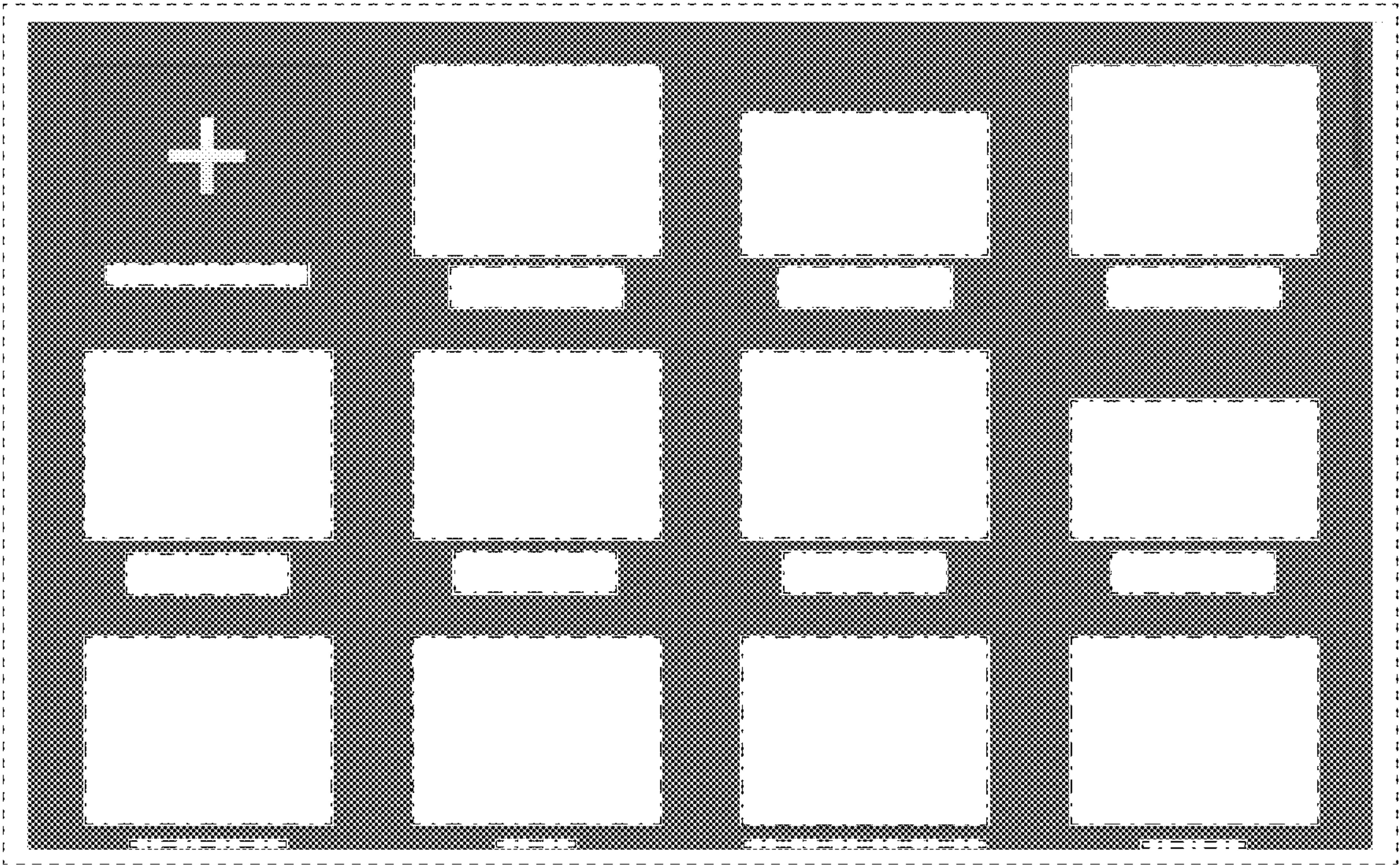

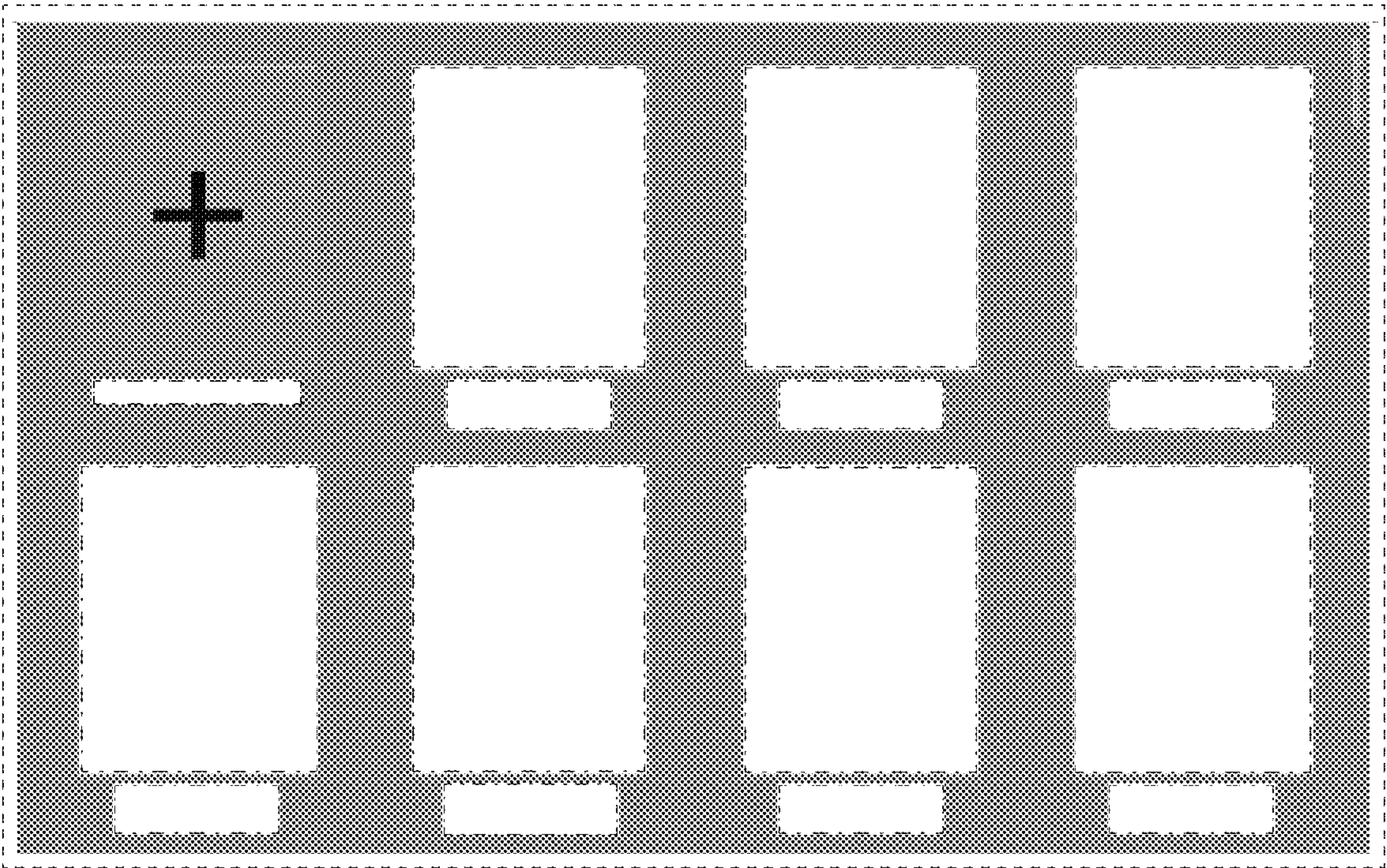

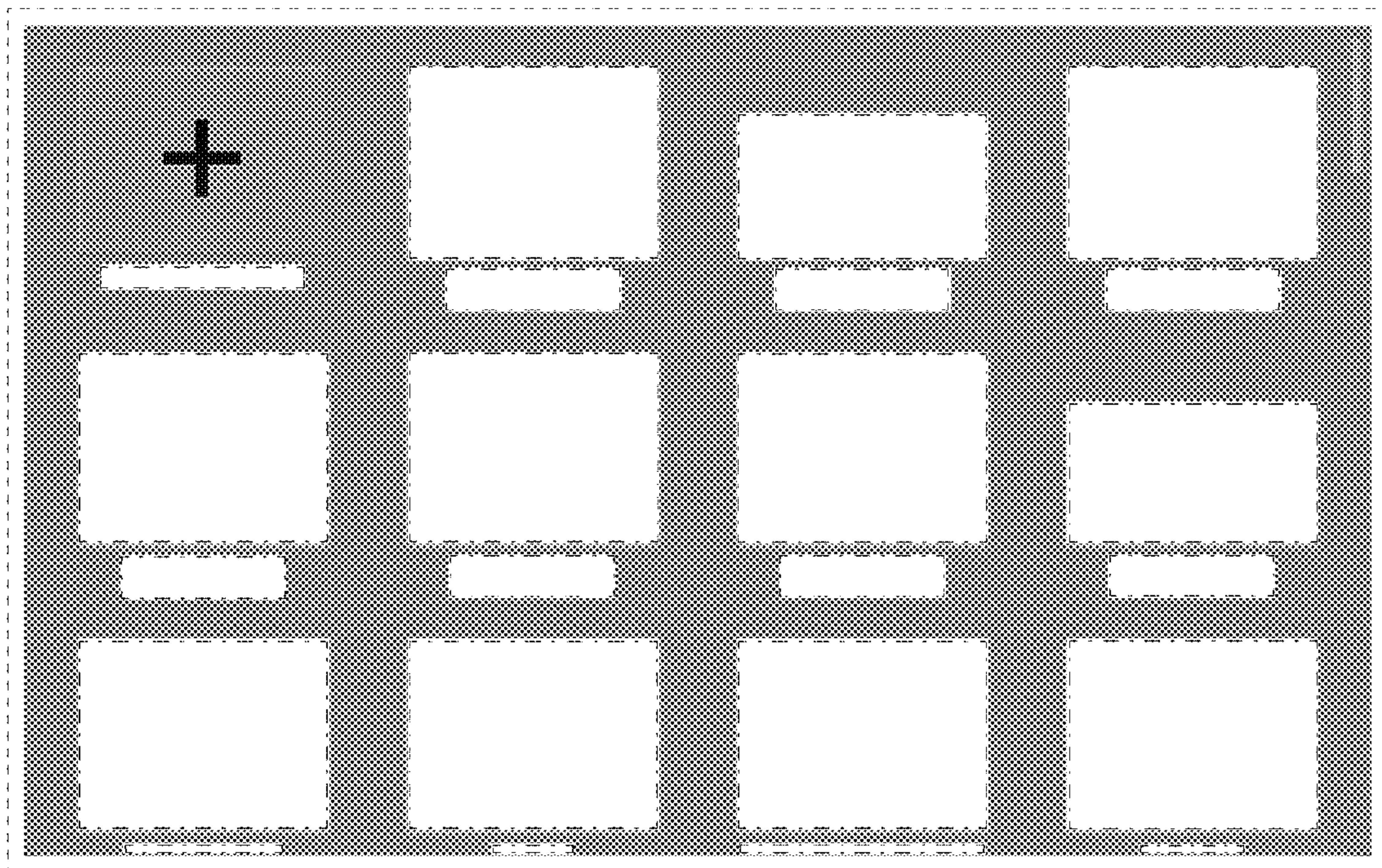
