The ornamental design for a display screen with a graphical user interface, as shown and described.

DESCRIPTION

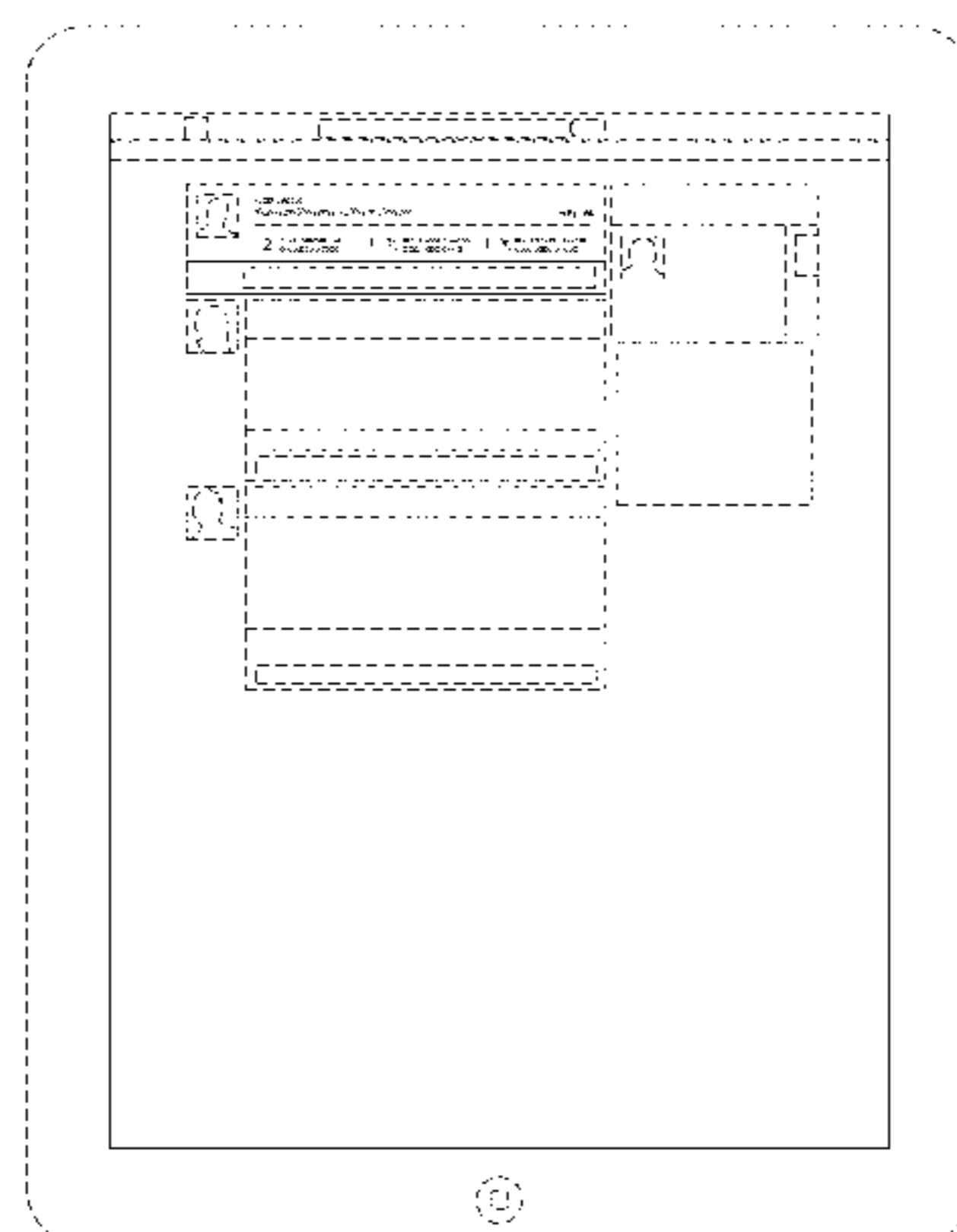
FIGS. 1 and 2 are portrait and landscape front views of a display screen with a graphical user interface, showing our new design, according to a first and second embodiment thereof.

FIGS. 3 and 4 are portrait and landscape front views of a display screen with graphical user interface, showing our new design, according to a third and fourth embodiment thereof; and,

FIGS. 5 and 6 are portrait and landscape front views of a display screen with graphical user interface, showing our new design, according to a fifth and sixth embodiment thereof.

The broken lines outside the largest solid line rectangle represent a display screen and forms no part of the claimed design. All other broken lines are environmental components of the graphical user interface and form no part of the claimed design.

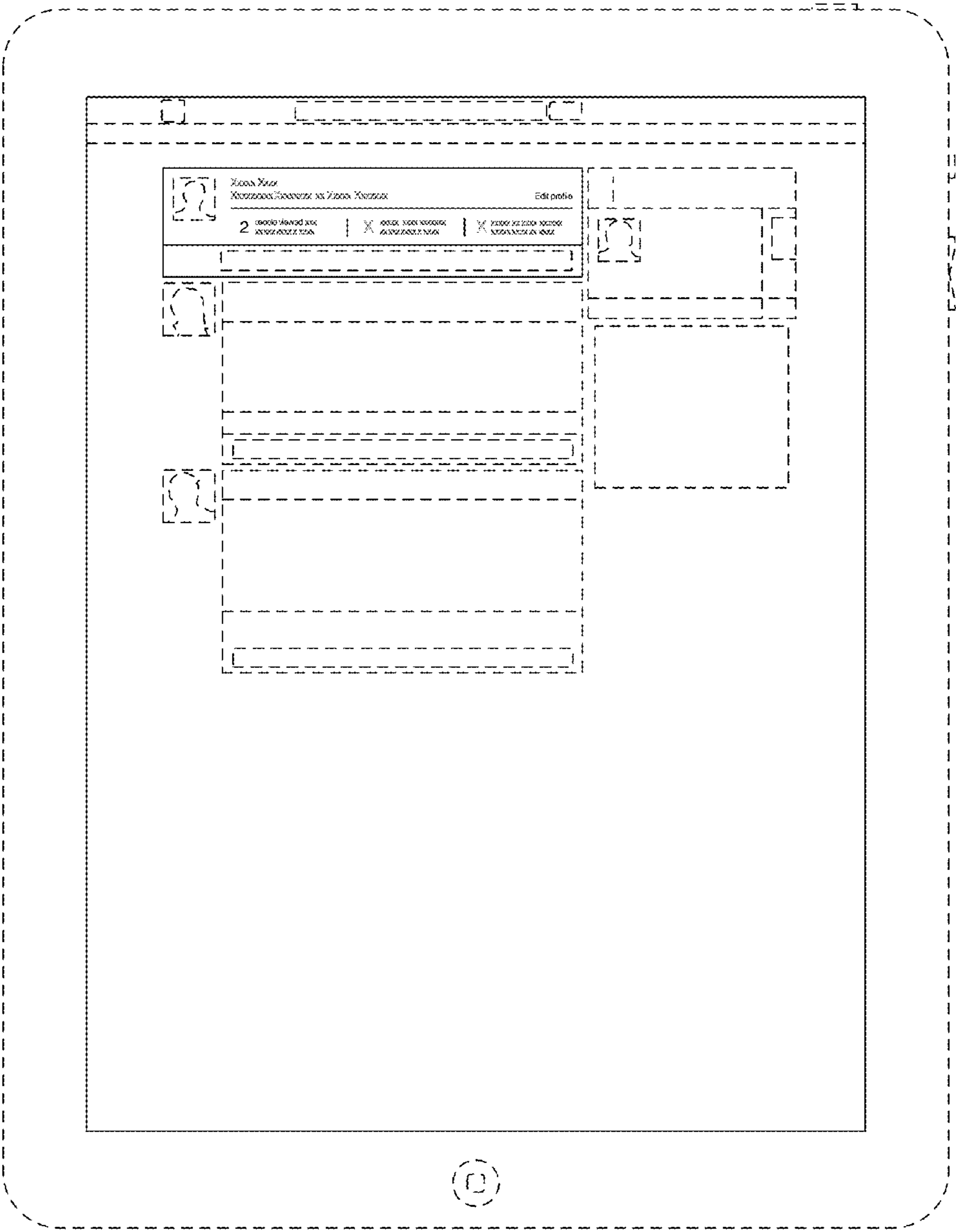

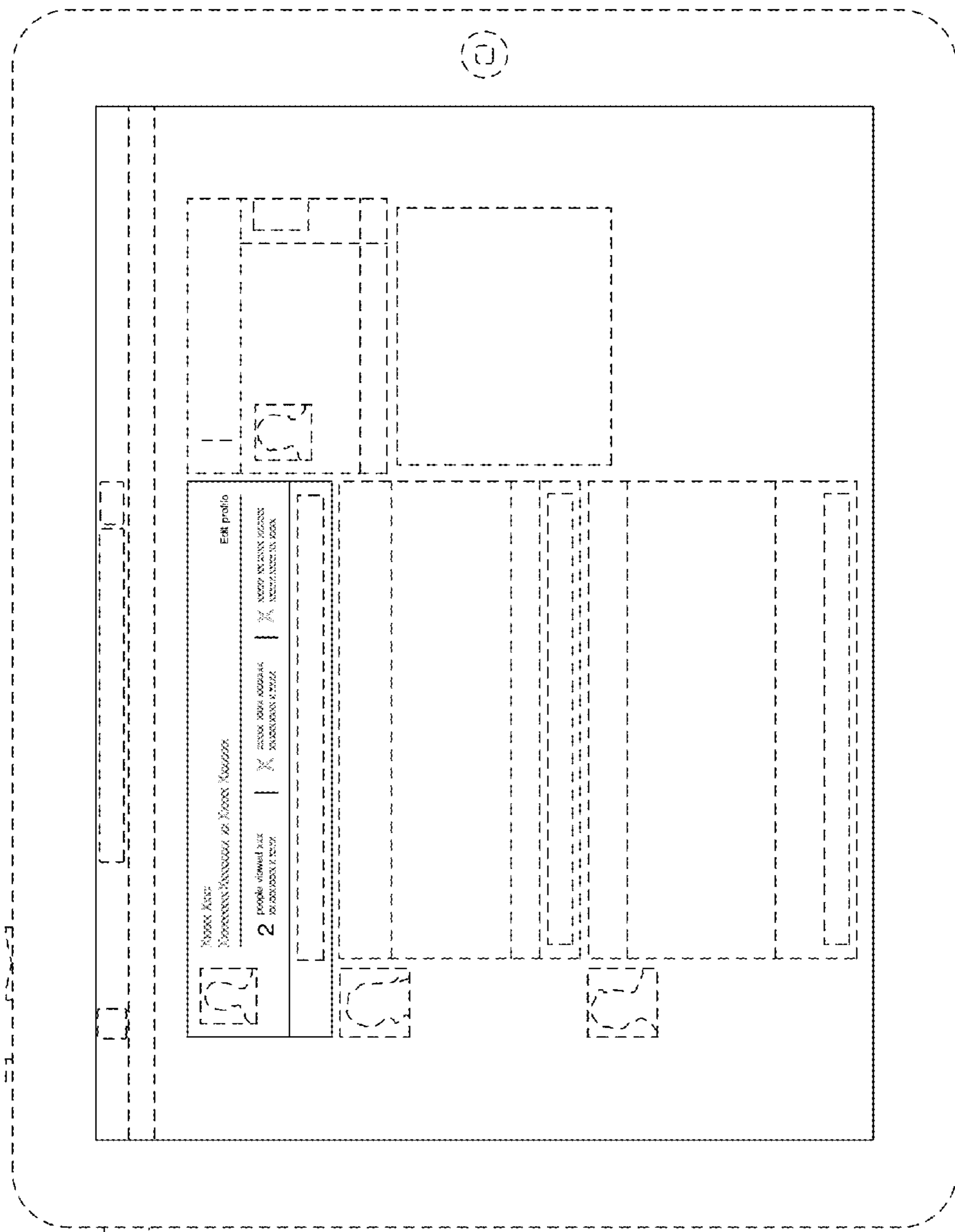

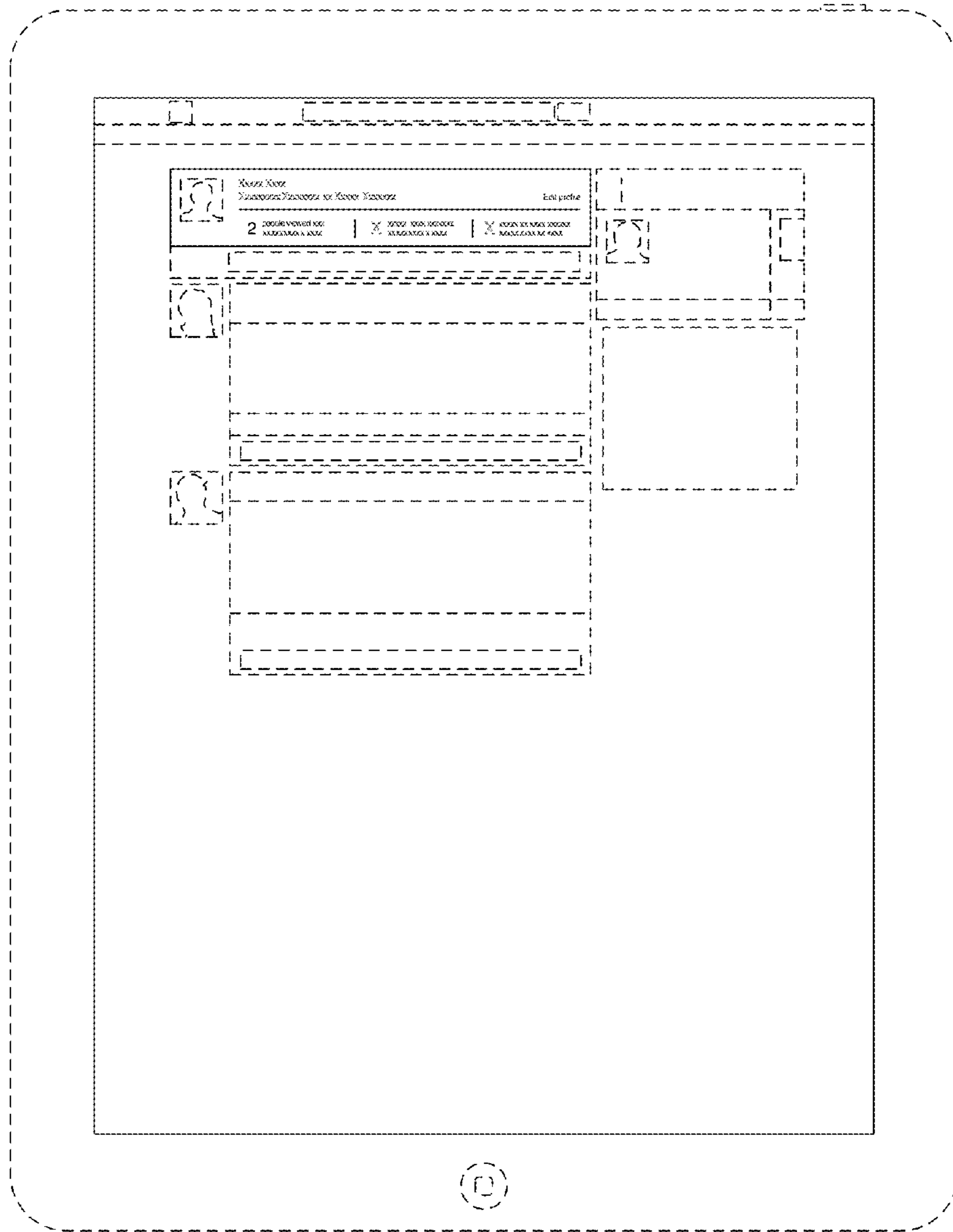

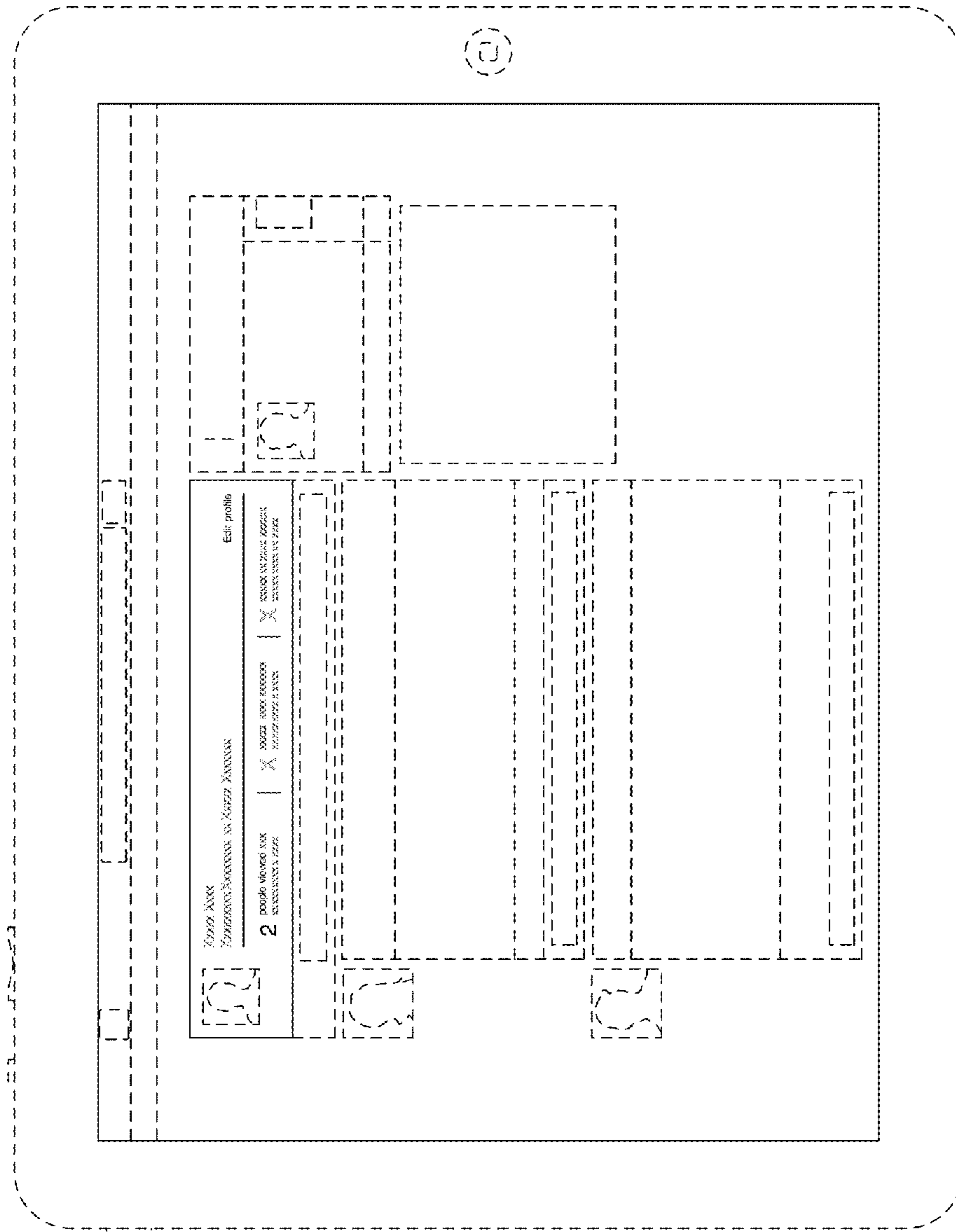

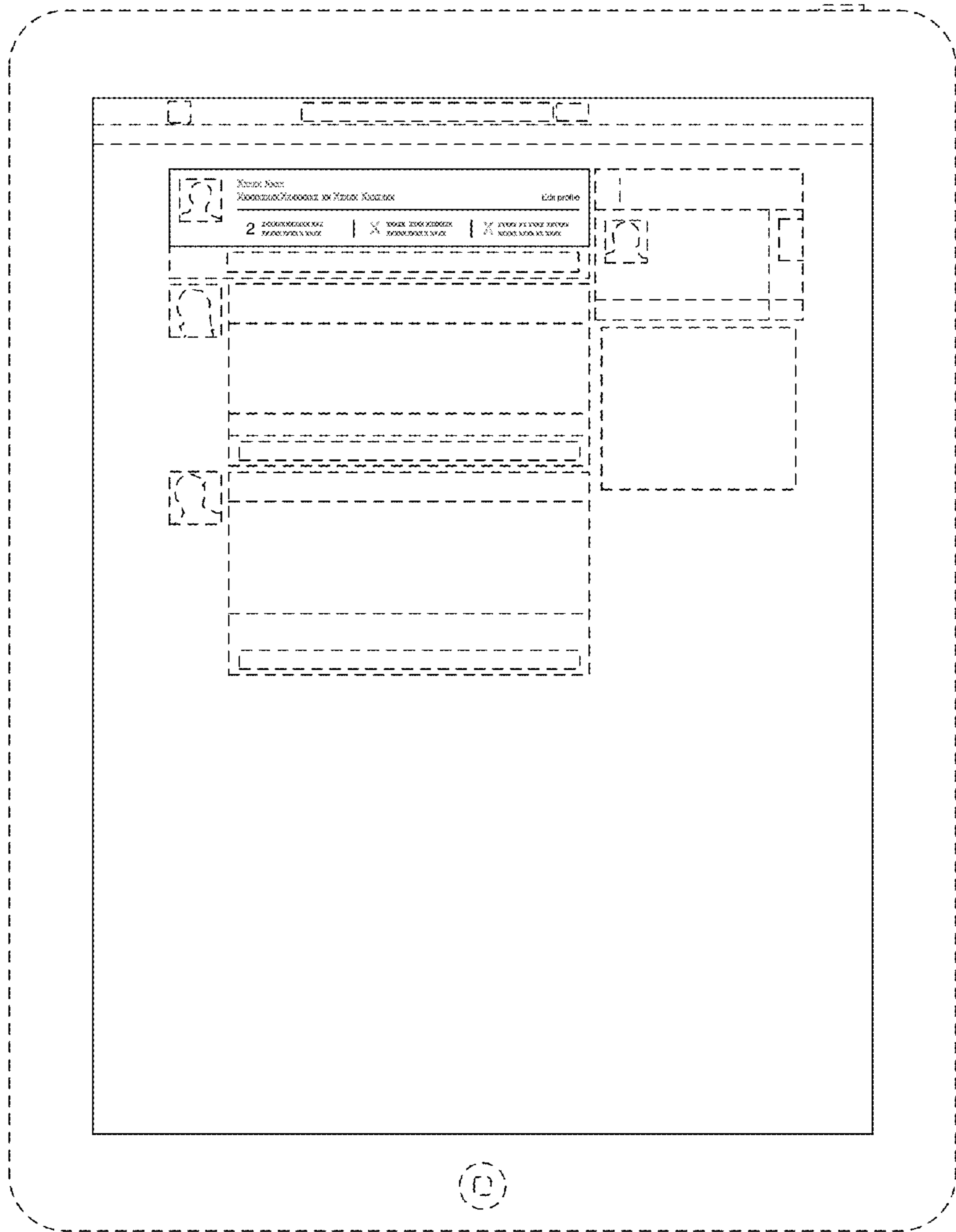
