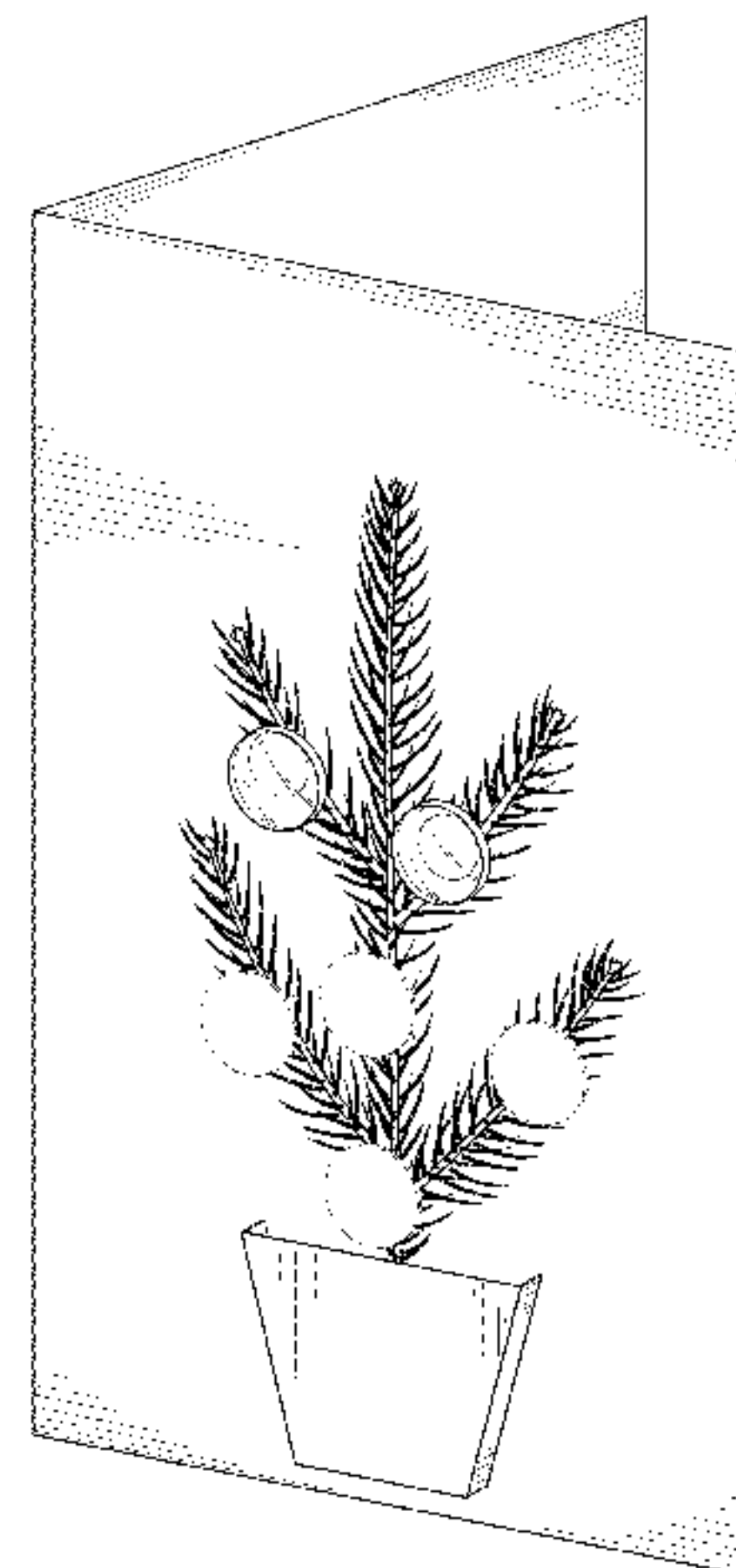
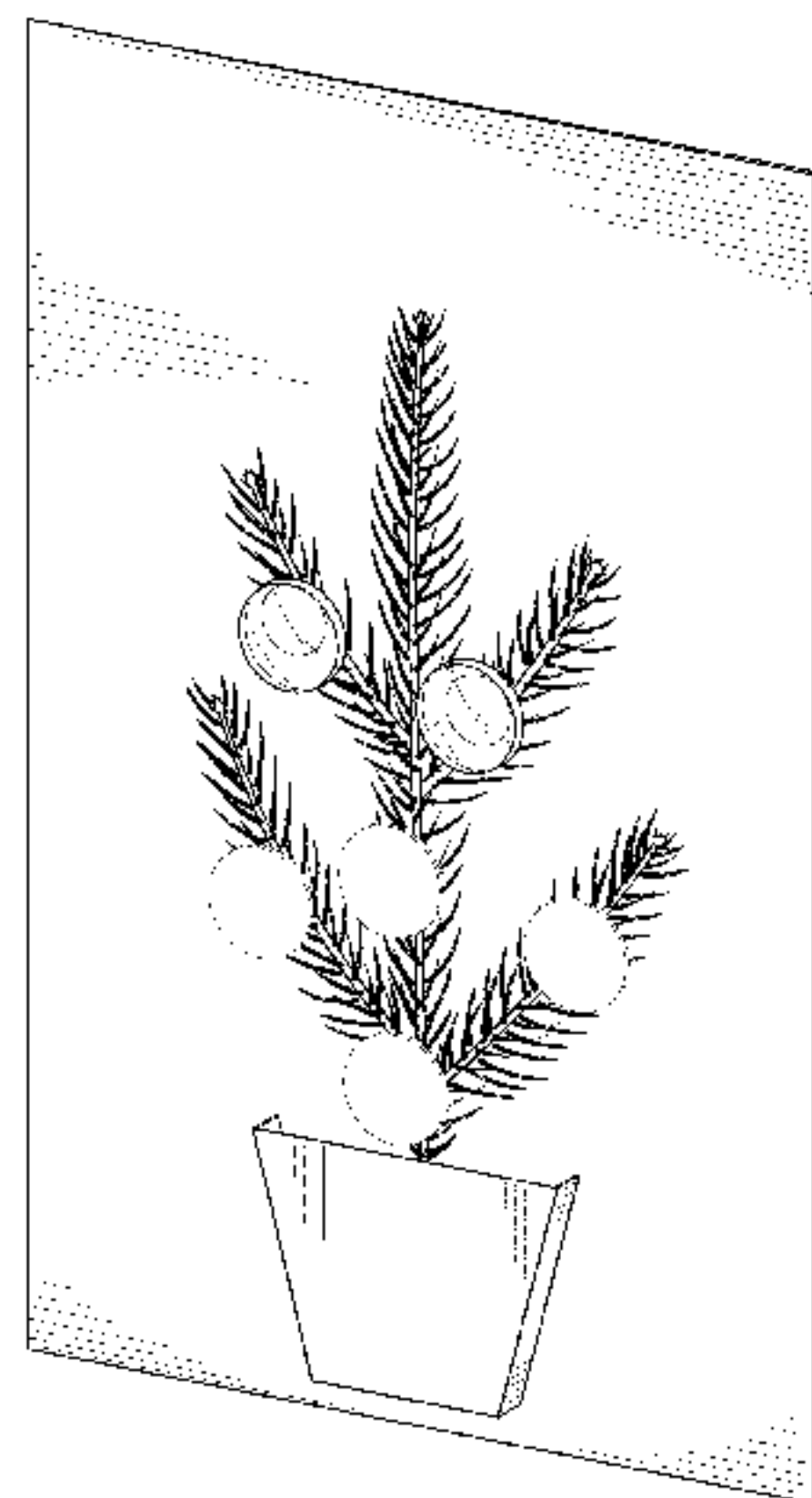
(57) **CLAIM**

The ornamental design for a Christmas tree greeting card, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view, in a closed position, of the Christmas tree greeting card showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a top view thereof;
FIG. 6 is a bottom view thereof; and,
FIG. 7 is a perspective view thereof, the Christmas tree greeting card shown in a partially open position.
The broken line showing of portions of the Christmas tree greeting card is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

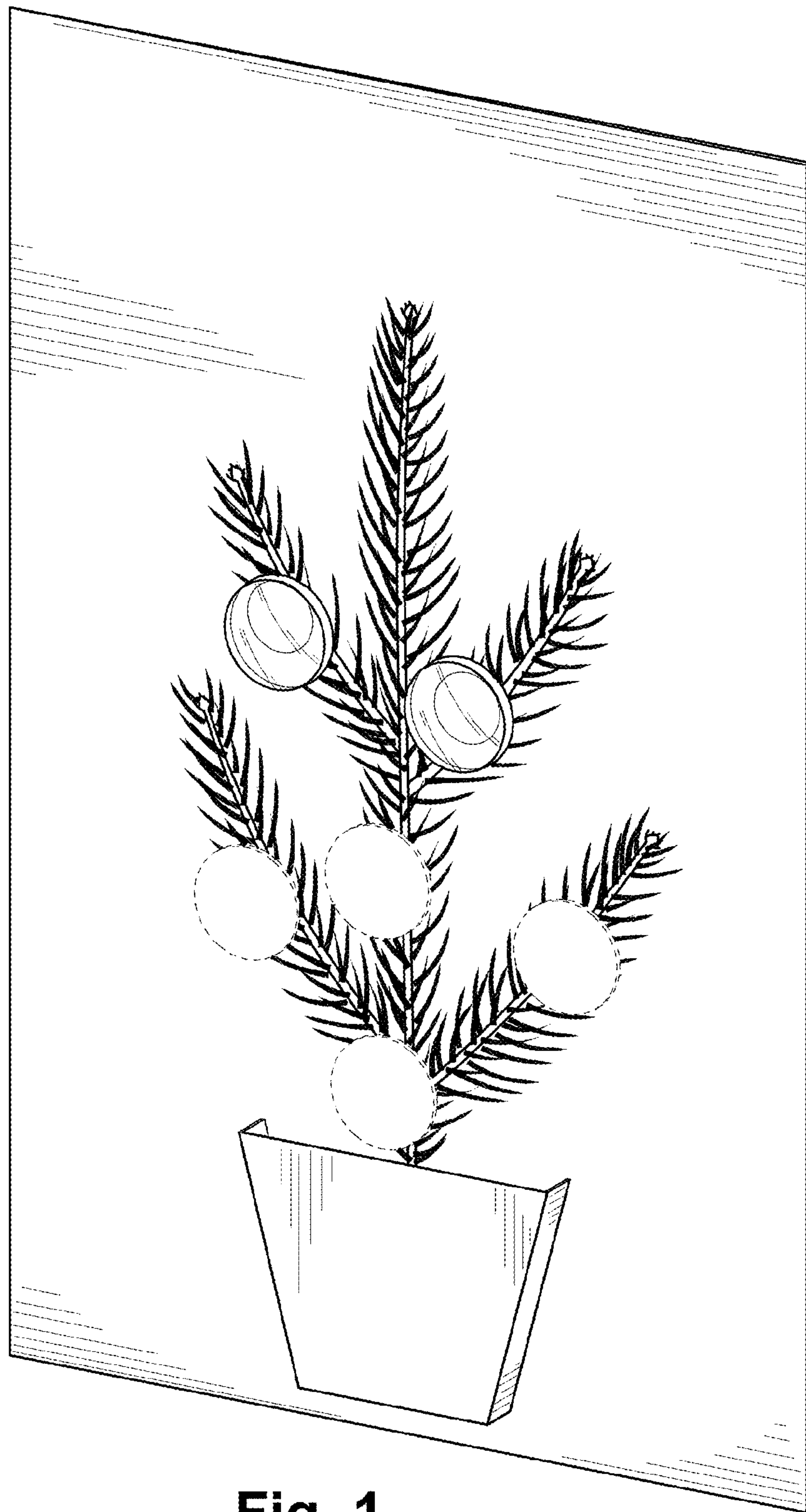

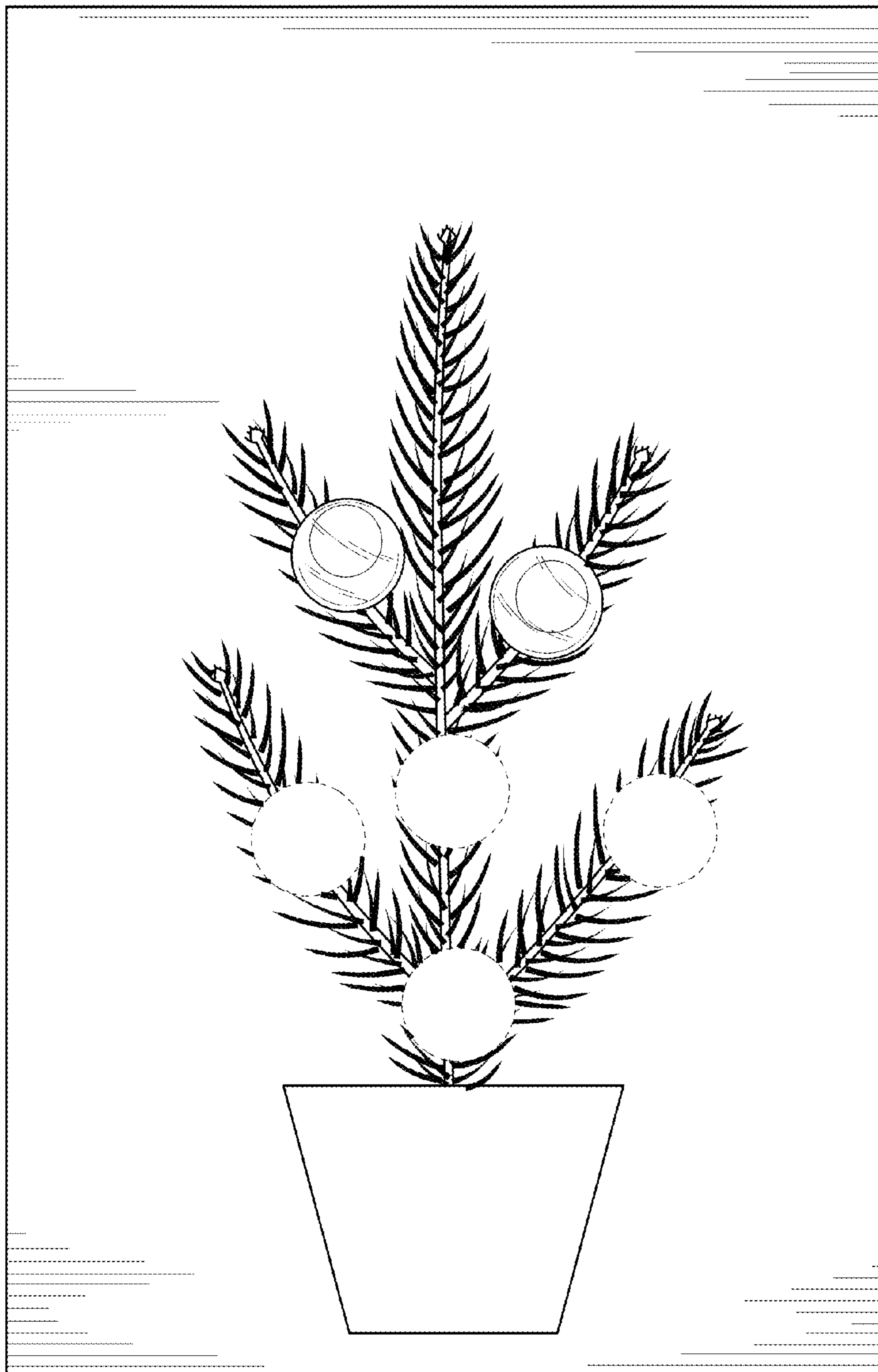

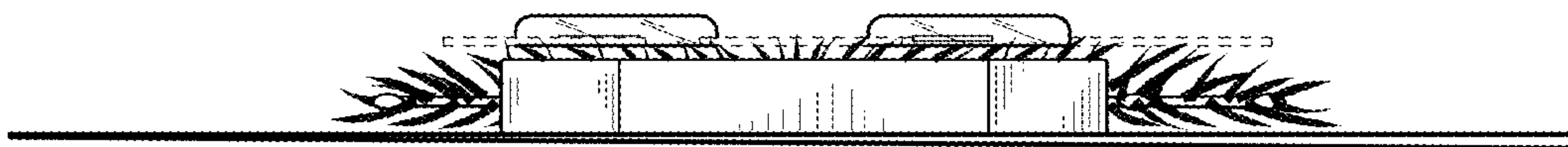

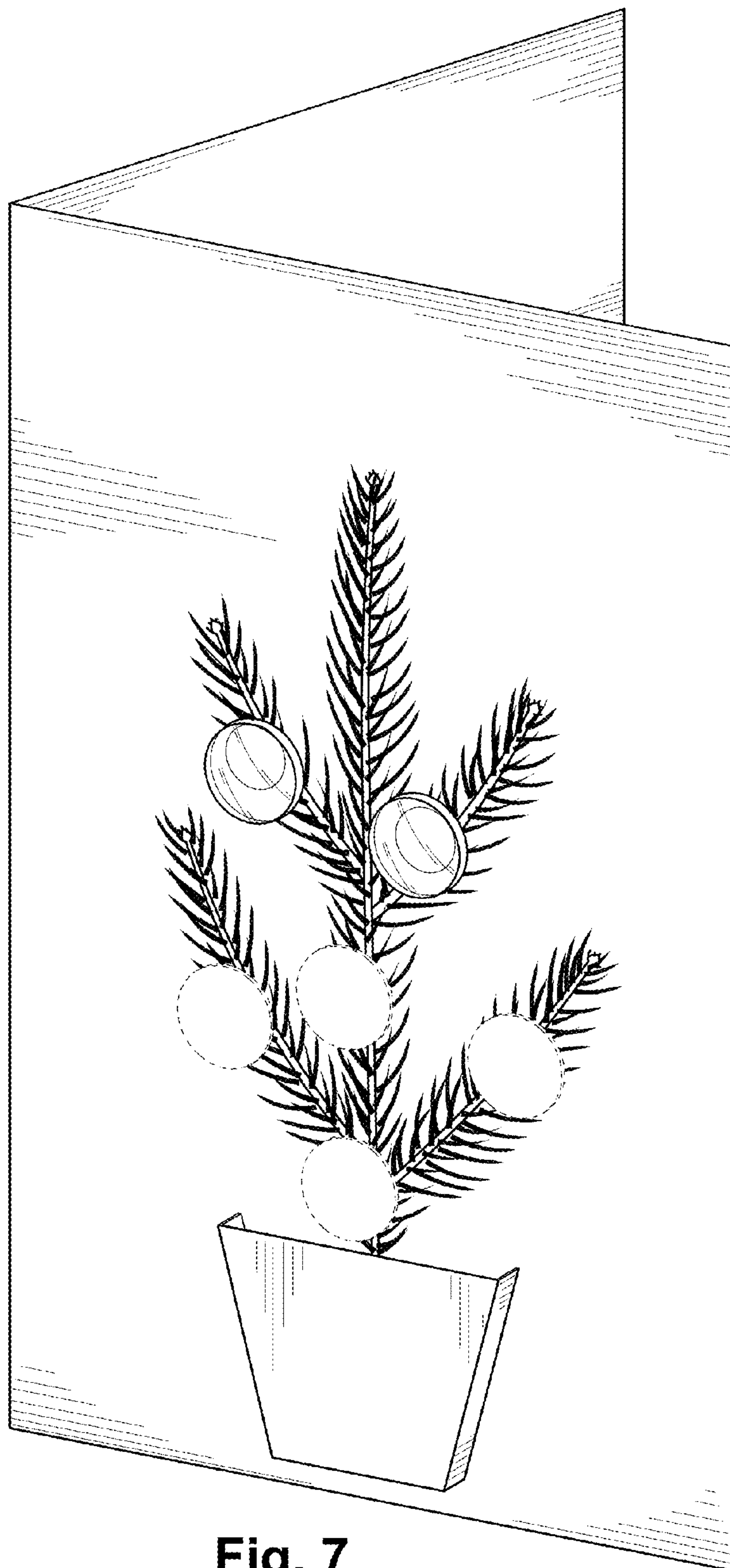
