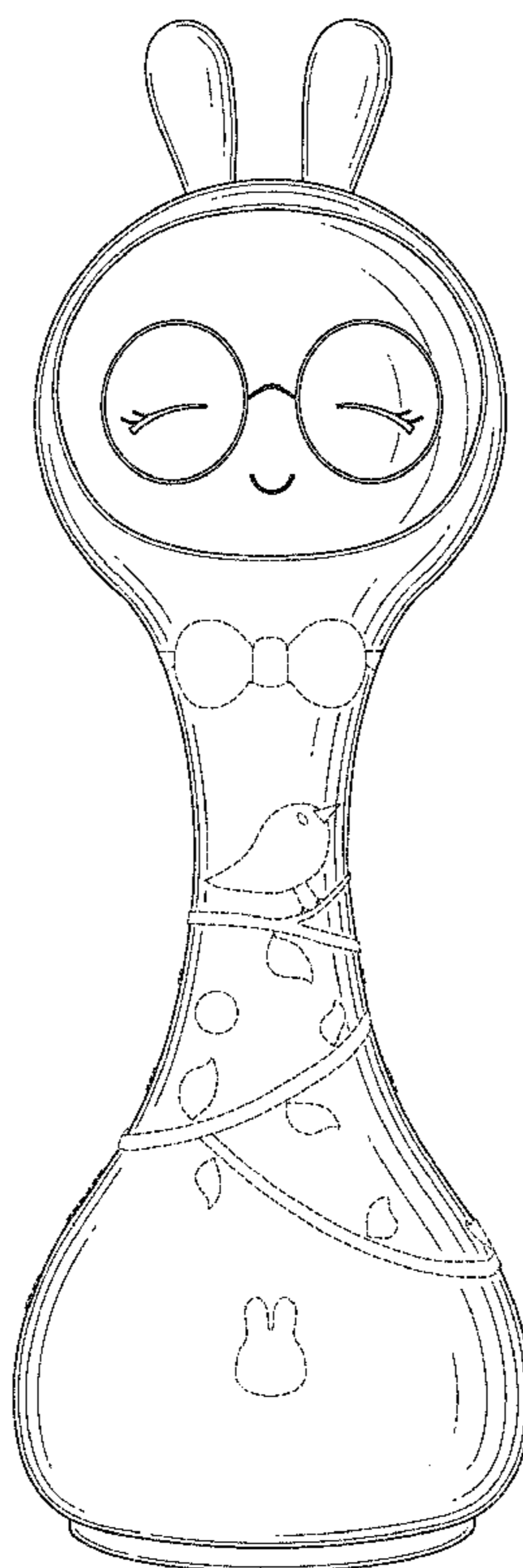
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front elevational view of the toy for children, showing my new design;

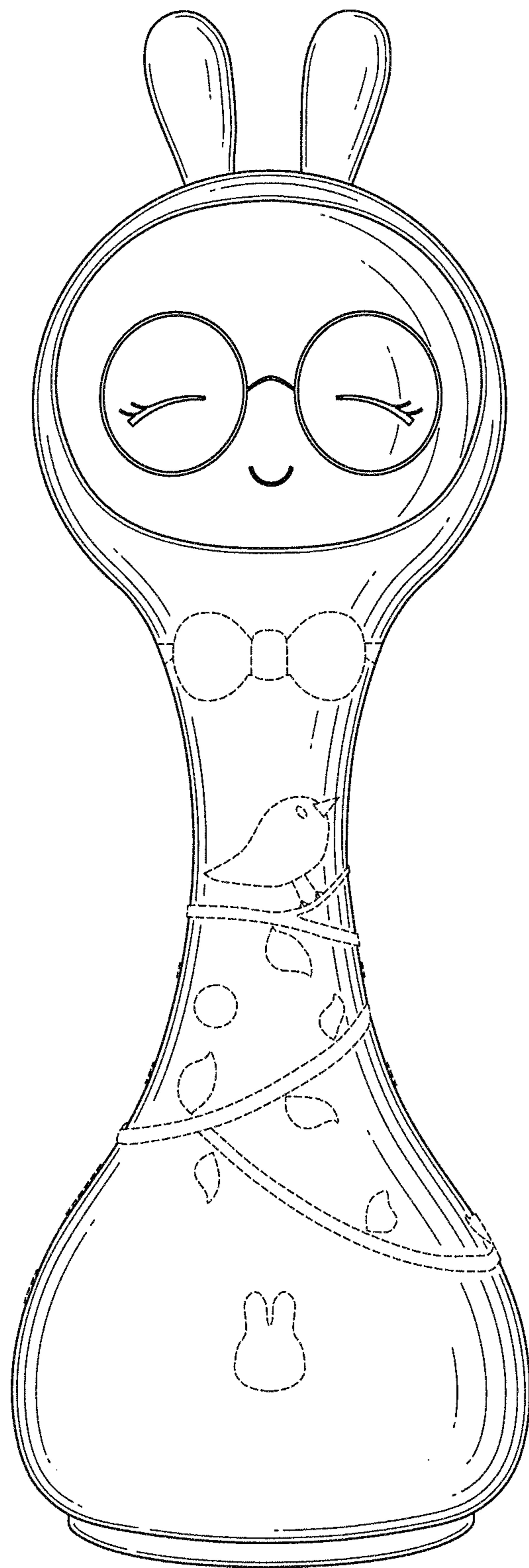

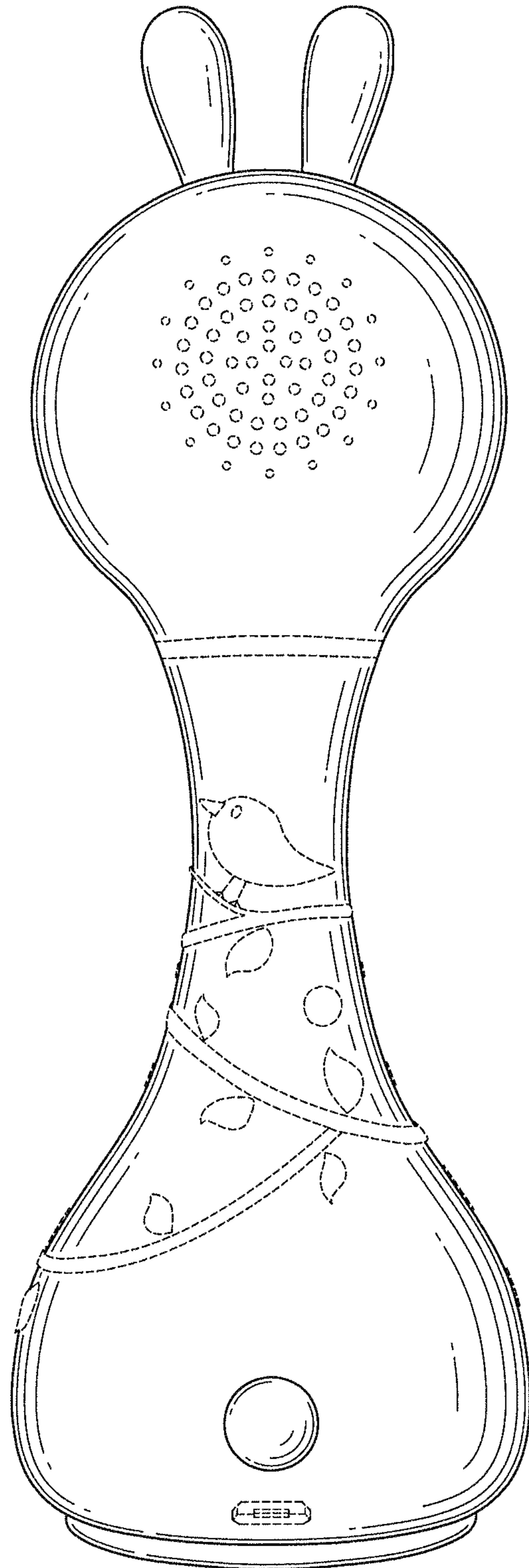

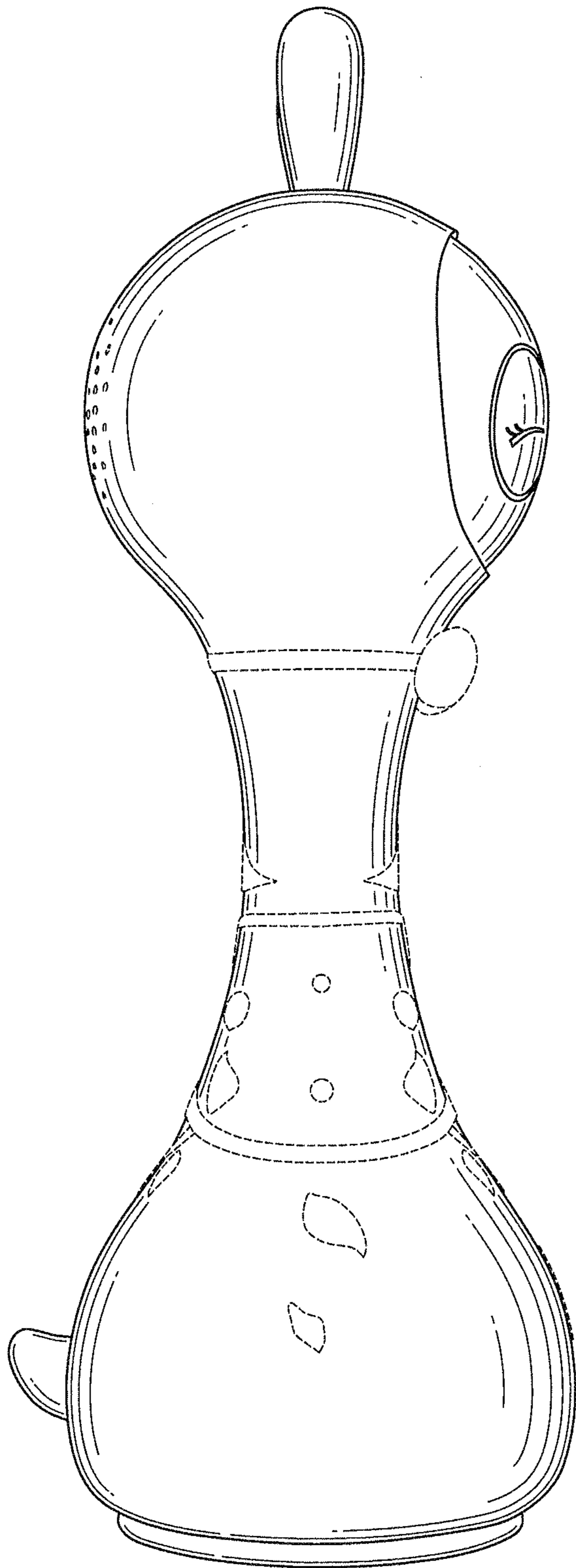

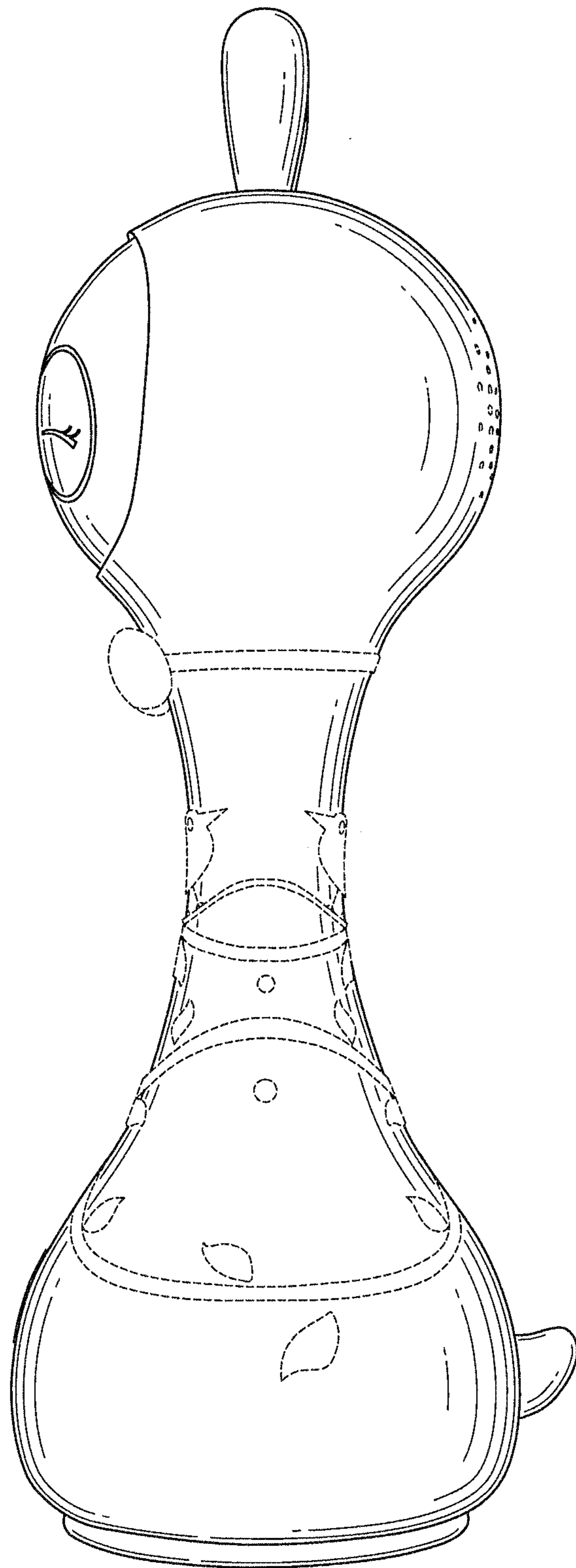

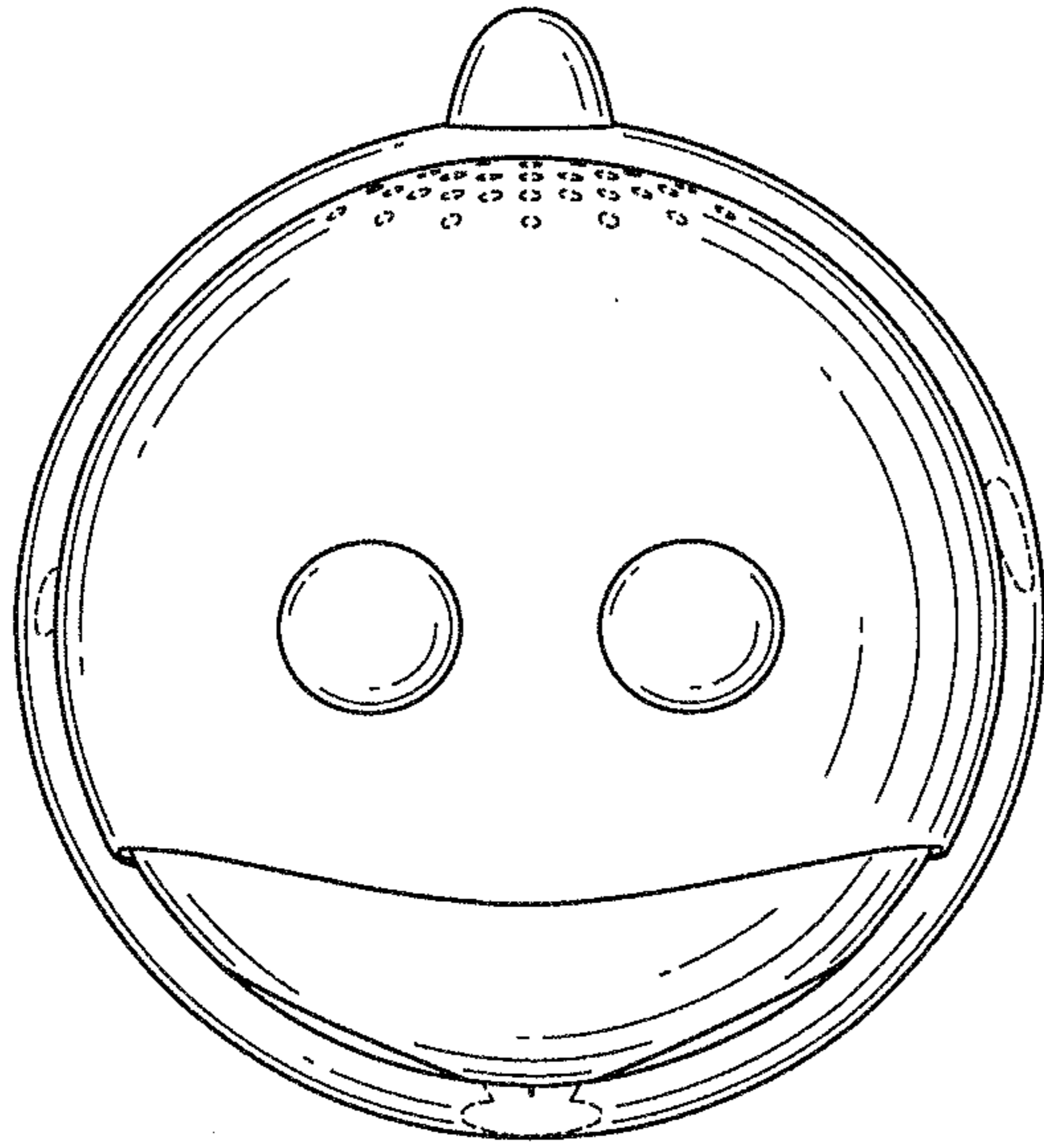

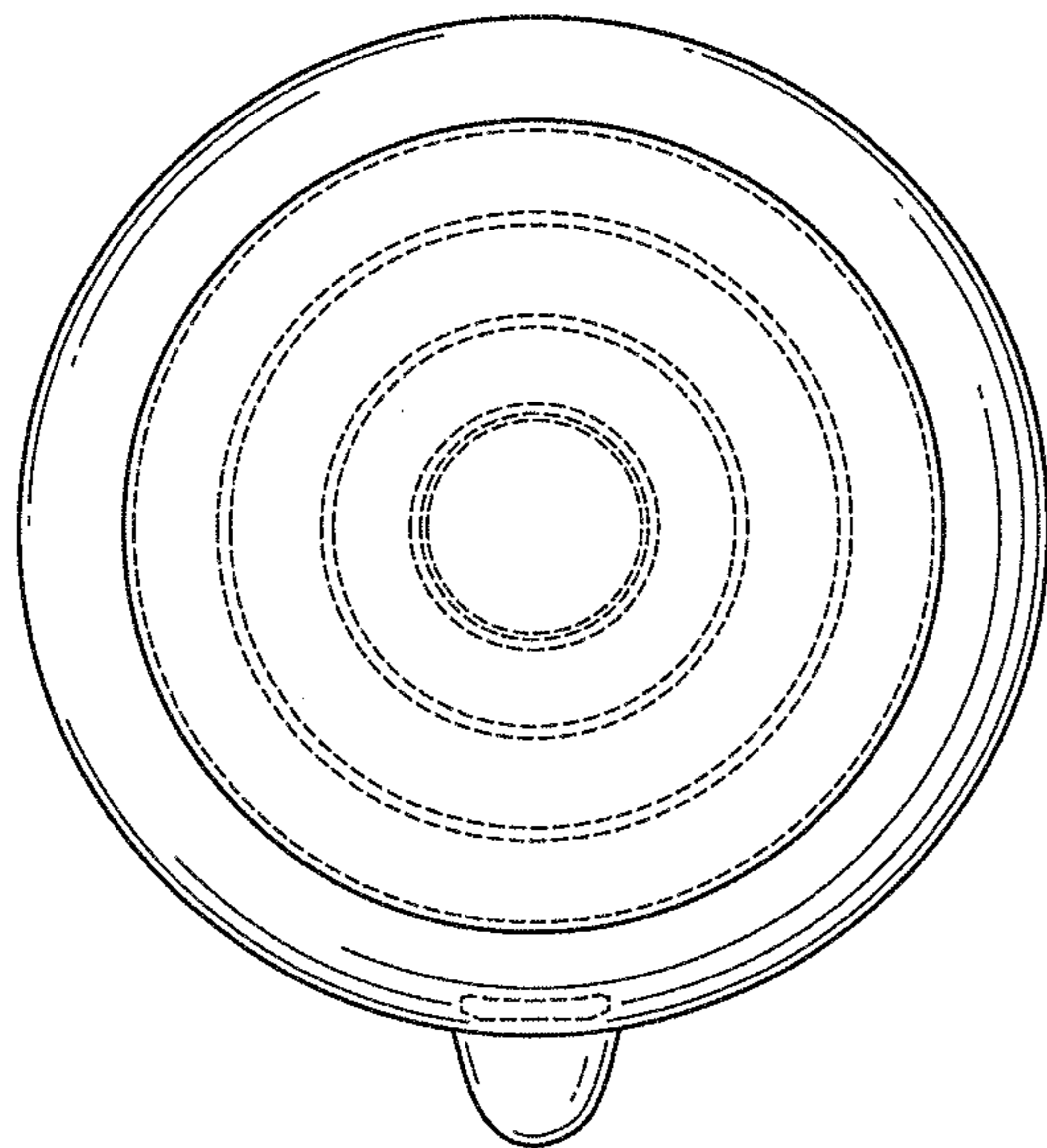
