FIG. 1 is a first perspective view of a golf club head showing our new design;

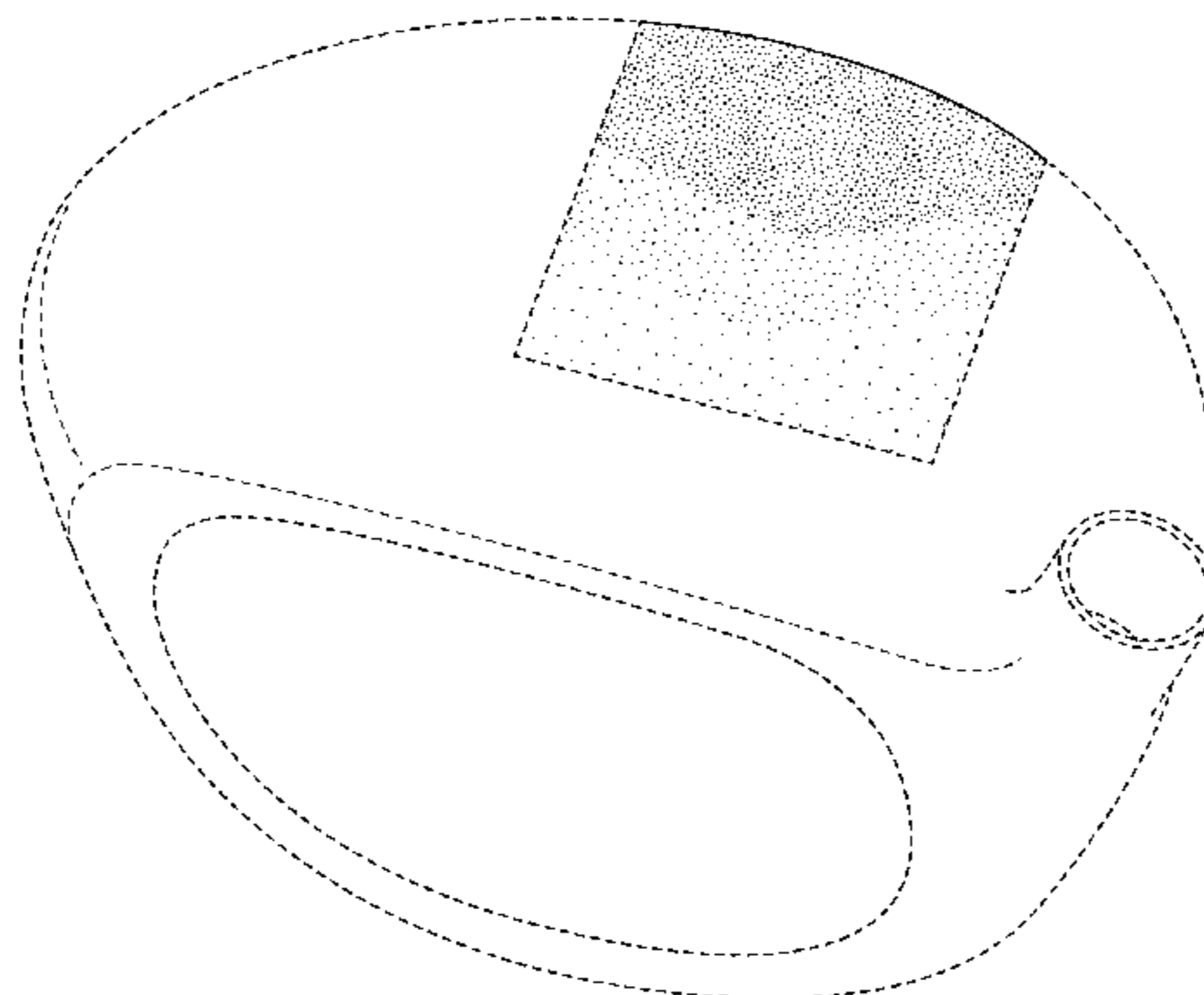
FIG. 2 is a top view thereof;

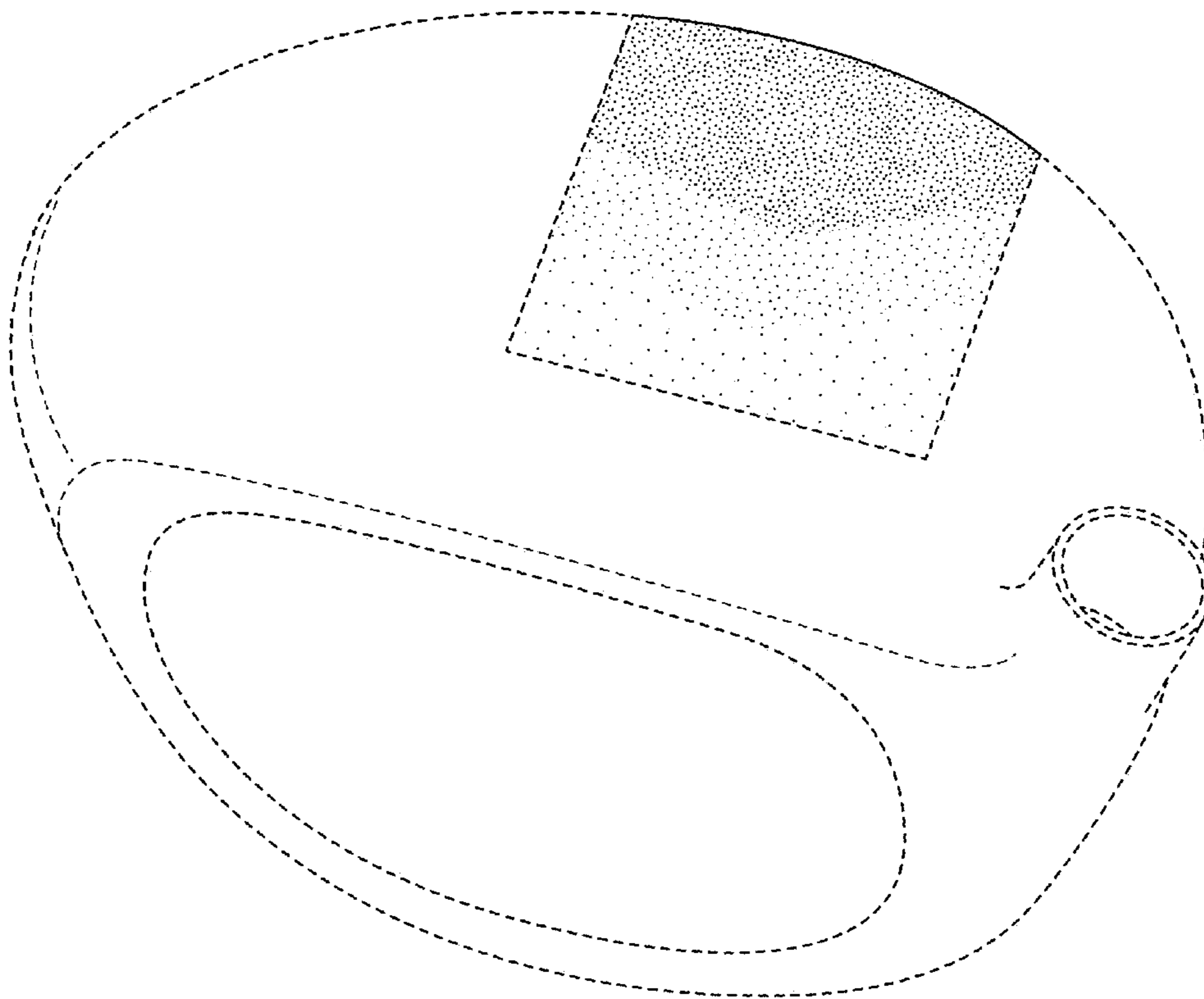

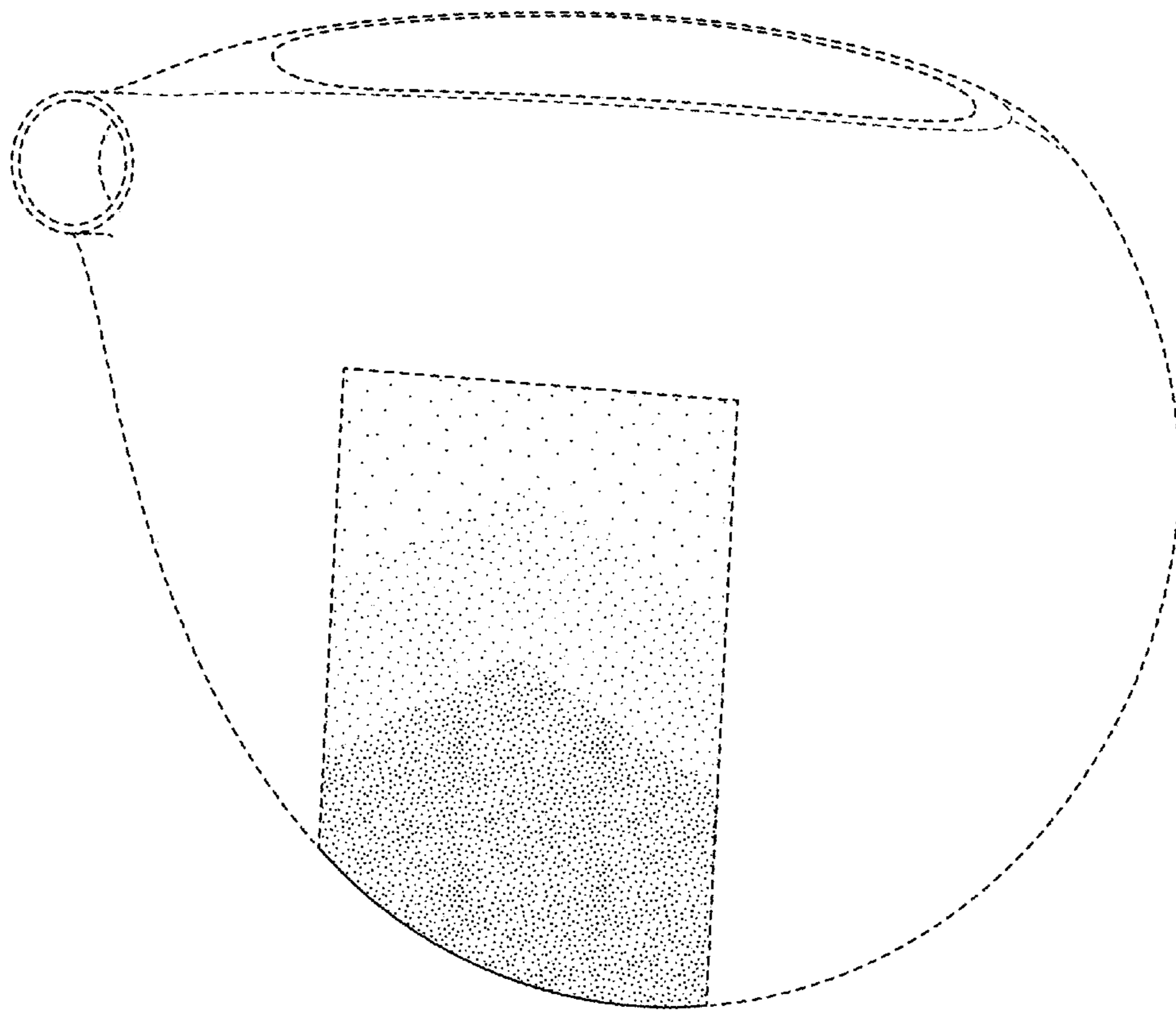

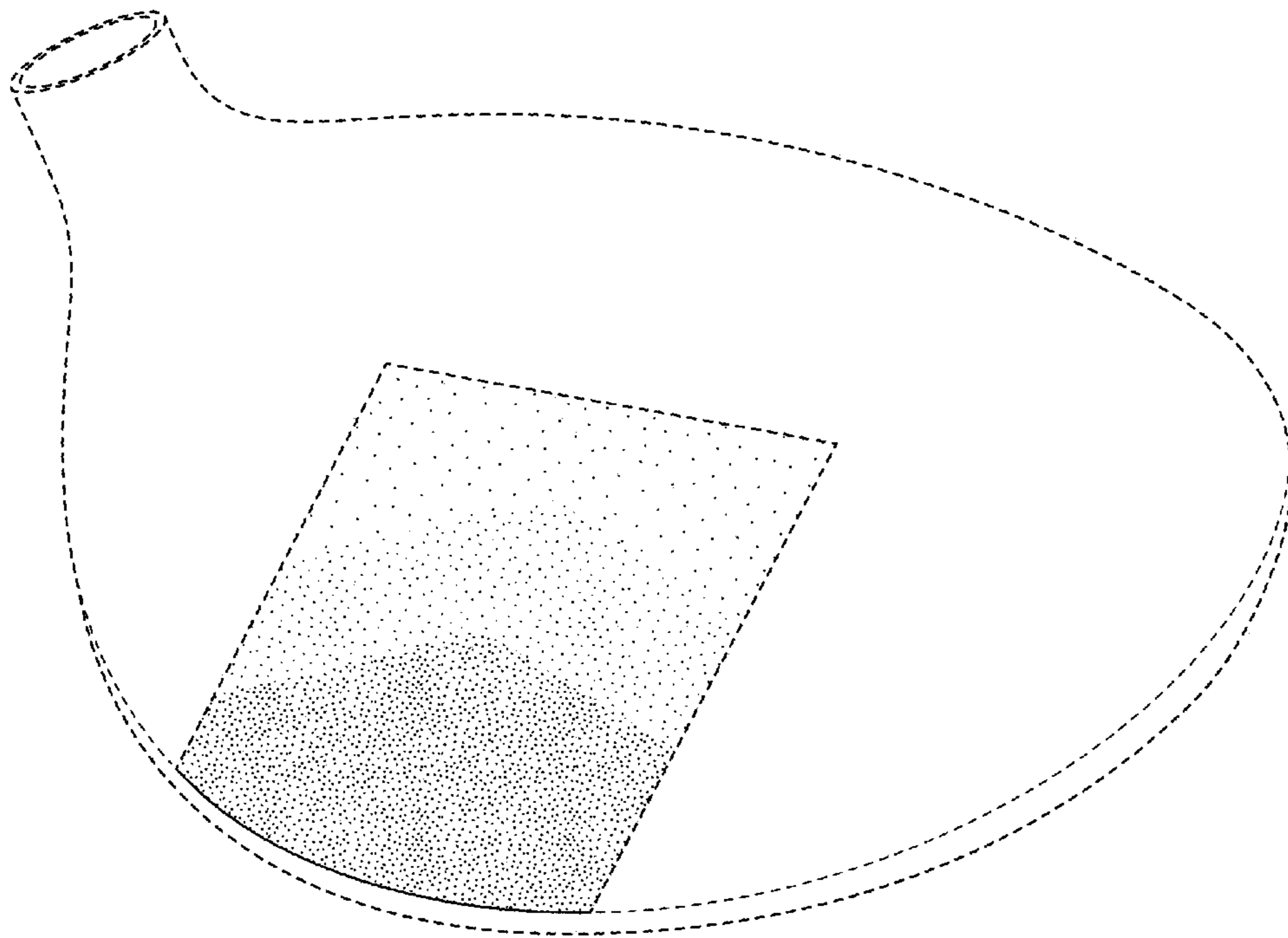

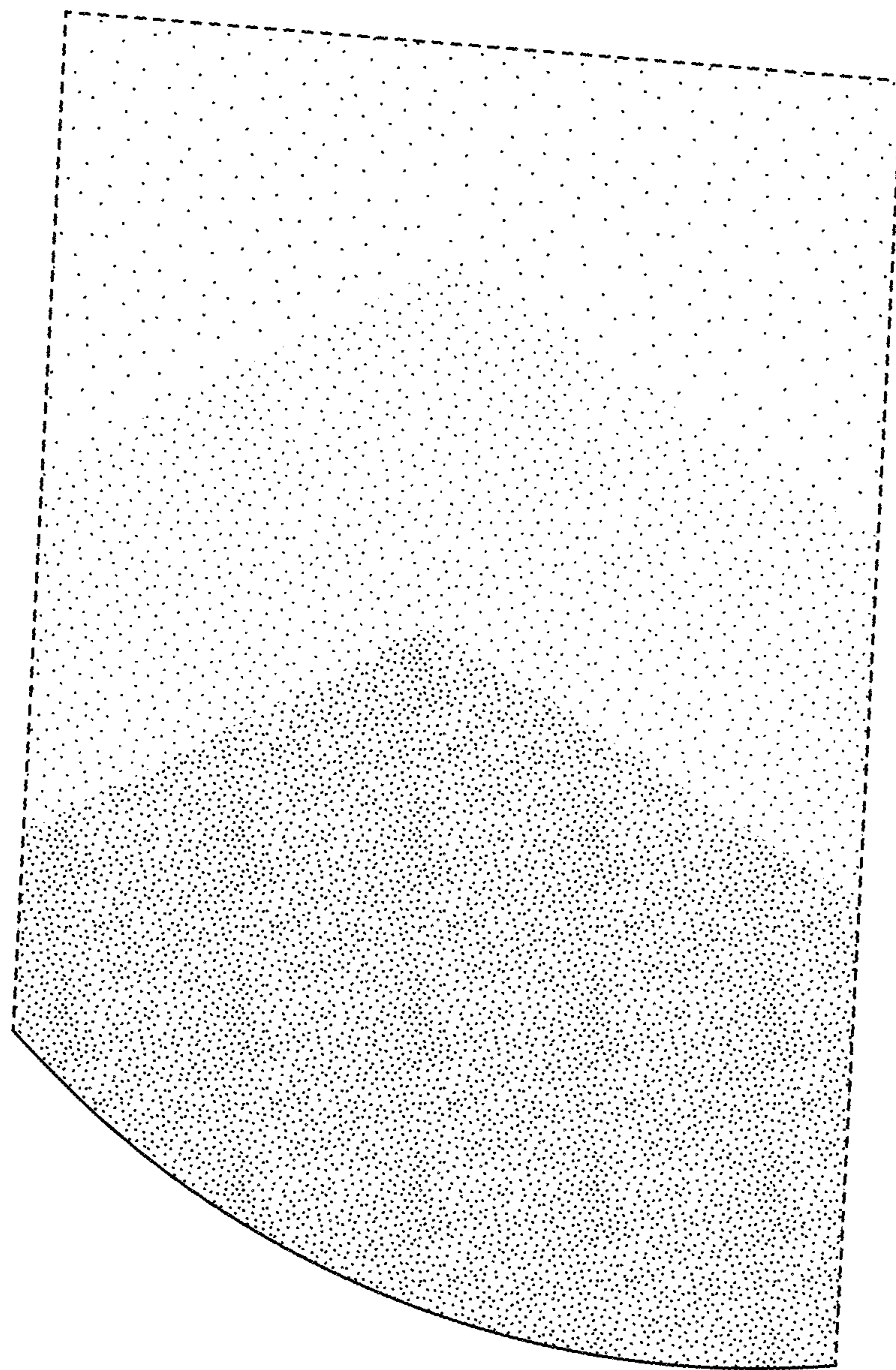
