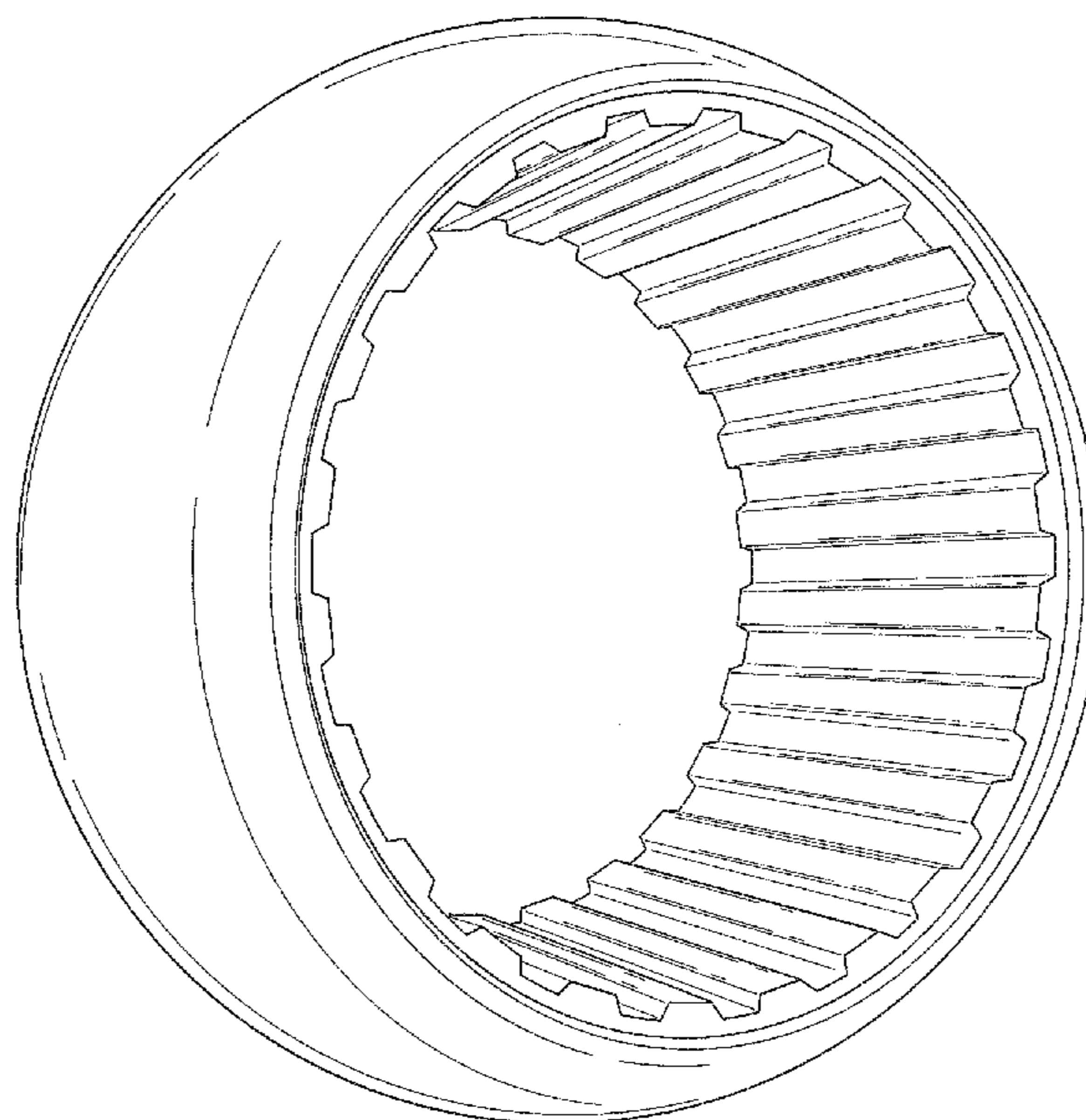
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of an air vent in accordance with the present design;  
FIG. 2 is a front plan view thereof;  
FIG. 3 is a rear plan view thereof;  
FIG. 4 is a side elevation view thereof; and,  
FIG. 5 is a perspective view thereof showing an air vane in broken line.

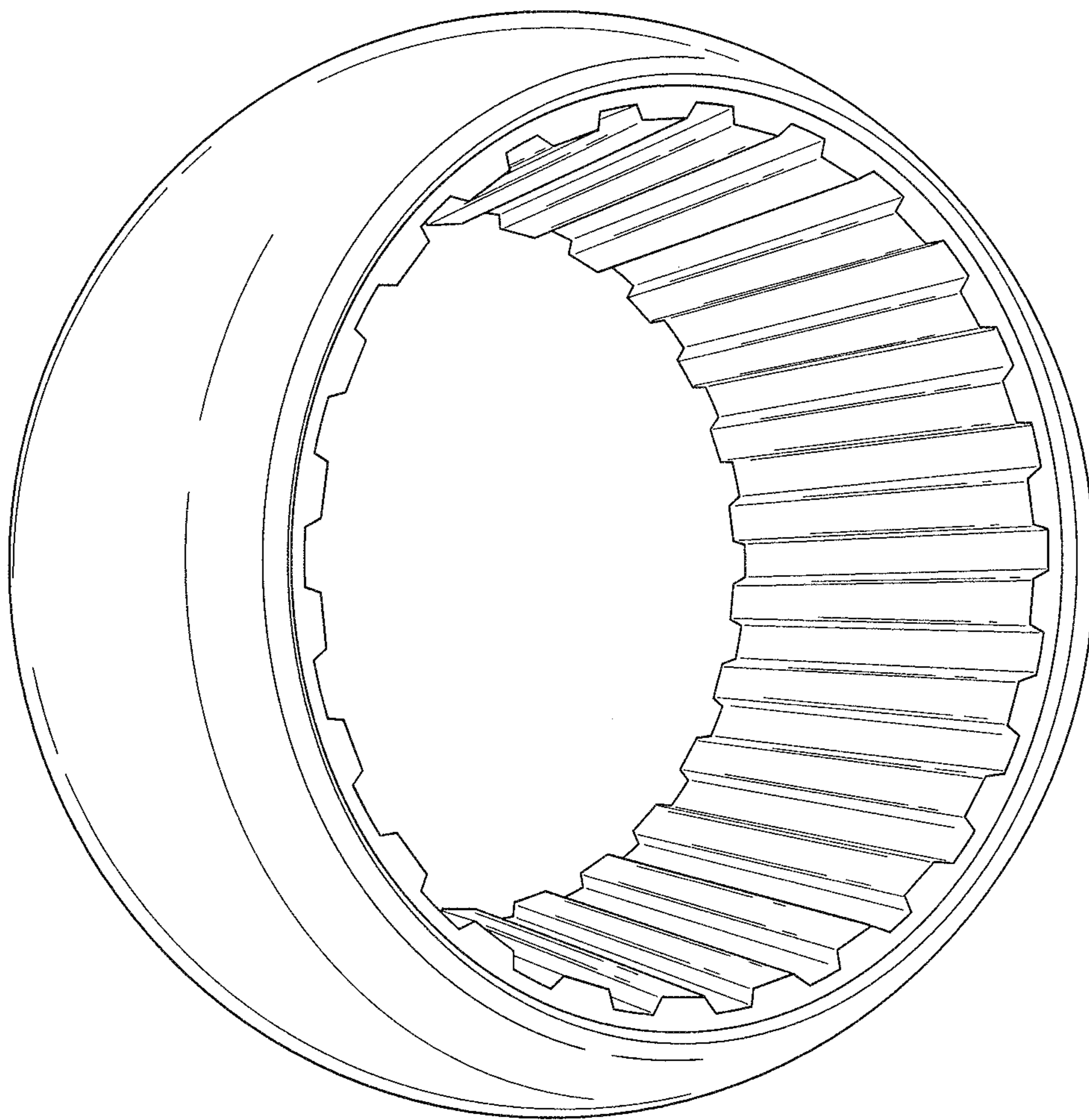

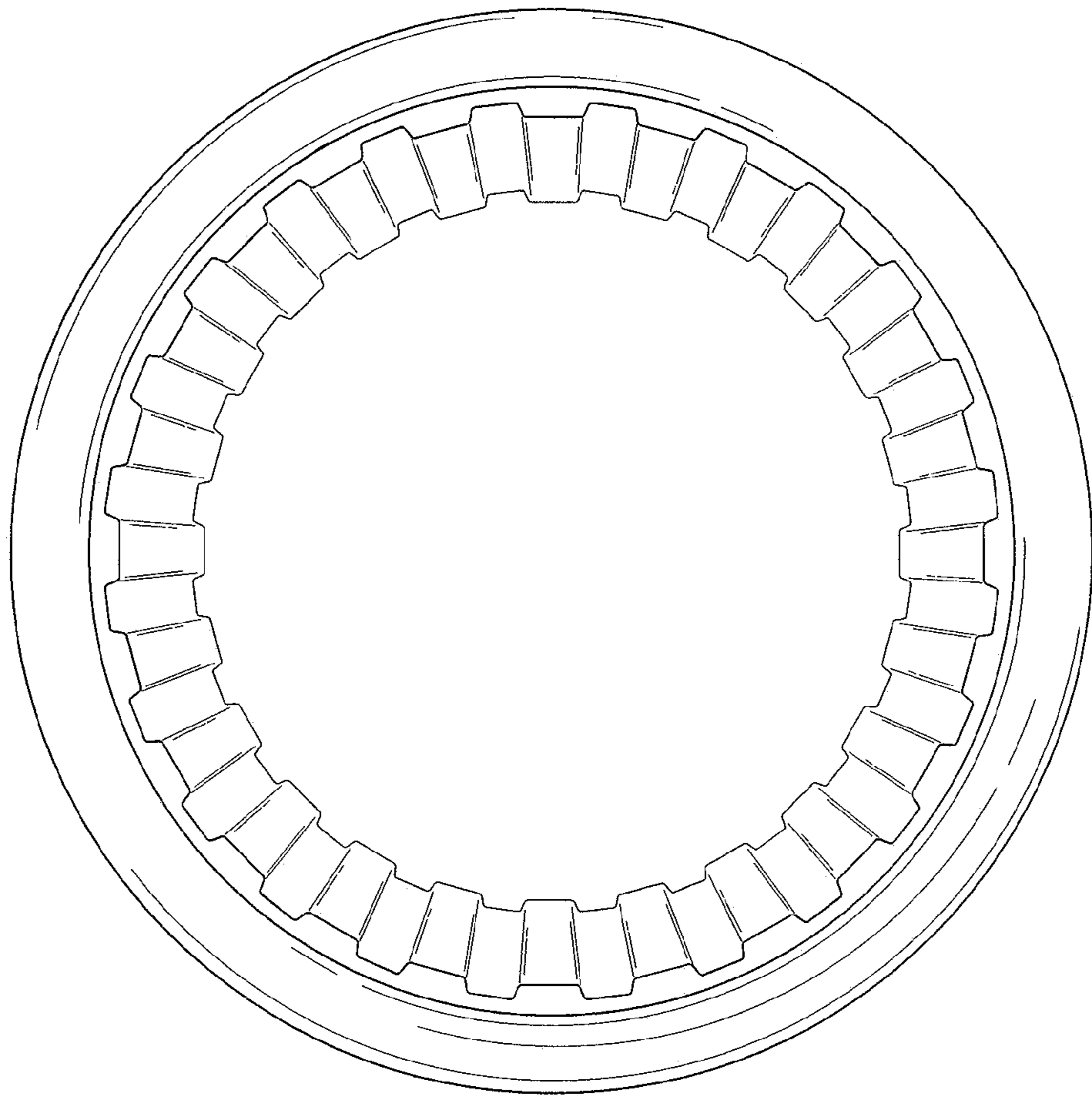

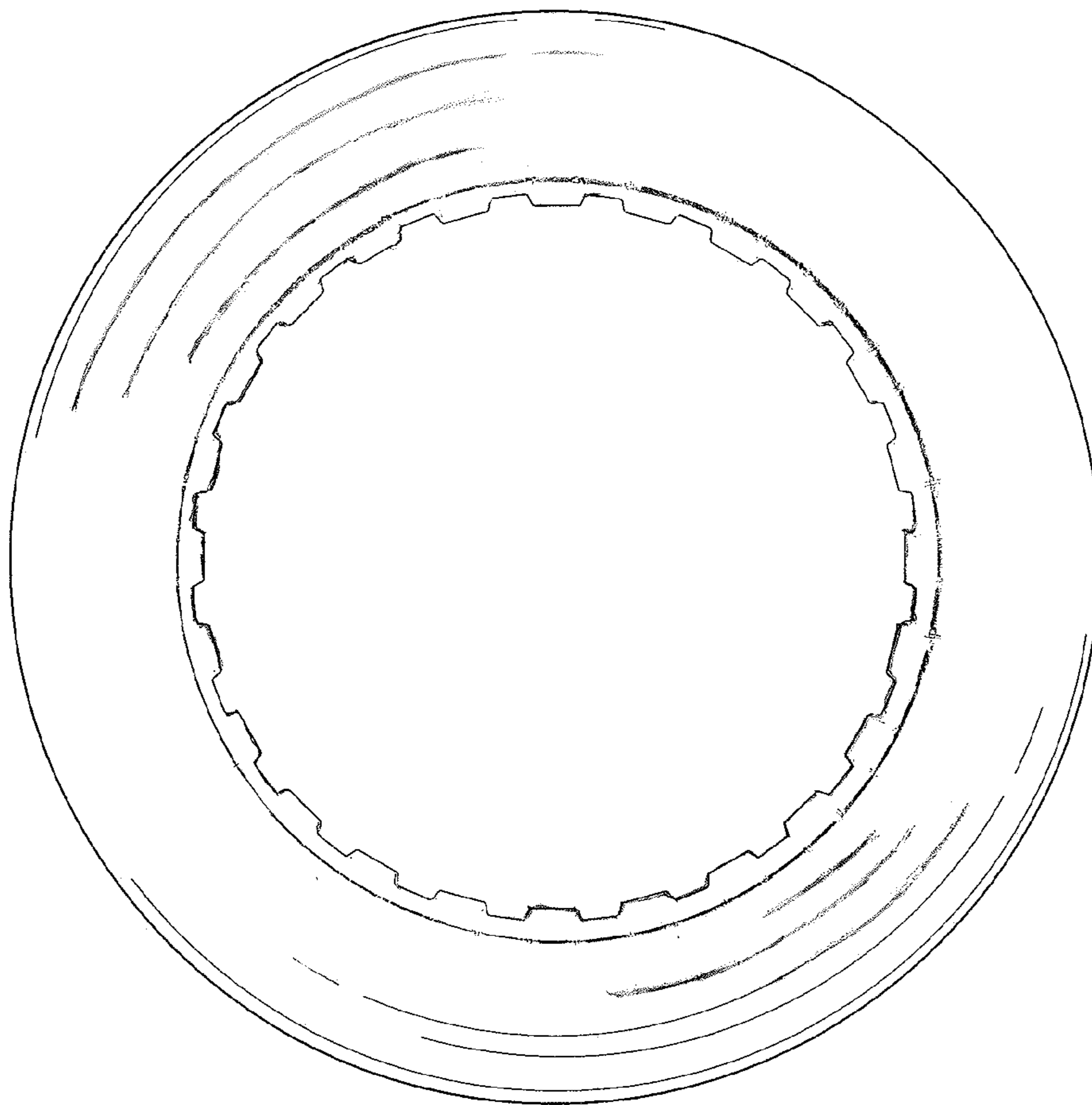

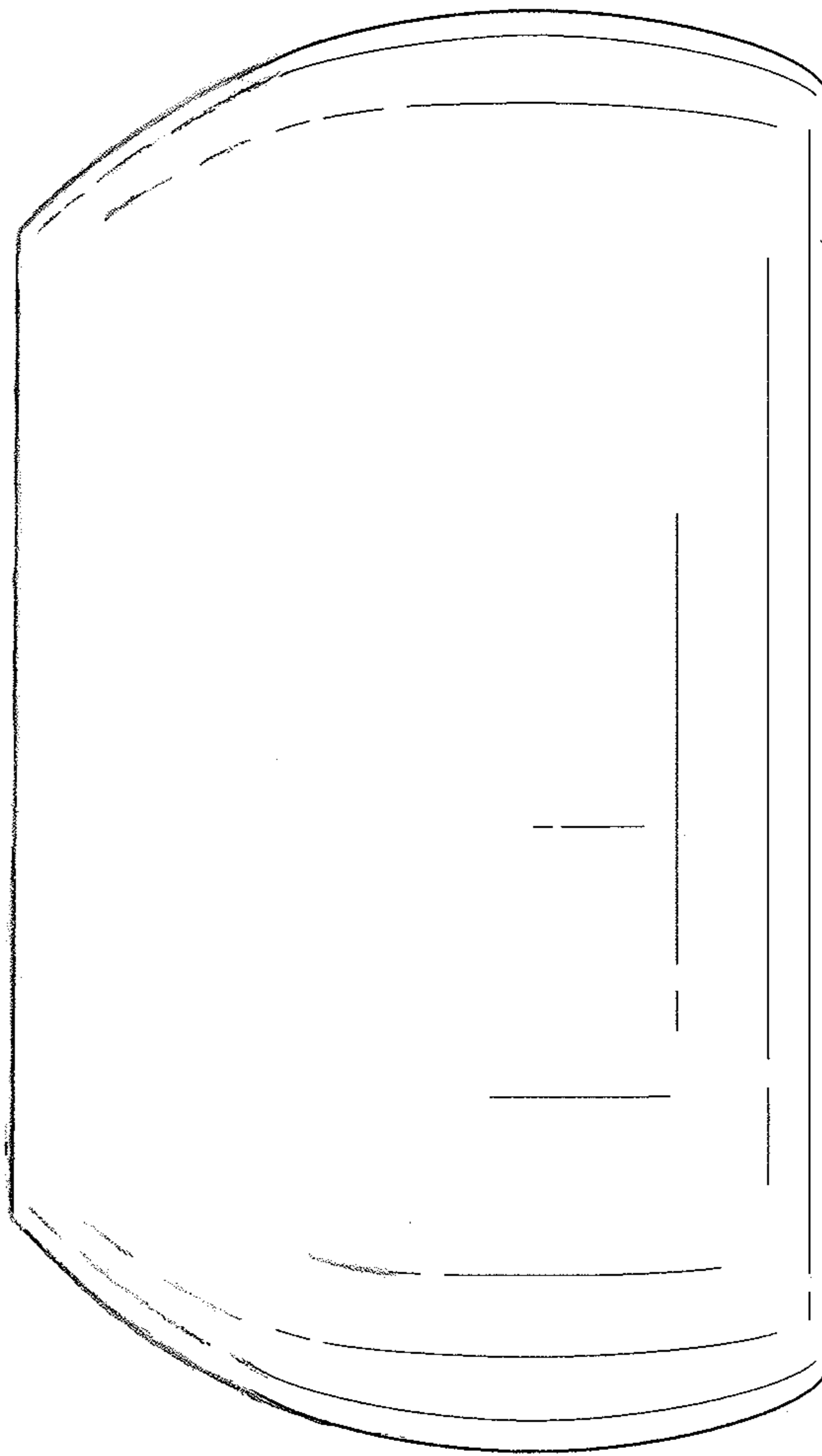

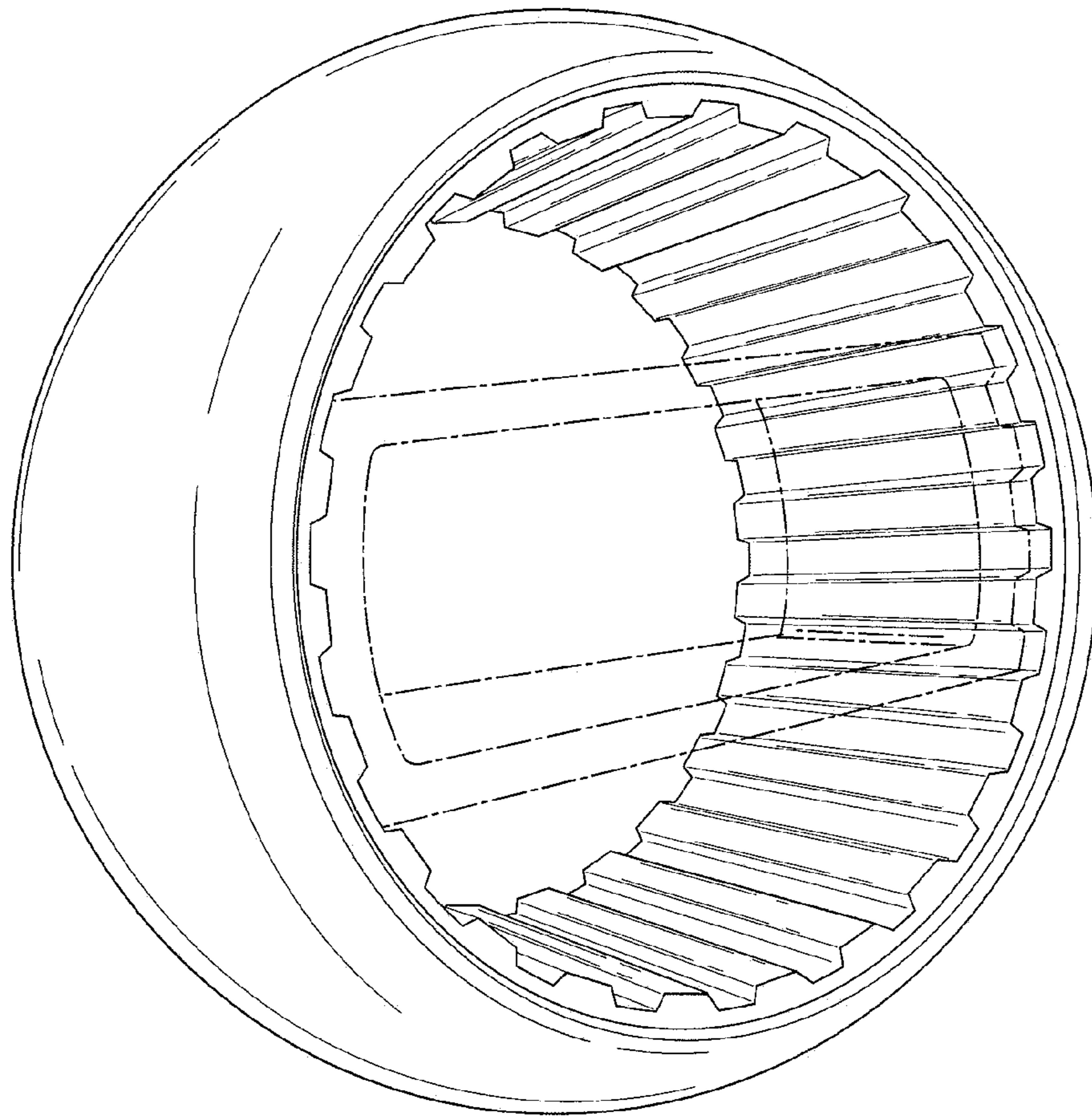
