DESCRIPTION

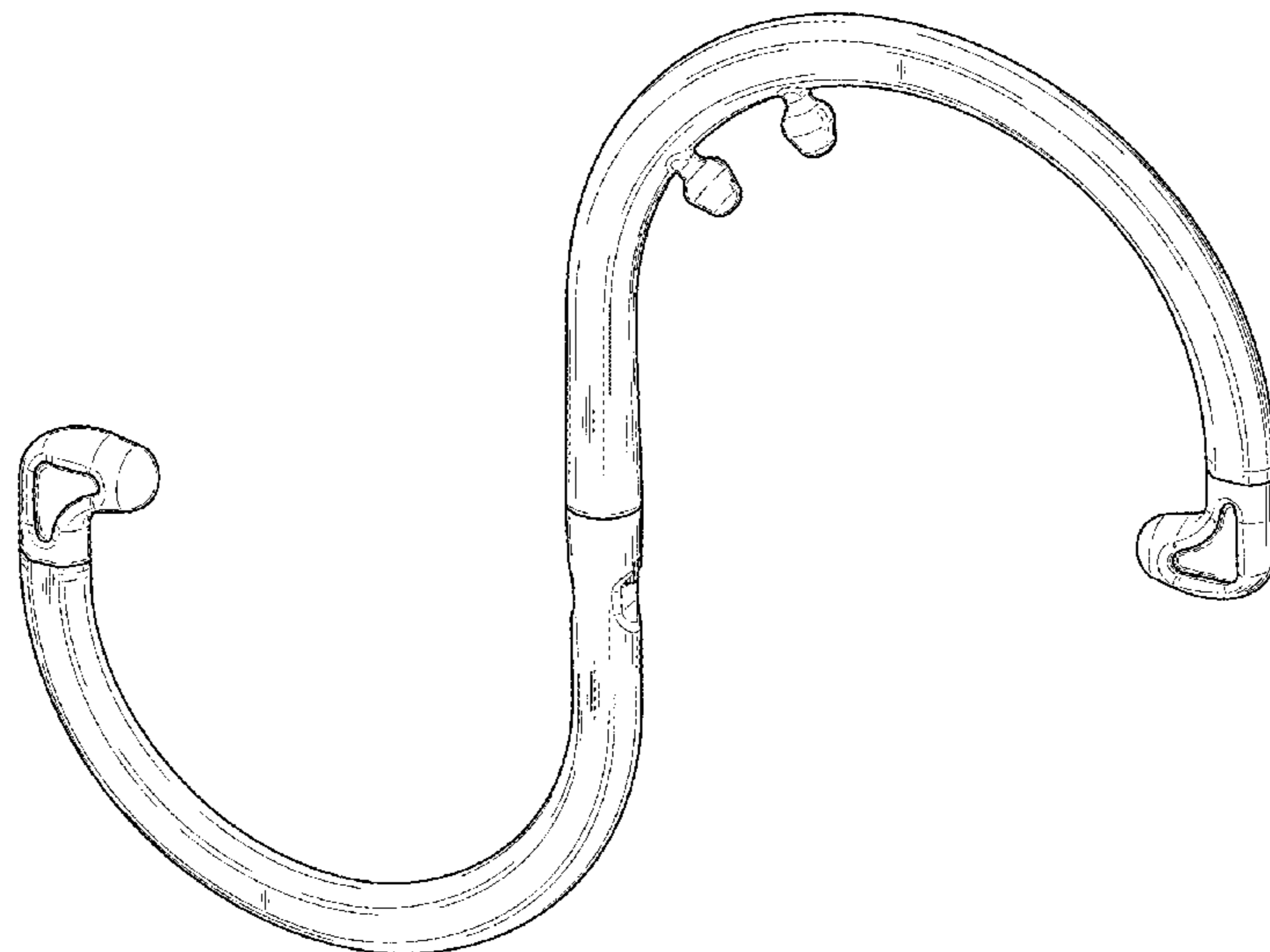
FIG. 1 is a perspective view of a trigger point massager showing our new design;

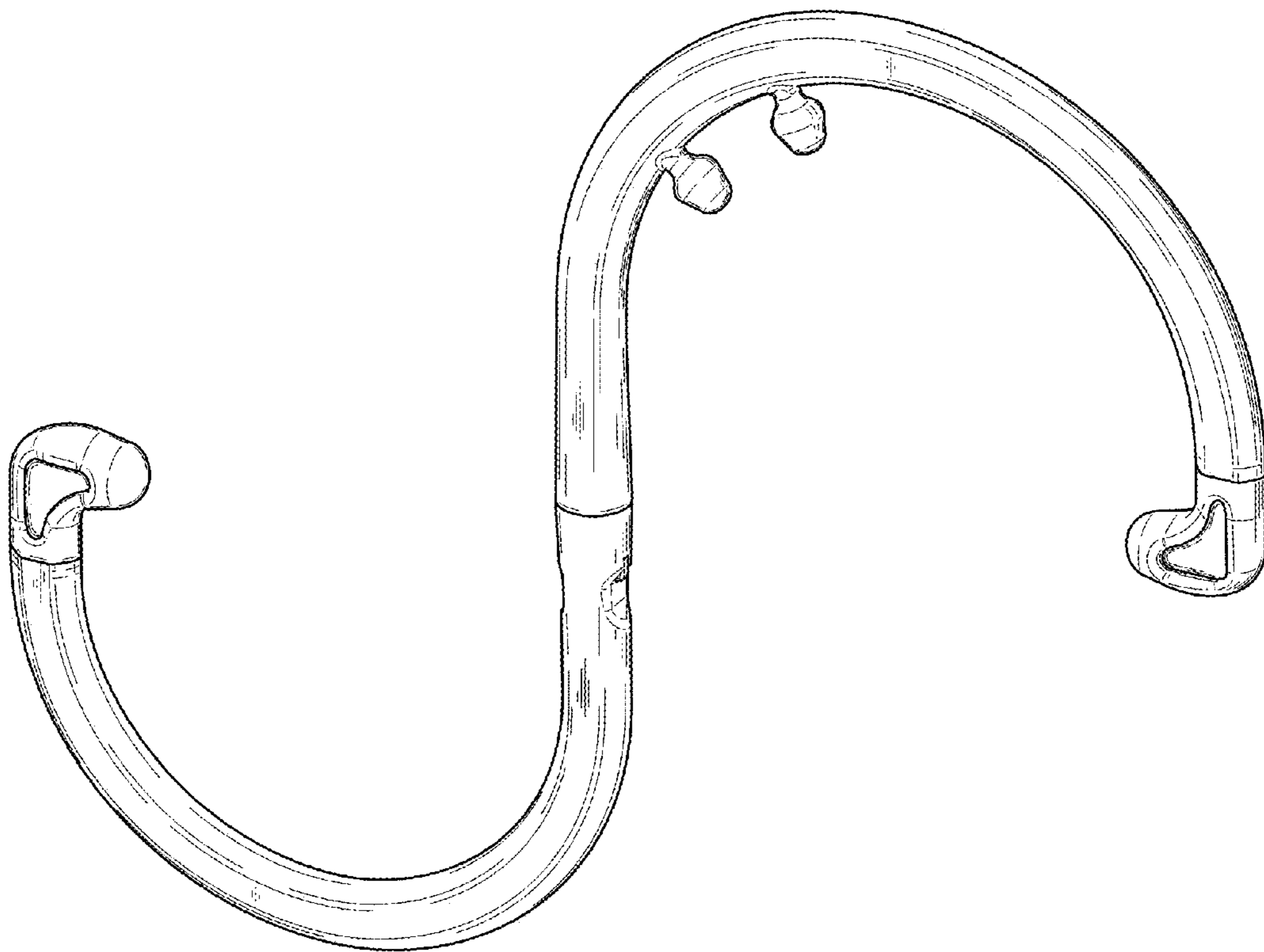

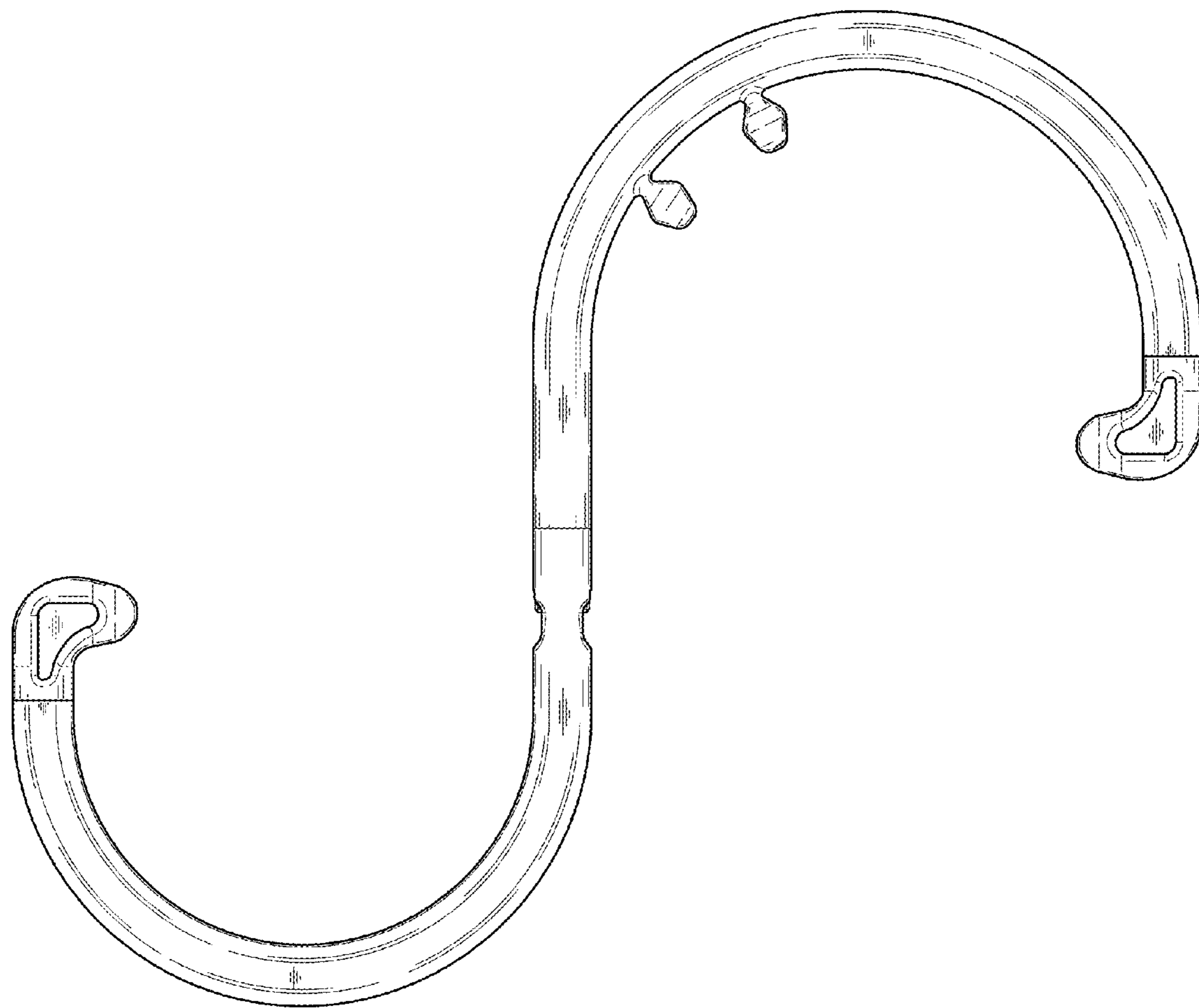

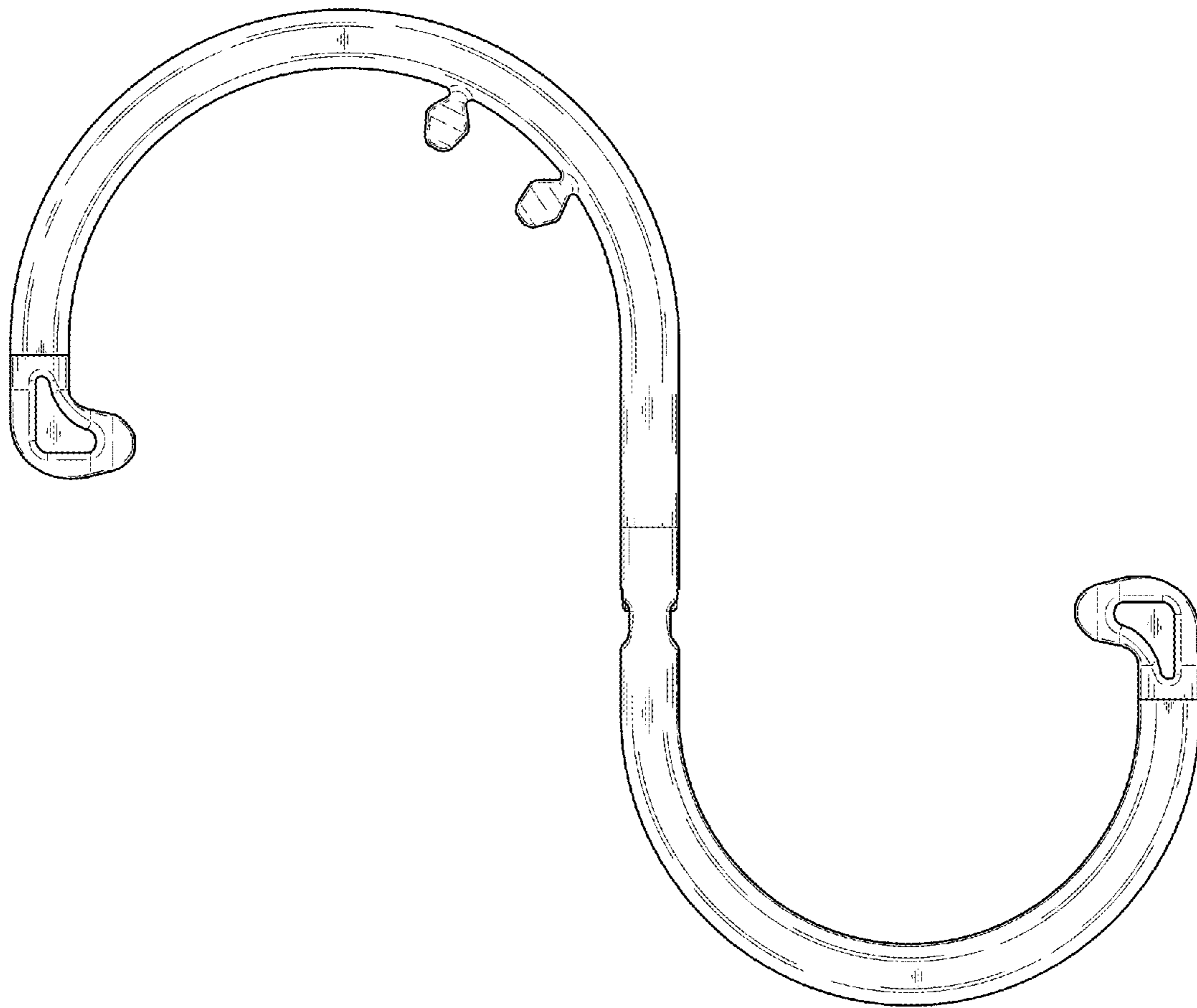

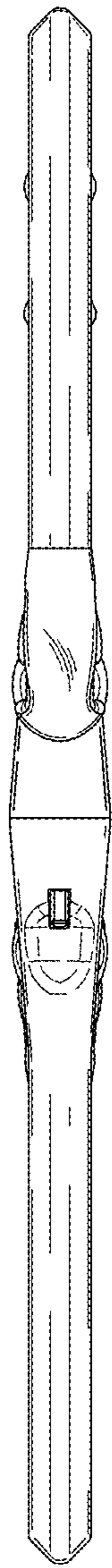

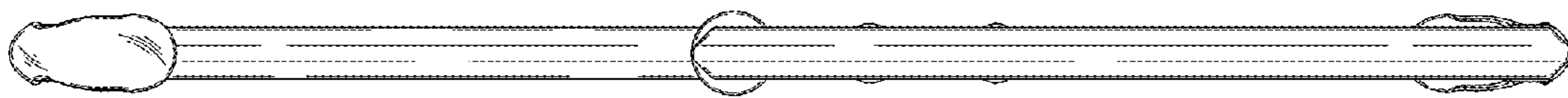

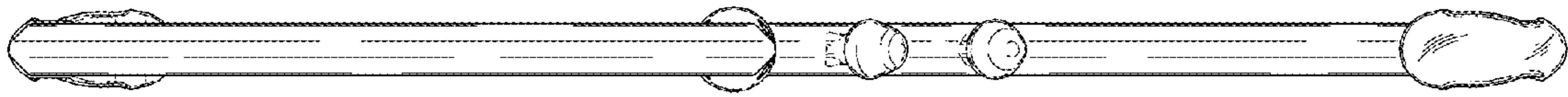
