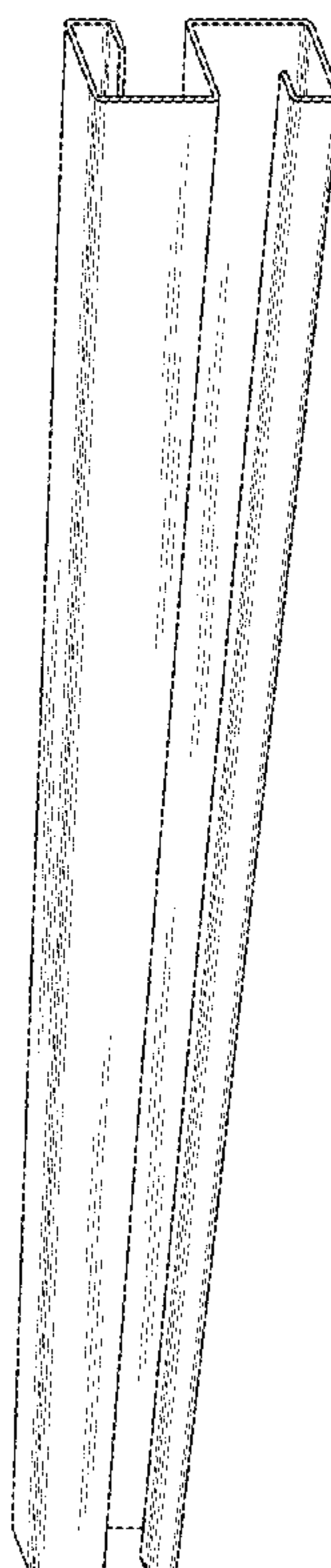

**DESCRIPTION**

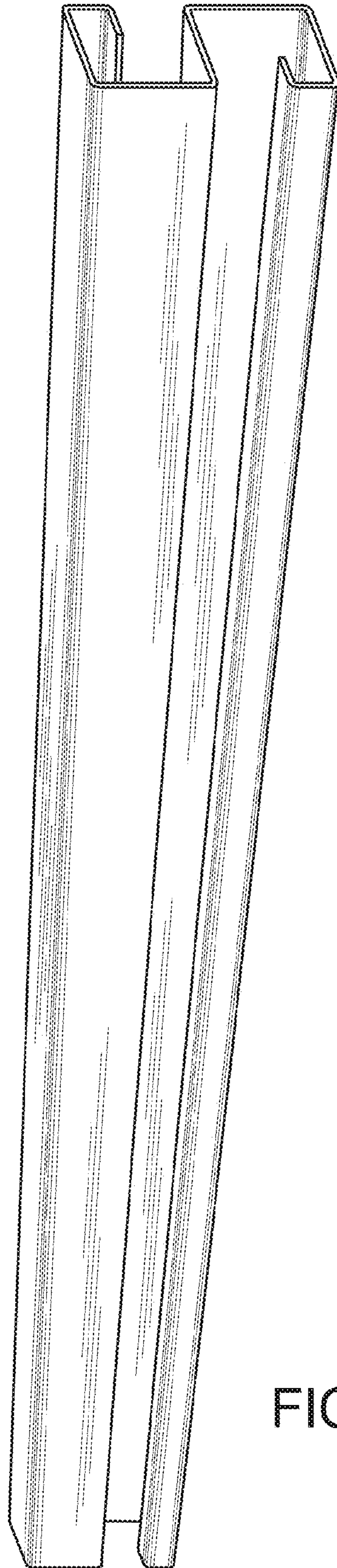

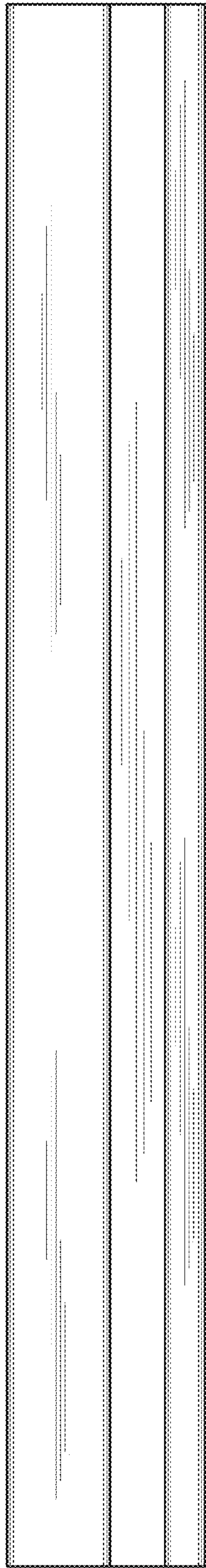

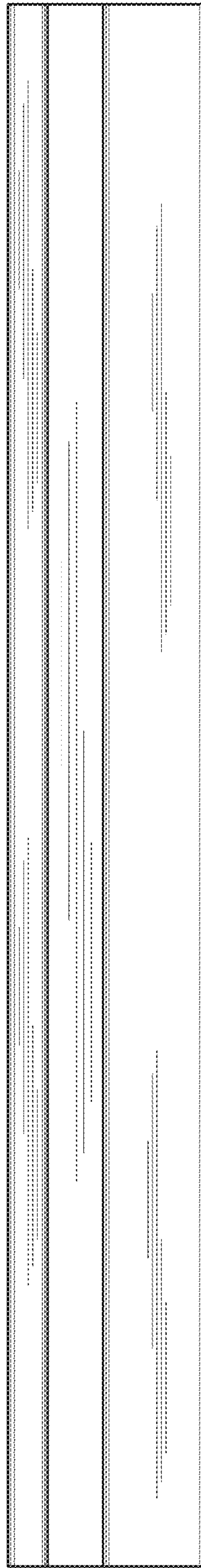

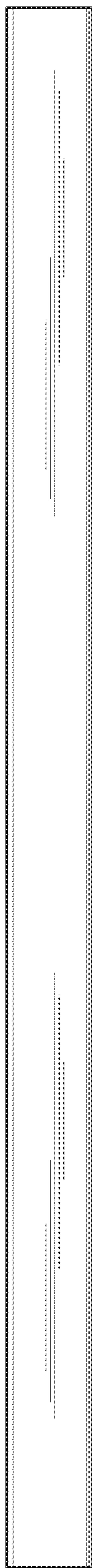

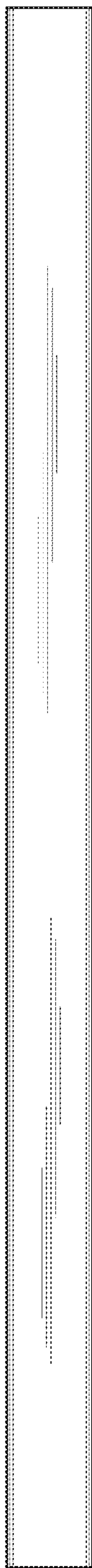

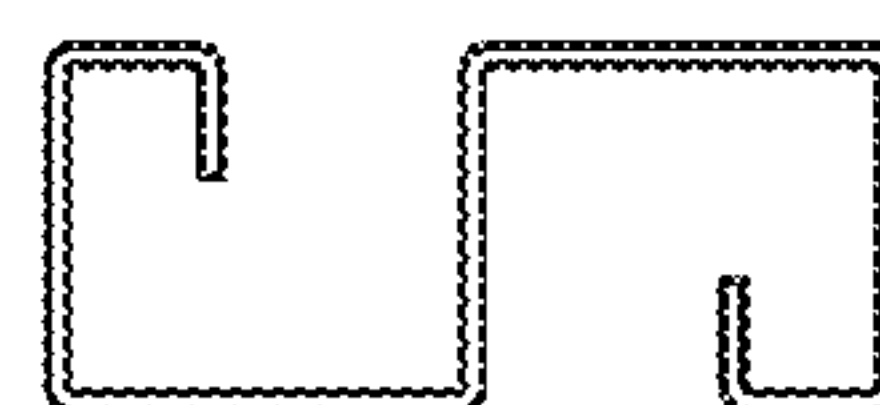

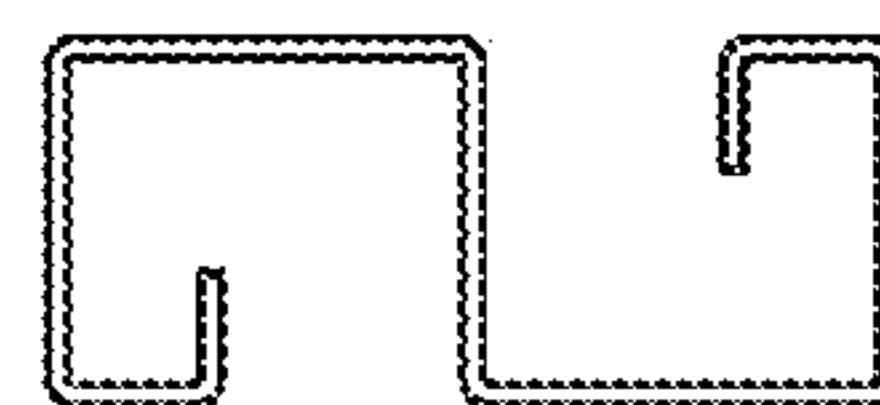
